(57) CLAIM

The ornamental design for a table board, as shown.

DESCRIPTION

FIG. 1 is a front view of a table board showing my new design, the rear being a mirror image thereof;
FIG. 2 is a side view thereof, the opposite side being a mirror image thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a perspective view thereof;
FIG. 5 is an enlarged detailed view showing a portion of the rounded corner taken from the encircled area 5 shown in FIG. 4;
FIG. 6 is a front view of a second embodiment of my new design, the rear being a mirror image thereof;
FIG. 7 is a left side view thereof;
FIG. 8 is a right side view thereof;
FIG. 9 is a top plan view thereof; and,
FIG. 10 is a perspective view thereof.

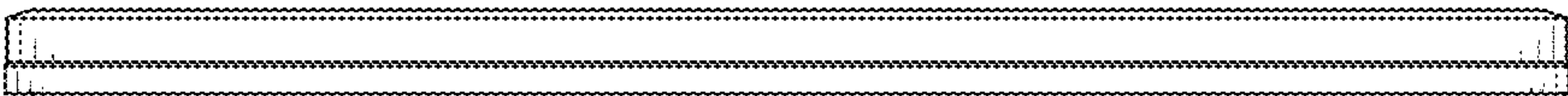

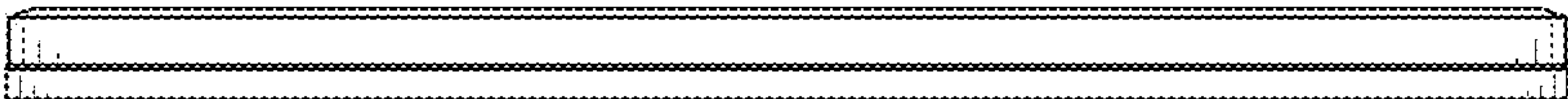

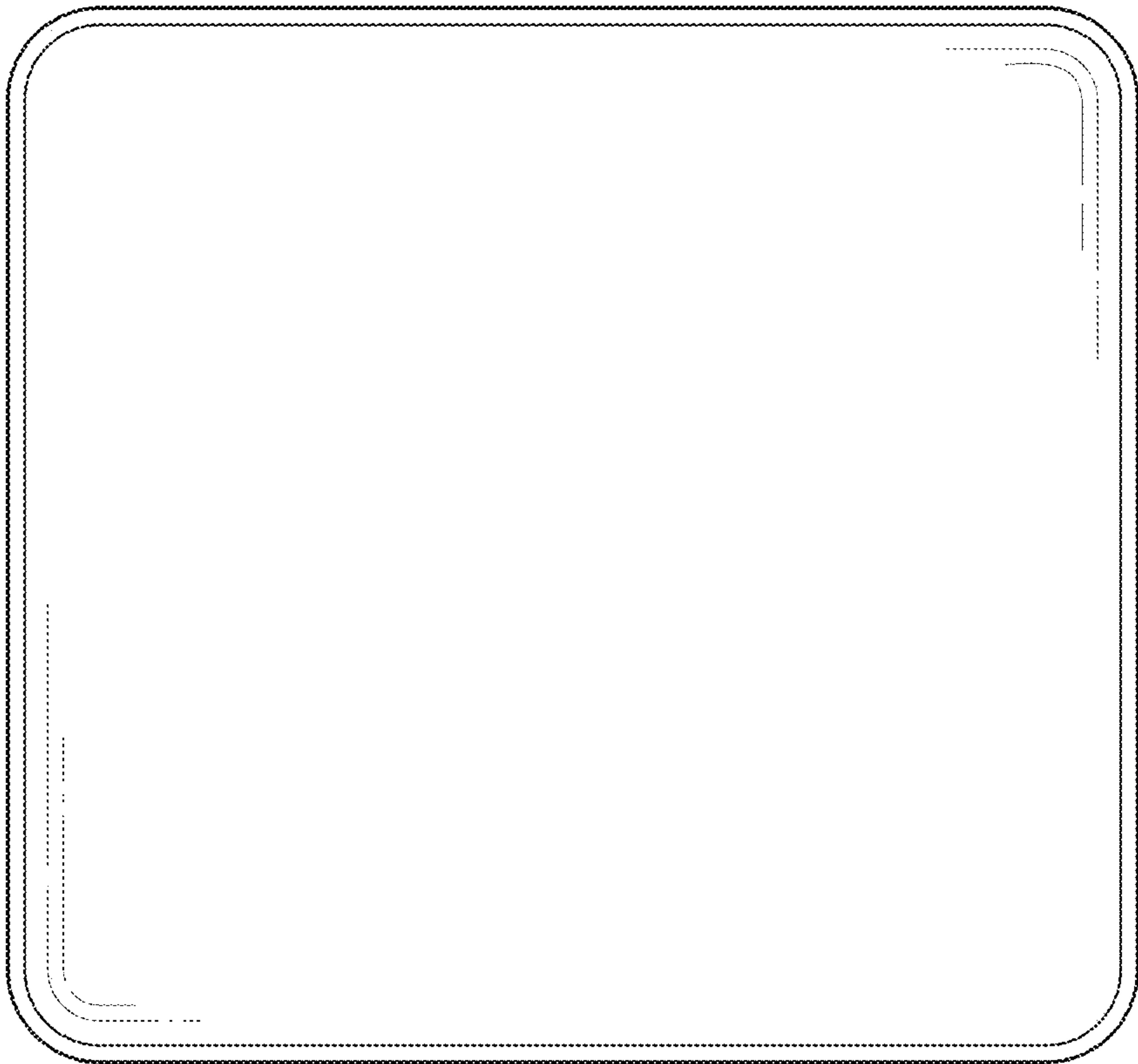

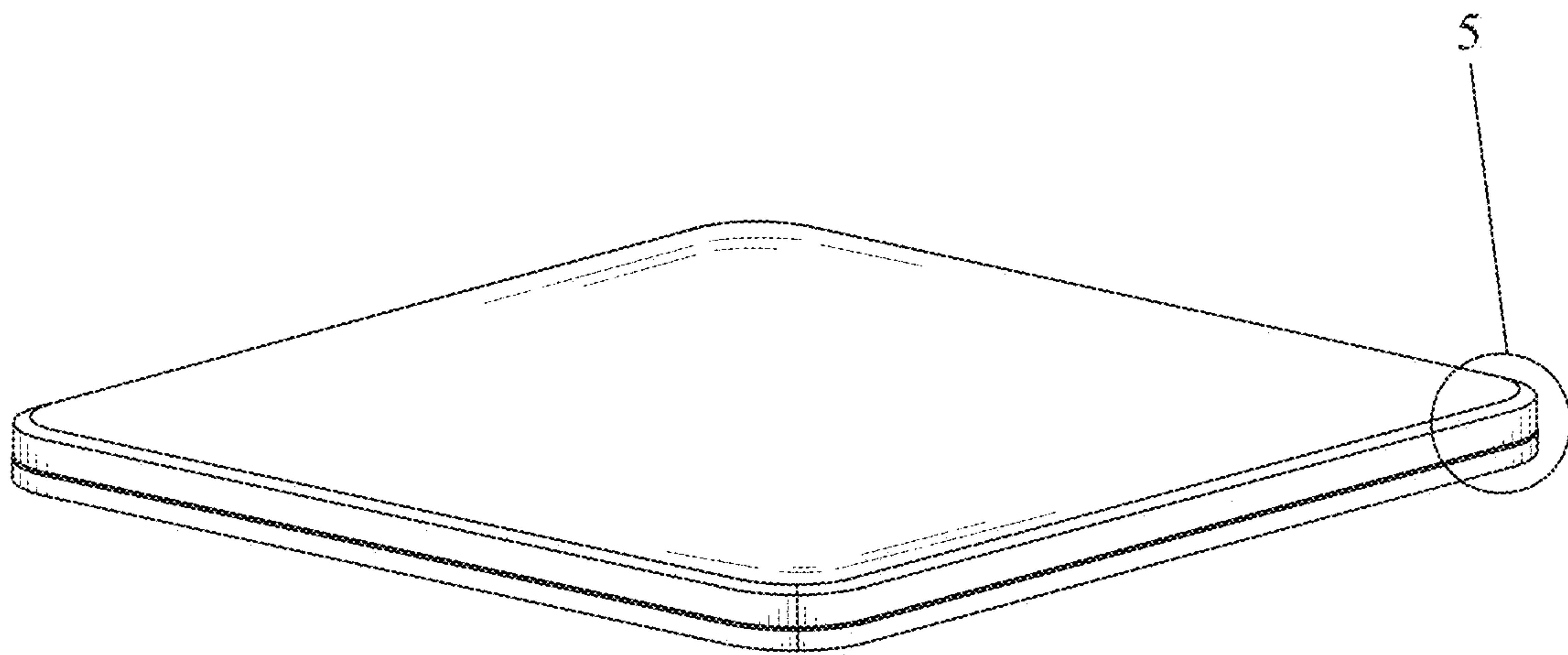

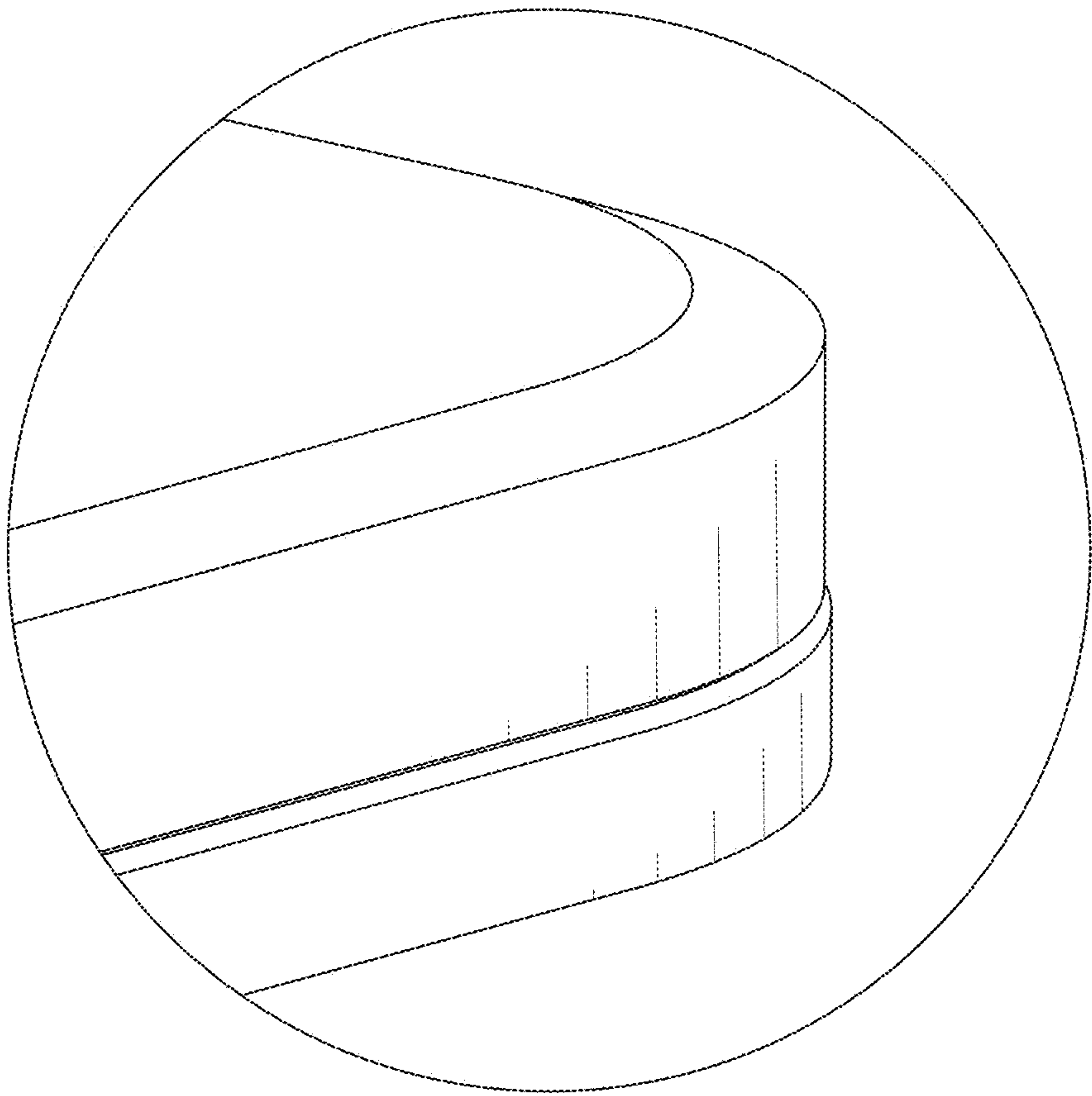

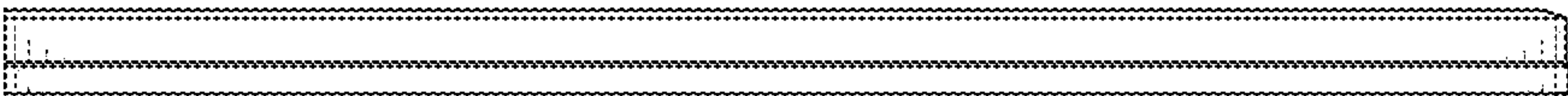

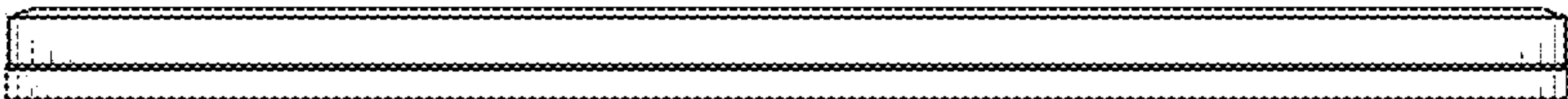

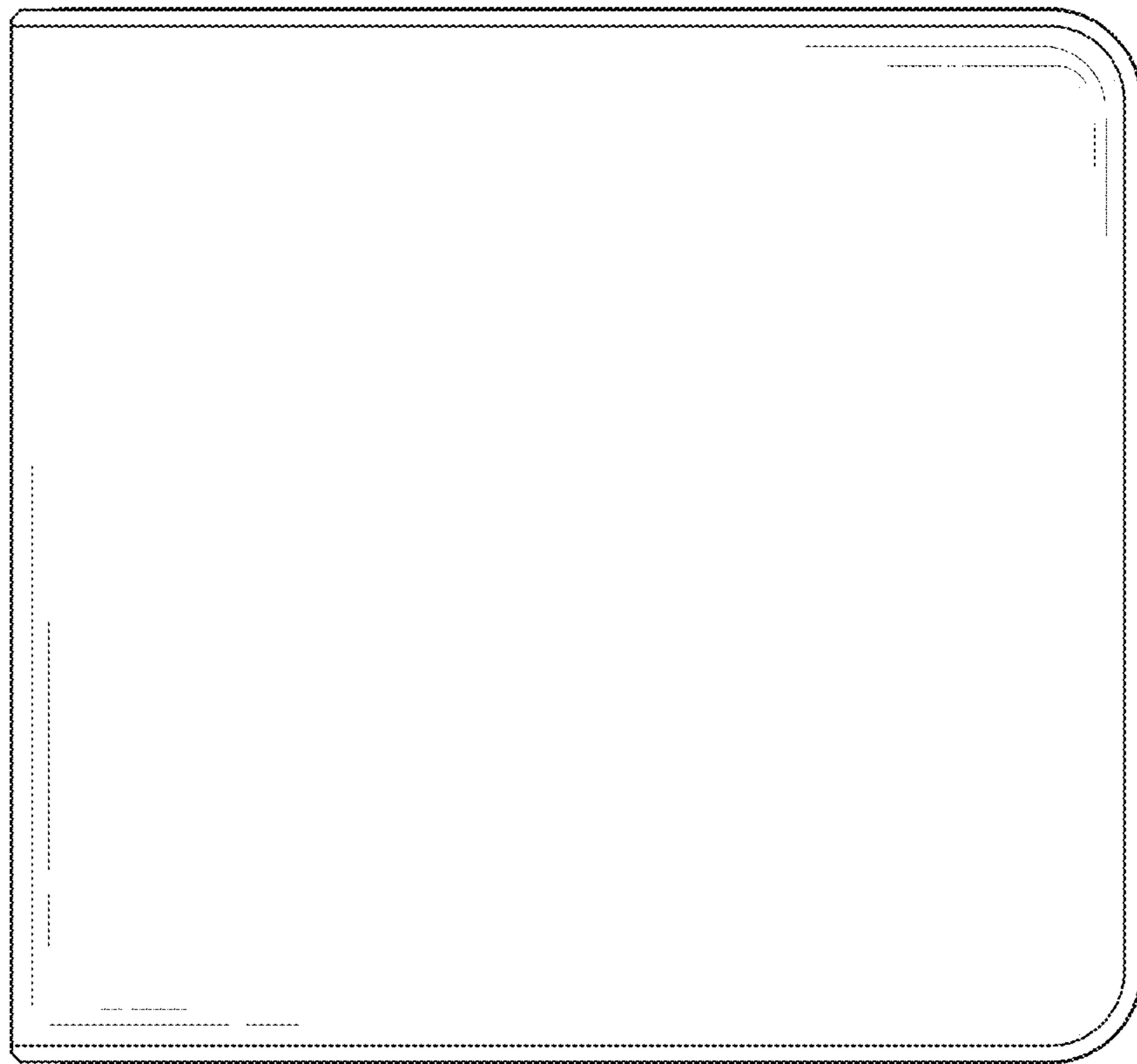

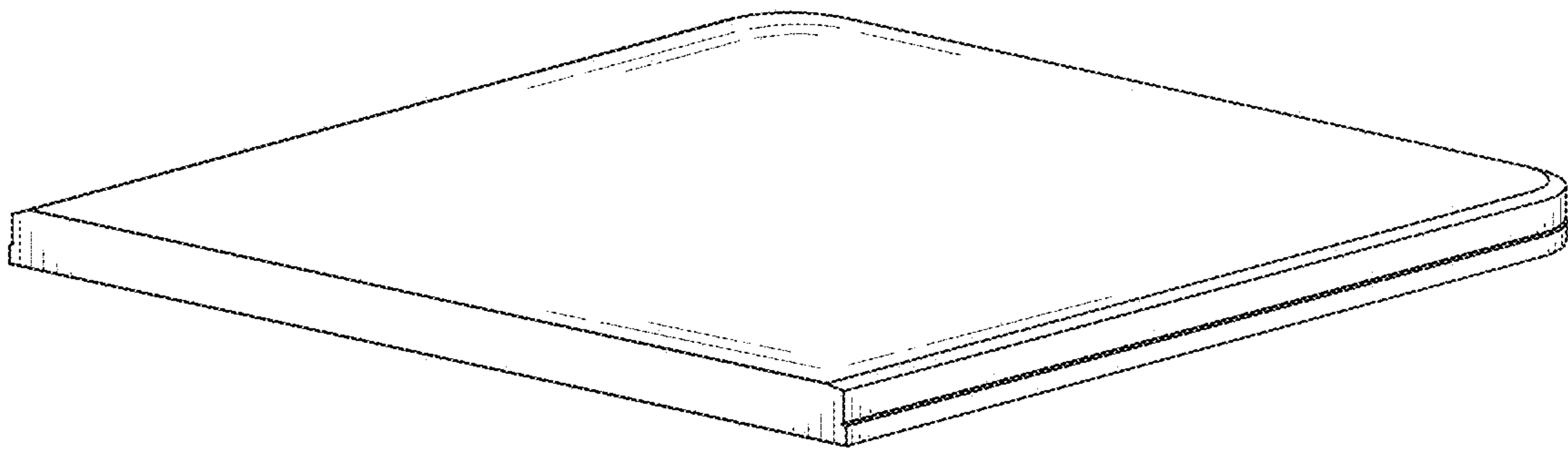
