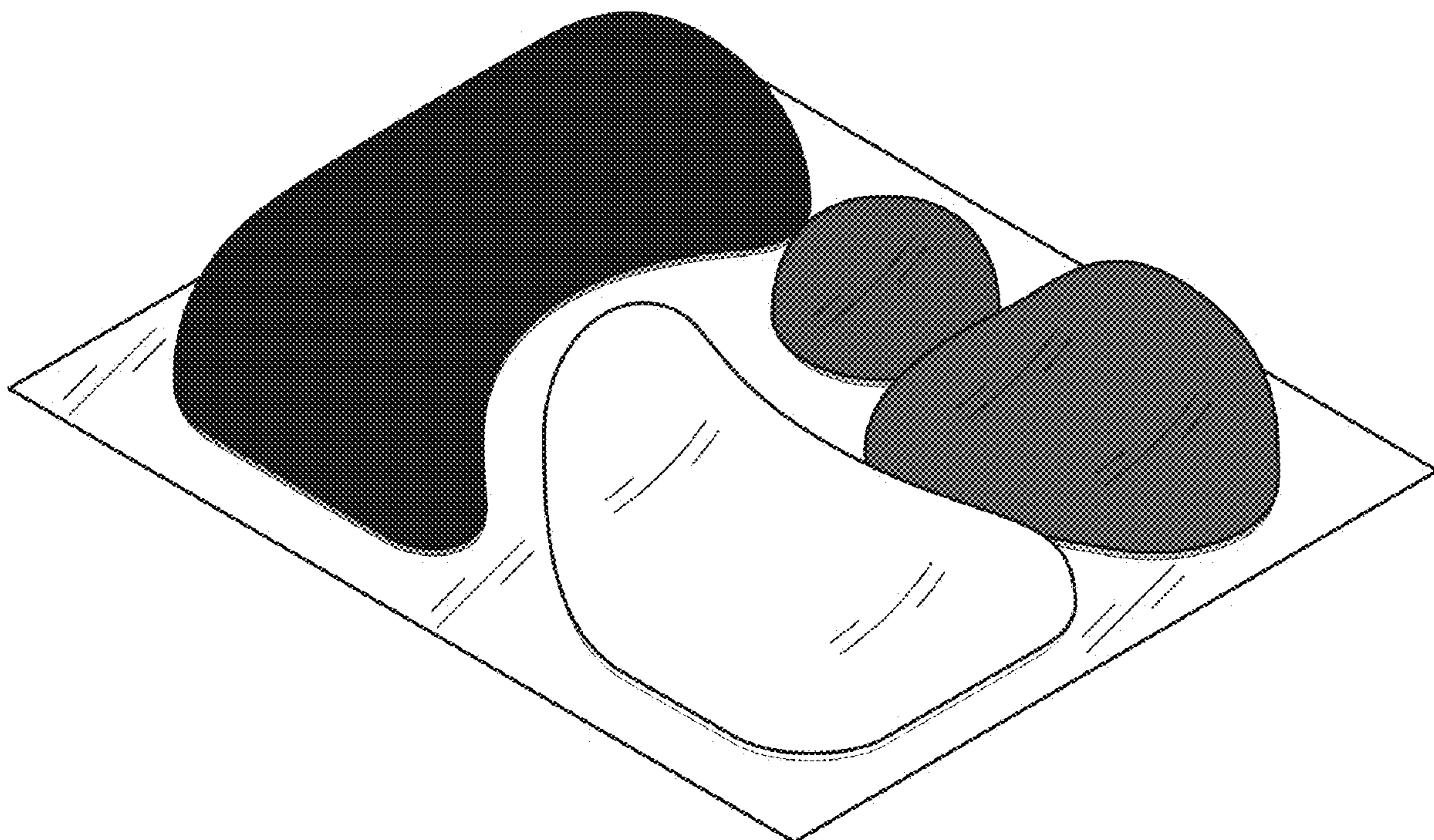
The ornamental design for a capsule containing washing product, as shown and described.

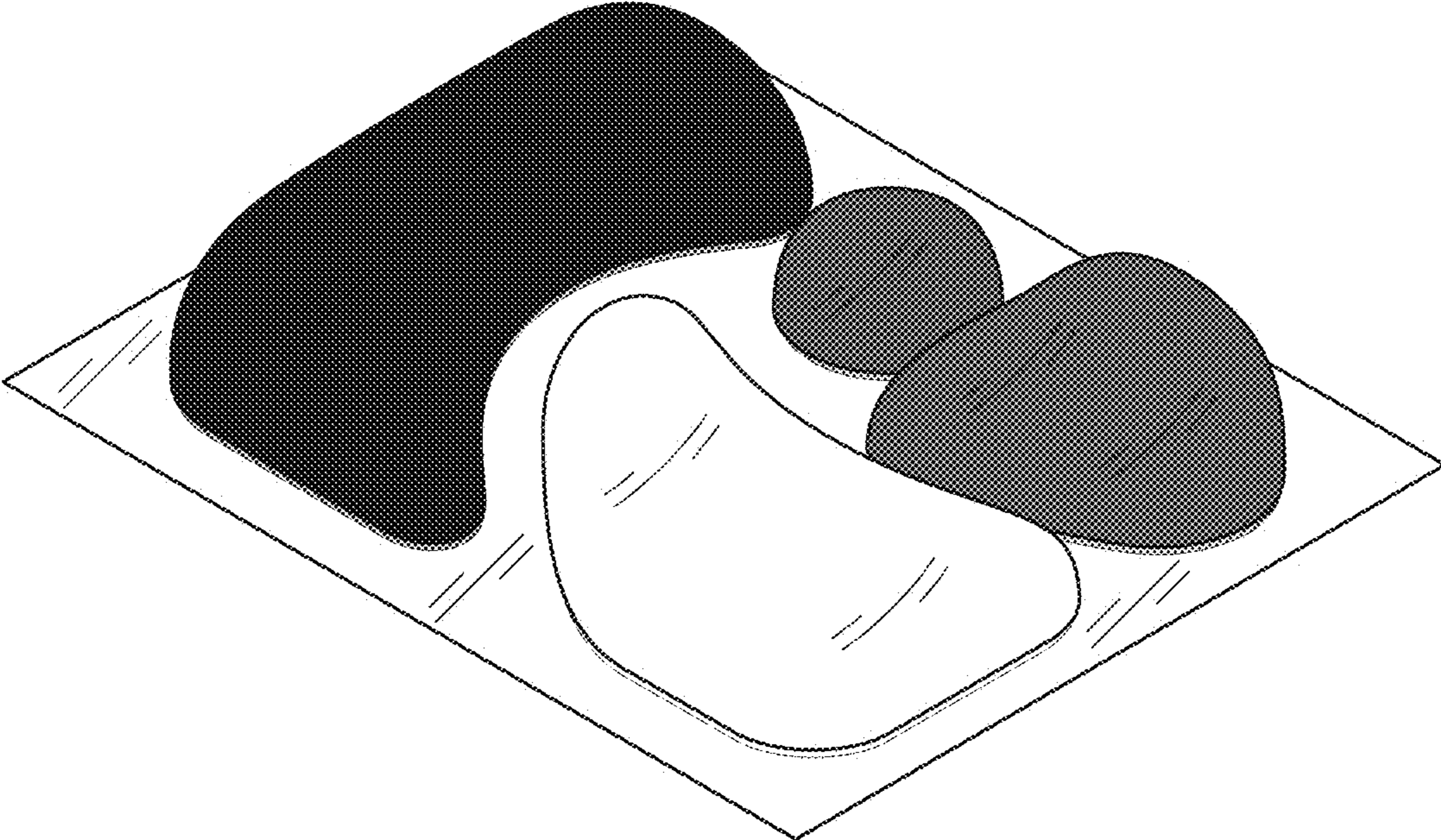

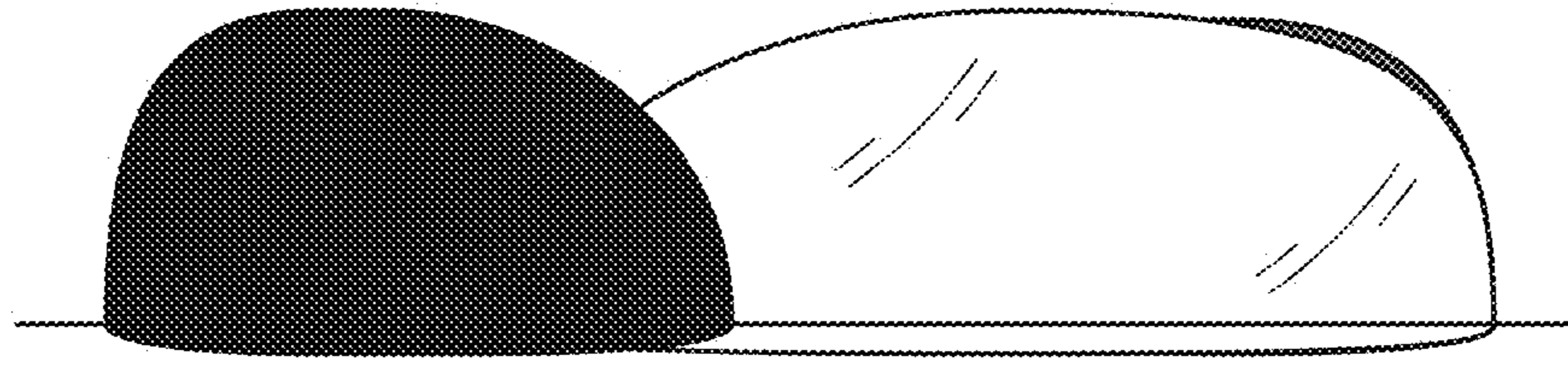

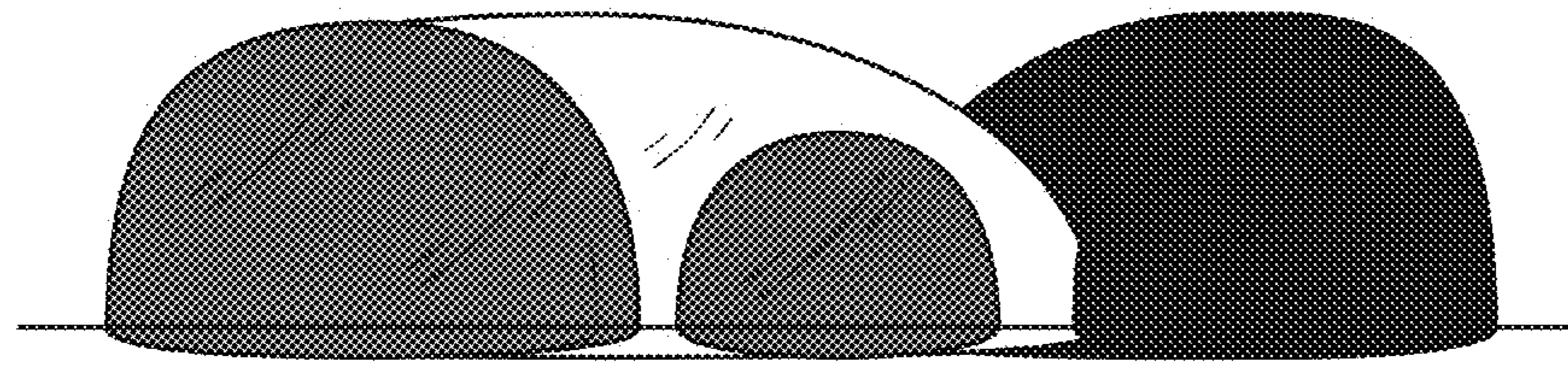

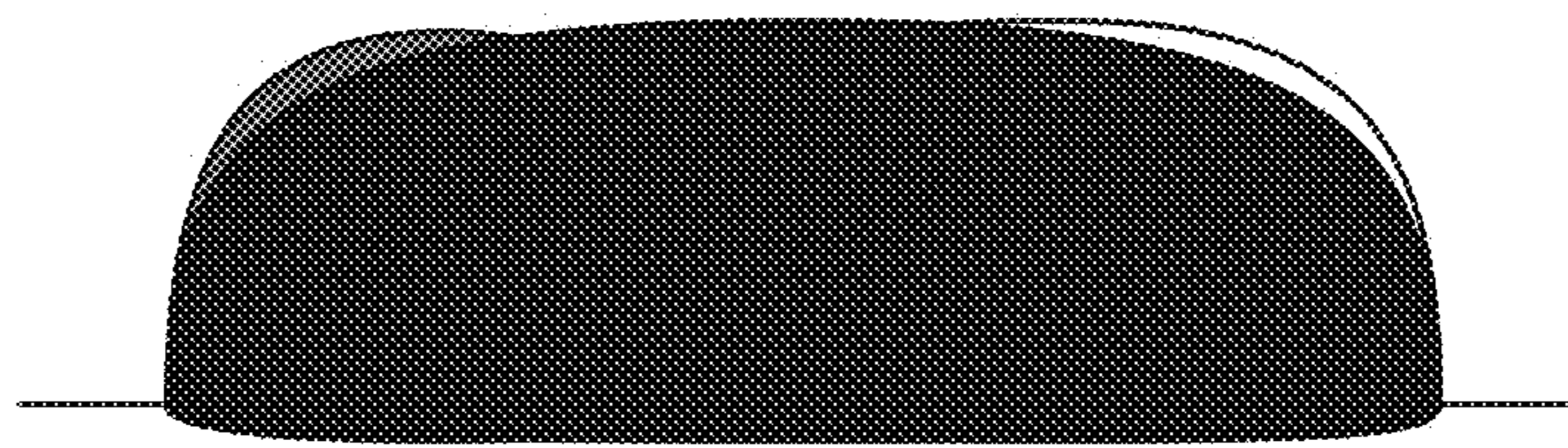

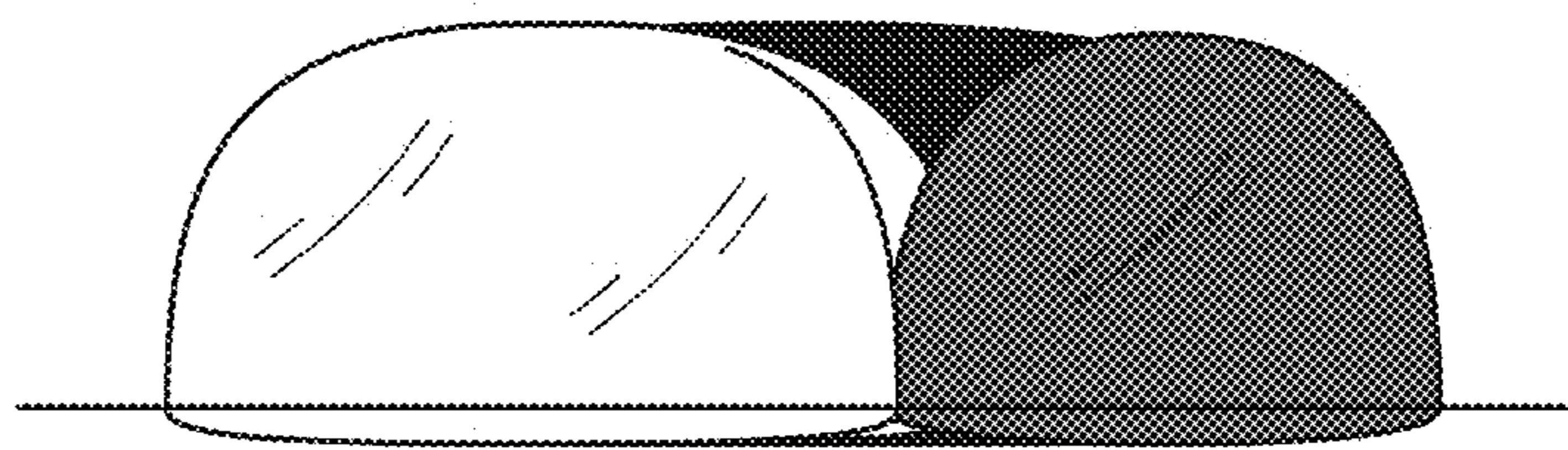

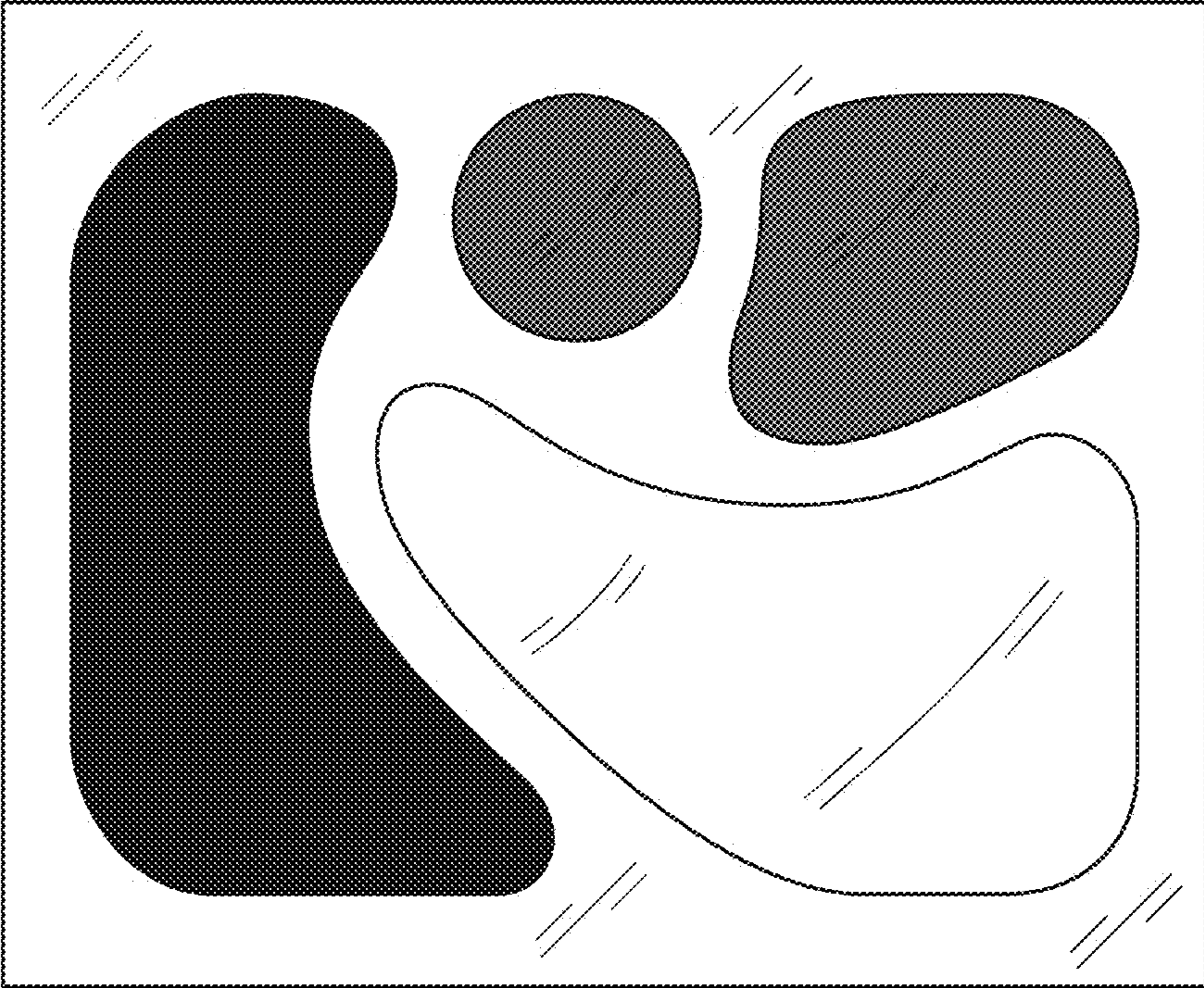

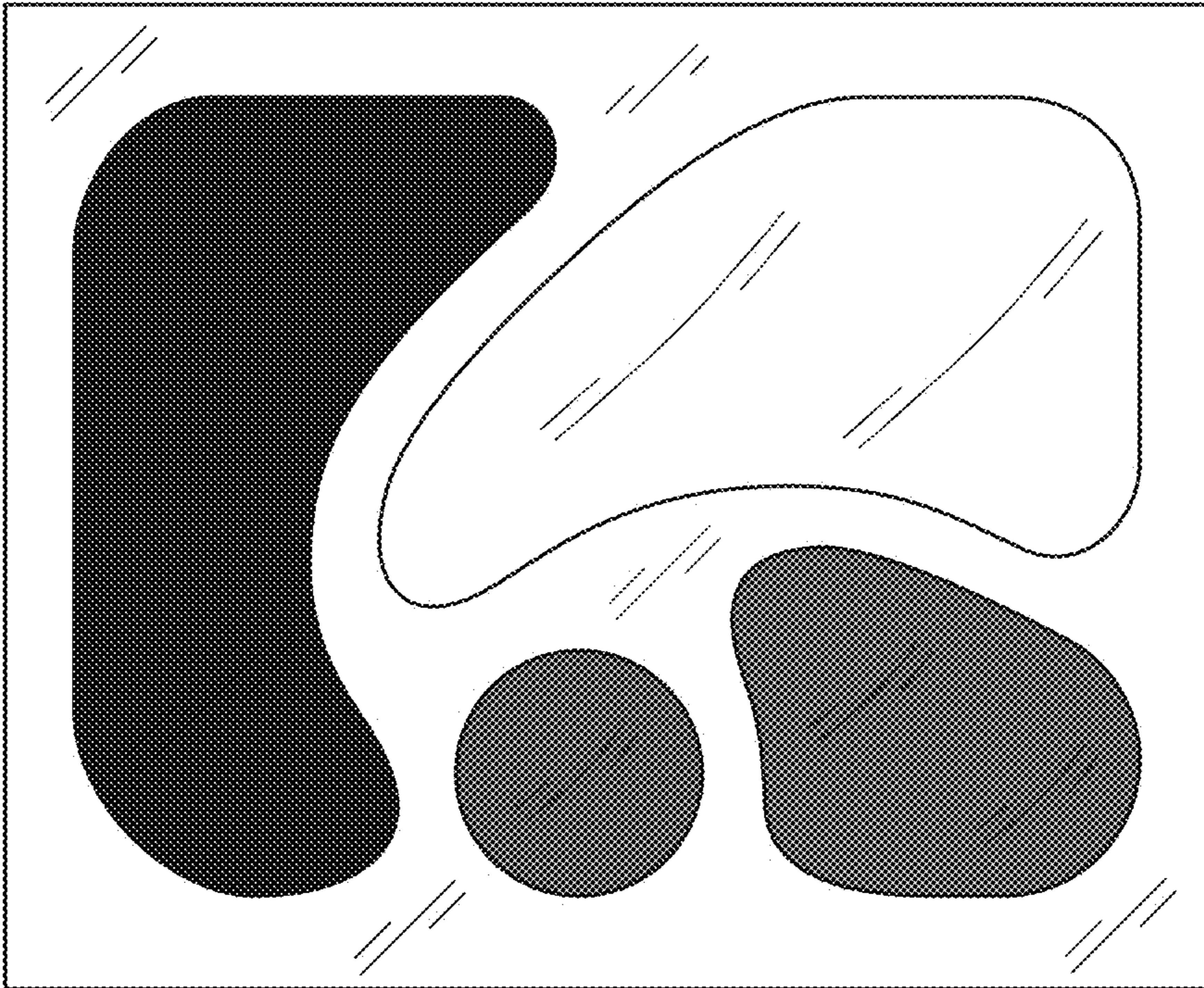
