(57) **CLAIM**


The ornamental design for a bicycle rack, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a bicycle rack, showing our new design;  
FIG. 2 is a bottom perspective view thereof;  
FIG. 3 is a front elevational view thereof the rear elevational view being a mirror image thereof;  
FIG. 4 is a top plan view thereof,  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is an enlarged left-side elevational view thereof; and,  
FIG. 7 is an enlarged right-side elevational view thereof.  
The broken lines shown illustrate portions of the bicycle rack that form no part of the claimed design.














