(57) **CLAIM**

The ornamental design for a vehicle roof, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side elevated view of a vehicle roof according to the present invention.

FIG. 2 is a bottom right perspective view of the roof shown in FIG. 1.

FIG. 3 is a front right perspective view thereof, from below.

FIG. 4 is a rear right perspective view thereof, from below.

FIG. 5 is a rear view thereof.

FIG. 6 is a top view thereof.

FIG. 7 is another top view showing the vehicle roof of FIGS. 1-6, but with the vehicle roof mounted on a vehicle shown in de-emphasized and half-tone portions so as to illustrate environmental structure. These portions form no part of the claimed design. More particularly, in FIG. 7 the inventive vehicle roof is shown within the broken line, and any elements shown outside the broken line form no part of the claimed design, but are instead included to show environmental aspects thereof.

FIG. 8 is a front left perspective view of a vehicle roof according to an alternative embodiment of the present invention.

FIG. 9 is a rear left perspective view of the roof shown in FIG. 8.

FIG. 10 is a rear right perspective view thereof, from below.

FIG. 11 is a front right perspective view thereof, from below.

FIG. 12 is left side elevated view thereof.

FIG. 13 is a right side elevated view thereof.

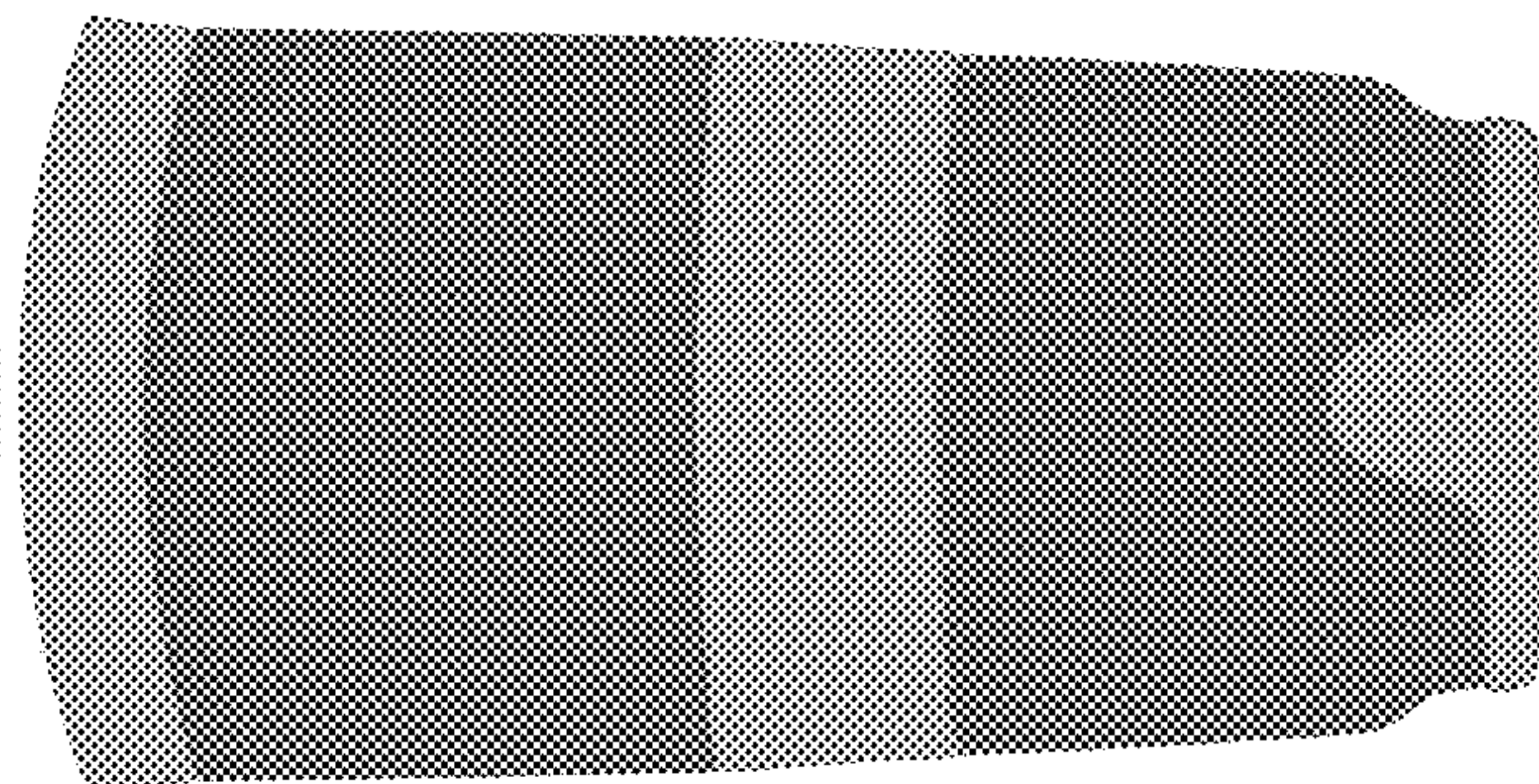
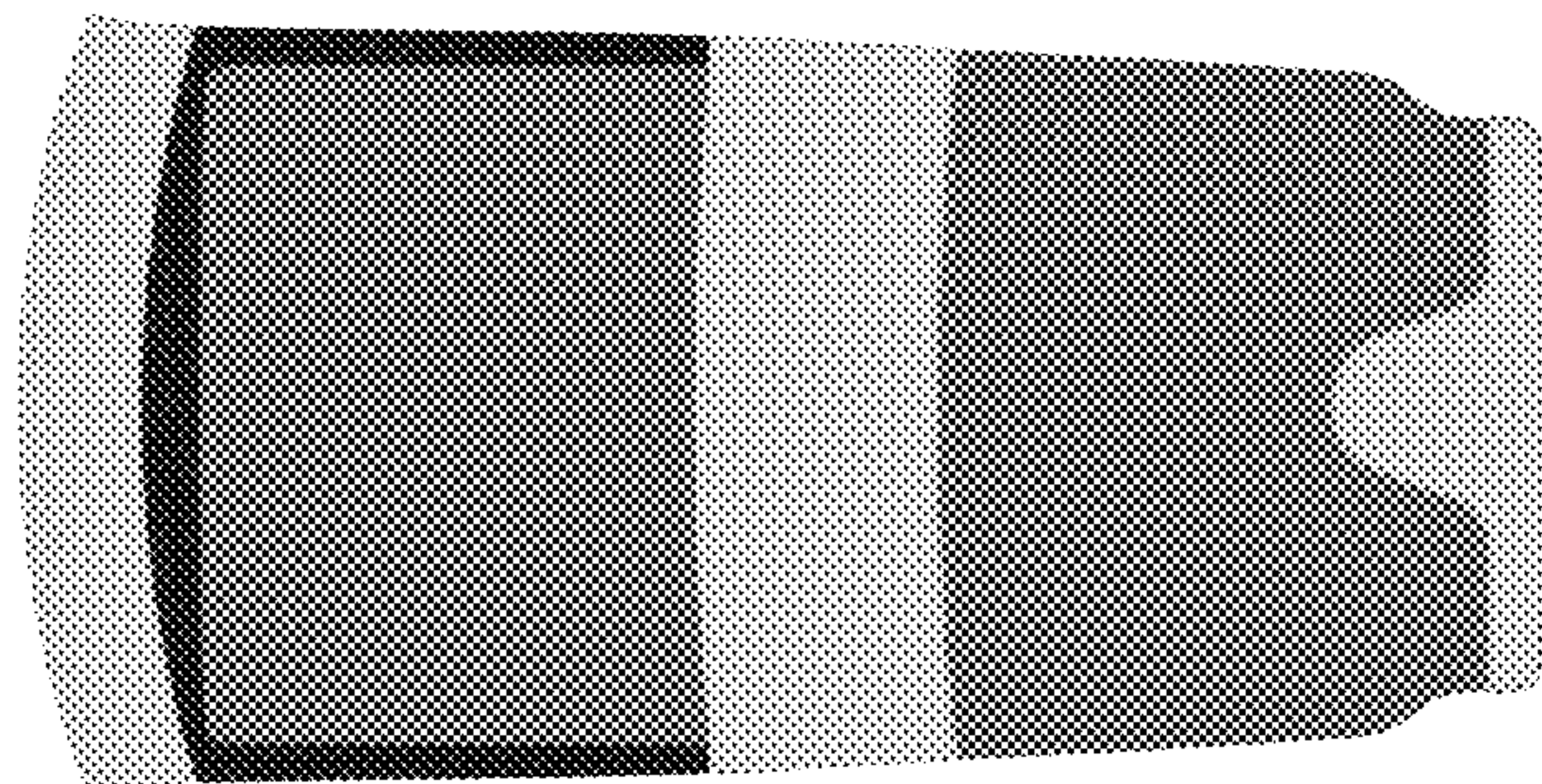
FIG. 14 is a front view thereof.

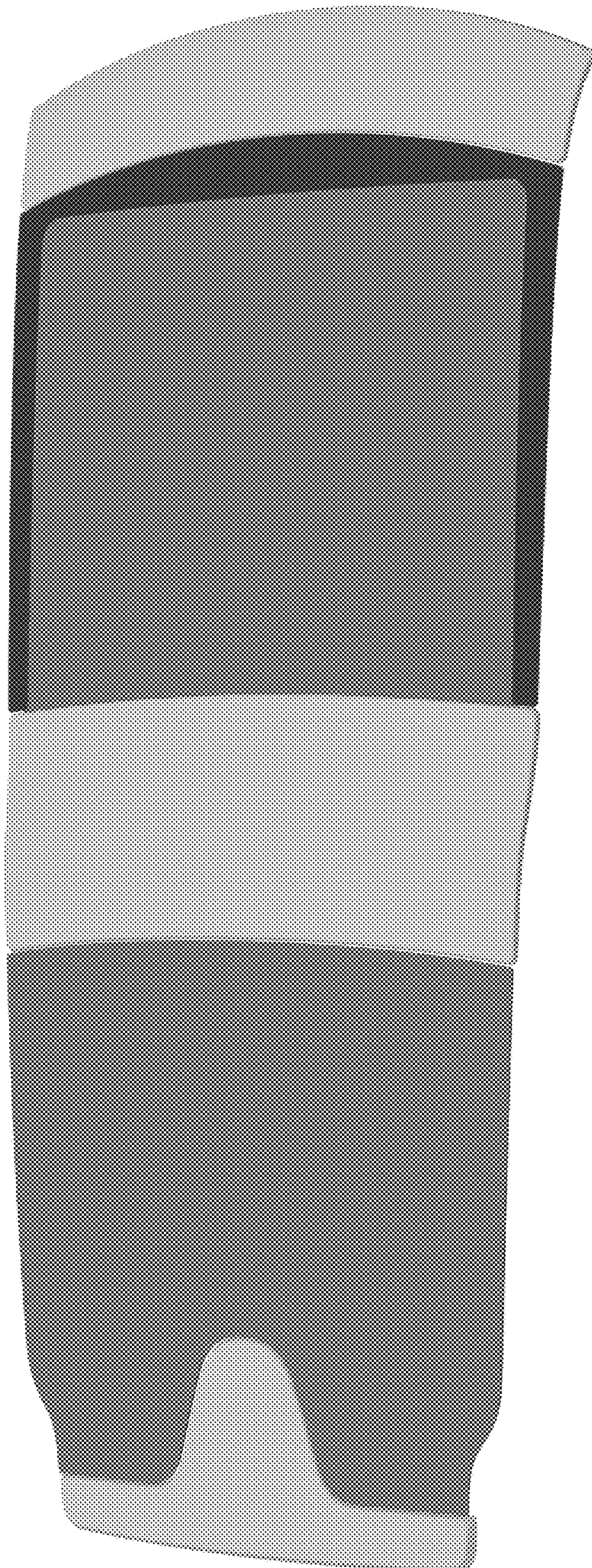

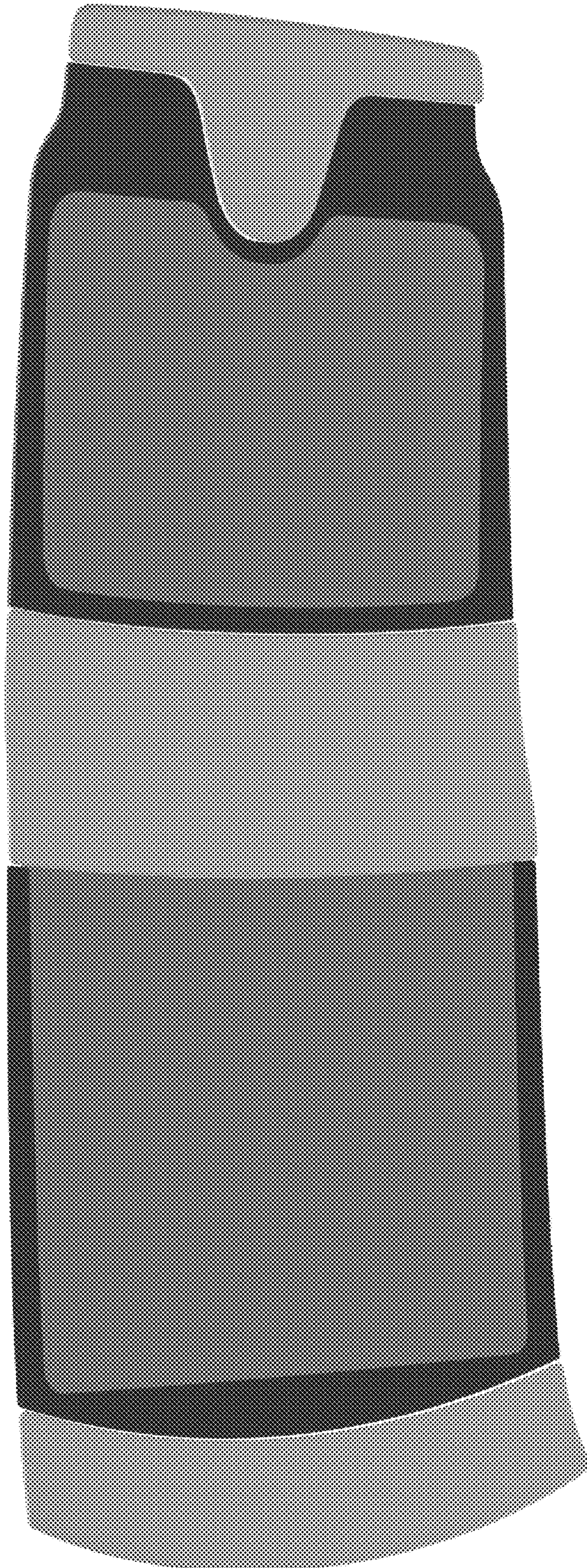

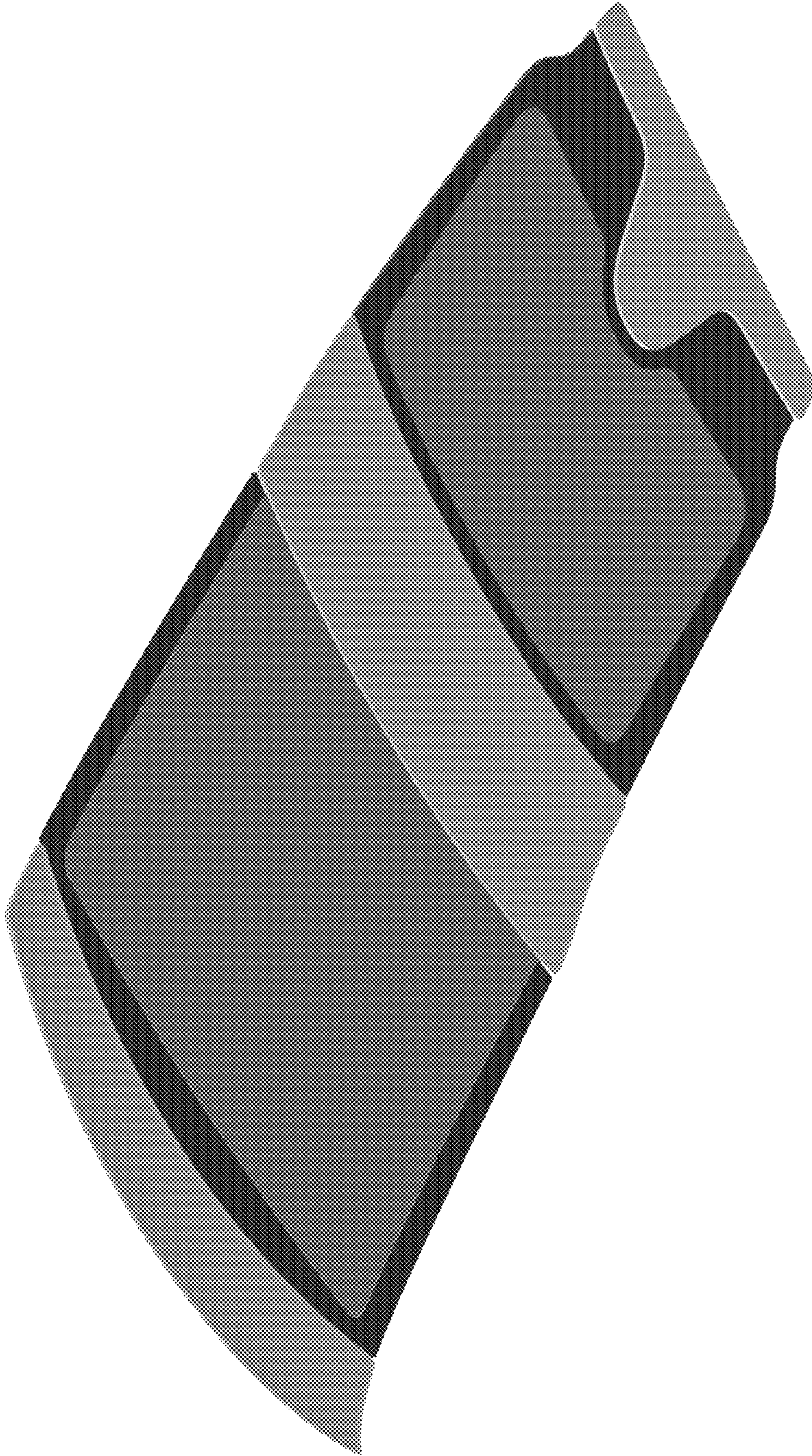

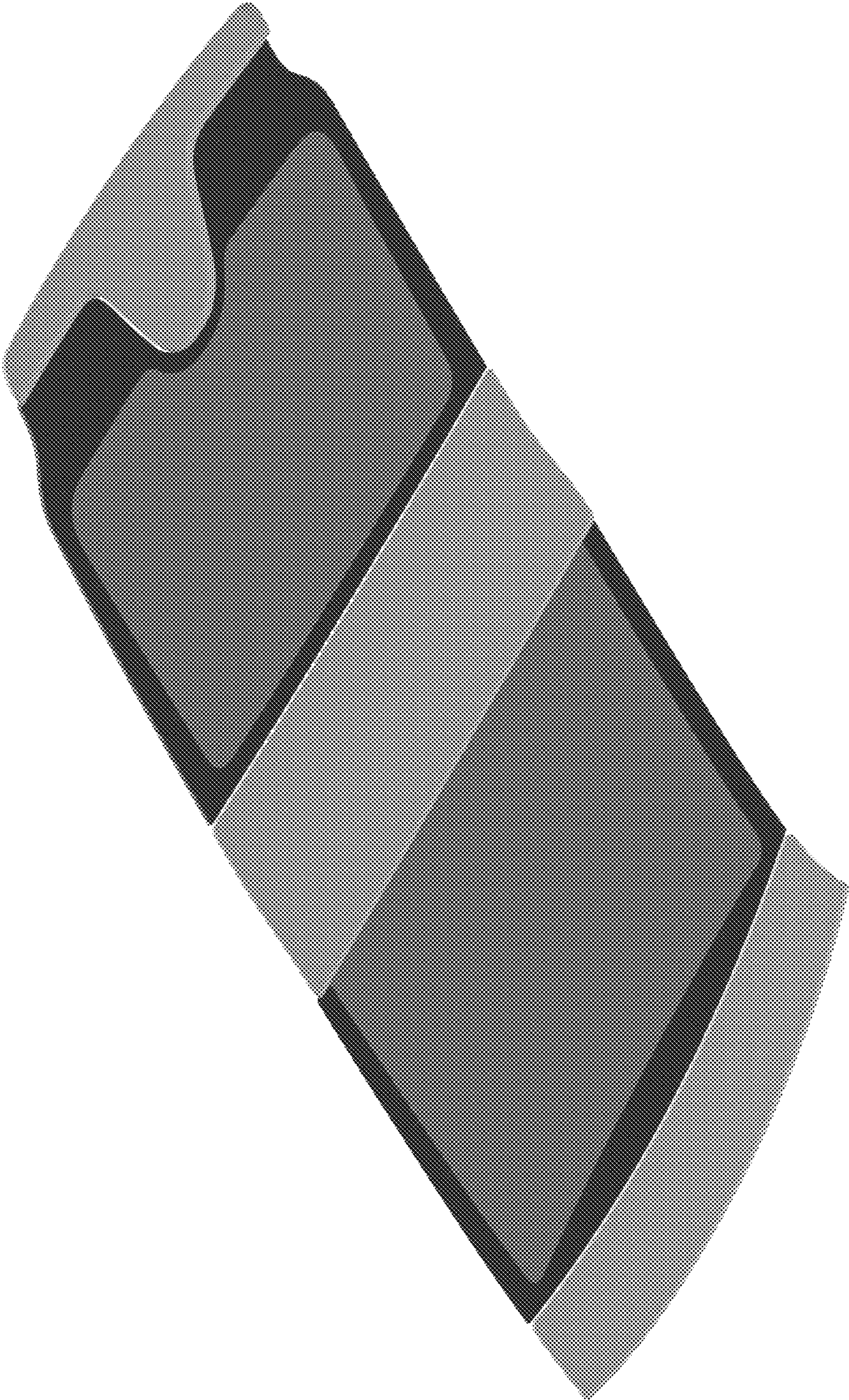

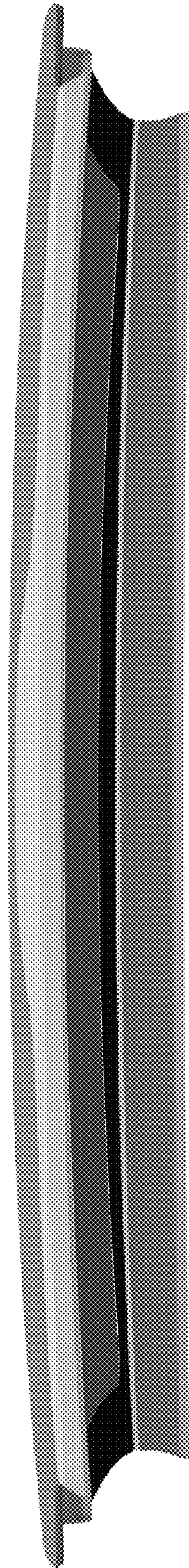

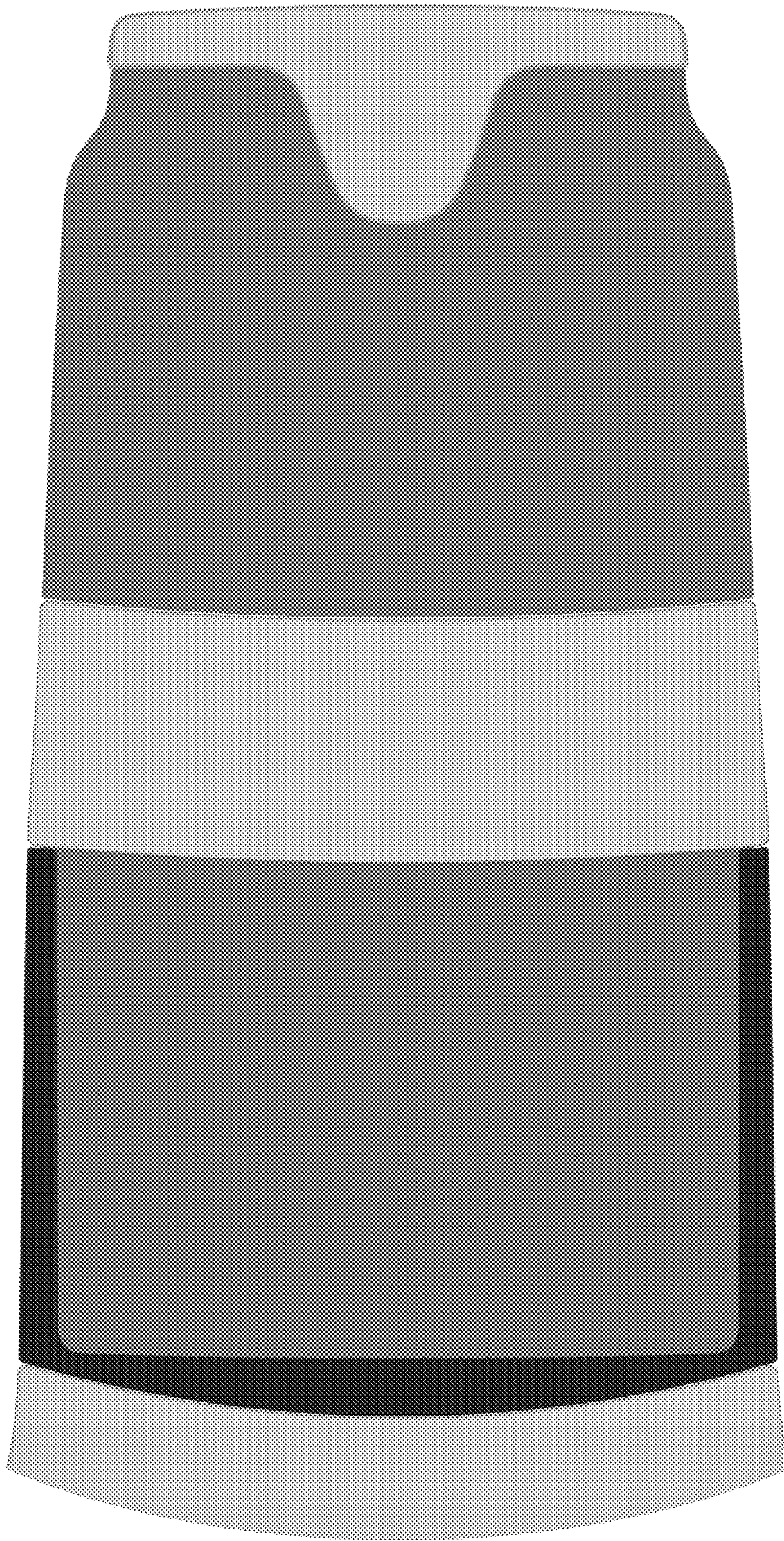

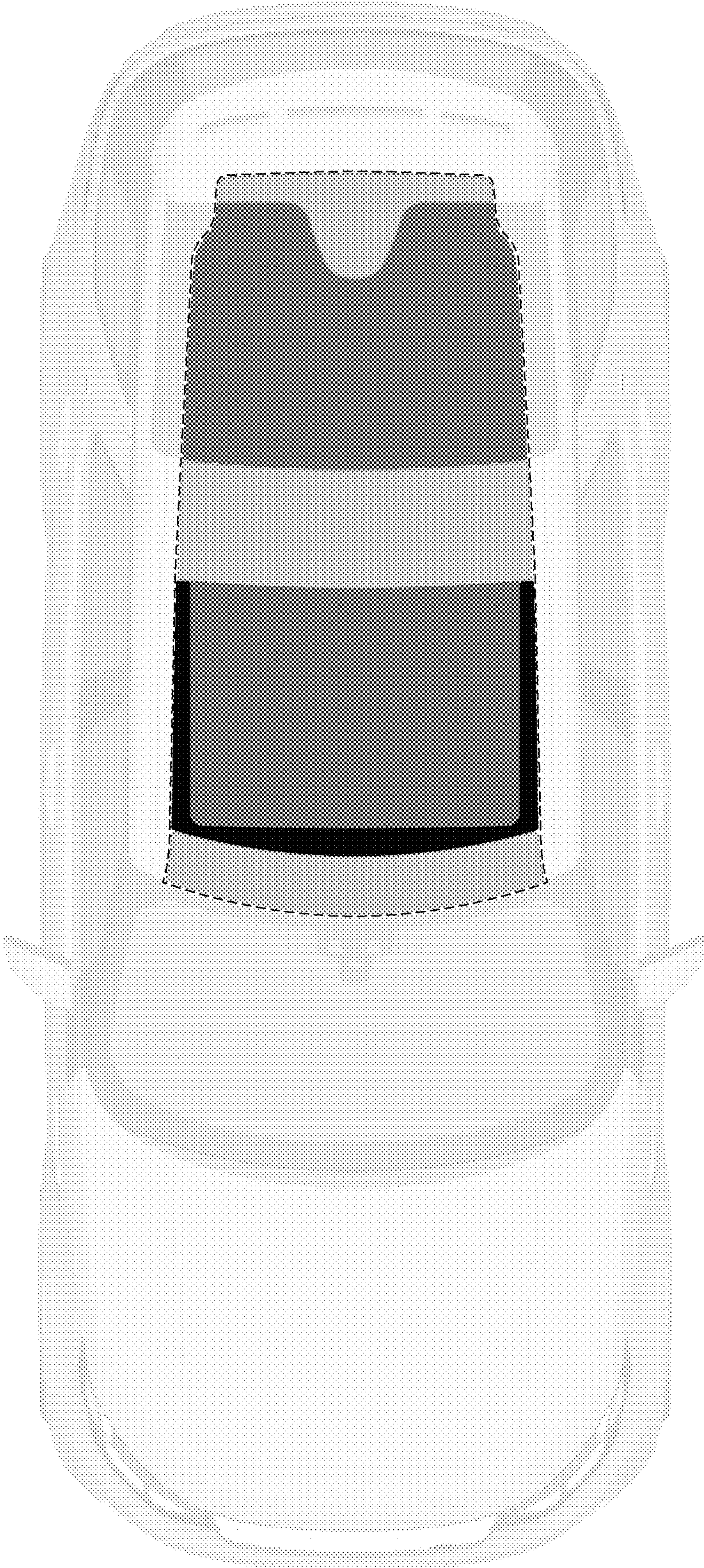

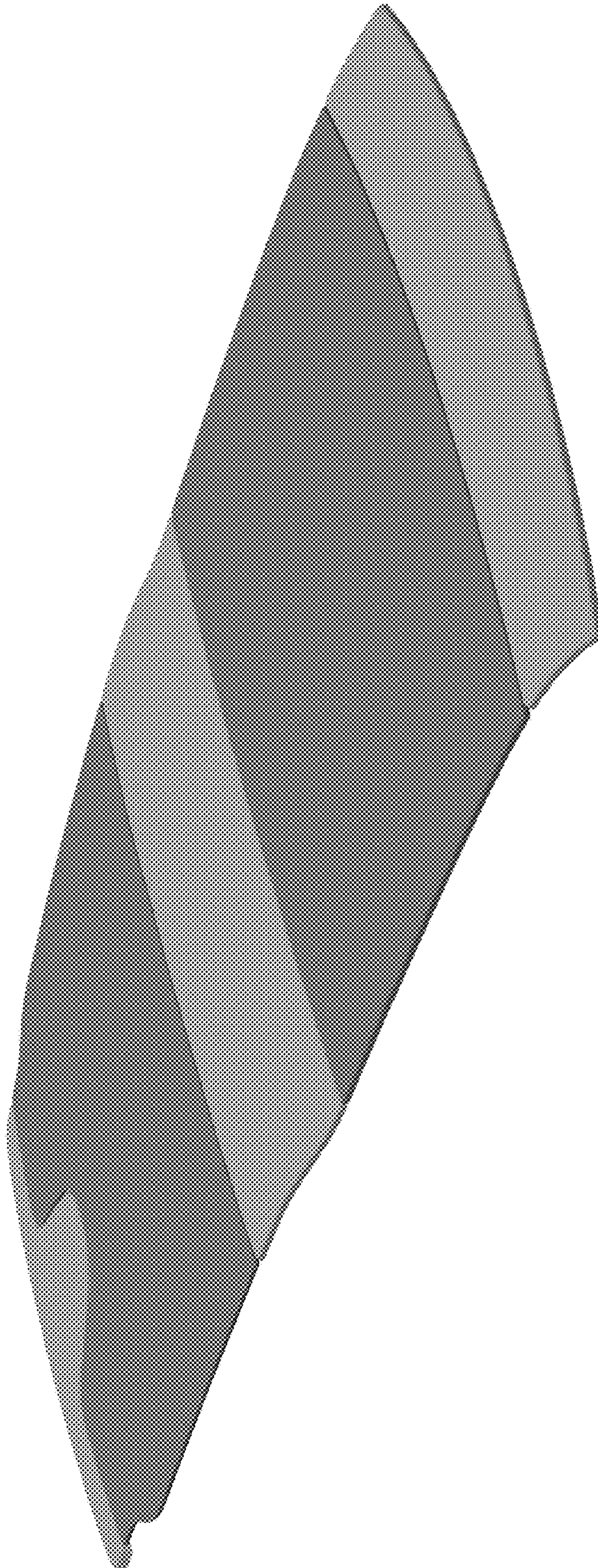

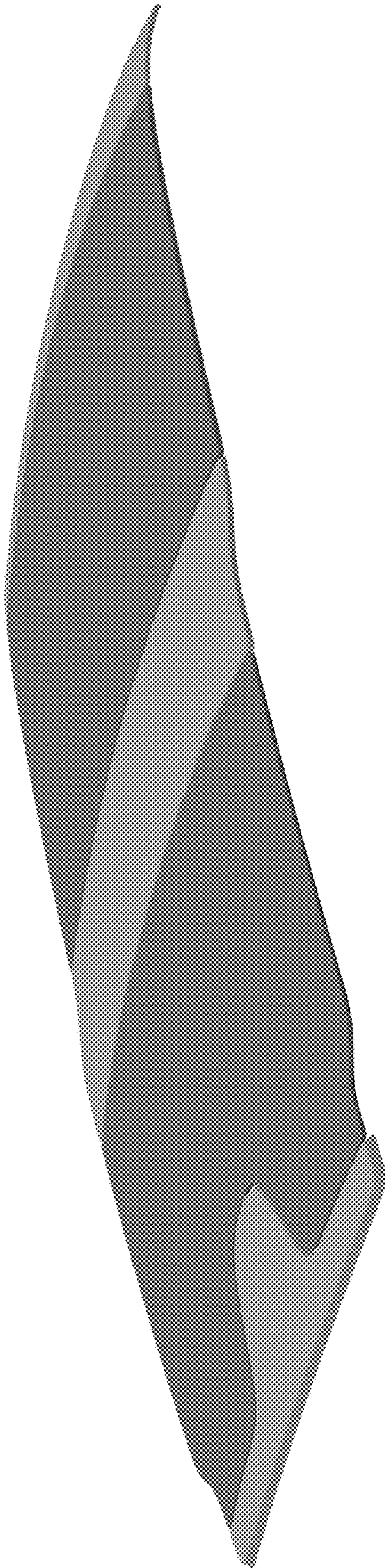

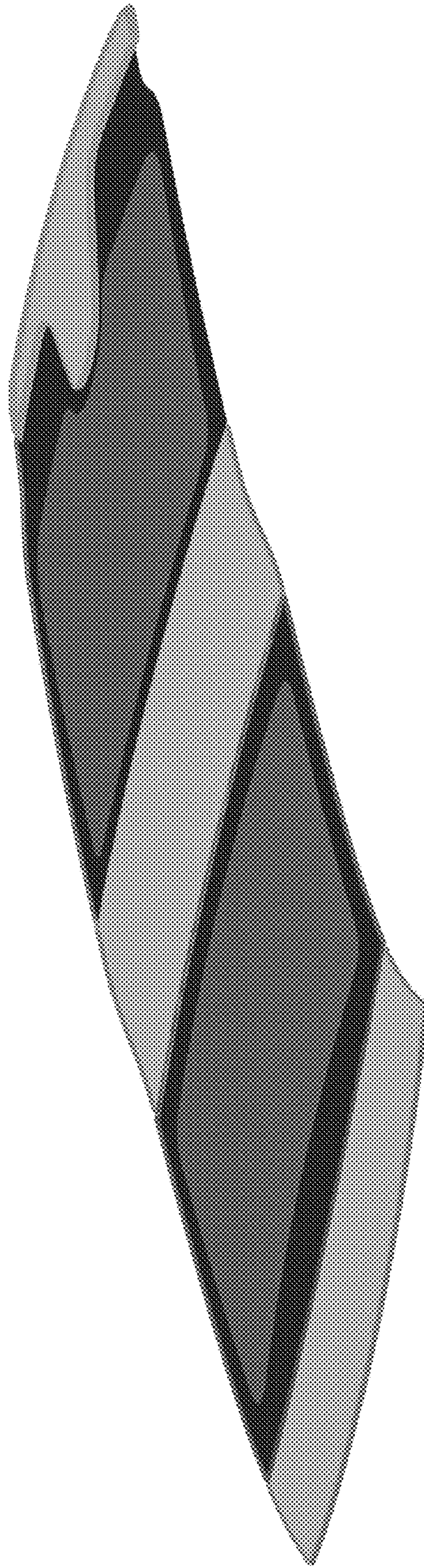

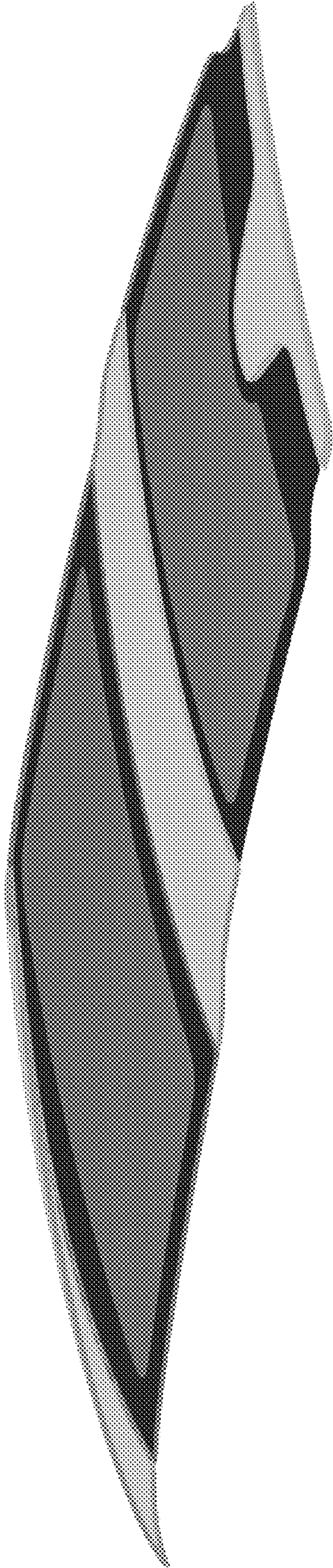

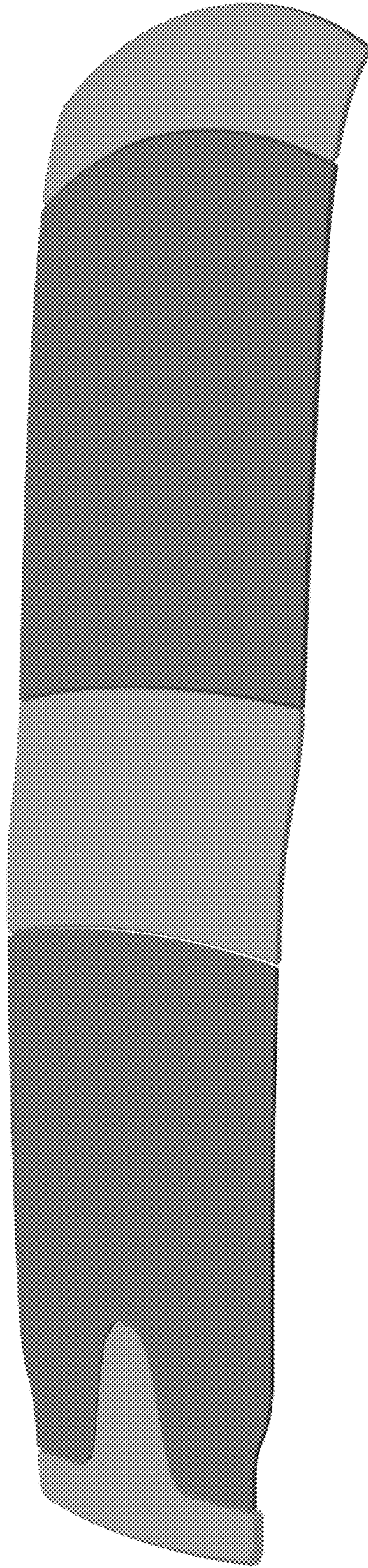

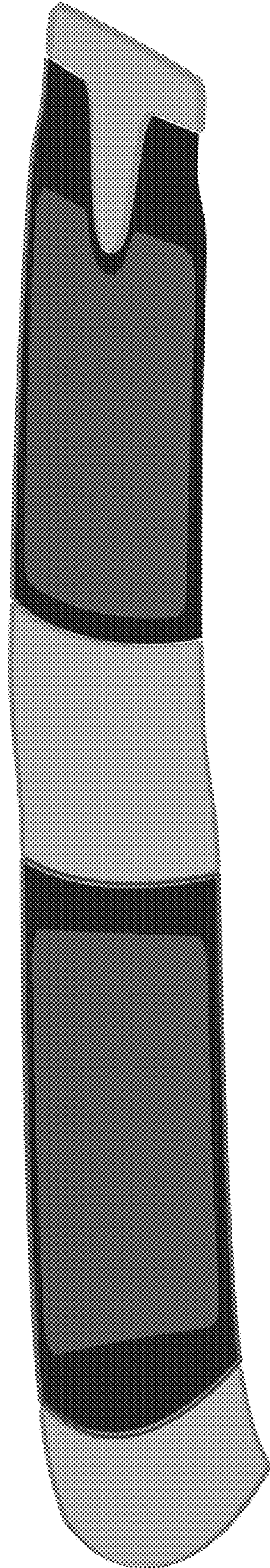

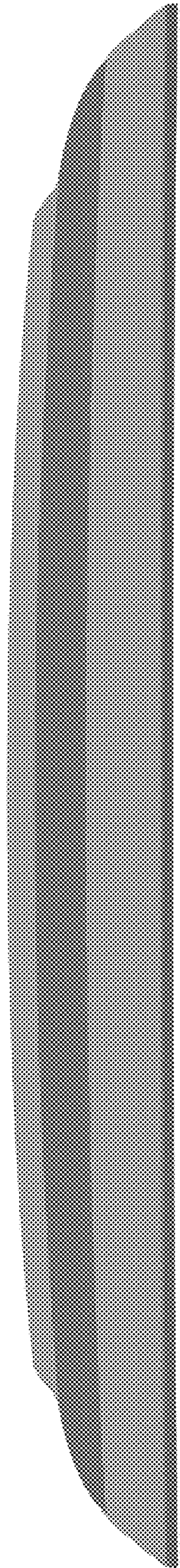

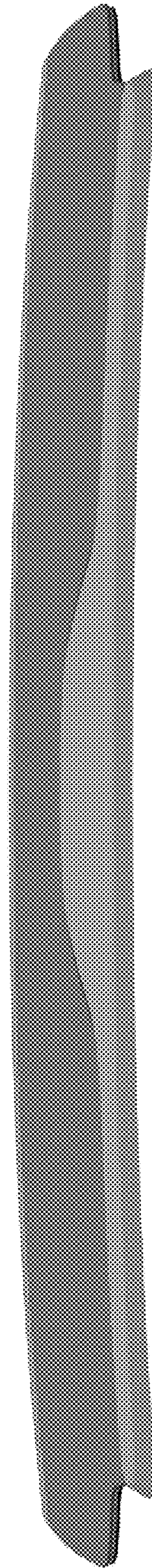

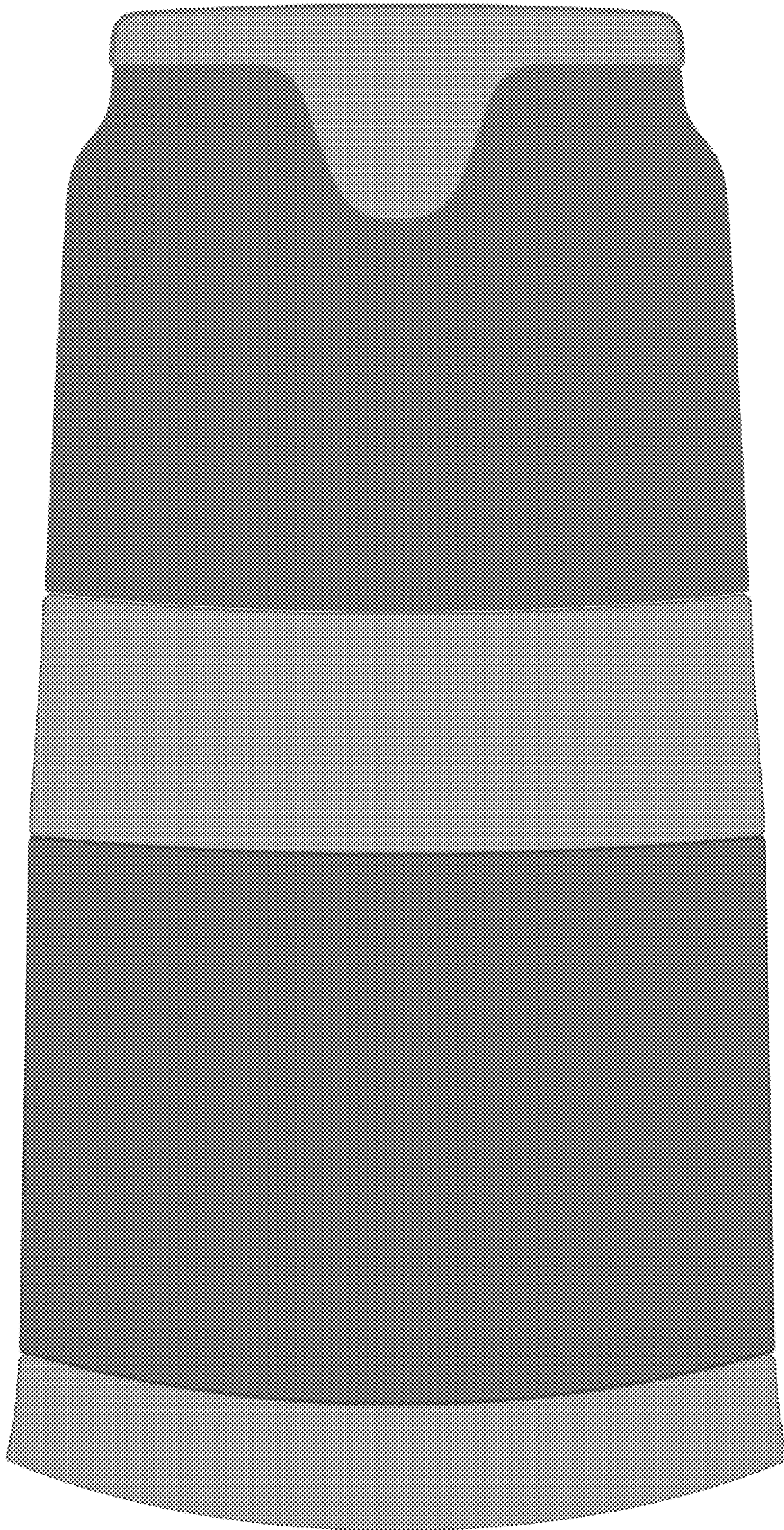

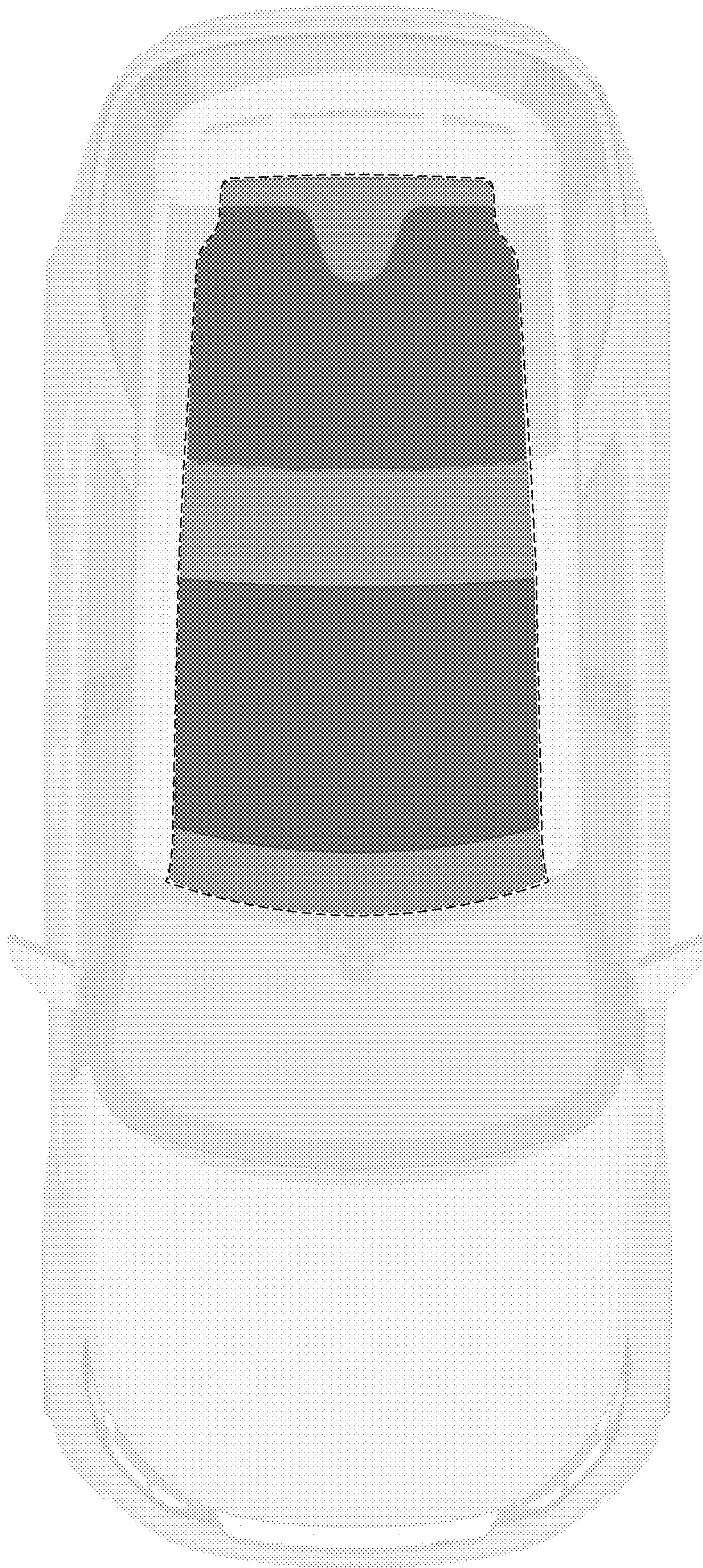
