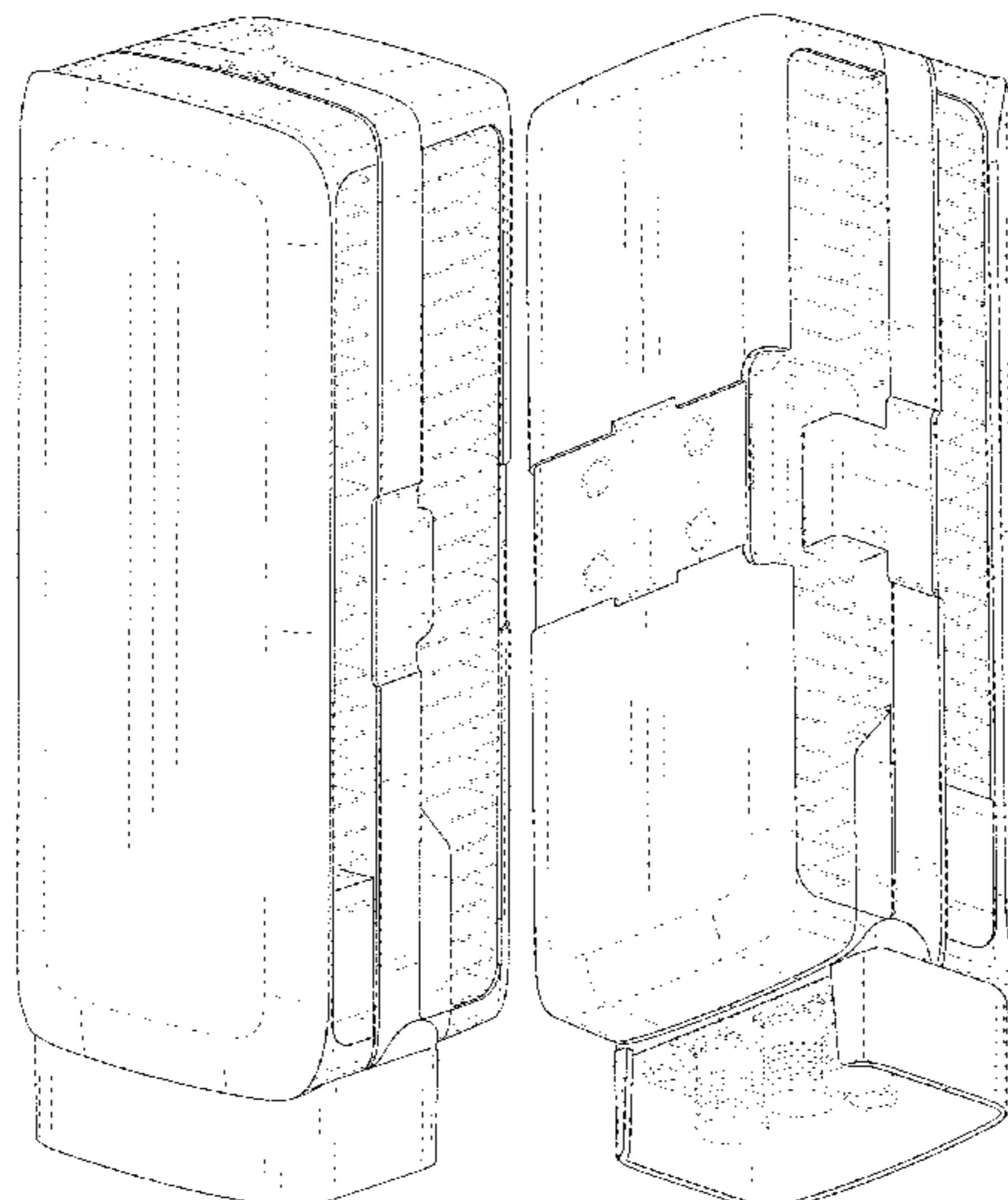
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a router showing my
new design;

FIG. 5 is a right-side view thereof;

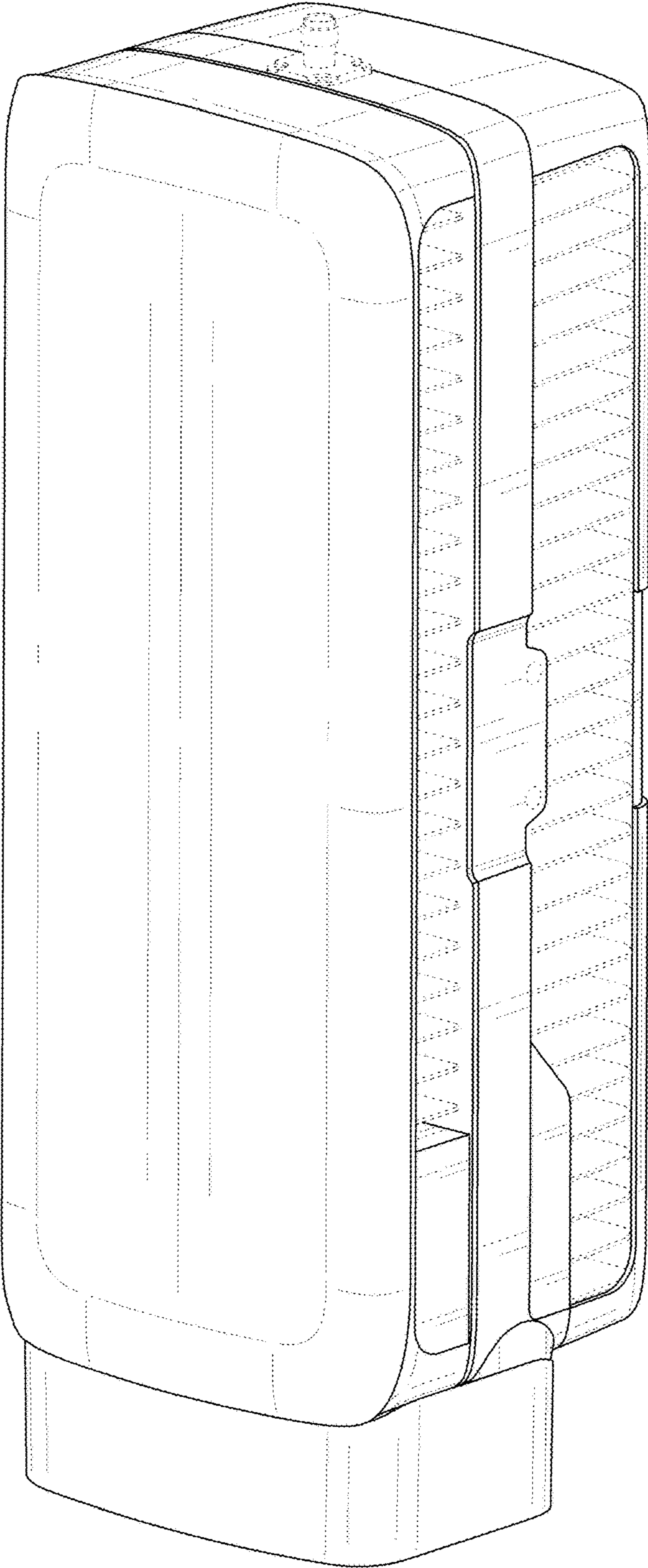

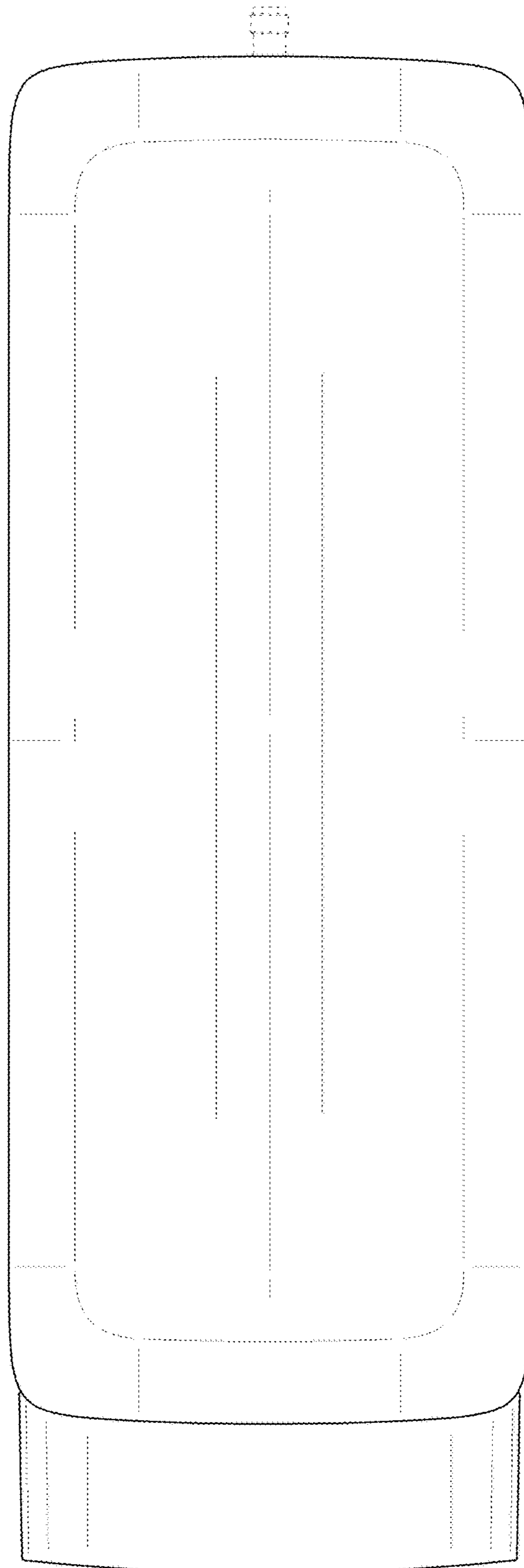

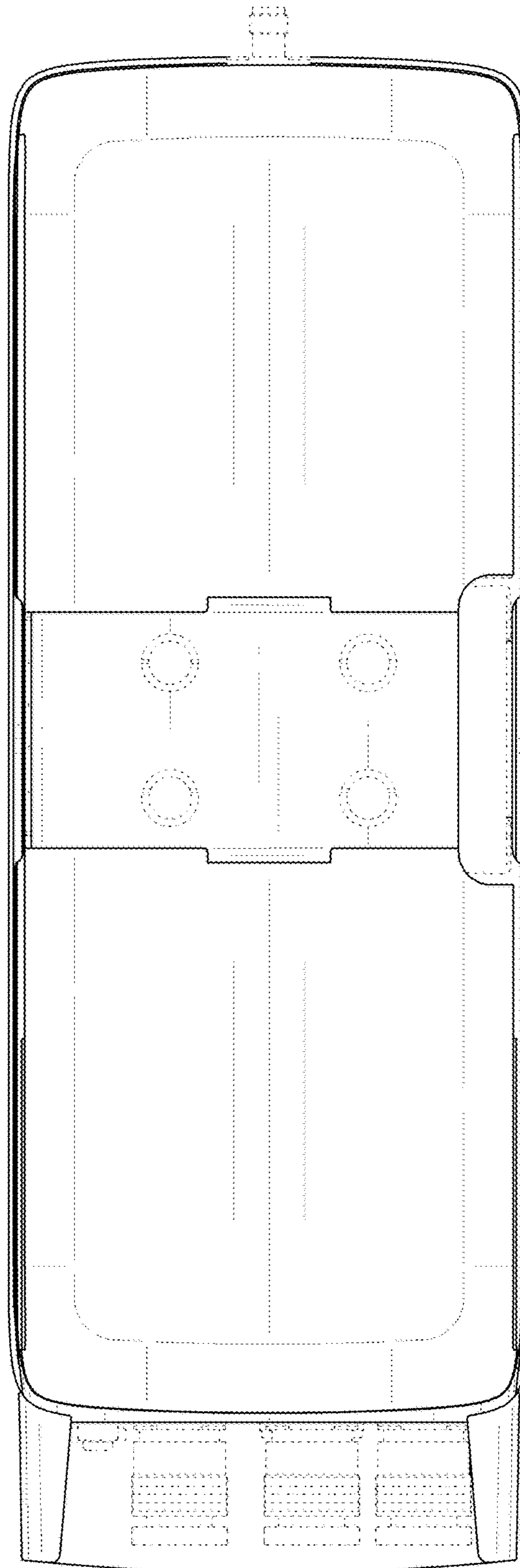

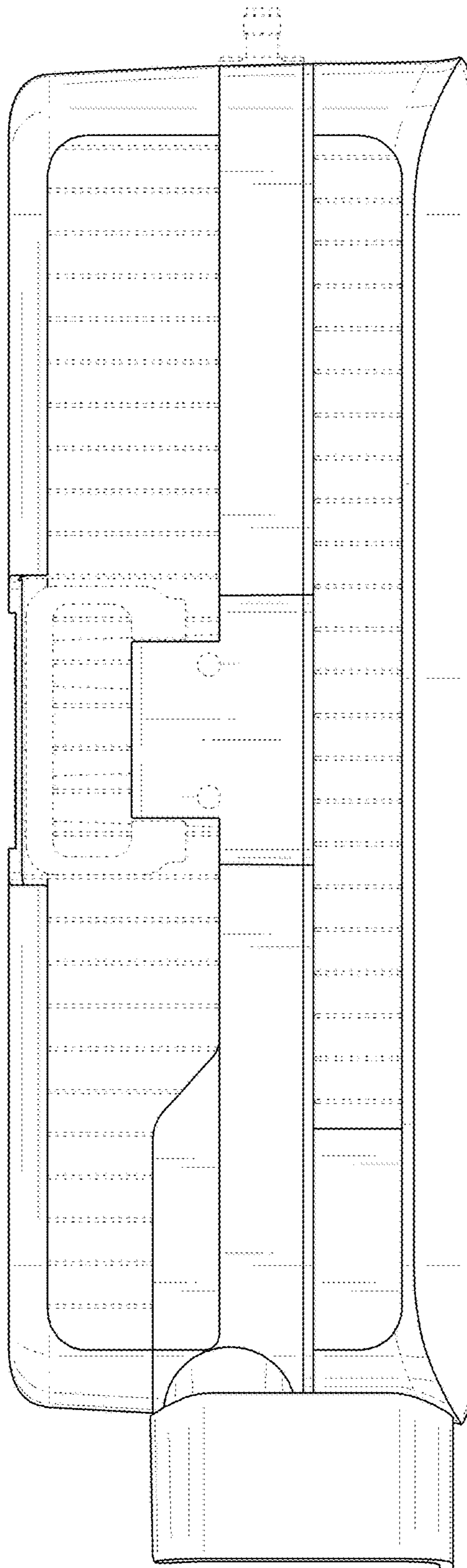

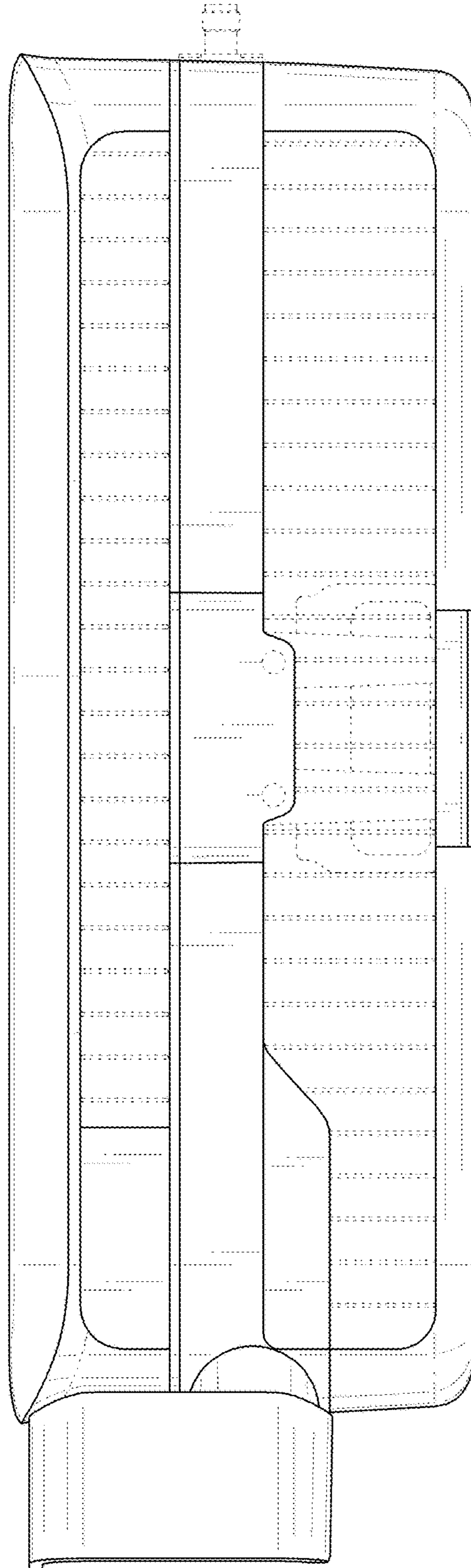

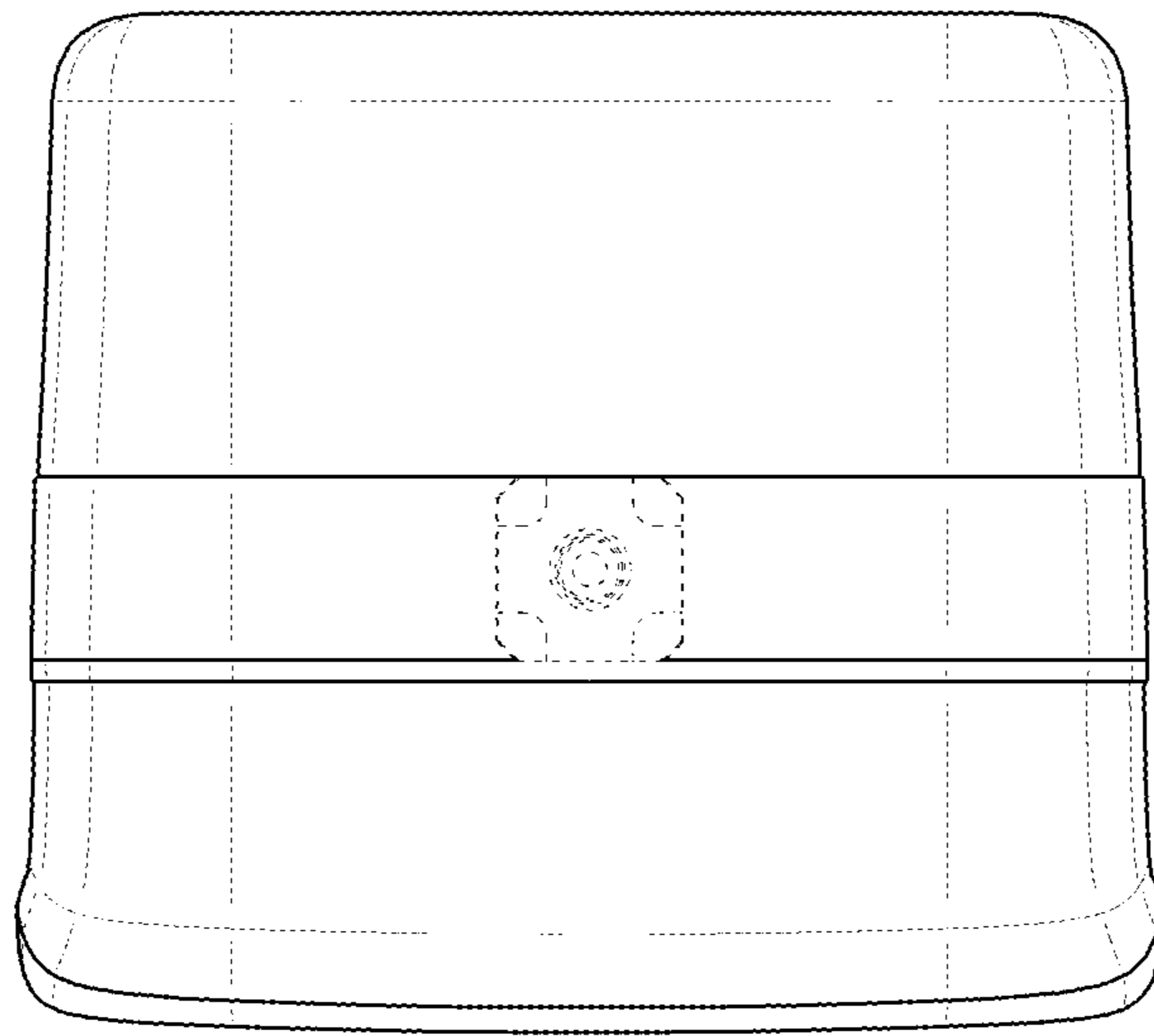

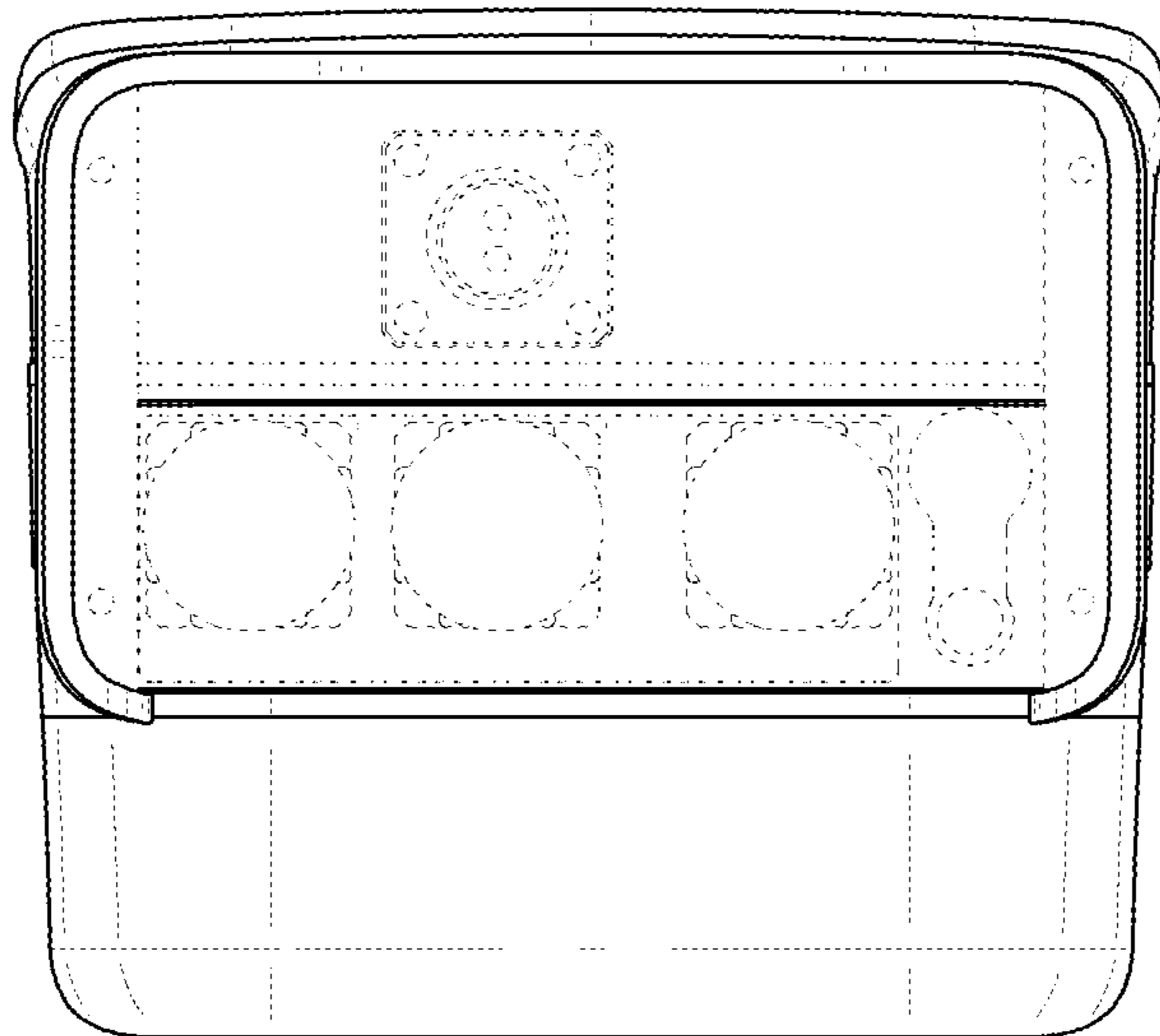
