The ornamental design for a gaming mouse, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right-side perspective view of a gaming mouse of the inventive subject matter.

FIG. 5 is a right-side view of the same.

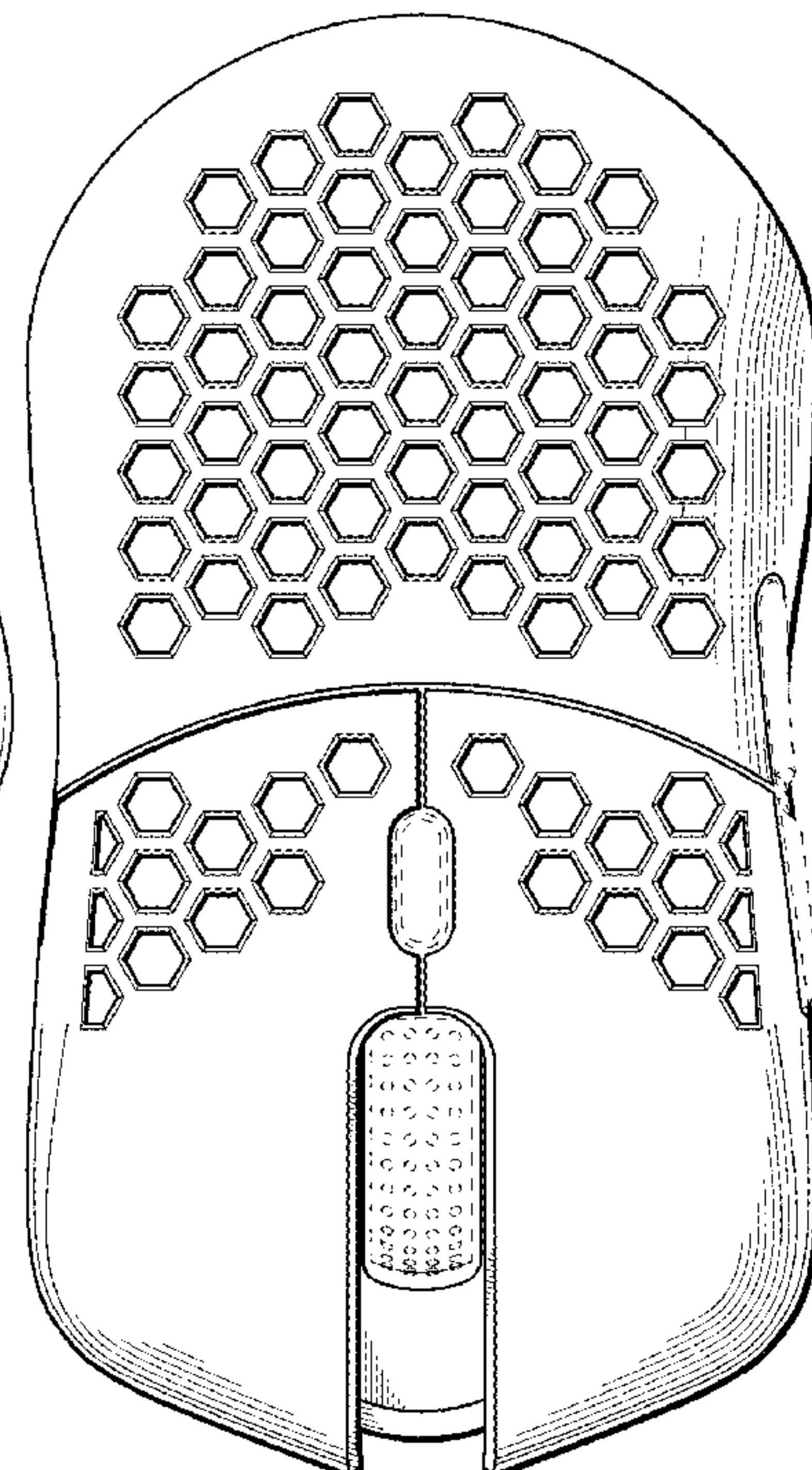
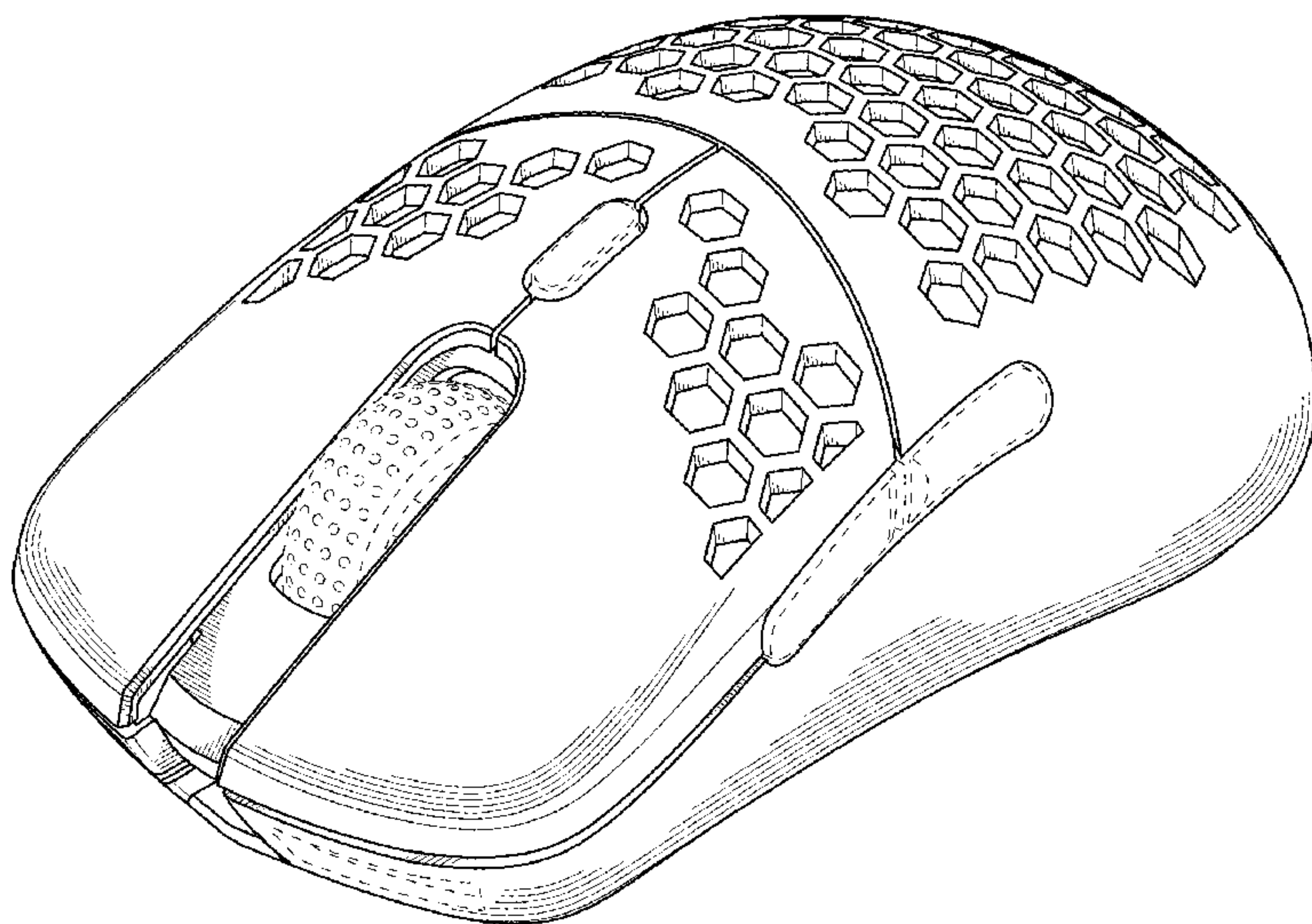
FIG. 6 is a left-side view of the same.

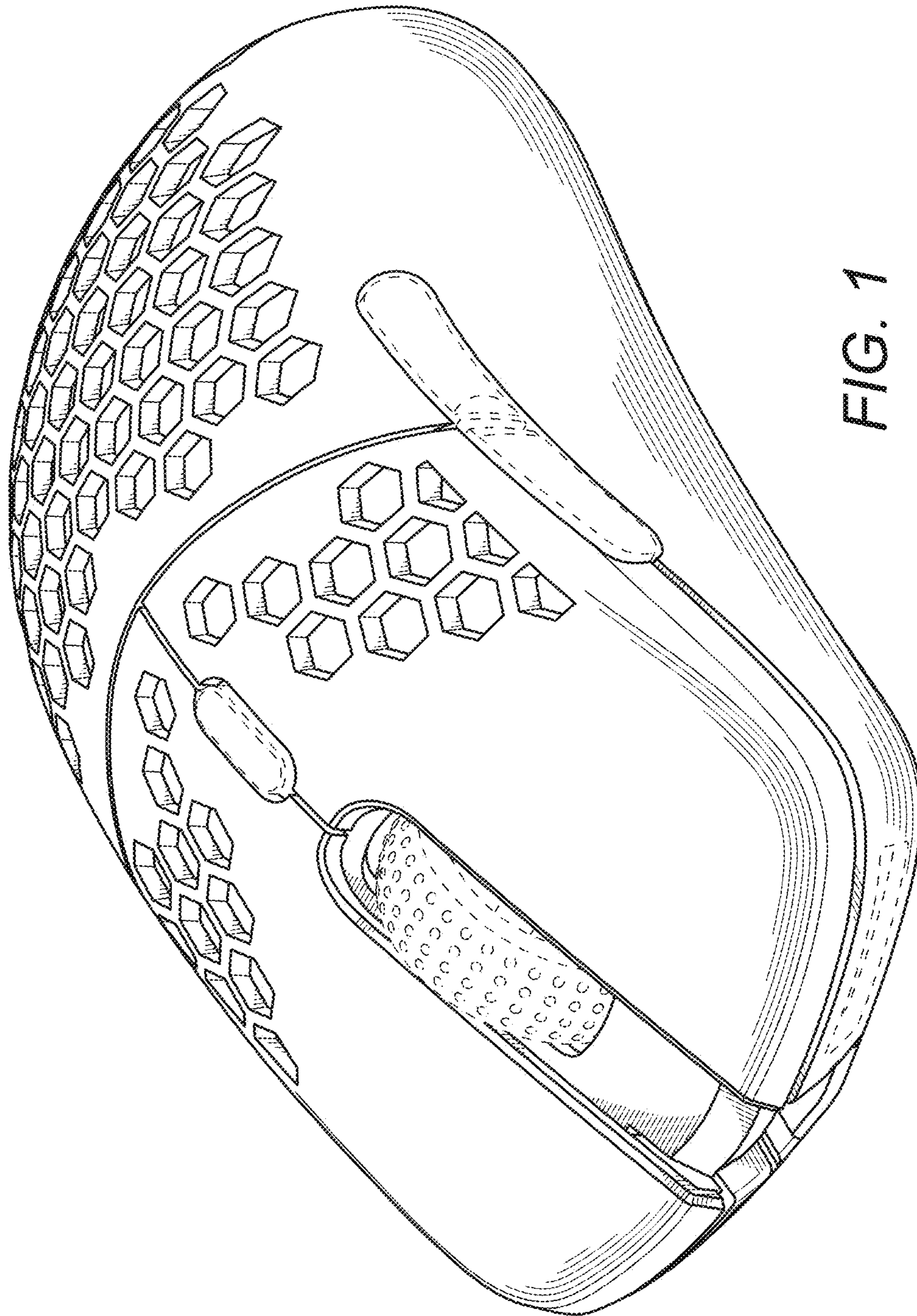

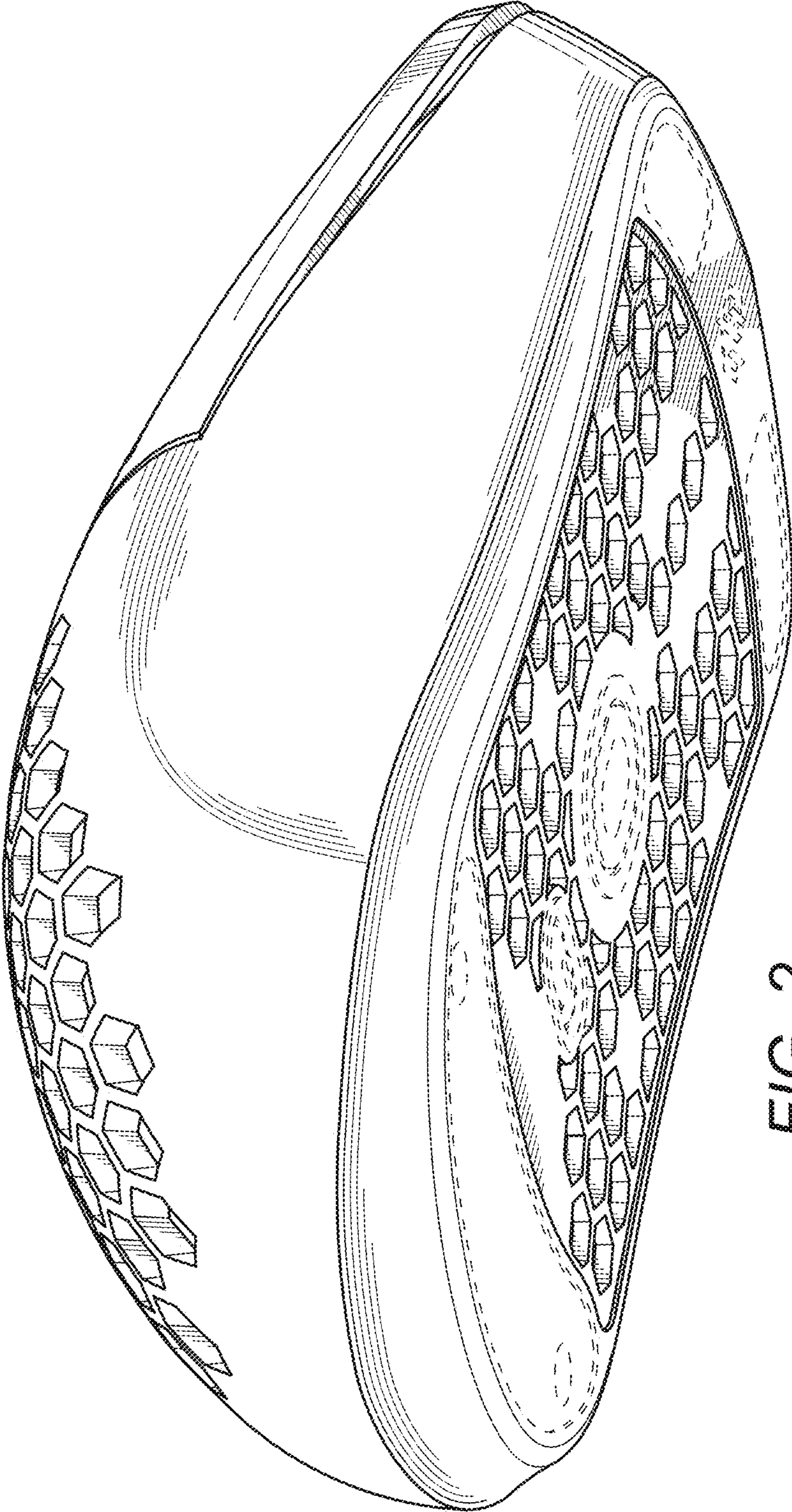

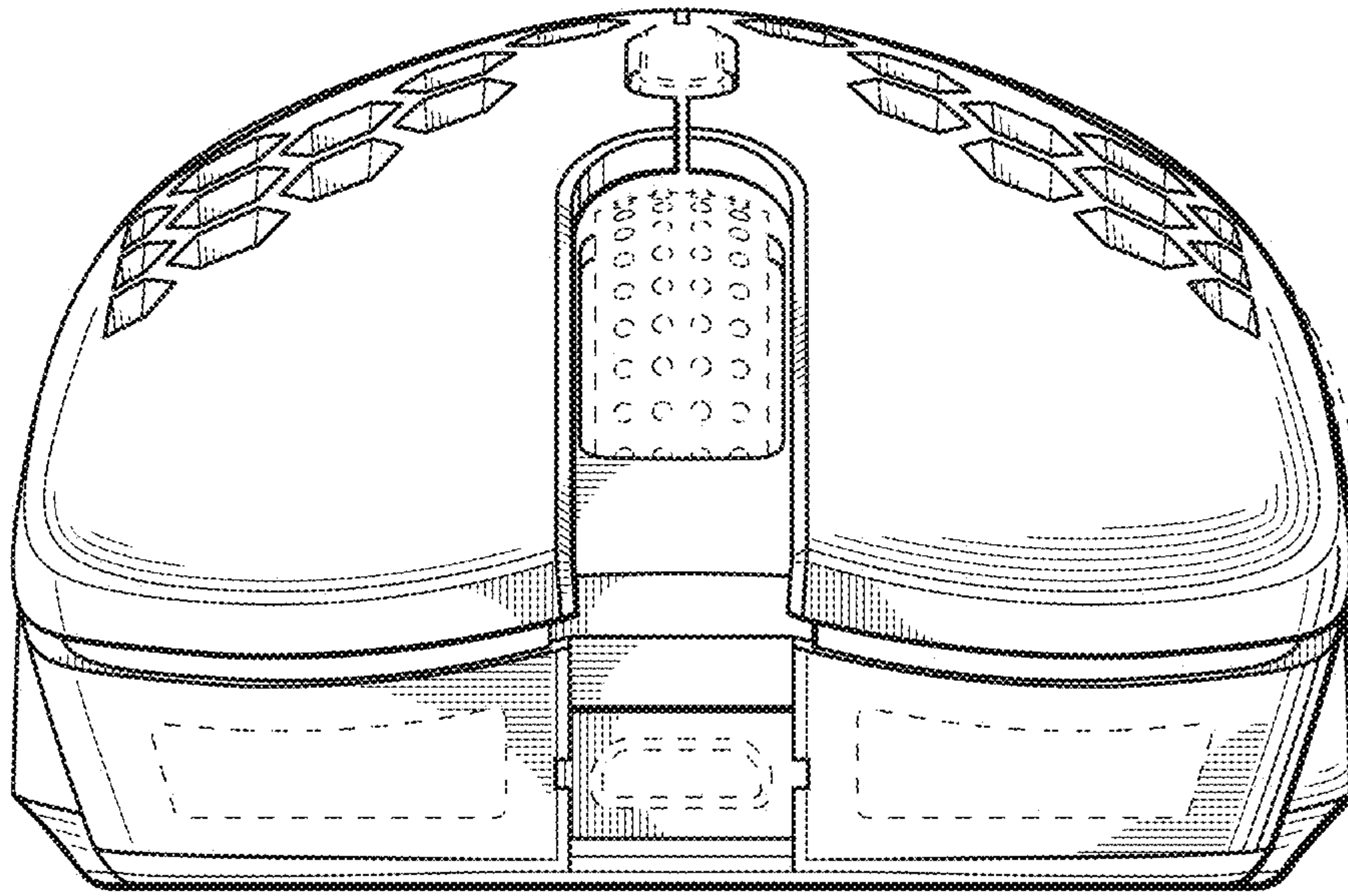

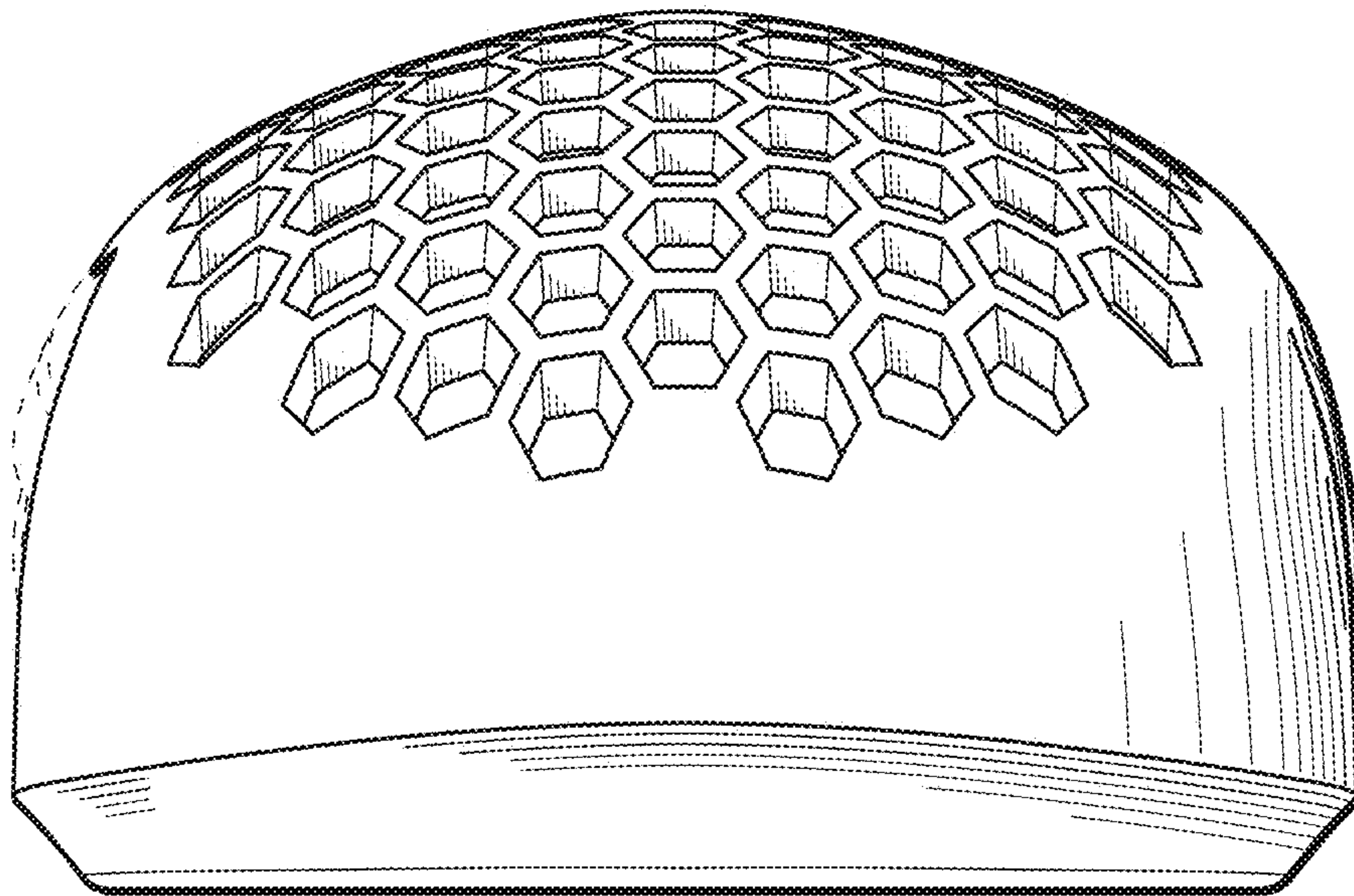

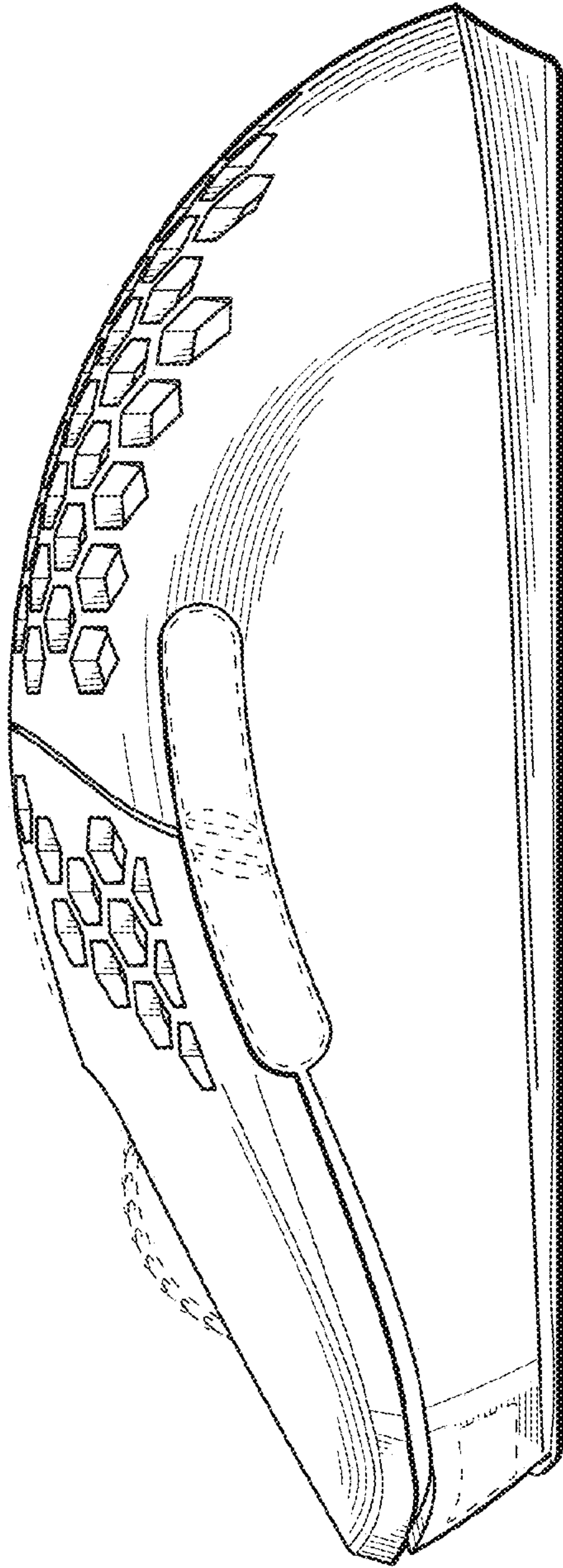

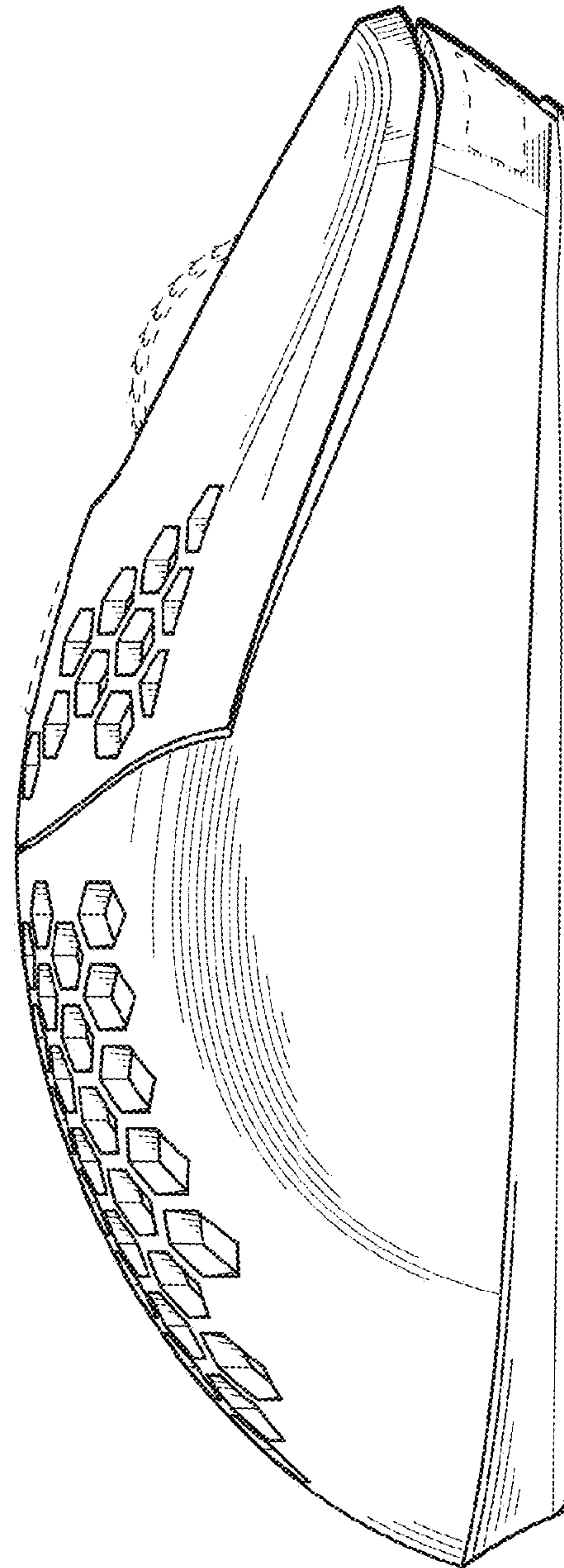

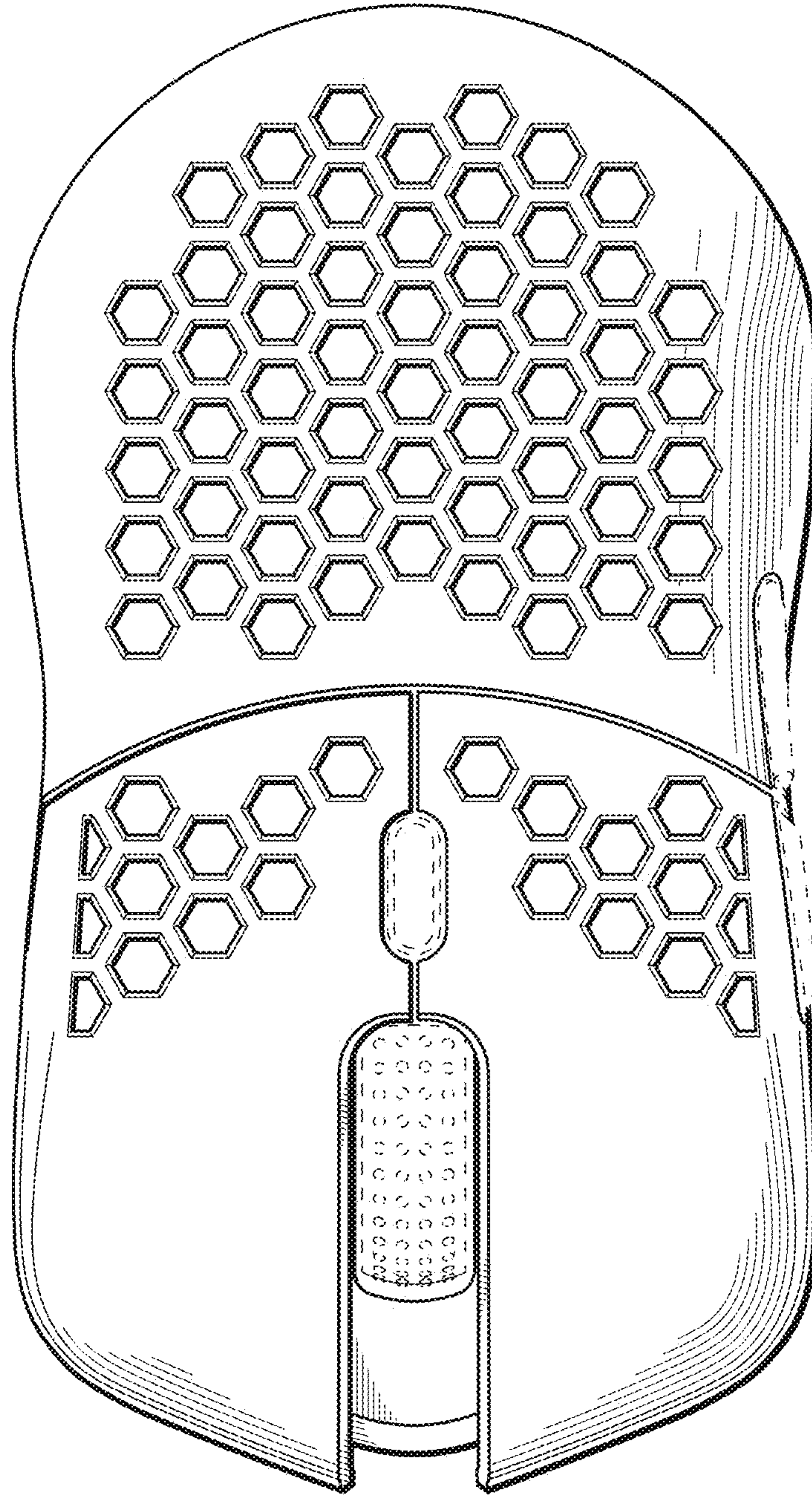

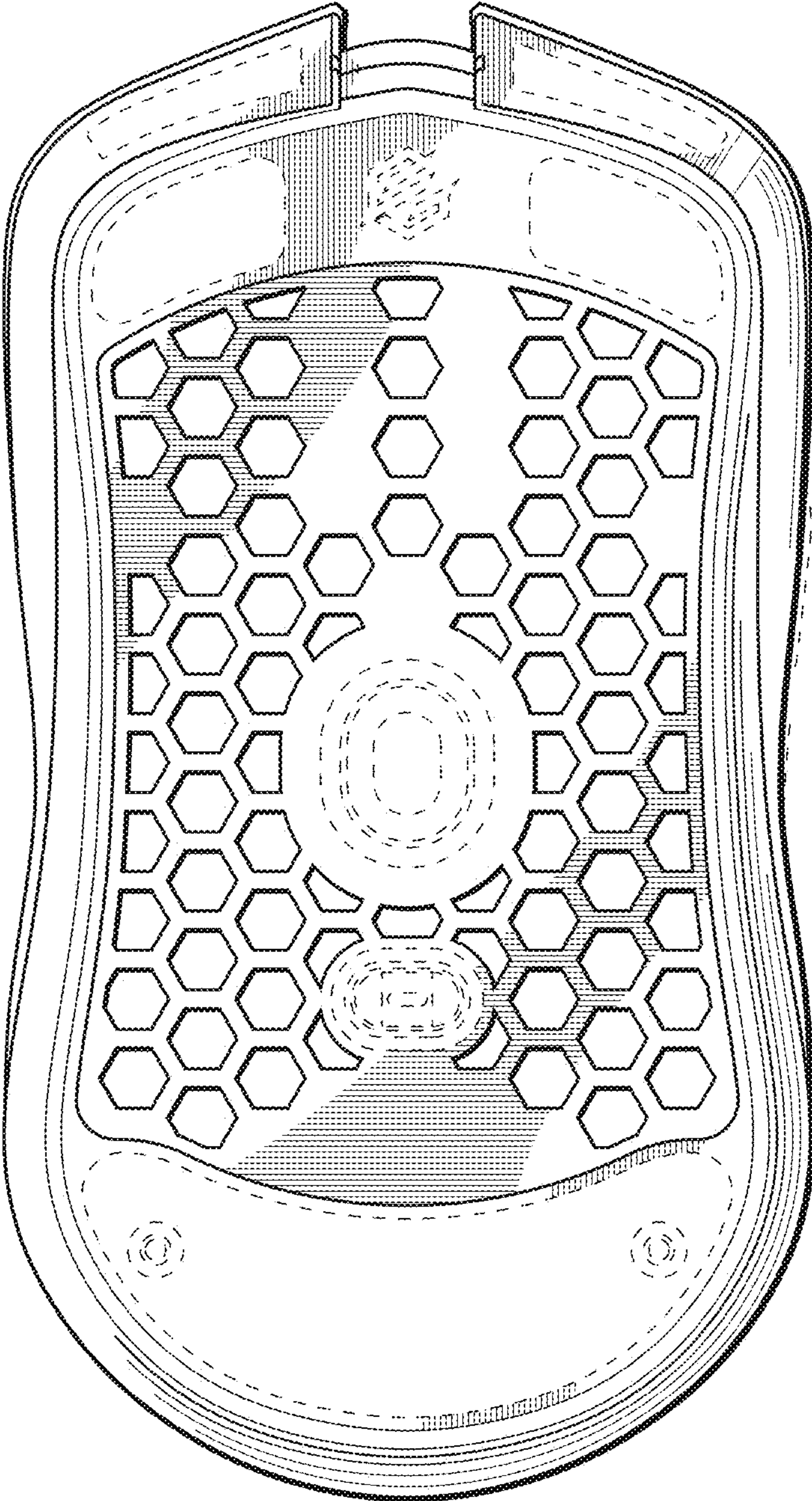
