DESCRIPTION

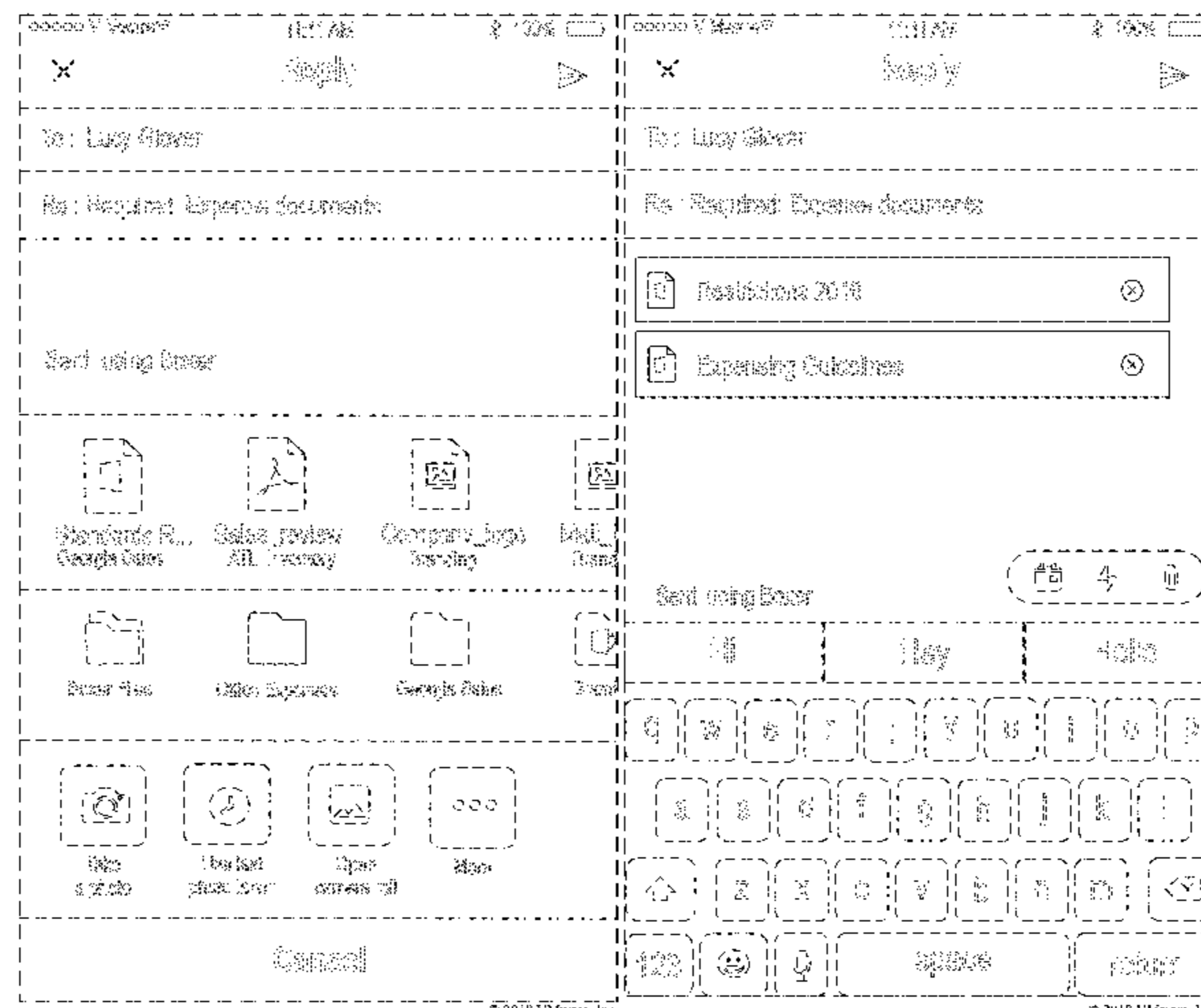

FIG. 1 is a first image in a first embodiment of a sequence depicting a display screen, or portion thereof, having a transitional graphical user interface showing the new design; FIG. 2 is a second image thereof; FIG. 3 is a third image thereof; FIG. 4 is a fourth image thereof; FIG. 5 is a fifth image thereof; FIG. 6 is a sixth image thereof; FIG. 7 is a first image in a second embodiment of a sequence depicting a display screen, or portion thereof, having a transitional graphical user interface showing the new design; FIG. 8 is a second image thereof; FIG. 9 is a third image thereof; FIG. 10 is a fourth image thereof; and, FIG. 11 is a fifth image thereof.

The outermost broken-line rectangle illustrates the perimeter of a display screen, or portion thereof, and forms no part of the claimed design. The remaining broken lines illustrate portions of the graphical user interface that form no part of the claimed design.

The appearance of the transitional graphical user interface sequentially transitions between the images shown in FIGS. 1-6 in the first embodiment, and FIGS. 7-11 in the second embodiment. The process or period in which one image transitions to another image forms no part of the claimed design.

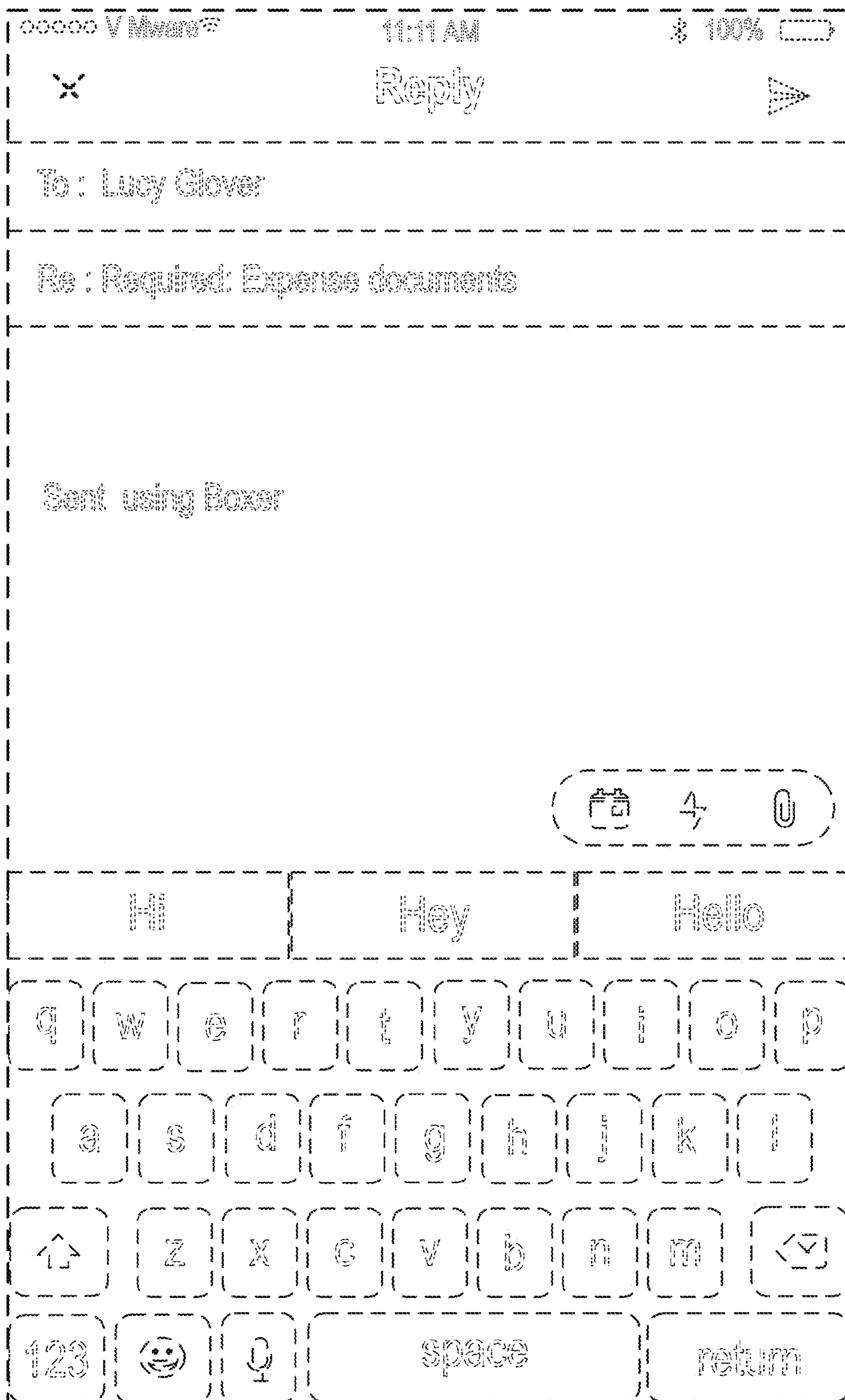

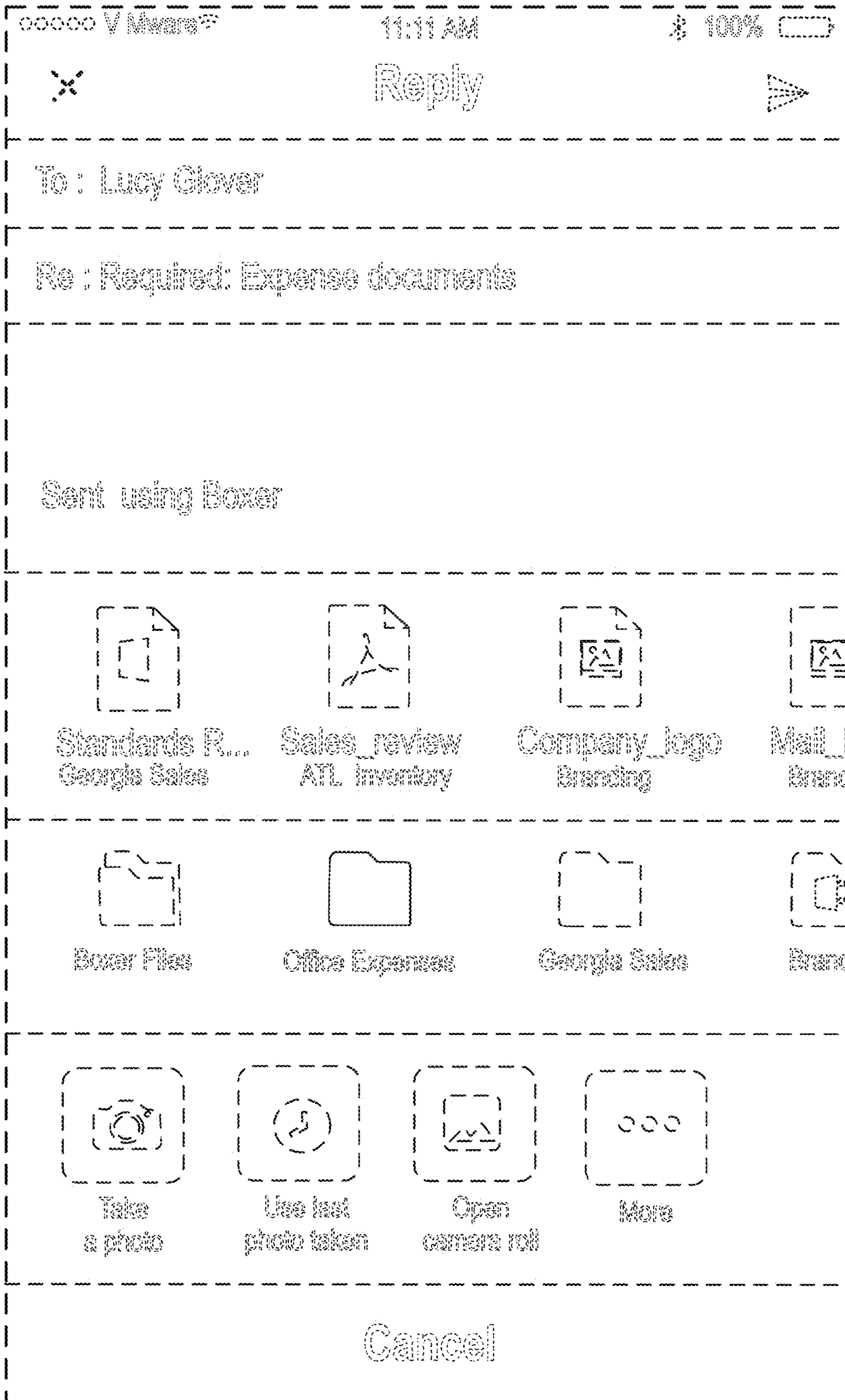

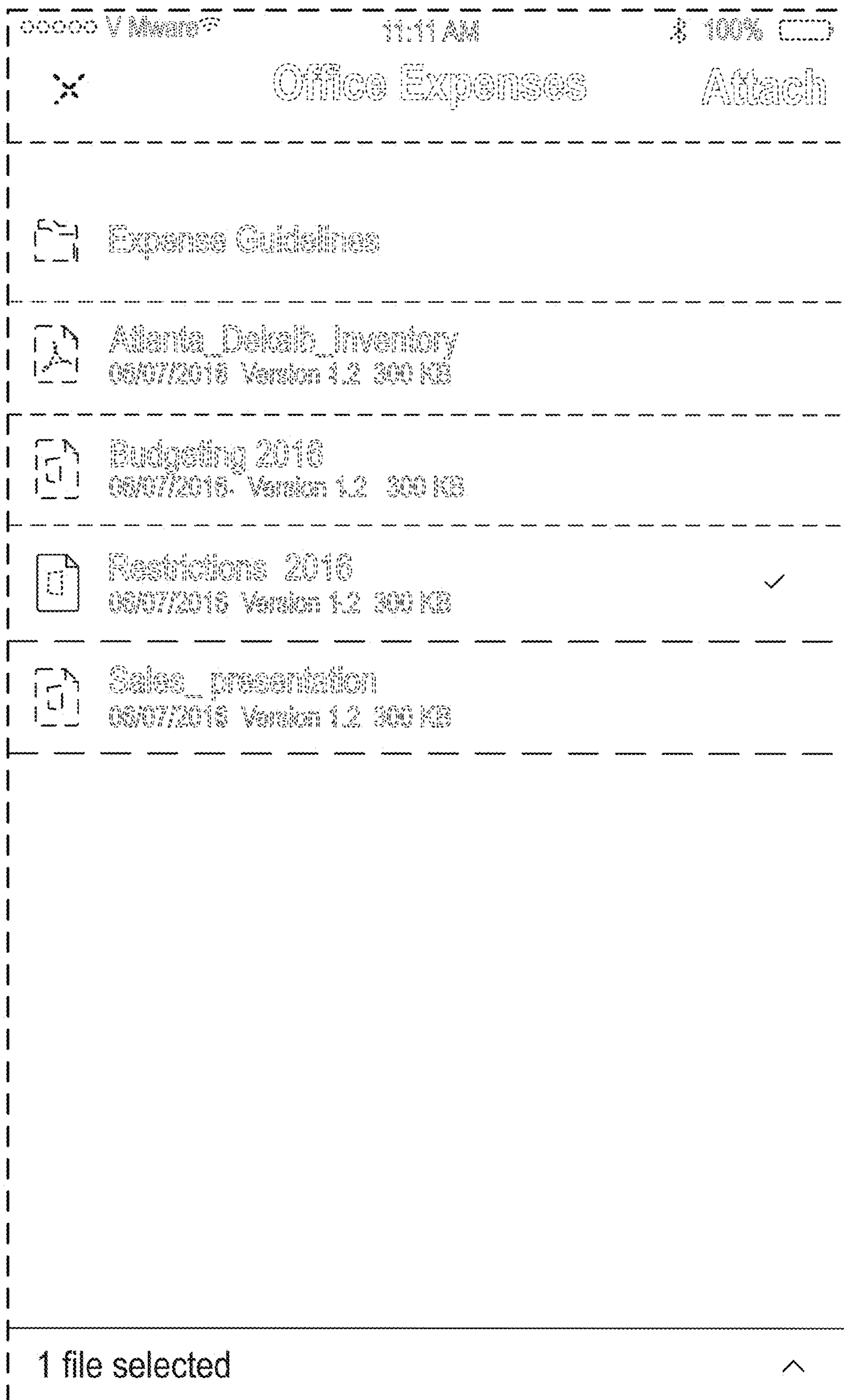

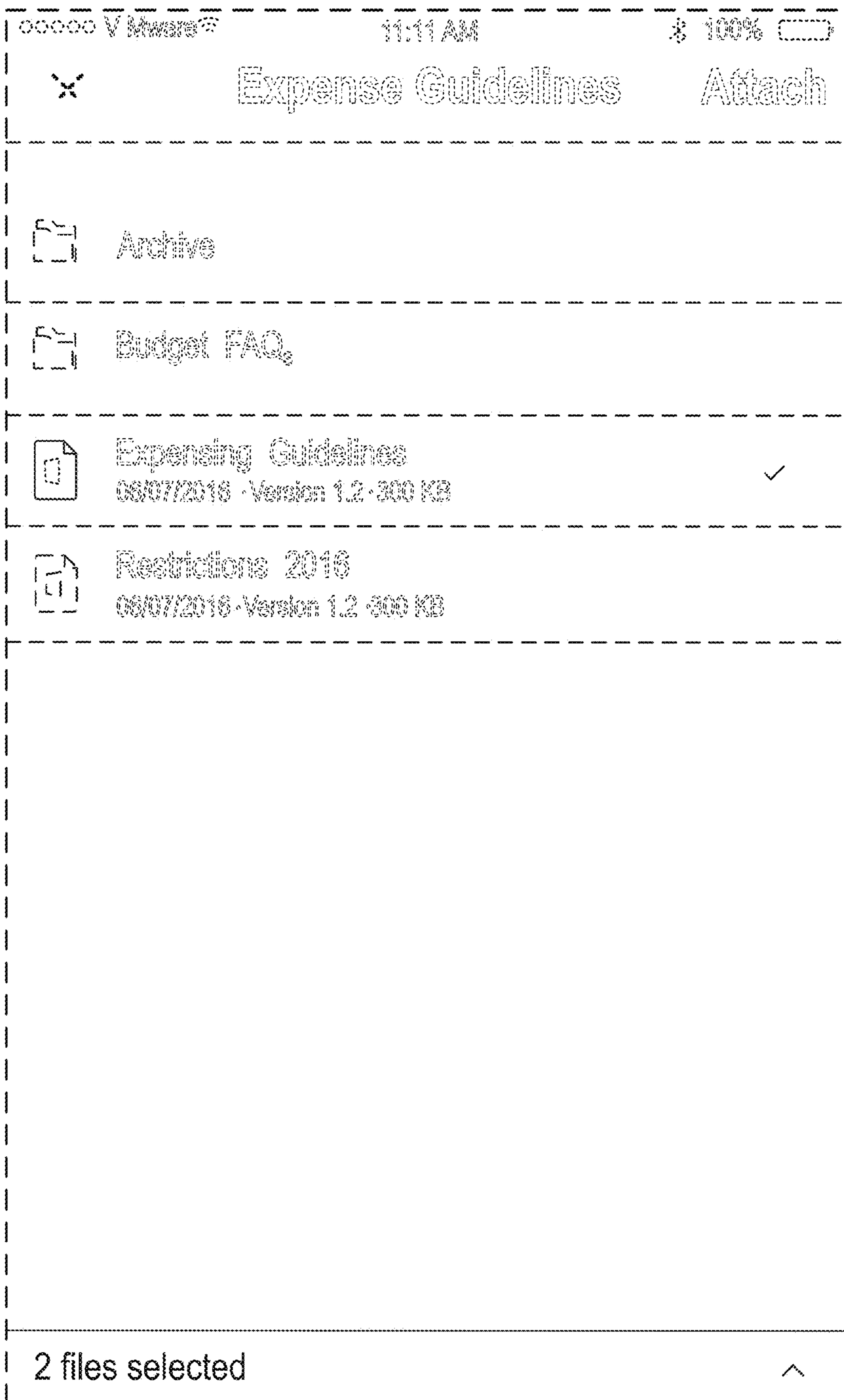

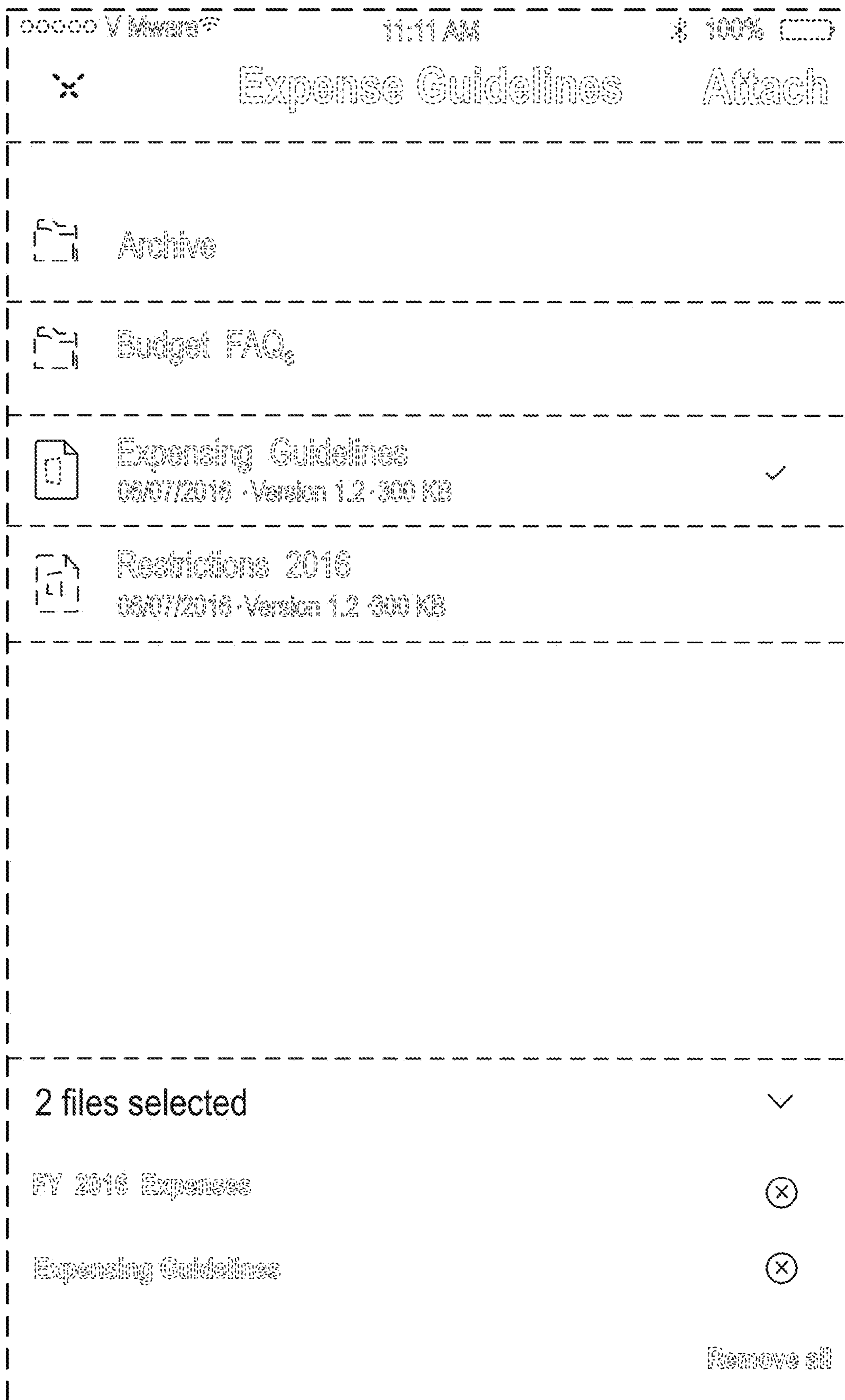

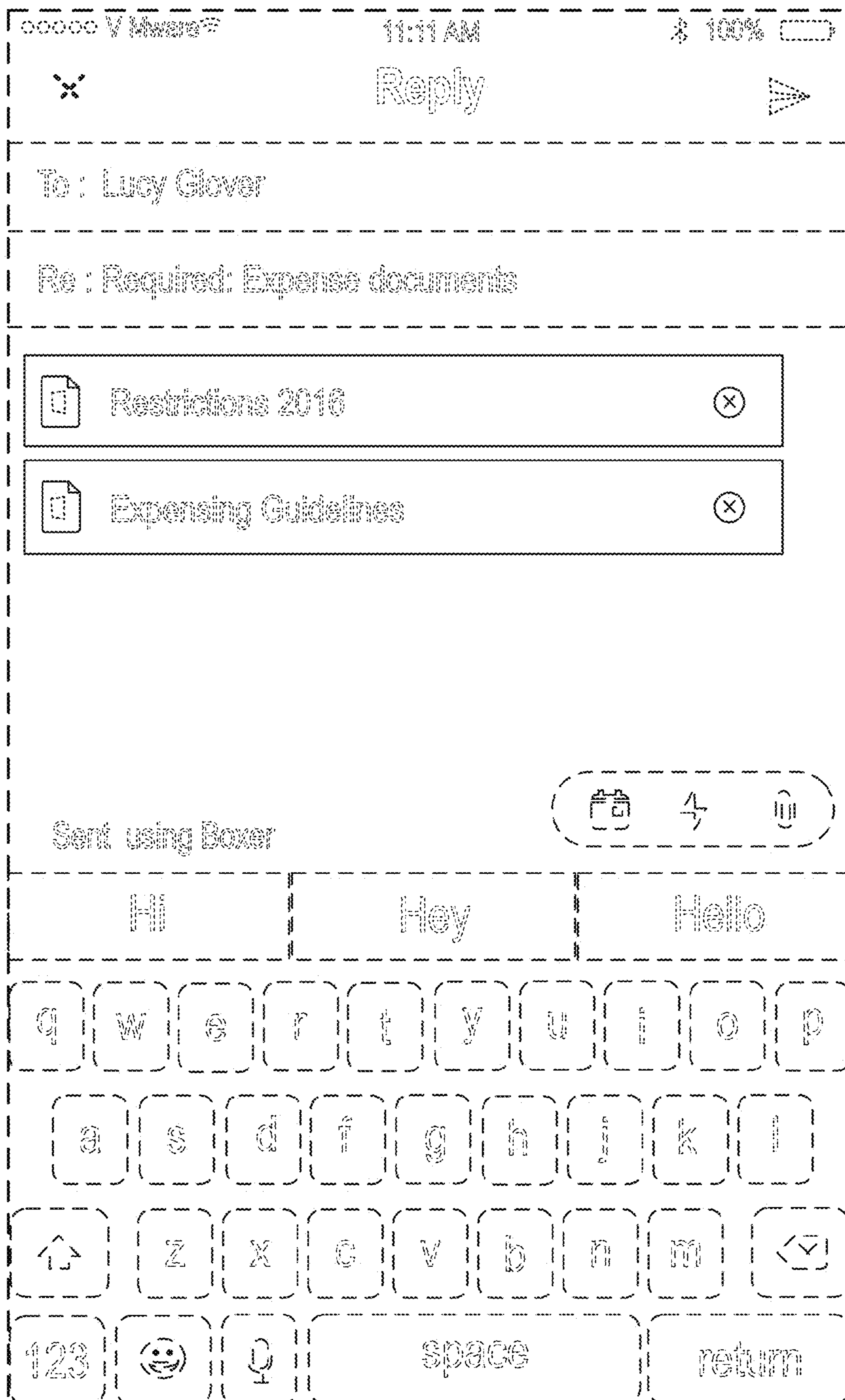

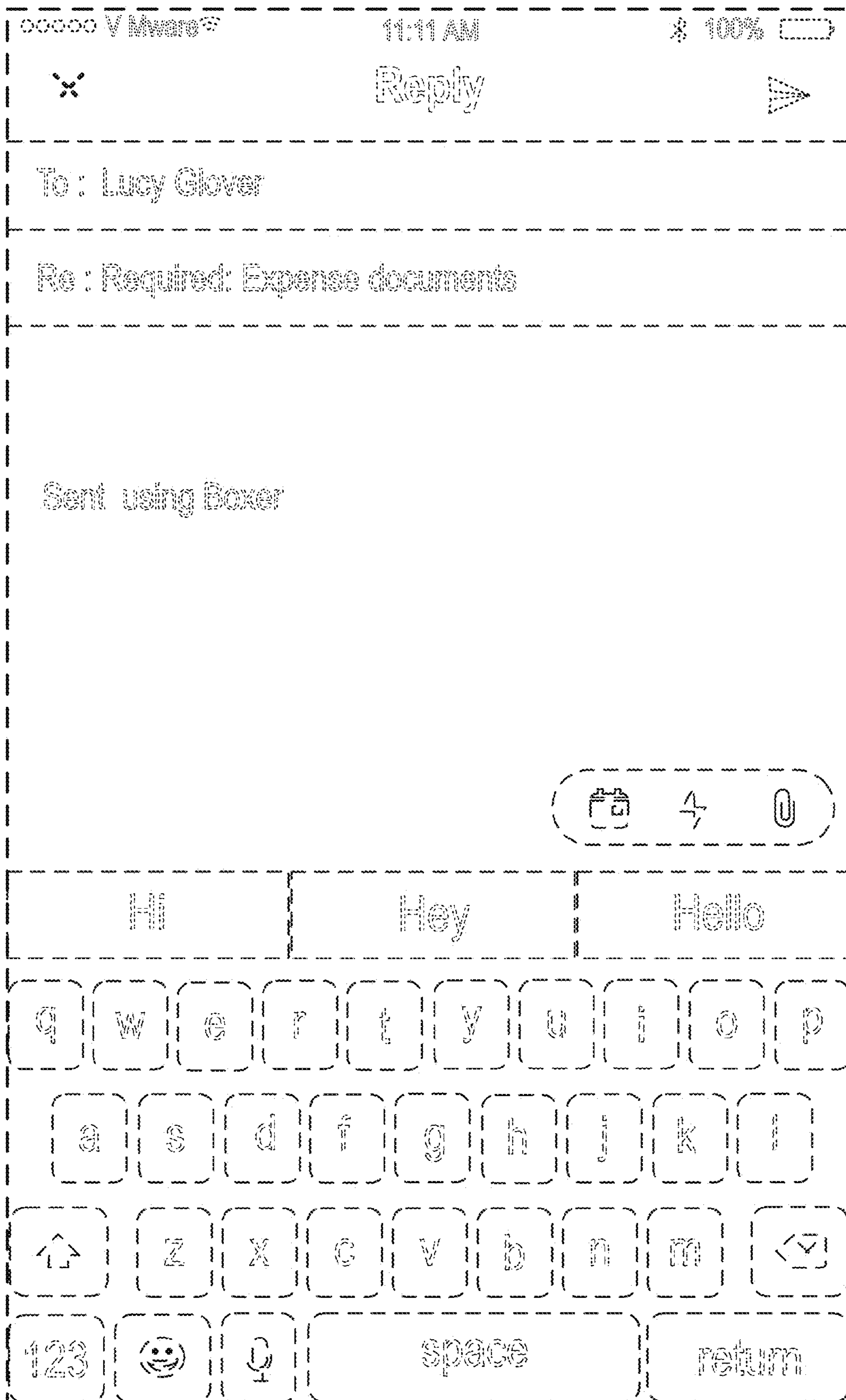

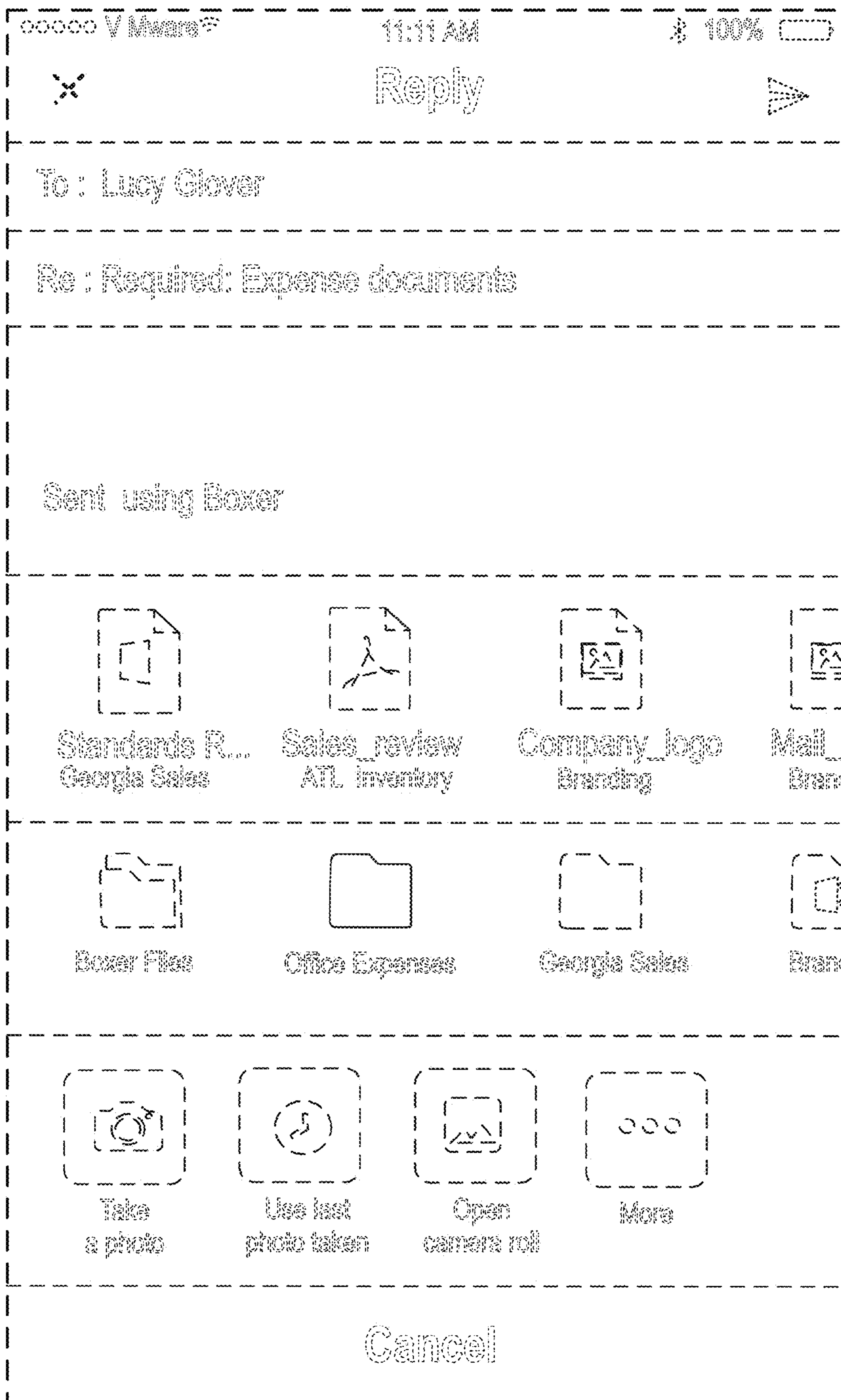

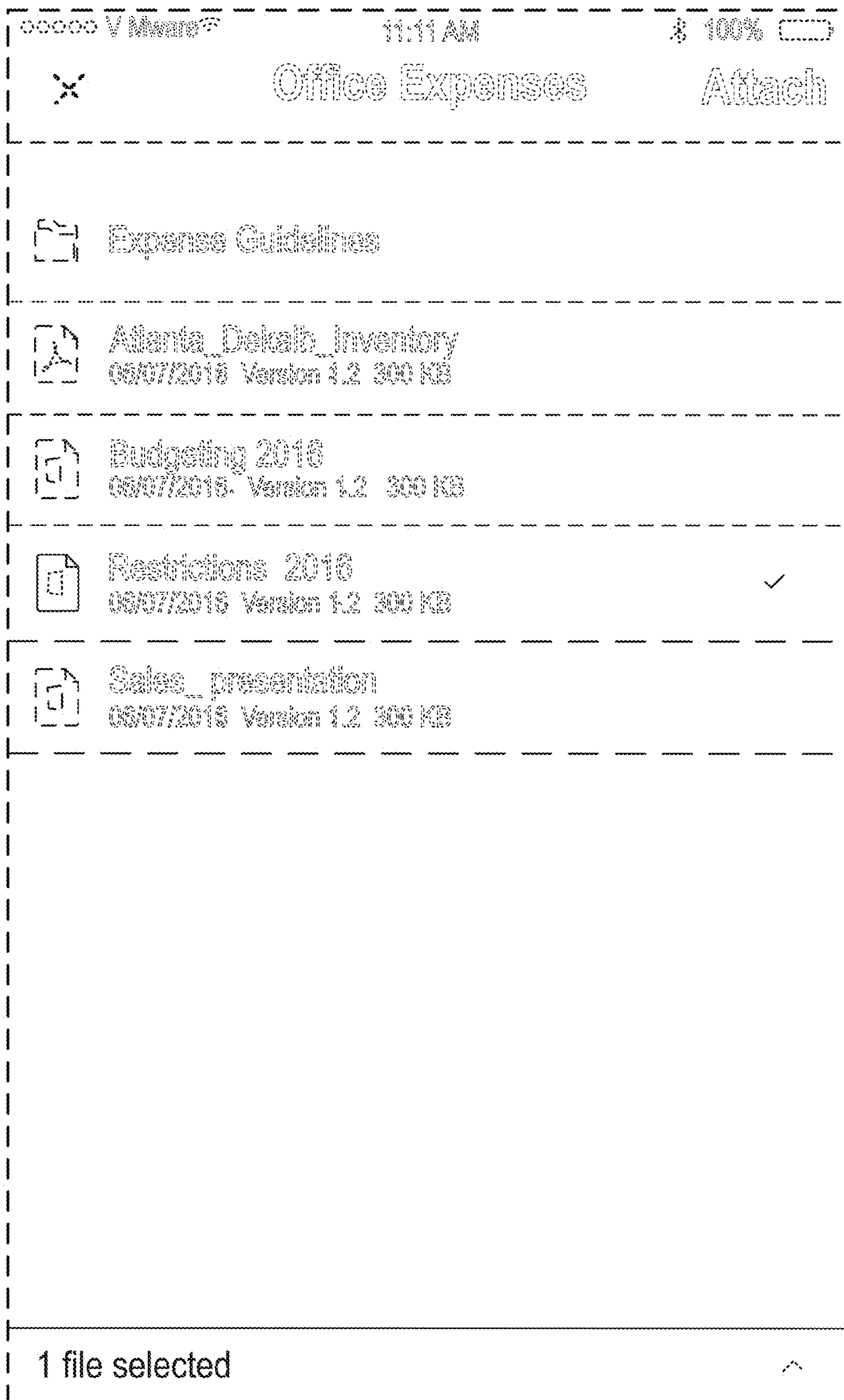

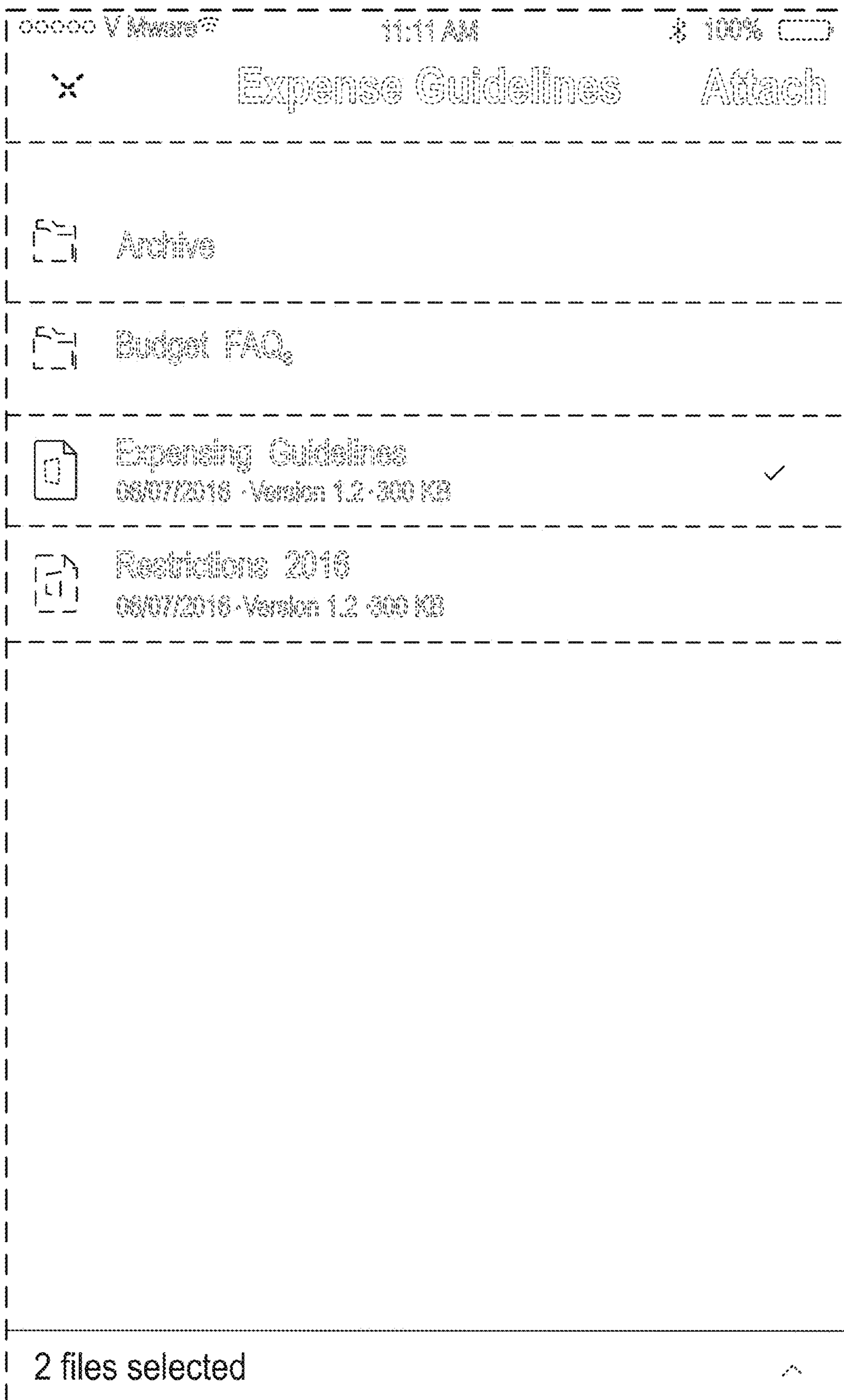

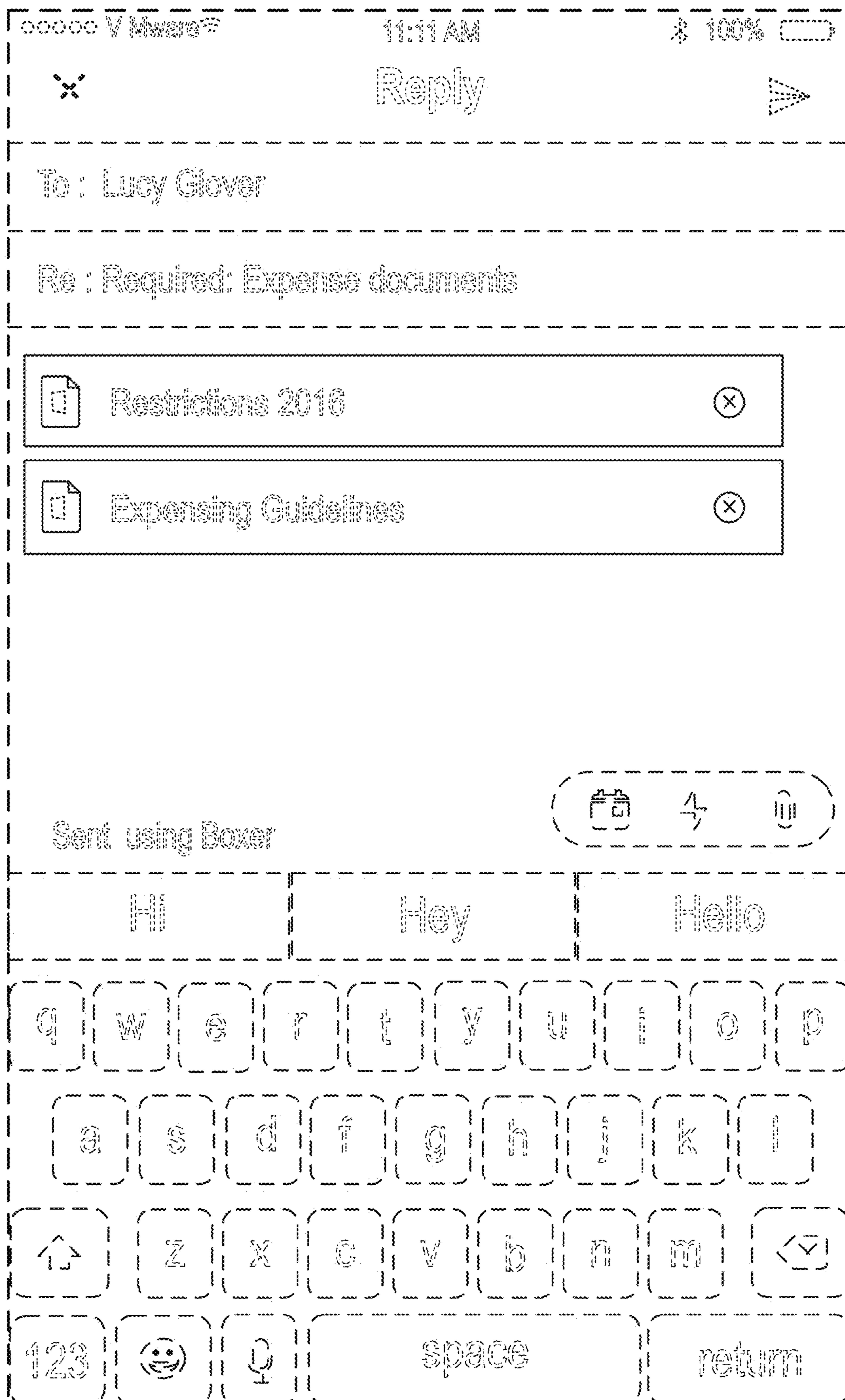
