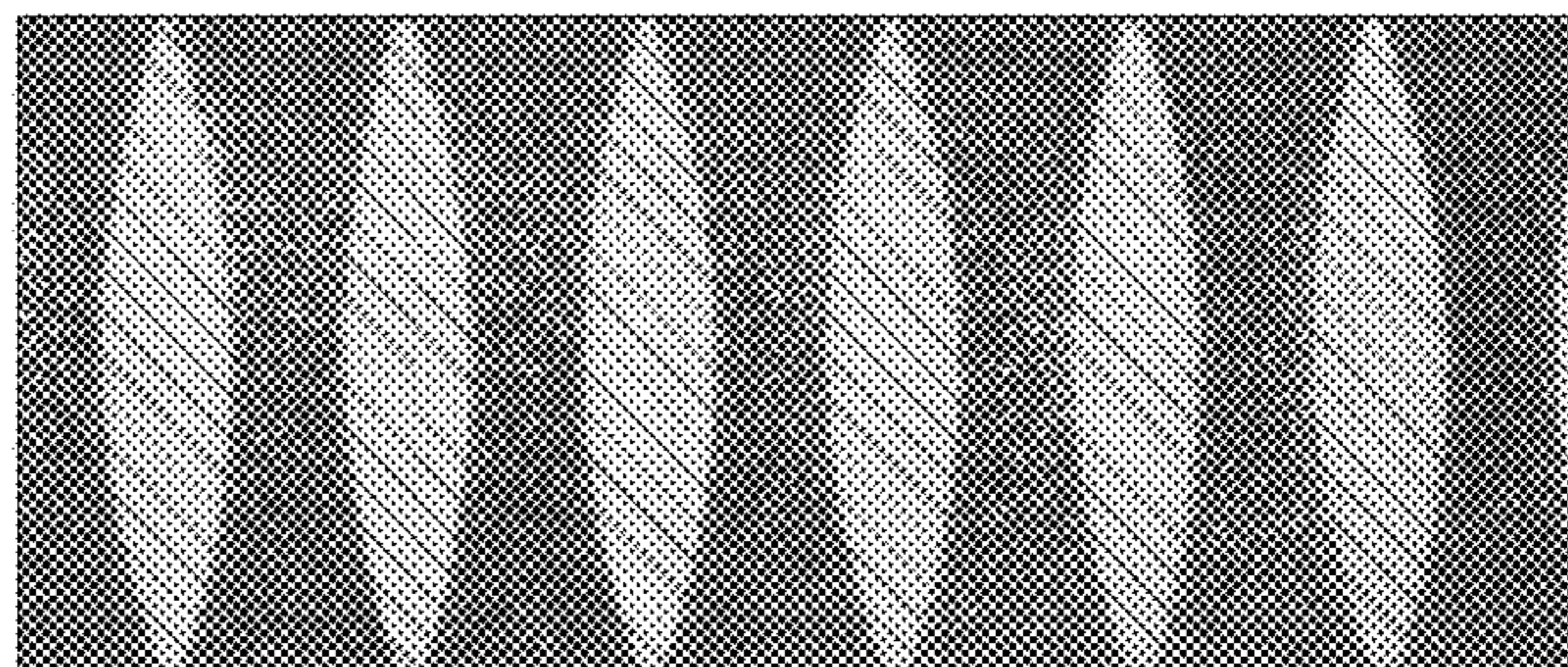
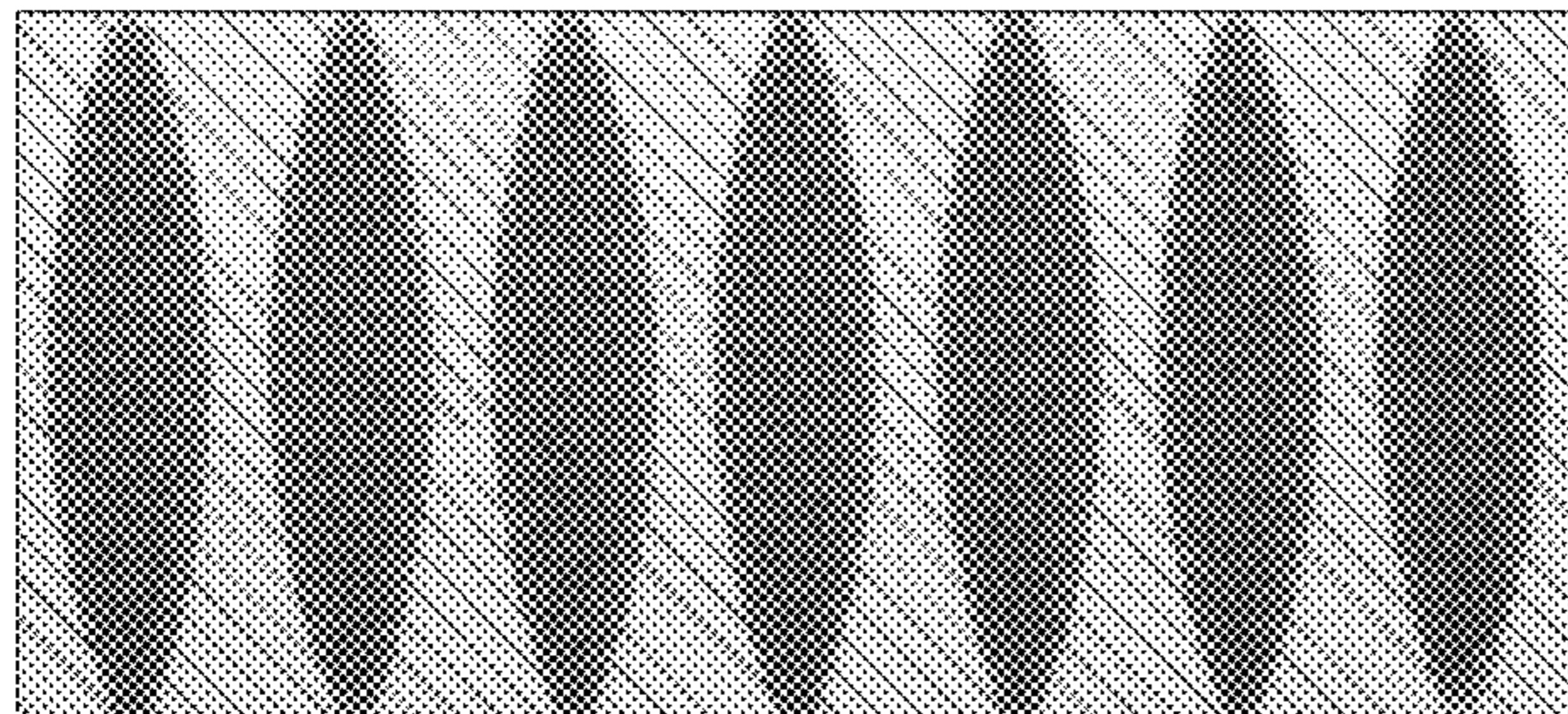
(57) **CLAIM**

The ornamental design for an abrasive strip, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of the abrasive strip;  
FIG. 2 is a rear elevation view of the abrasive strip of FIG. 1;  
FIG. 3 is a side view of the abrasive strip of FIG. 1;  
FIG. 4 is a front elevation view of an alternative embodiment of the abrasive strip;  
FIG. 5 is a rear elevation view of the abrasive strip of FIG. 4;  
FIG. 6 is a side view of the abrasive strip of FIG. 4;  
FIG. 7 is a front elevation view of another alternative embodiment of the abrasive strip;  
FIG. 8 is a rear elevation view of the abrasive strip of FIG. 7;  
FIG. 9 is a front elevation view of yet another alternative embodiment of the abrasive strip; and,  
FIG. 10 is a rear elevation view of the abrasive strip of FIG. 9.  
The broken lines in the abrasive strip depict the periphery boundaries. The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

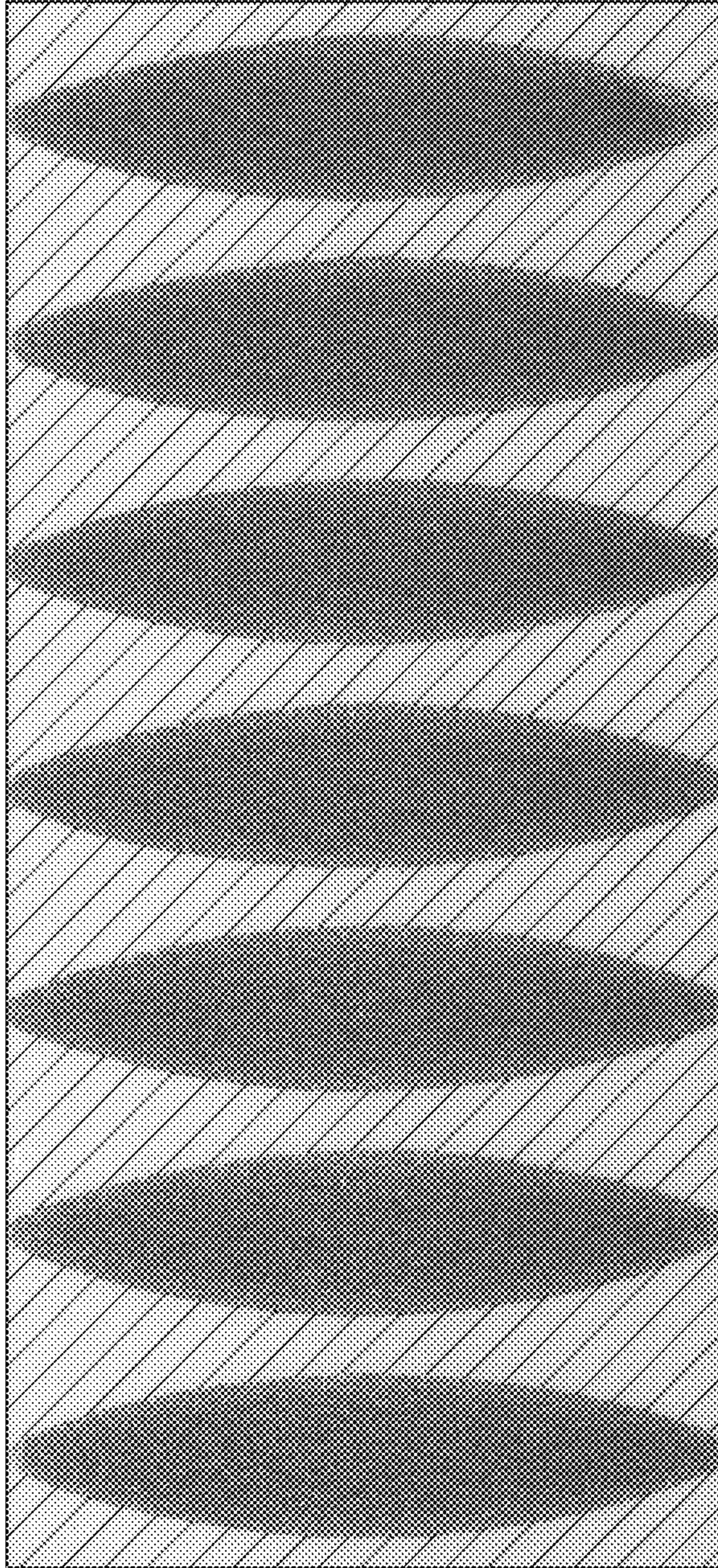

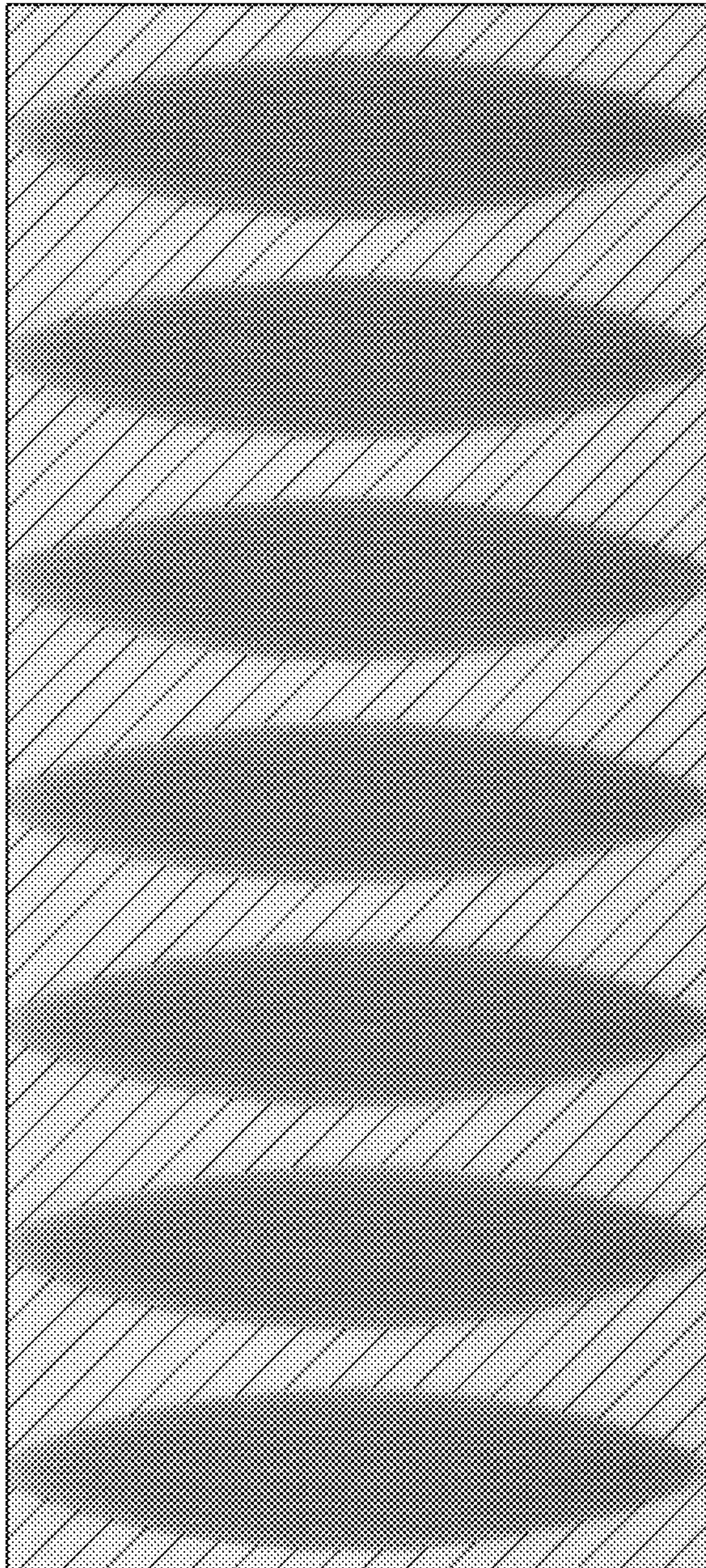

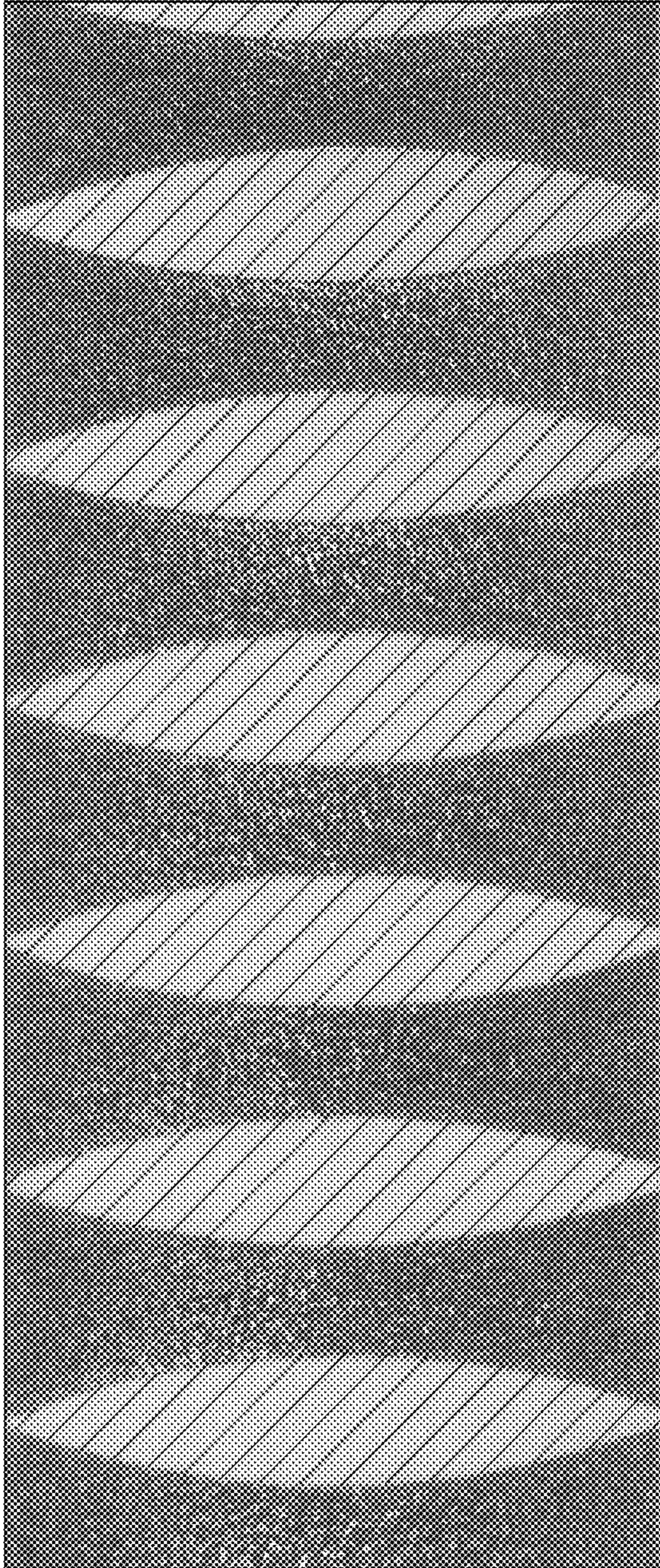

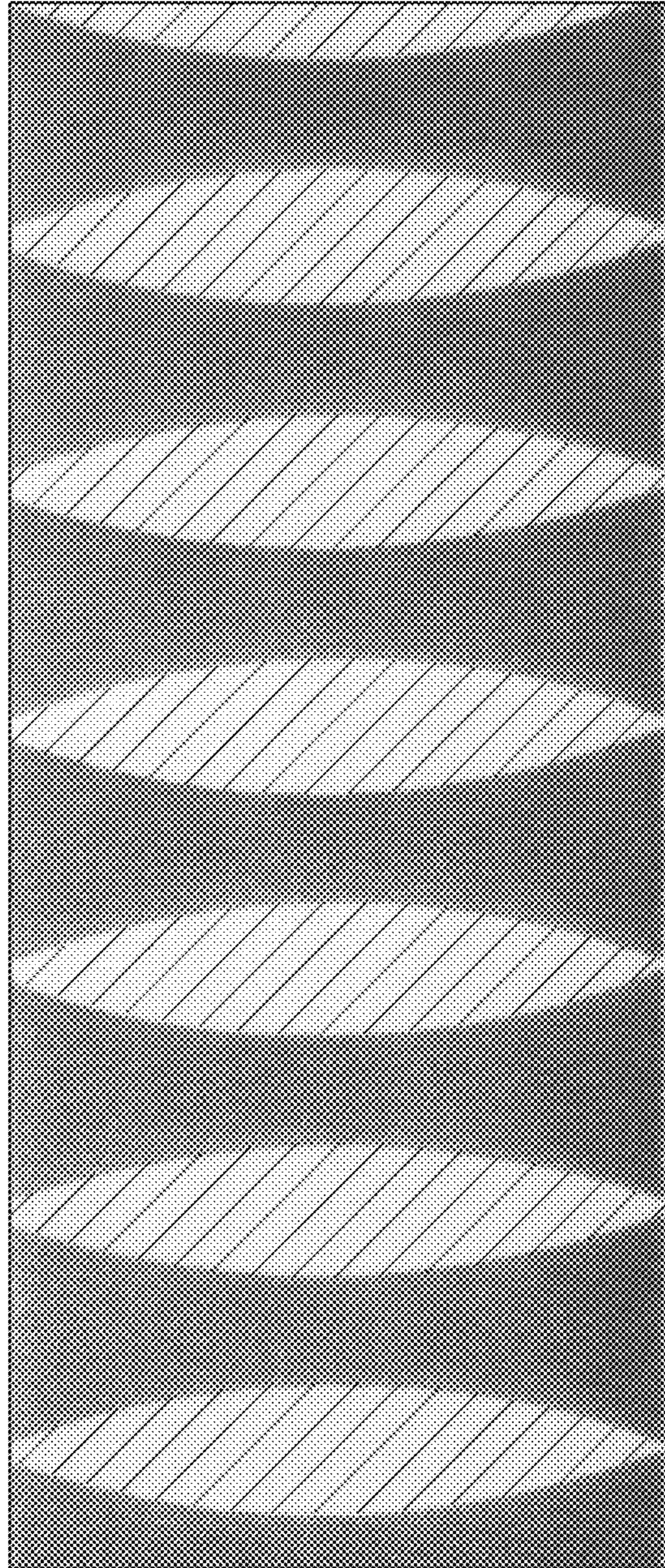

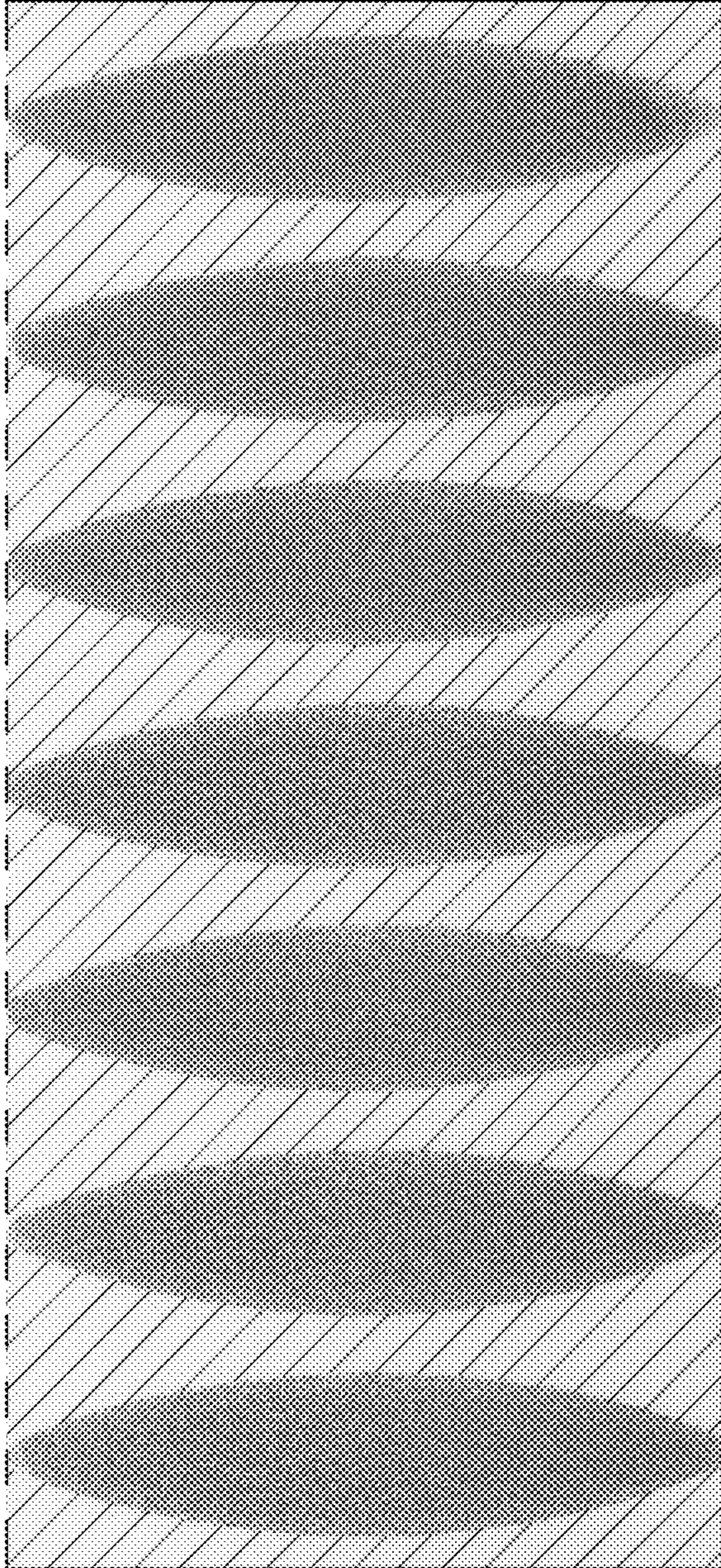

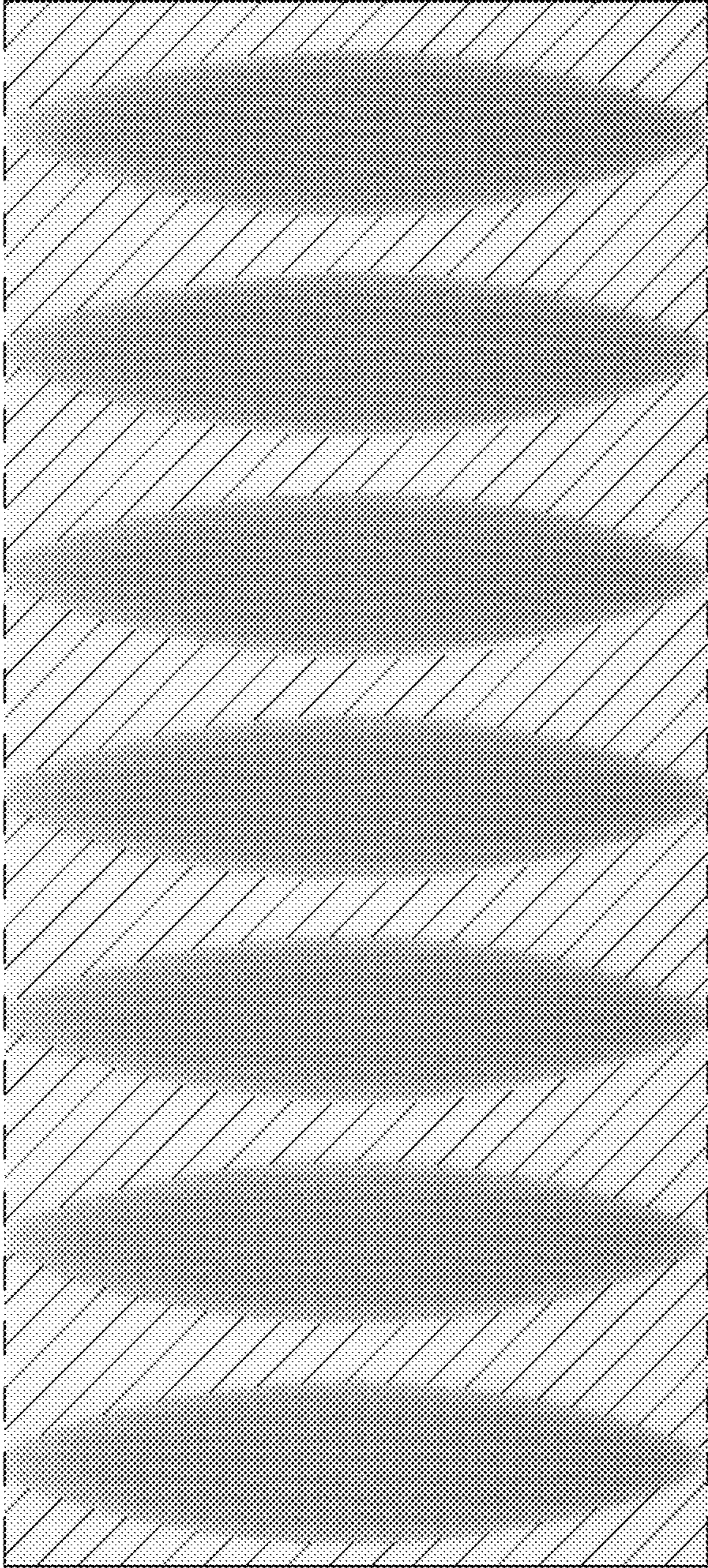

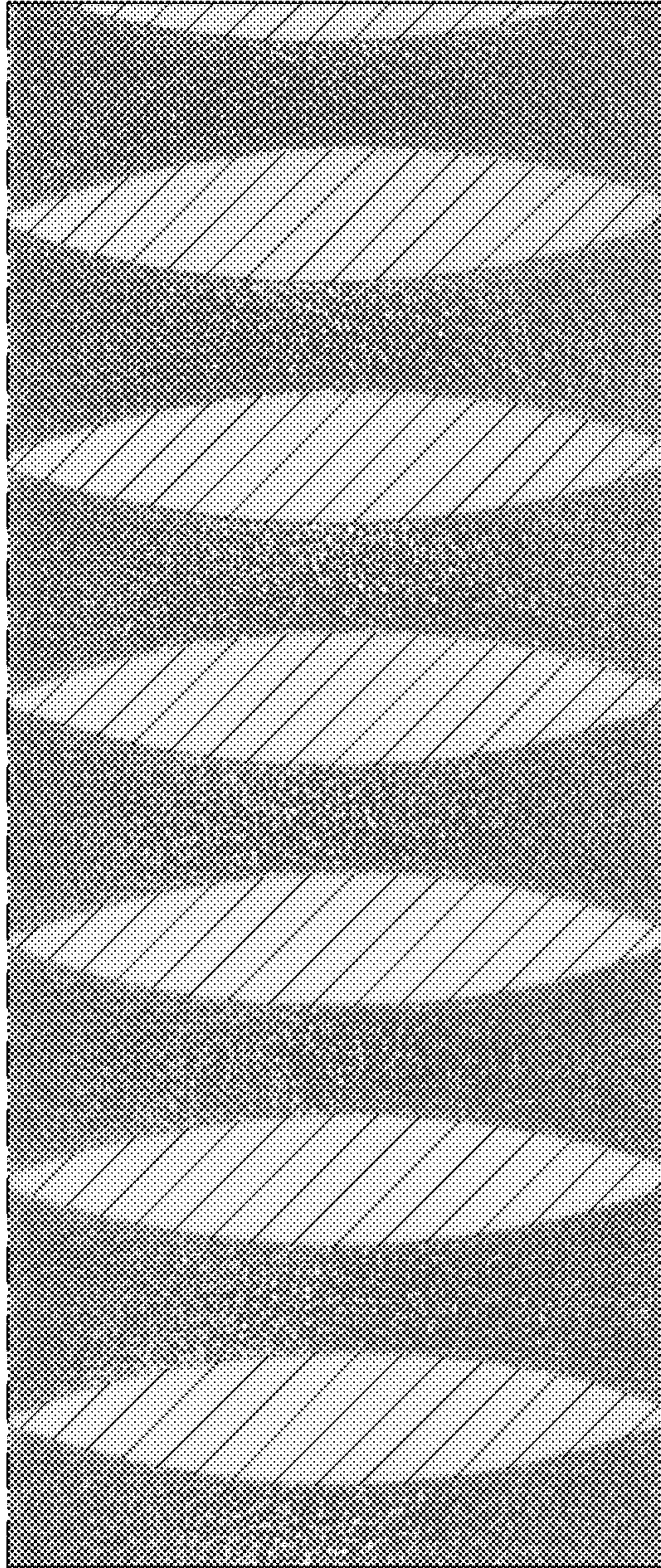

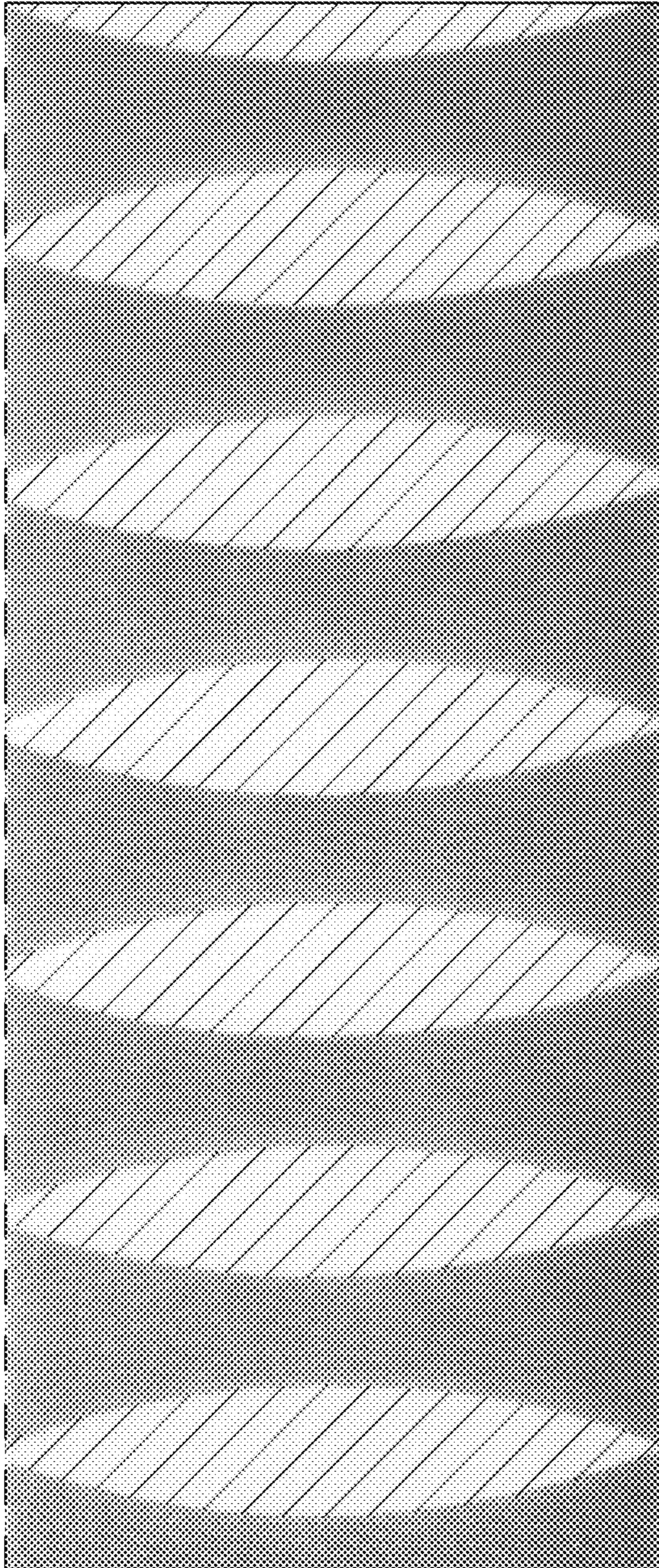
