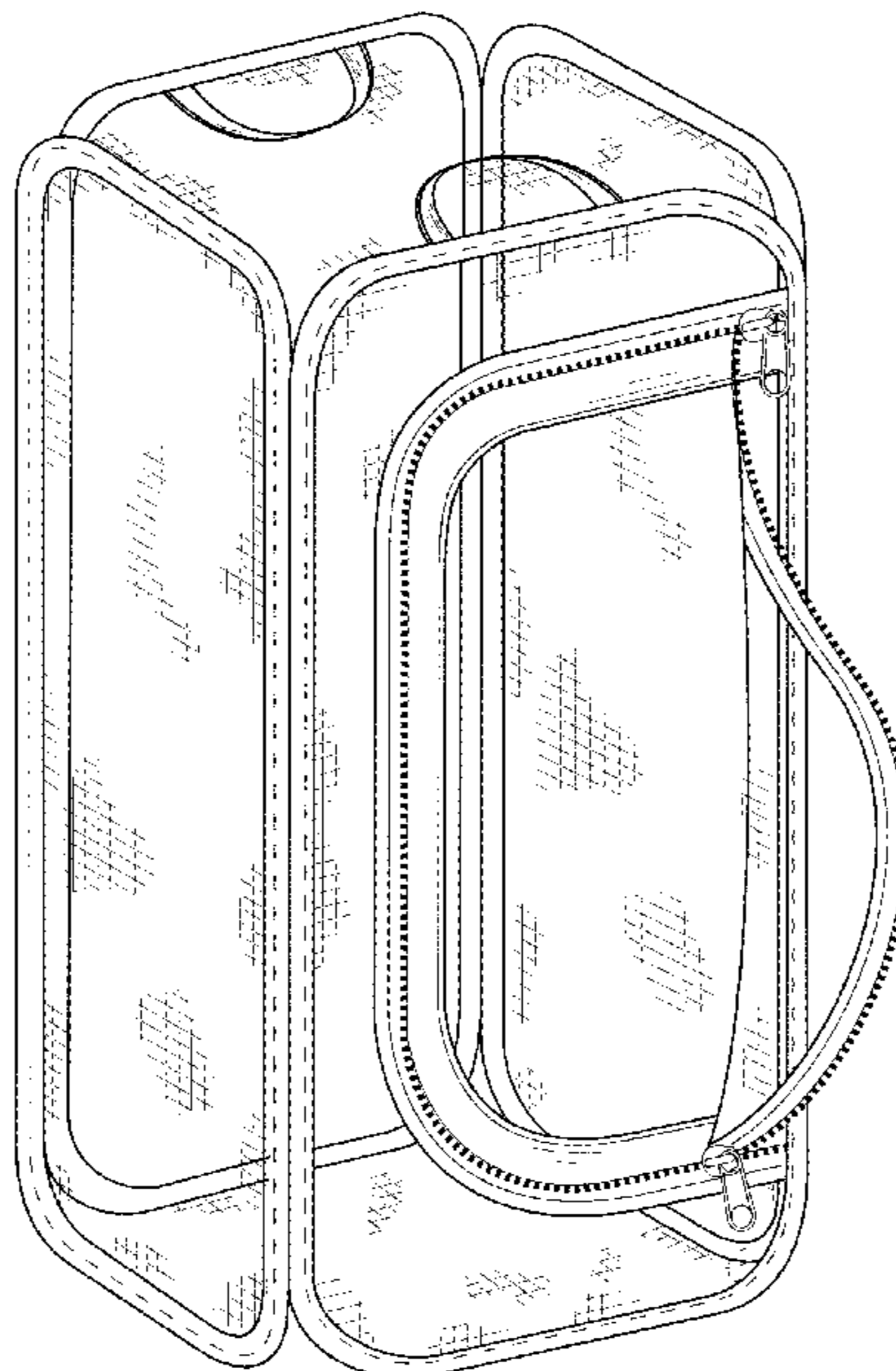
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of open state of an insect and butterfly cage showing my new design;

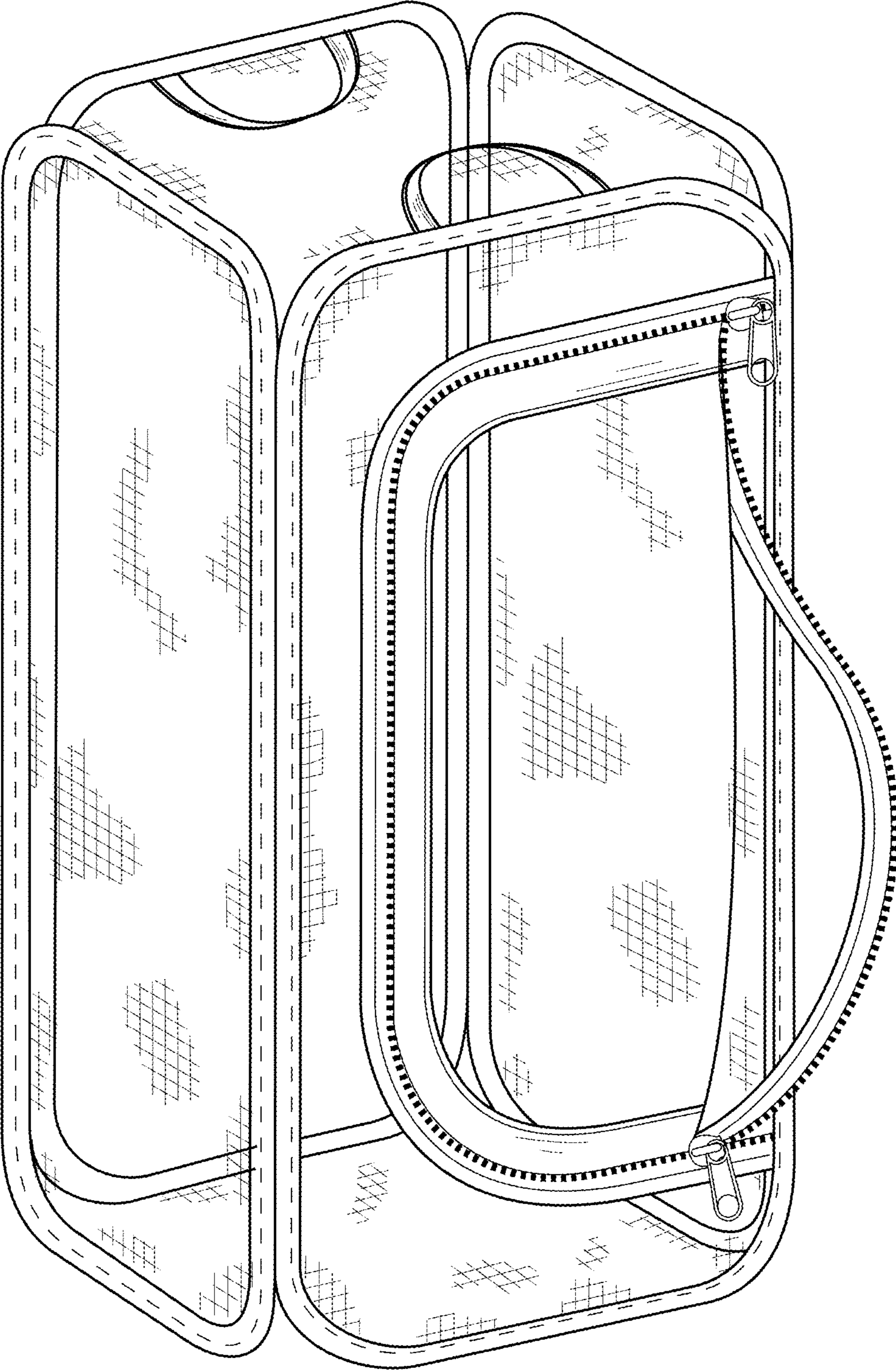

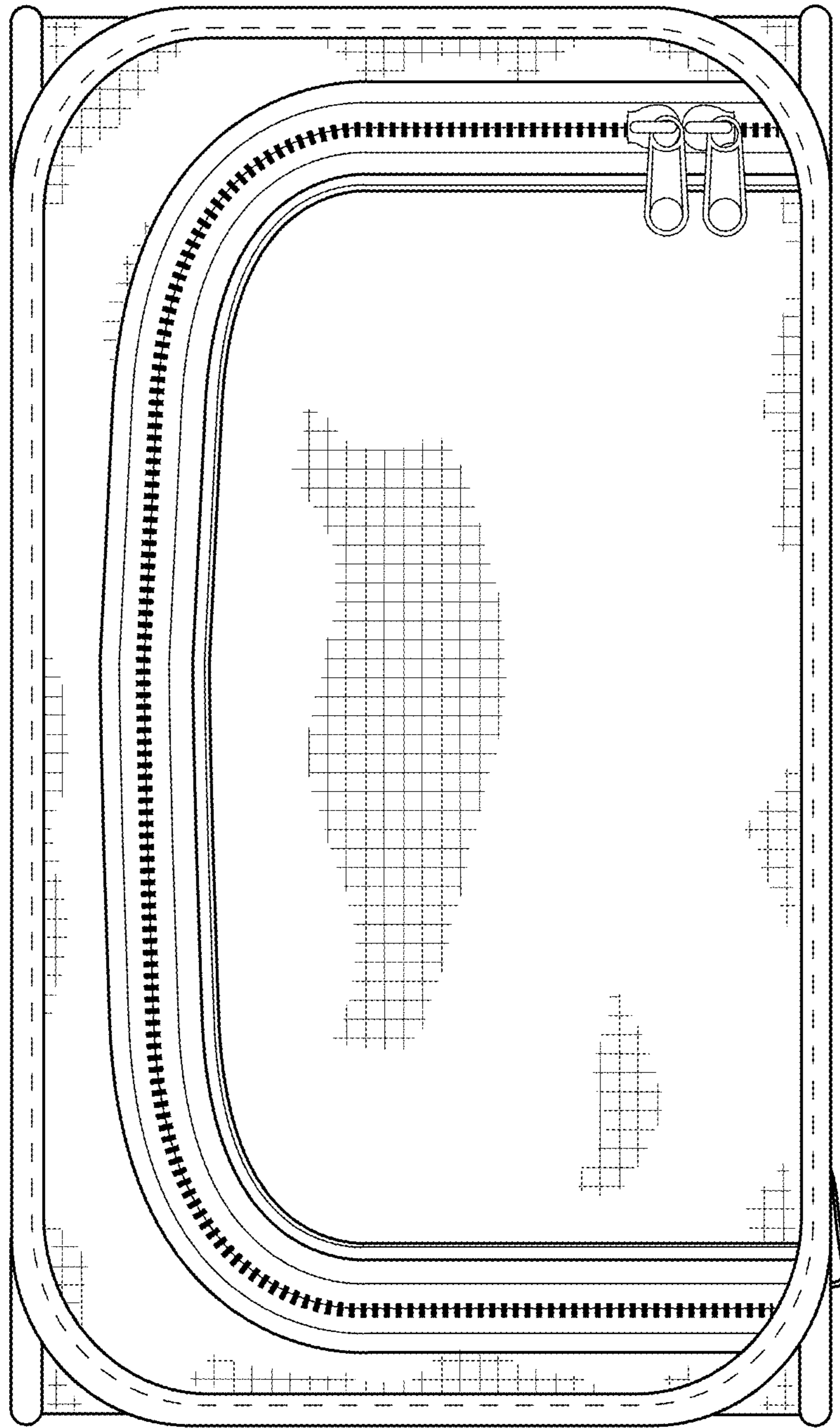

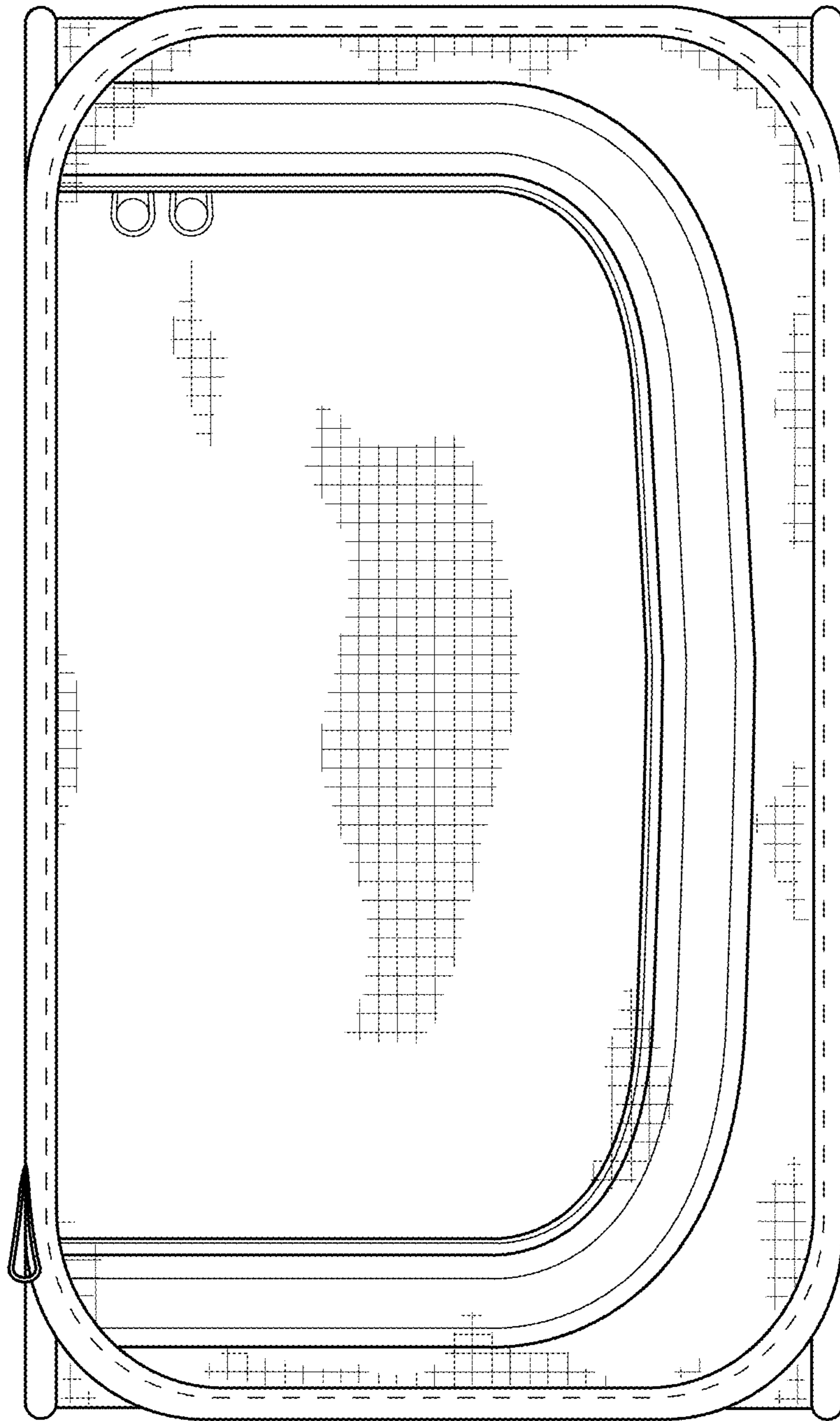

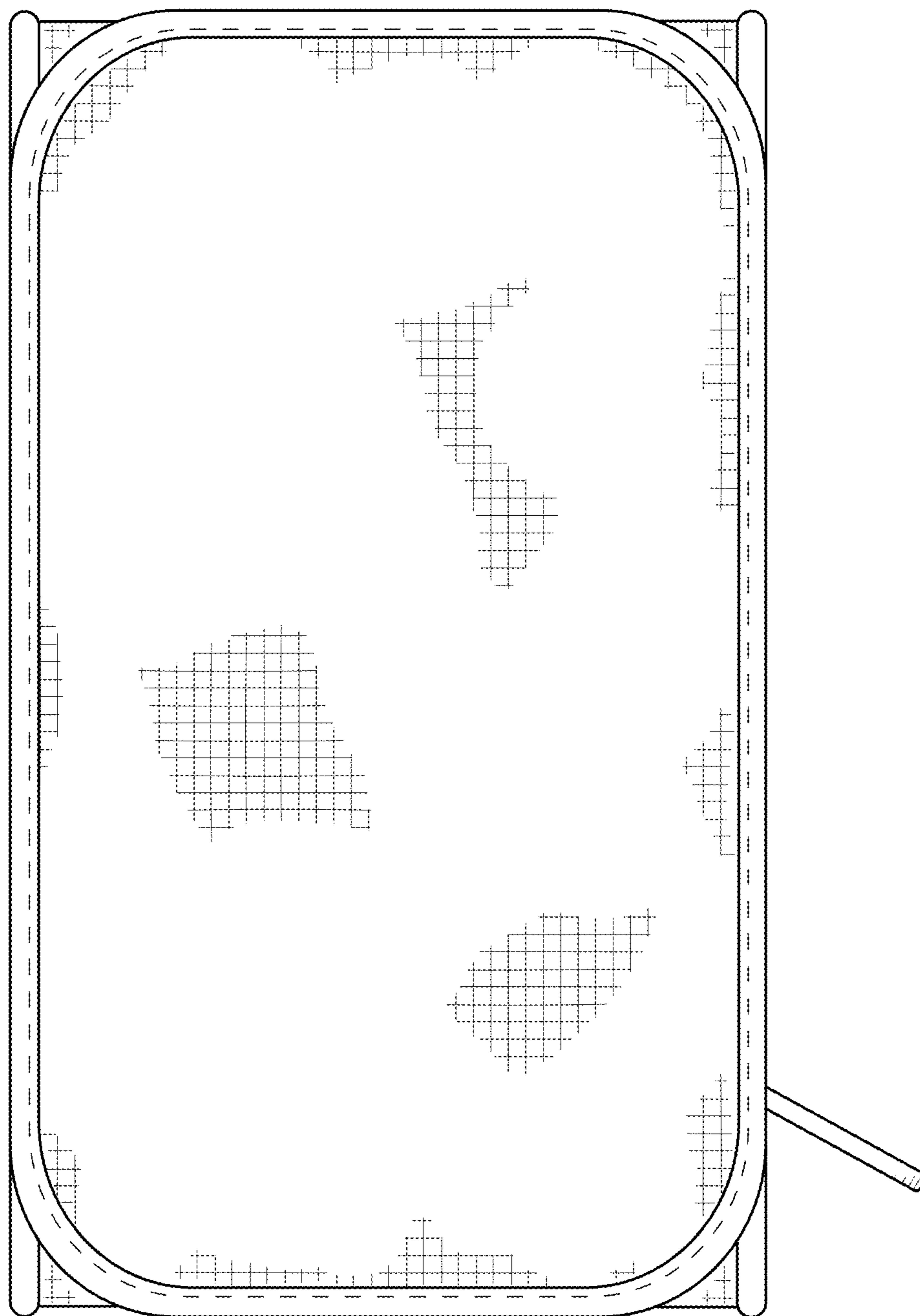

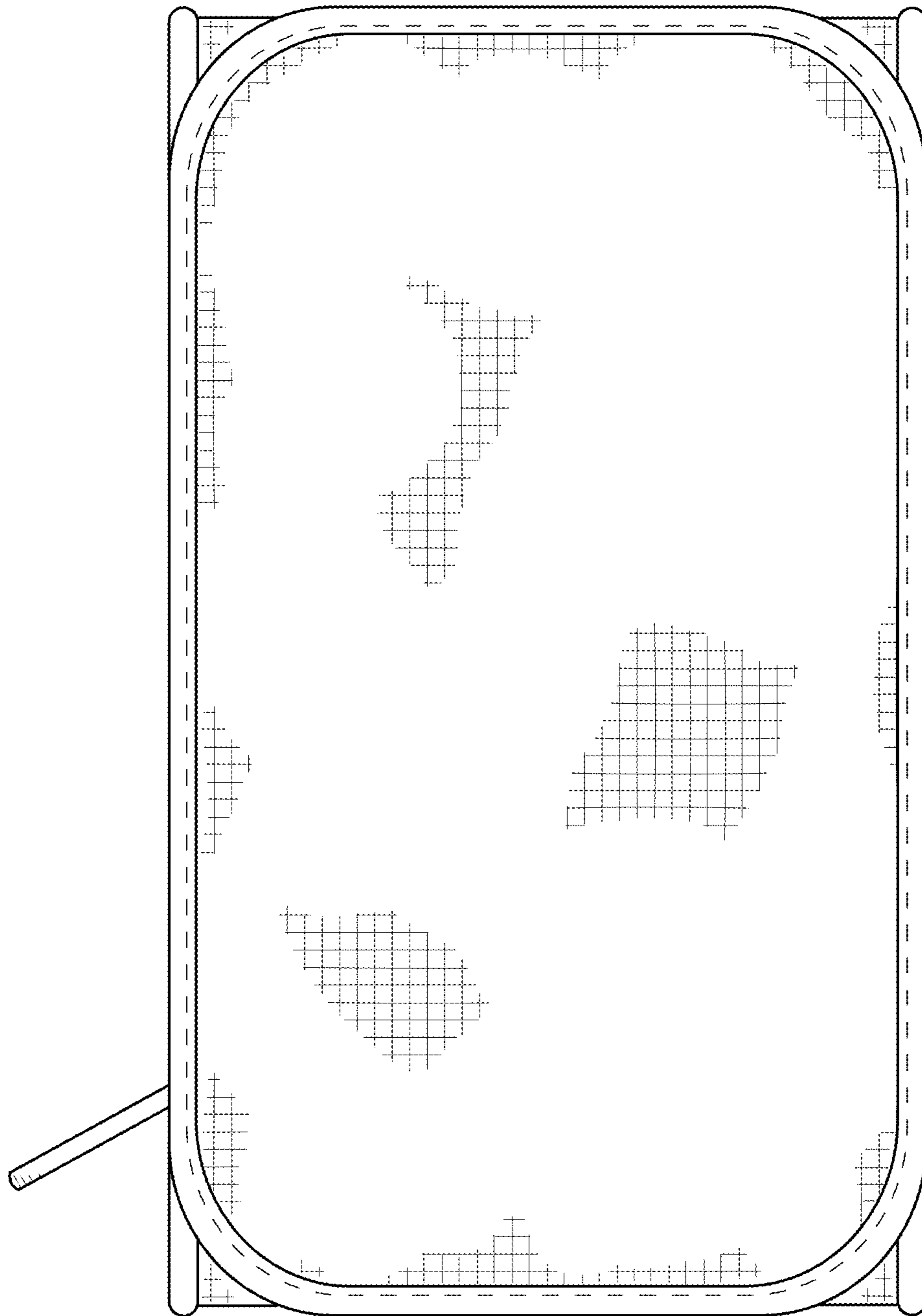

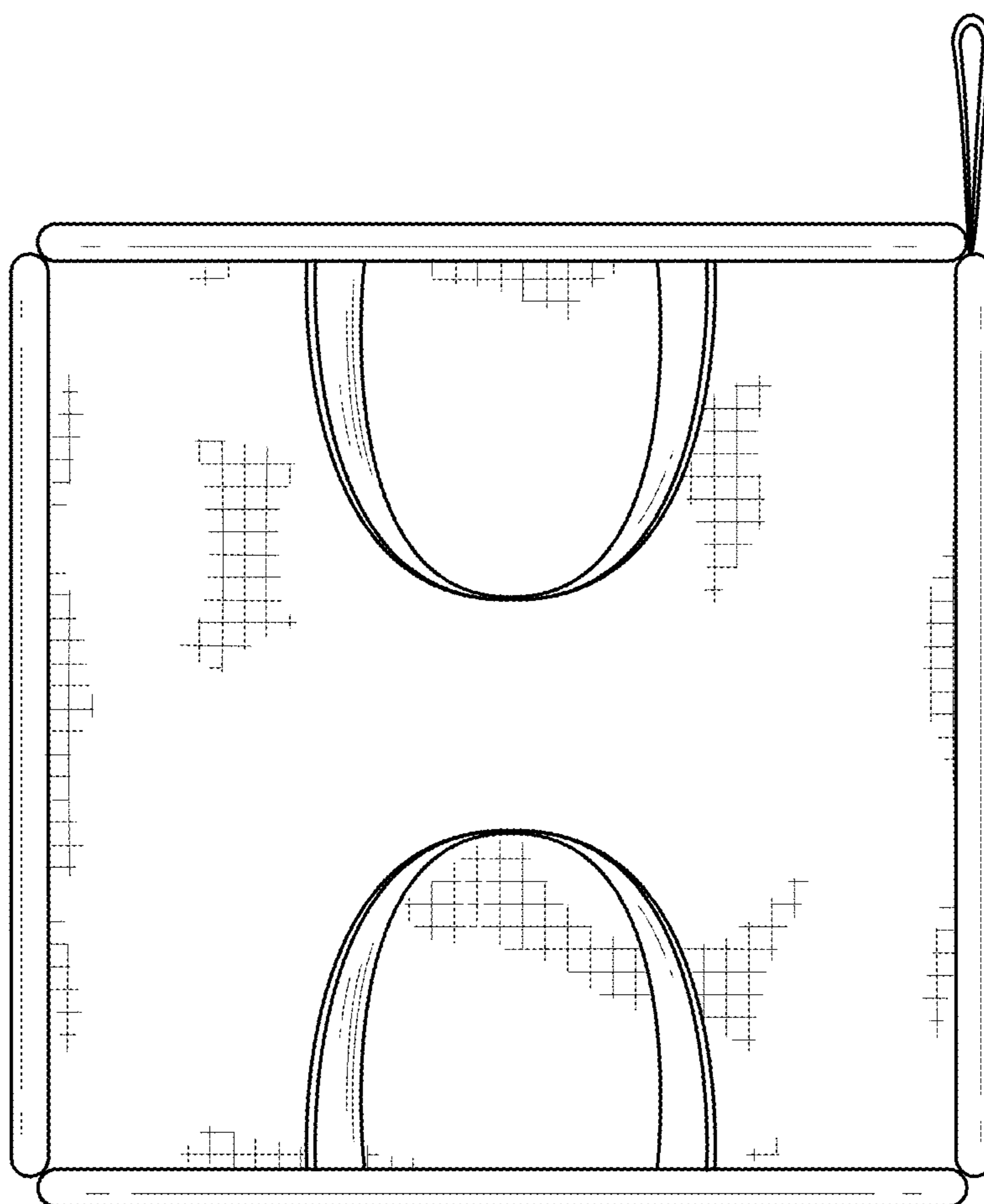

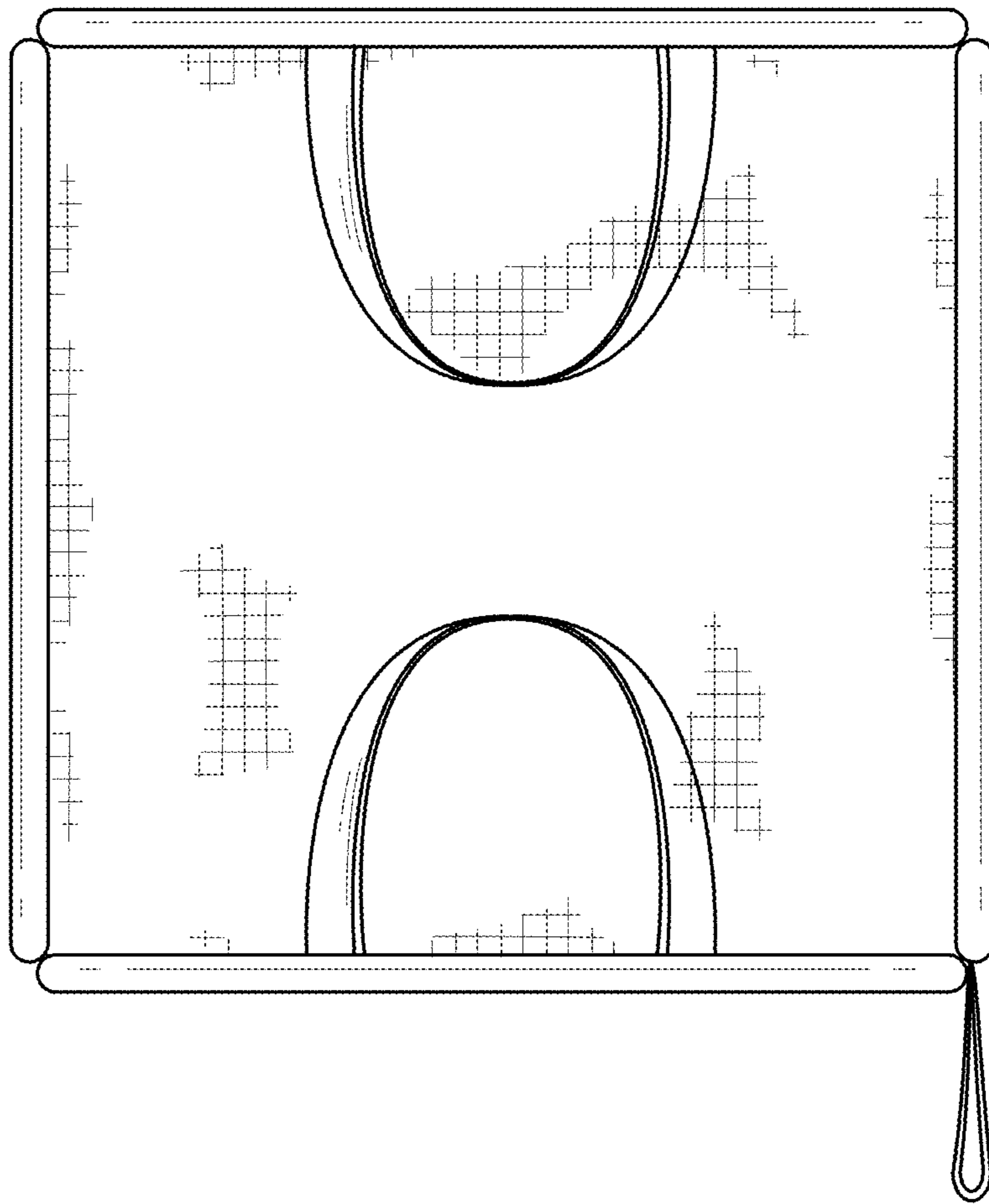
