(57) **CLAIM**

The ornamental design for a cooling device for neck, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of the front, top and right side view of a cooling device for neck showing my new design;

FIG. 2 is a second perspective view of the rear, bottom and left side view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a left side view thereof, a right side view being a mirror image;

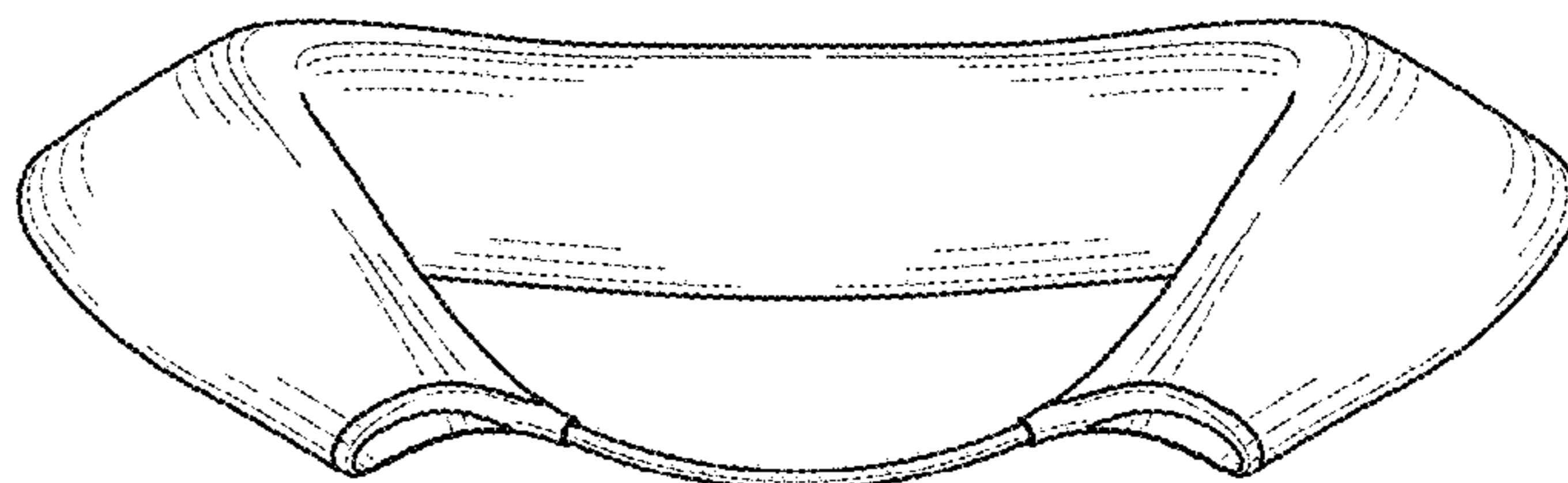
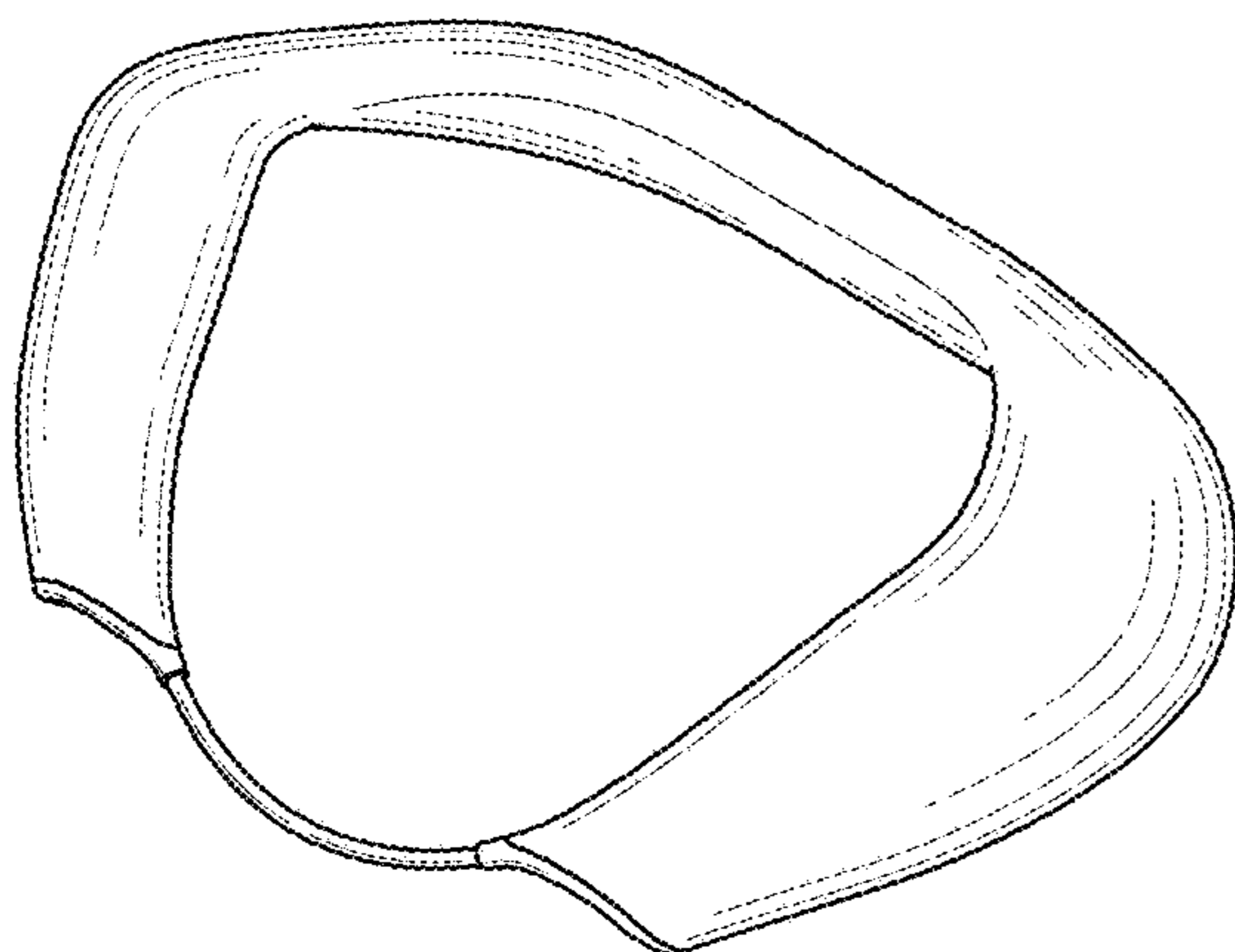
FIG. 6 is a top view thereof;

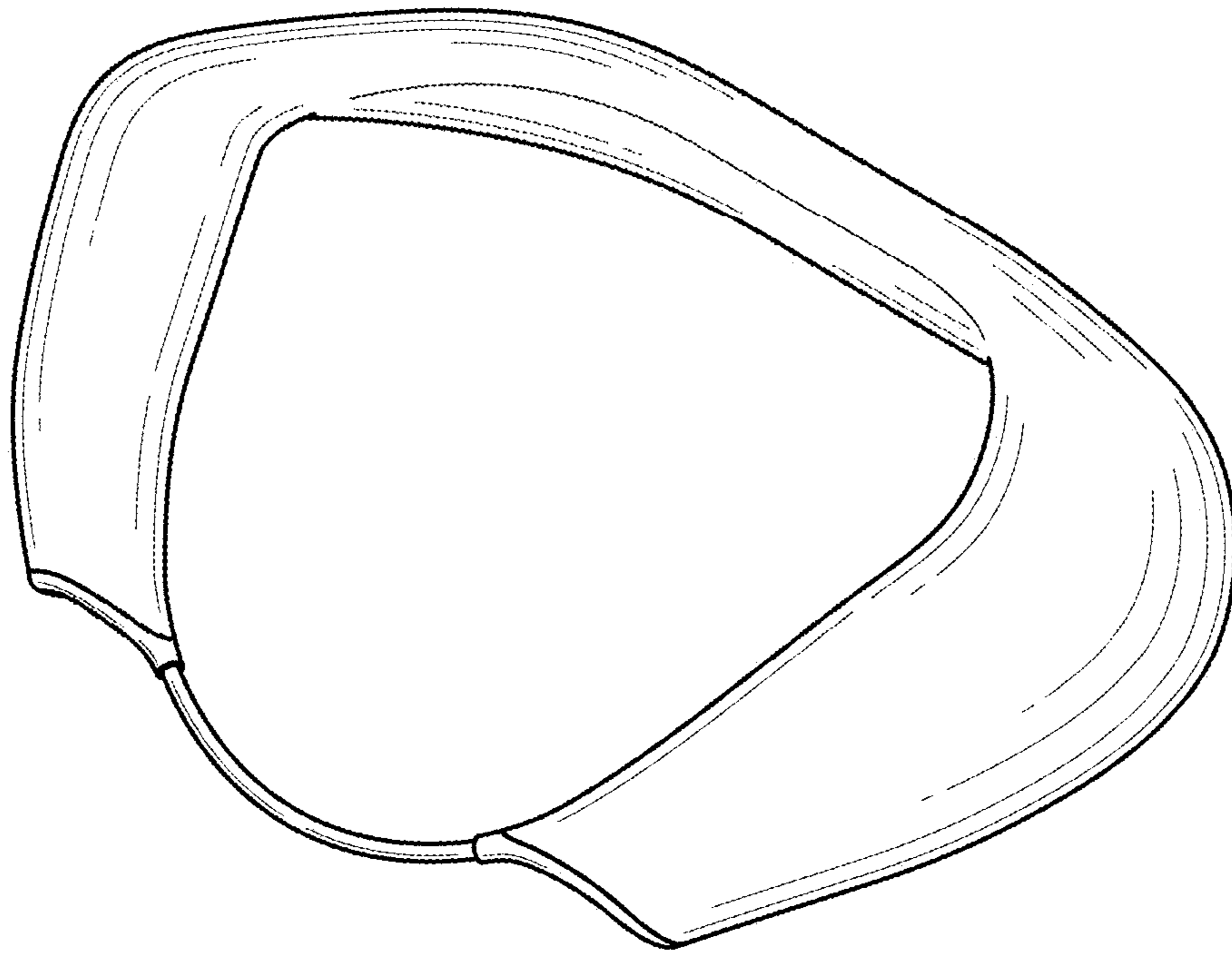

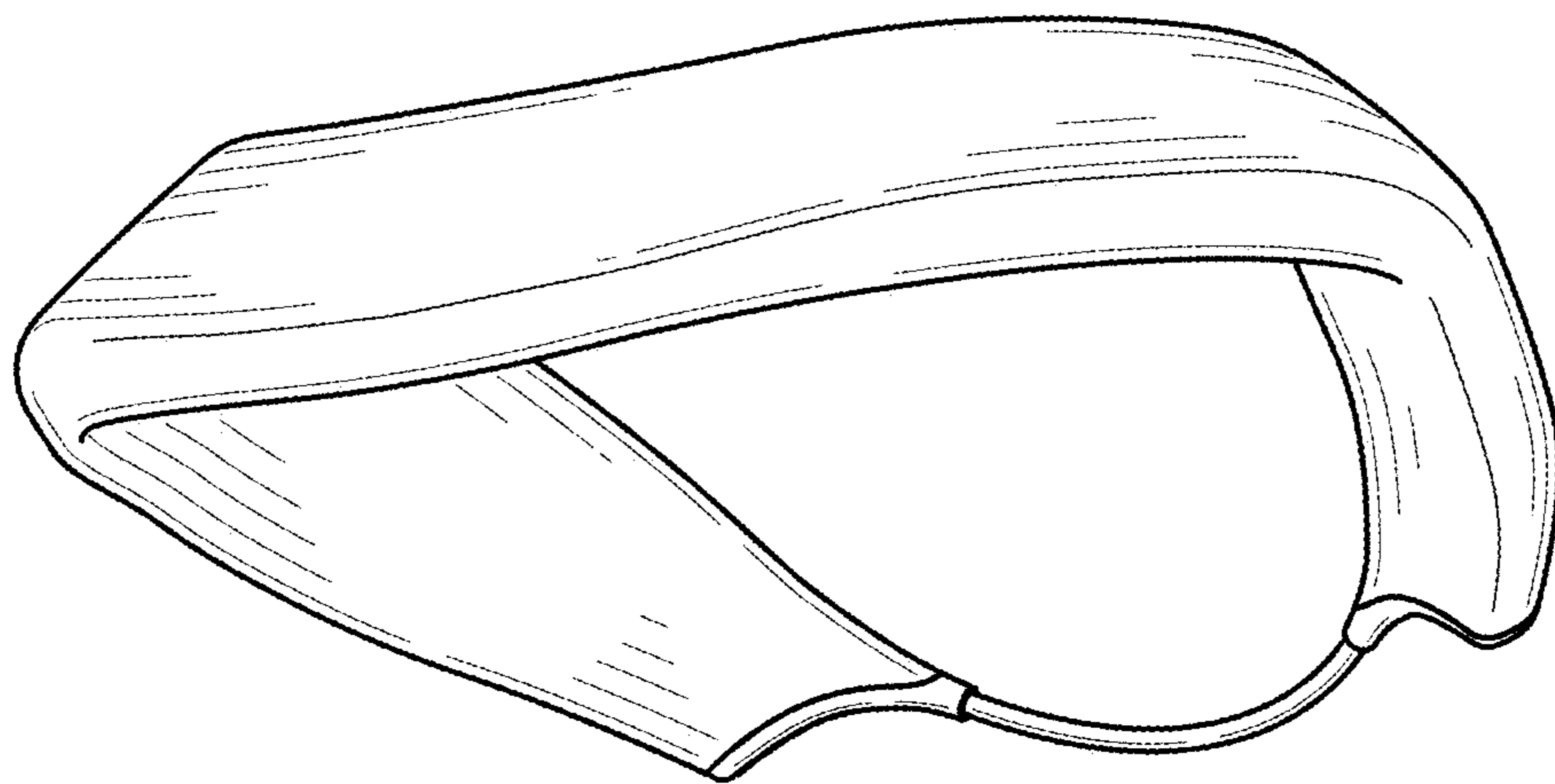

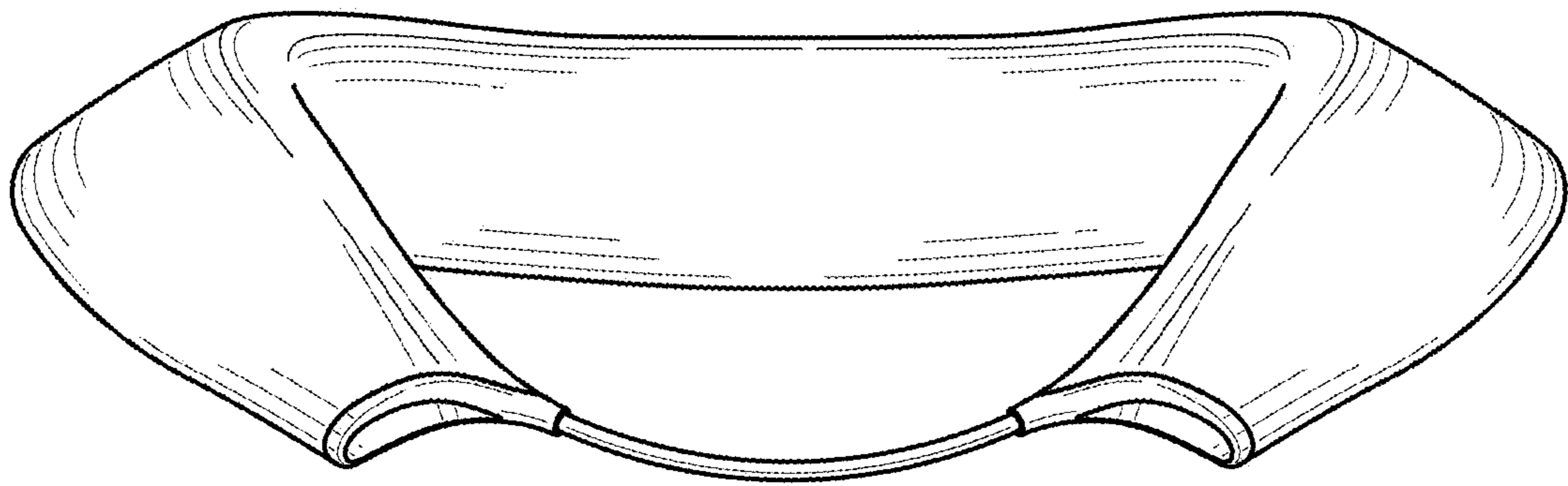

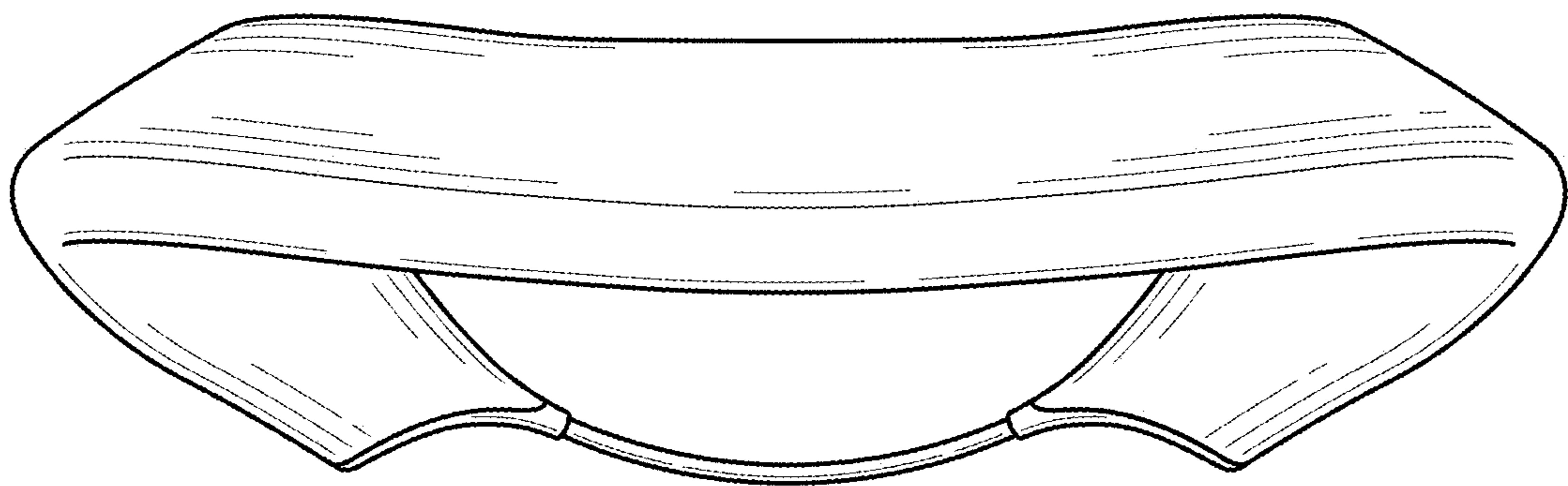

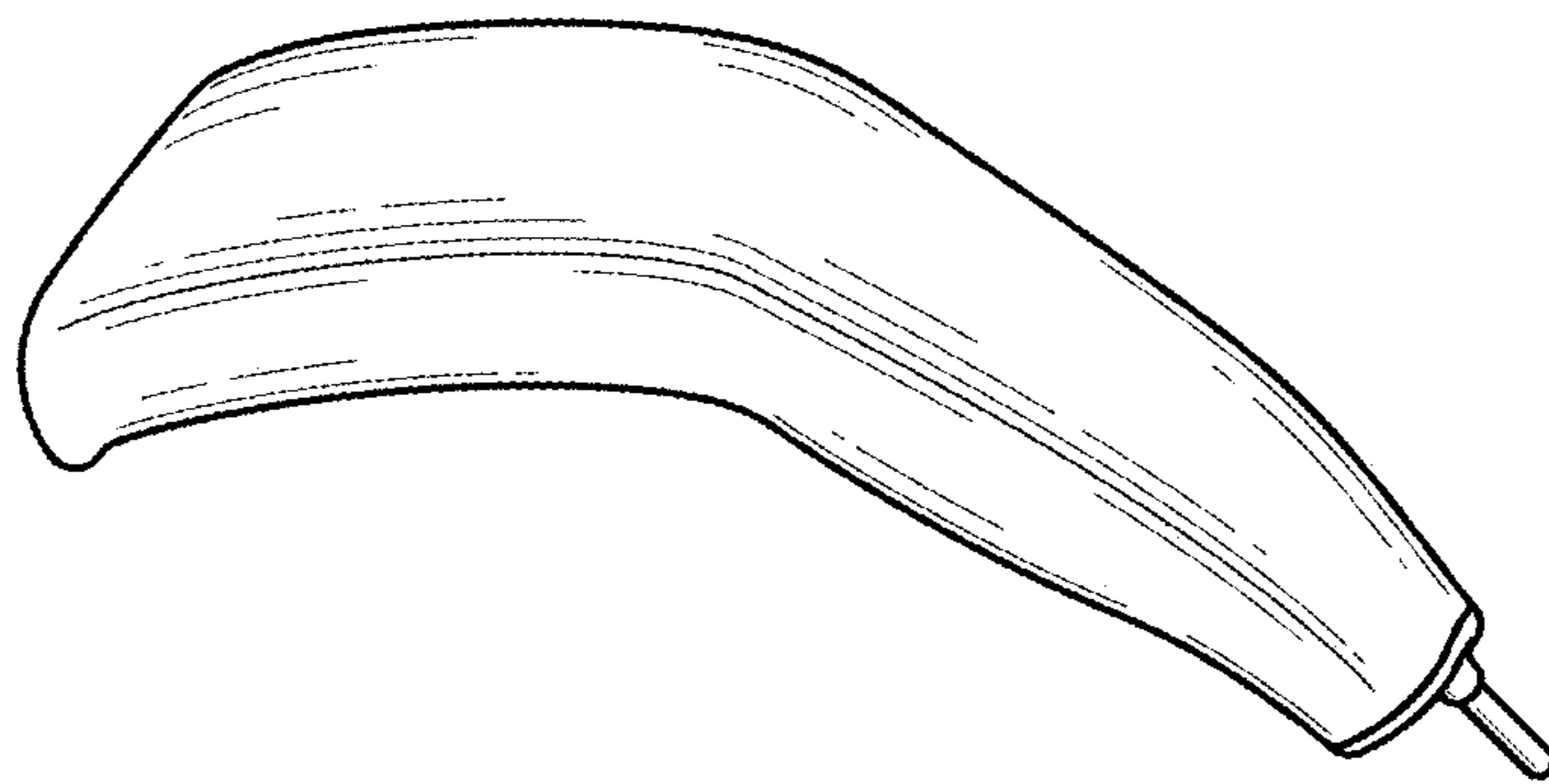

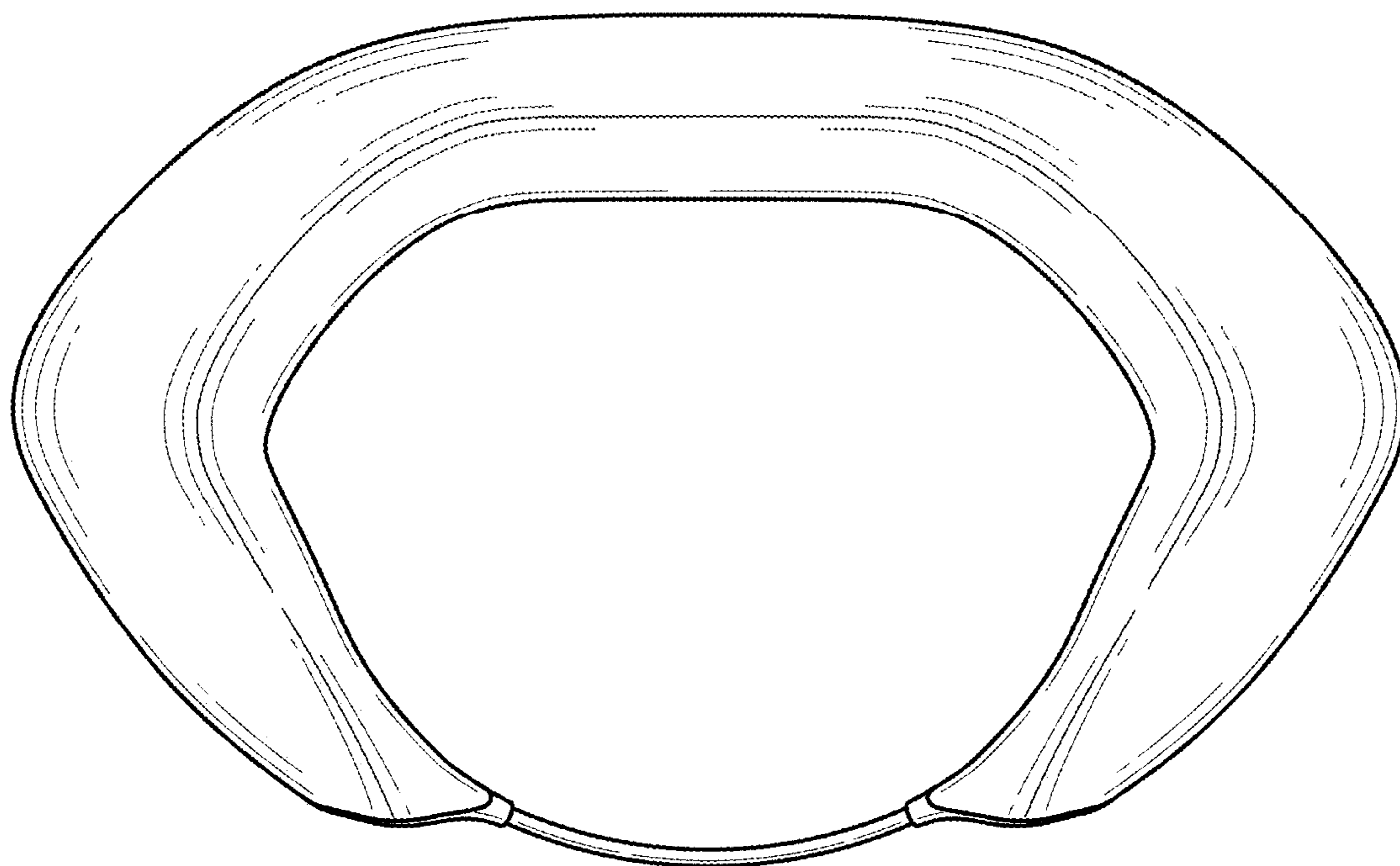

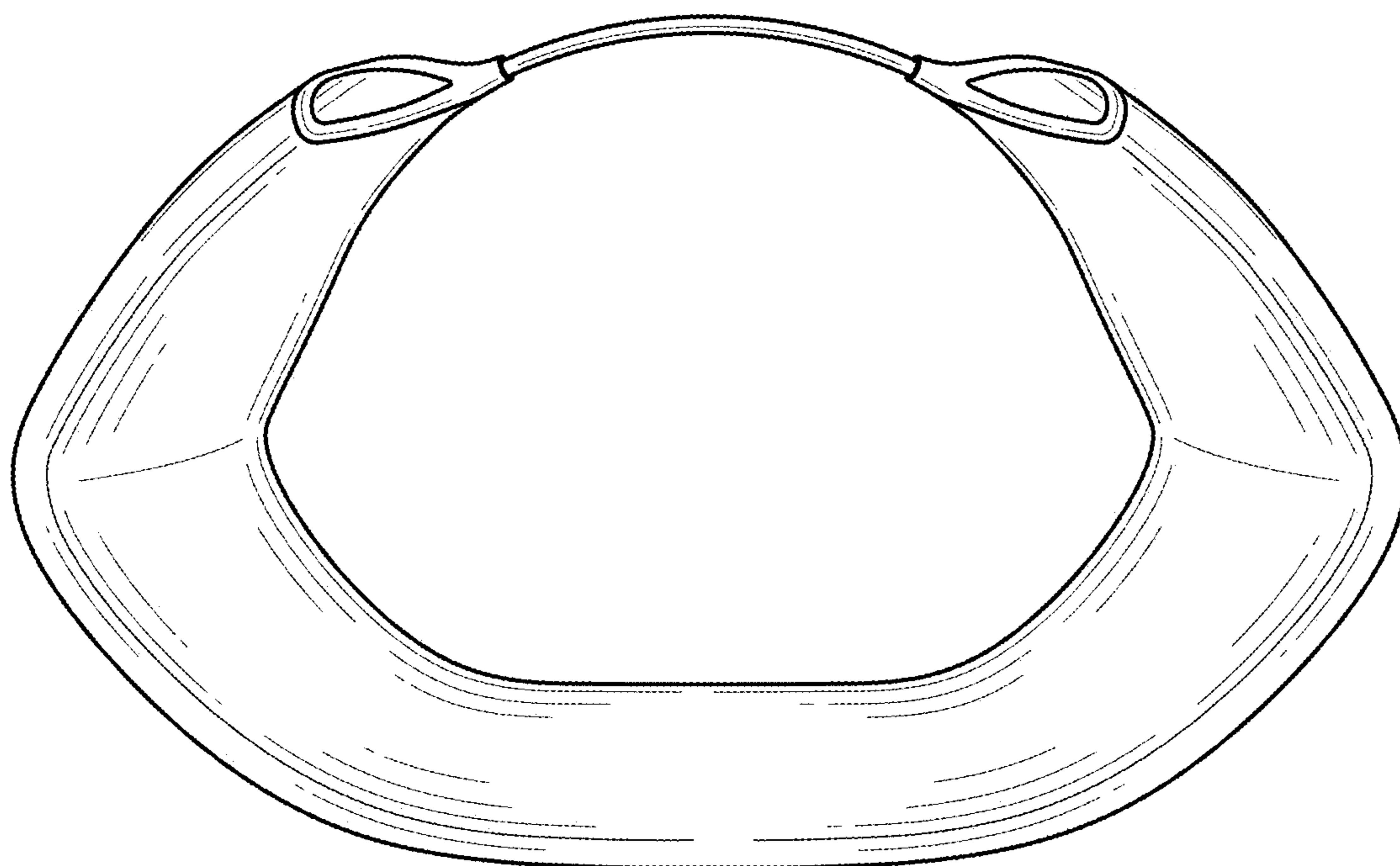

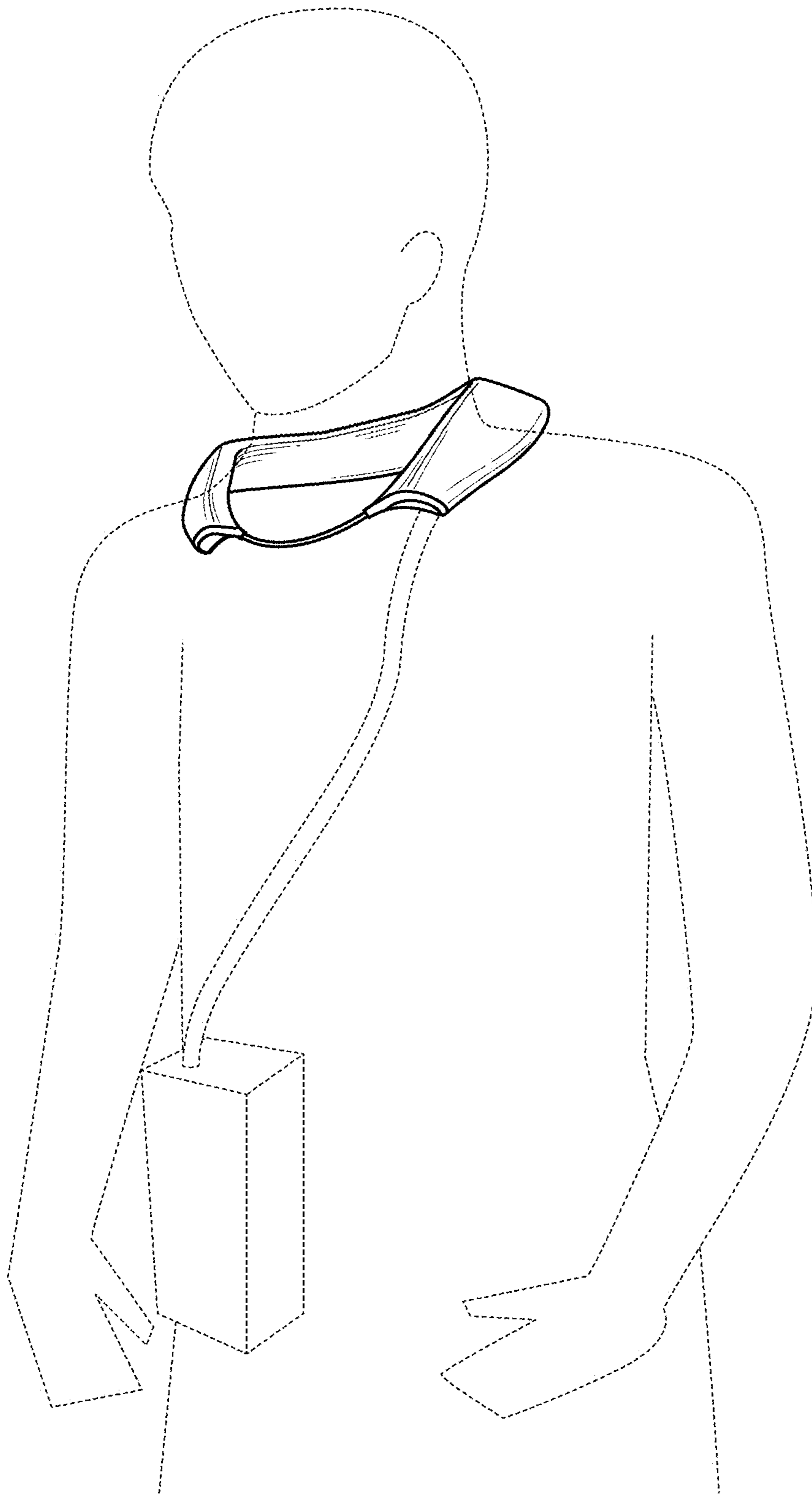
