(57) **CLAIM**

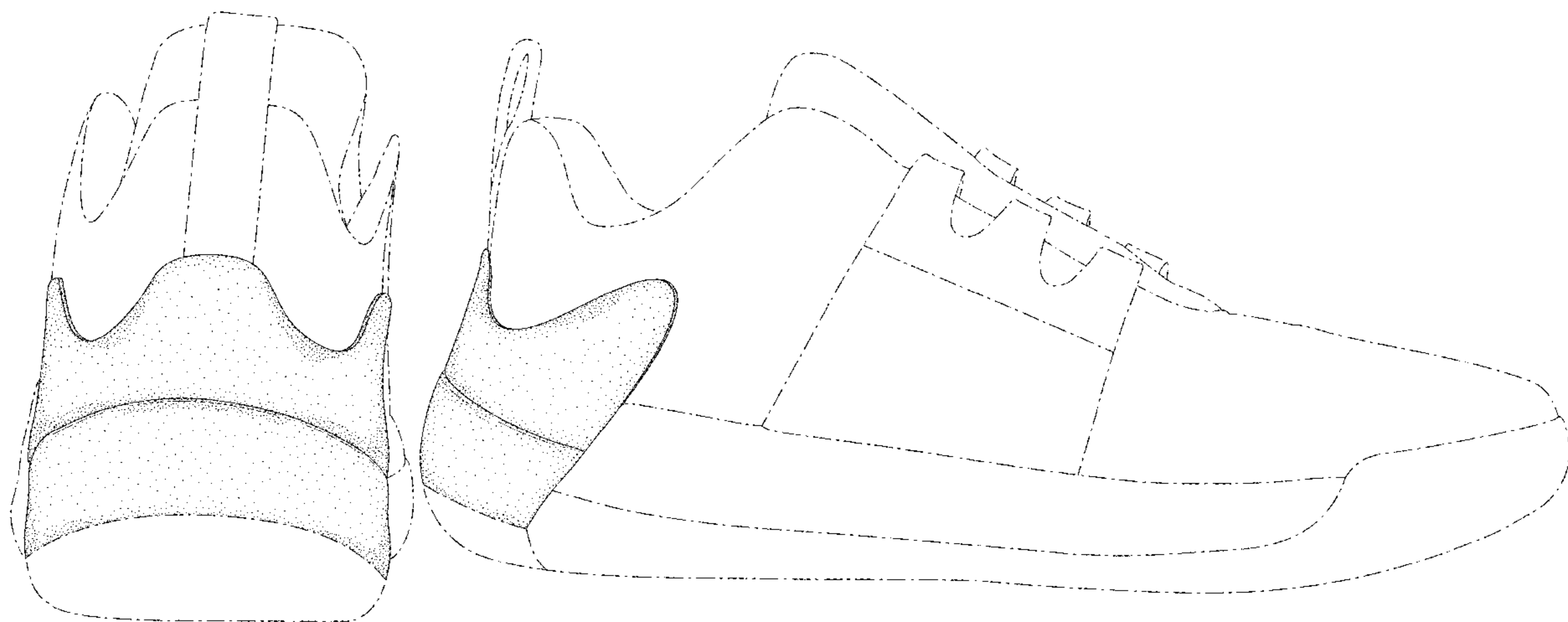
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a shoe showing my new design;
 FIG. 2 is a side view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is an opposite side view thereof; and,
 FIG. 5 is an opposite rear perspective view thereof.
 The broken line immediately adjacent to the bottom of the shaded area defines the lower bound of the claimed design and forms no part thereof. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

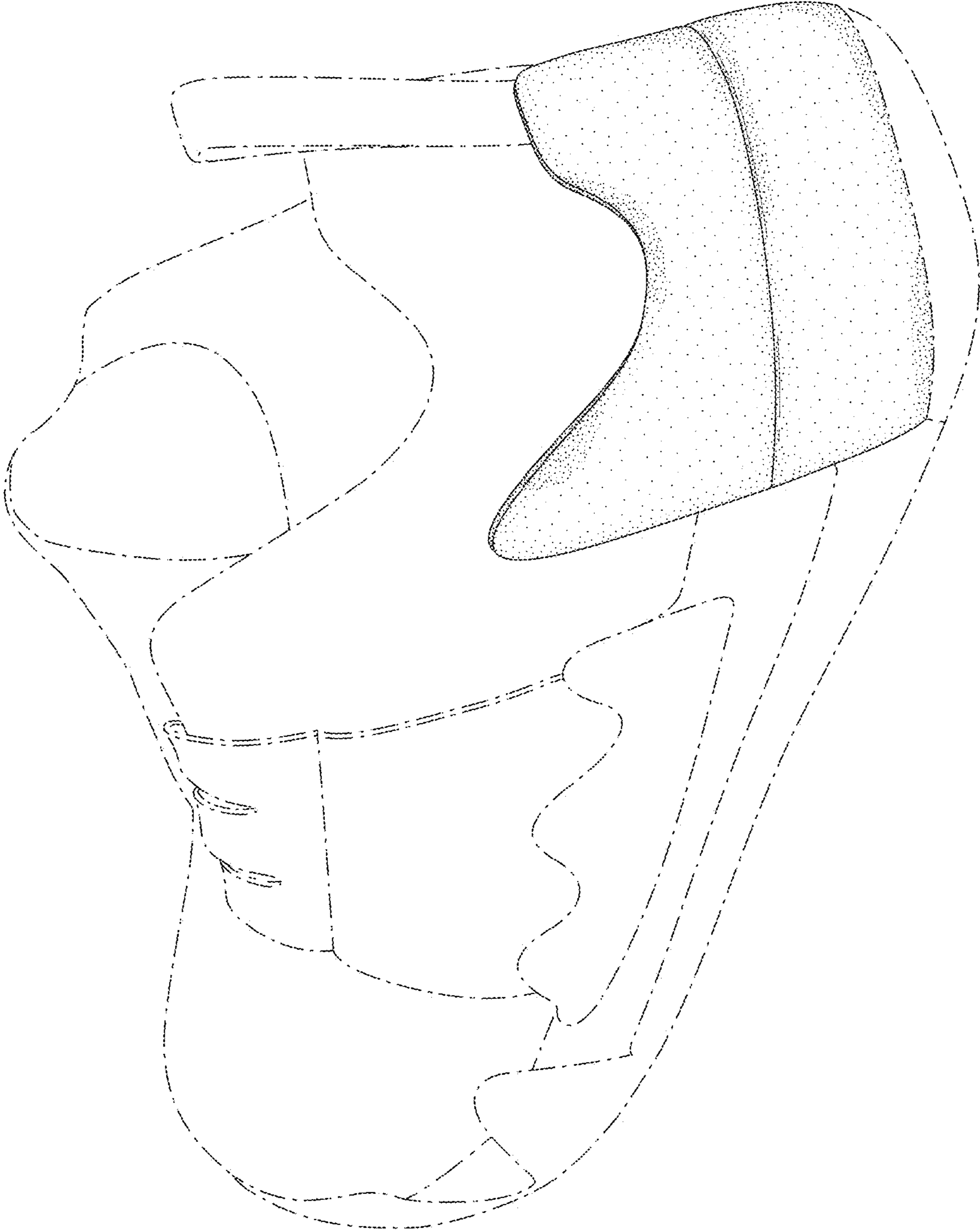

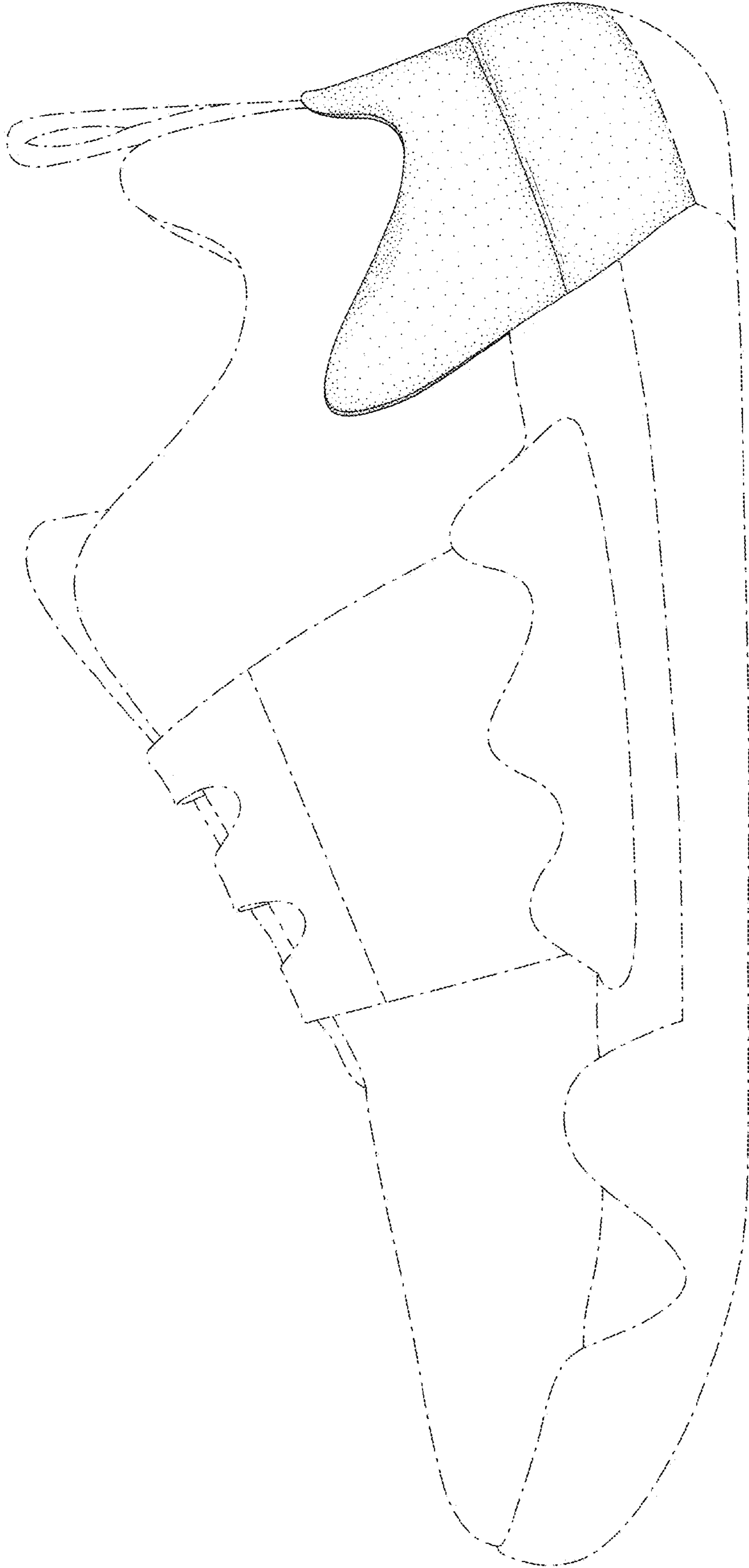

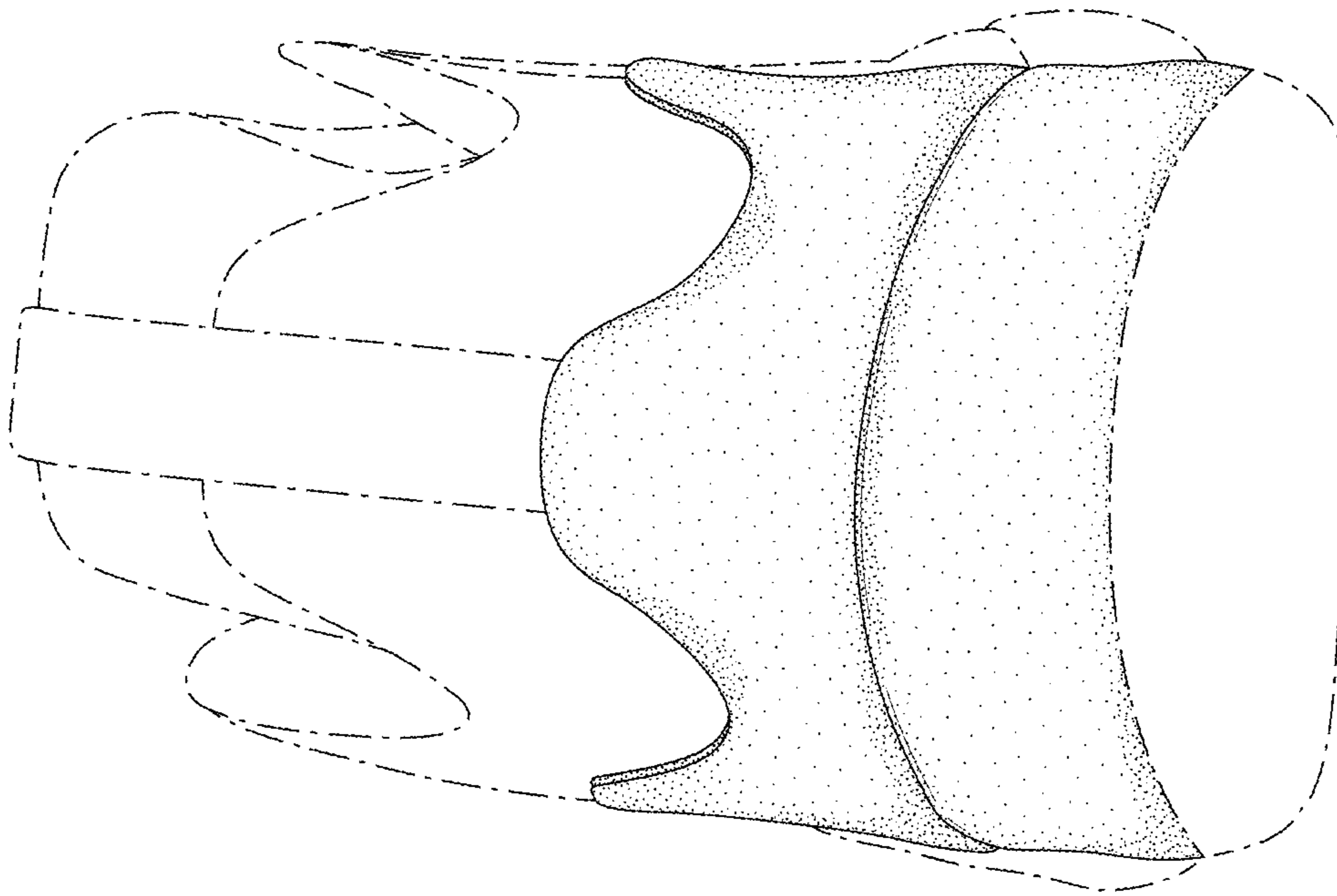

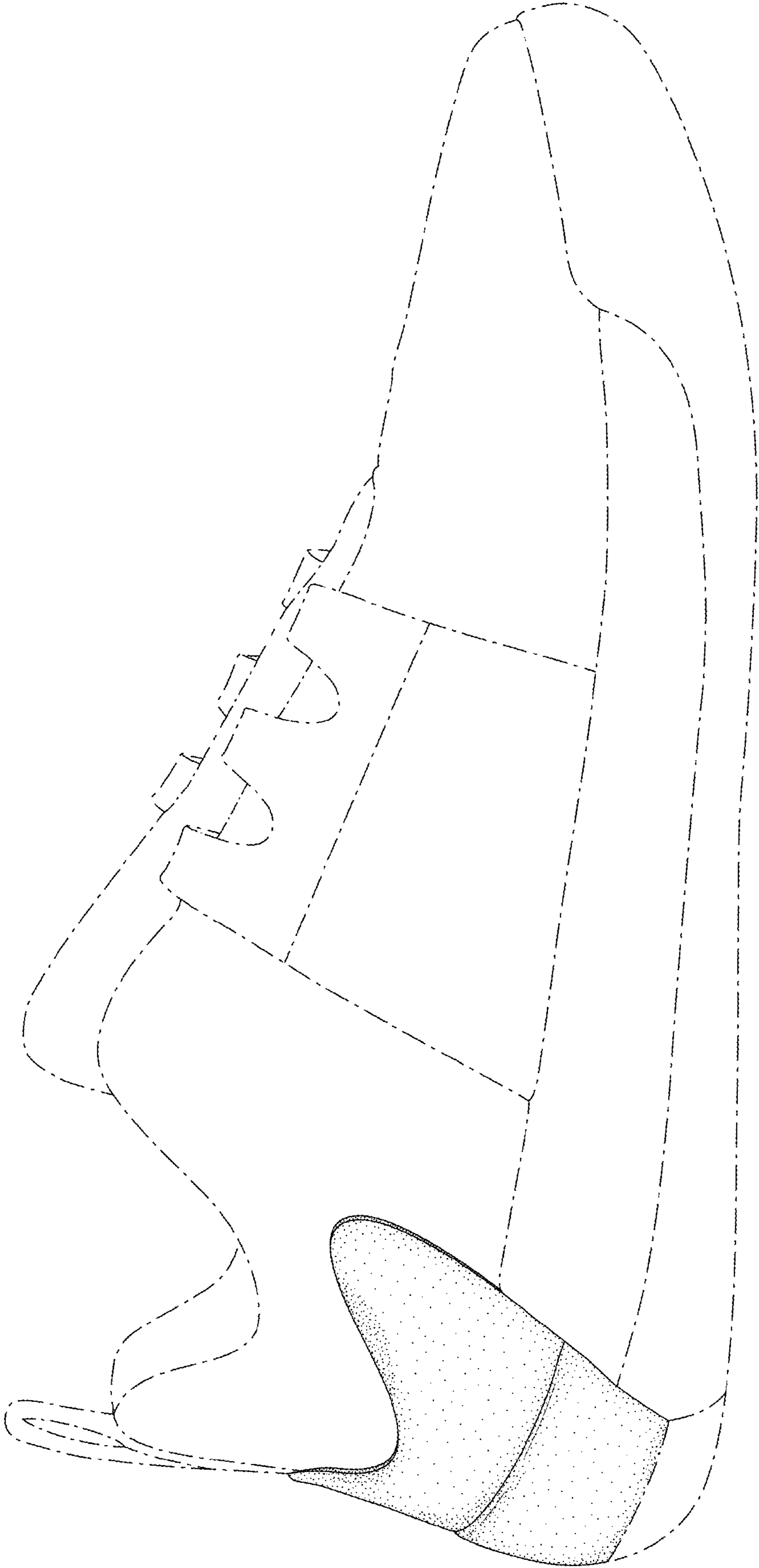

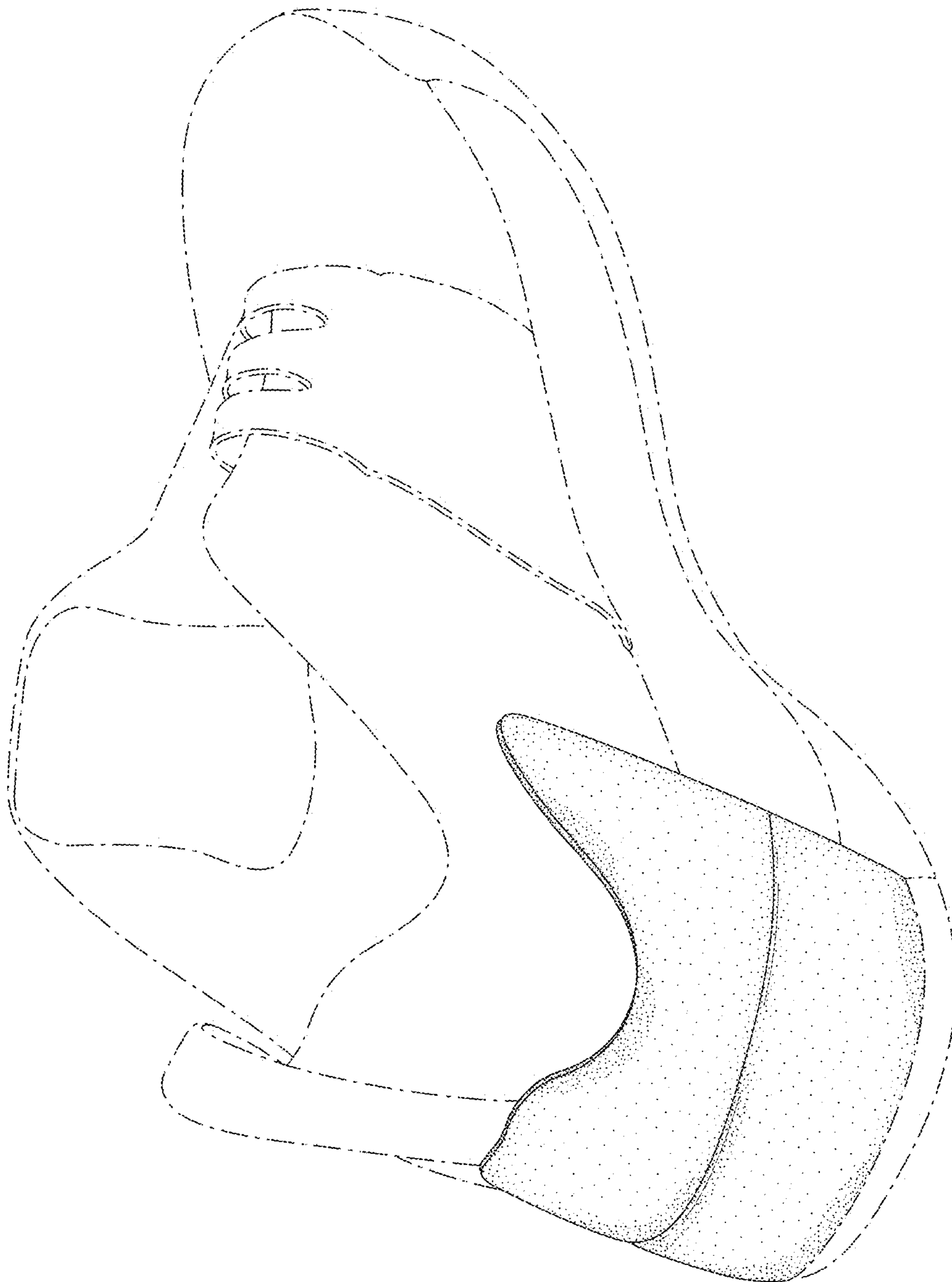
