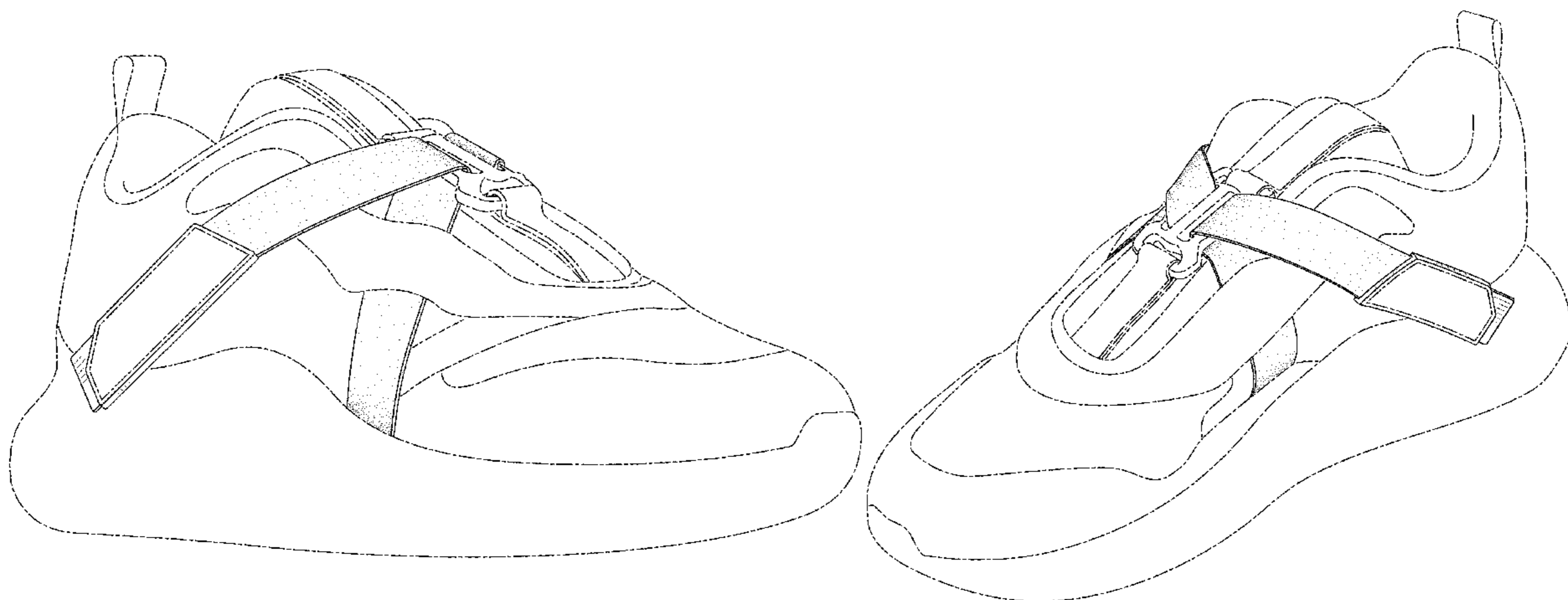
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is an opposite side view thereof;
FIG. 5 is an opposite side front perspective view thereof;
FIG. 6 is an alternate front perspective view thereof; and,
FIG. 7 is an opposite side alternate front perspective view thereof.
The broken lines immediately adjacent to the shaded area at the ends of the front-most straps define the bounds of the claimed design and form no part thereof. The unshaded broken line area within the ends of the pull straps on both sides of the shoe forms no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

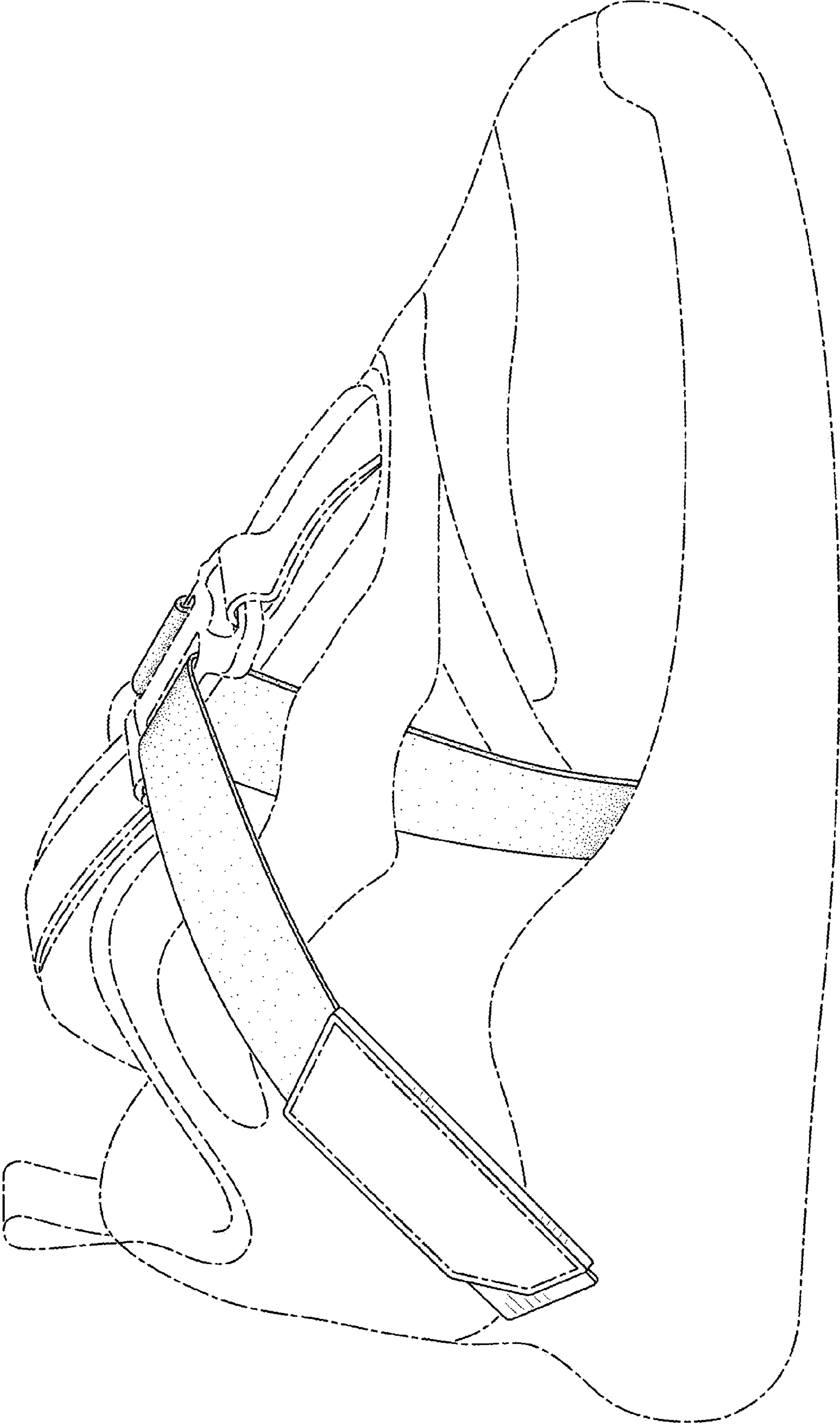

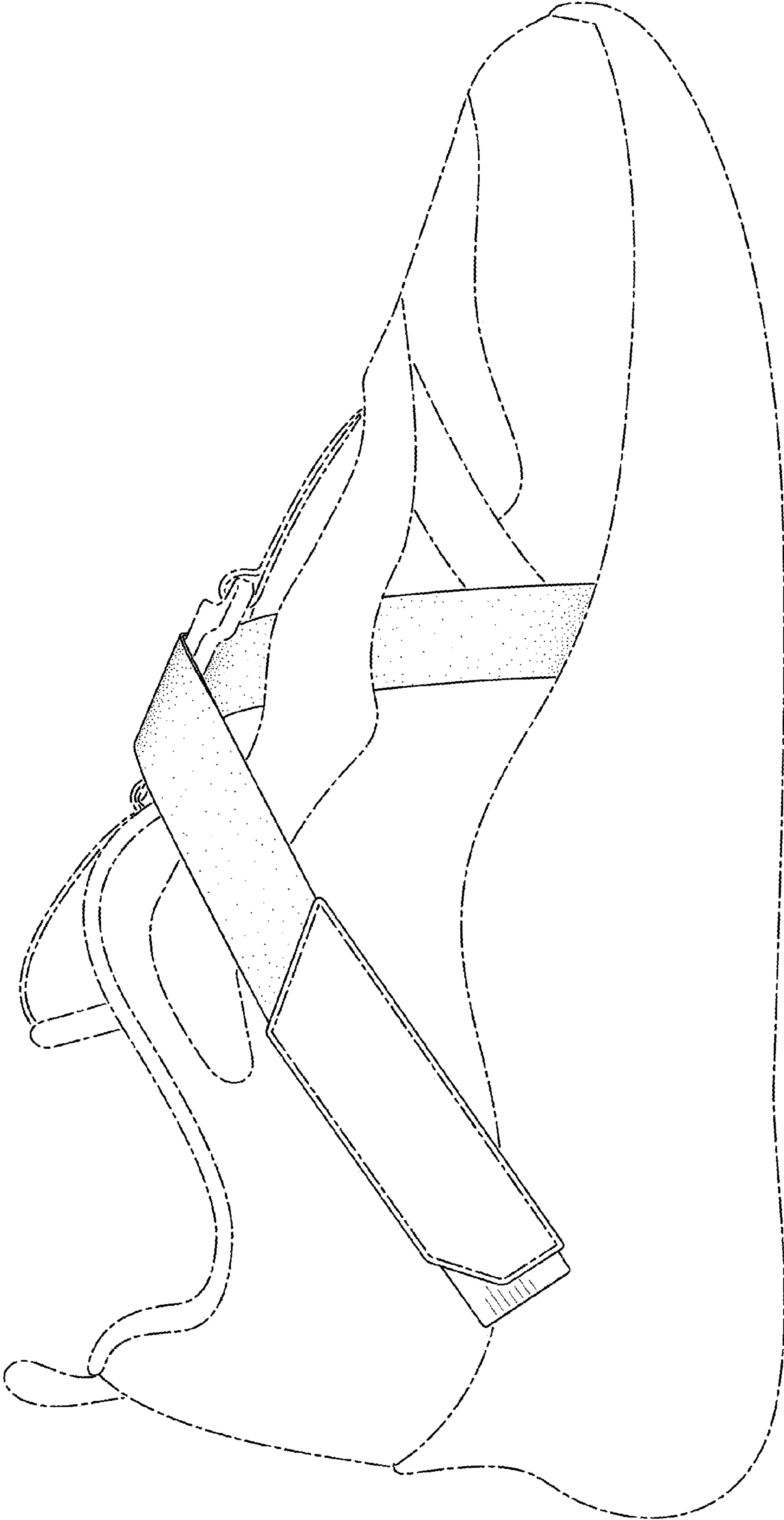

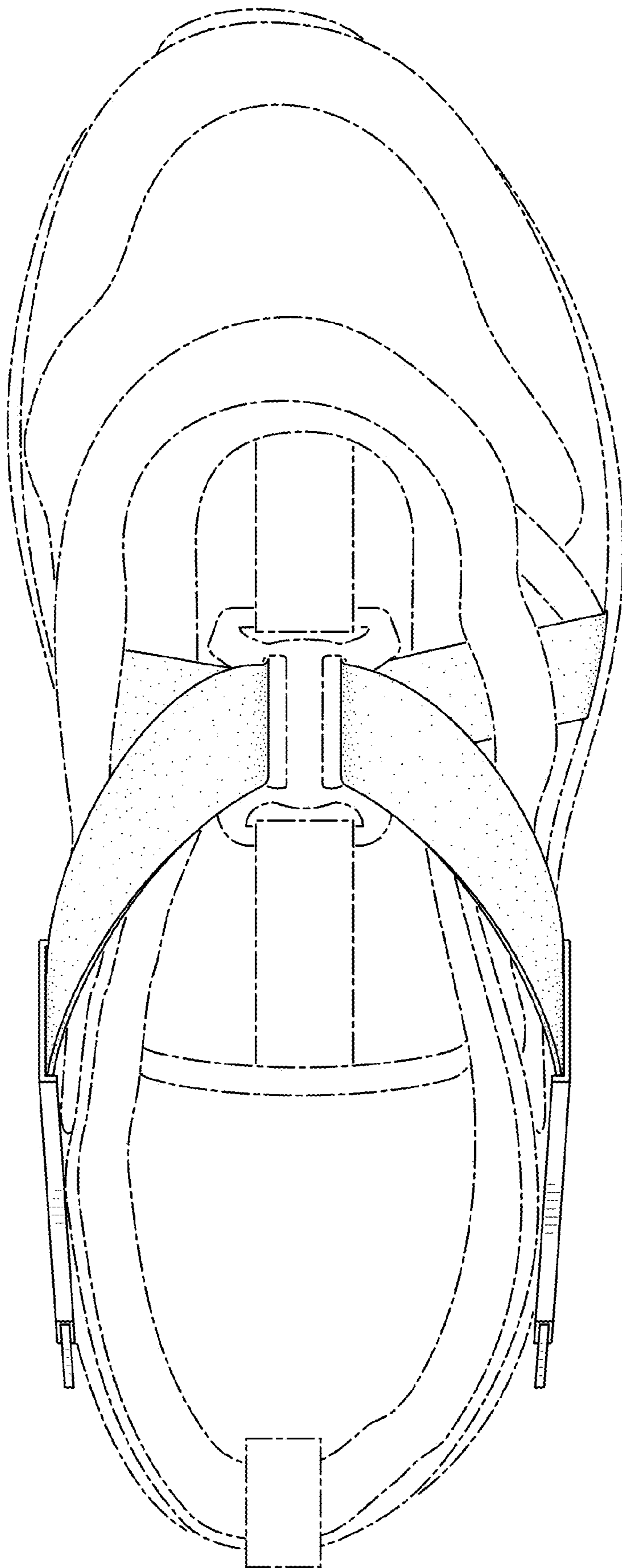

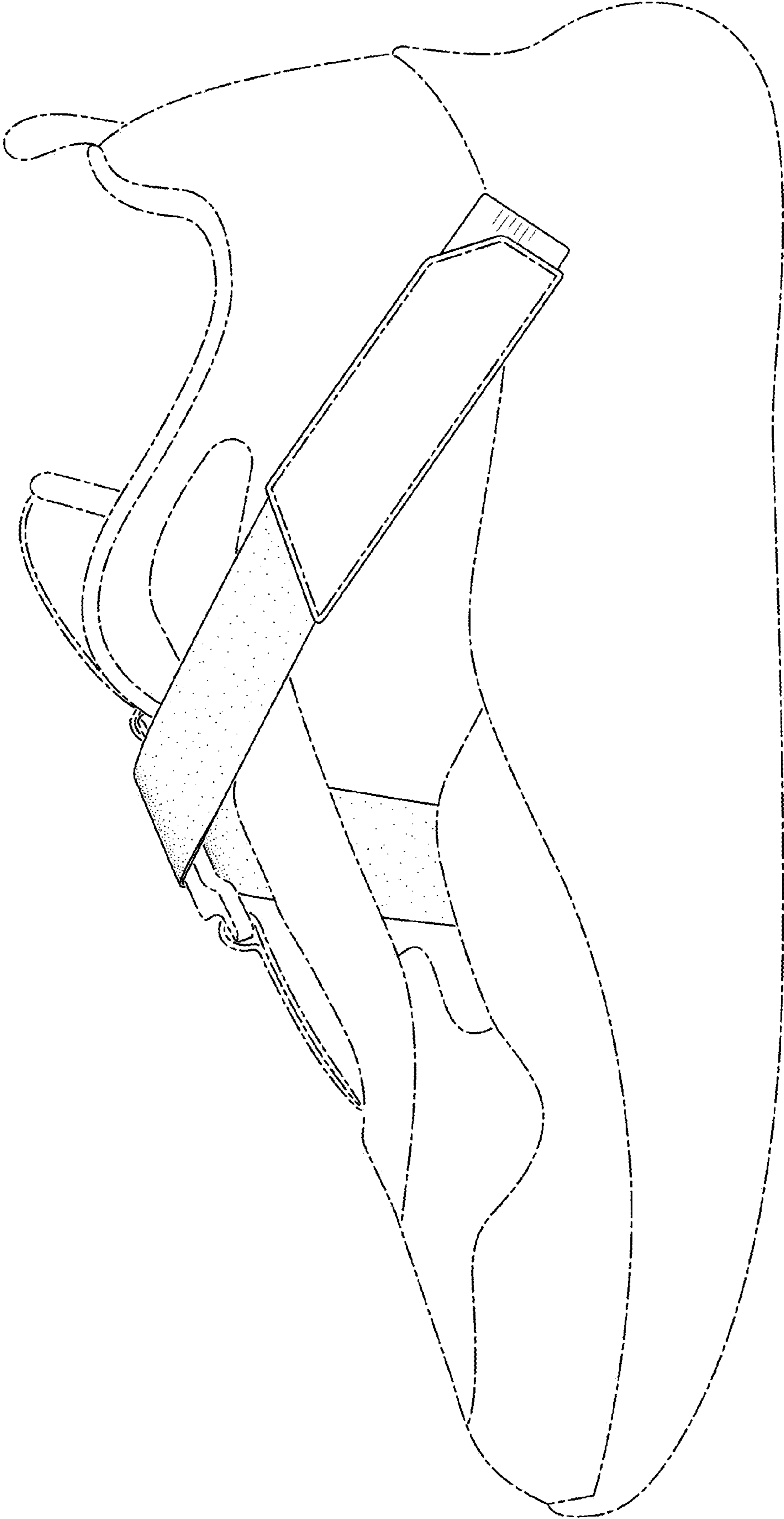

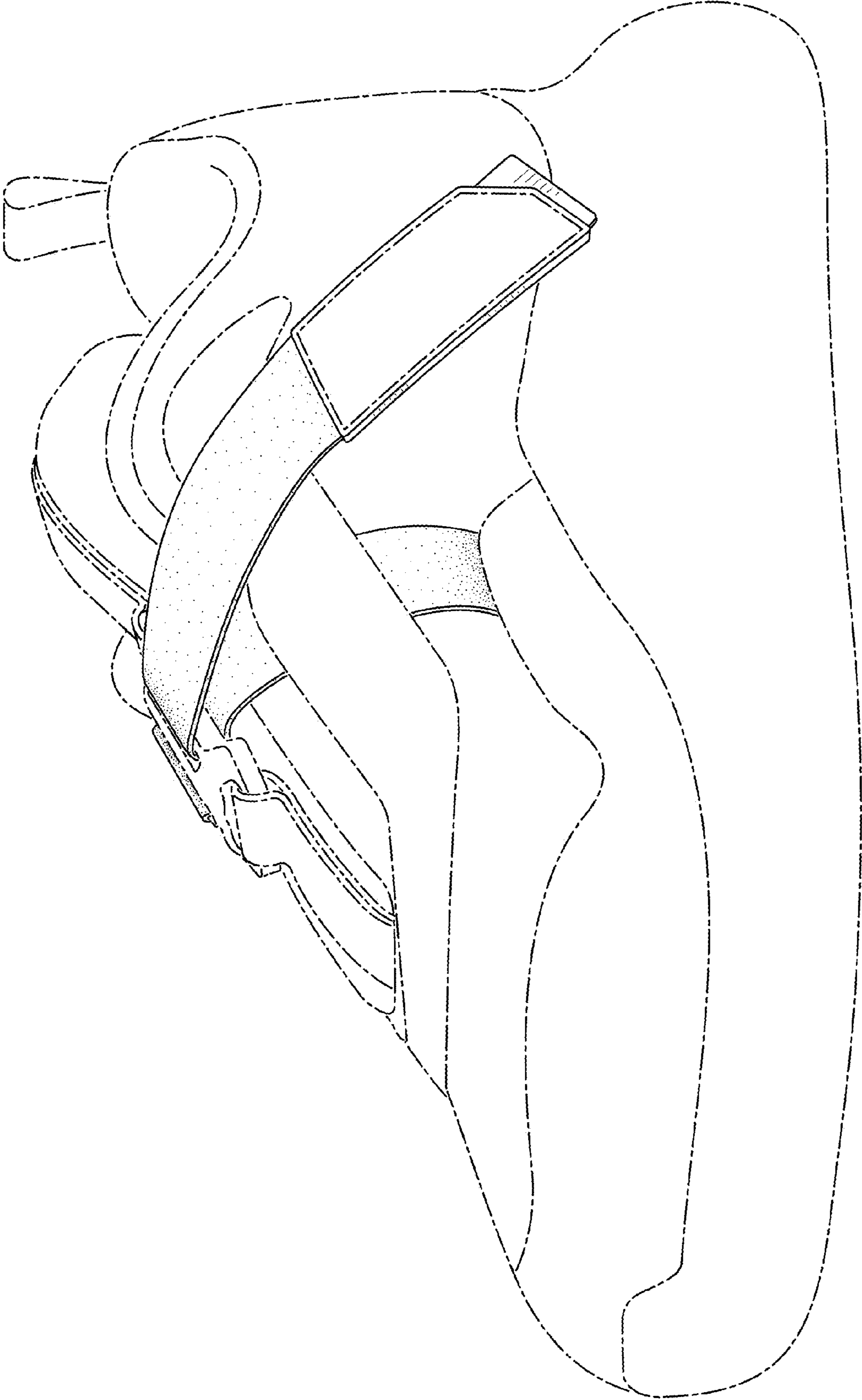

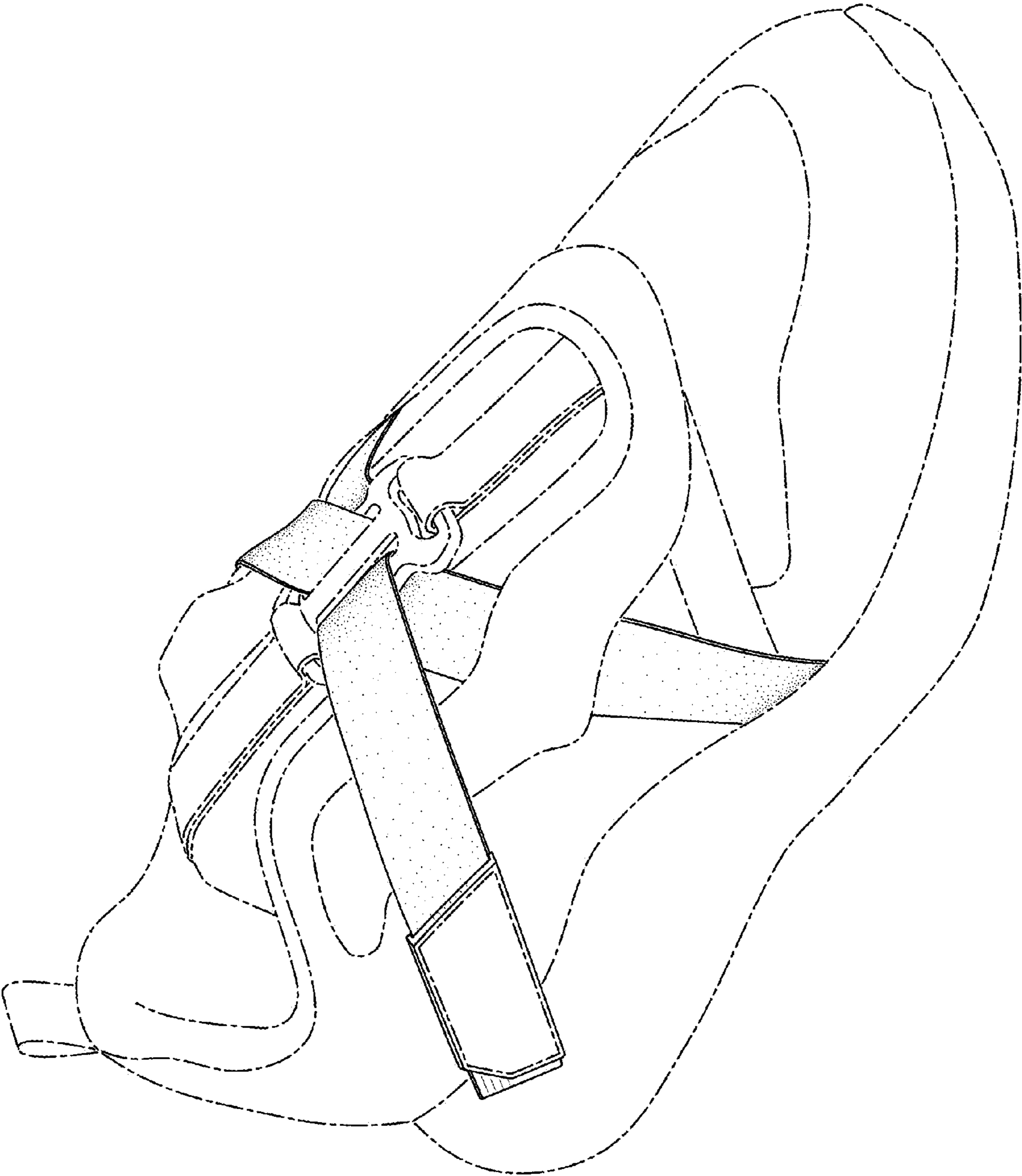

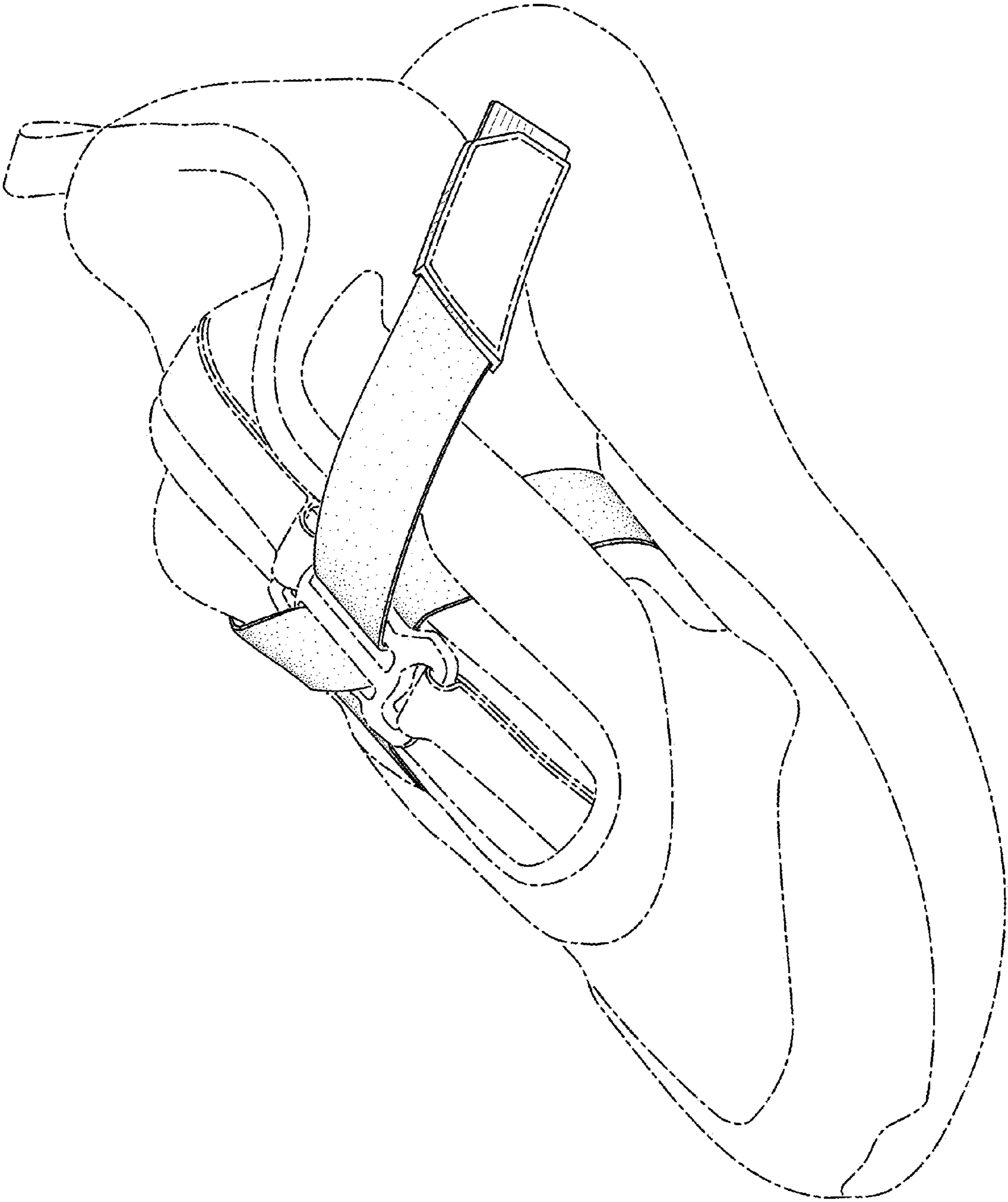
