**DESCRIPTION**

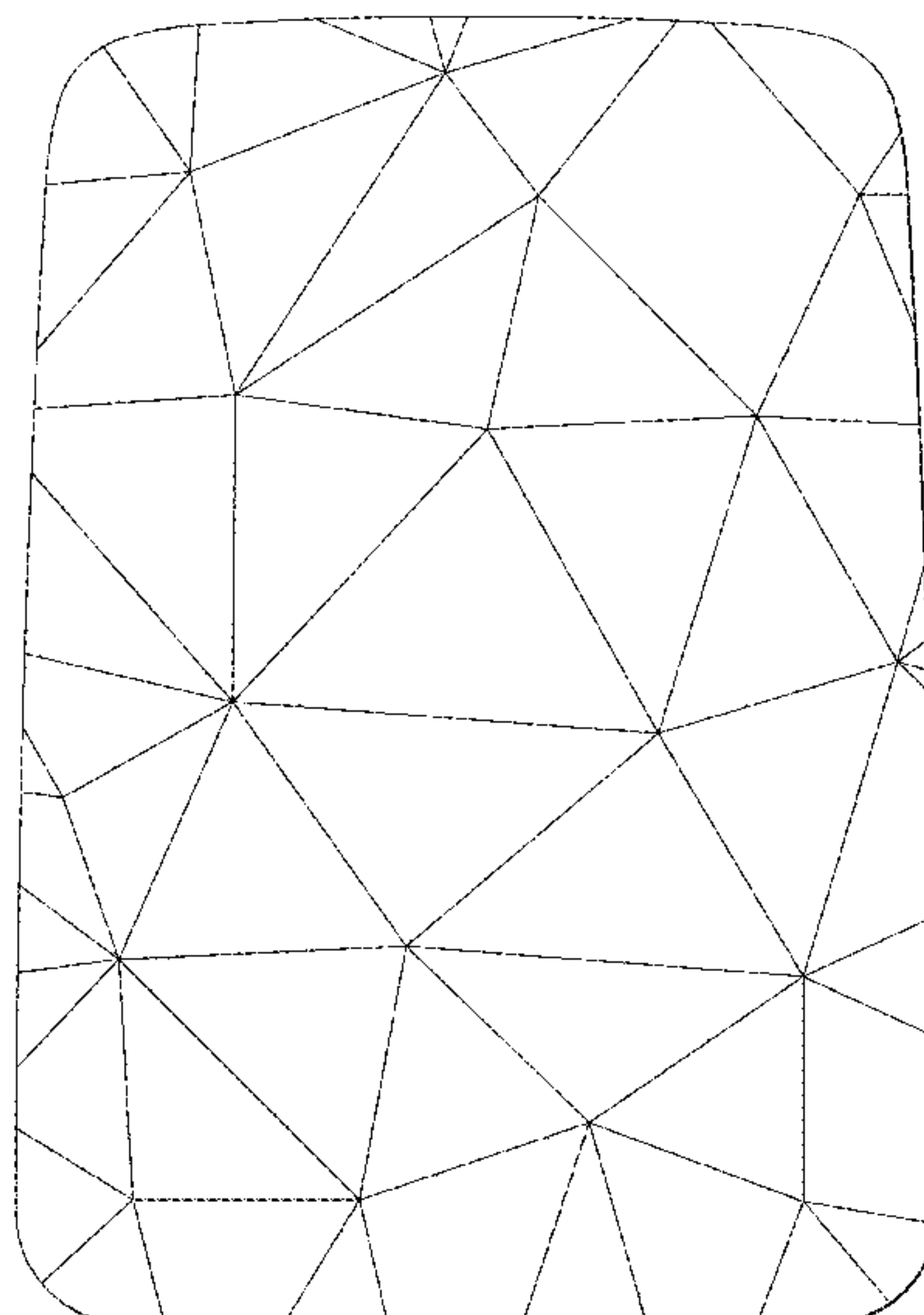

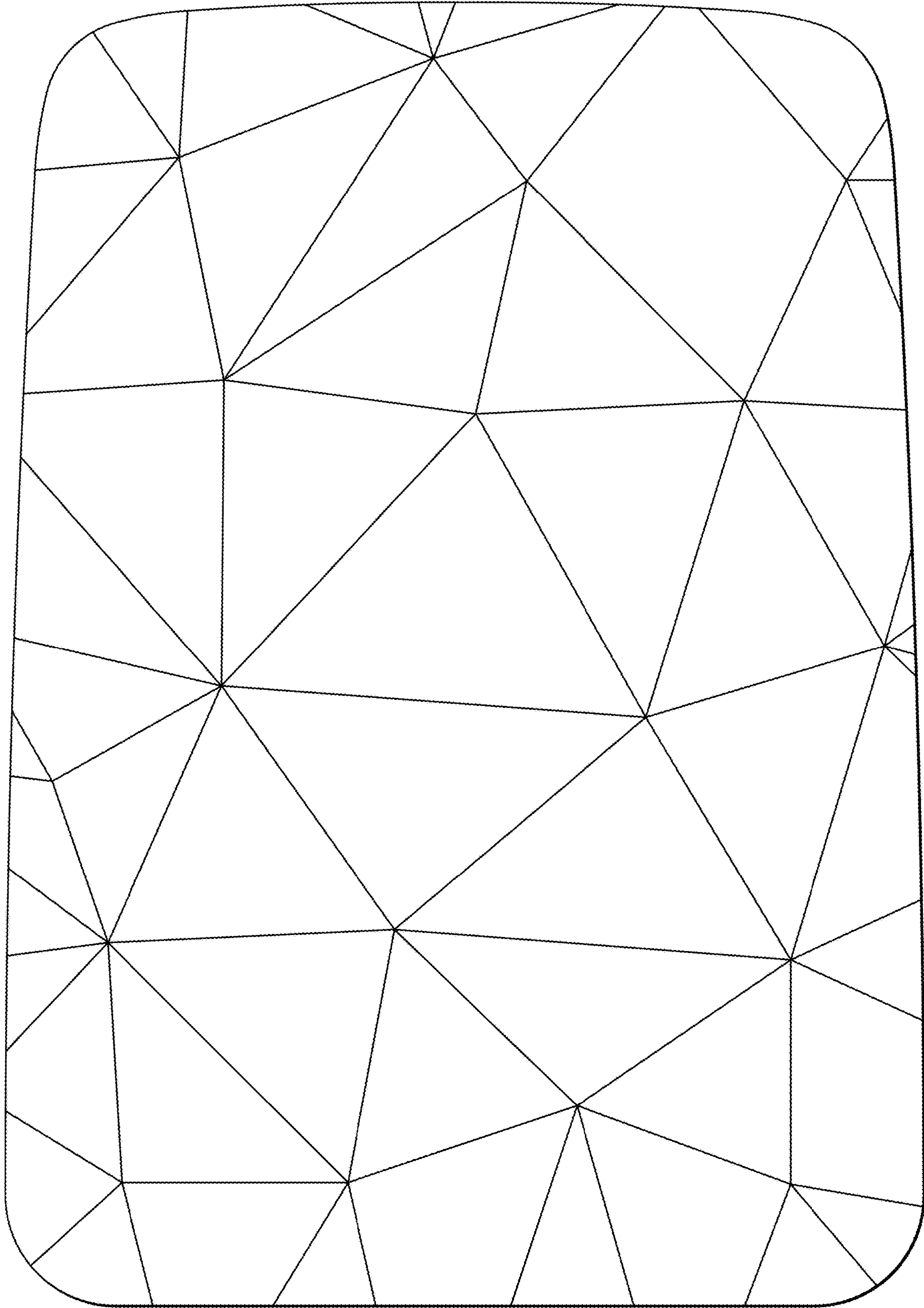
