The ornamental design for a vehicle seat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle seat incorporating my new design, viewed from in front of, above, and from the left side thereof;

FIG. 4 is a left side elevation view thereof;

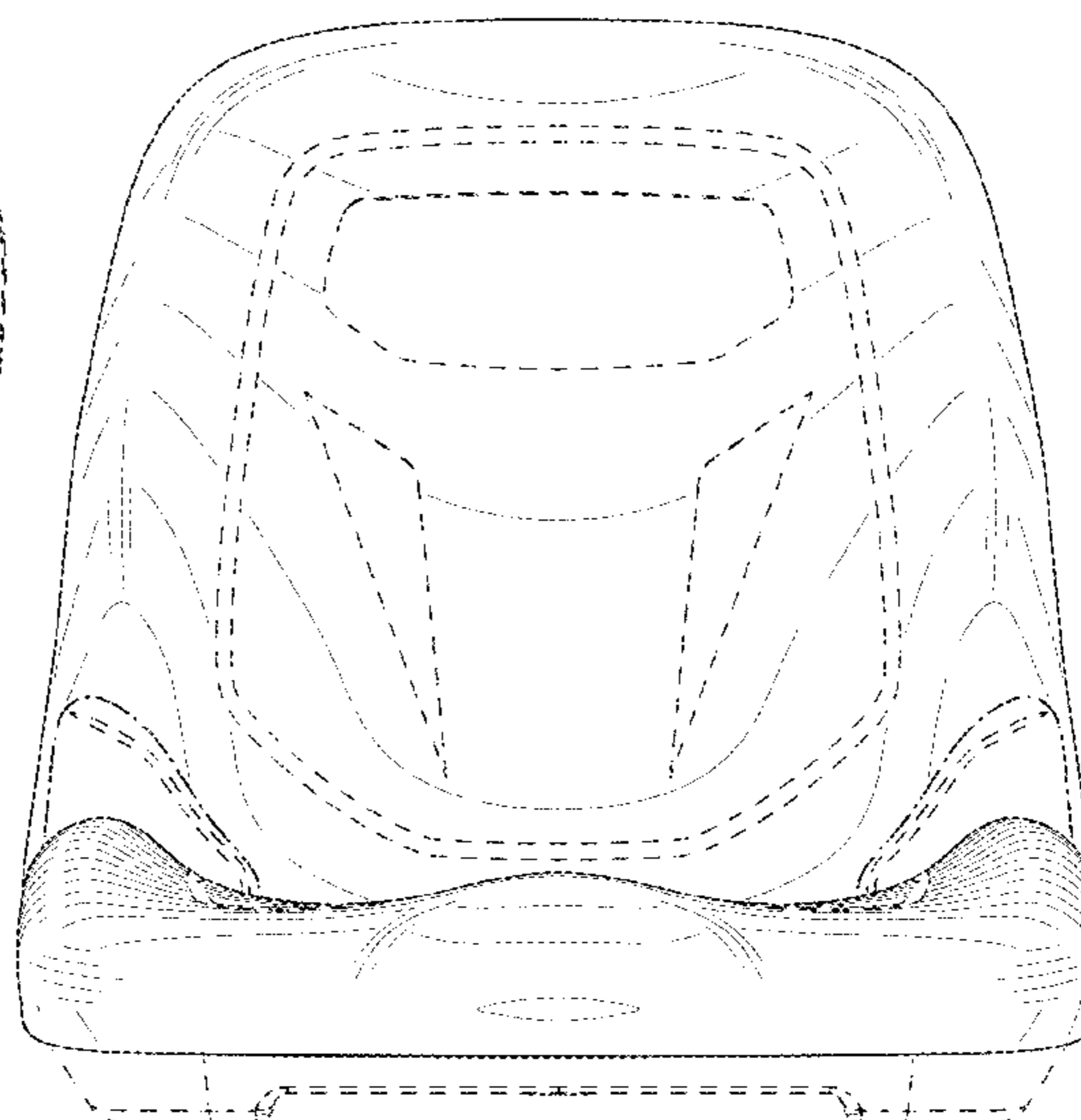
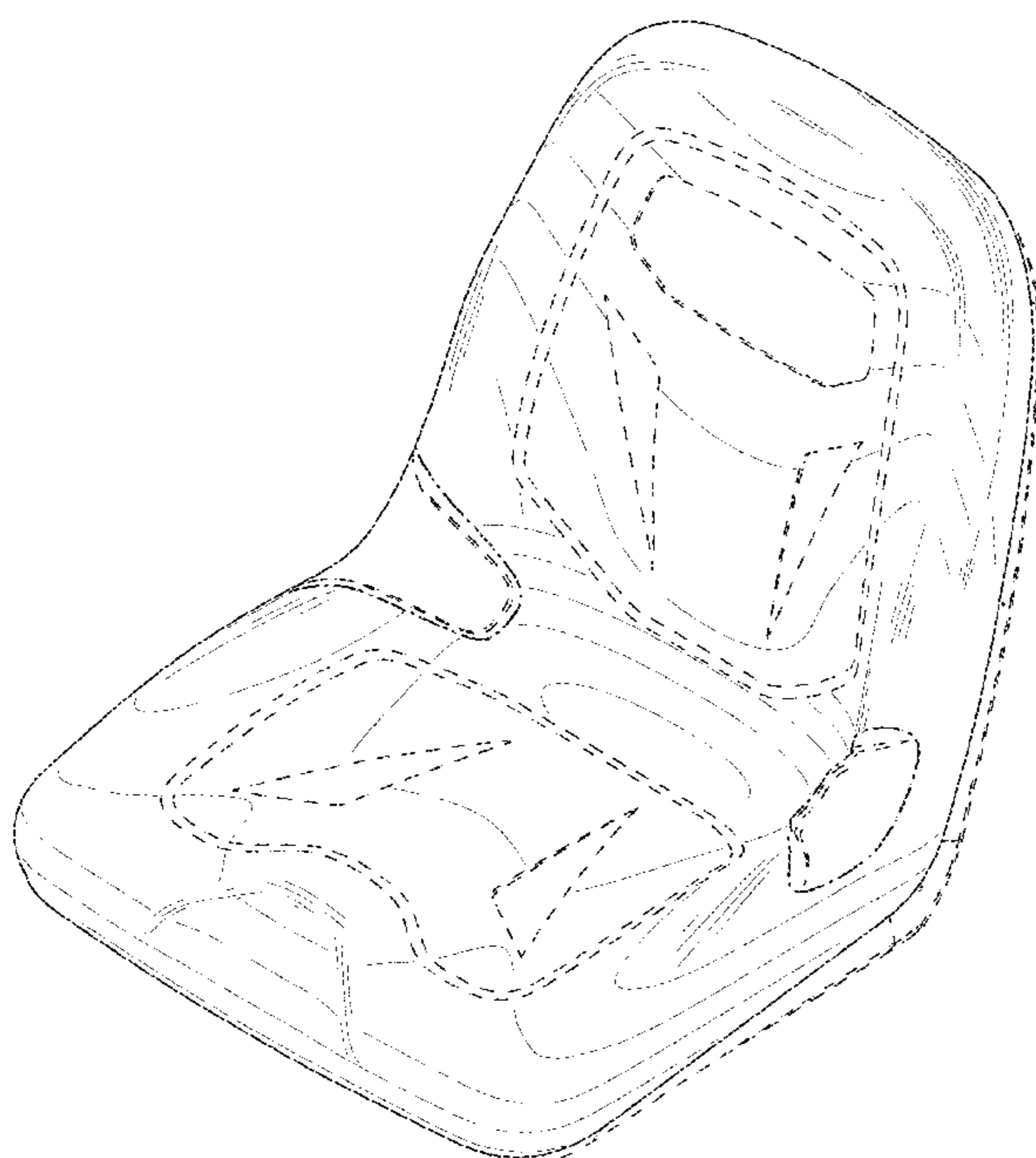
FIG. 5 is a right side elevation view thereof;

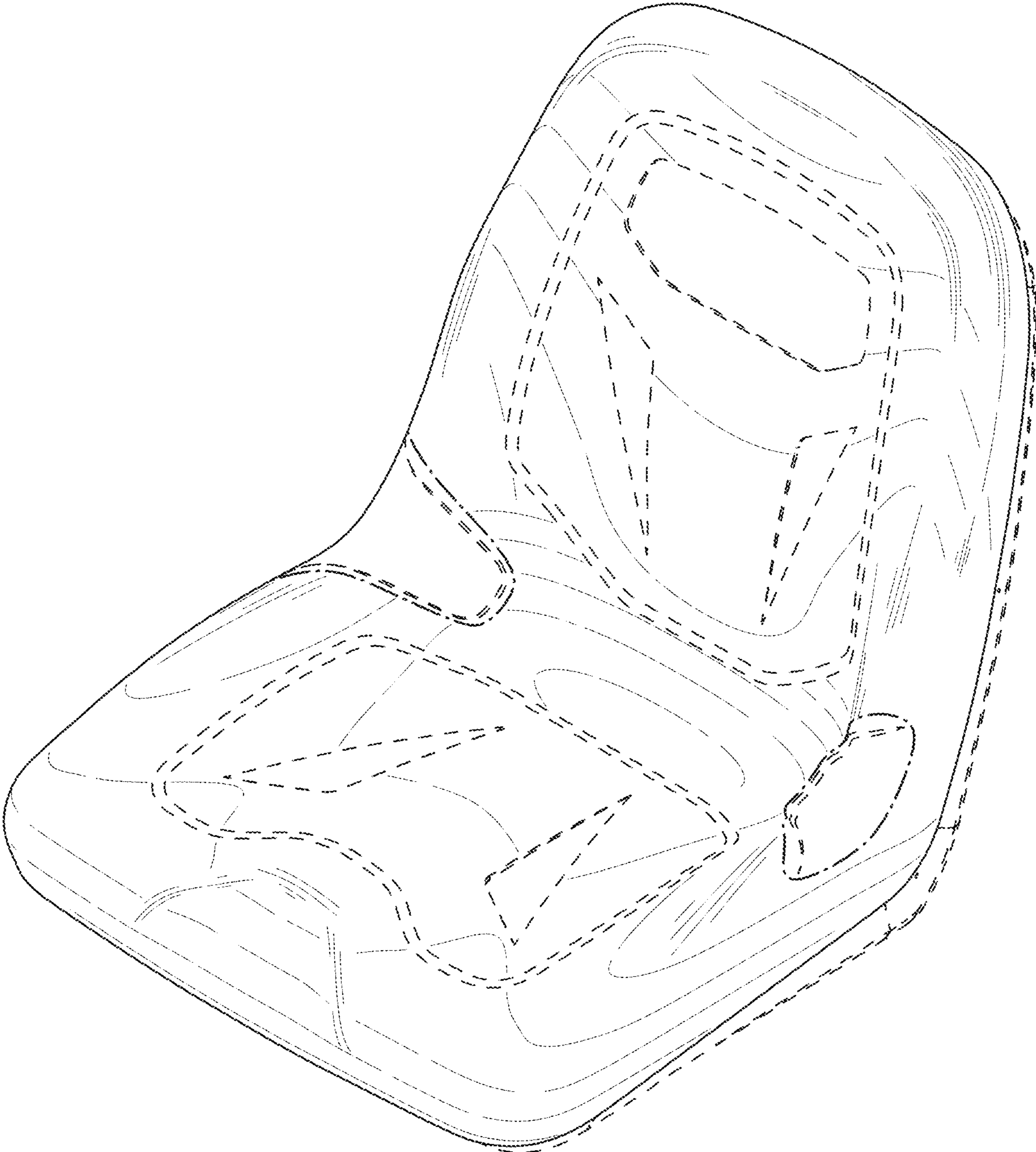

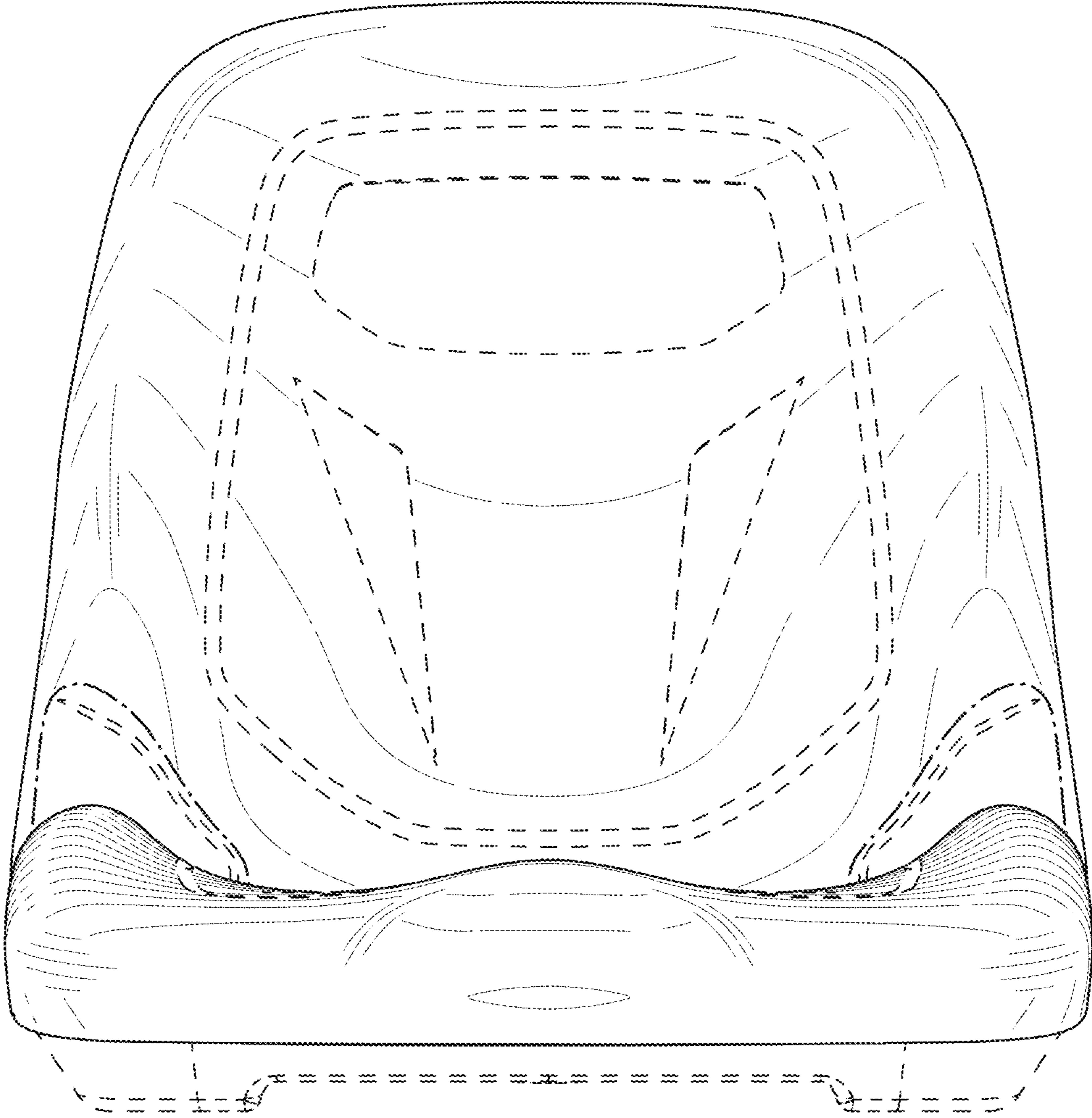

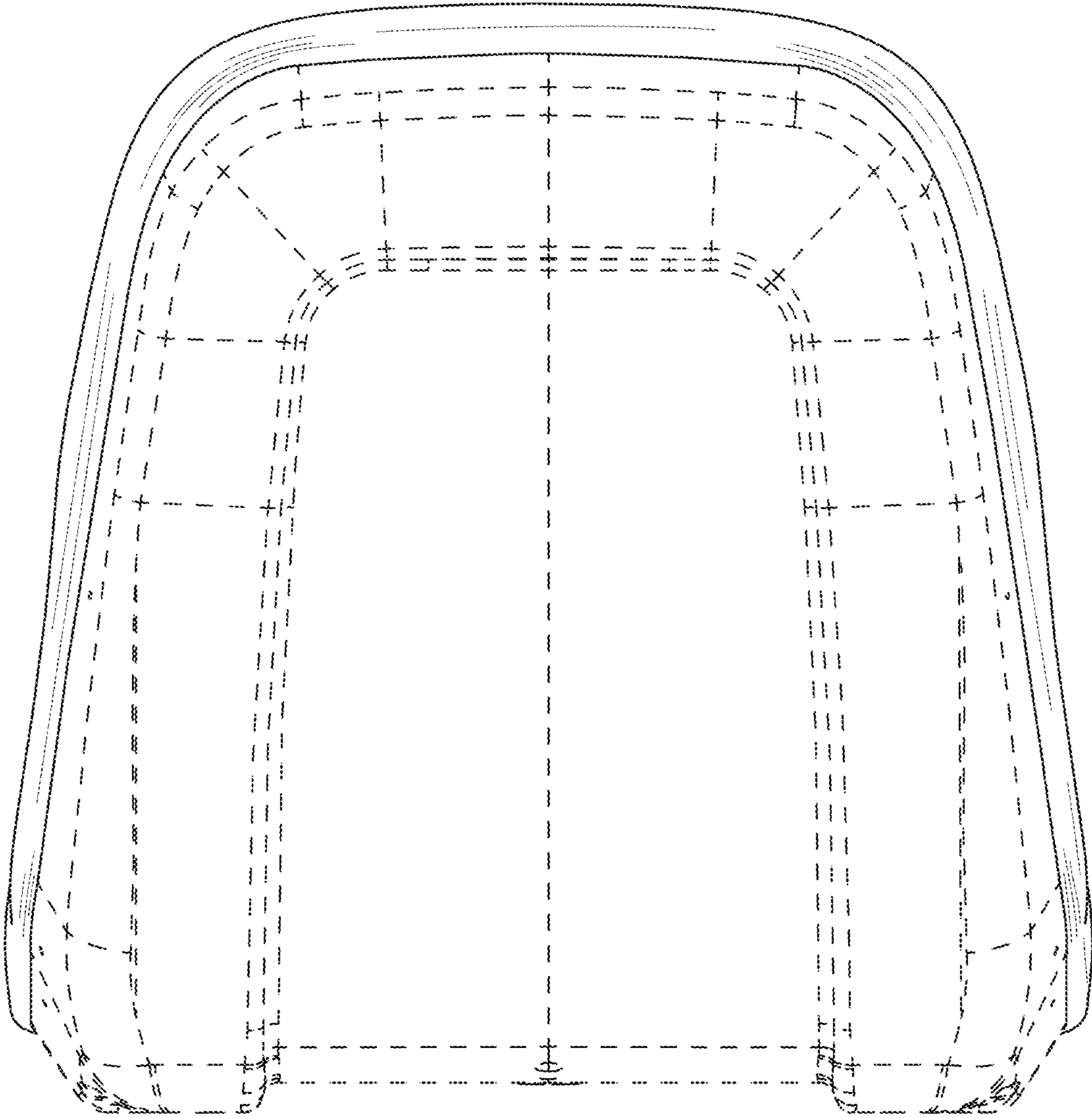

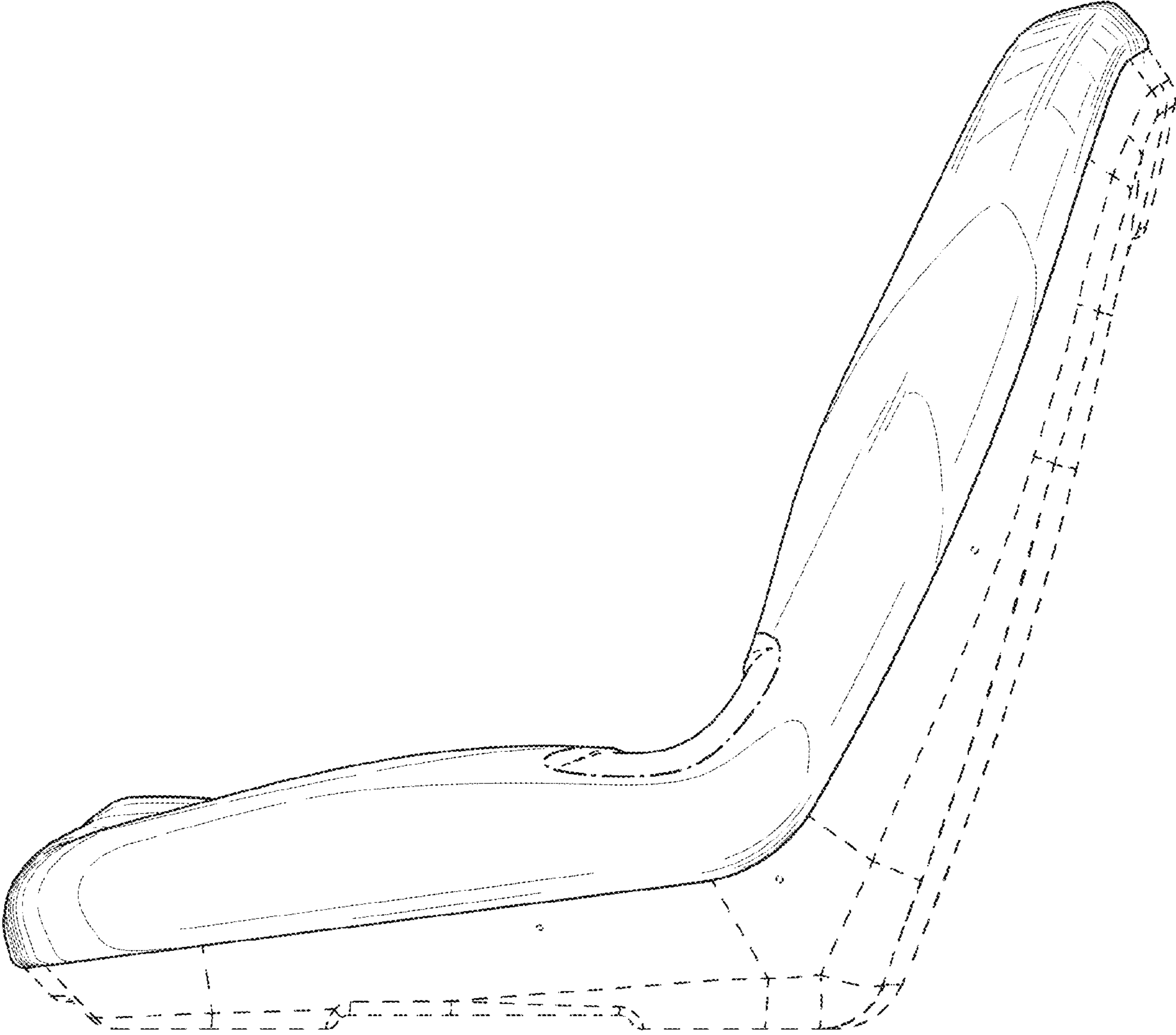

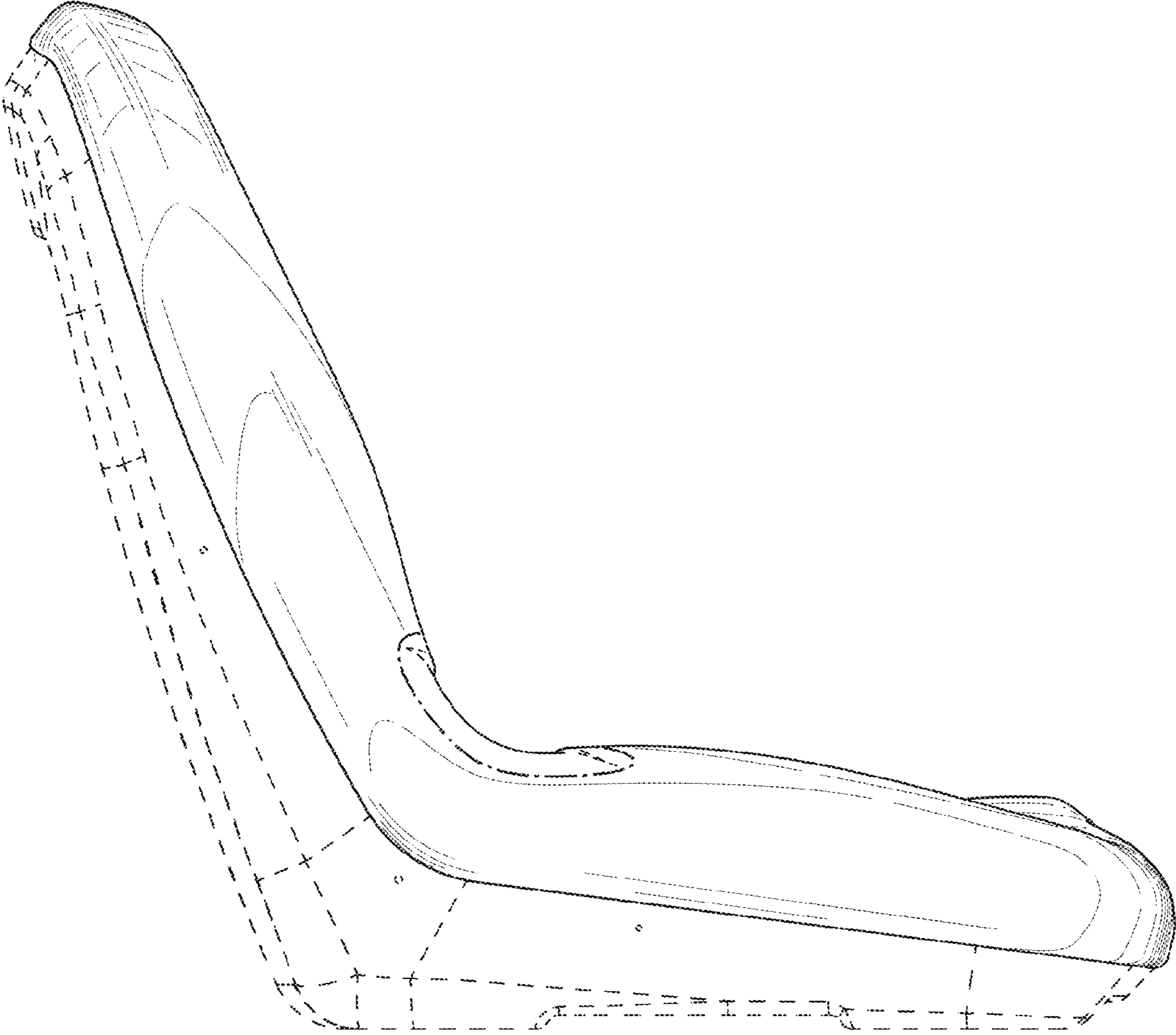

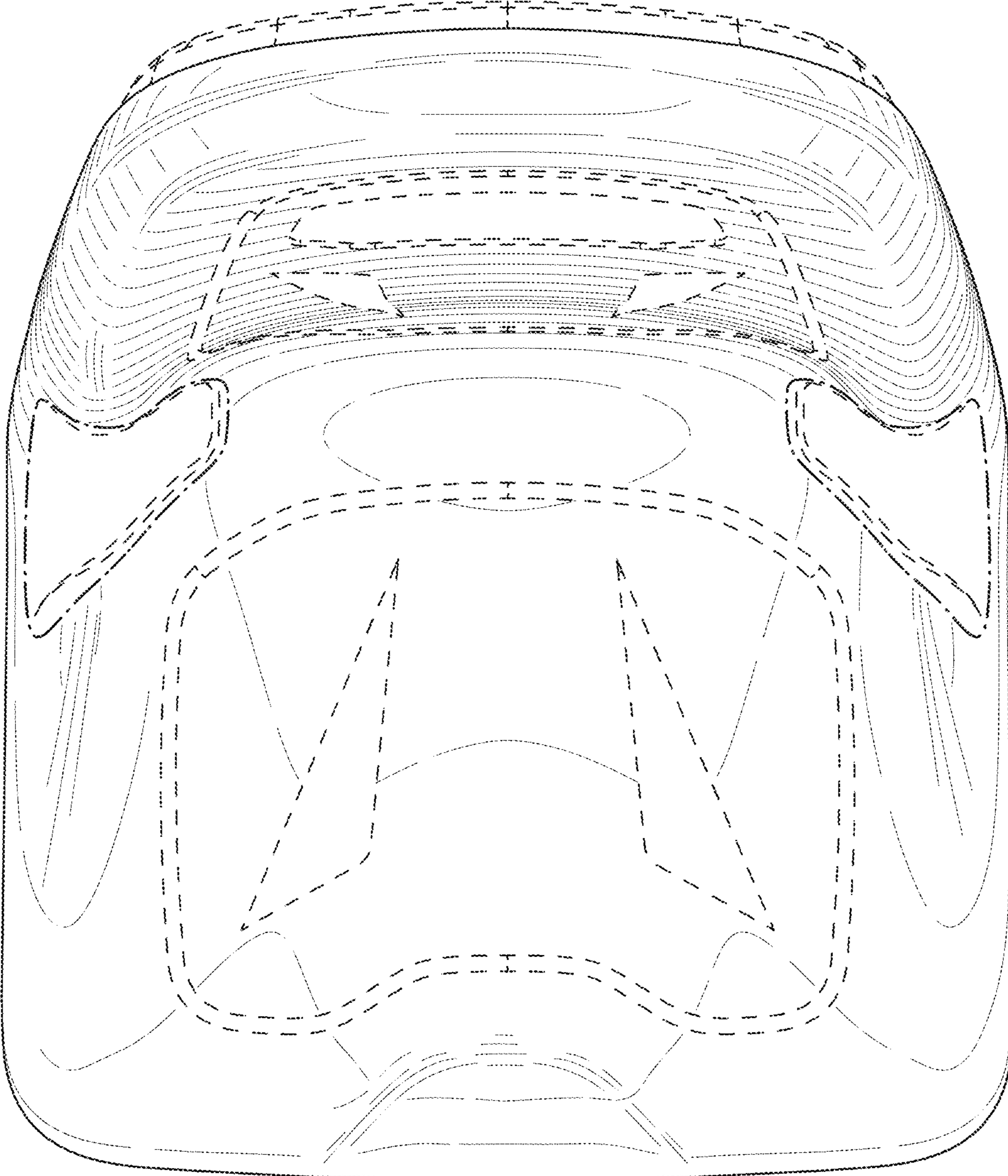

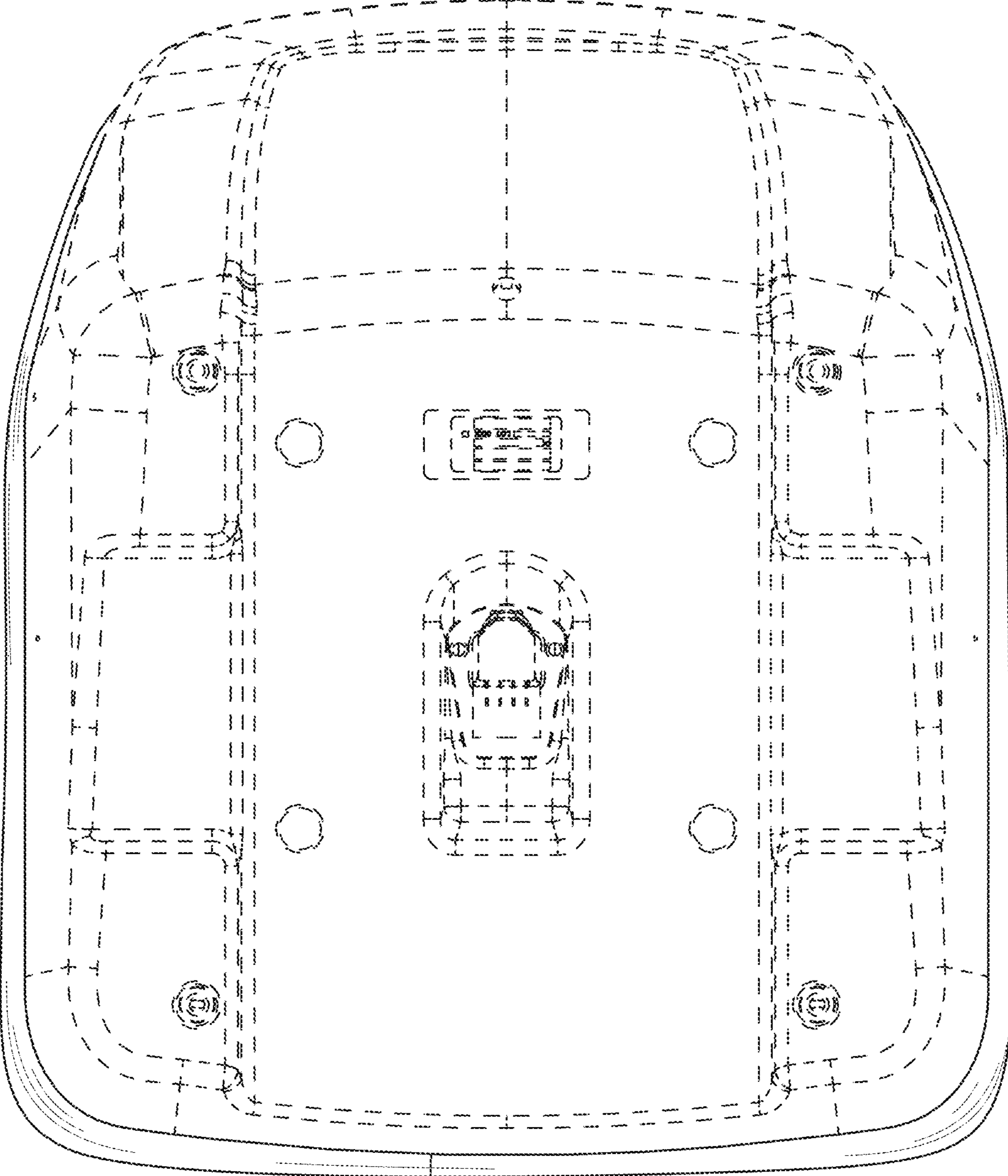
