(57) **CLAIM**

The ornamental design for a folded towel dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a folded towel dispenser according to my new design;

FIG. 2 is a front view of the folded towel dispenser seen in FIG. 1;

FIG. 3 is a rear view of the folded towel dispenser seen in FIG. 1;

FIG. 4 is a left side view of the folded towel dispenser seen in FIG. 1, the right side view being a mirror image of the same;

FIG. 5 is a top view of the folded towel dispenser seen in FIG. 1;

FIG. 6 is a bottom view of the folded towel dispenser seen in FIG. 1;

FIG. 7 is a perspective view of a second embodiment of a folded towel dispenser according to my new design;

FIG. 8 is a front view of the folded towel dispenser seen in FIG. 7;

FIG. 9 is a rear view of the folded towel dispenser seen in FIG. 7;

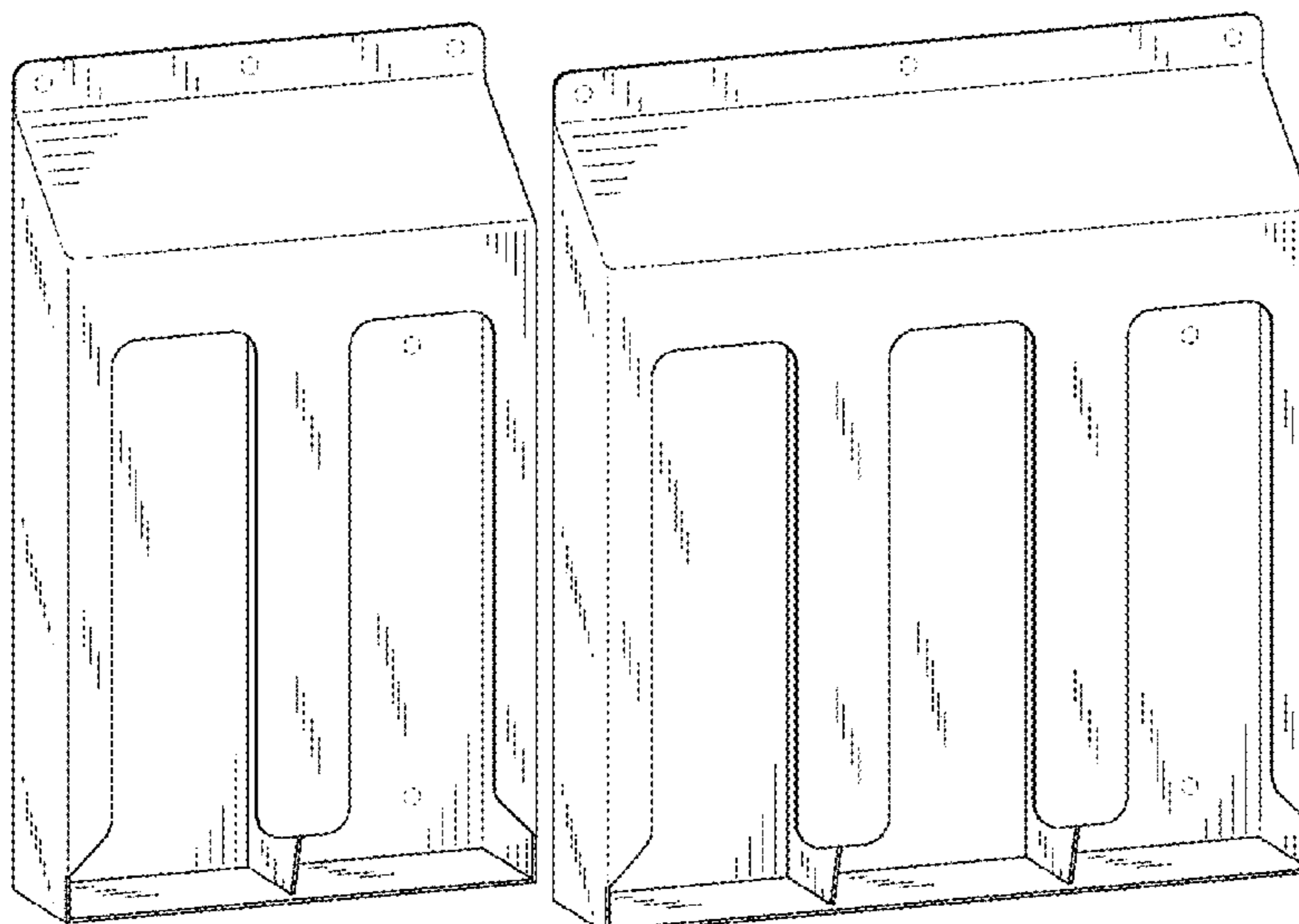
FIG. 10 is a left side view of the folded towel dispenser seen in FIG. 7, the right side view being a mirror image of the same;

FIG. 11 is a top view of the folded towel dispenser seen in FIG. 7; and,

FIG. 12 is a bottom view of the folded towel dispenser seen in FIG. 7.

Broken lines in the figures illustrate portions of the folded towel dispenser that form no part of the claimed design. Shade lines in the figures show contour and not surface ornamentation.

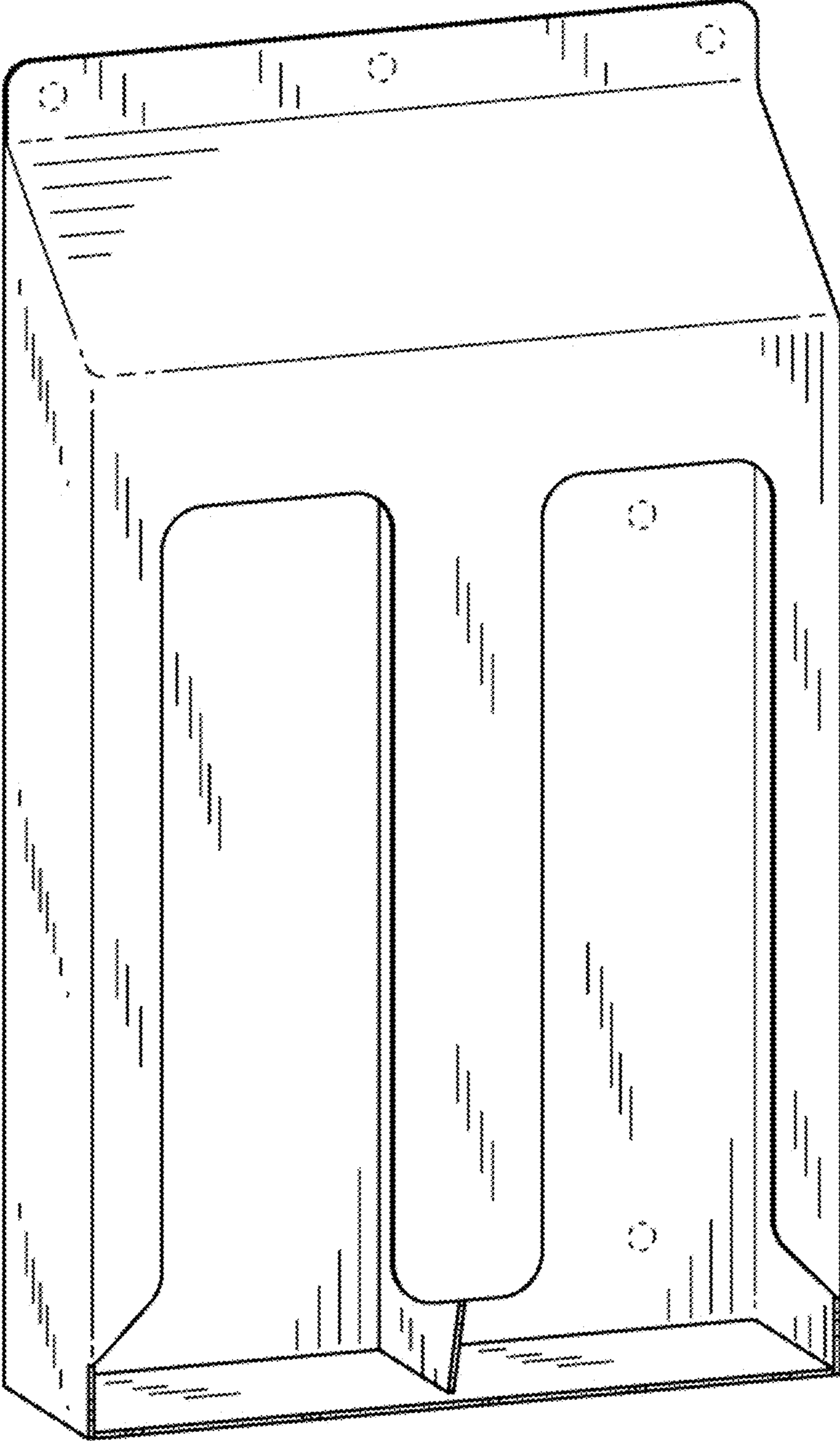

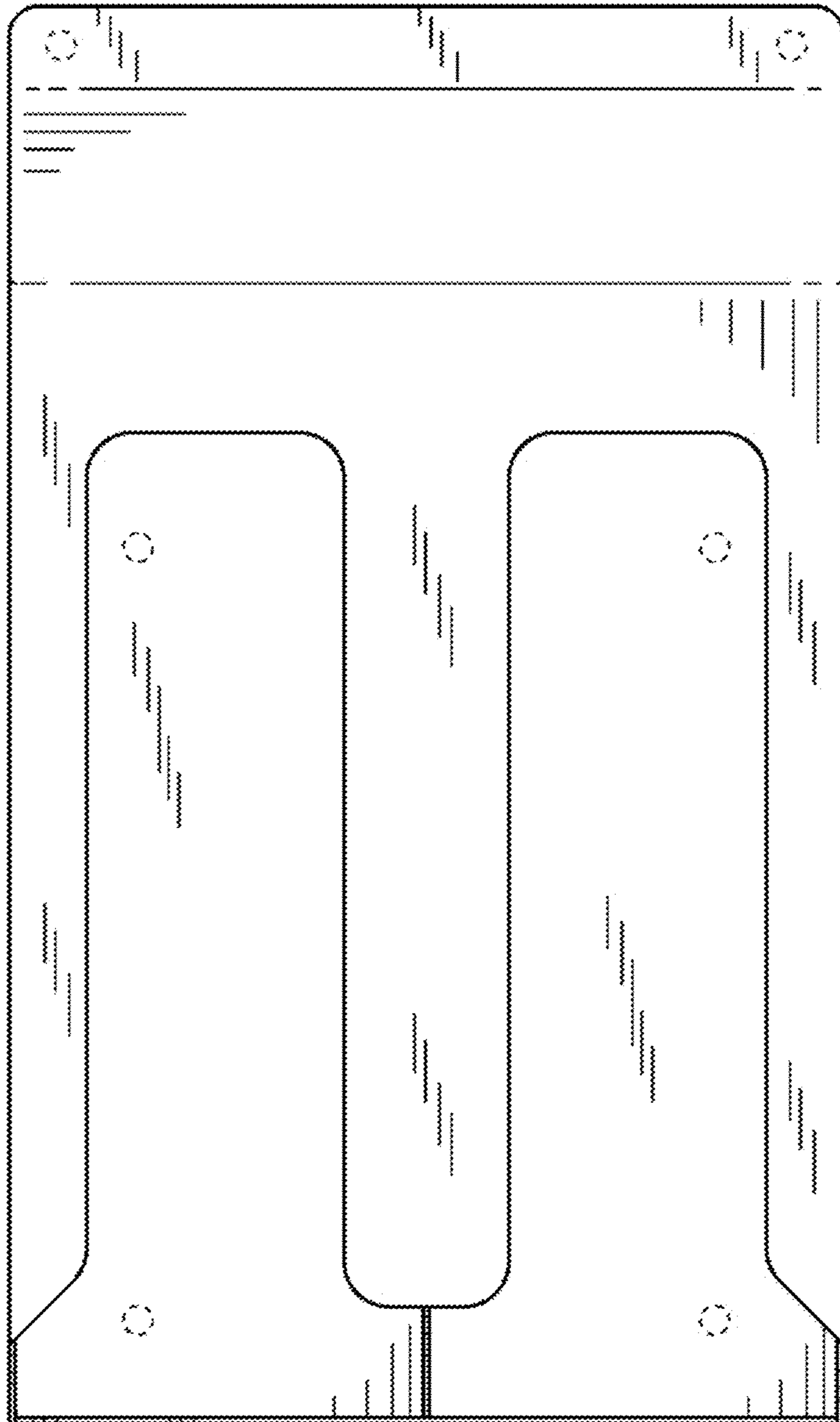

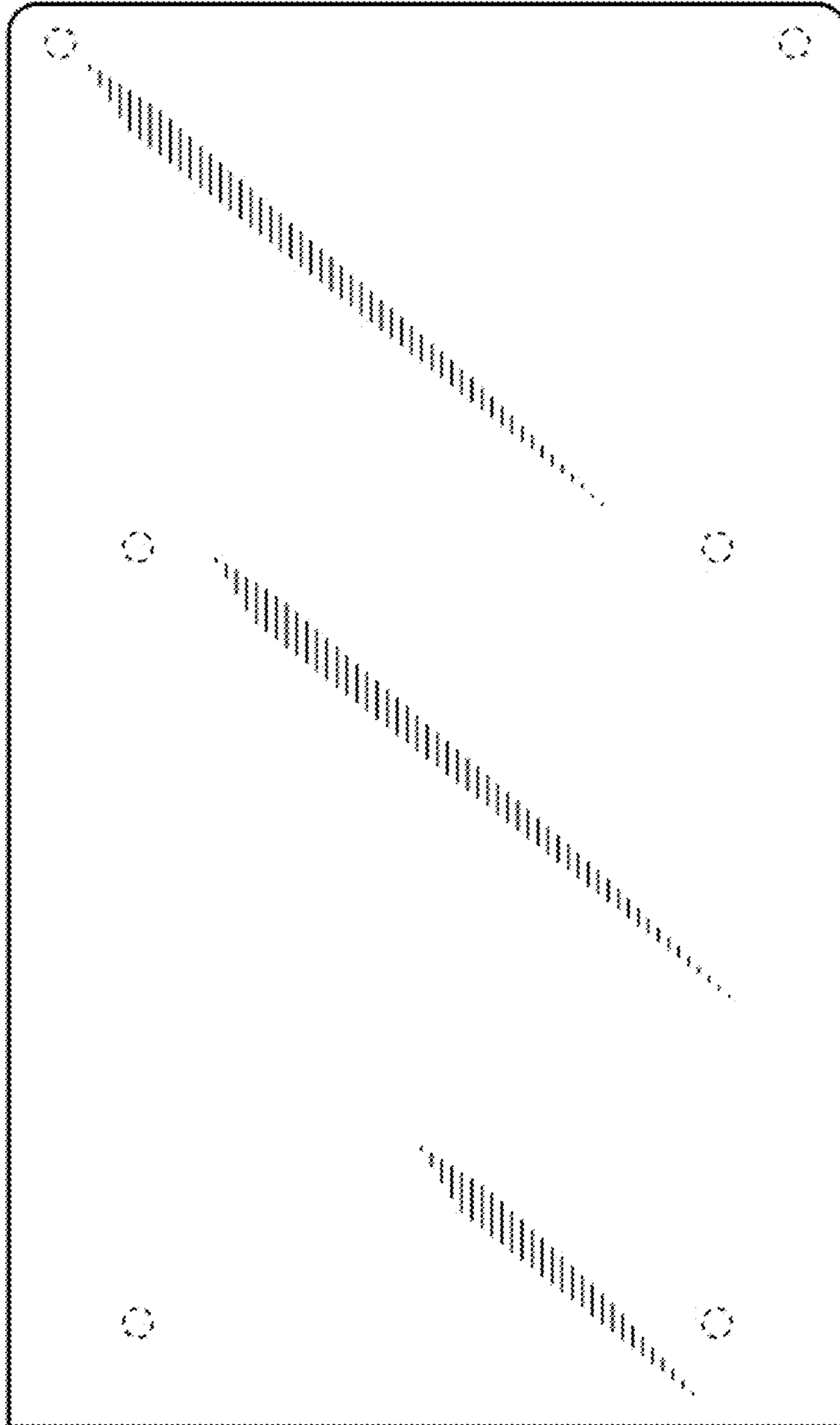

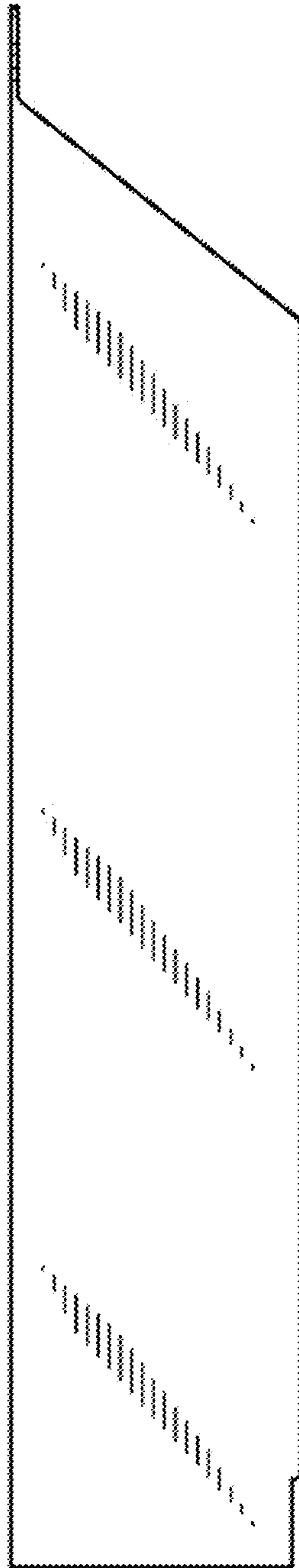

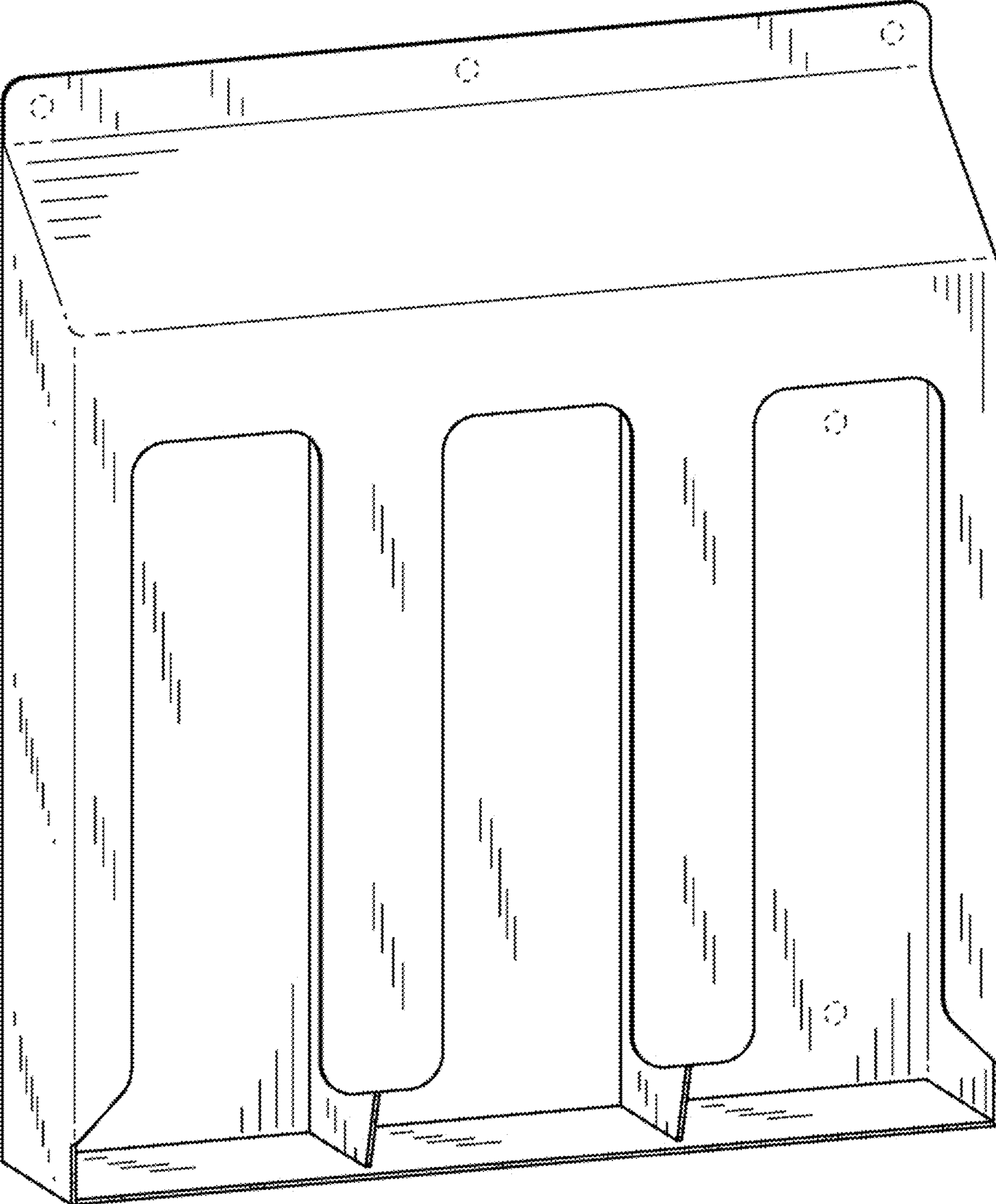

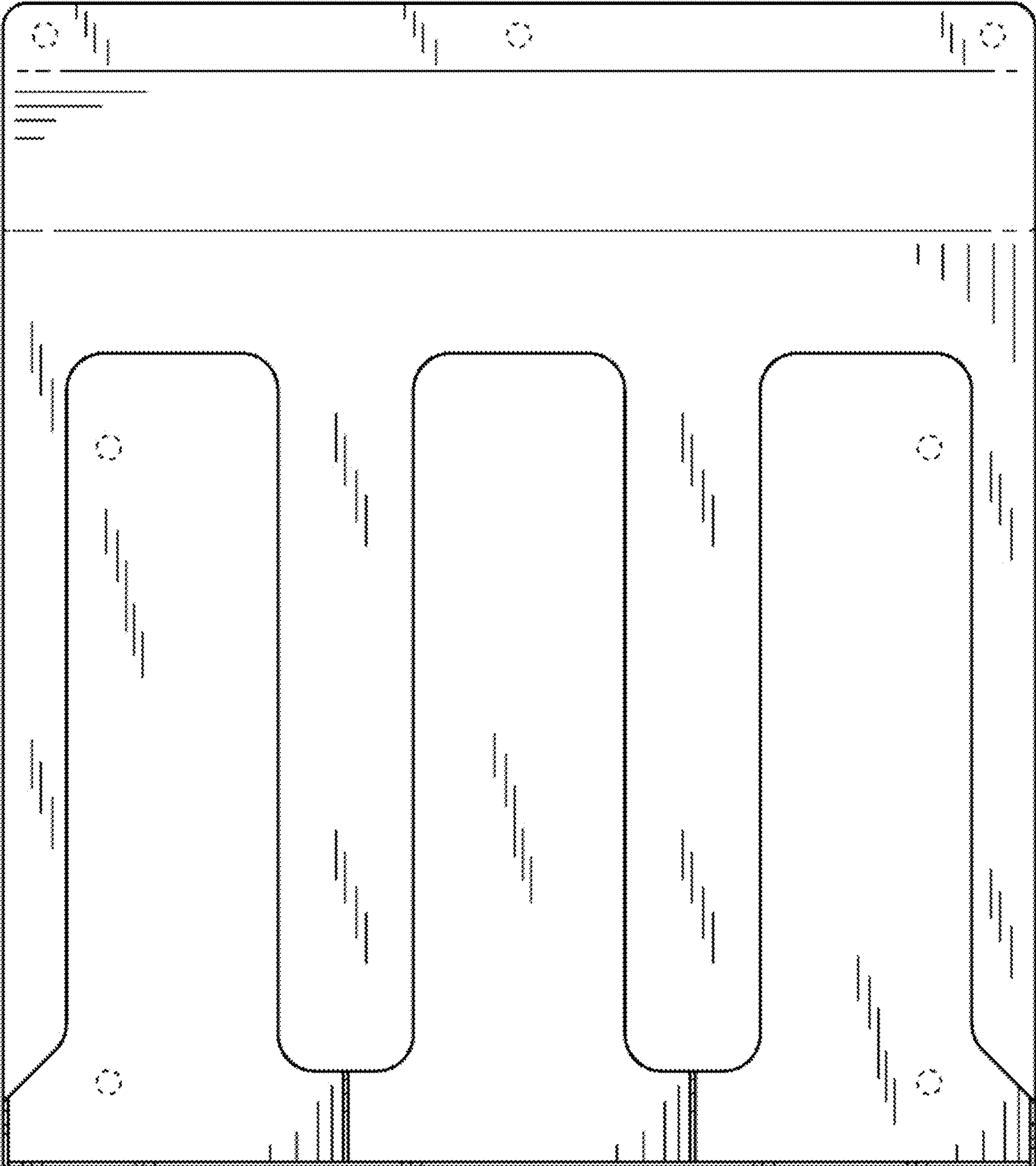

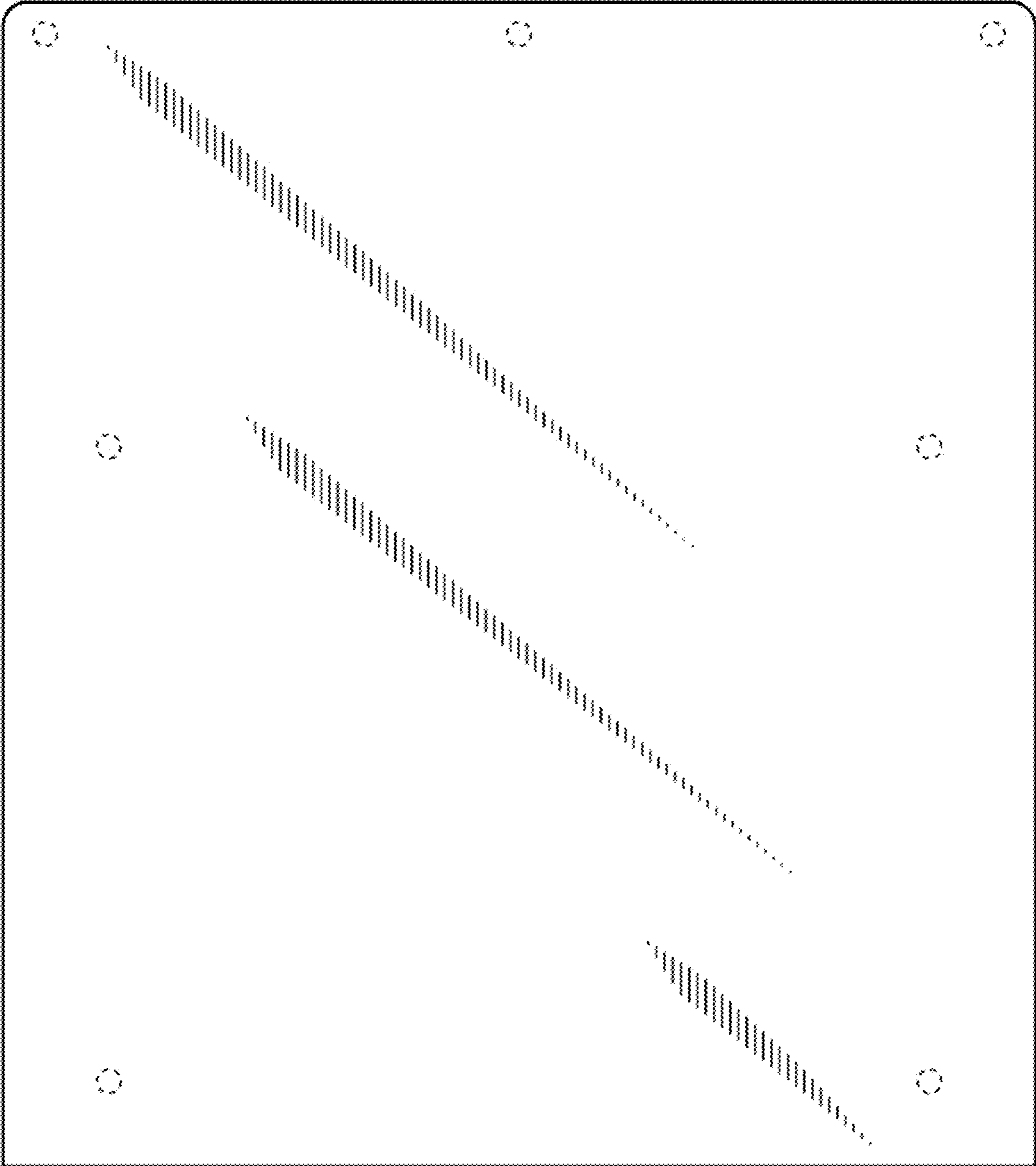

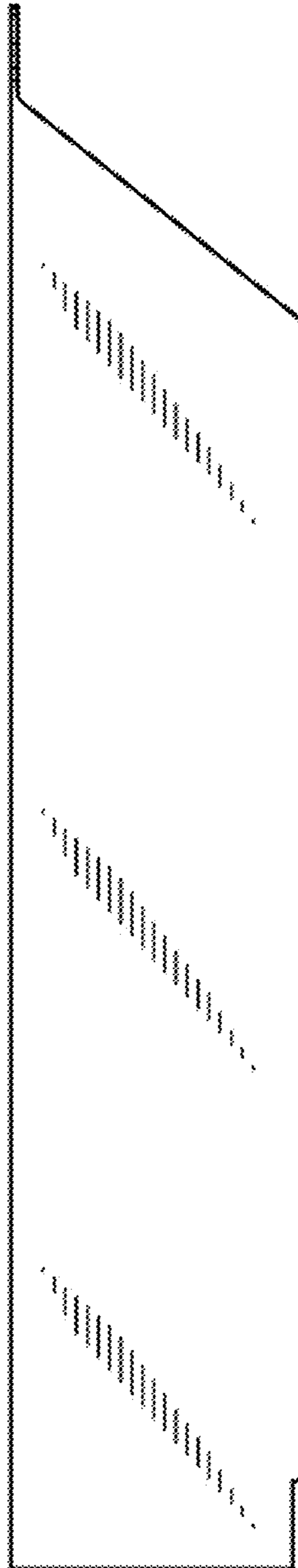

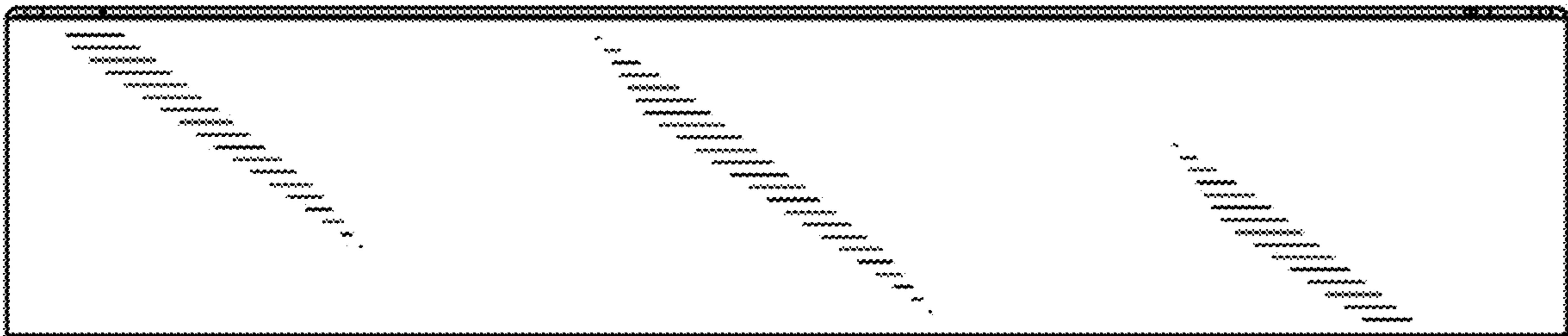
