**DESCRIPTION**

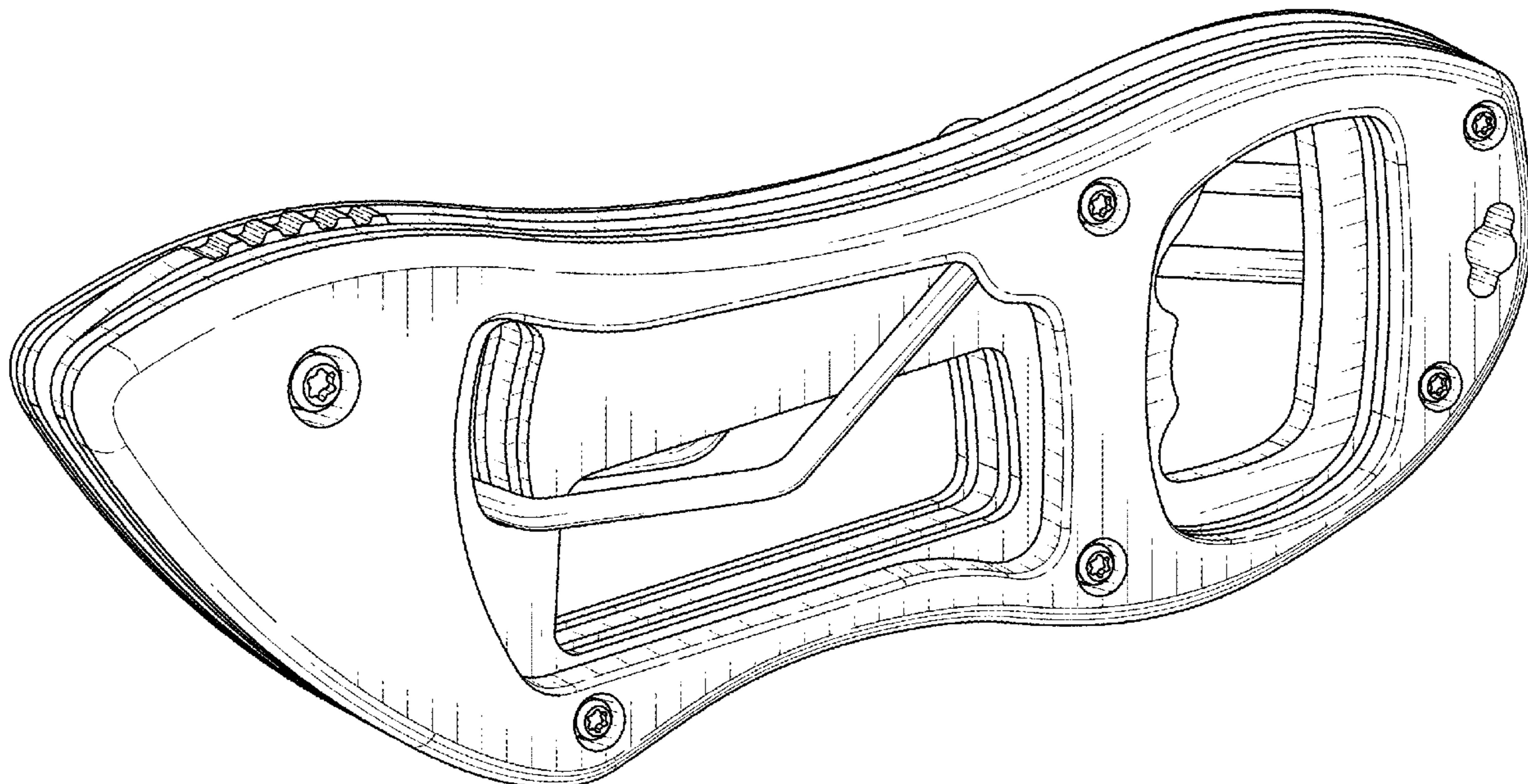
FIG. 1 is a perspective view of a utility knife, showing my new design;

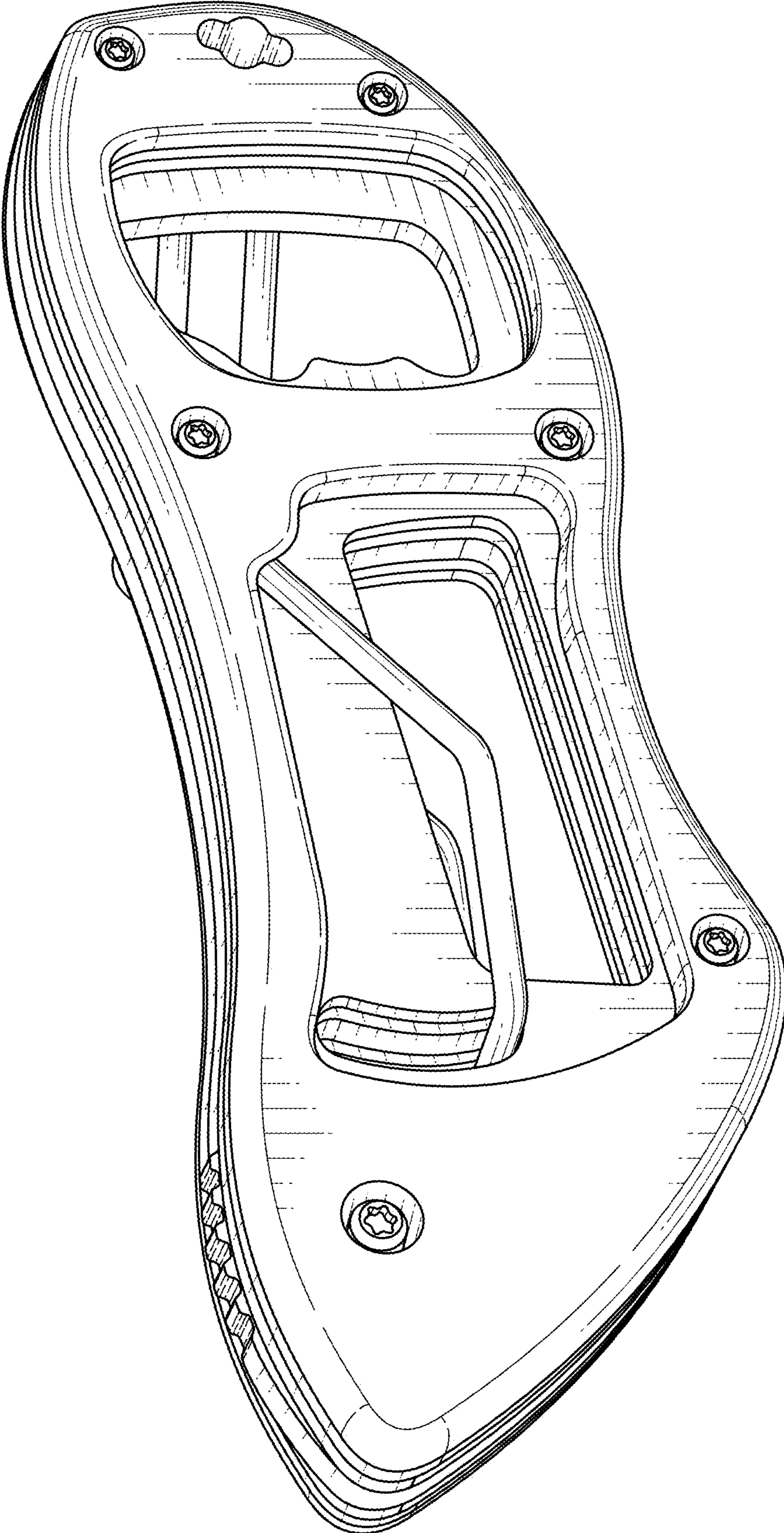

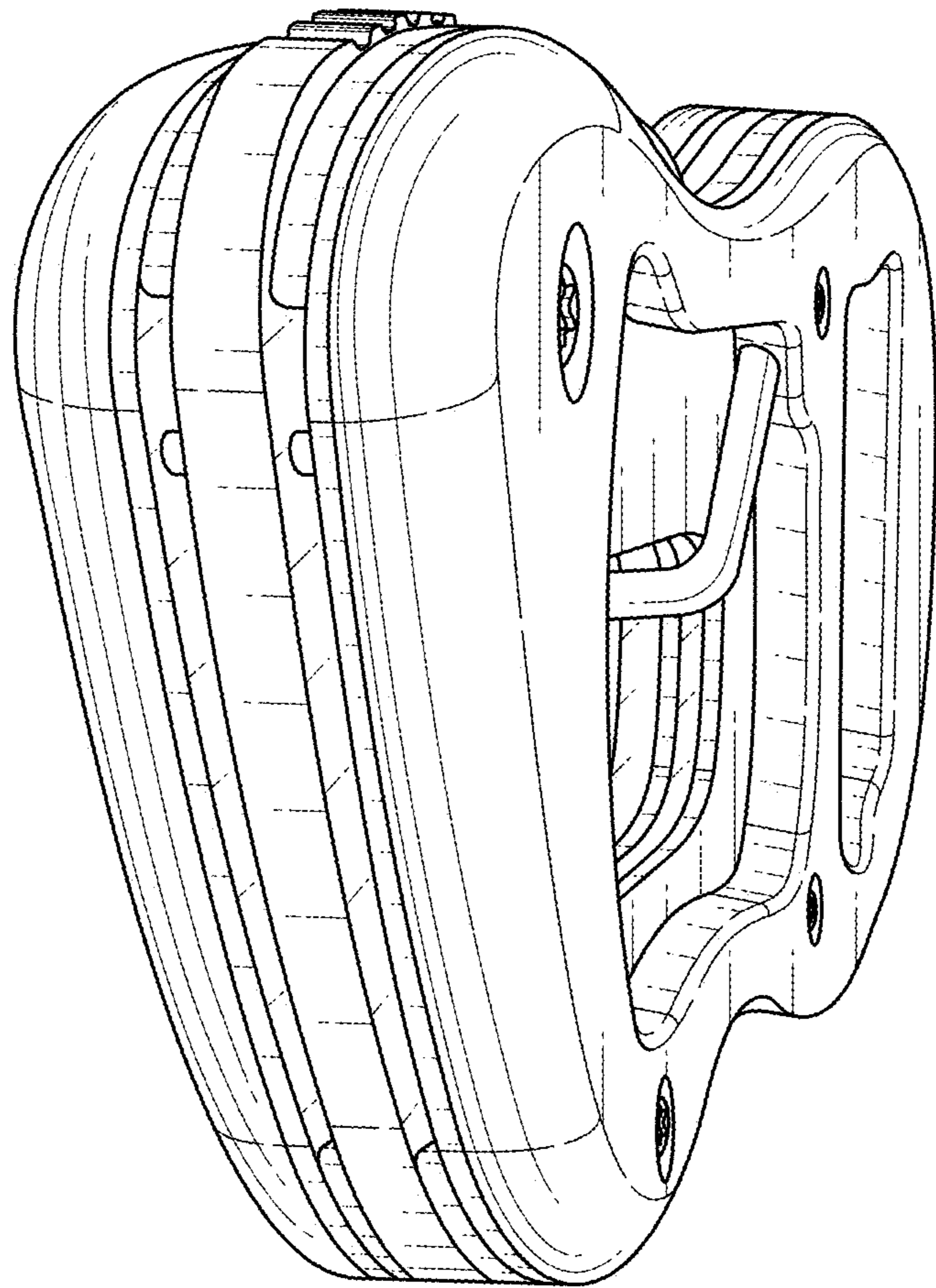

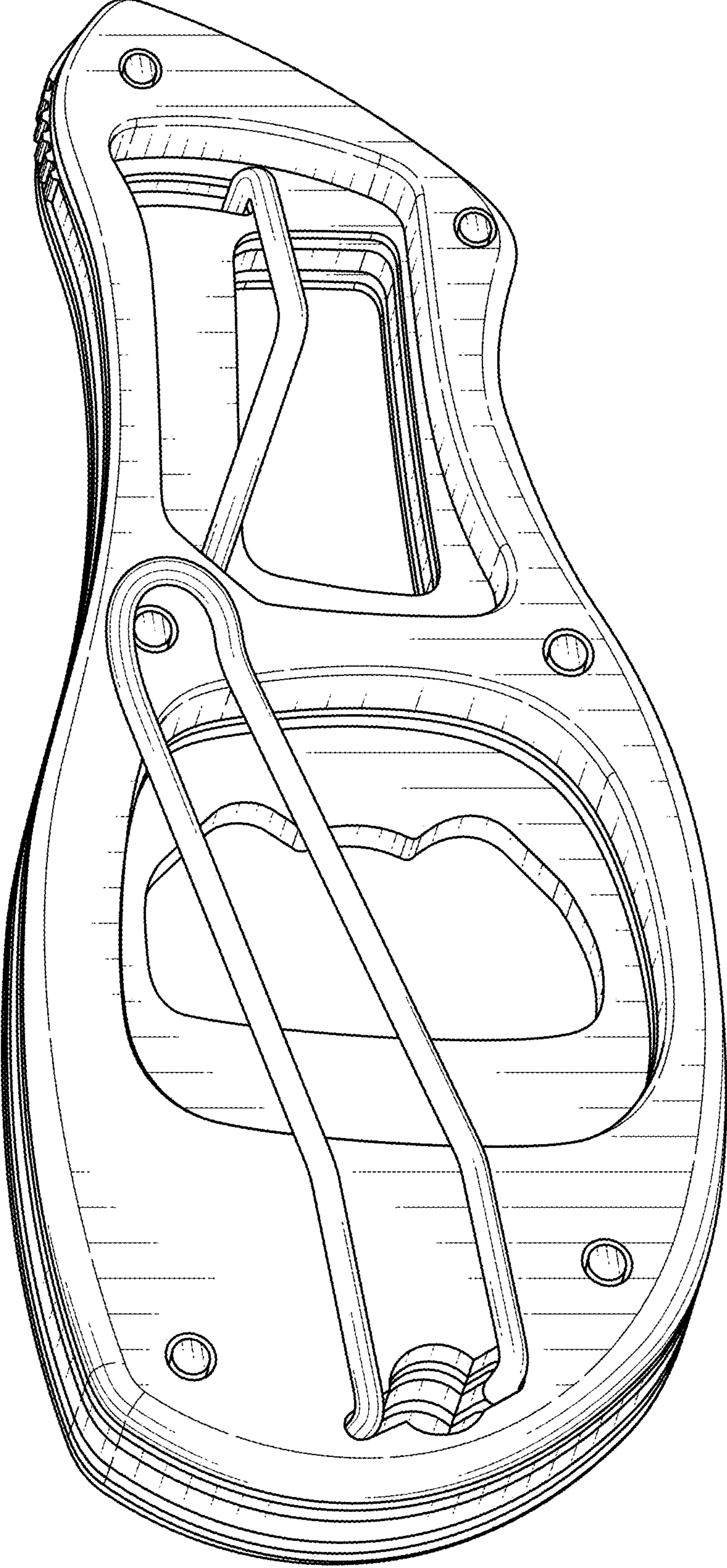

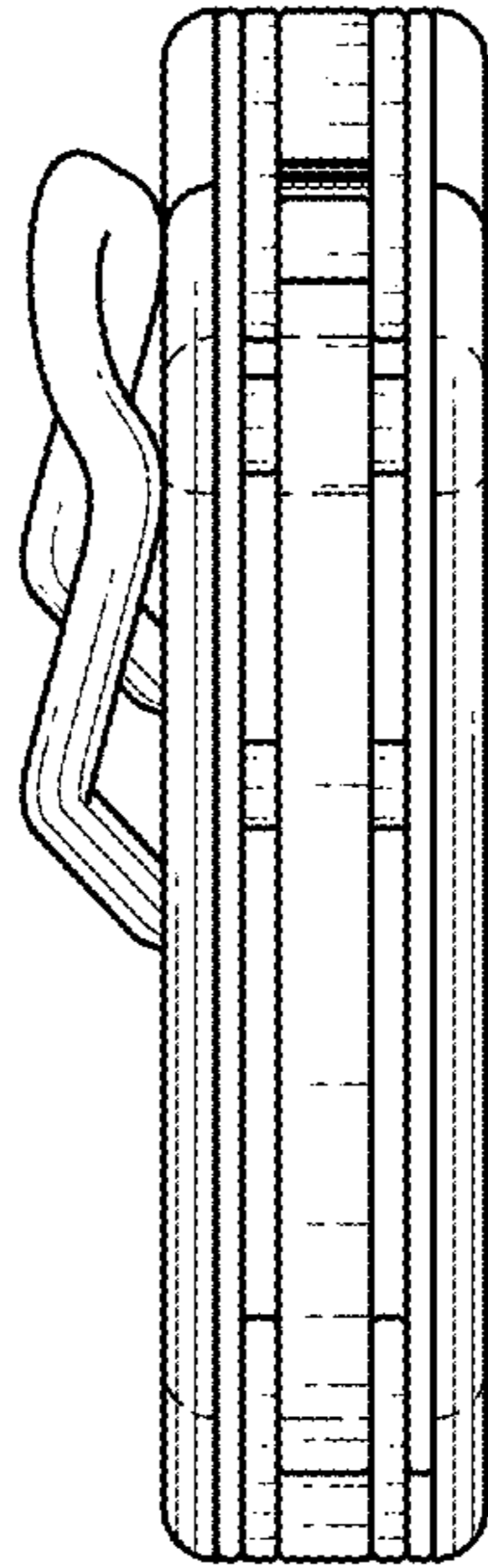

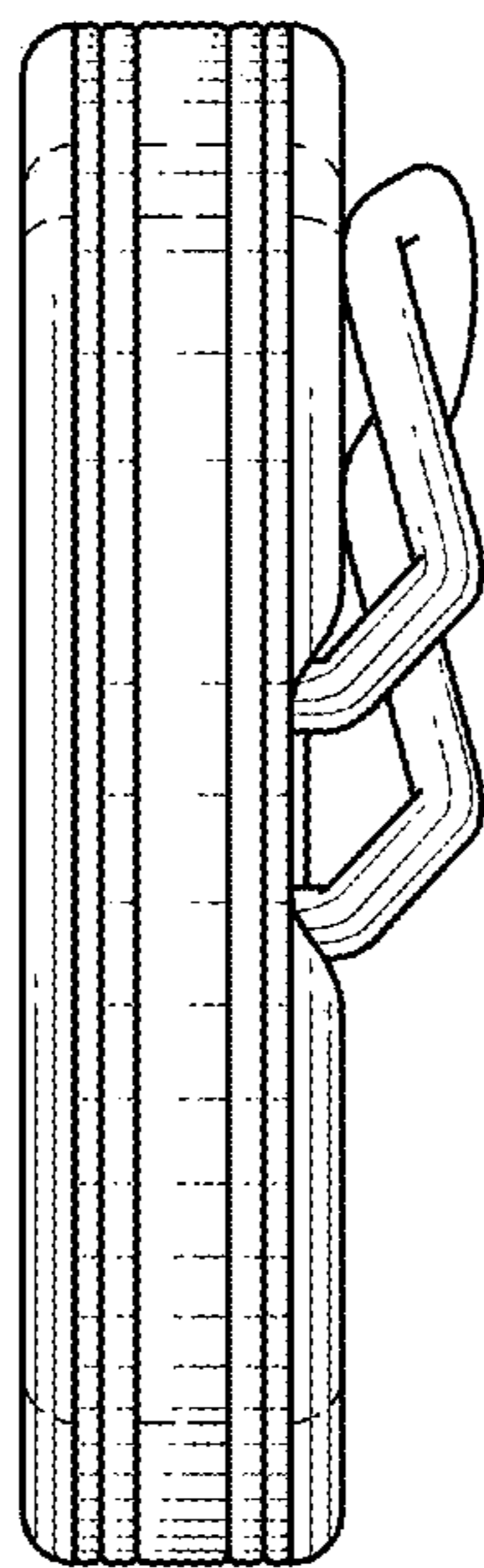

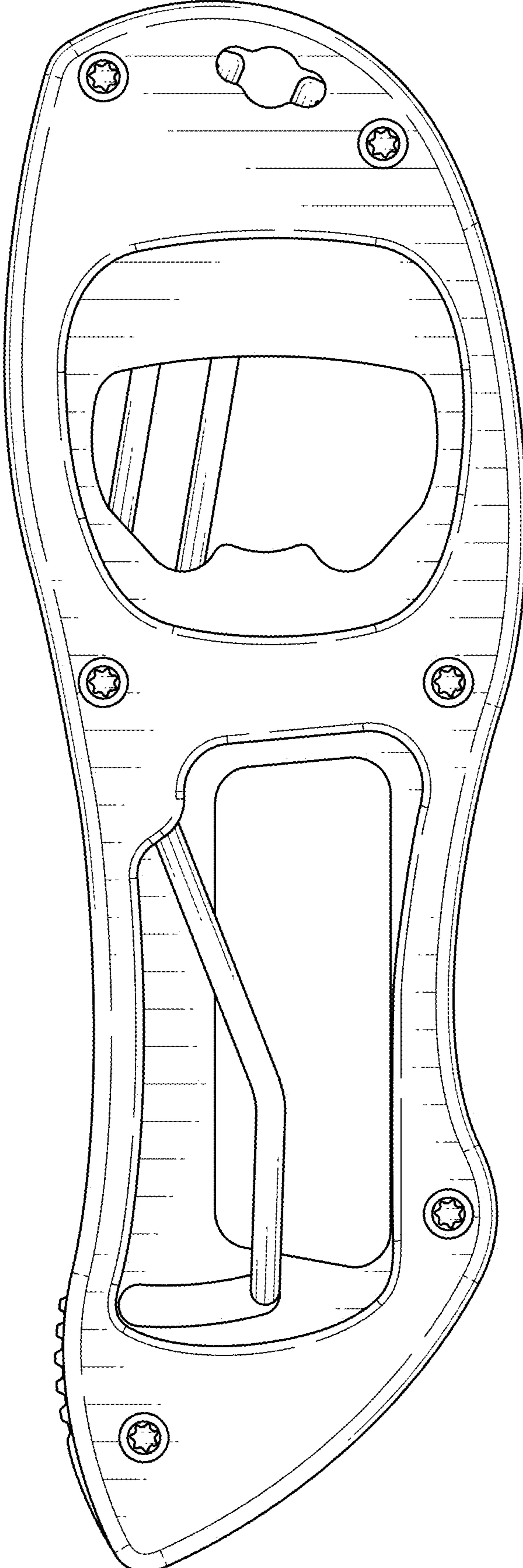

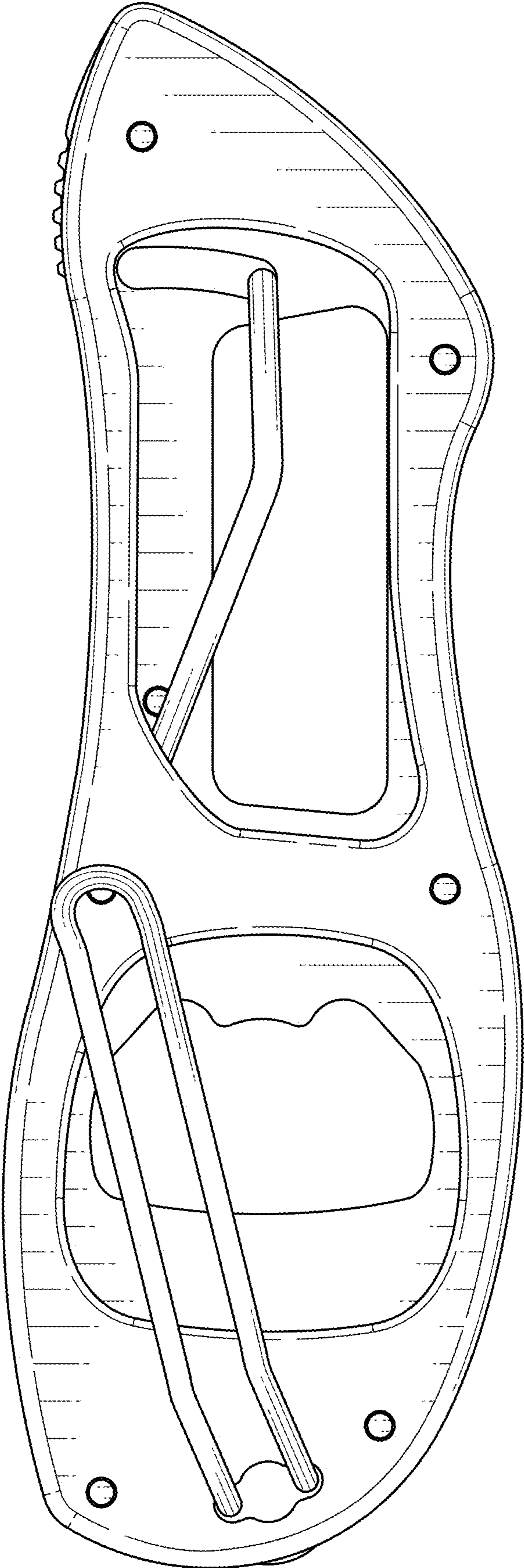

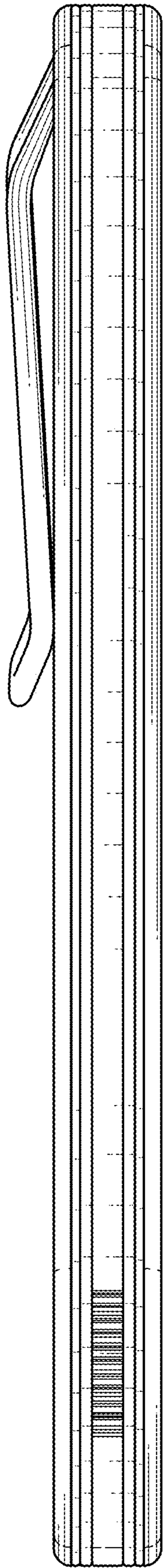

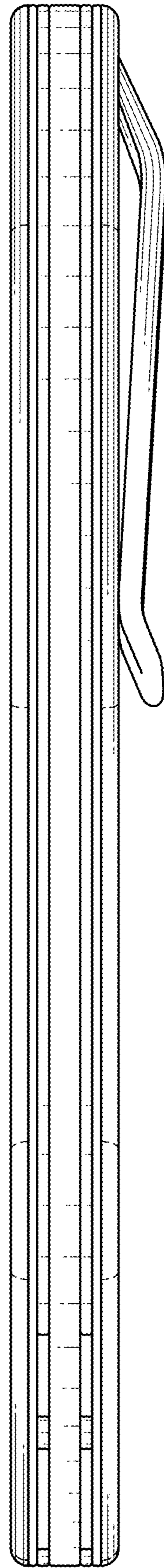

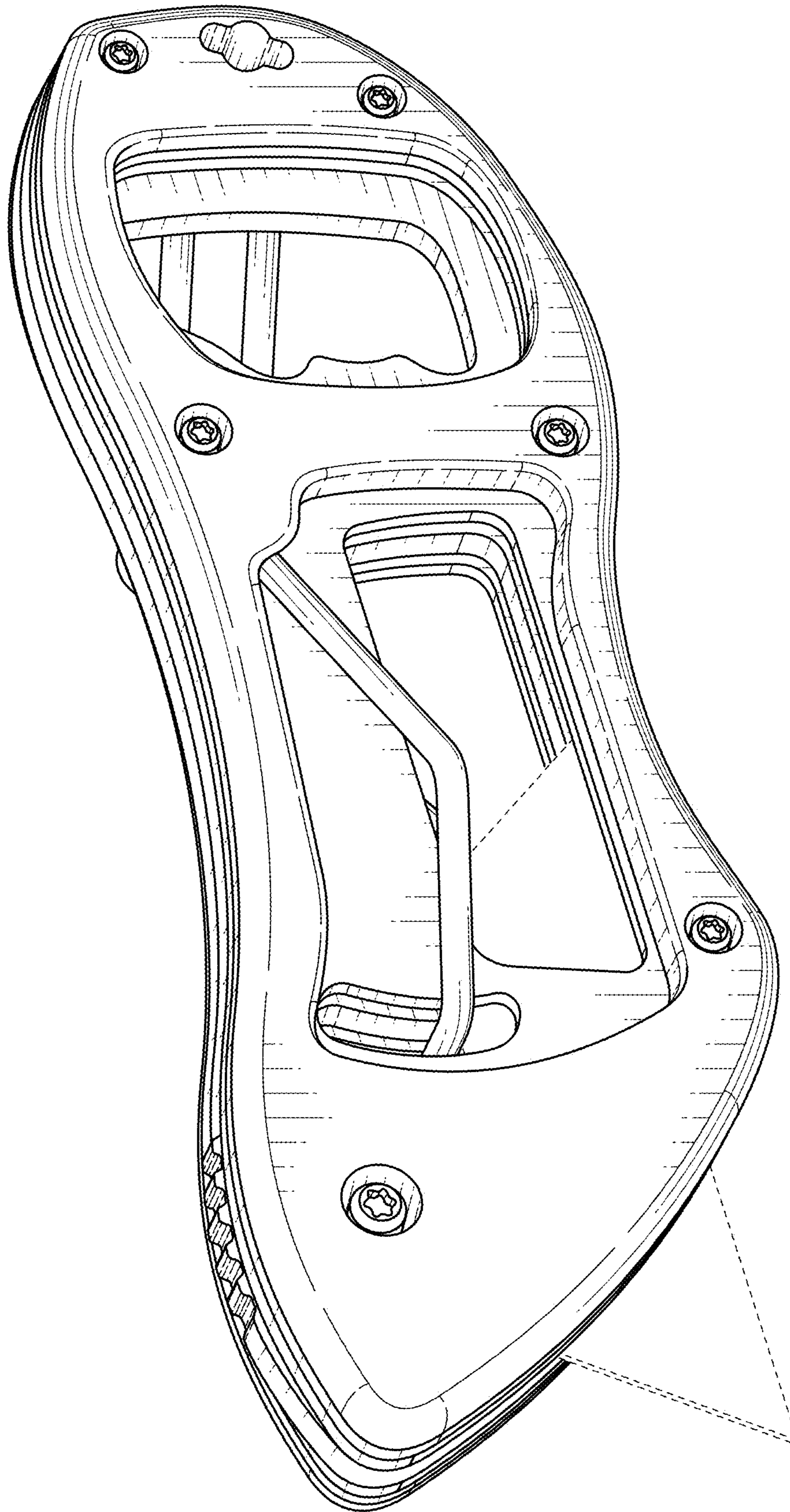
