The ornamental design for a table edge rail cover, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a (TITLE), showing our new design;
FIG. 2 is a side elevation view thereof;

FIG. 4 is a bottom plan view thereof.

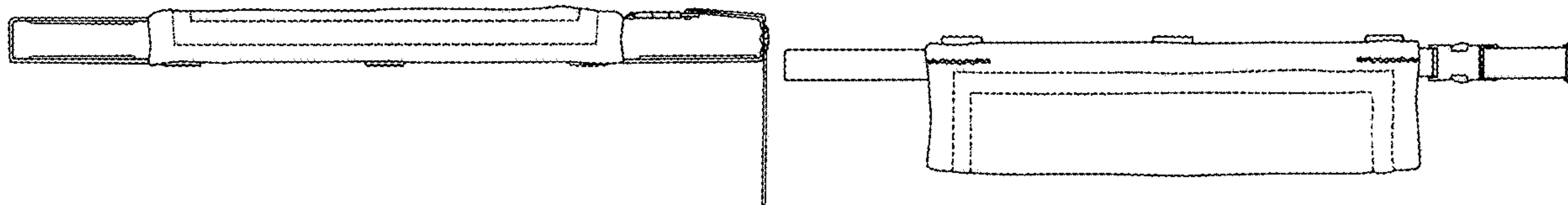

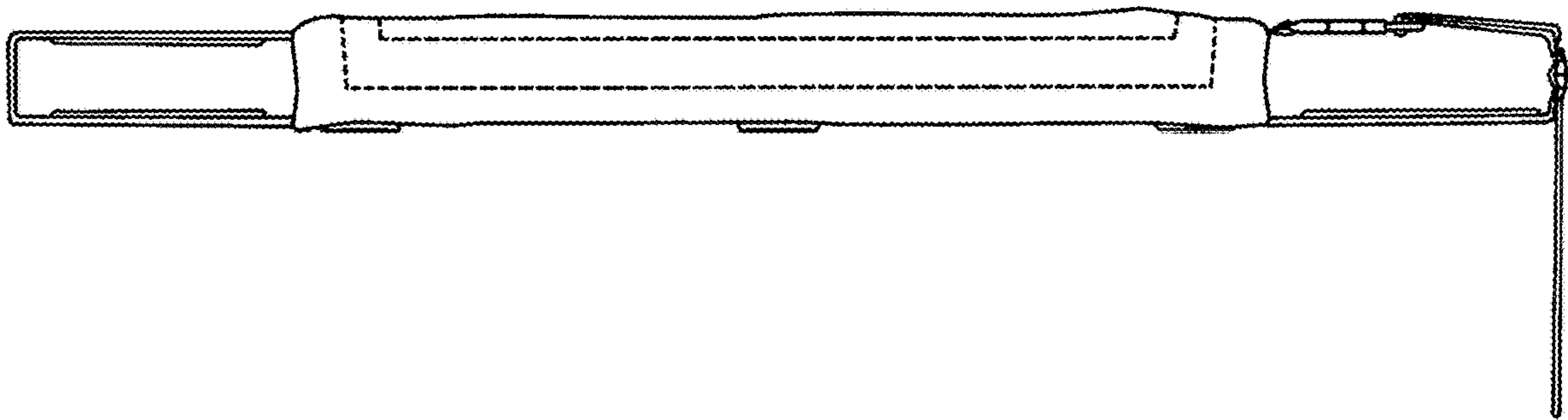

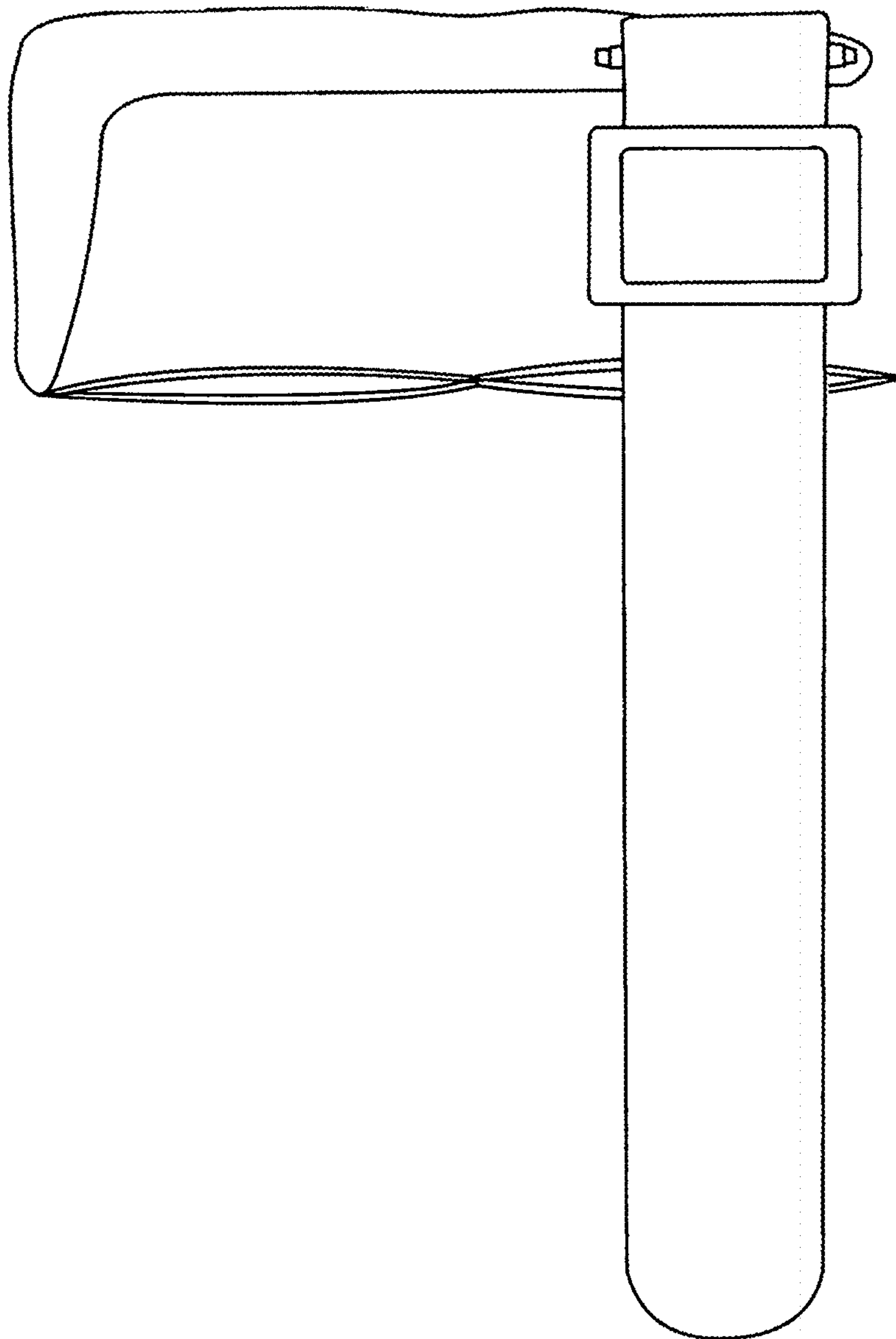

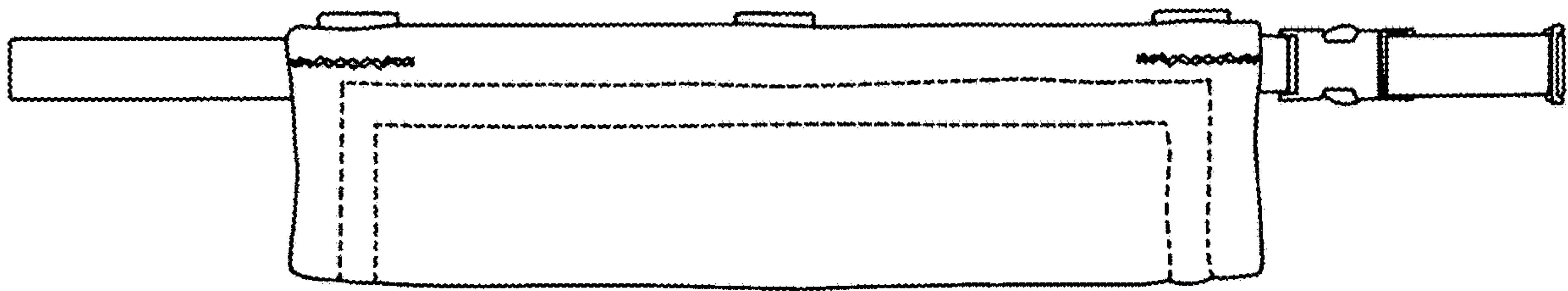
