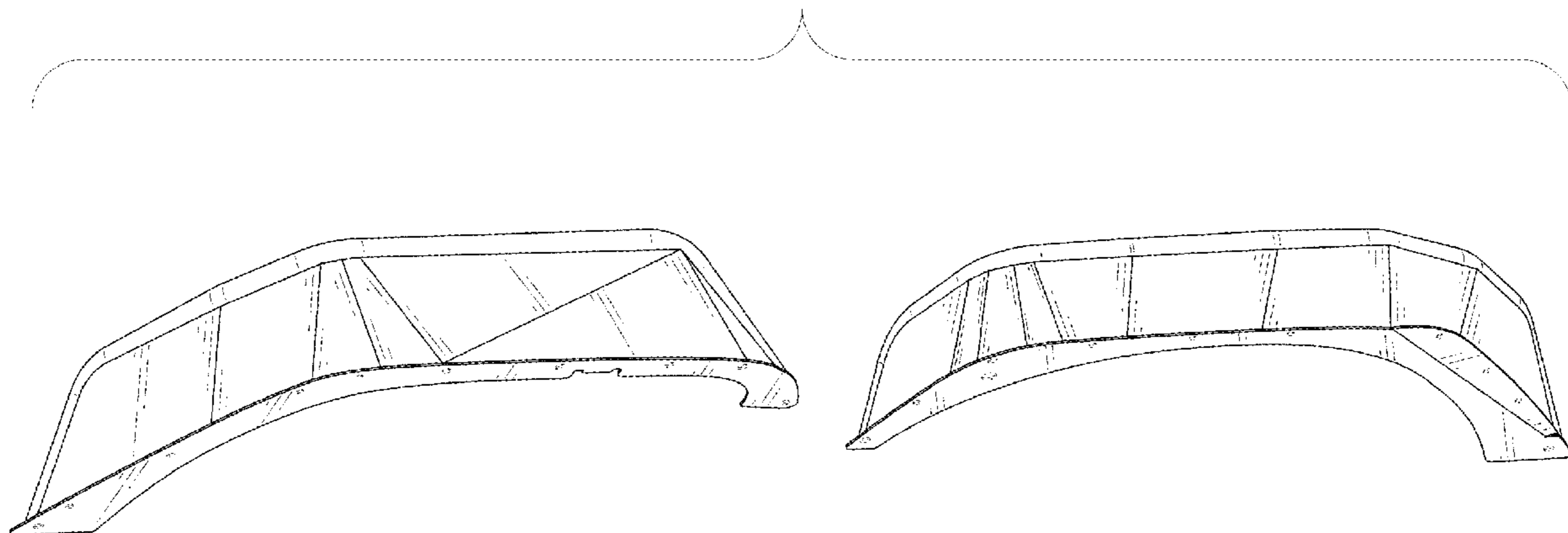
The ornamental design for car fender set, as shown and described.

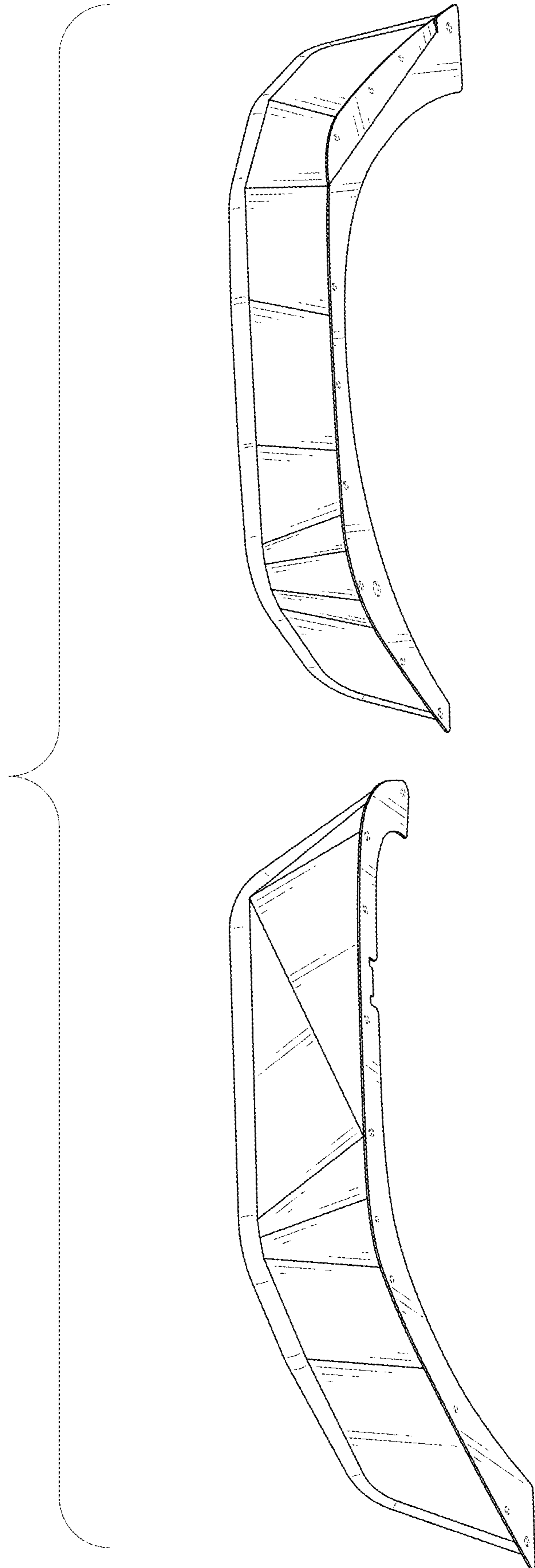

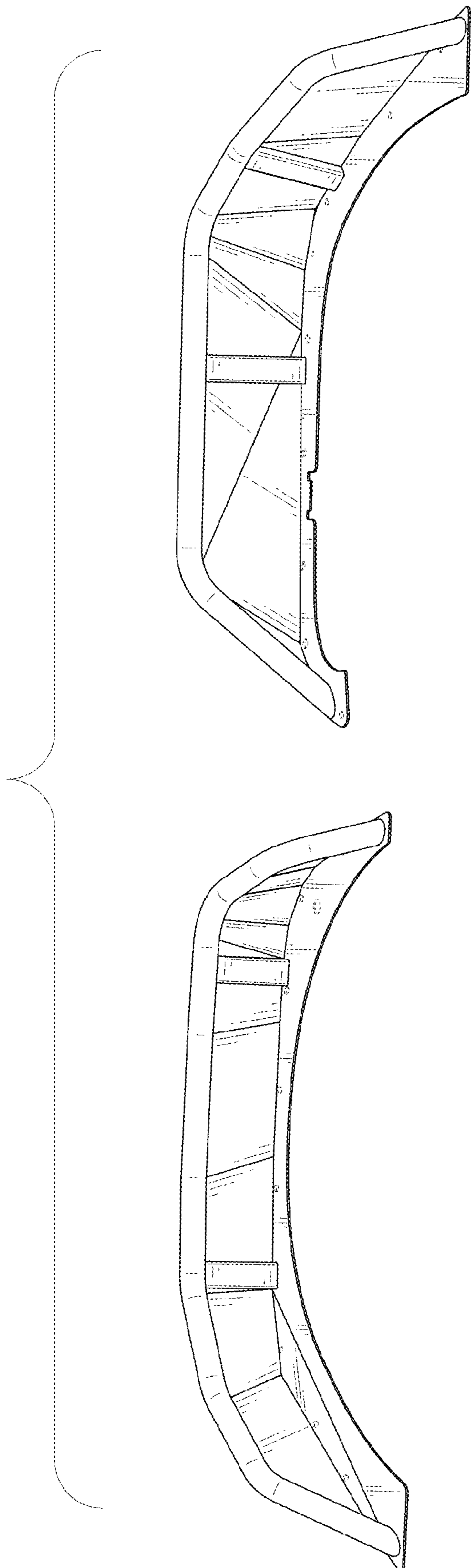

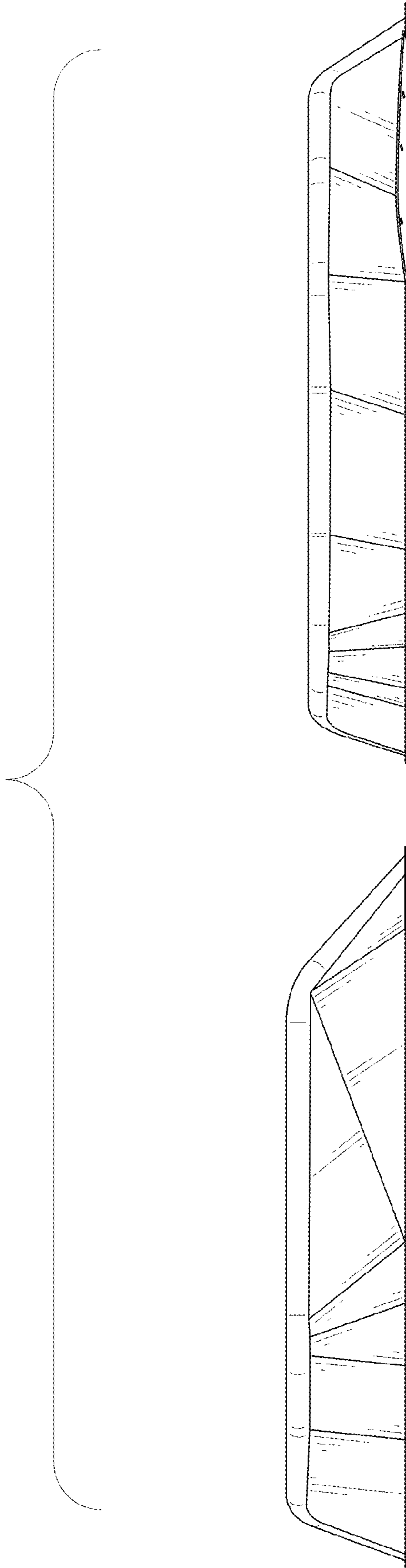

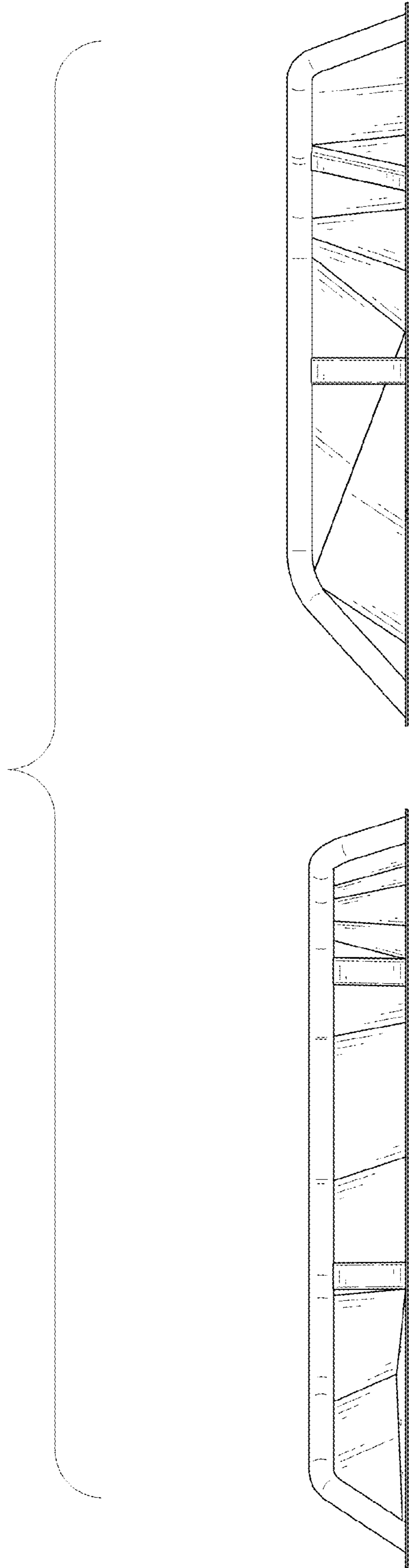

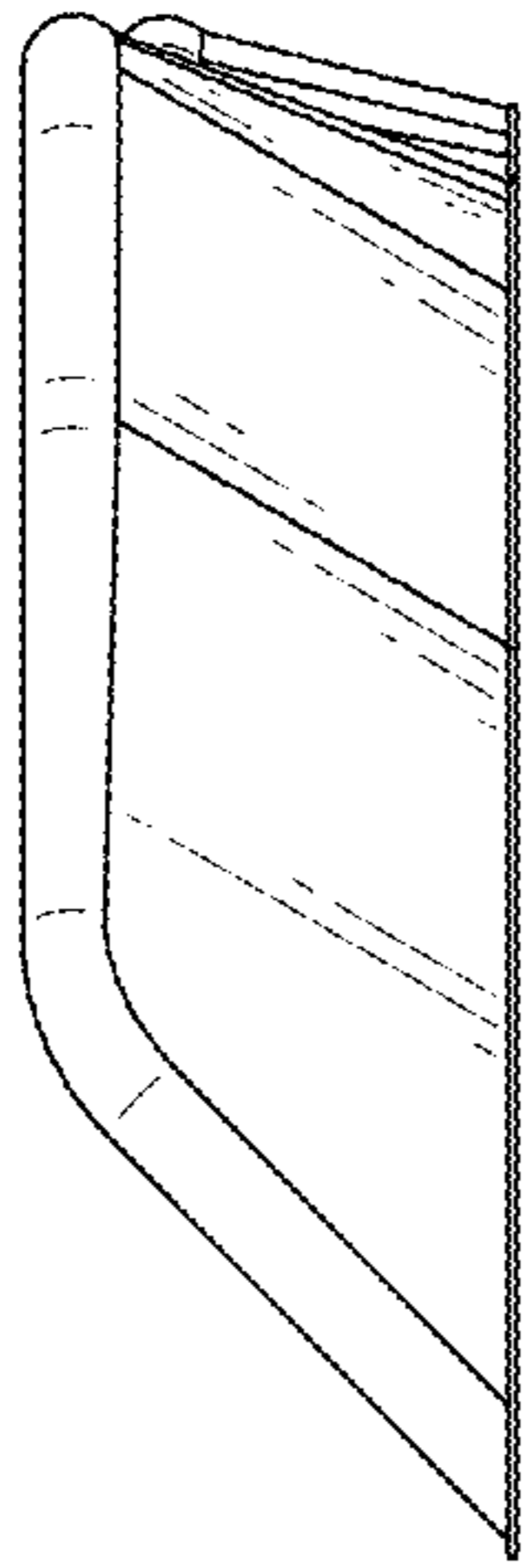

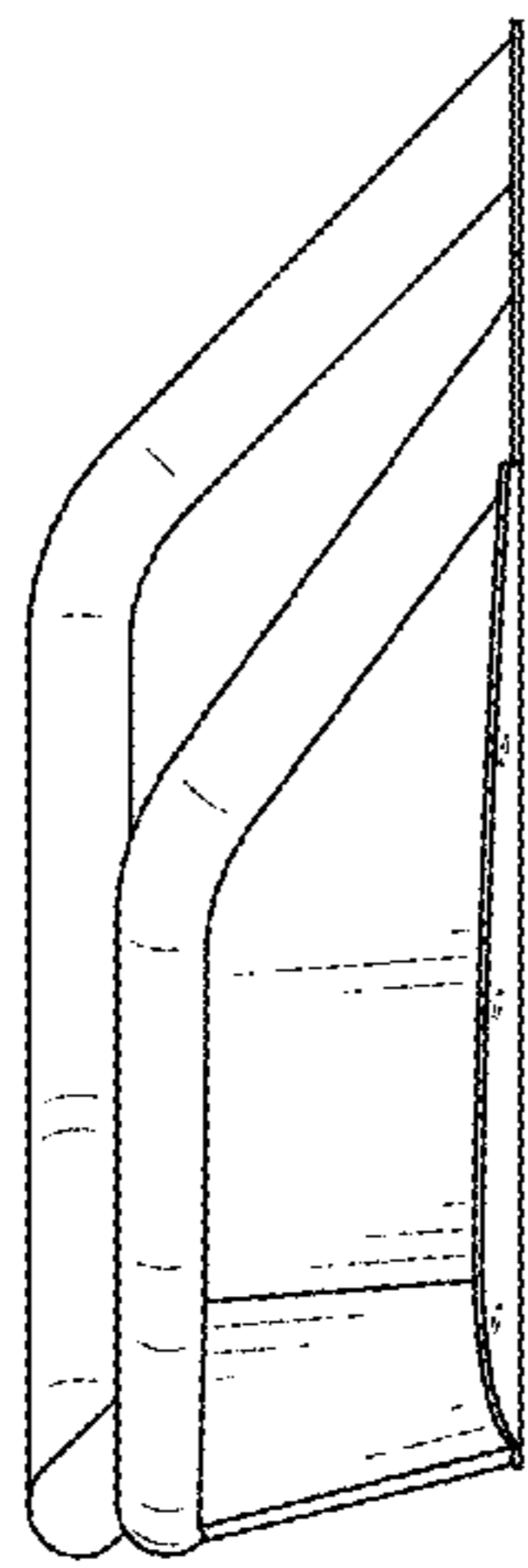

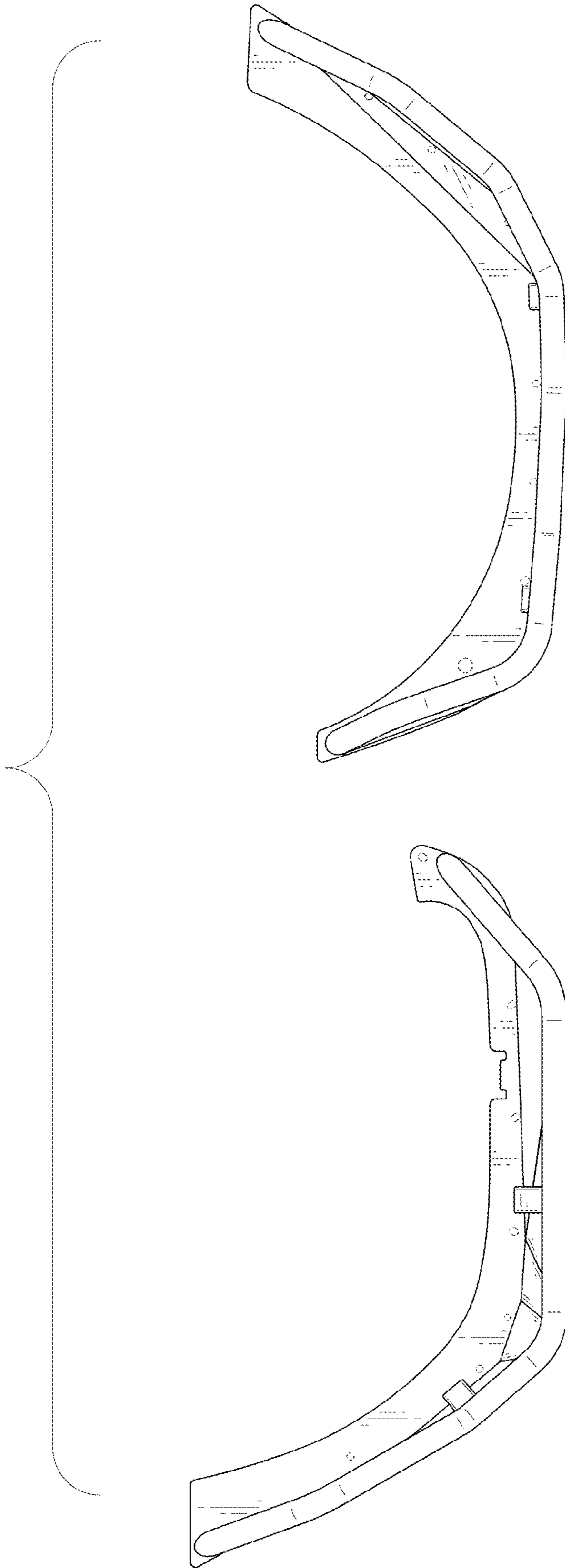

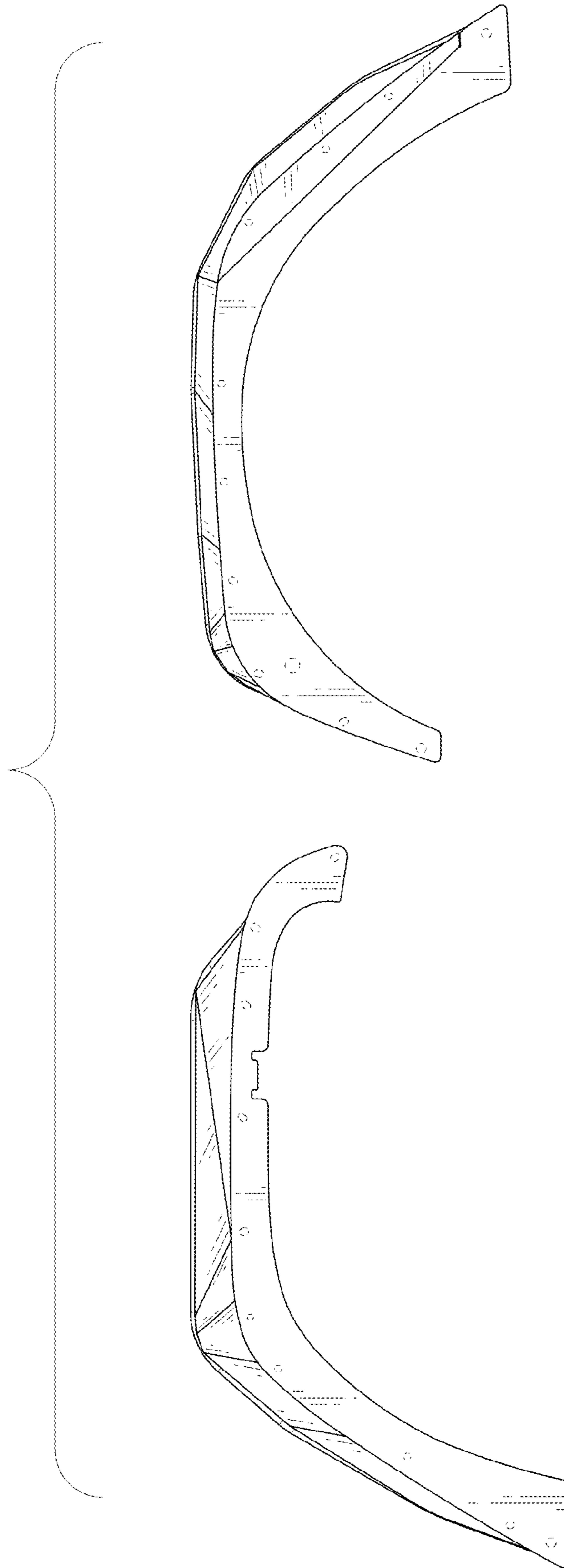
