FIG. 11 is another front view thereof, but mounted on a vehicle to show environment structure, the vehicle being unclaimed and shown in broken lines.

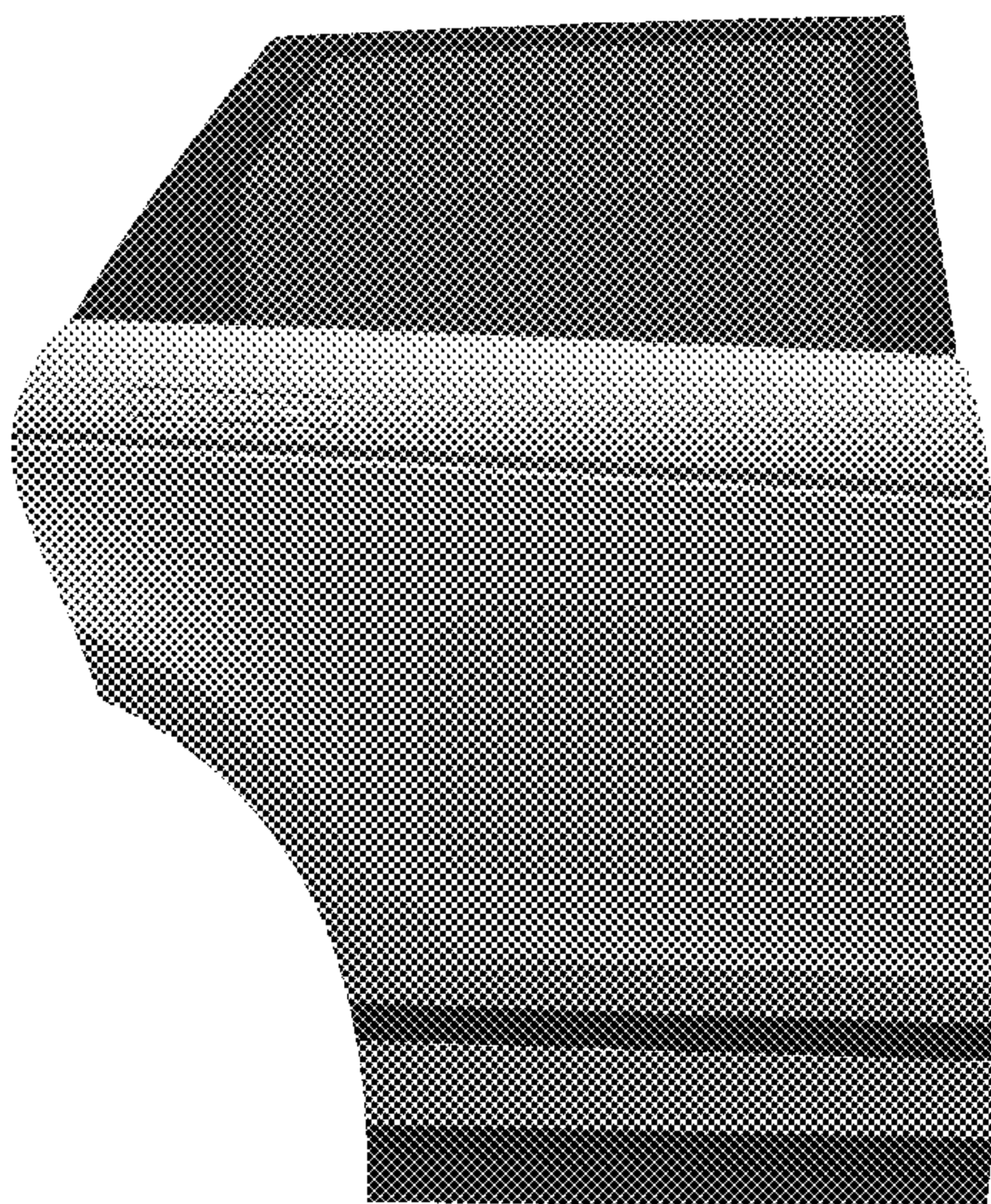

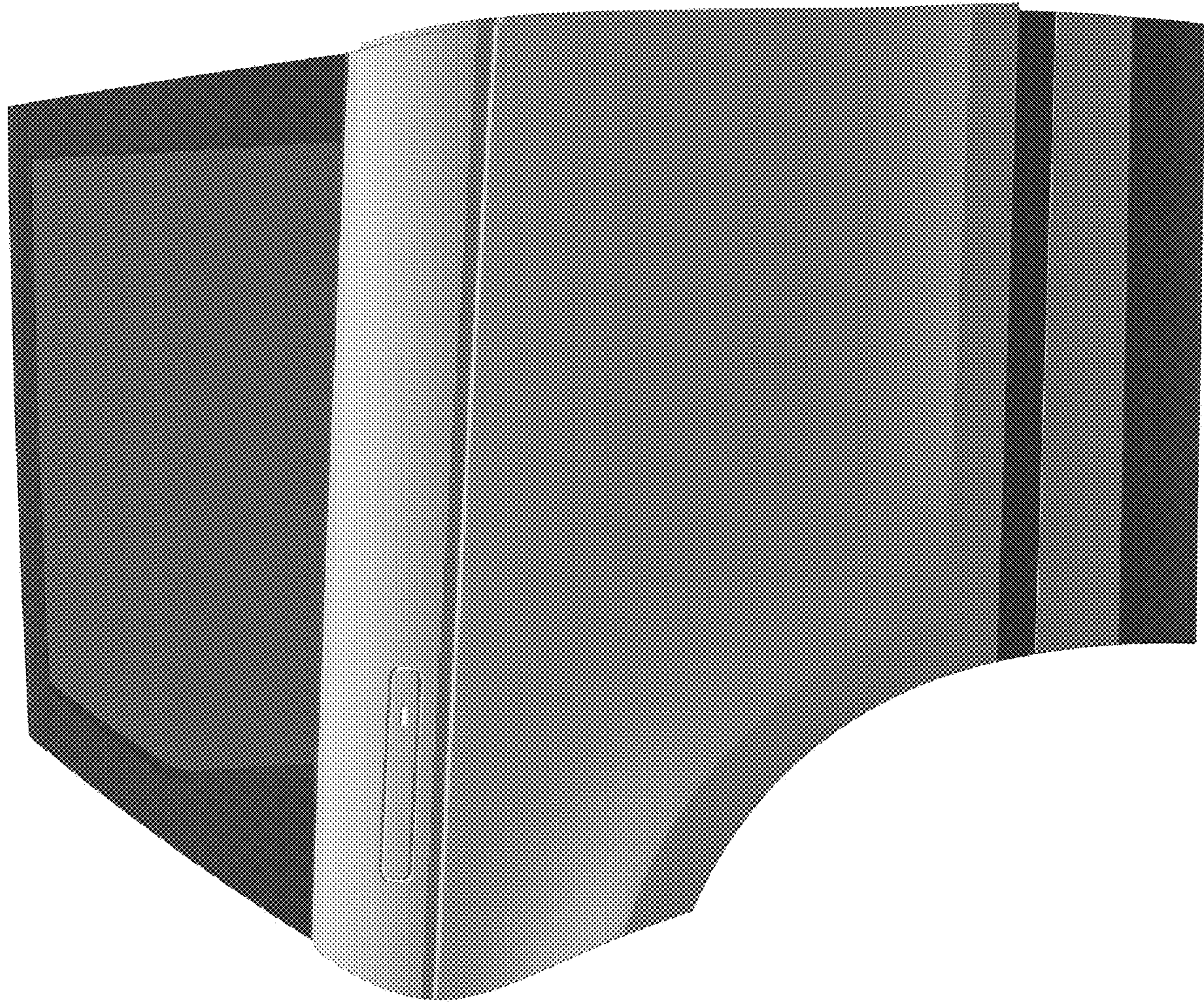

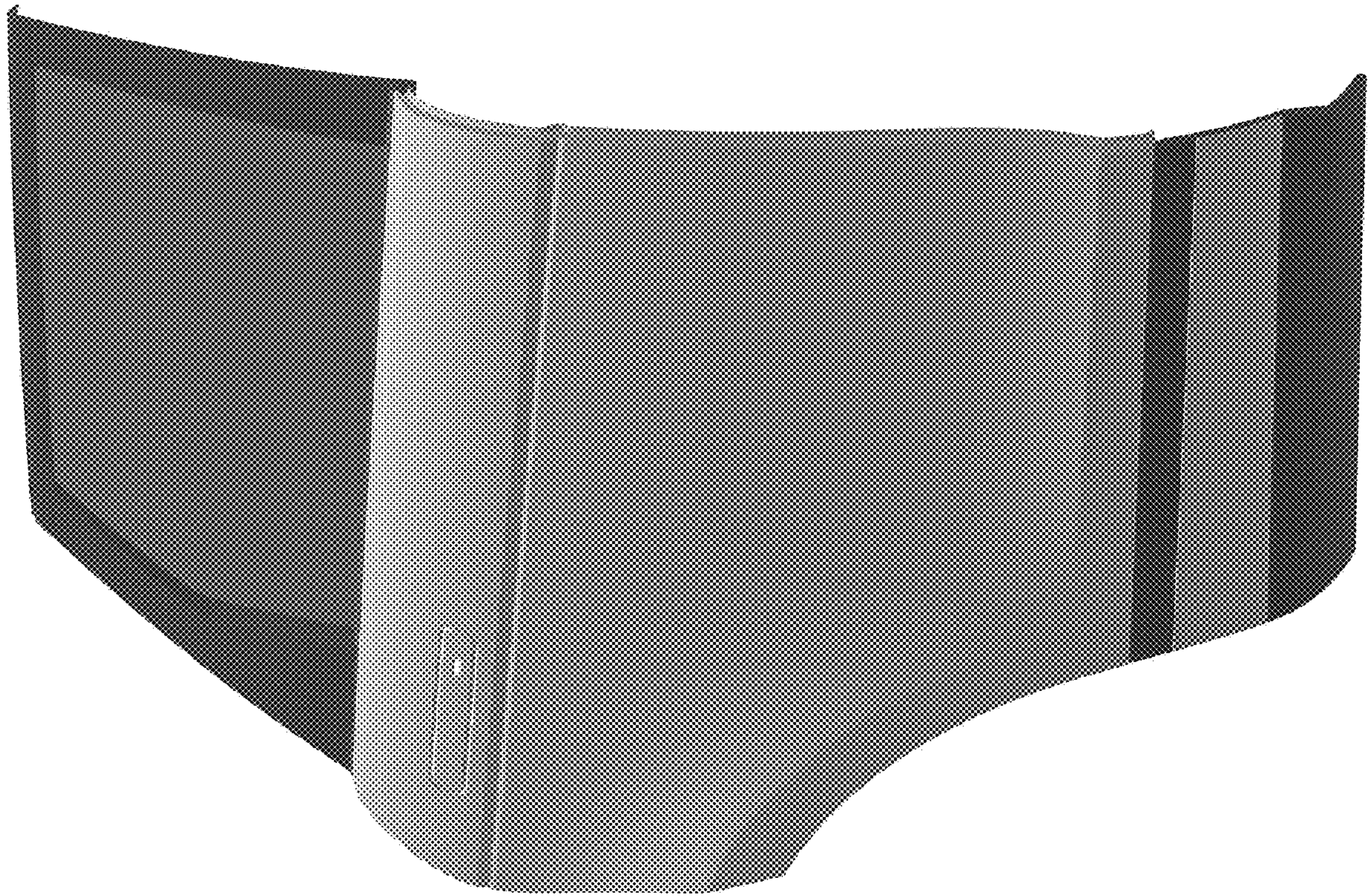

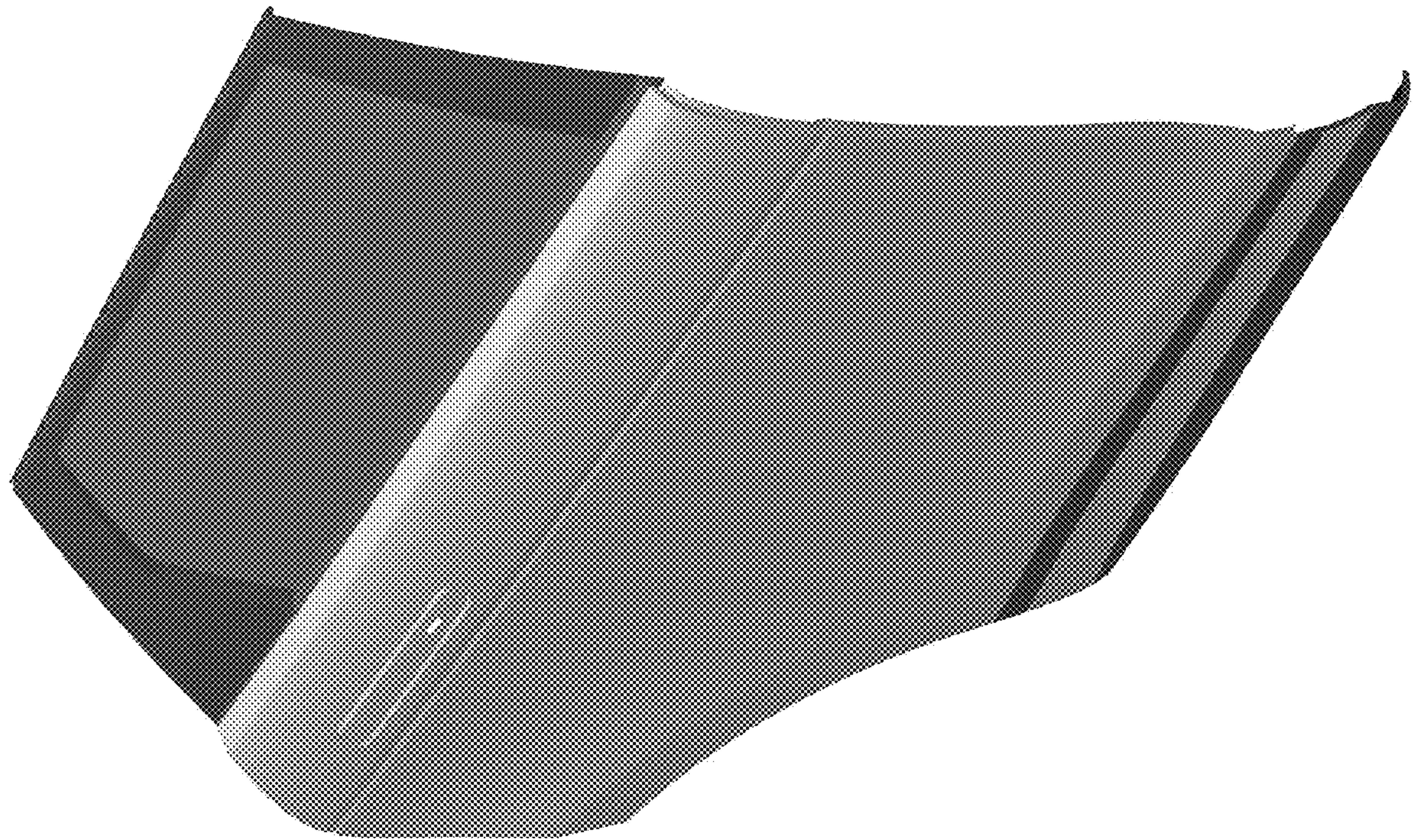

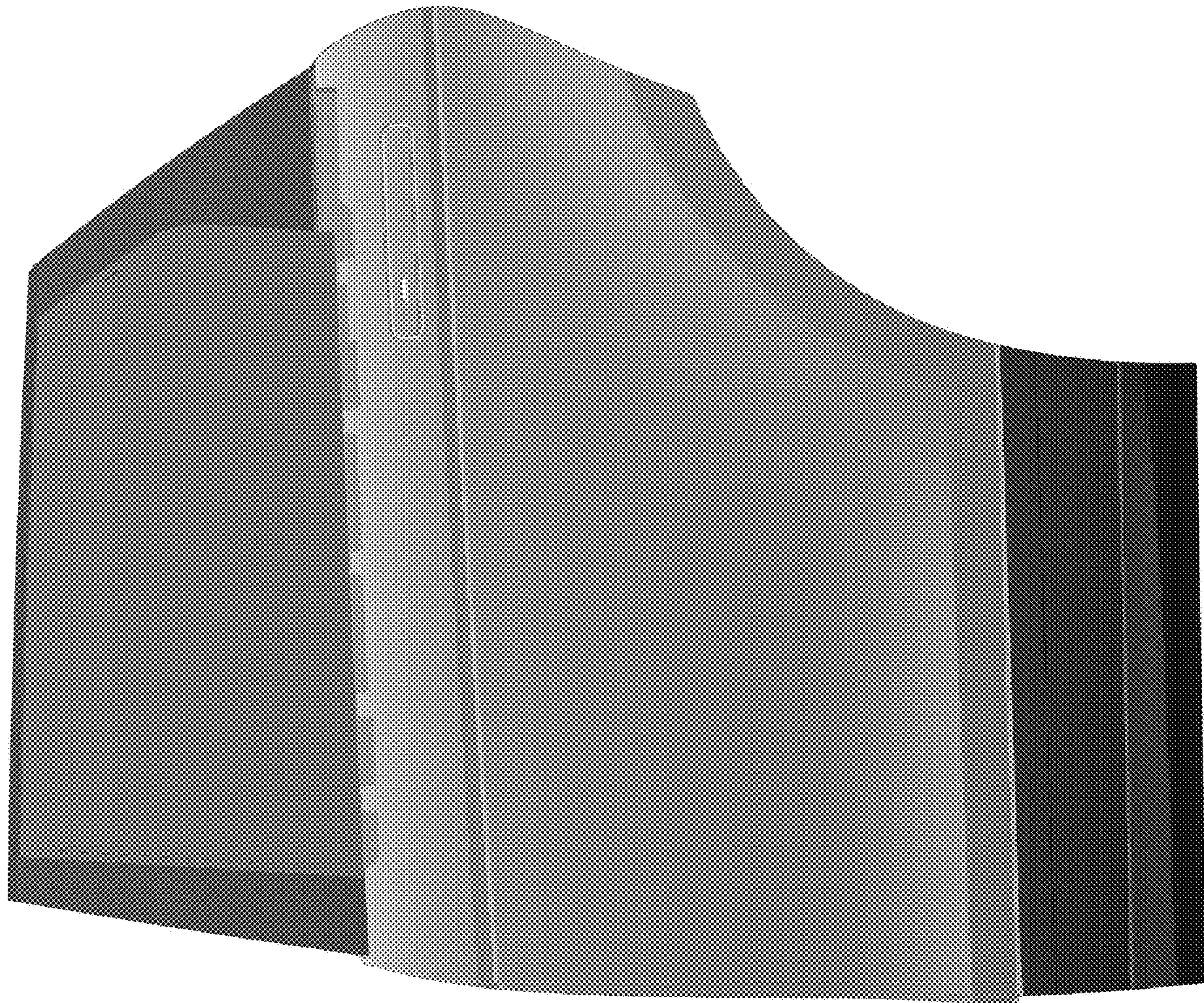

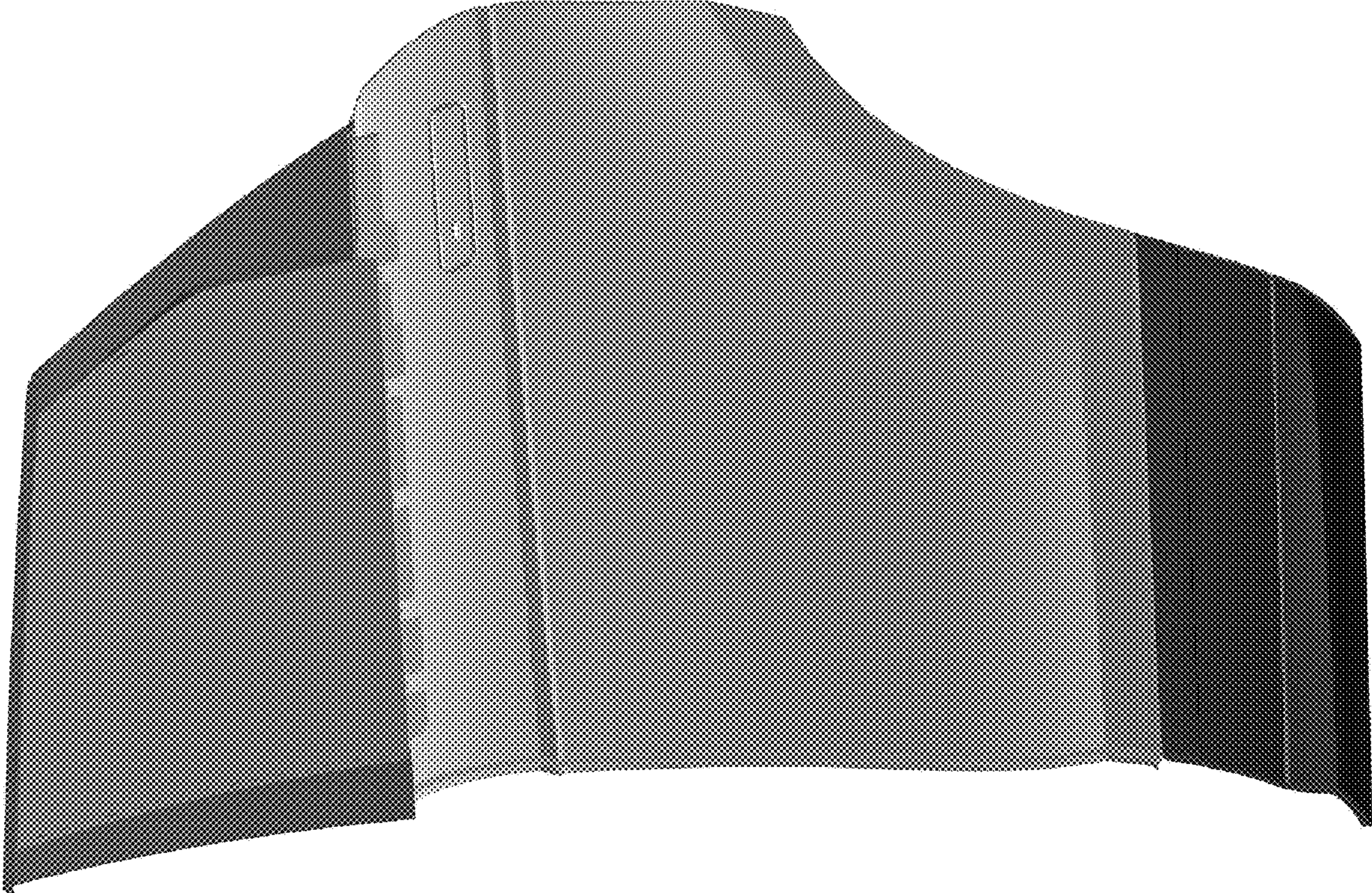

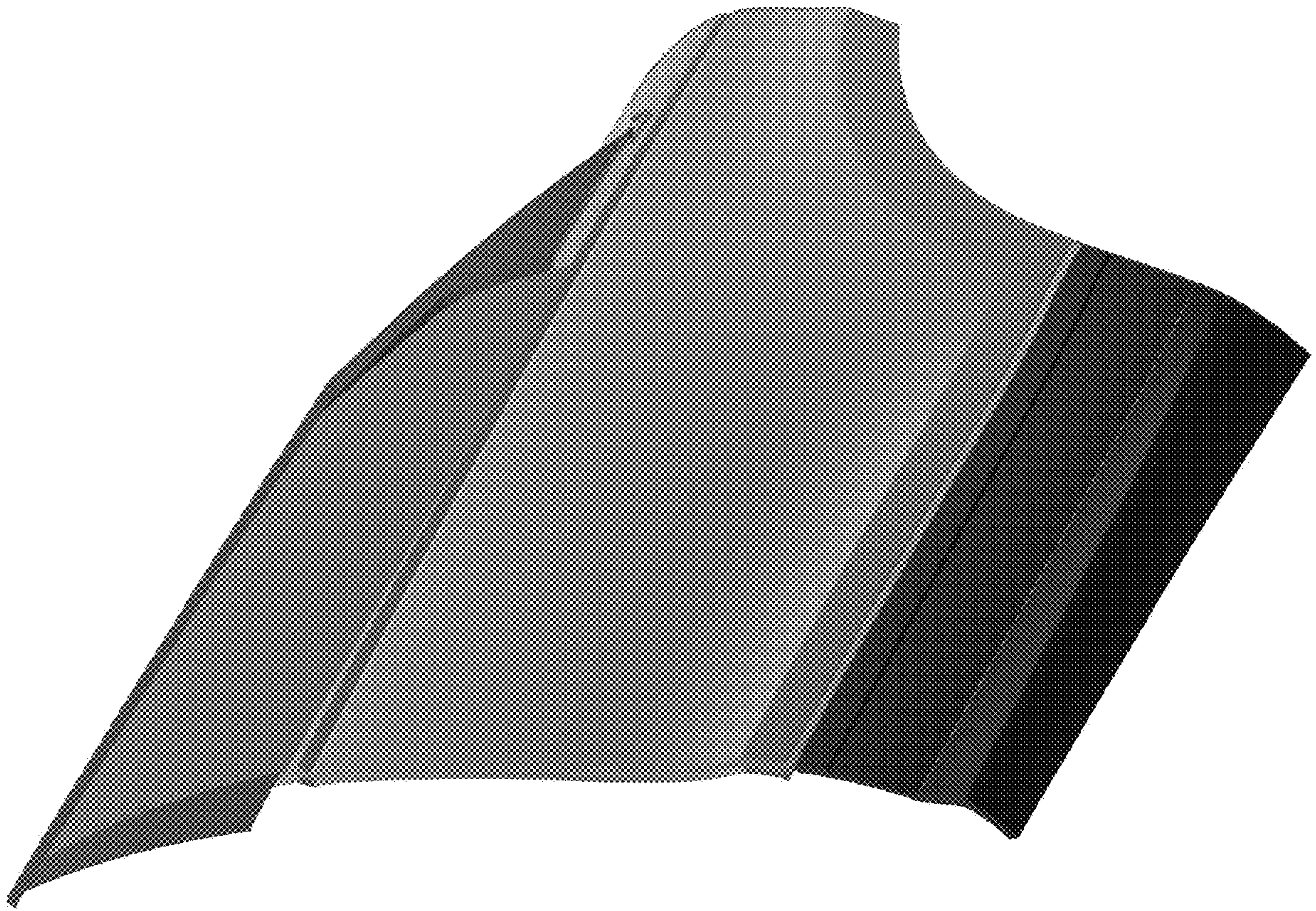

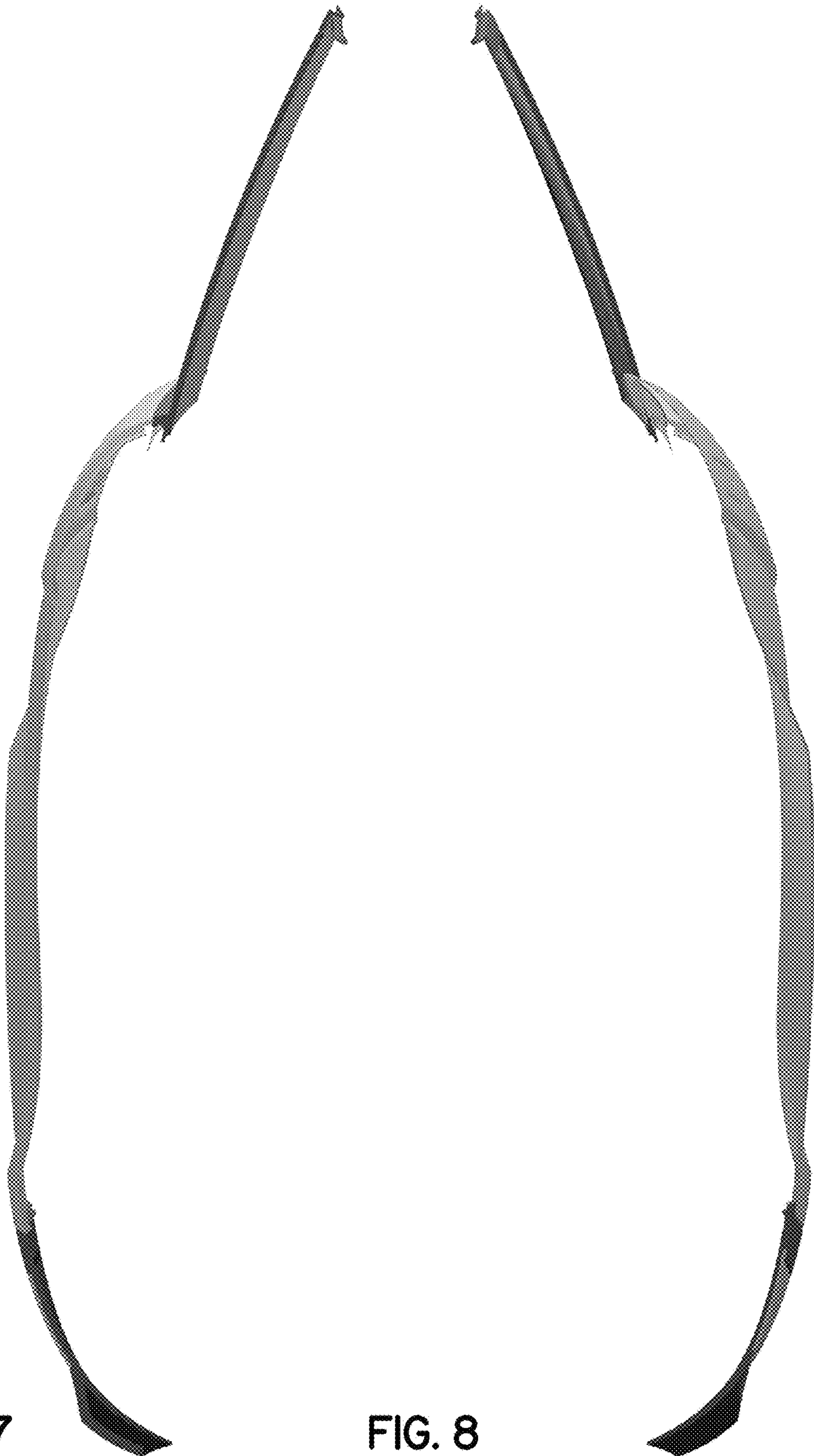

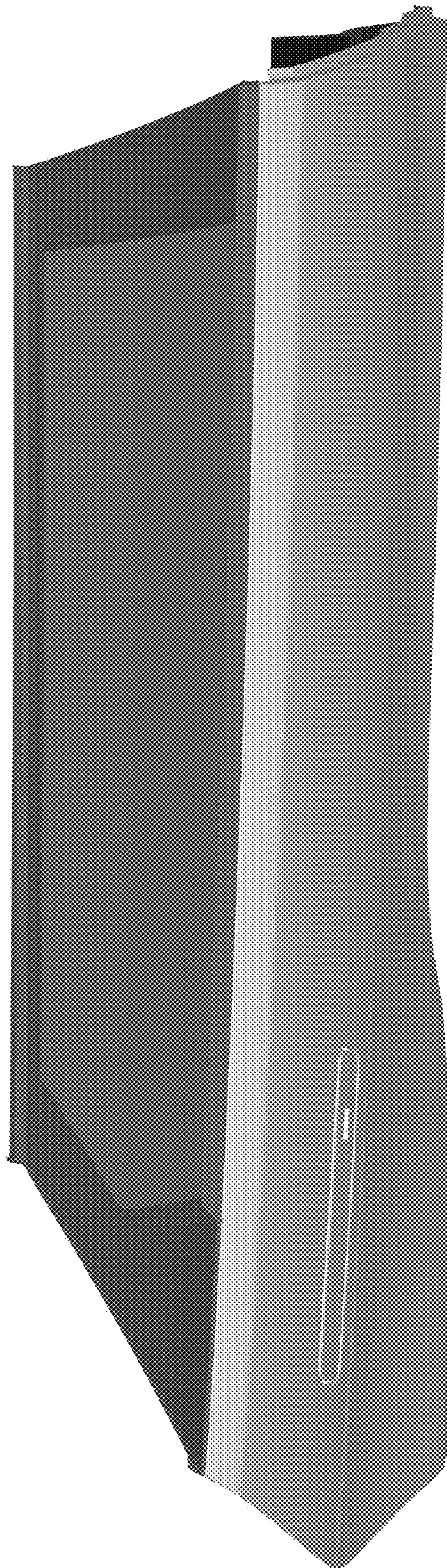

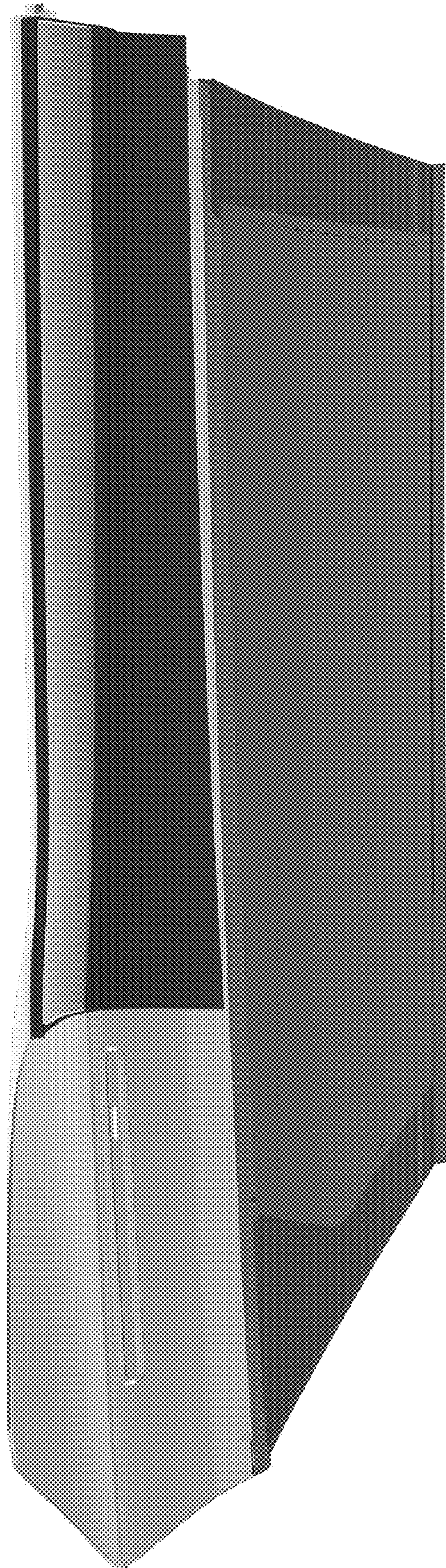

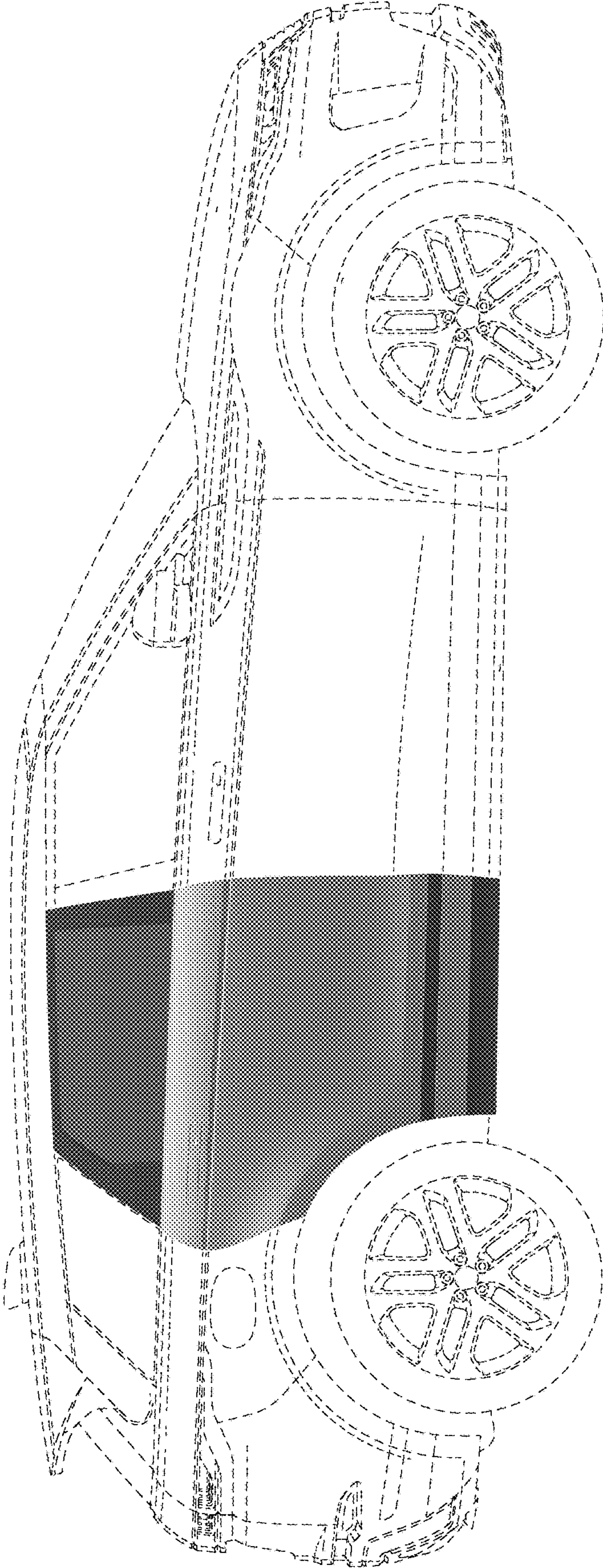
