DESCRIPTION

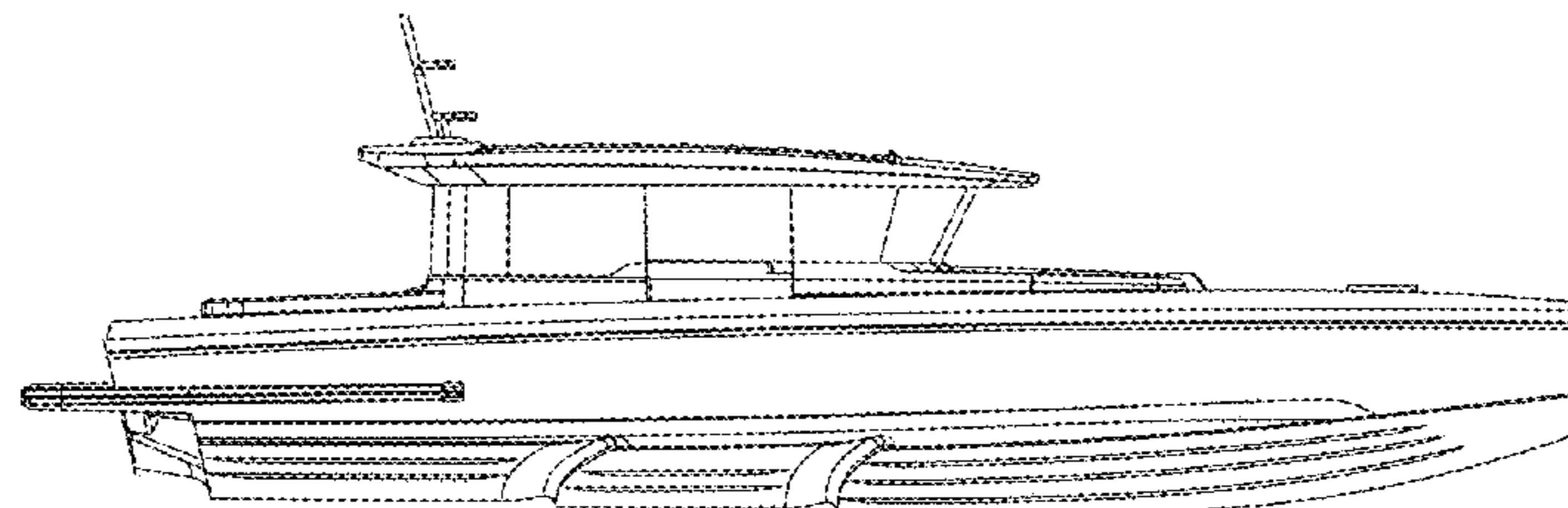
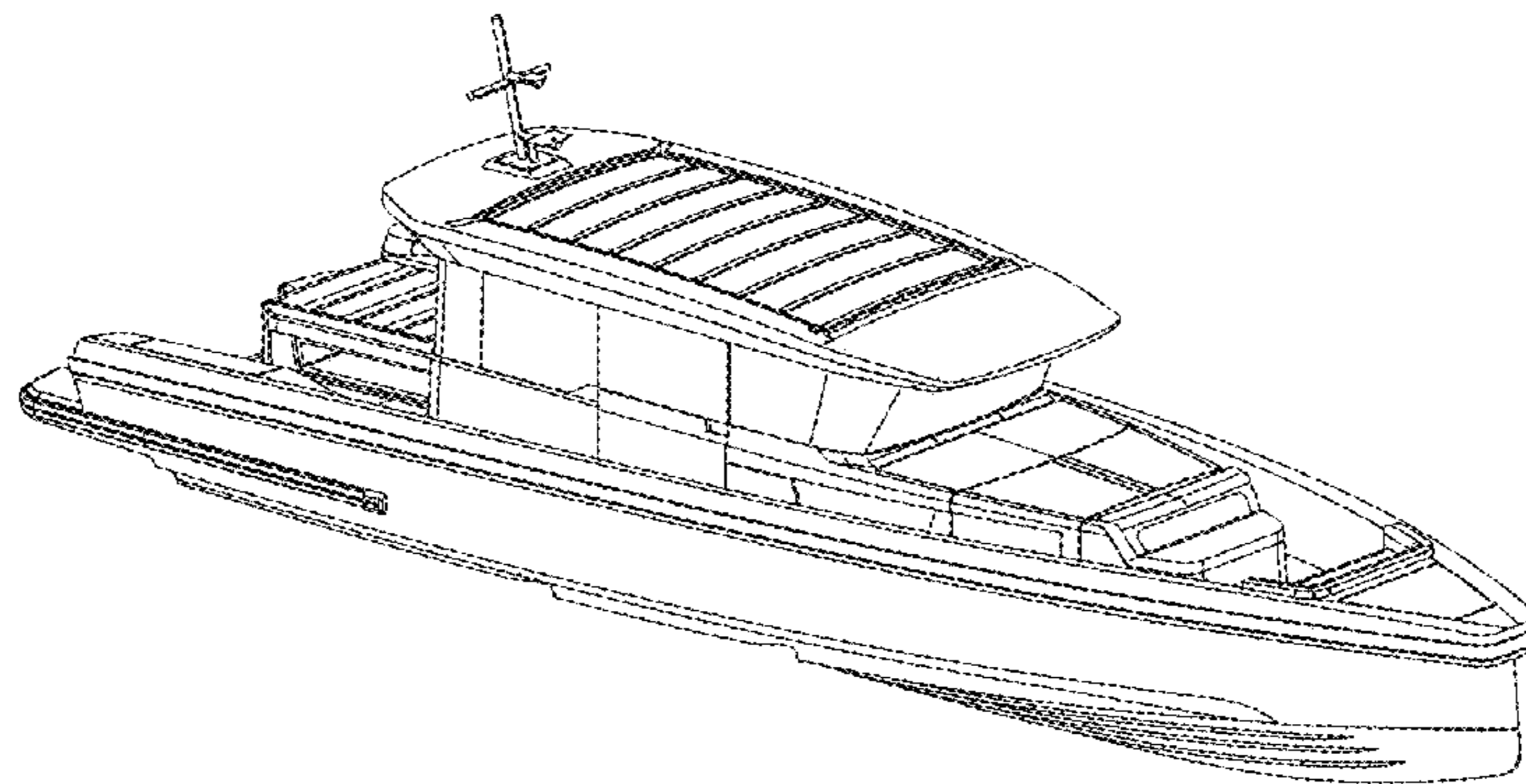
FIG. 1 is a perspective front view of a boat showing our new design;

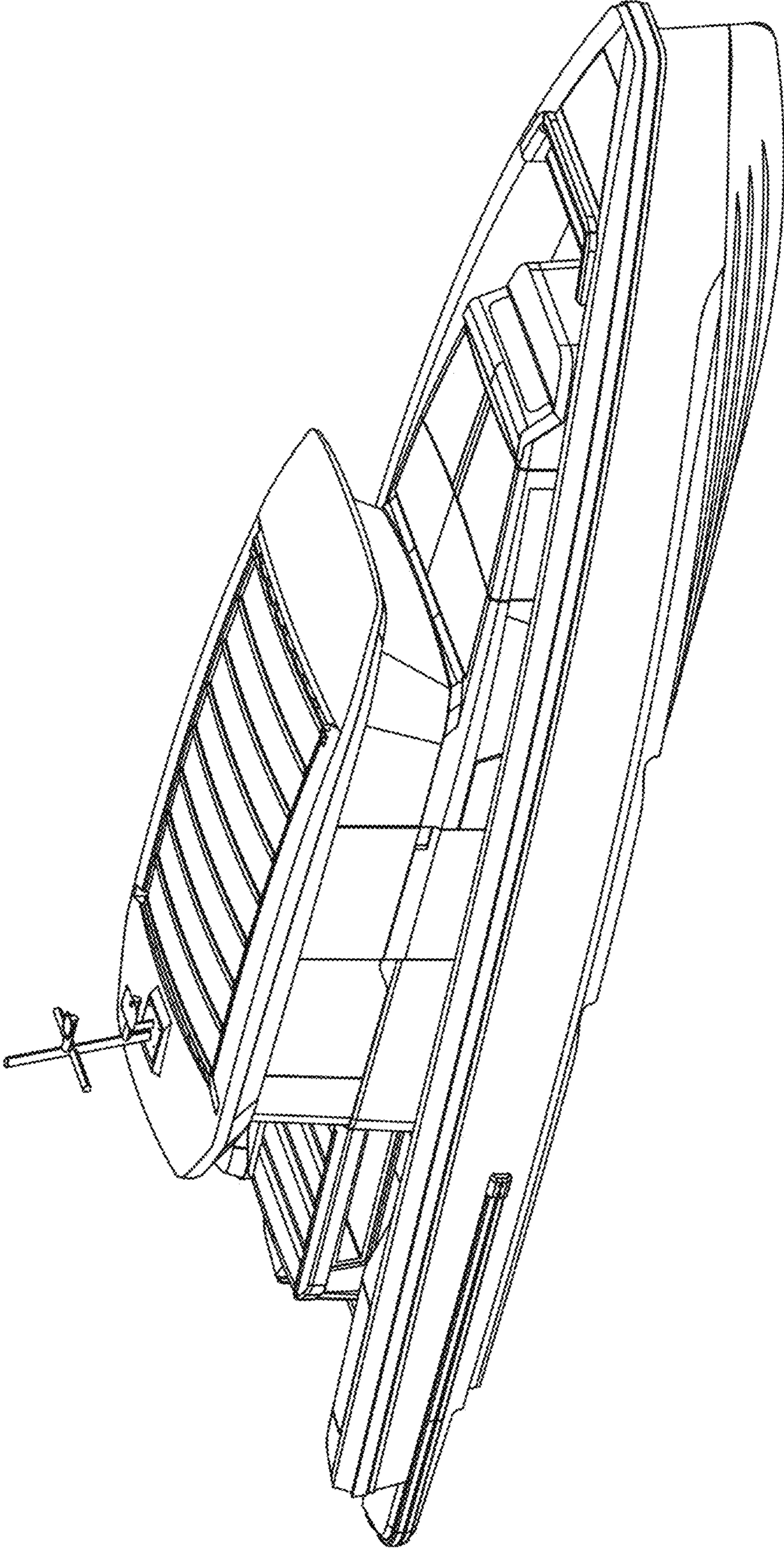

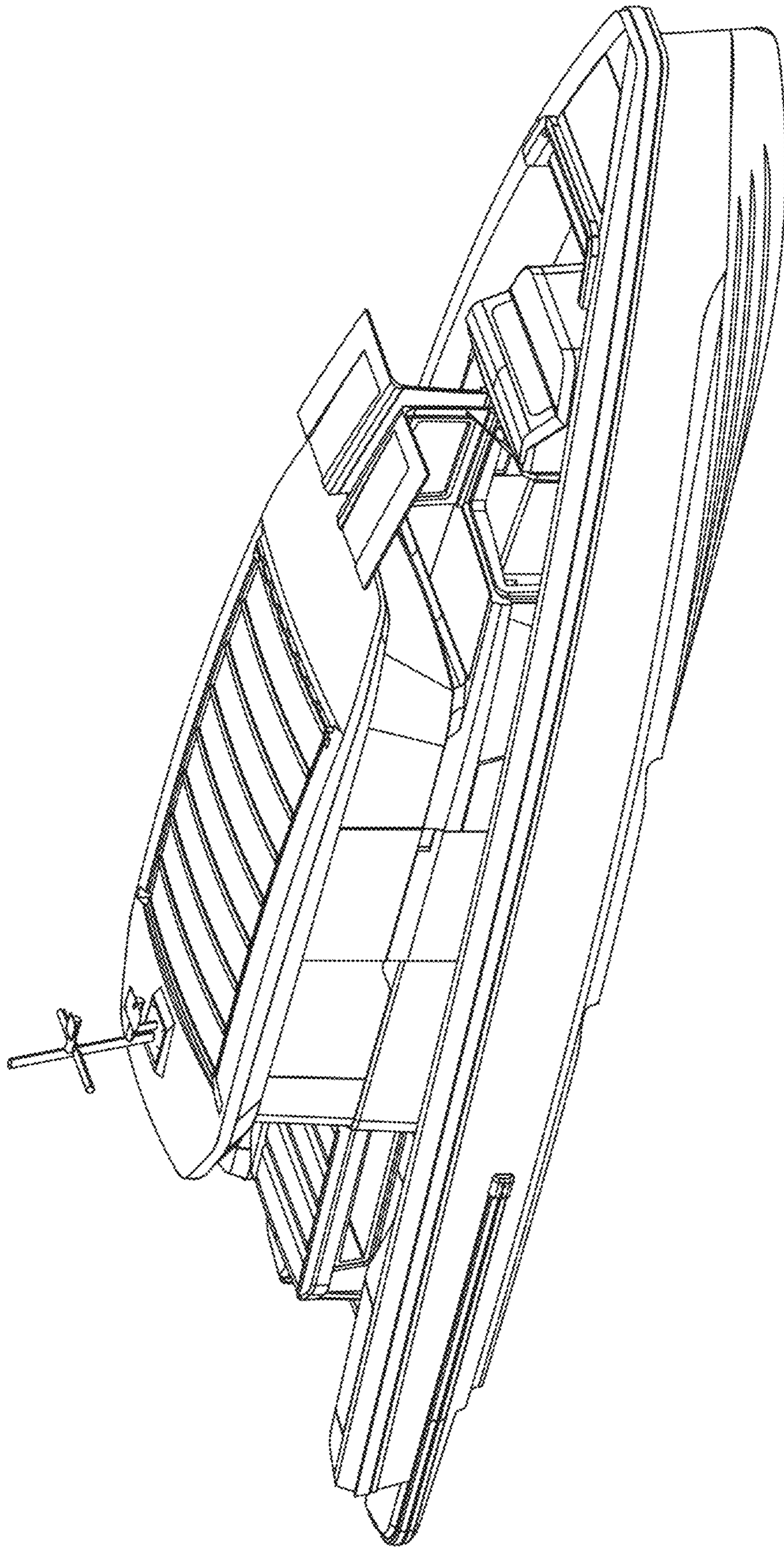

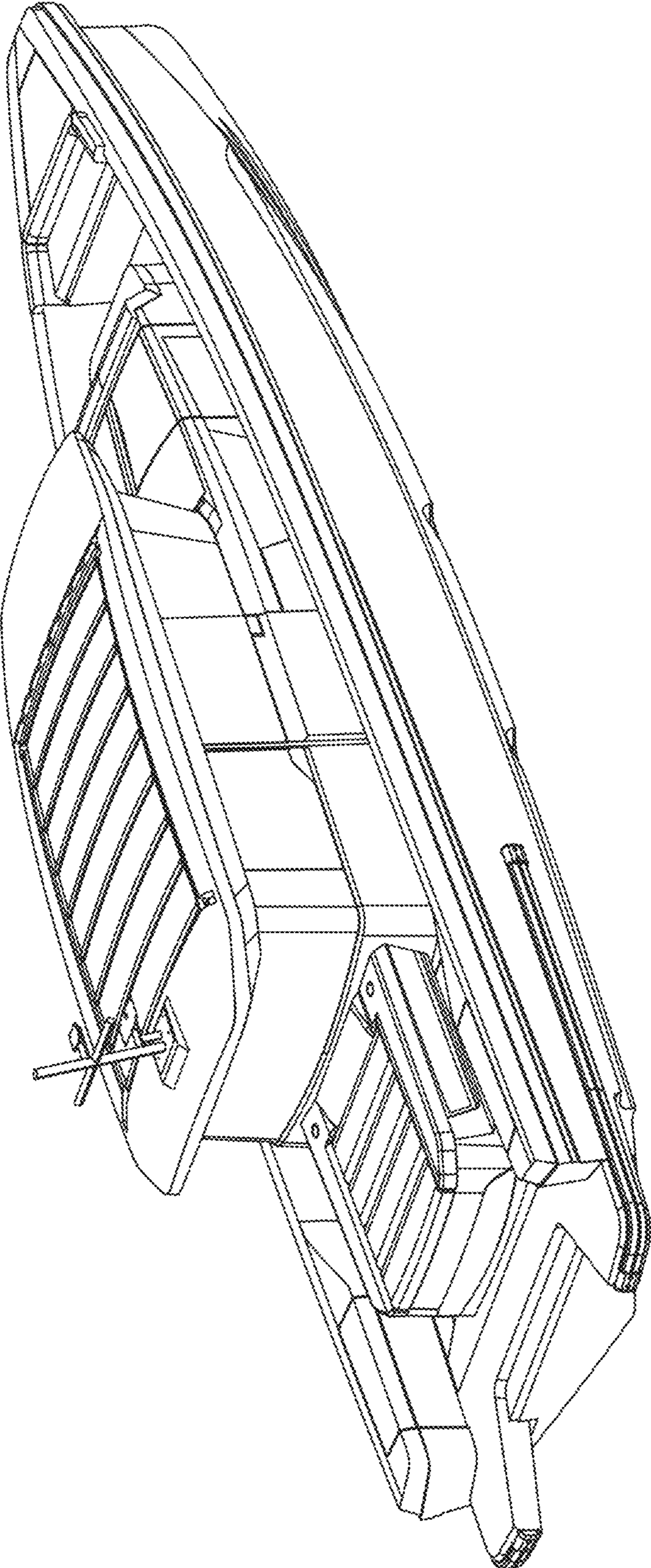

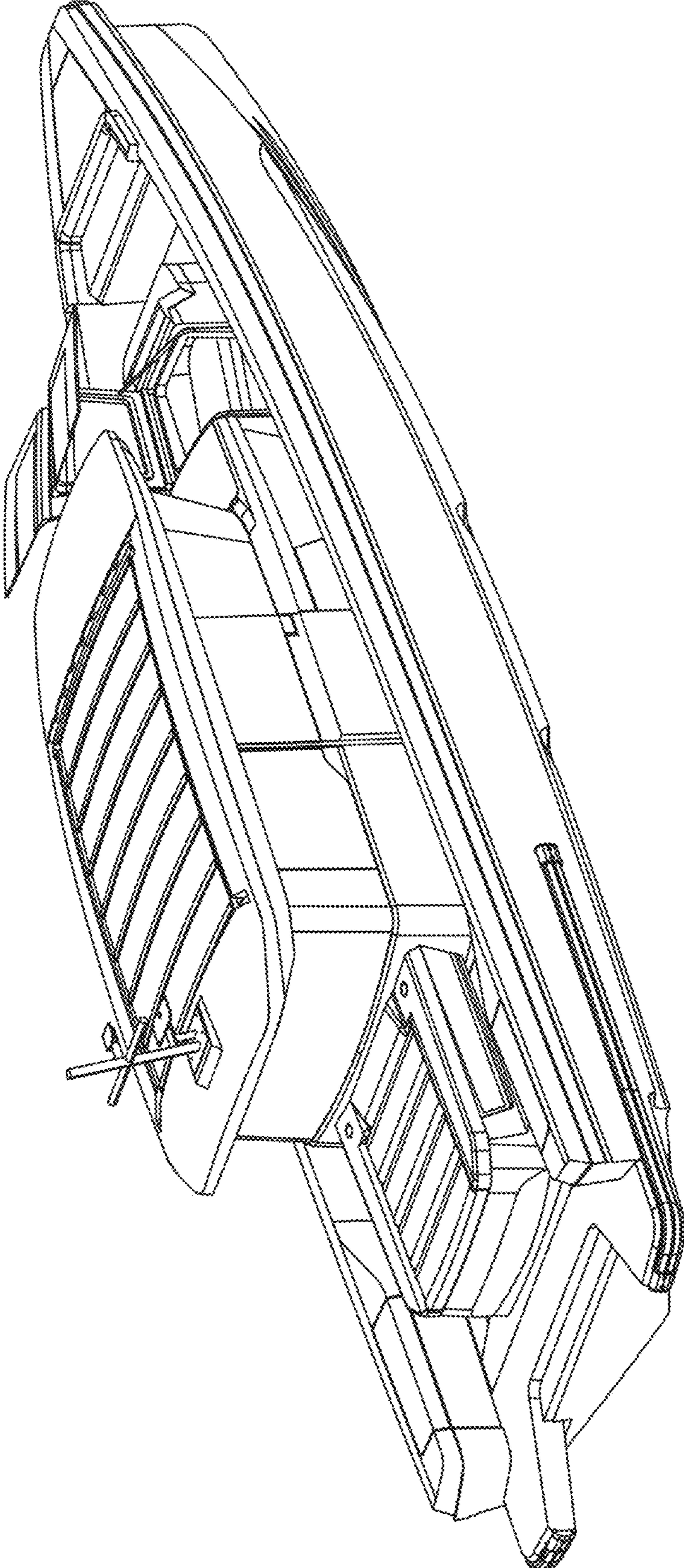

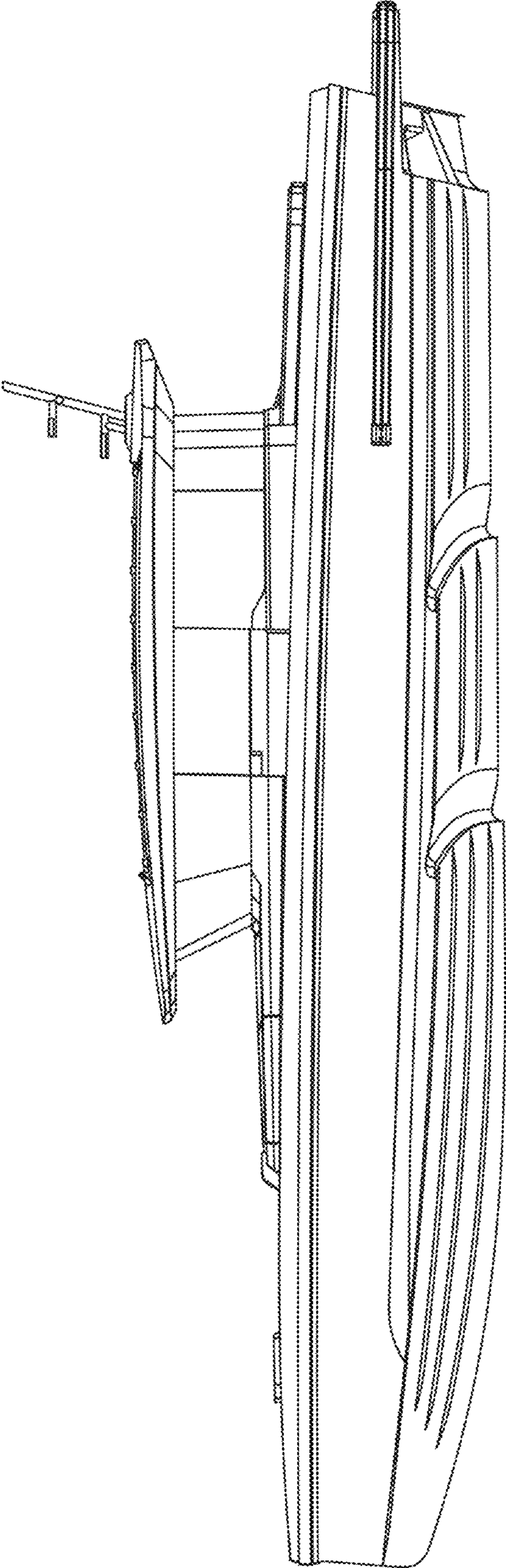

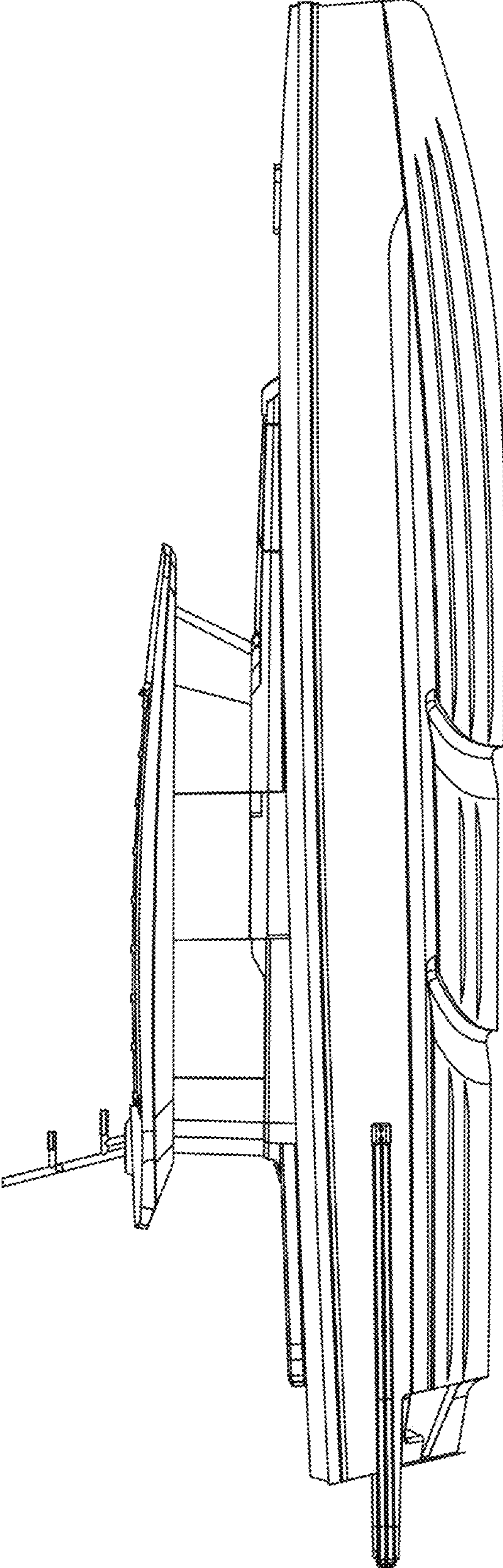

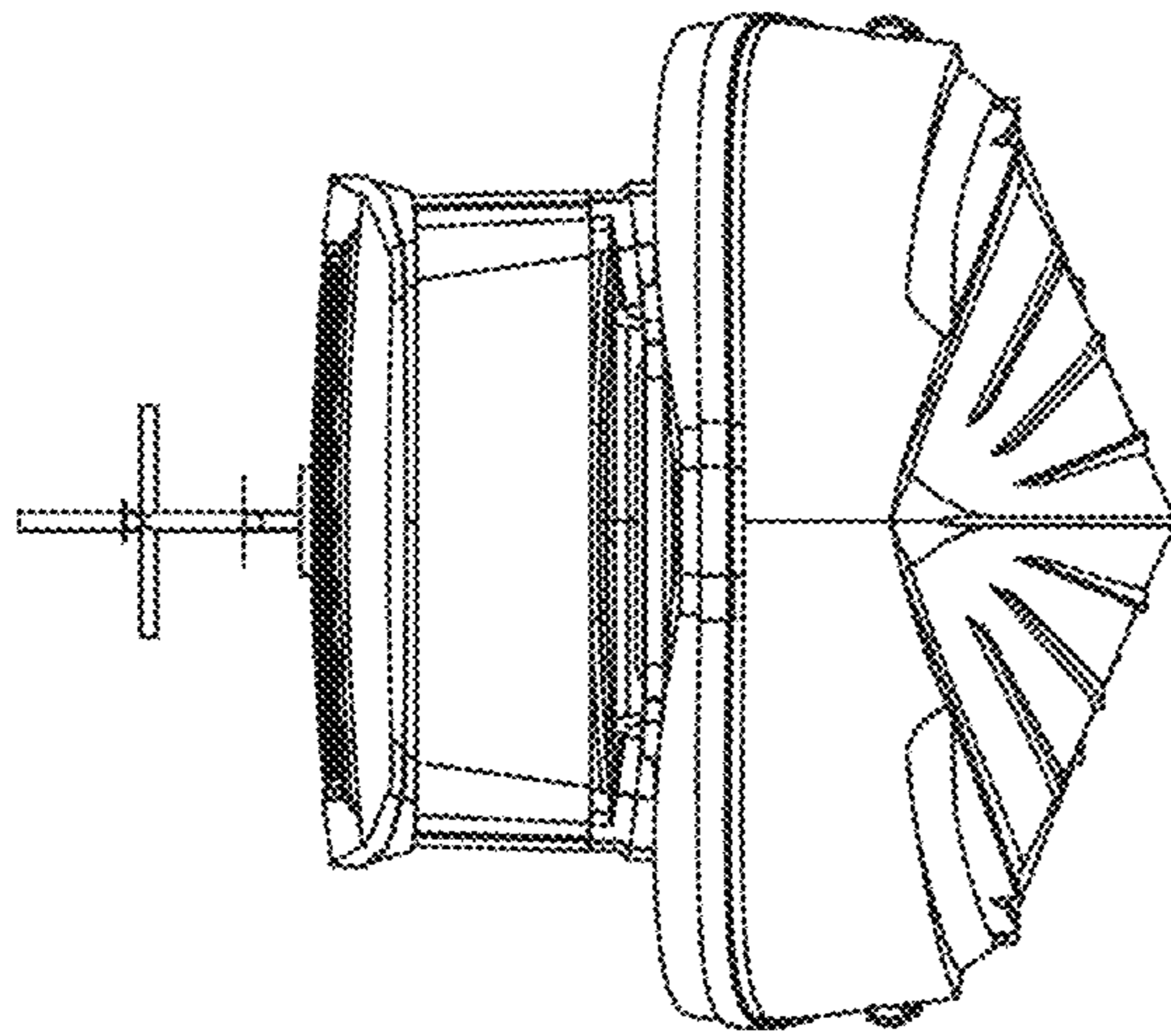

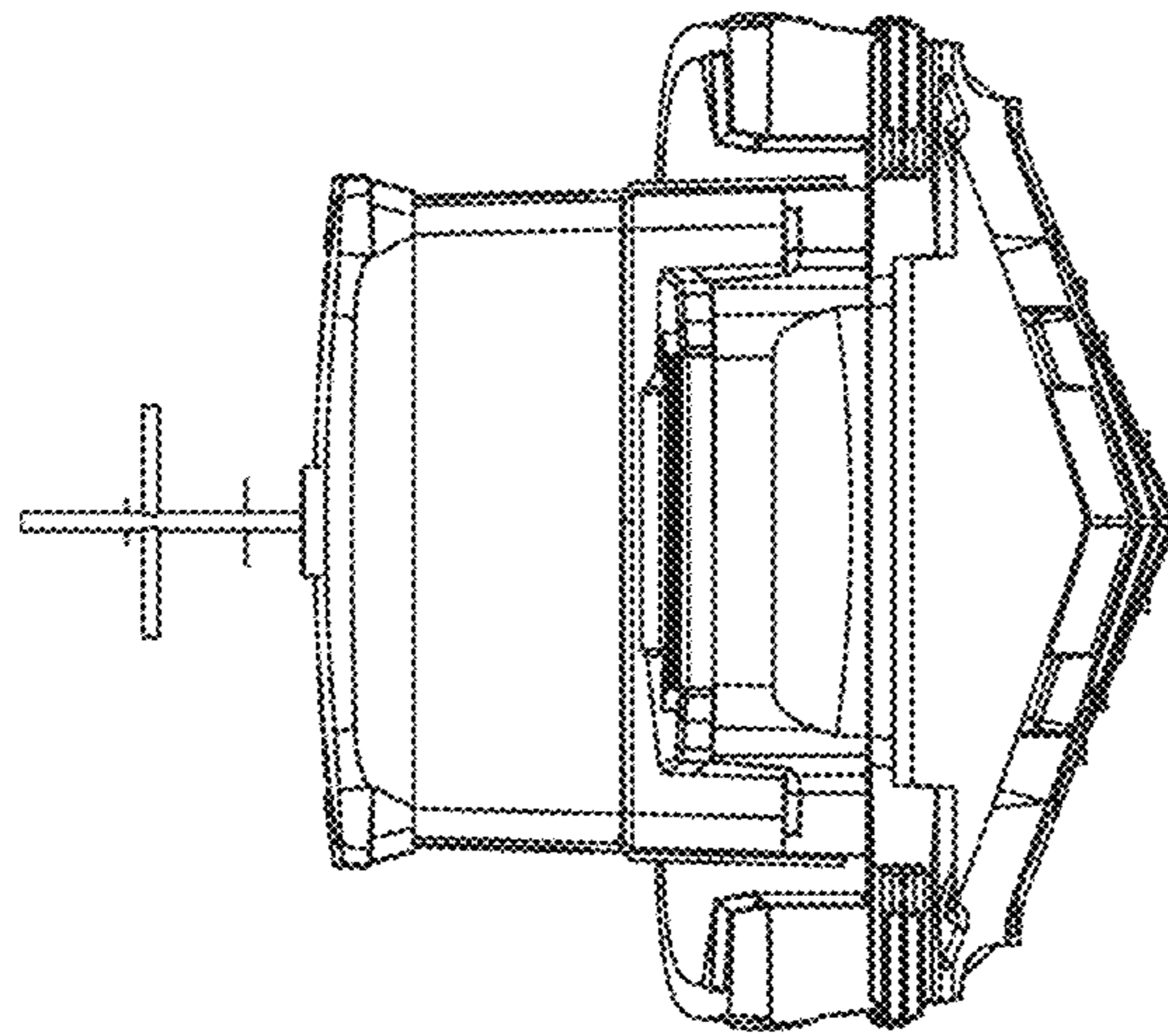

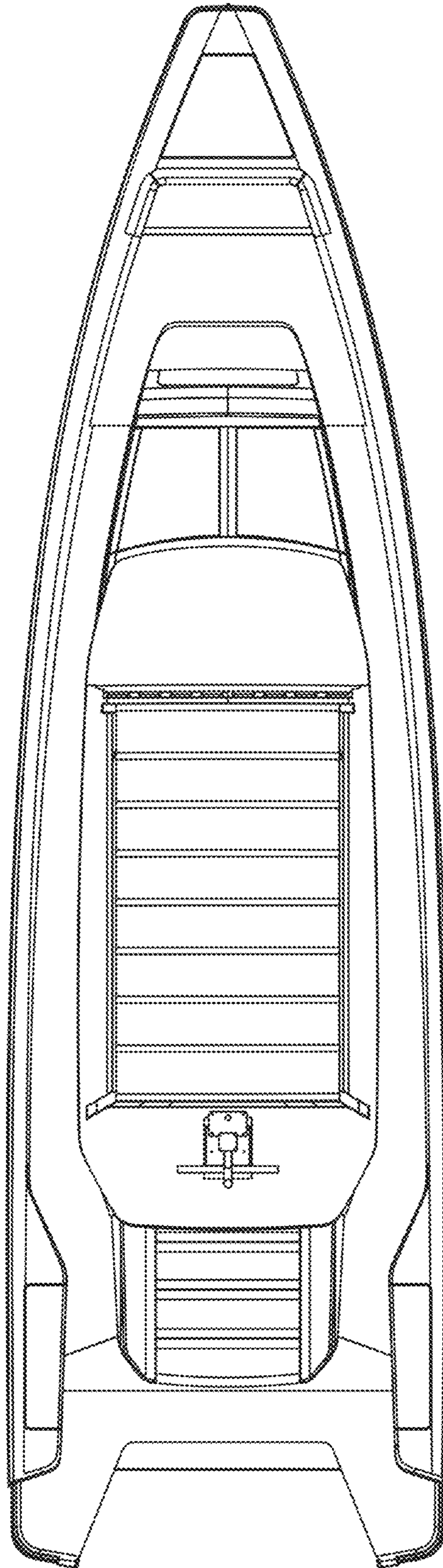

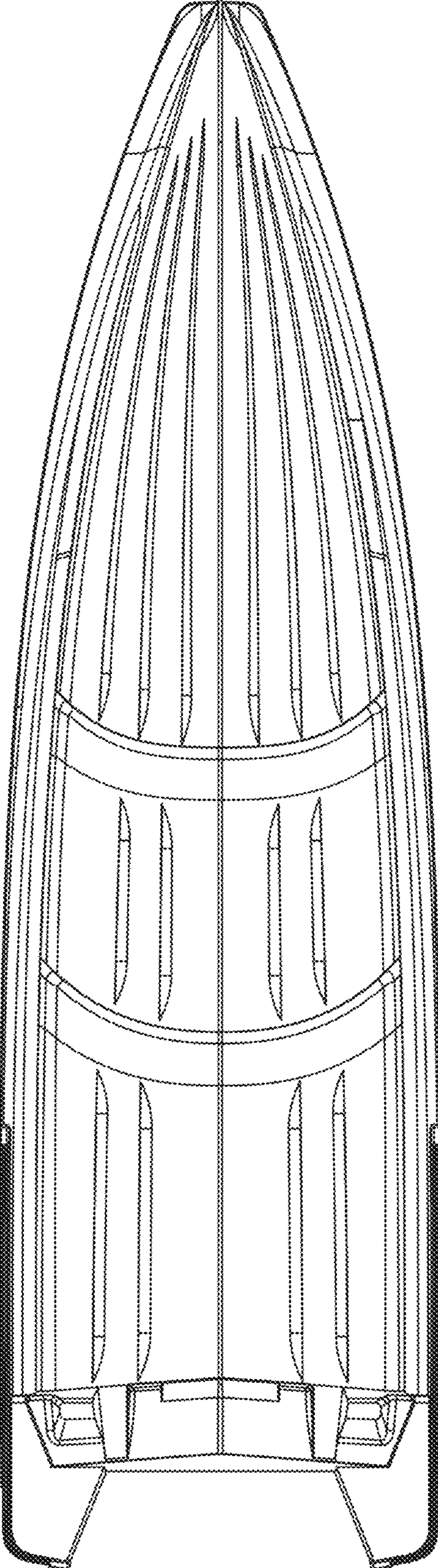
