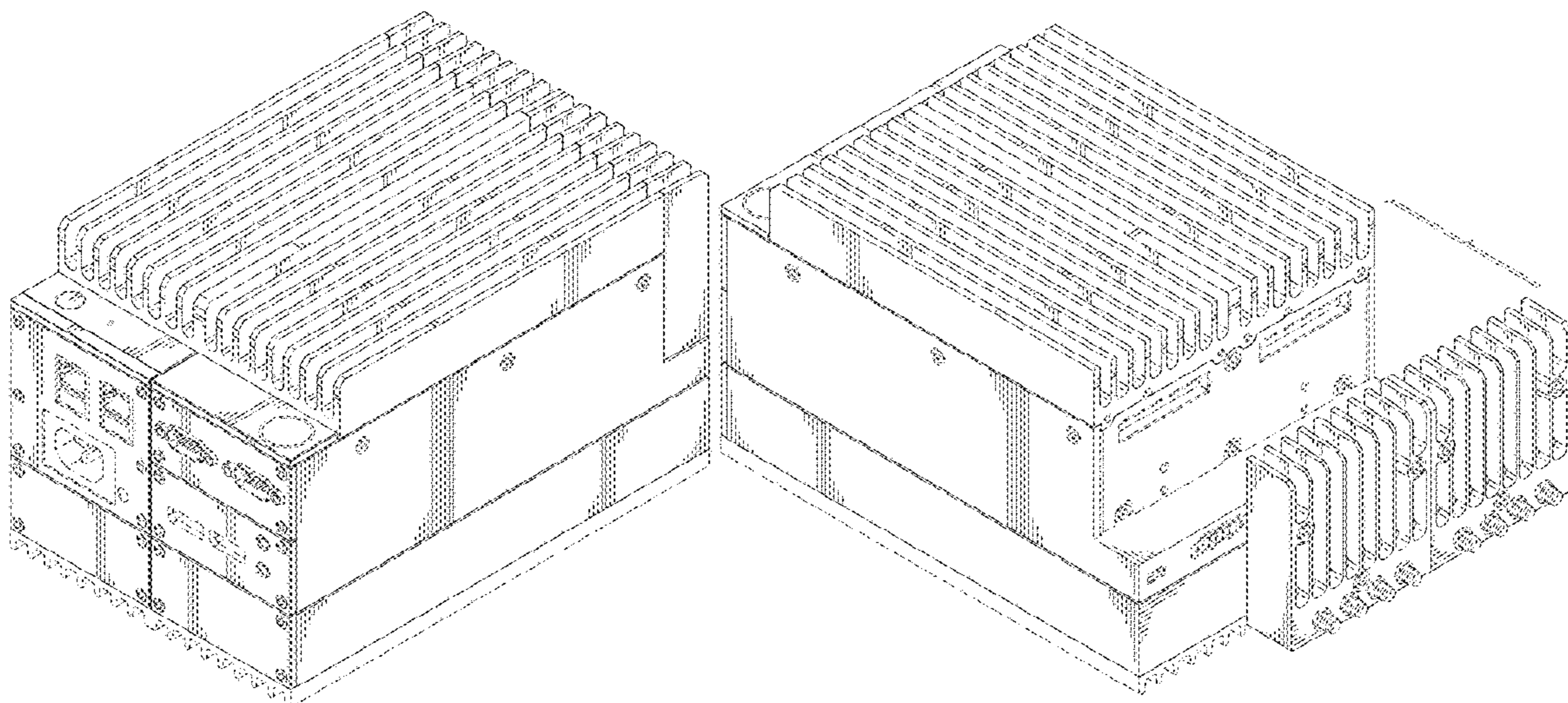
(57) **CLAIM**

The ornamental design for an information handling system IoT gateway, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the information handling system IoT gateway comprising the present invention;

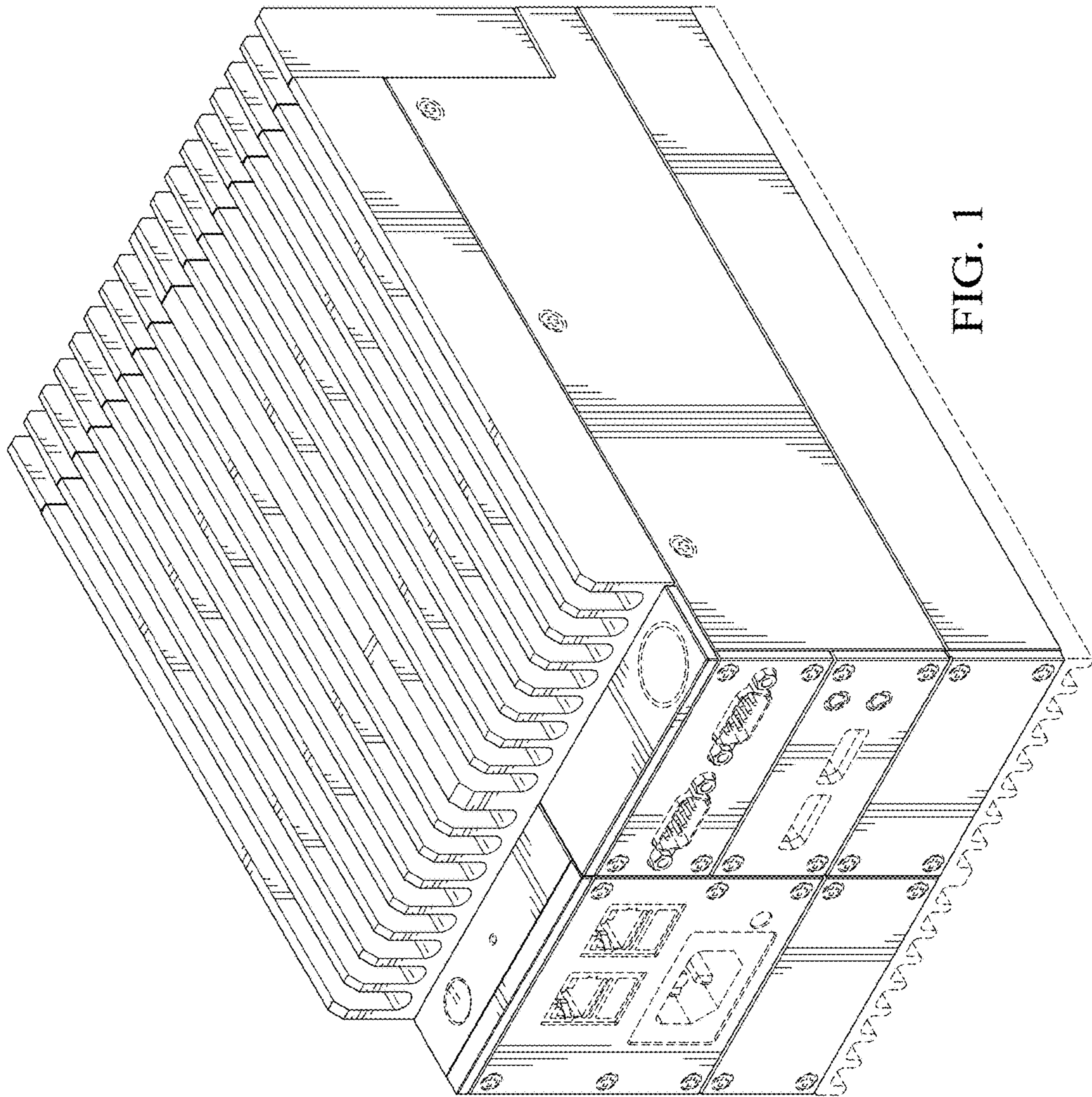

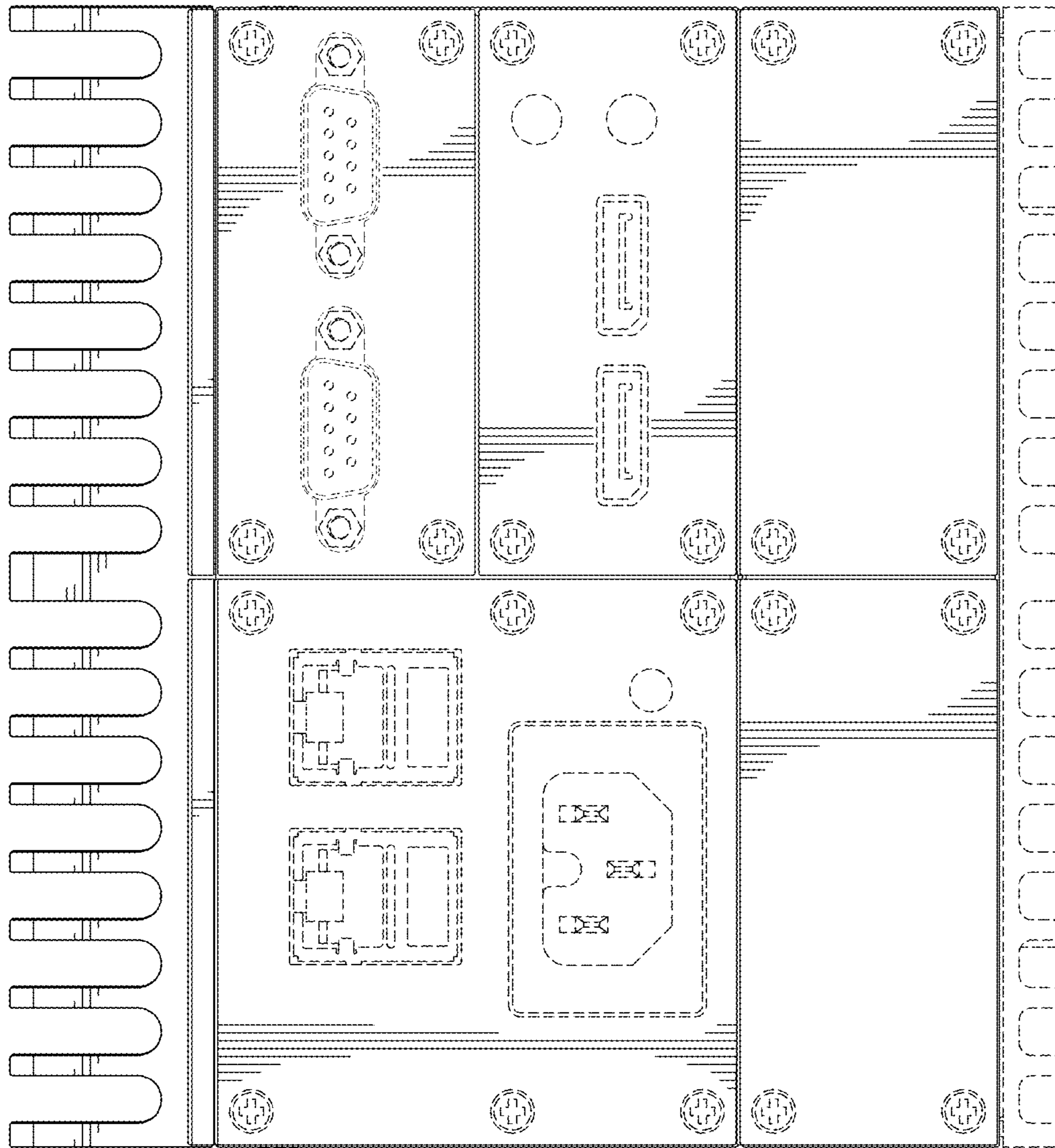

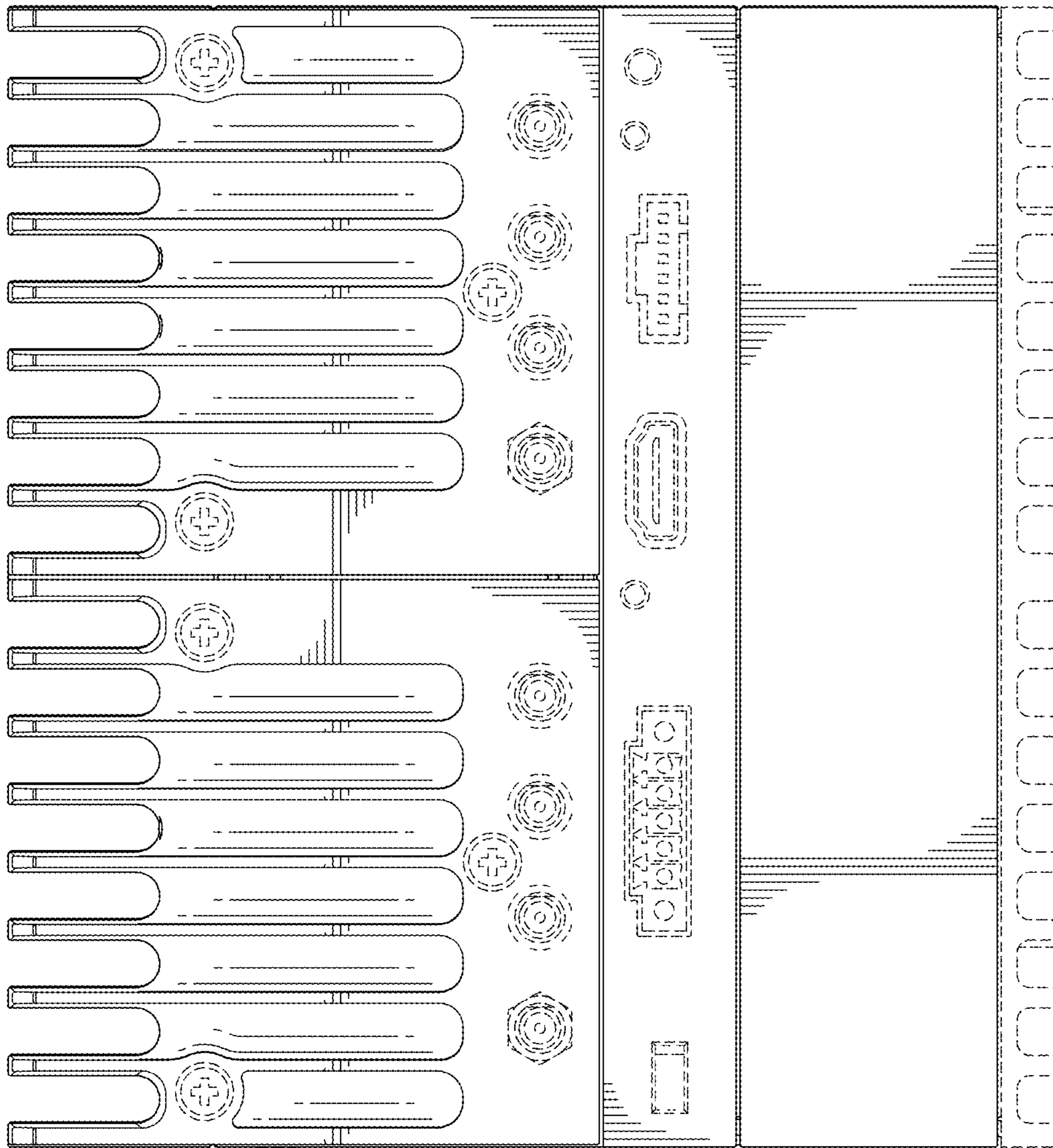

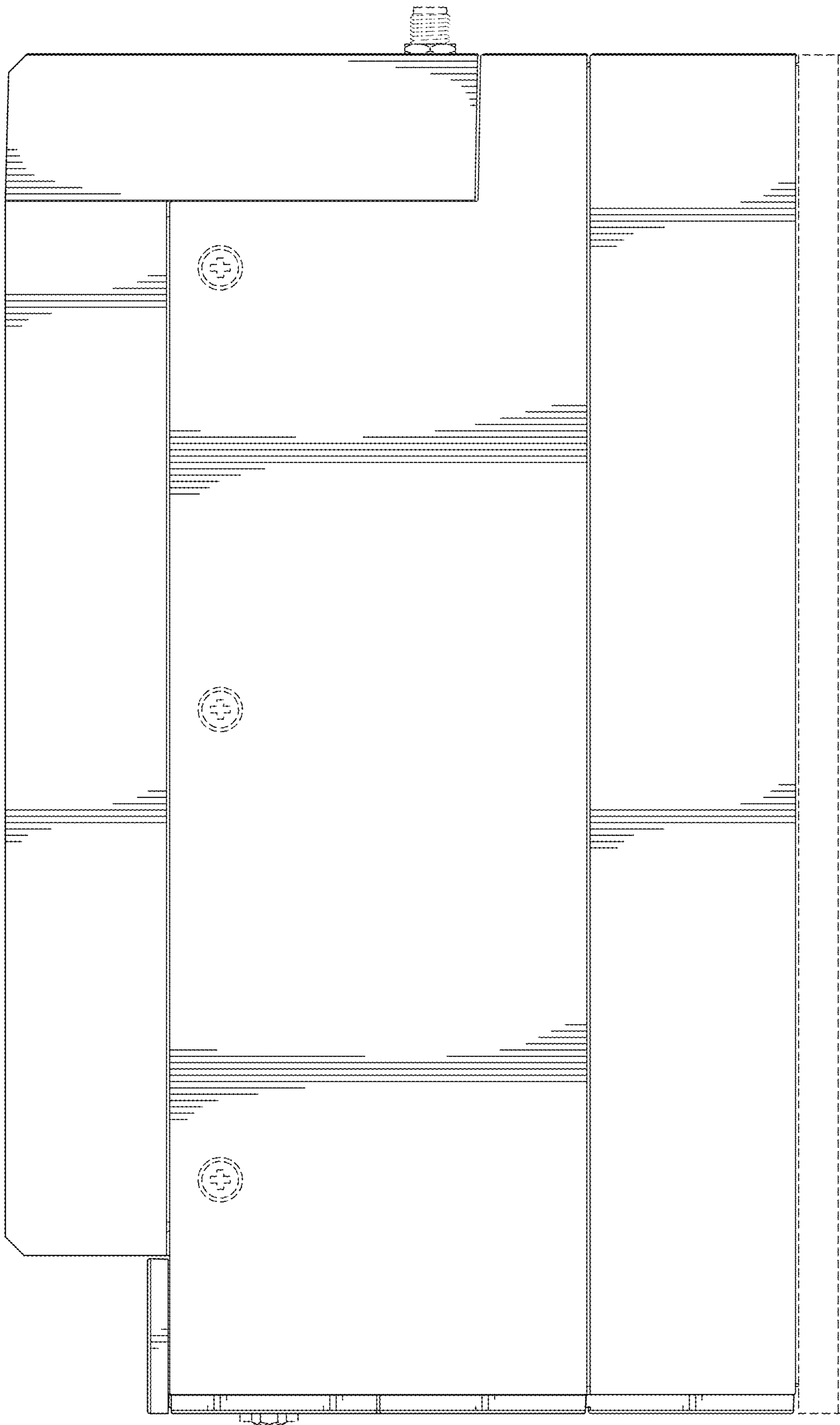

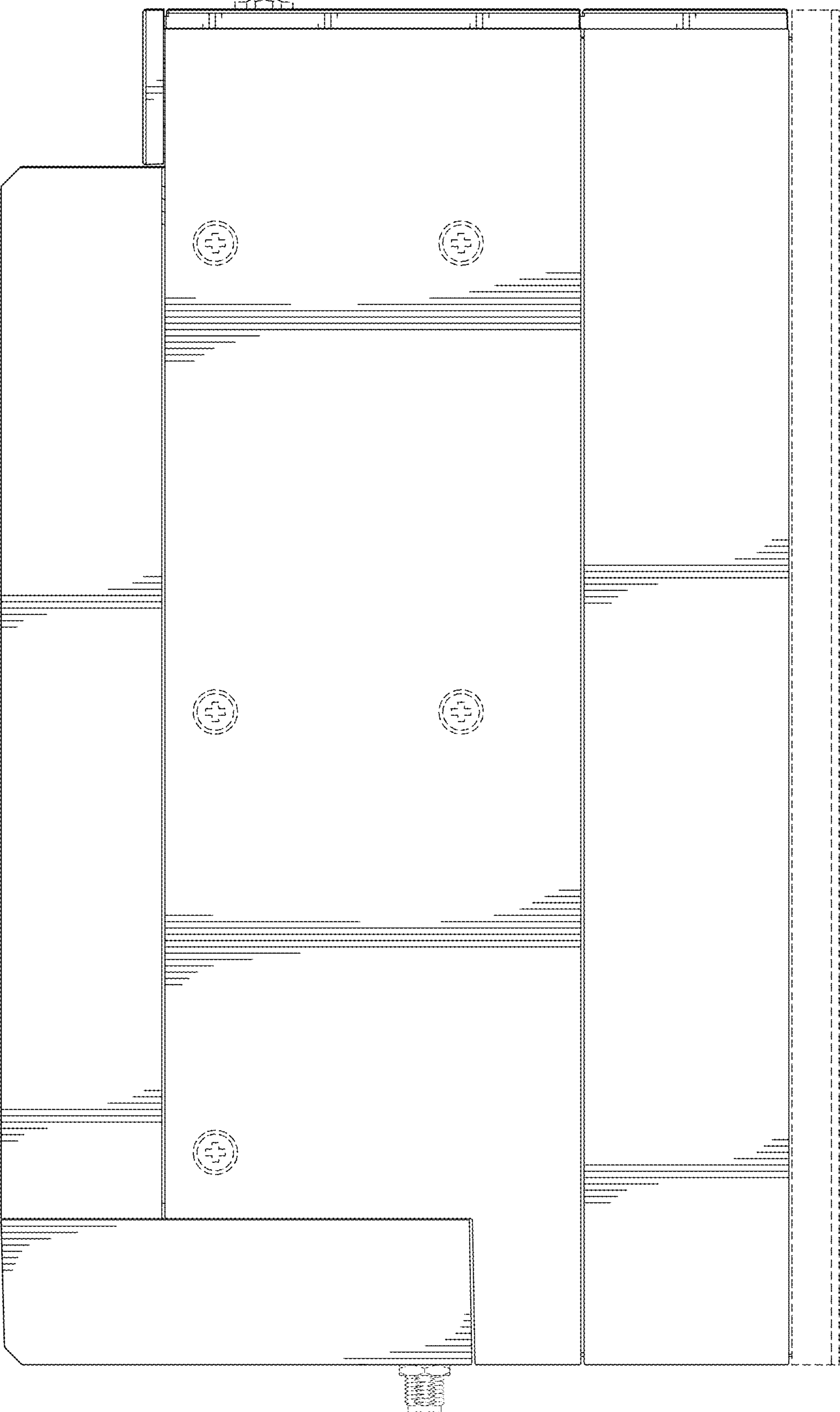

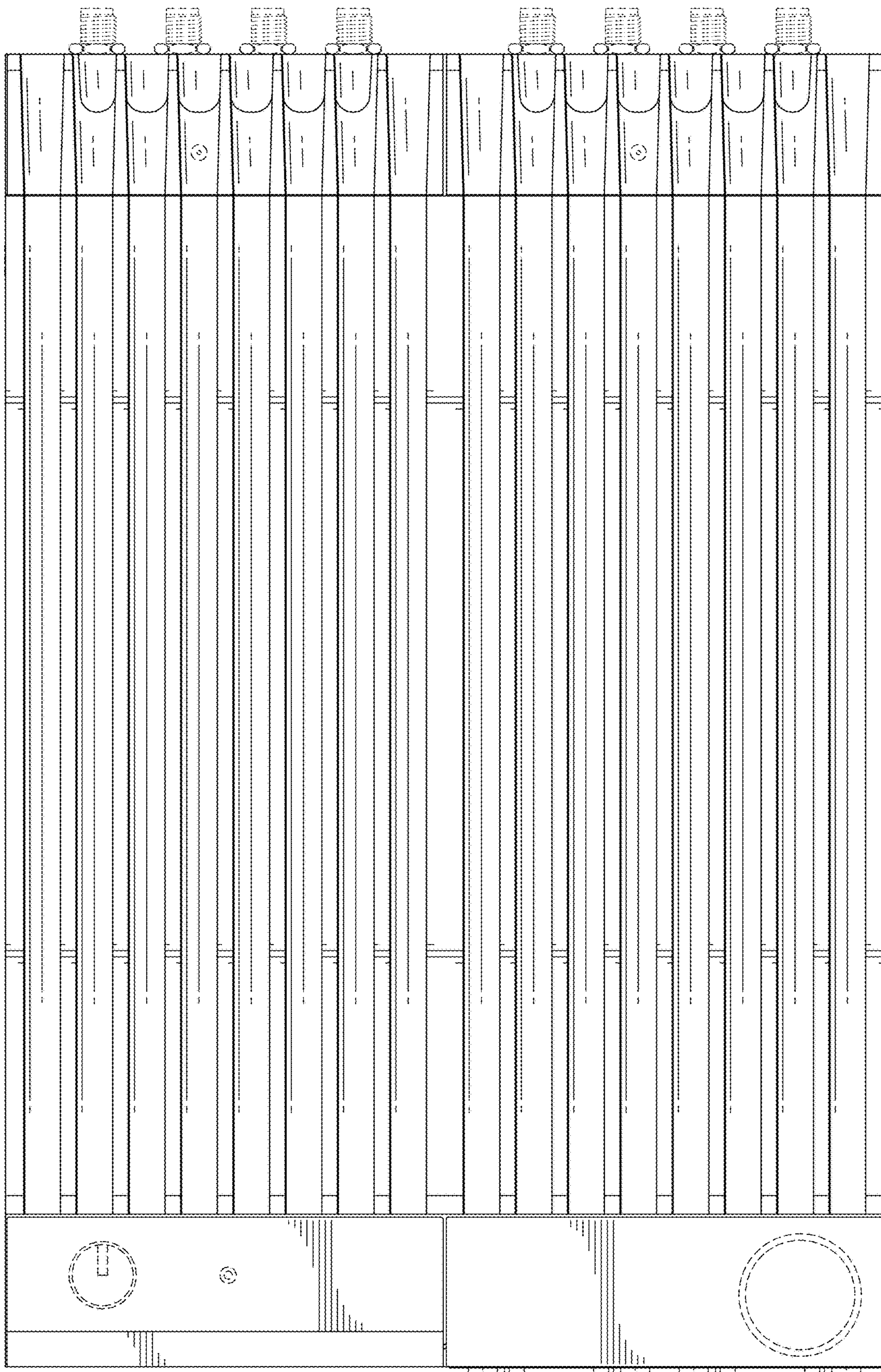

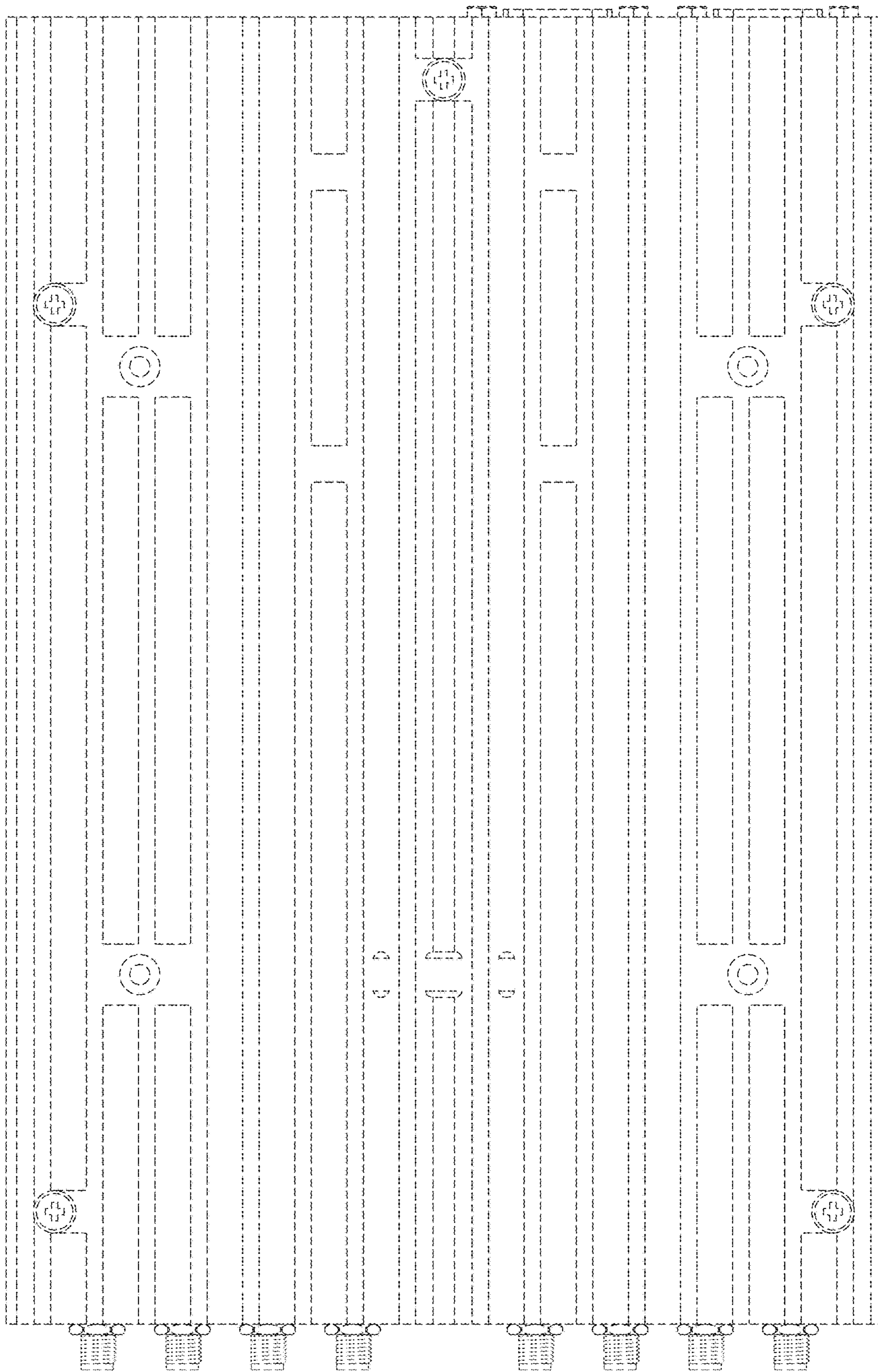

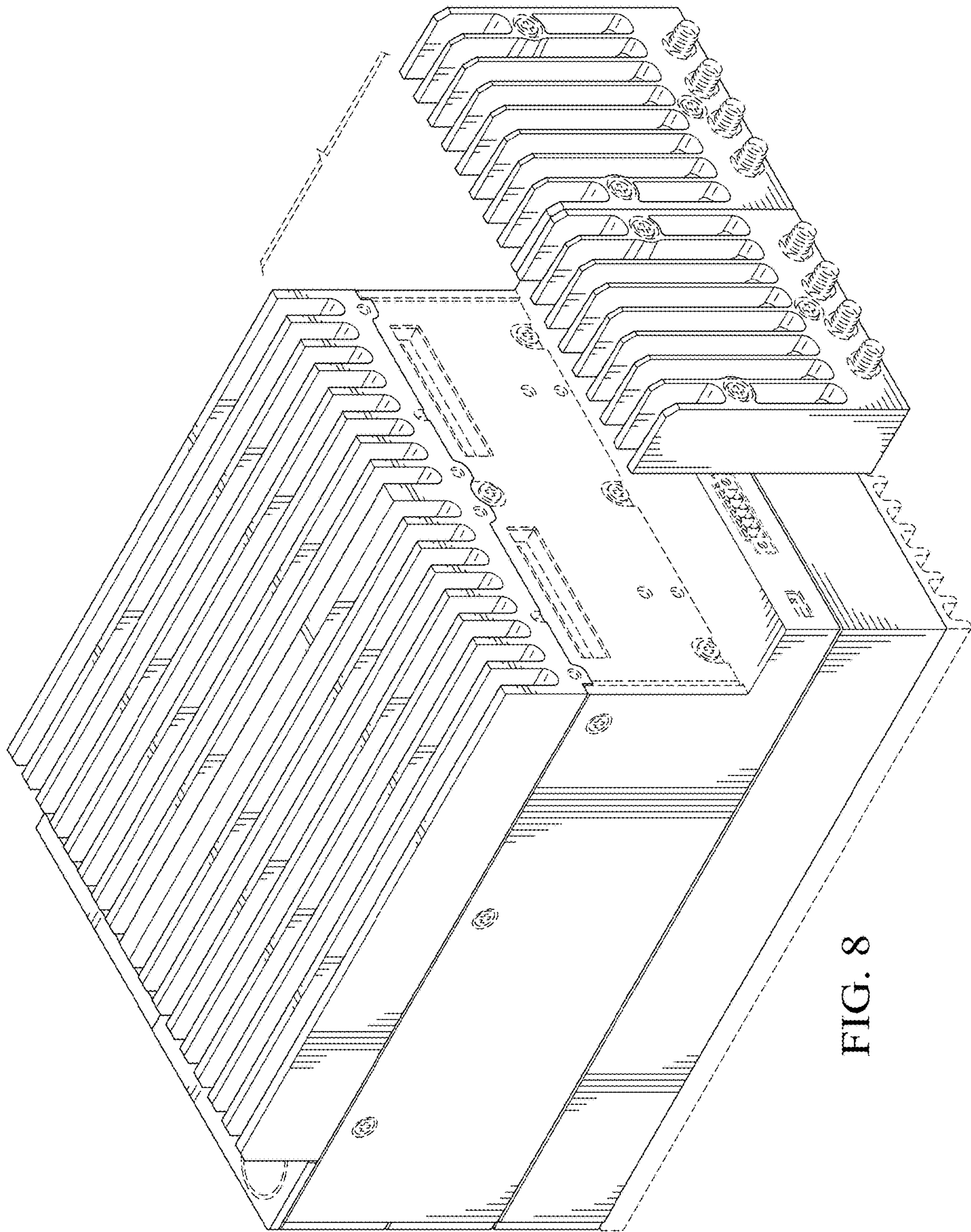
