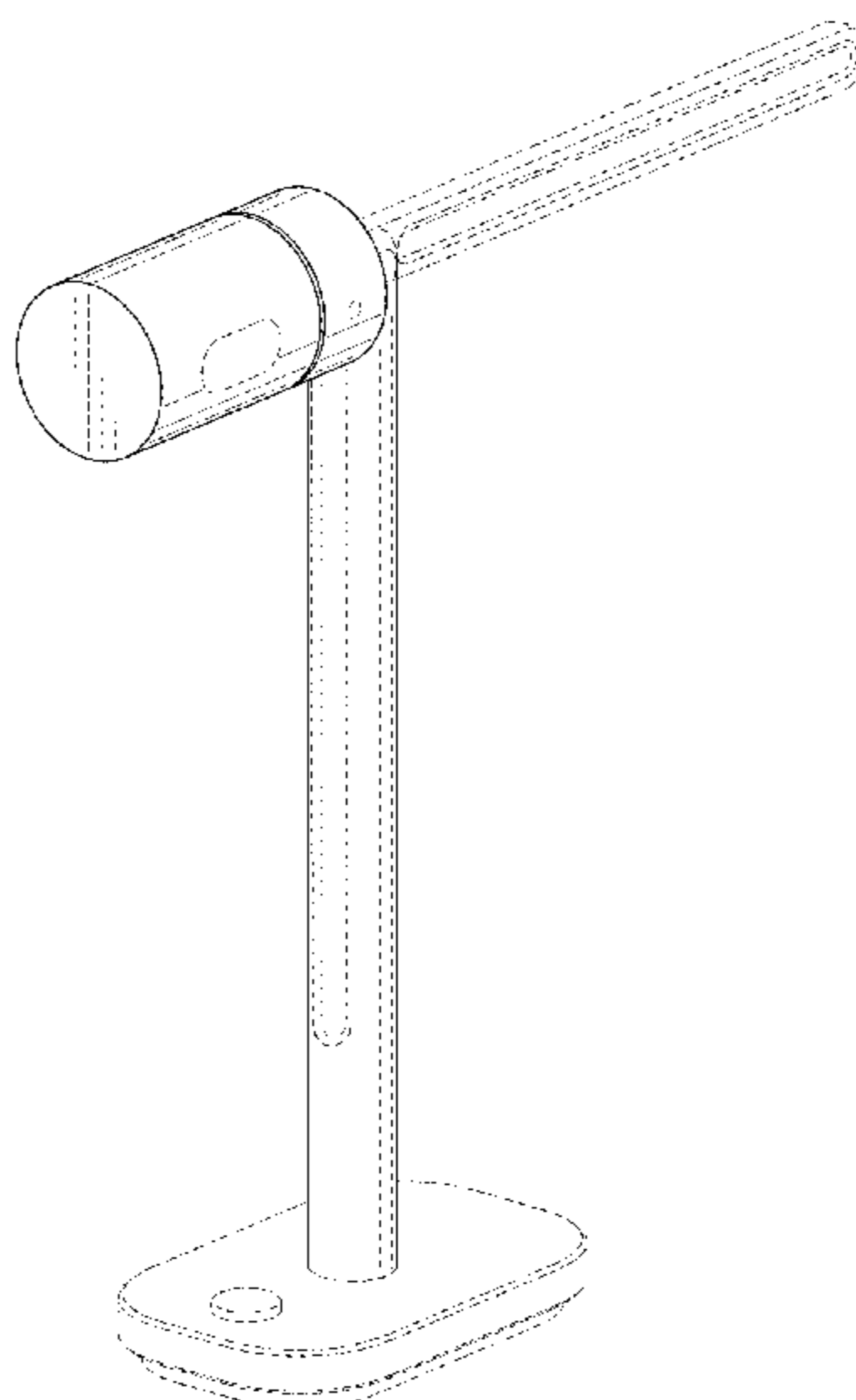
The ornamental design for a projector equipped with lamp,

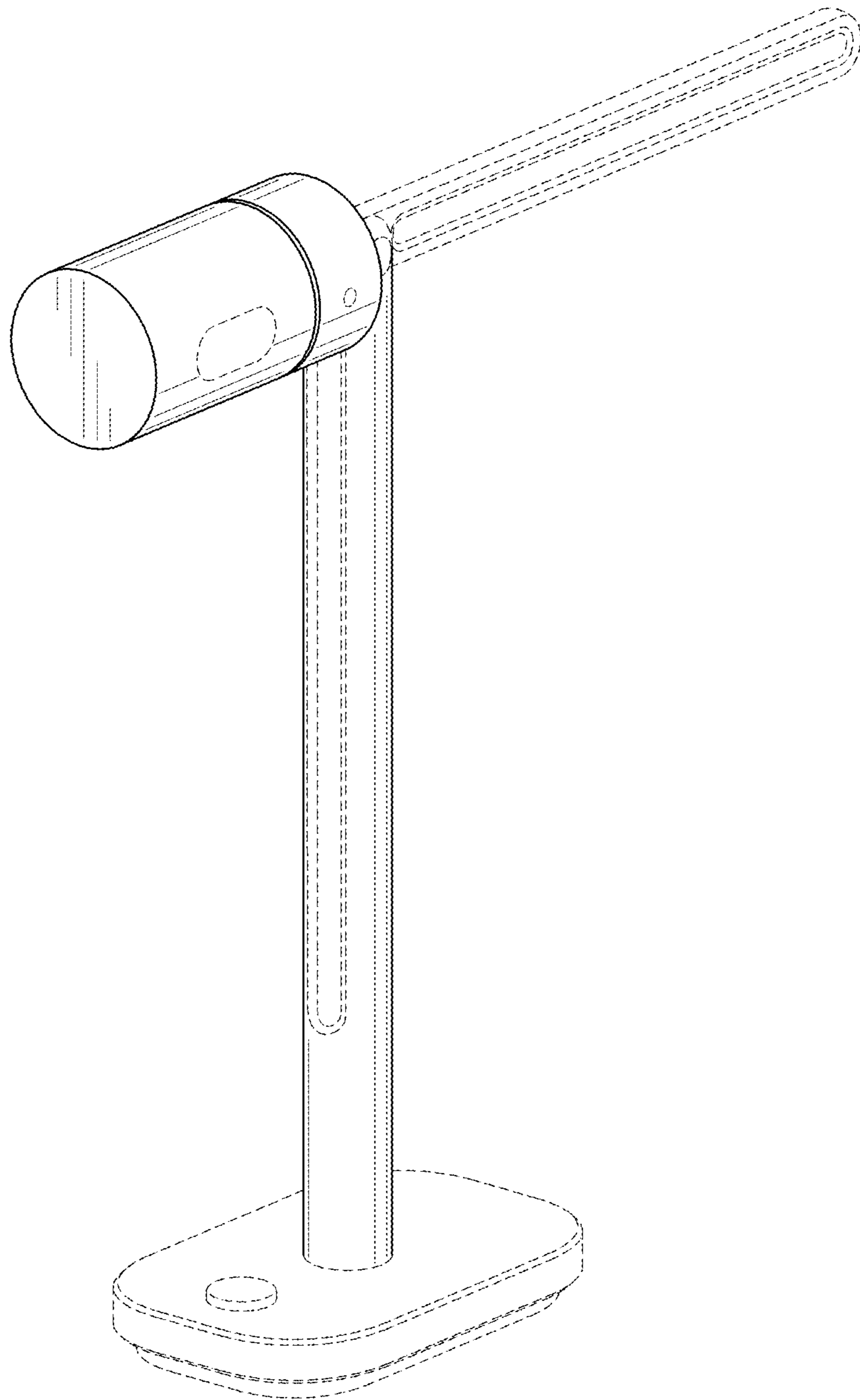

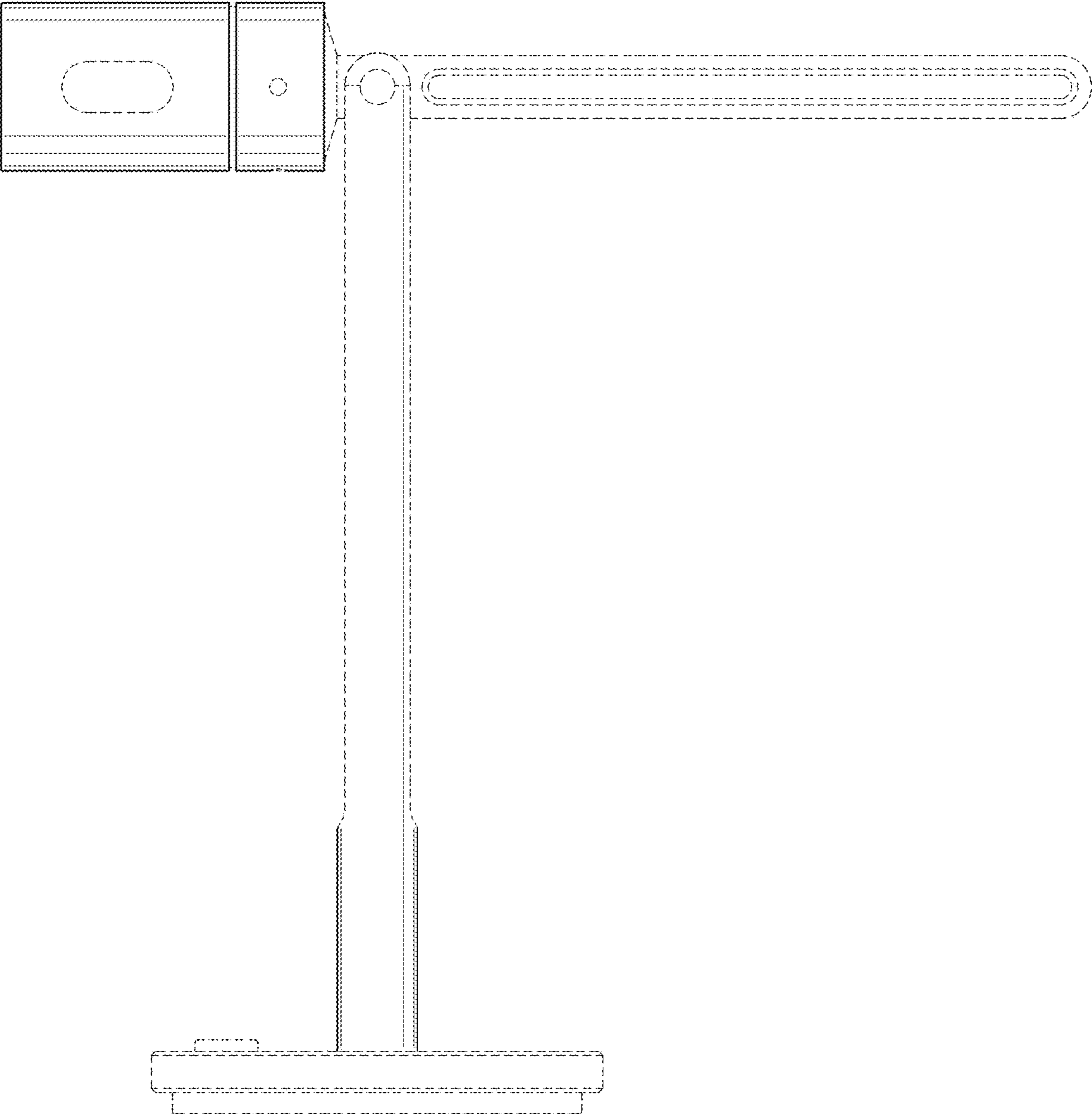

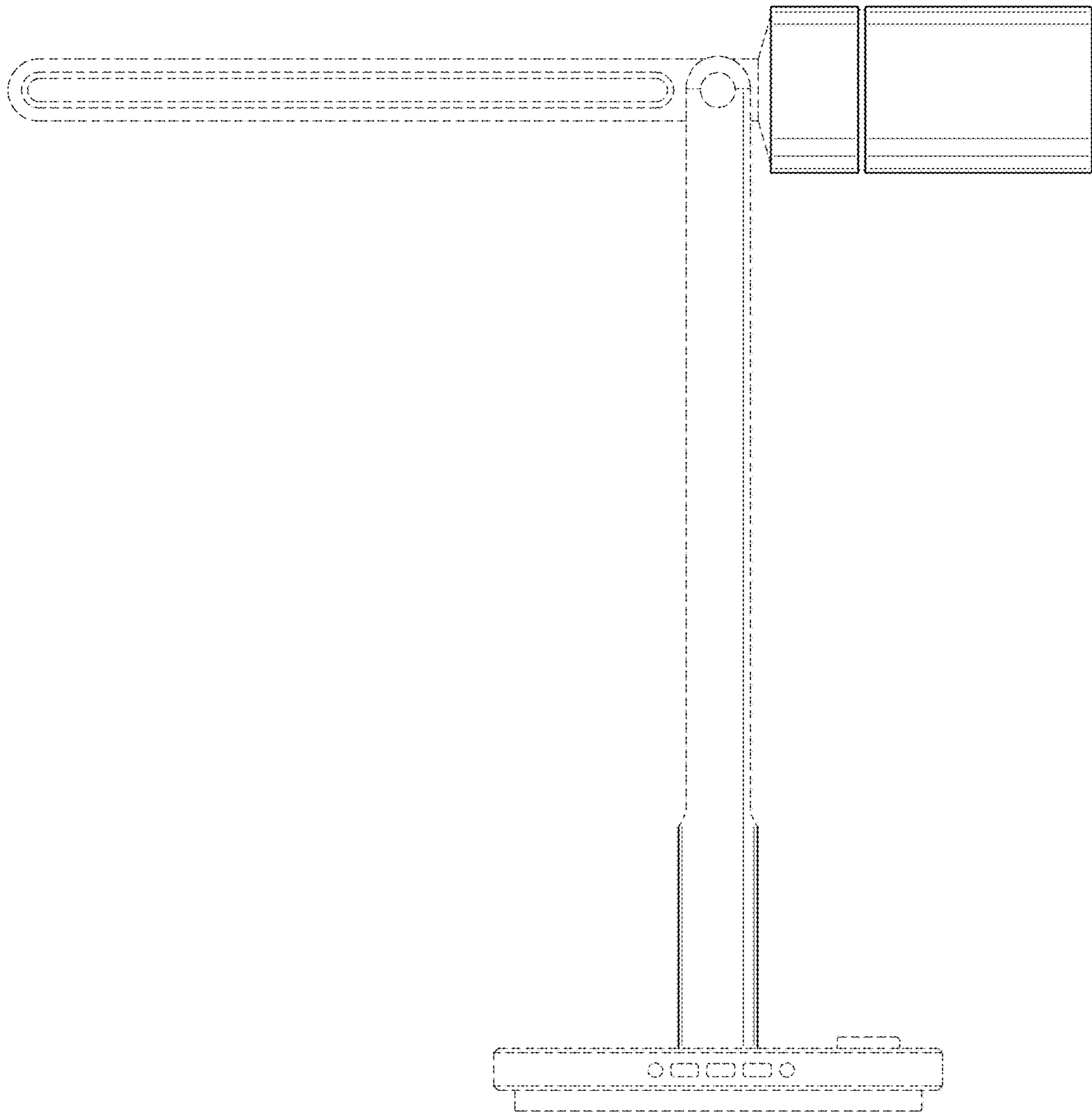

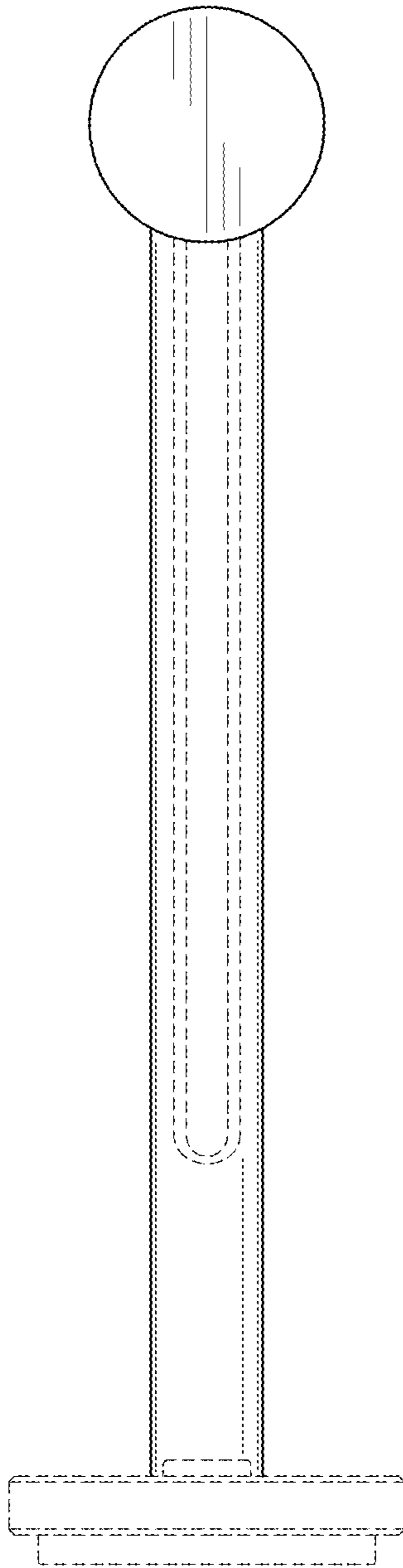

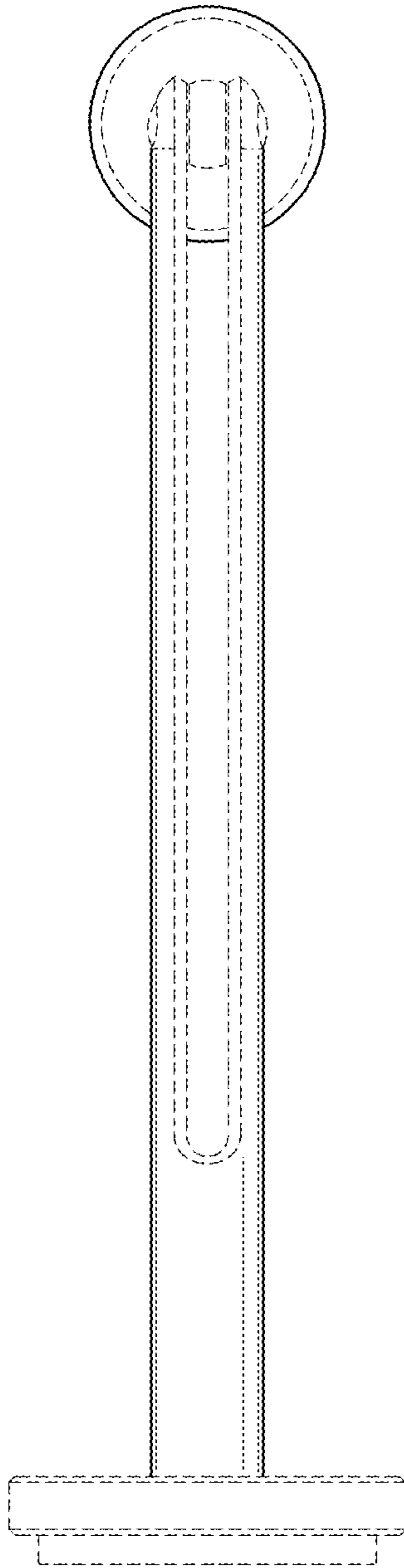

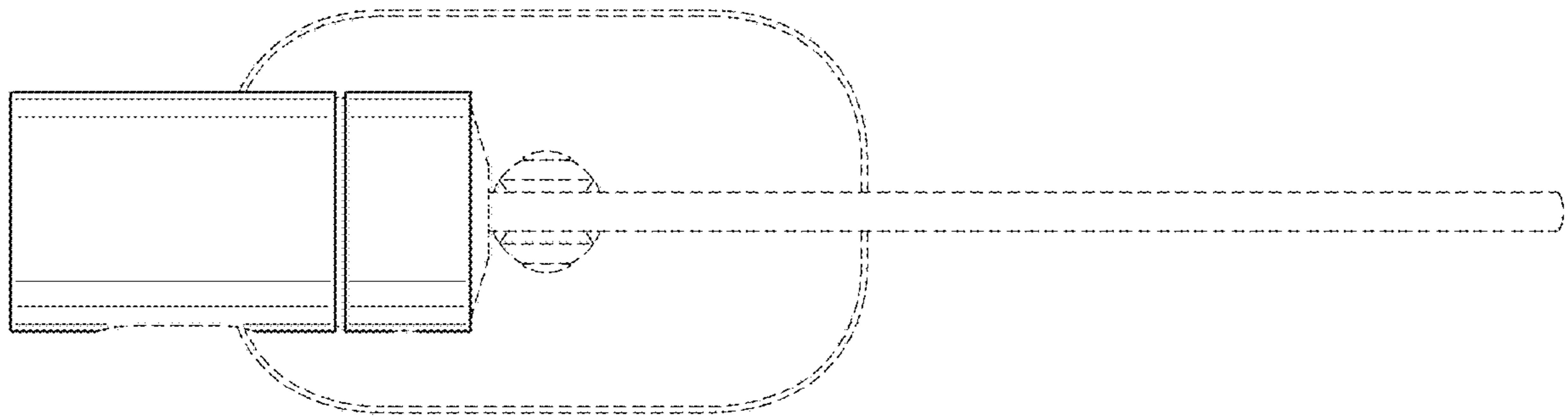

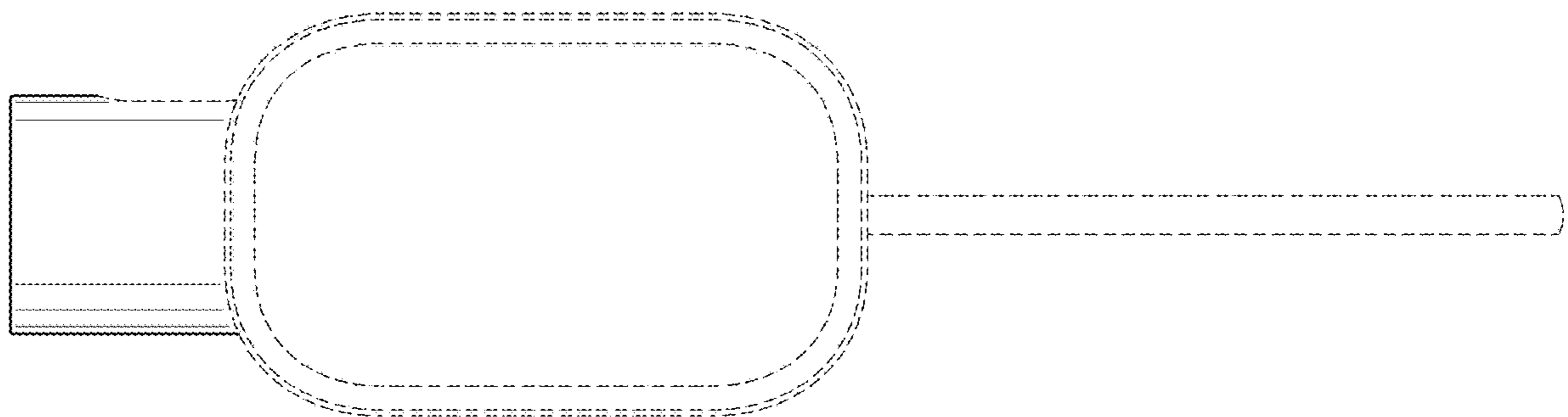

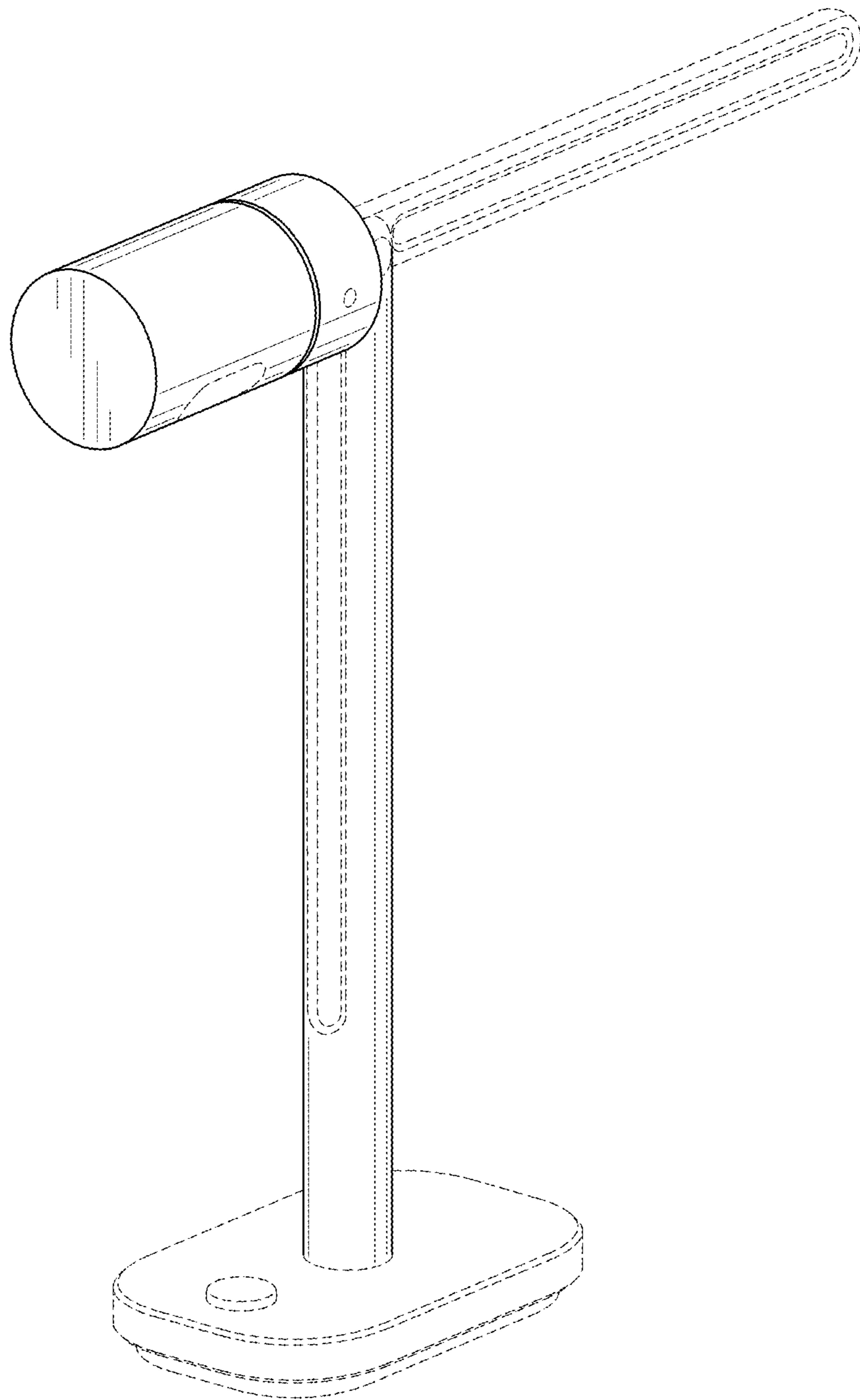

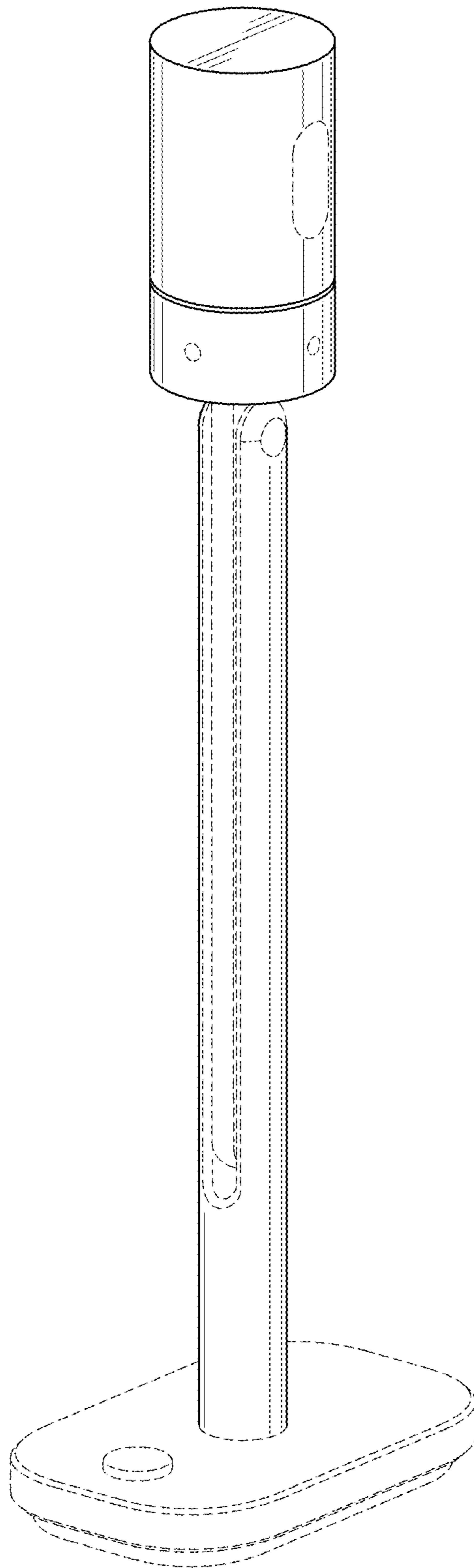

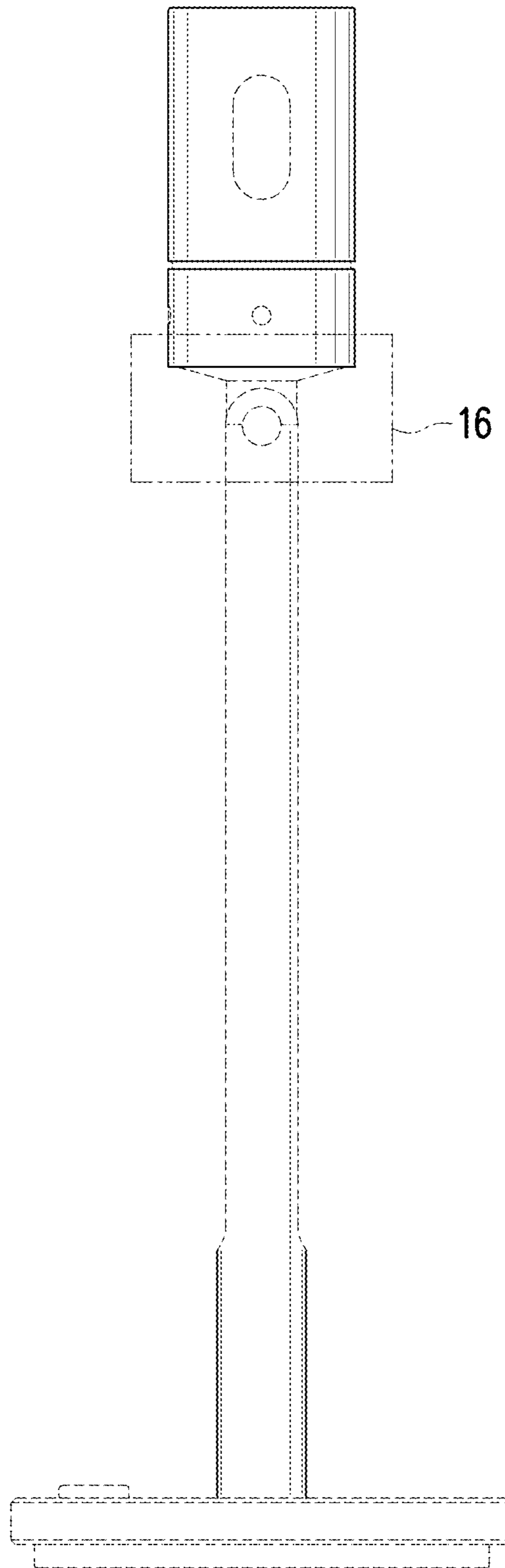

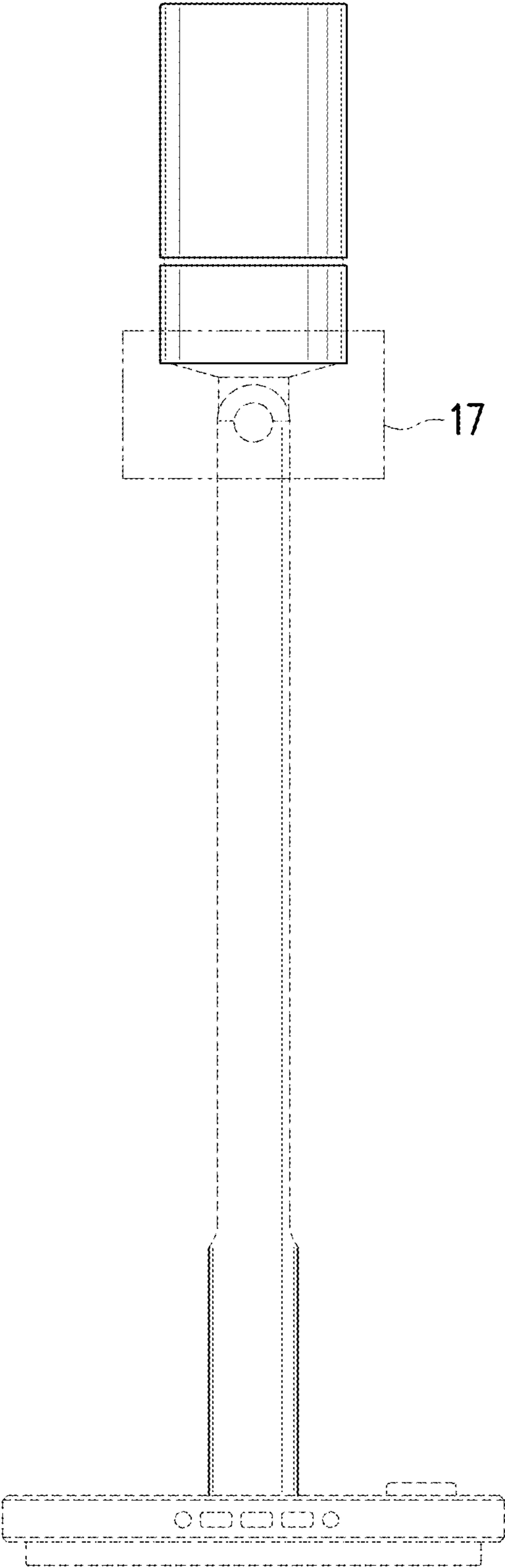

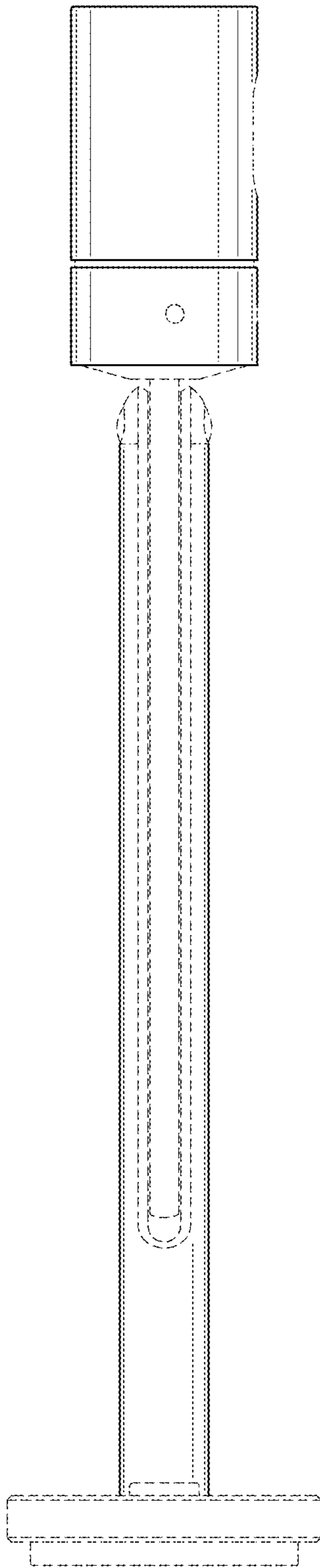

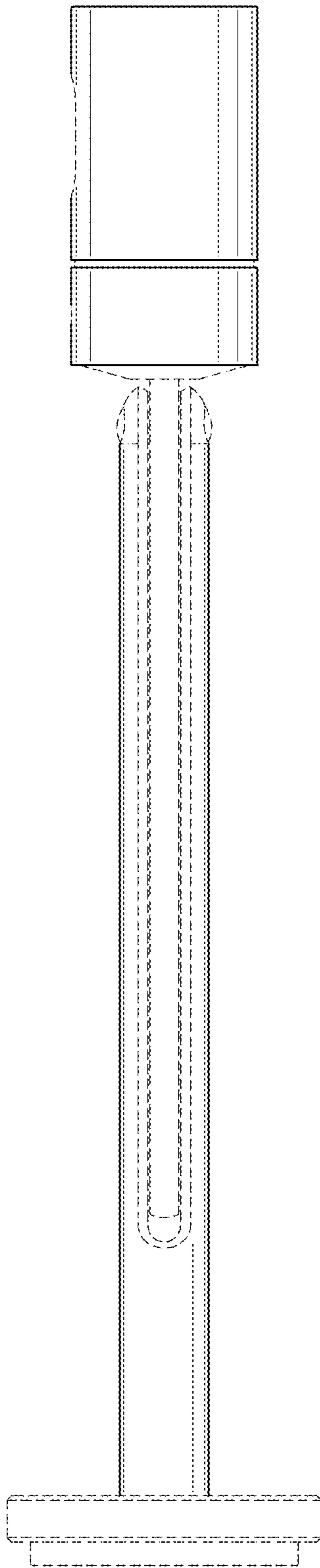

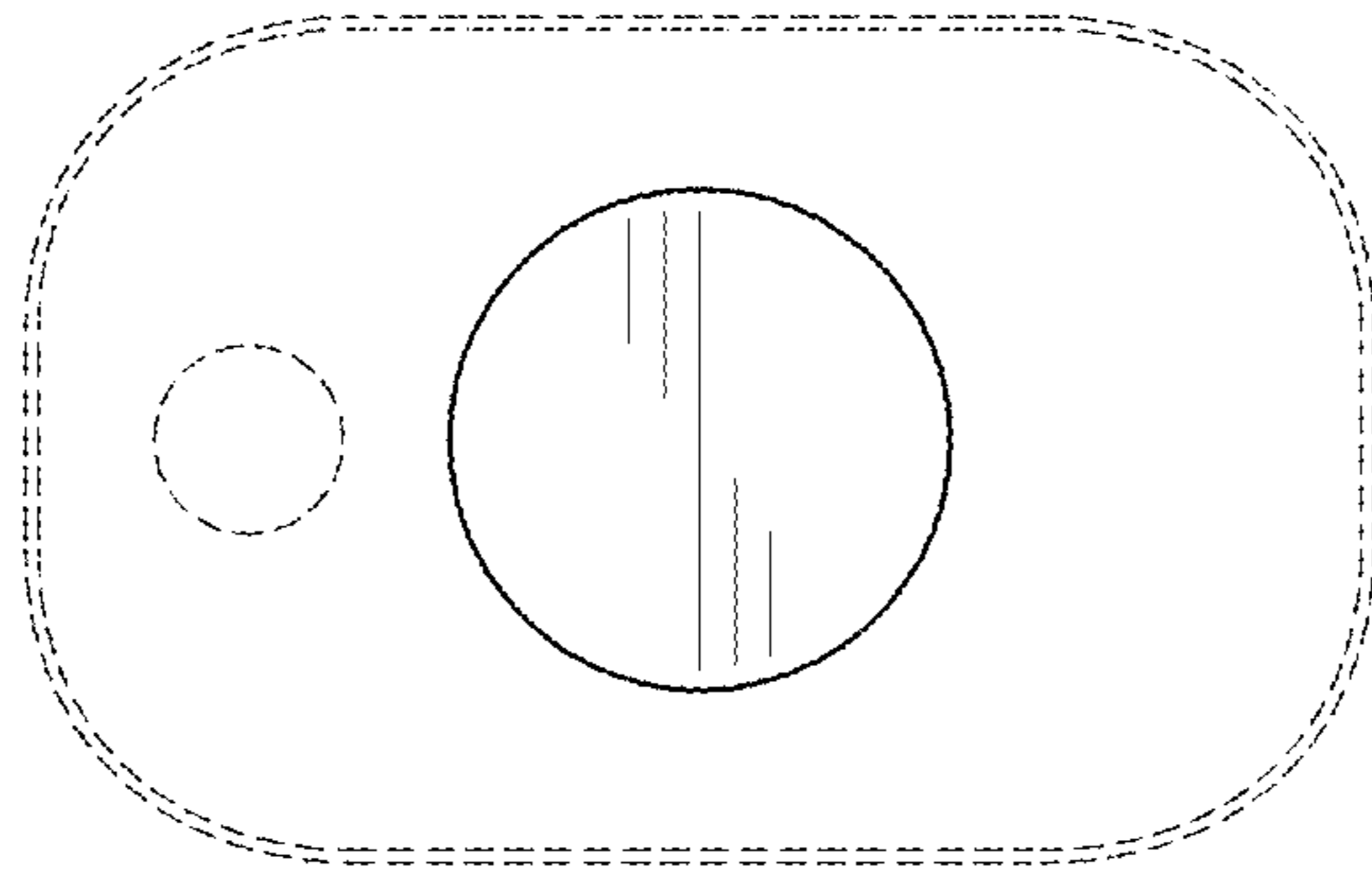

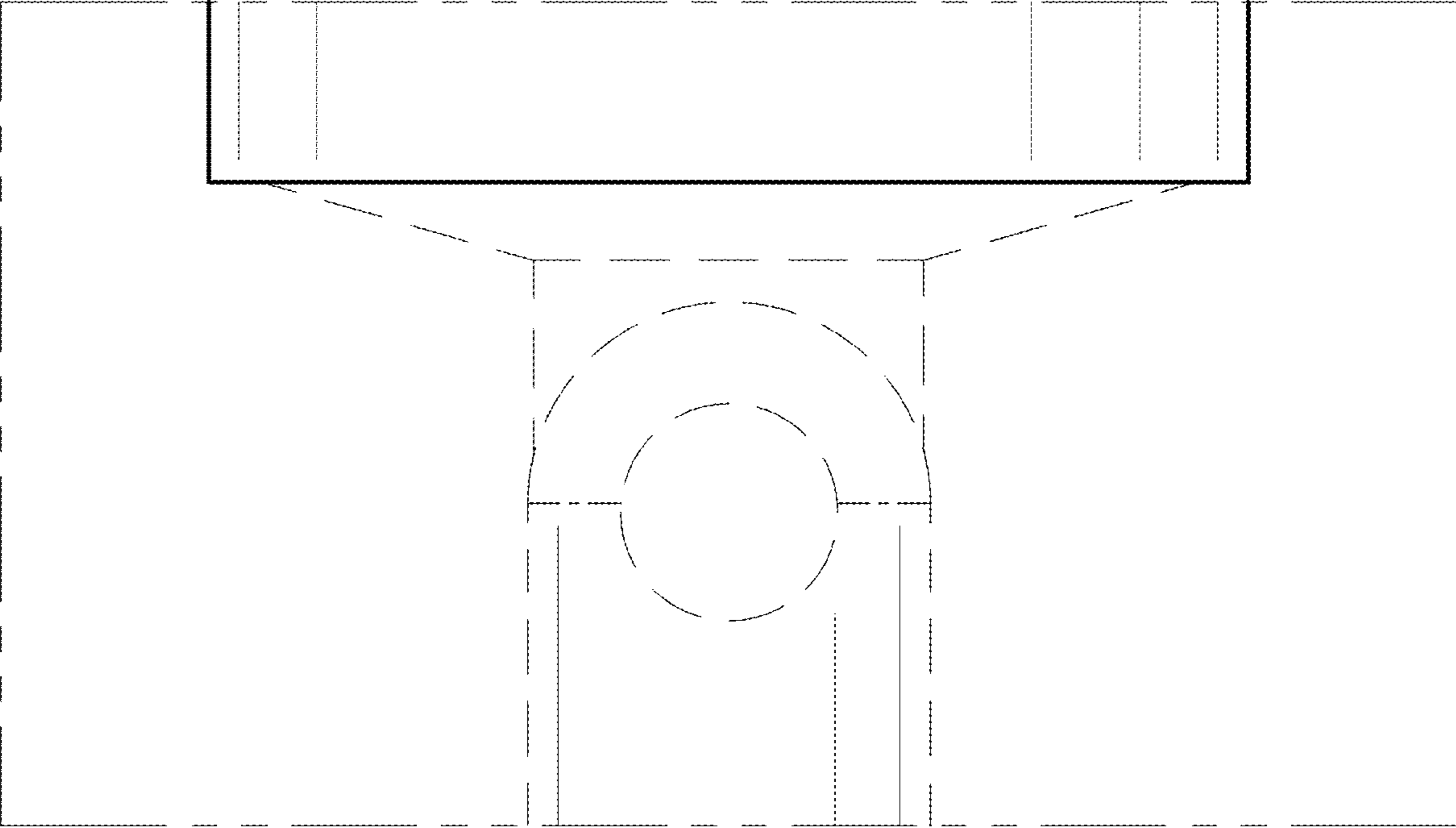

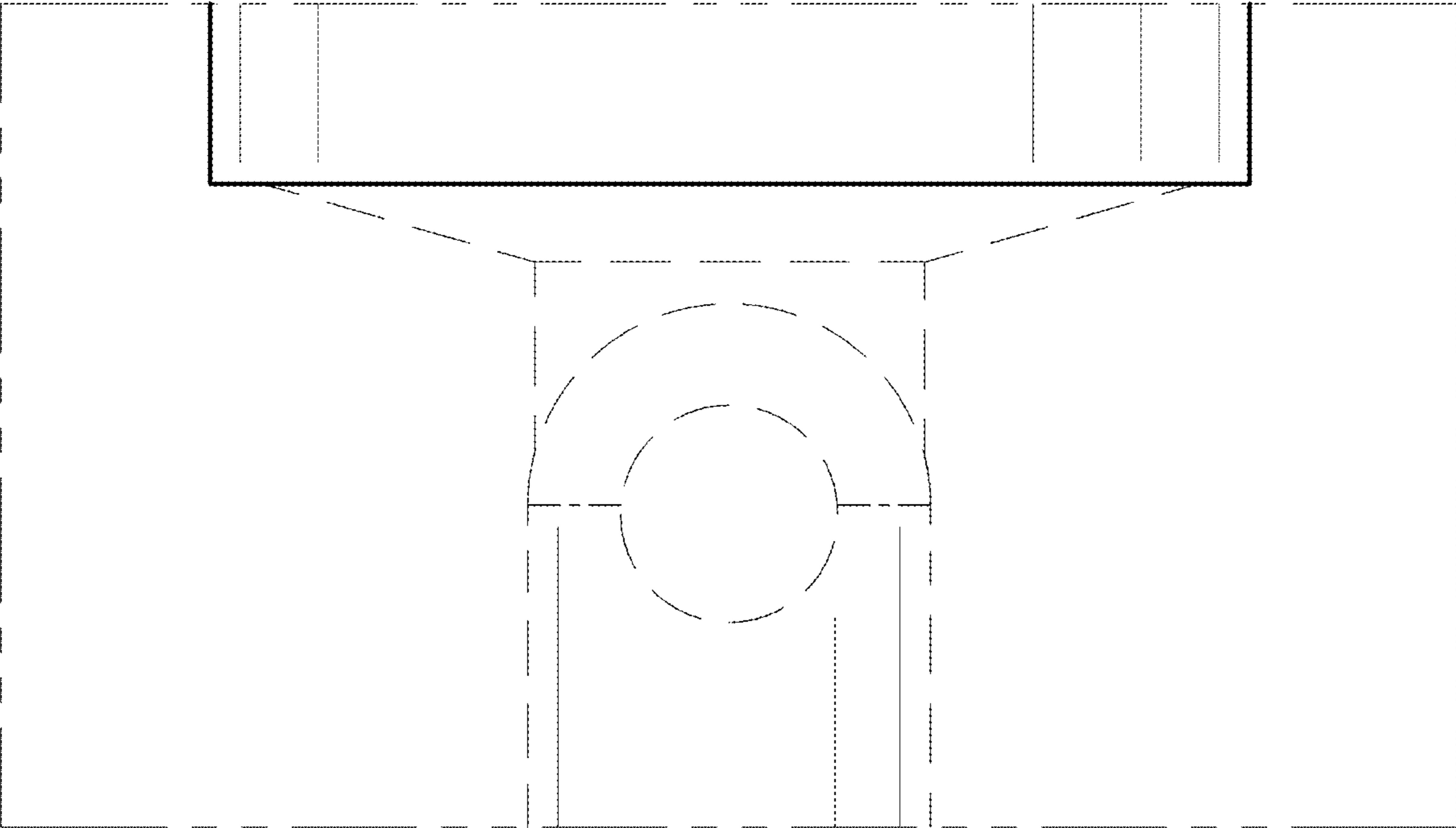
