The ornamental design for a typeface, as shown and described.

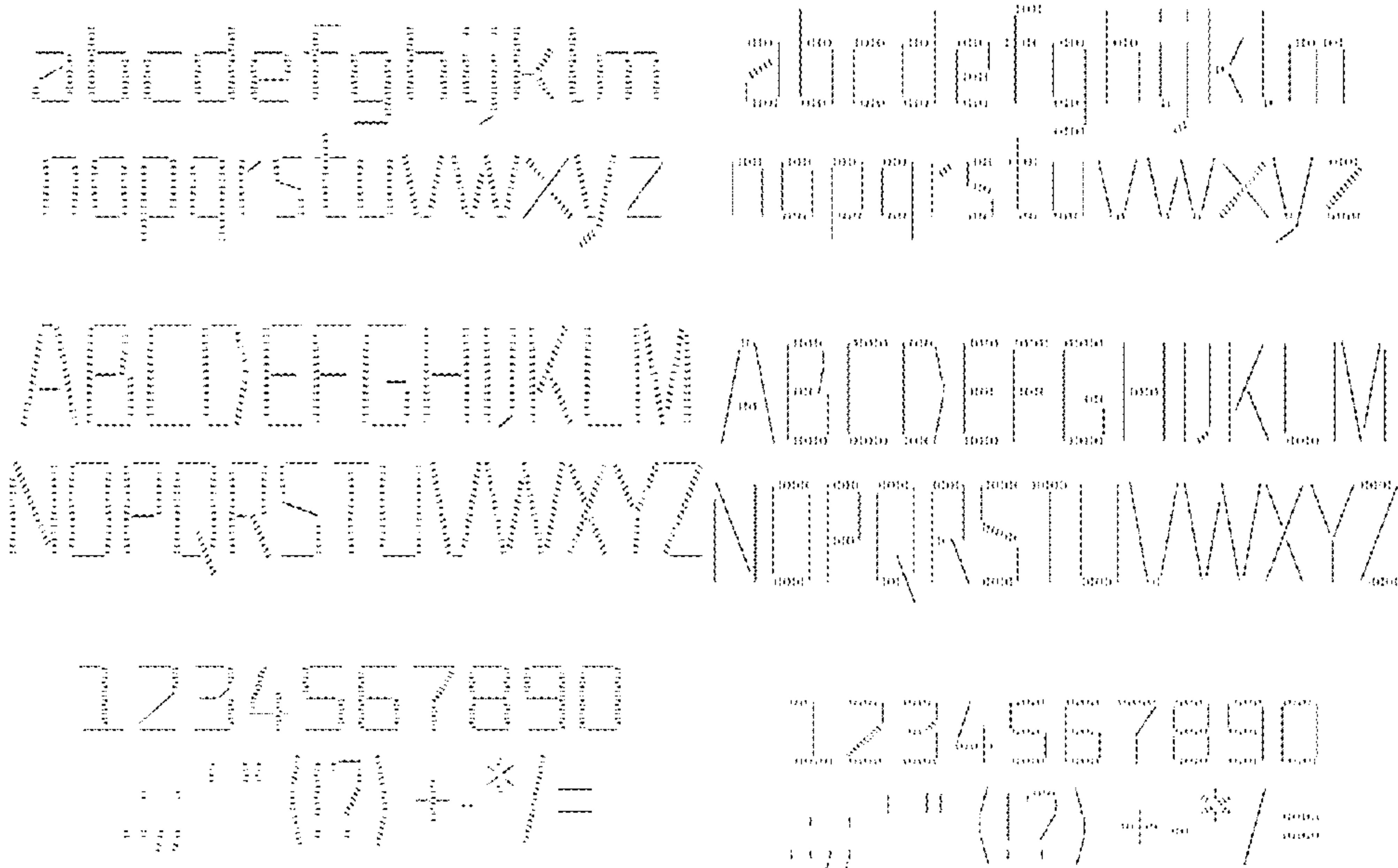
DESCRIPTION

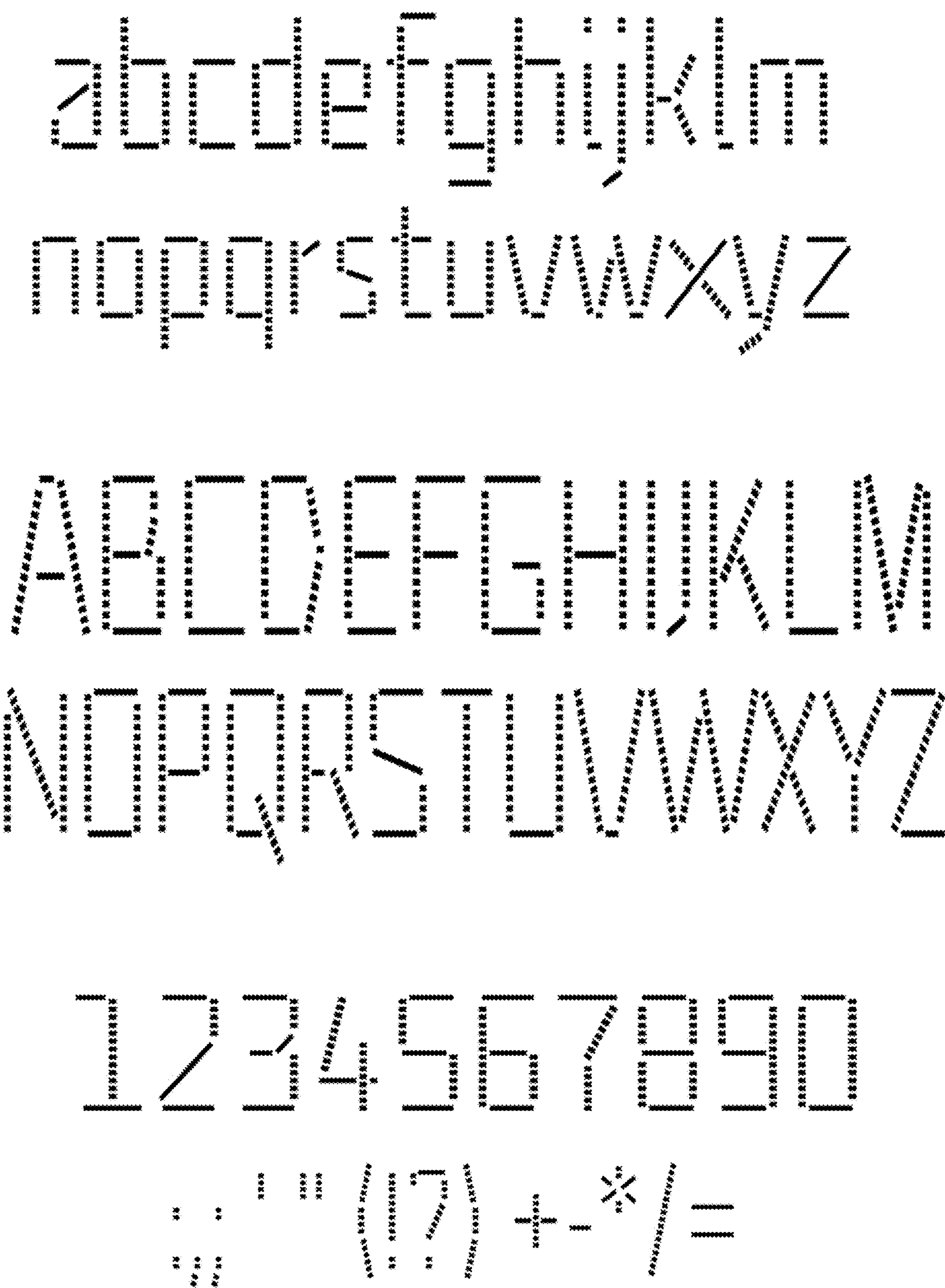
