(57) **CLAIM**

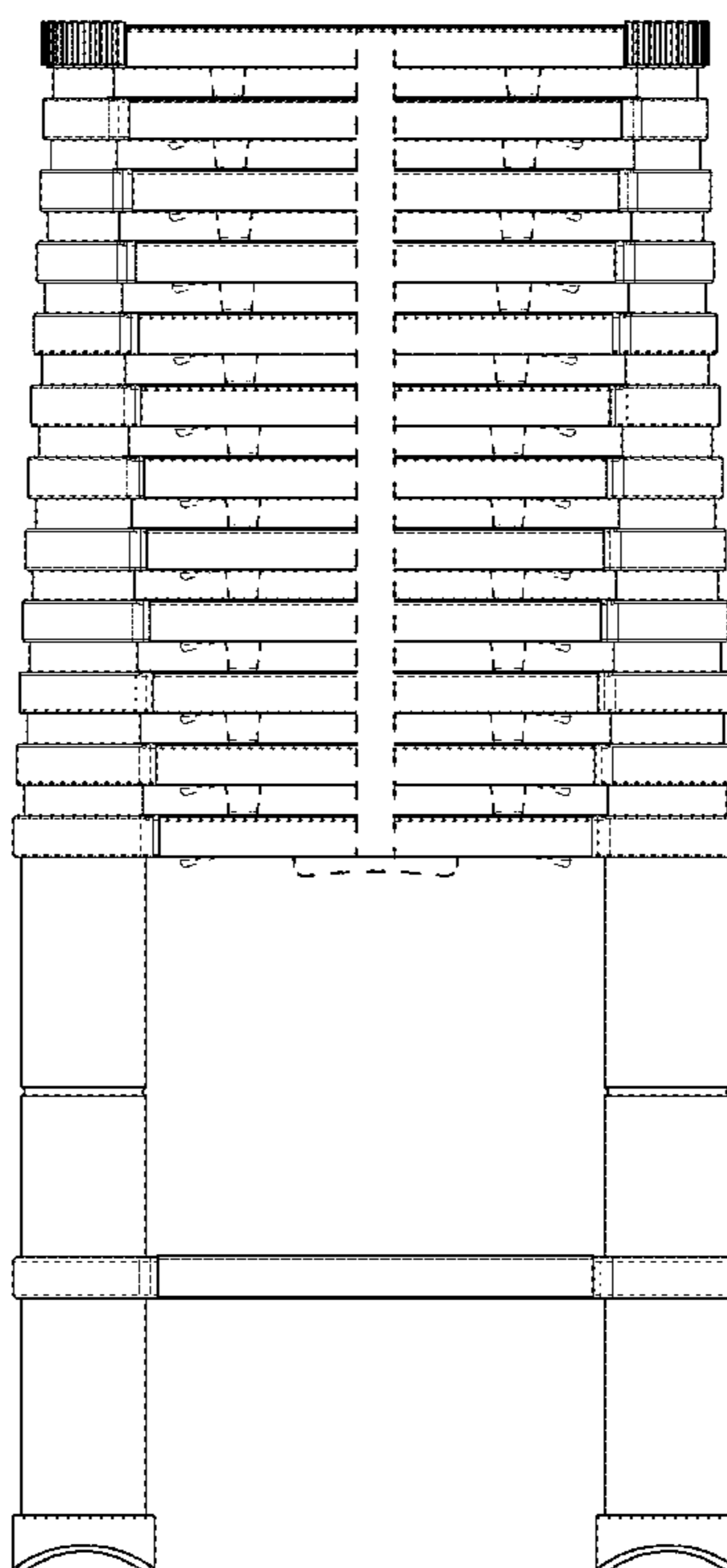
The ornamental design for an adjustable ladder, as shown and described.

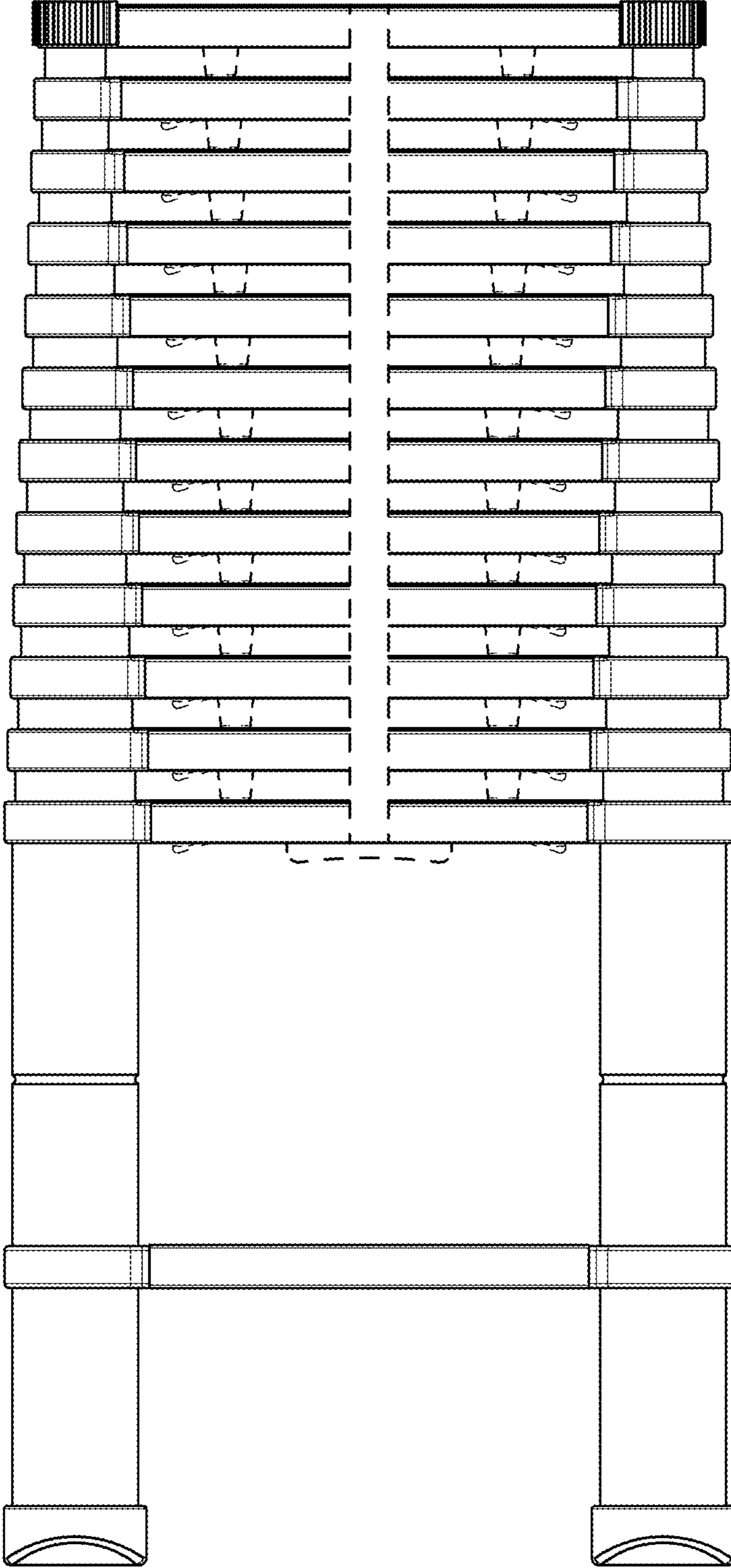

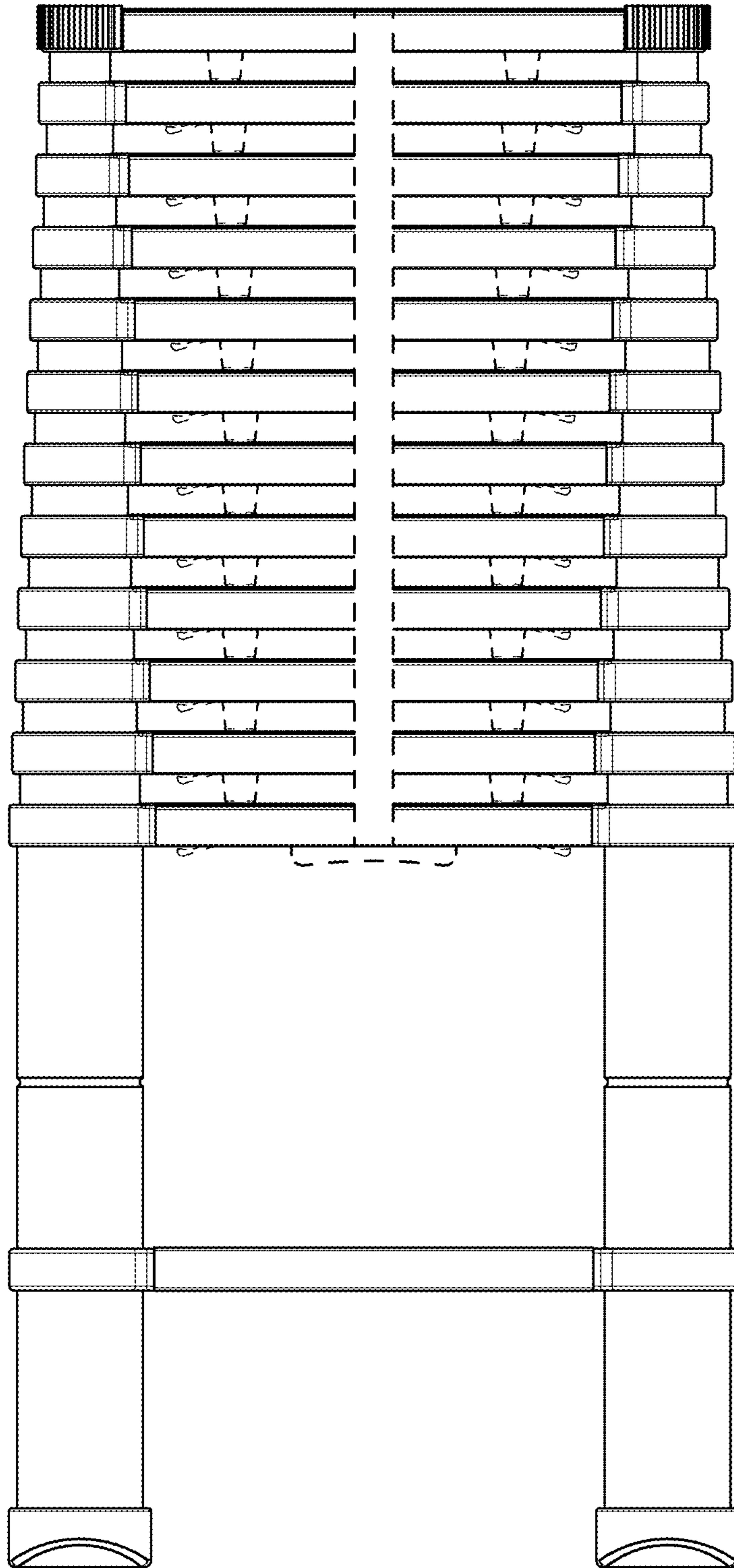

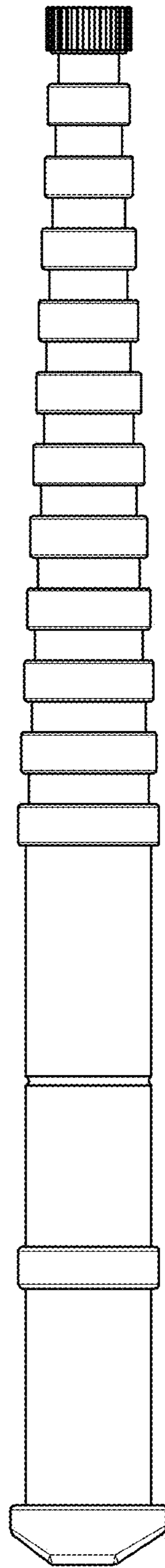

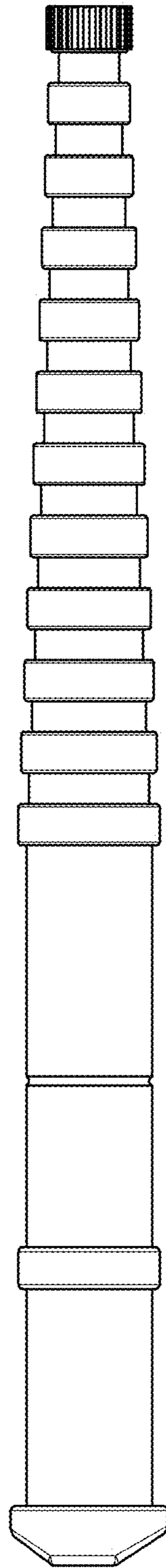

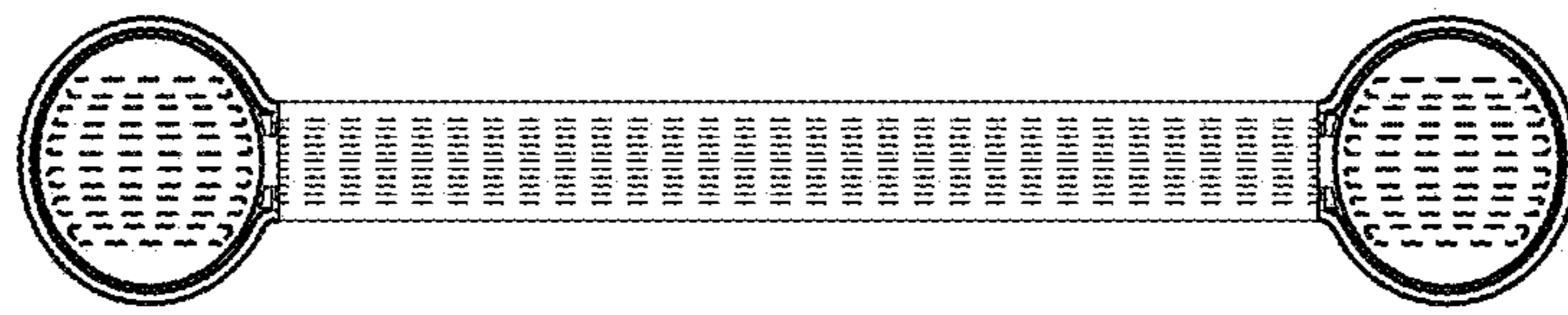

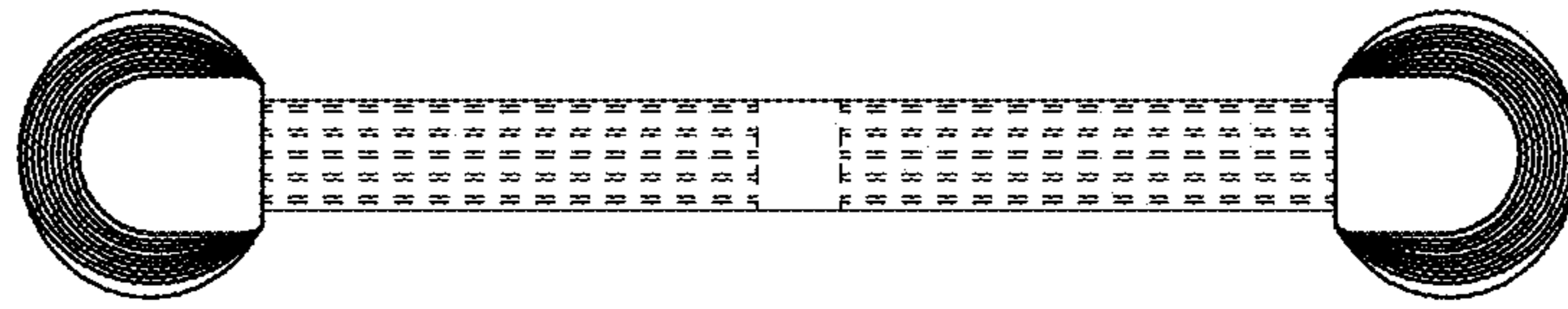

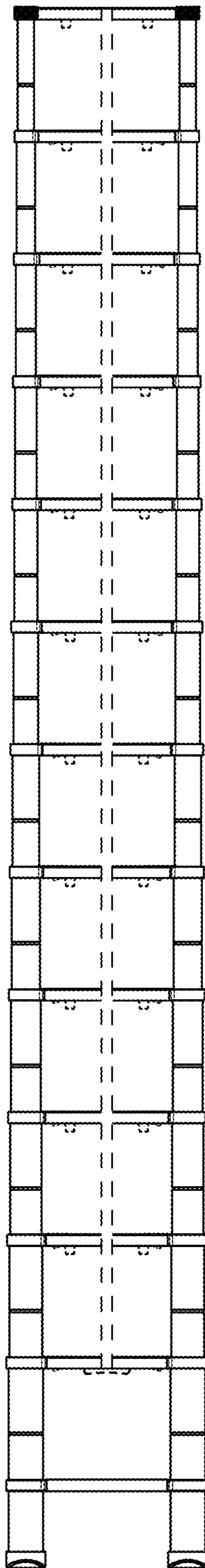

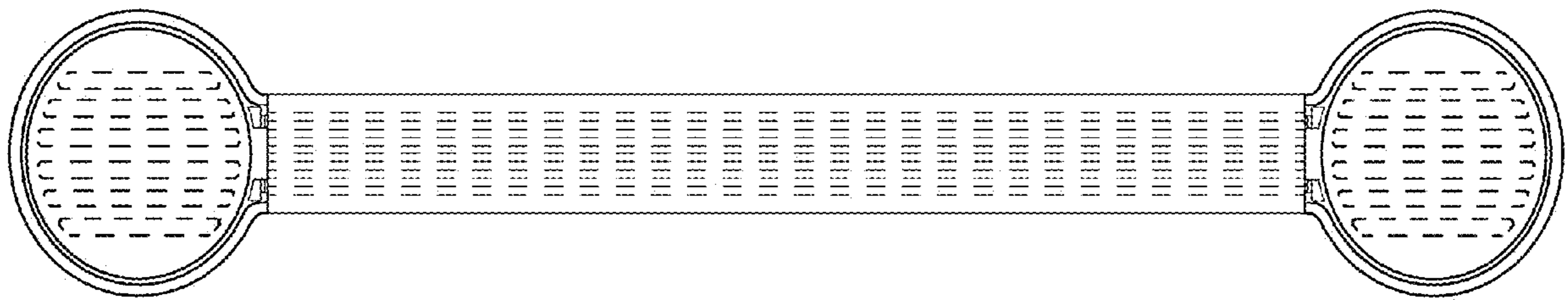

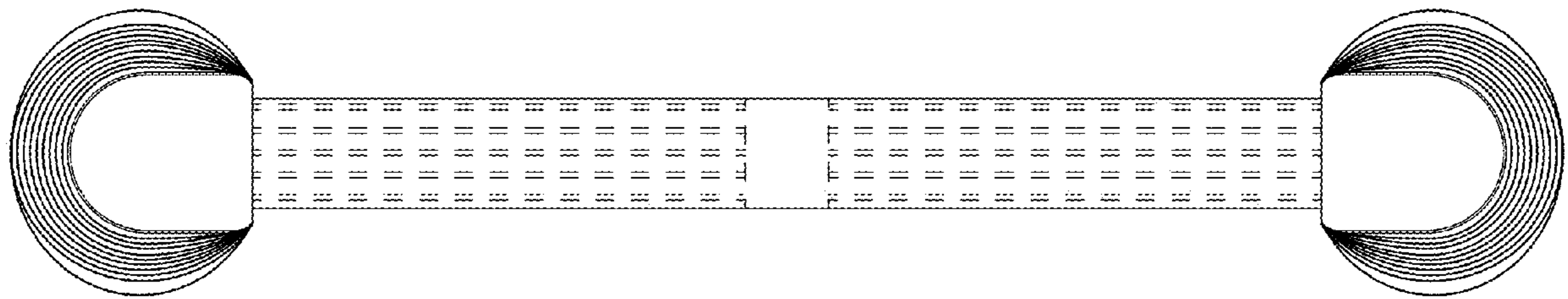
