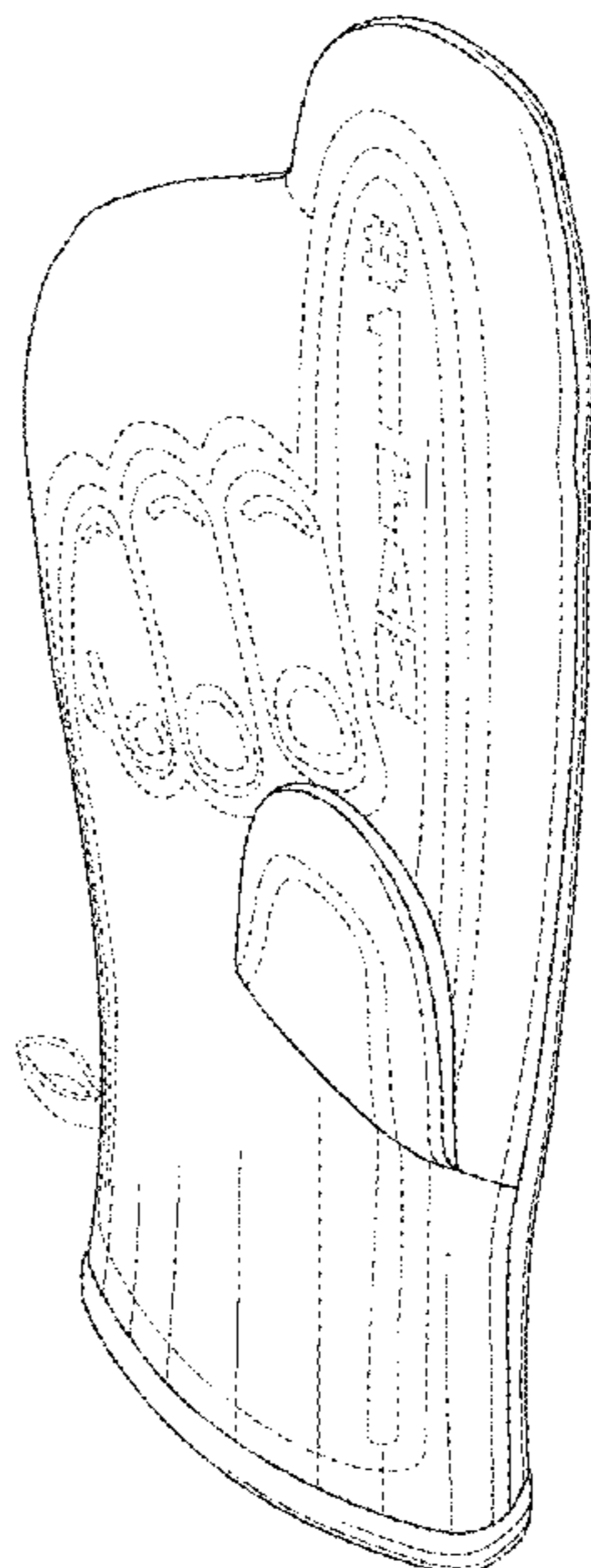
(57) **CLAIM**

The ornamental design for an oven mitt, as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of an embodiment of an oven mitt of the instant design;
FIG. 2 is a front elevation view of the oven mitt of FIG. 1.
FIG. 3 is a rear elevation view of the oven mitt of FIG. 1.
FIG. 4 is a left side elevation view of the oven mitt of FIG. 1.
FIG. 5 is a right side elevation view of the oven mitt of FIG. 1.
FIG. 6 is a top plan view of the oven mitt of FIG. 1; and,
FIG. 7 is a bottom plan view of the oven mitt of FIG. 1.
The broken lines in the drawings show portions of the oven mitt and form no part of the claimed design.

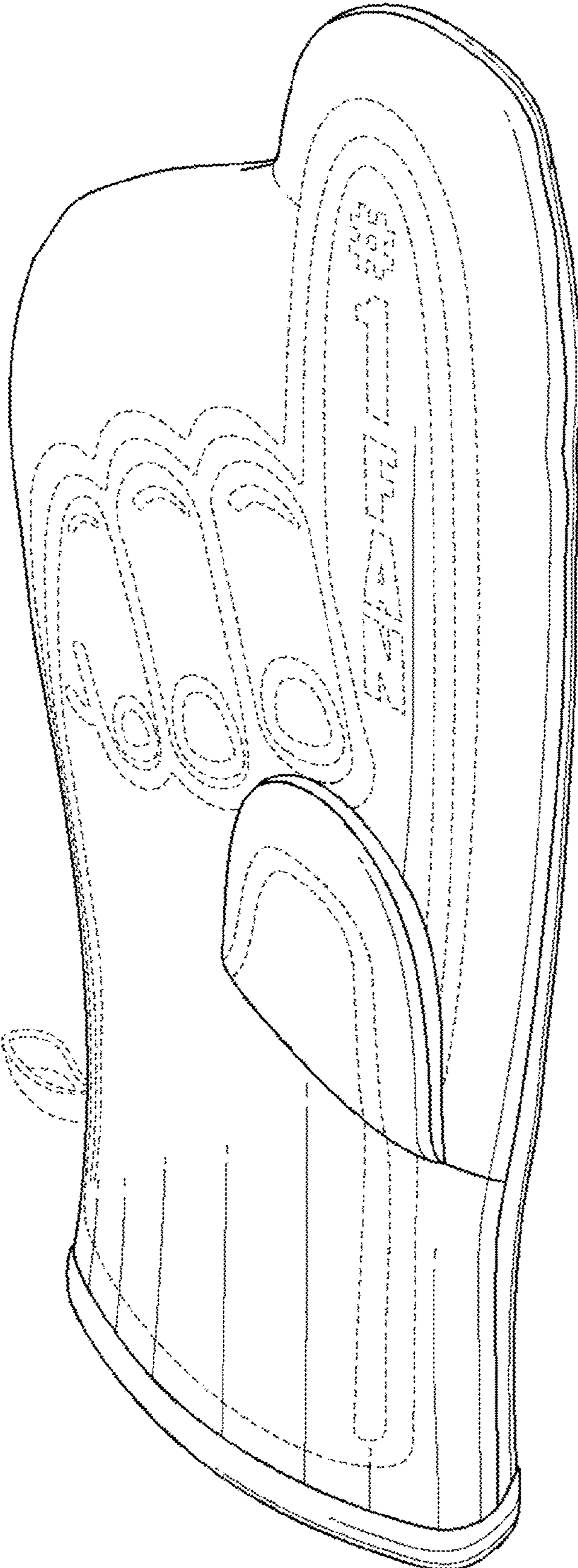

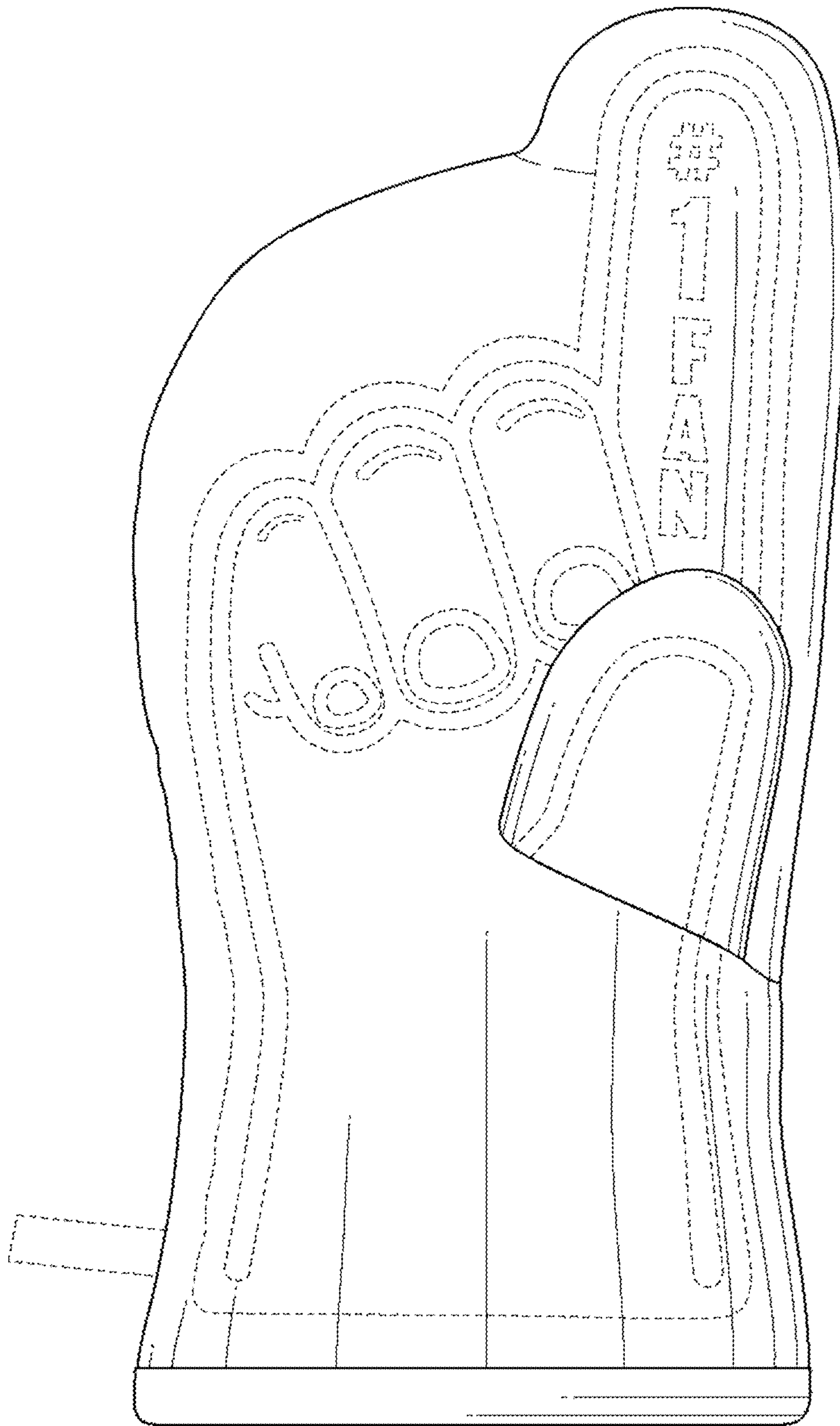

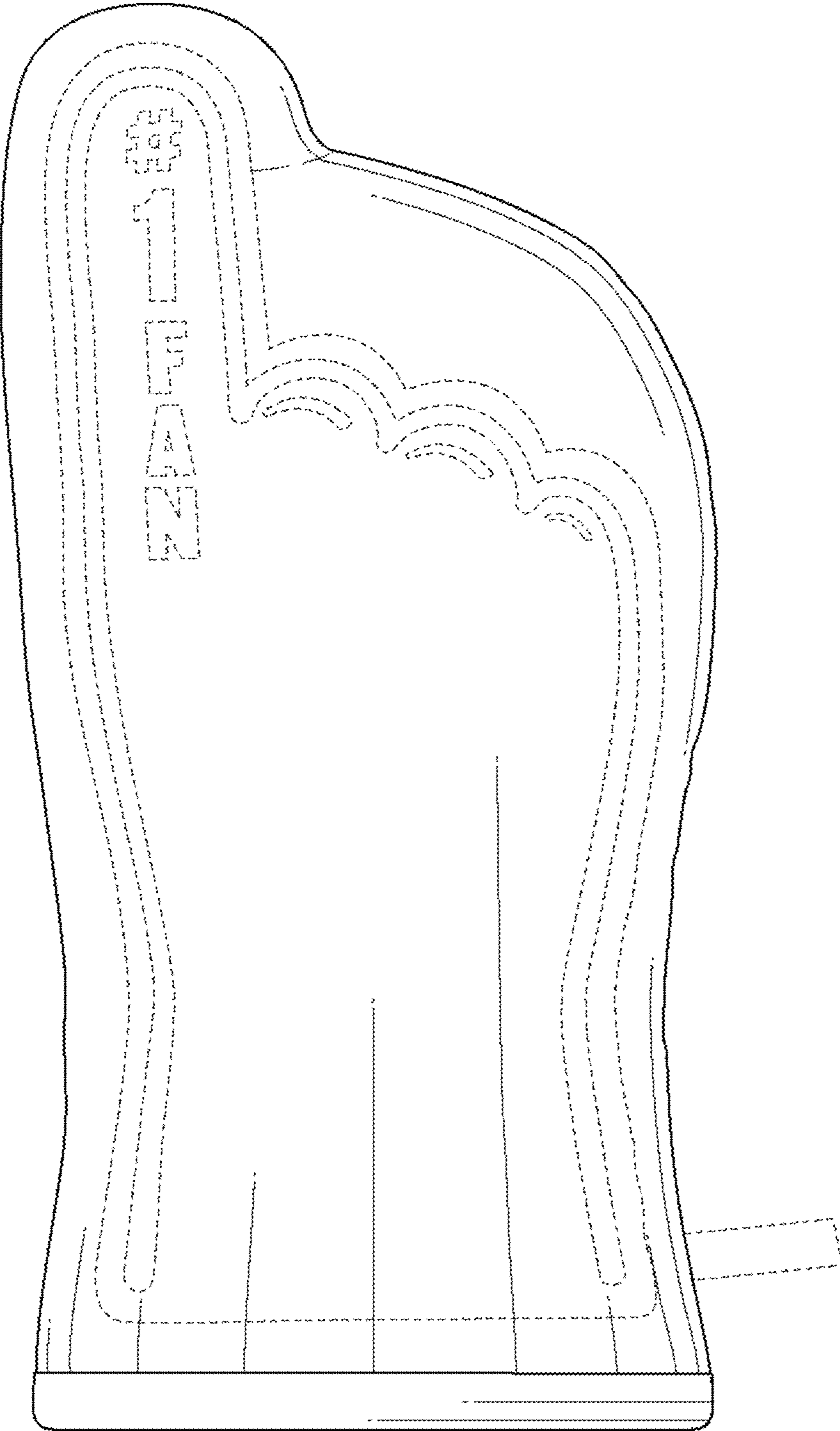

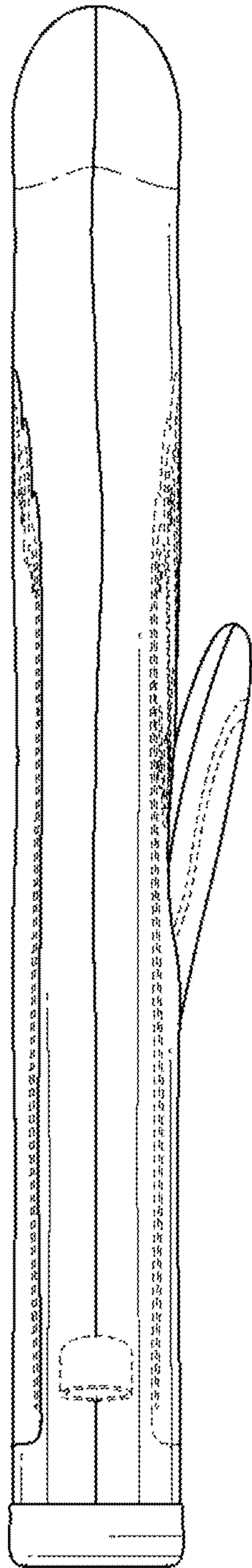

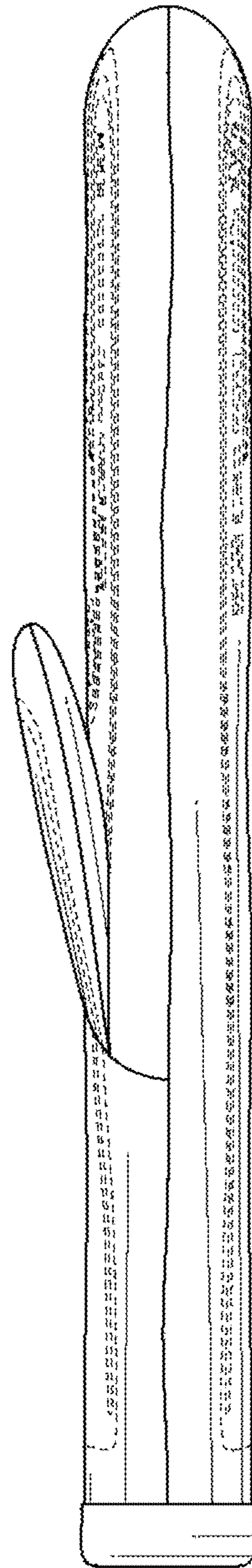

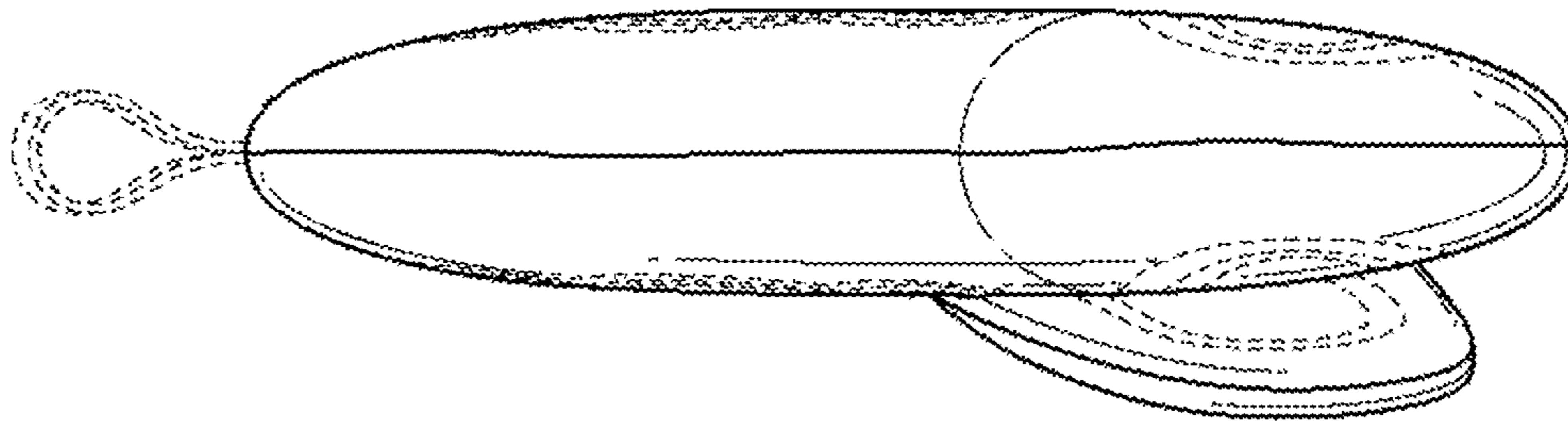

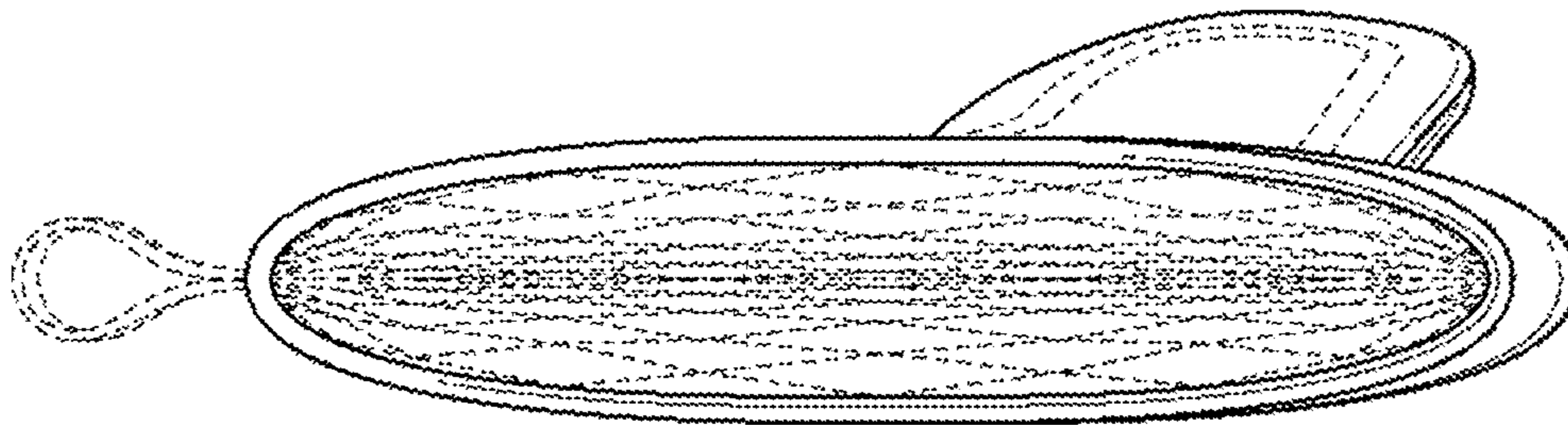
