The ornamental design for a shirt, as shown and described.

DESCRIPTION

FIG. 1 is a left-side front perspective view of a shirt showing my new design;

FIG. 2 is a left side view thereof;

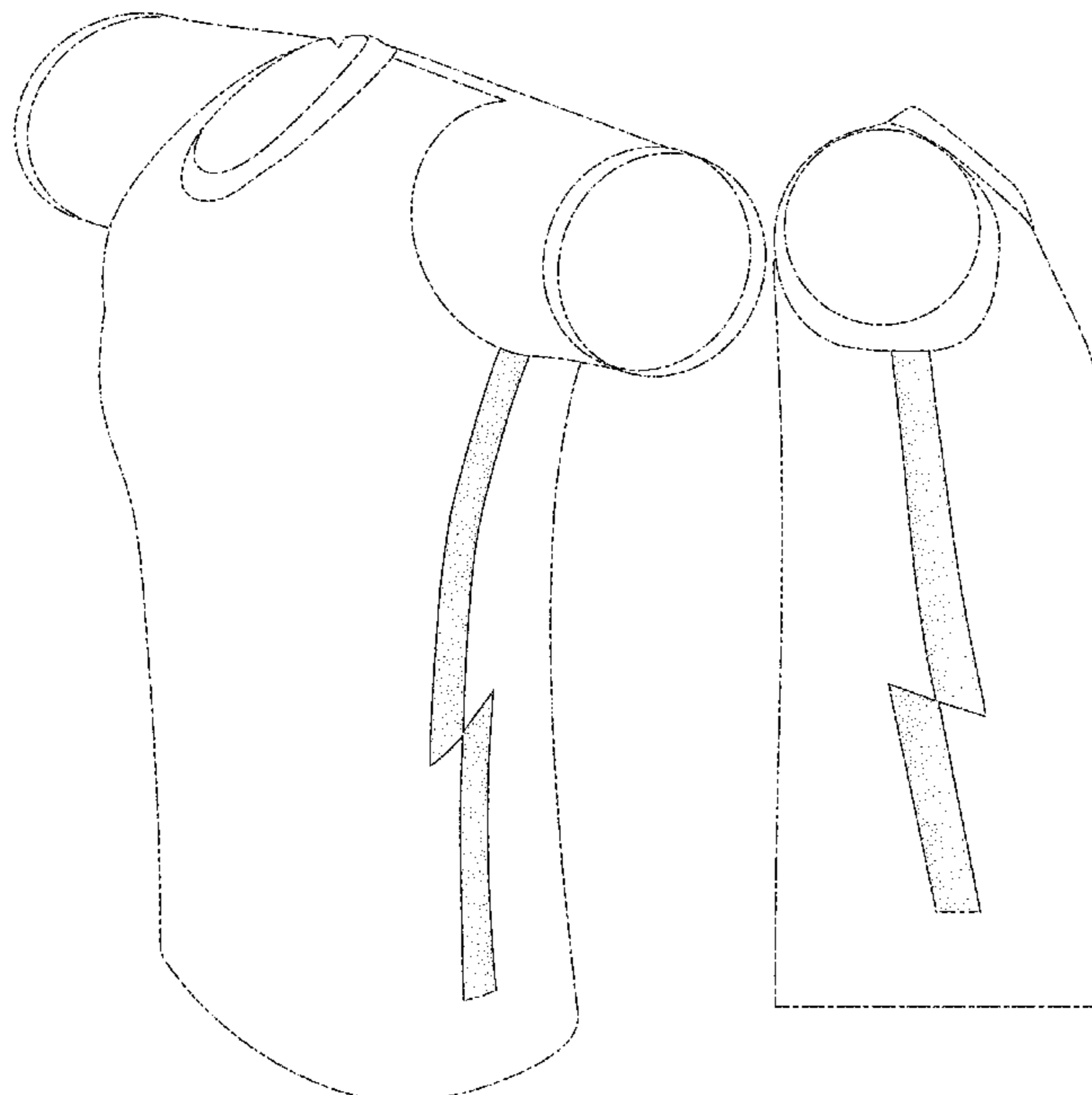
FIG. 3 is a right side view thereof;

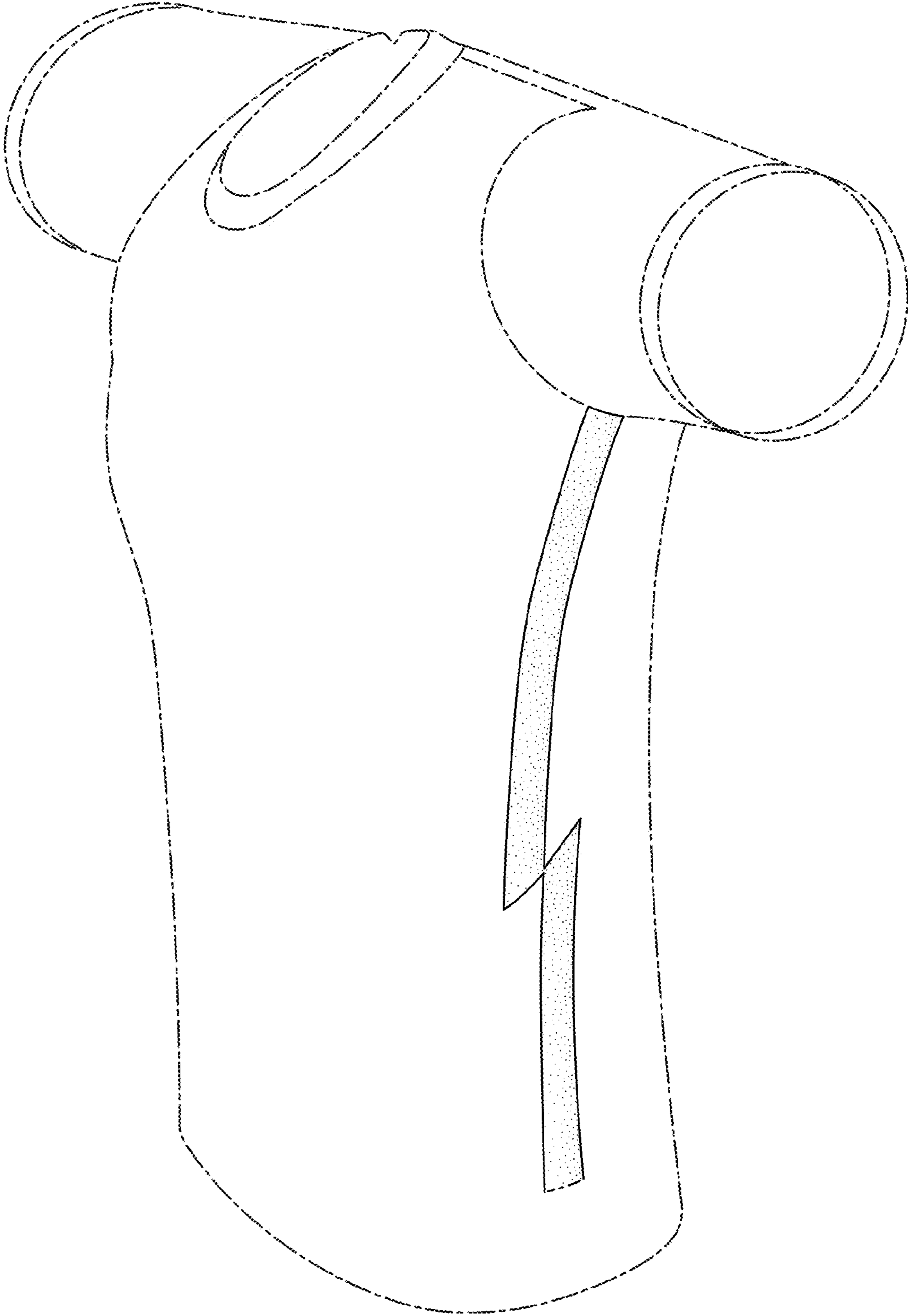

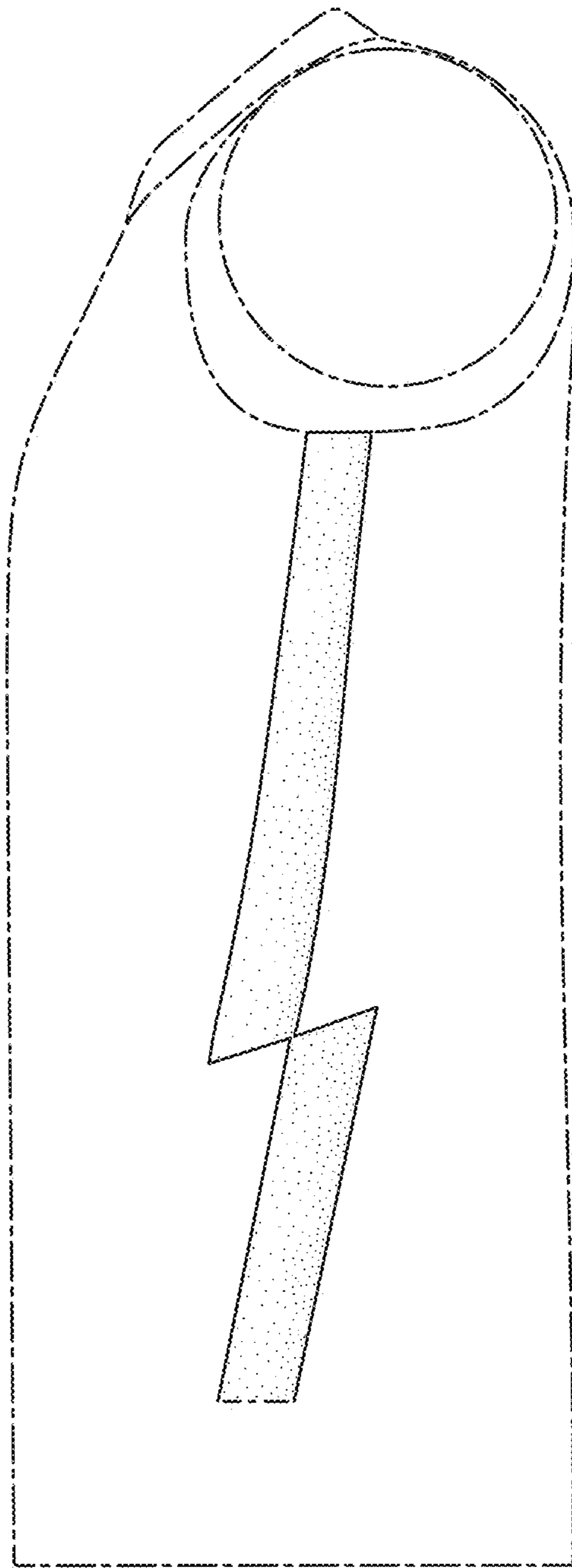

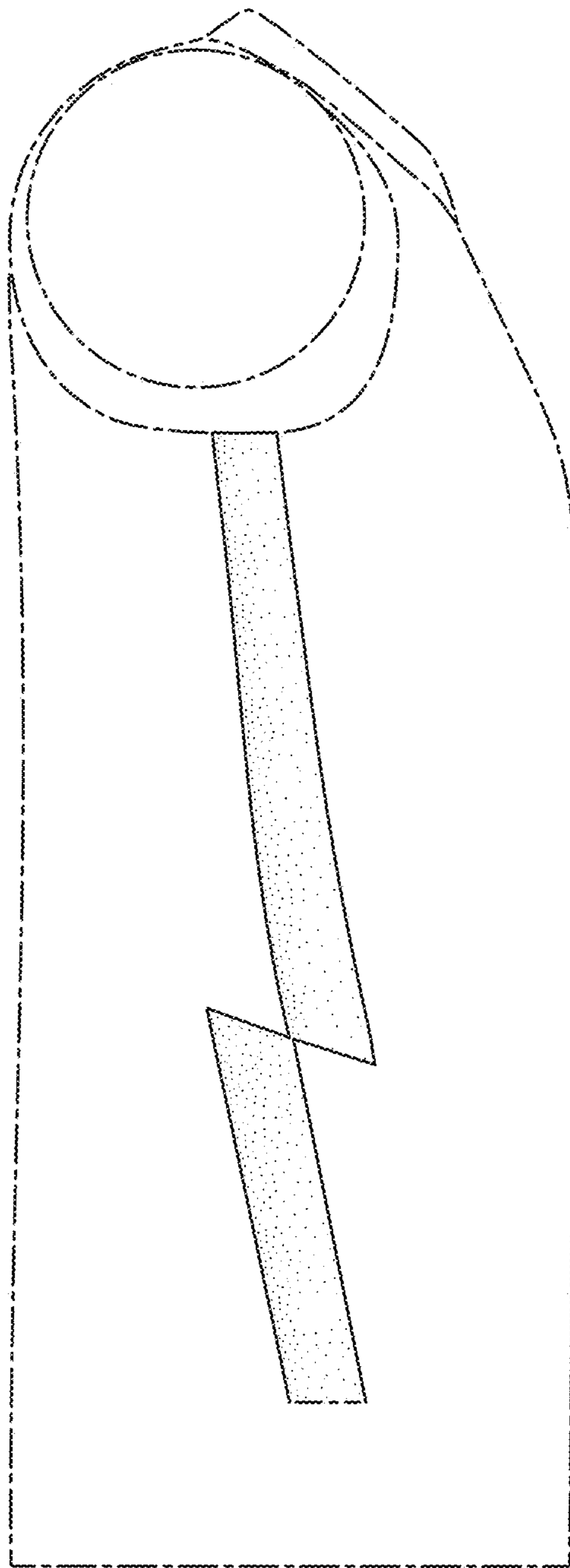

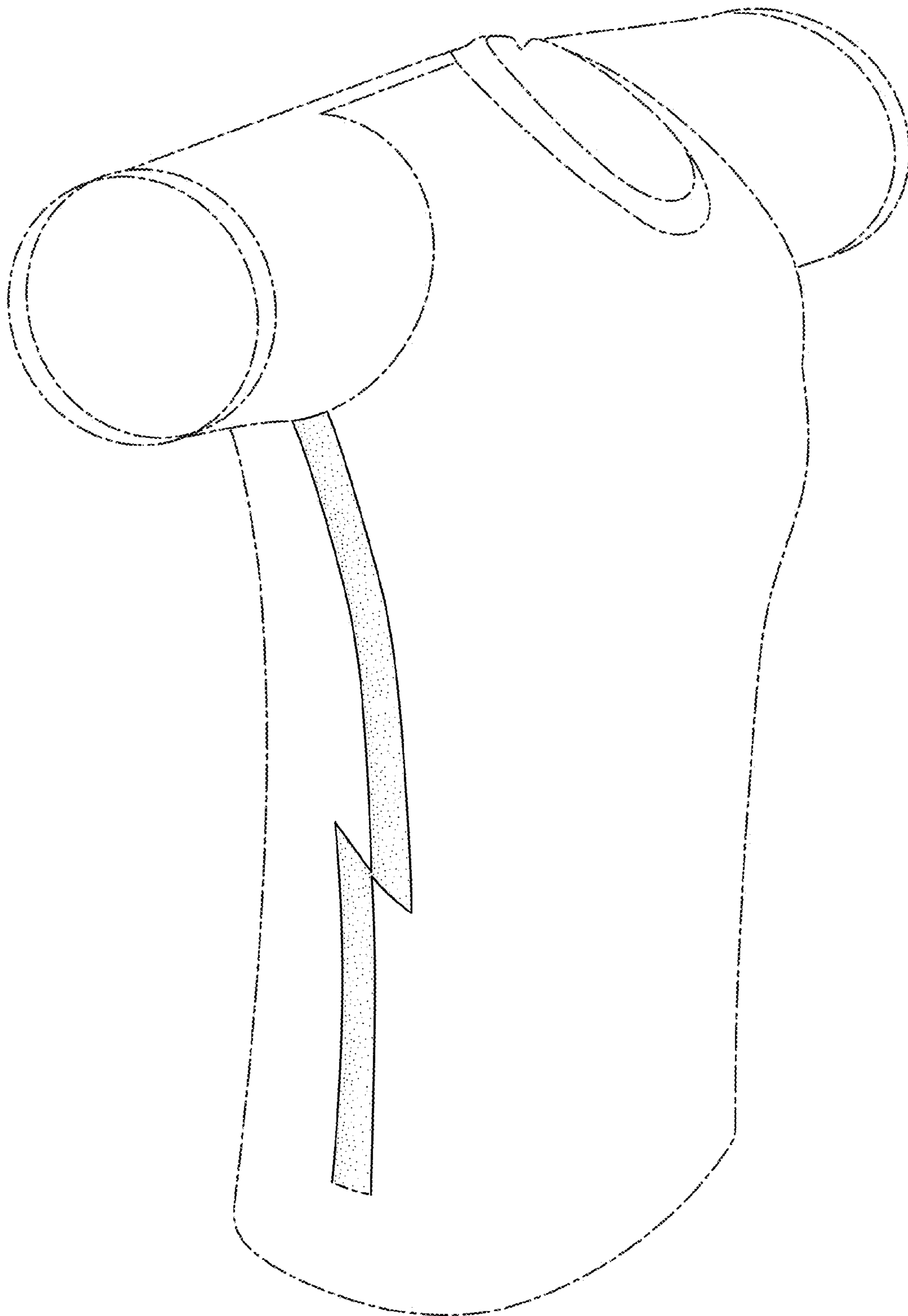

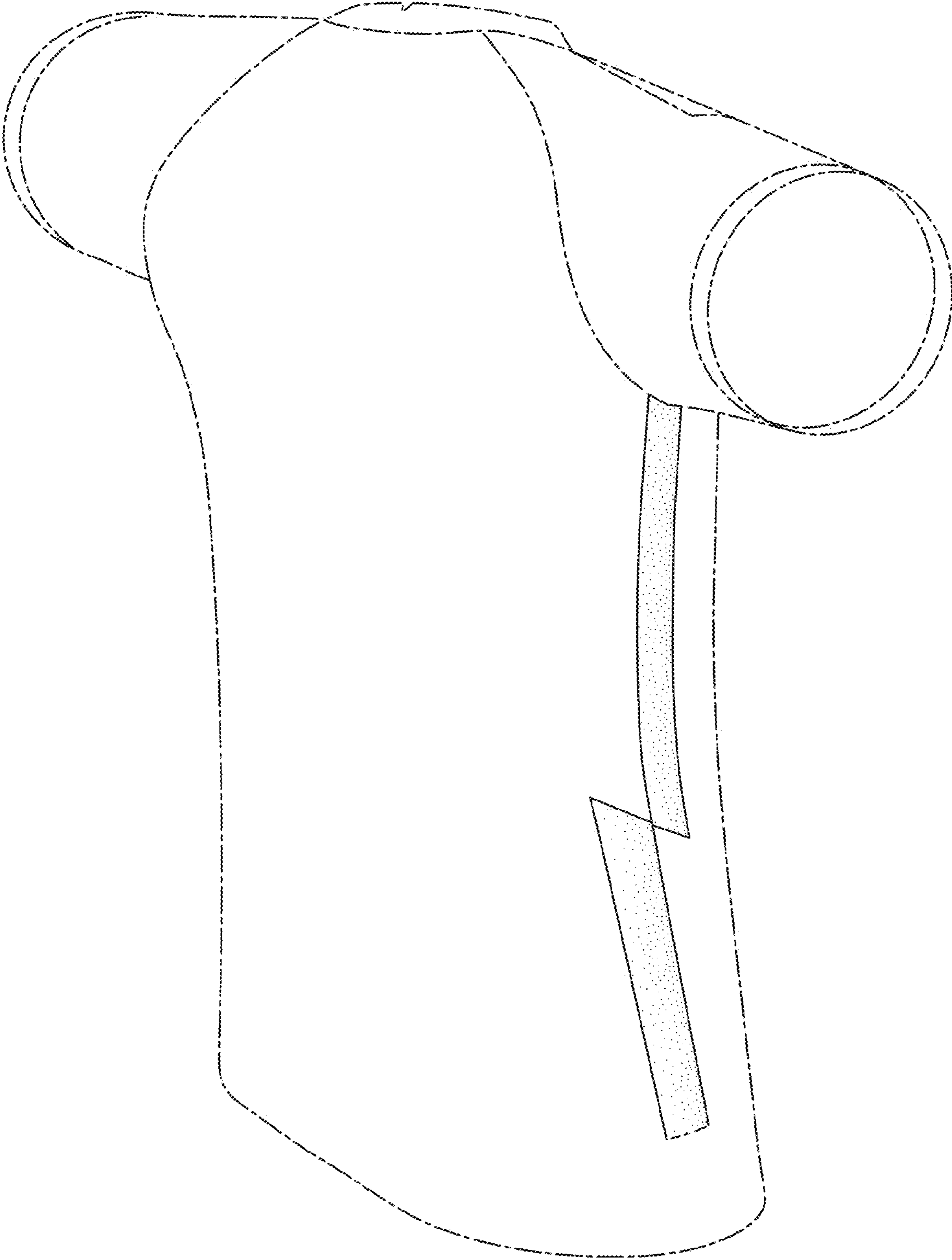
