(57) **CLAIM**

I claim the ornamental design for a reversible sleeved garment, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a reversible sleeved garment of the present invention.

FIG. 2 is a front view of the reversible sleeved garment illustrated in FIG. 1.

FIG. 3 is a rear perspective view of the reversible sleeved garment illustrated in FIG. 1; and,

FIG. 4 is a rear view of the reversible sleeved garment illustrated in FIG. 1.

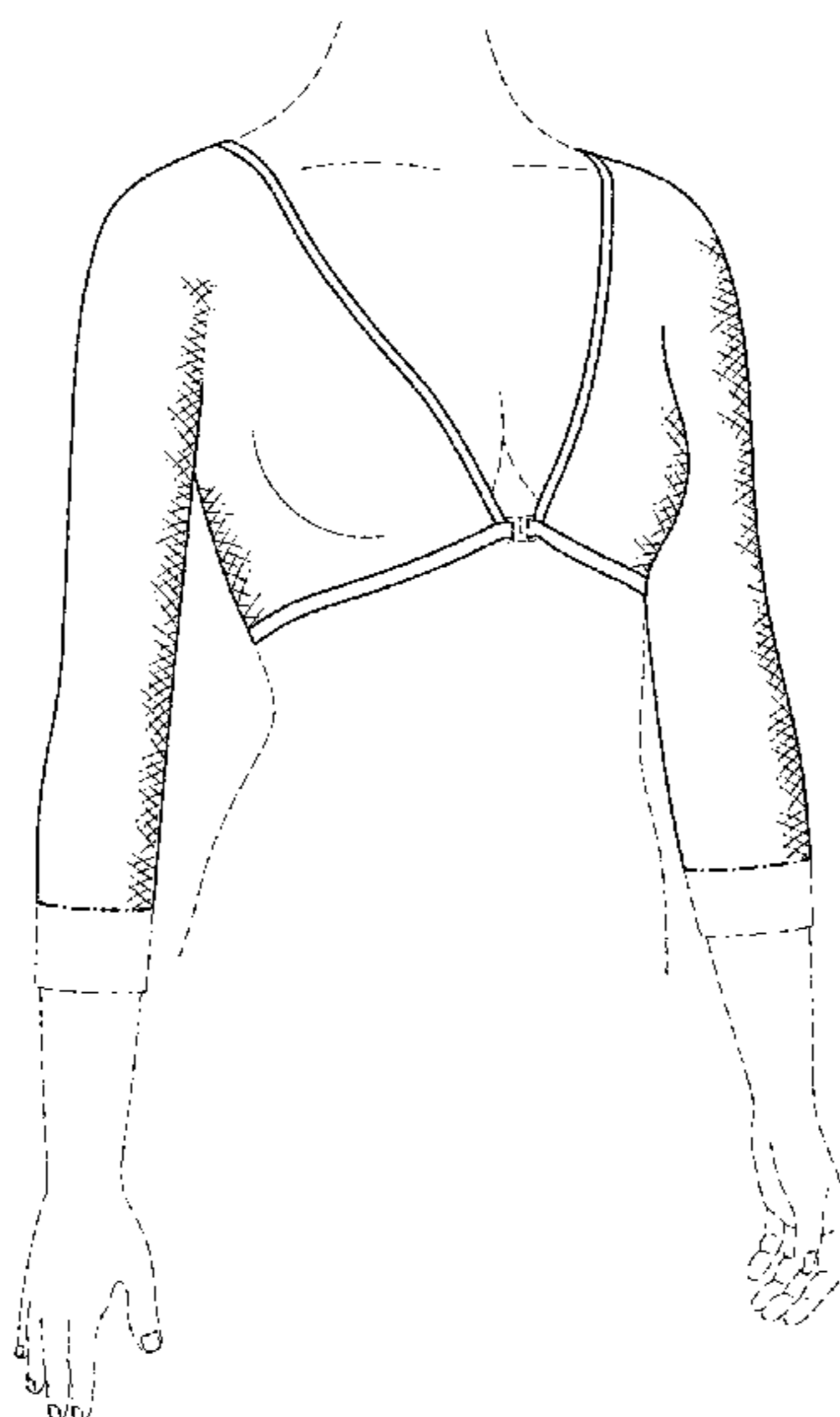
The broken lines illustrating a human figure depict environmental structure that forms no part of the claimed design.

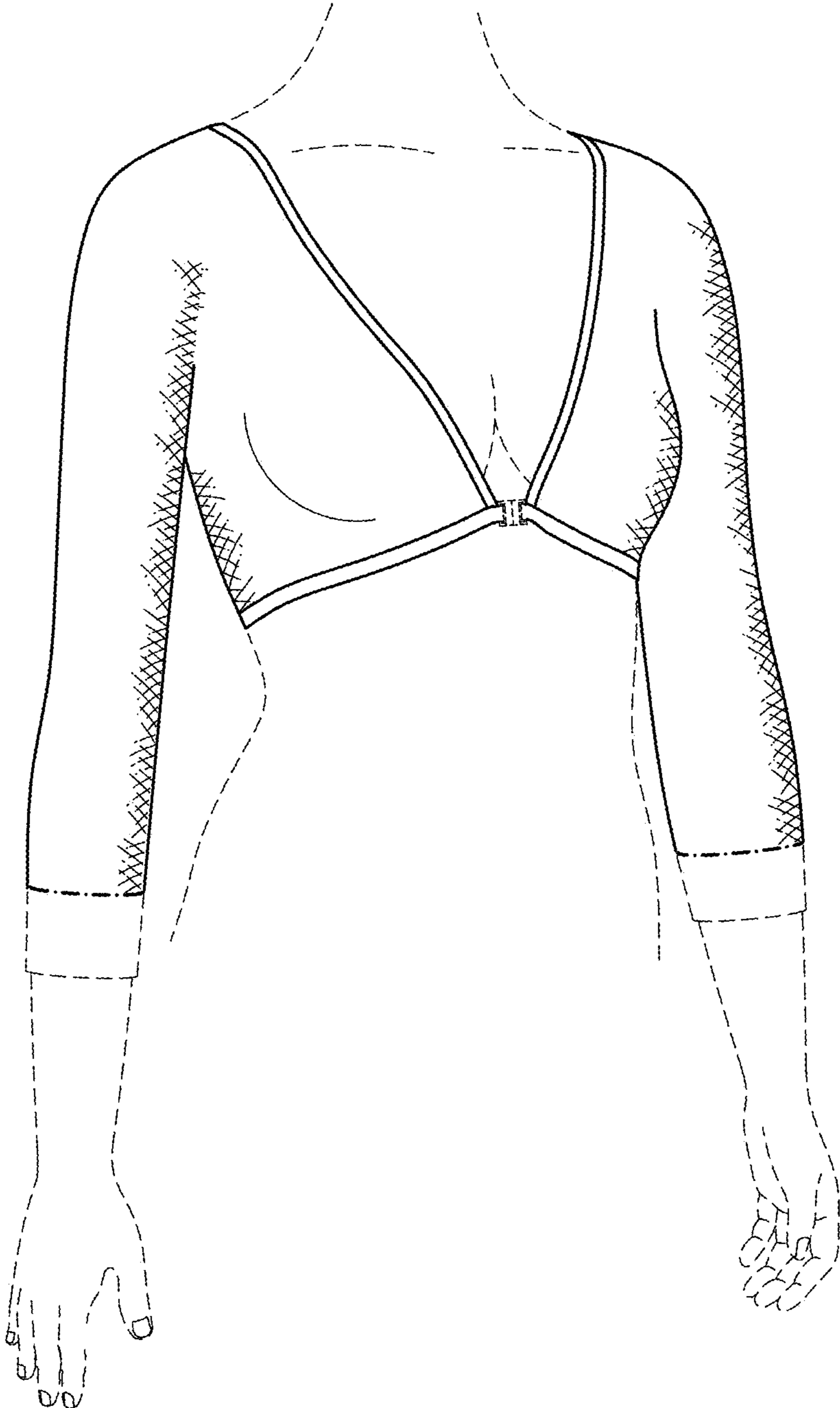

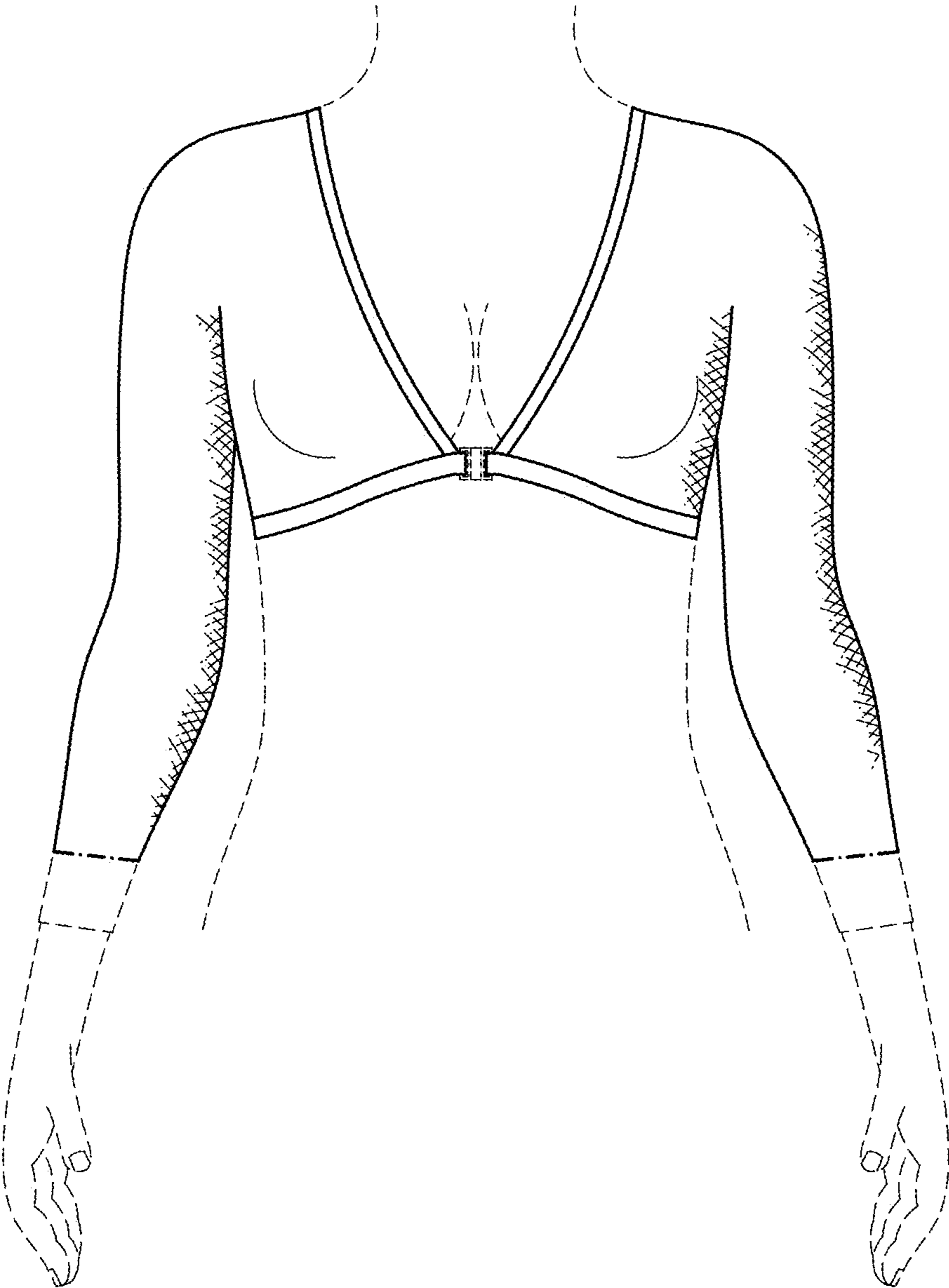

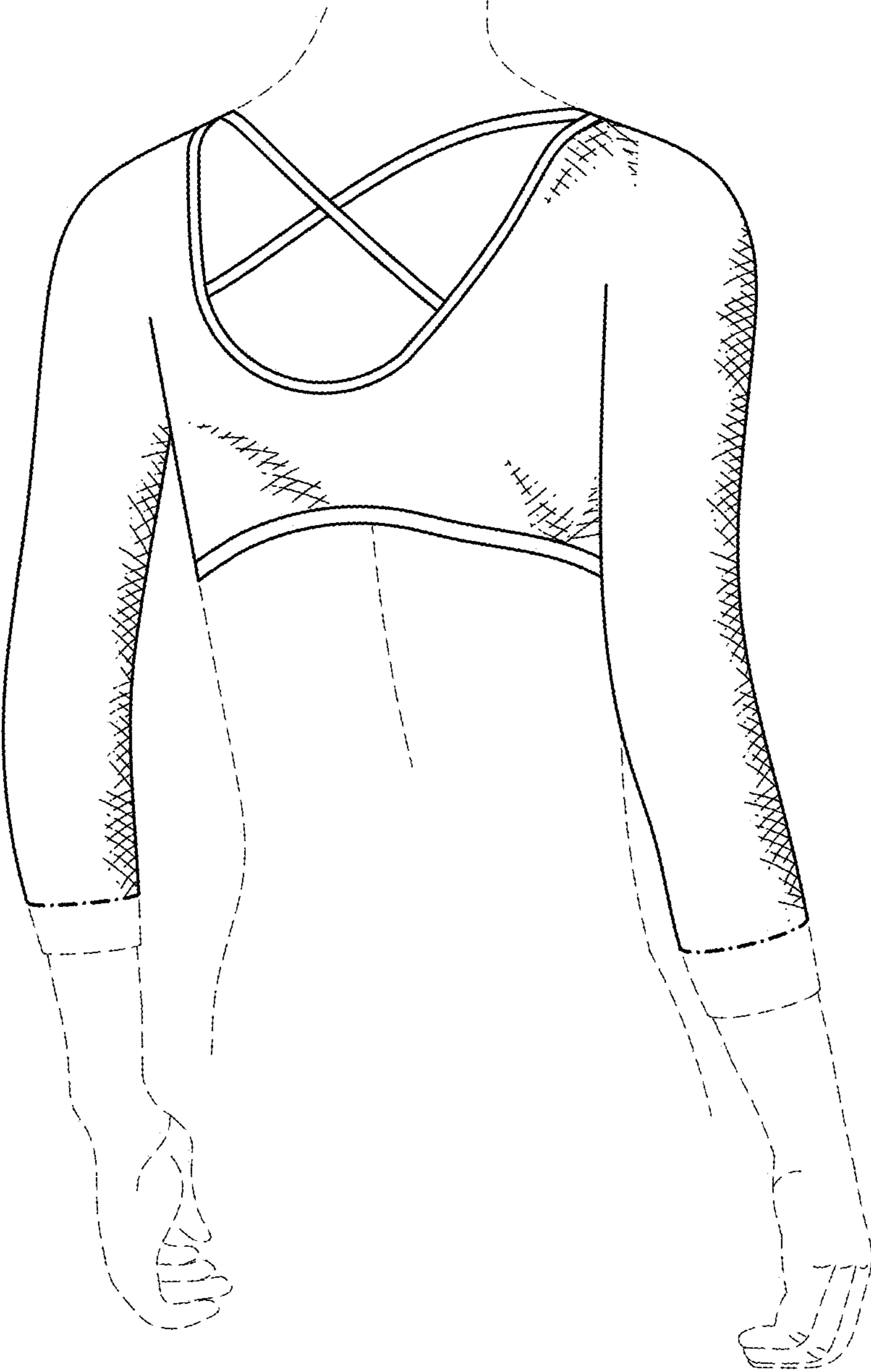
