(57) **CLAIM**

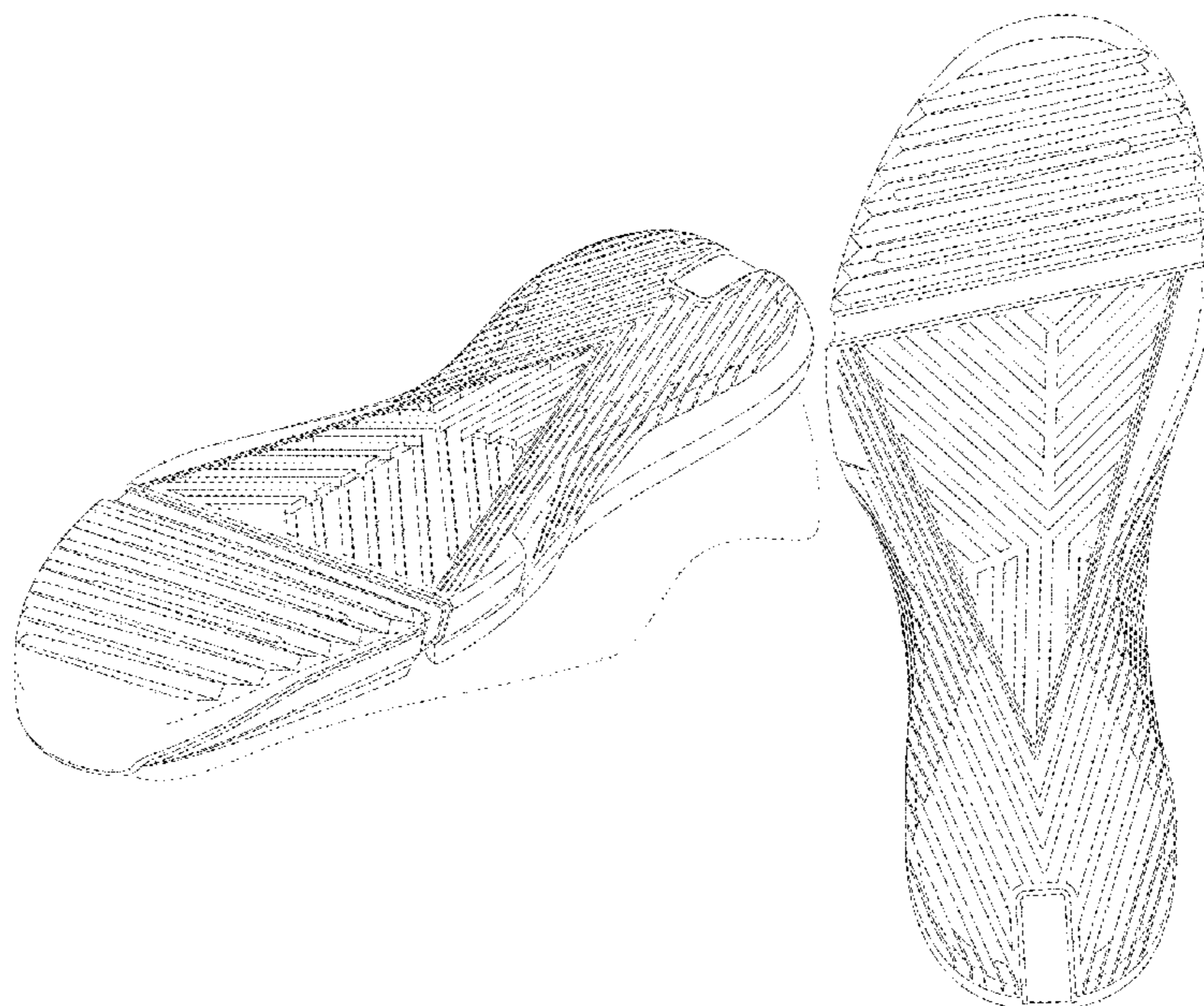
The ornamental design for a sole structure, as shown and described.

DESCRIPTION

FIG. 1 is a lateral side and front view in perspective of a sole structure showing my new design;
 FIG. 2 is a lateral side view of the sole structure of FIG. 1;
 FIG. 3 is a medial side view of the sole structure of FIG. 1;
 FIG. 4 is a top view of the sole structure of FIG. 1;
 FIG. 5 is a bottom view of the sole structure of FIG. 1;
 FIG. 6 is a front view of the sole structure of FIG. 1; and,
 FIG. 7 is a rear view of the sole structure of FIG. 1.

The sole structure illustrated in the drawings is a first embodiment showing a right-footed form of the sole structure. A second embodiment is for the left-footed form of the sole structure, which is a mirror image of the right-footed form, is not illustrated. The broken line illustration in the figures, showing environmental structure, is not part of the claimed design.

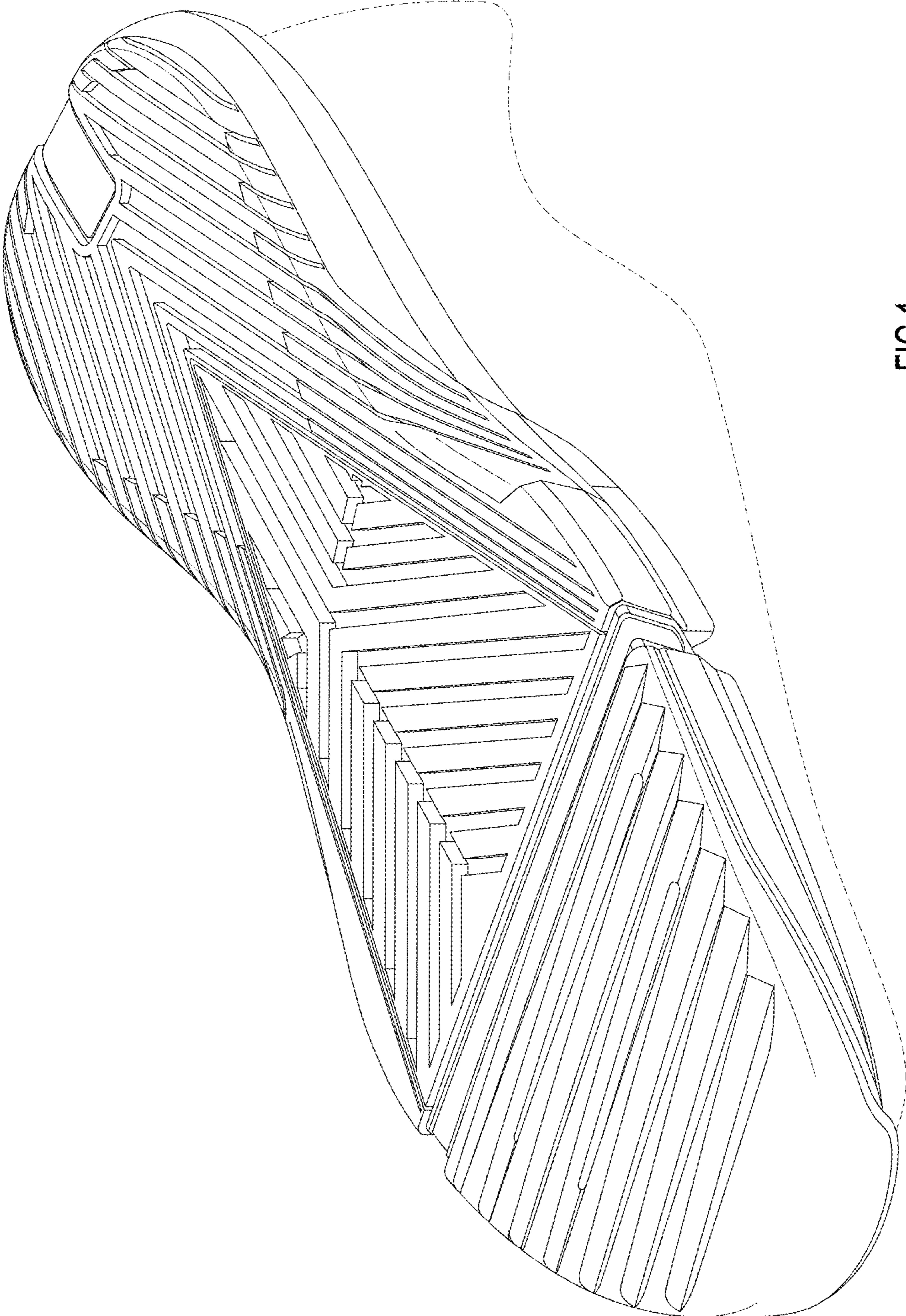

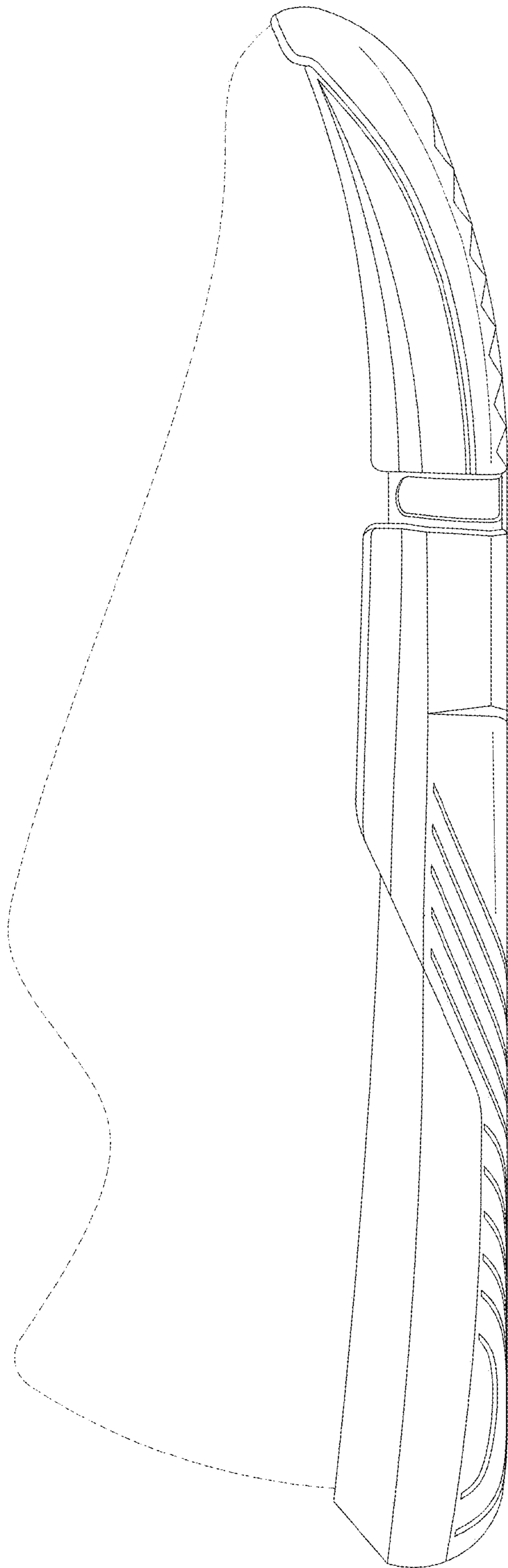

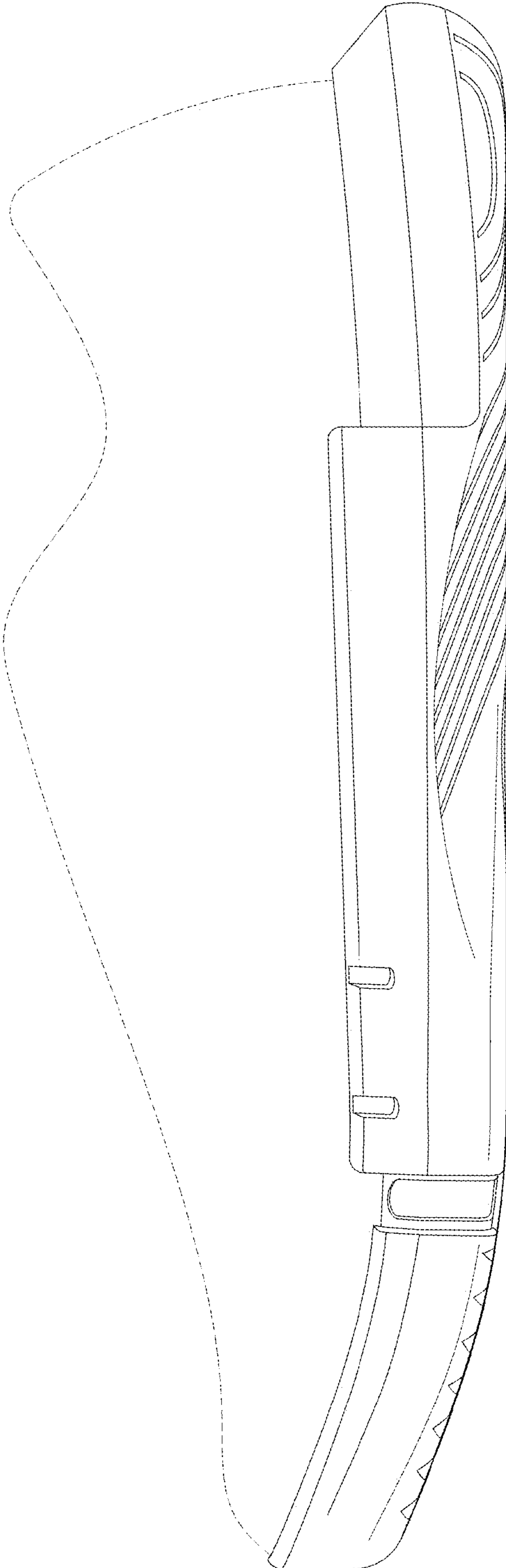

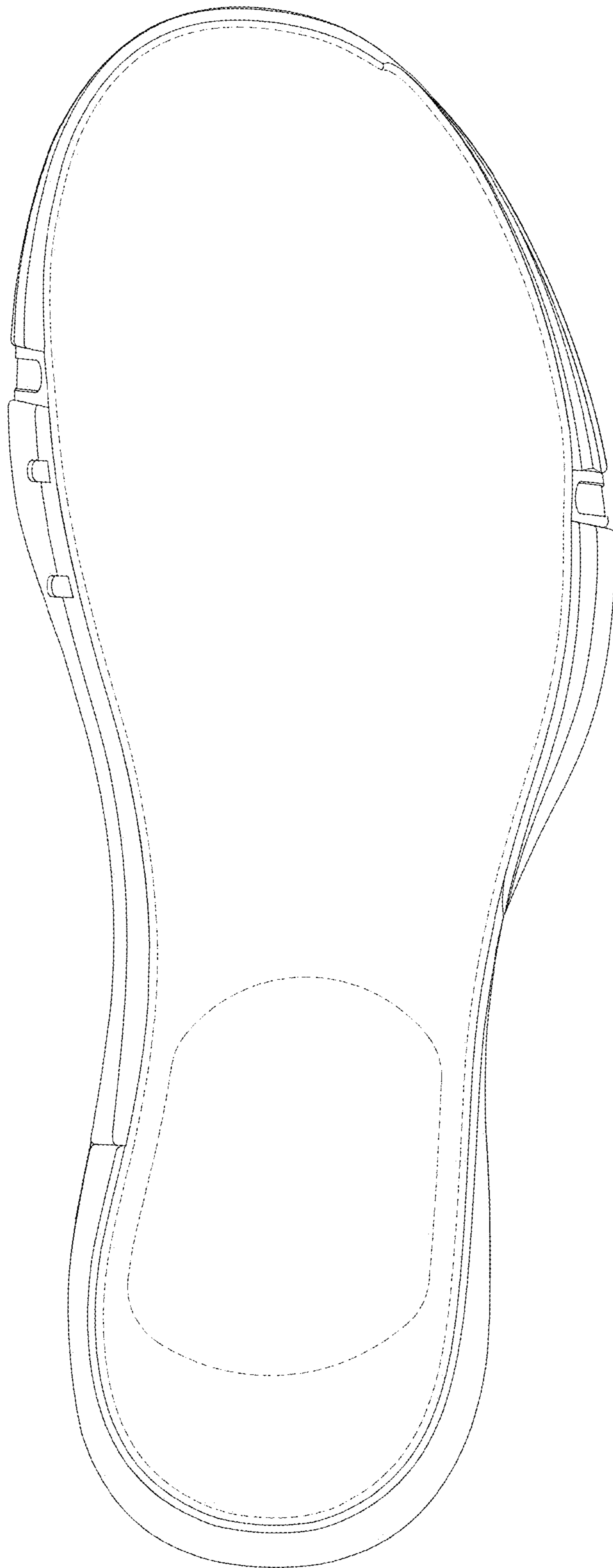

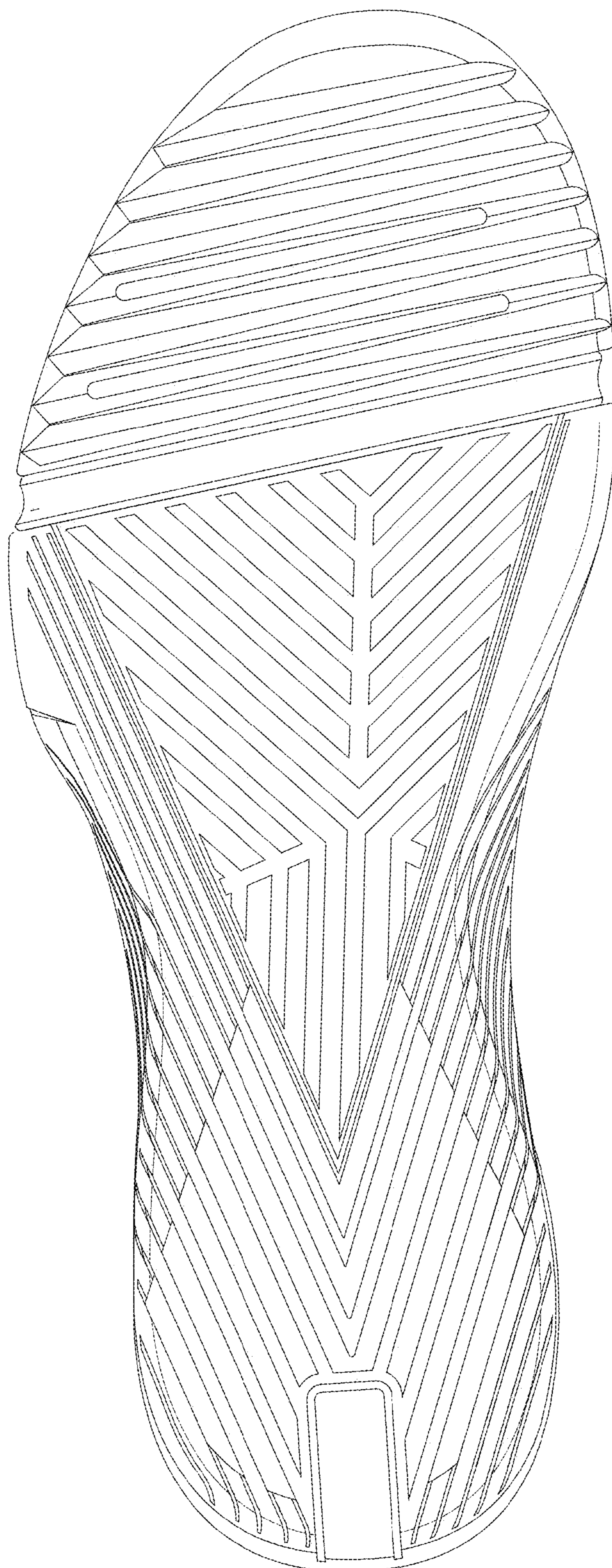

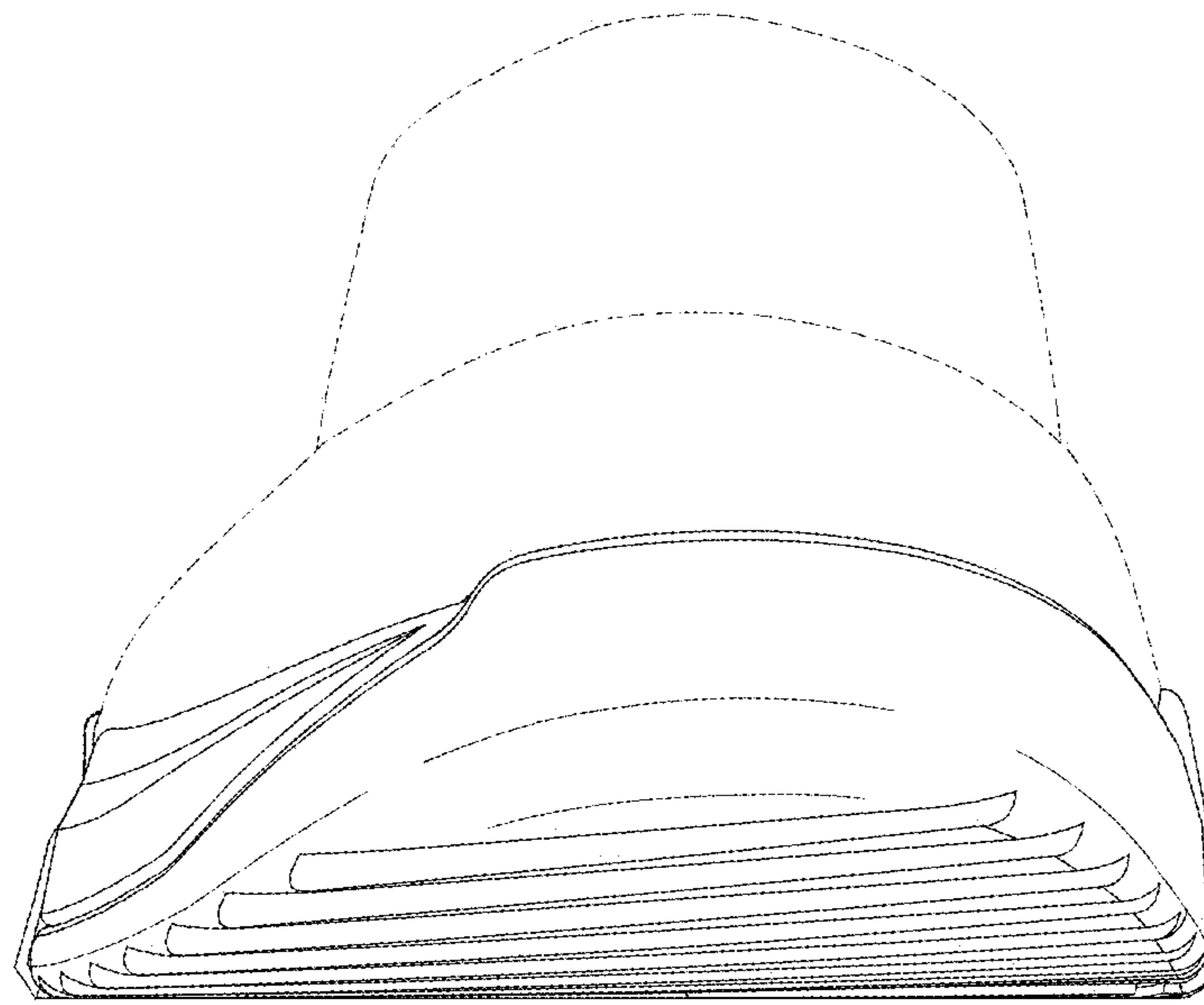

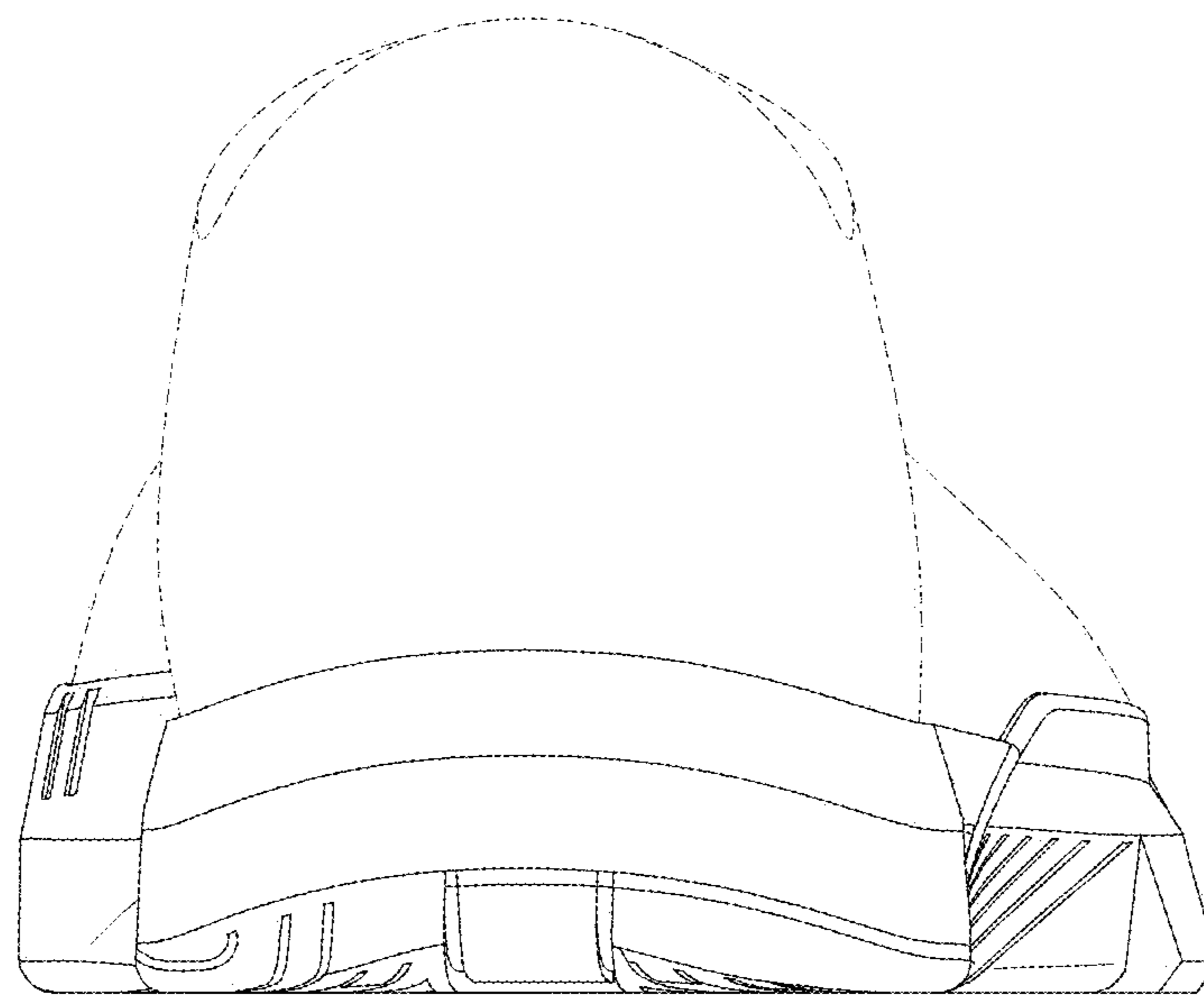
