Portions of the dial shown in broken lines form no part of the claimed design.

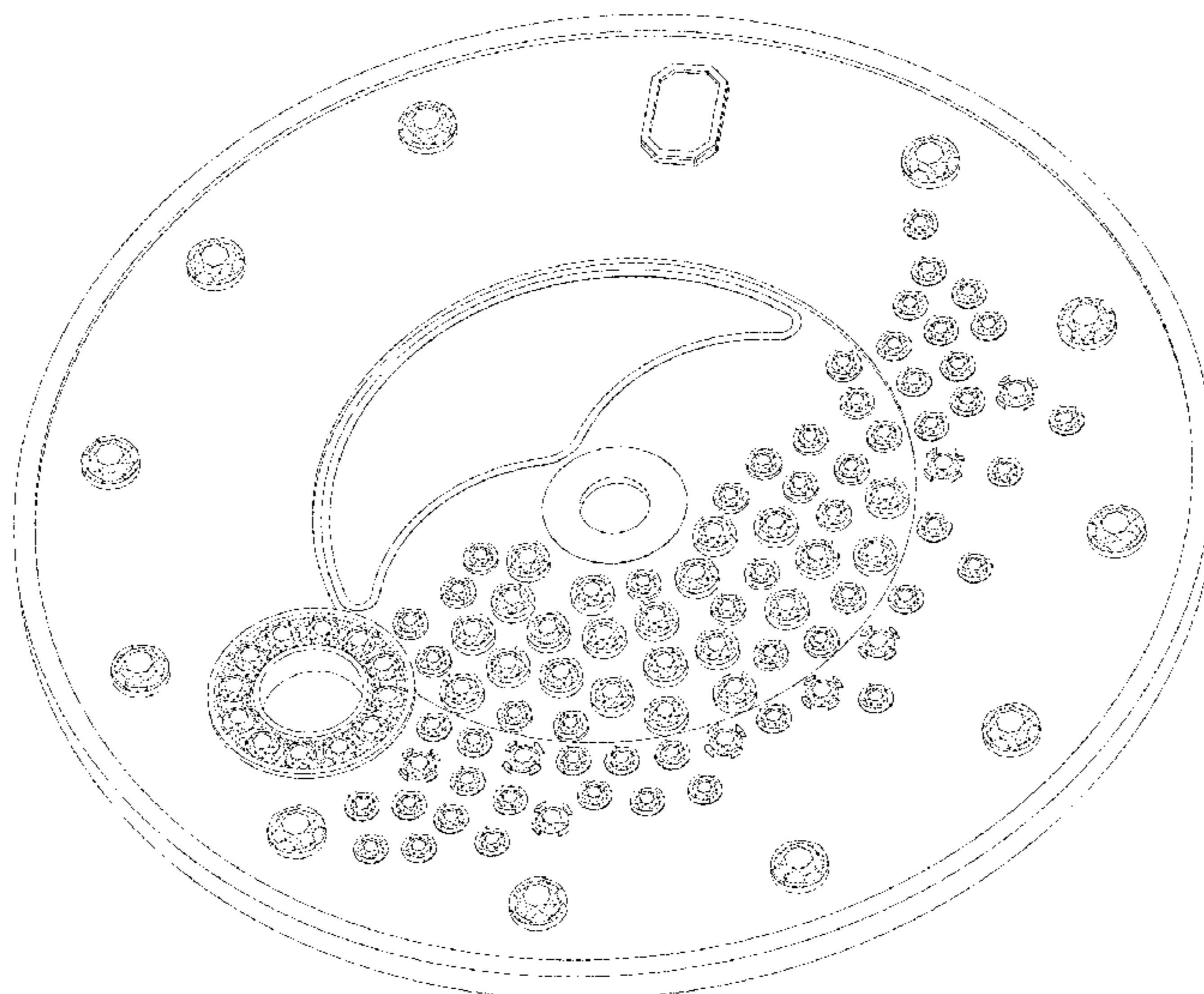

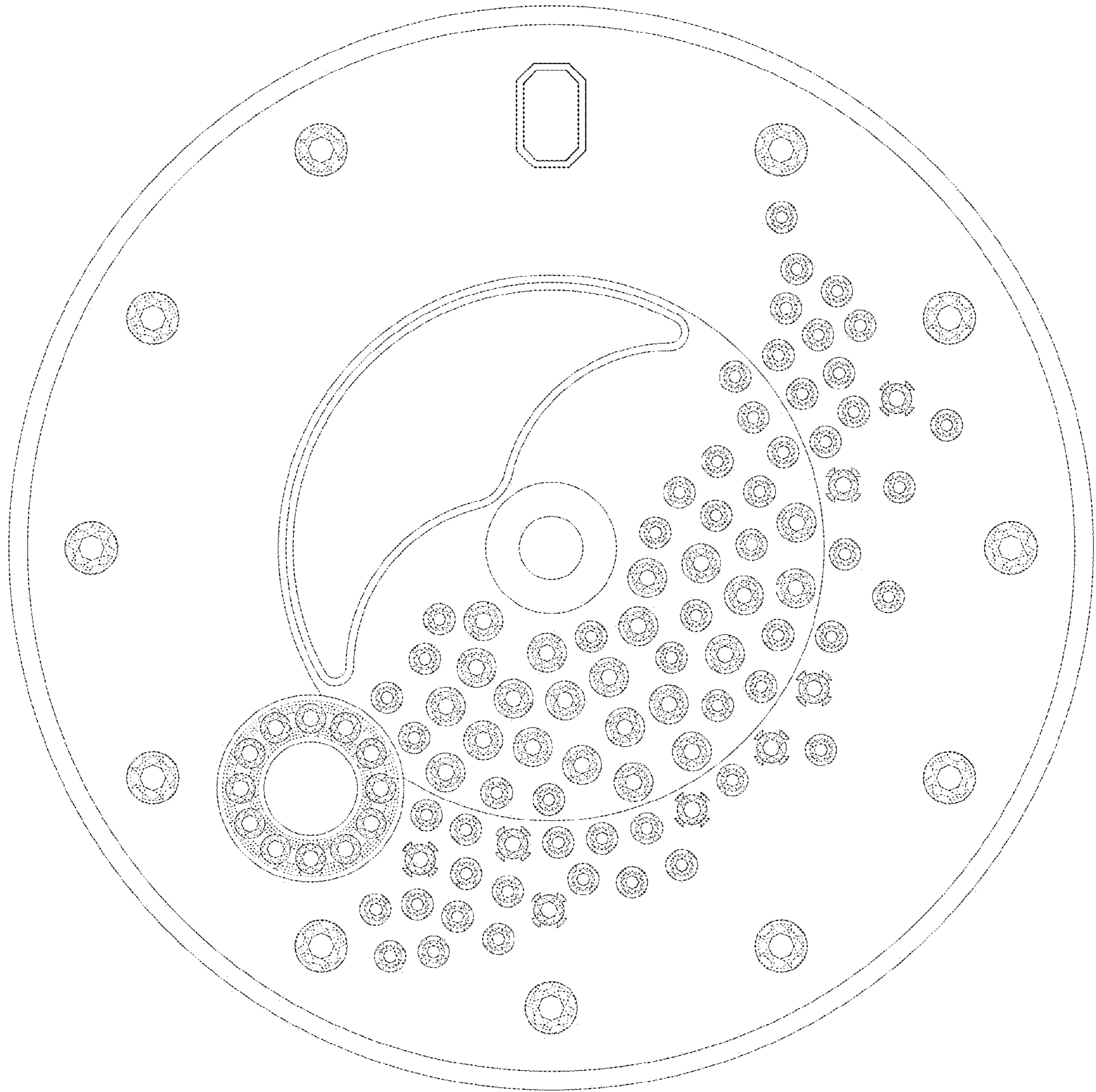

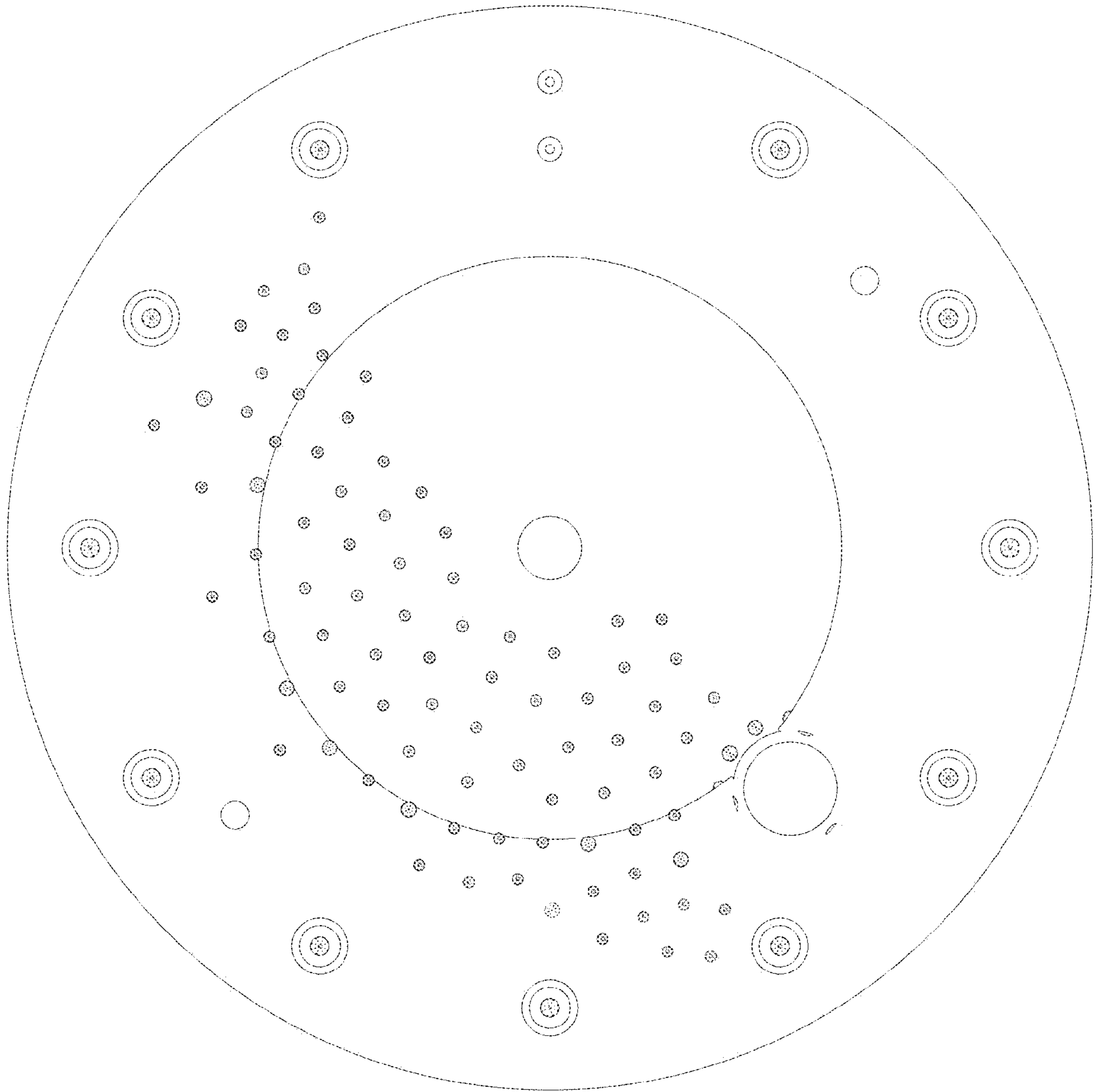

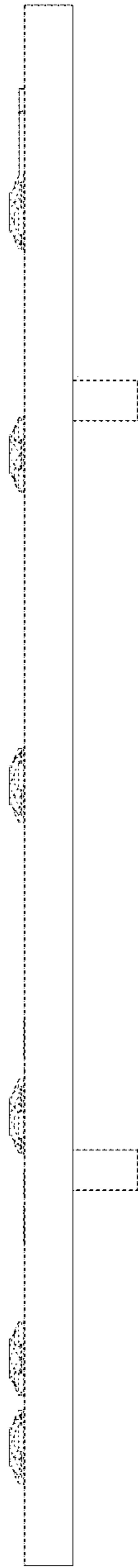

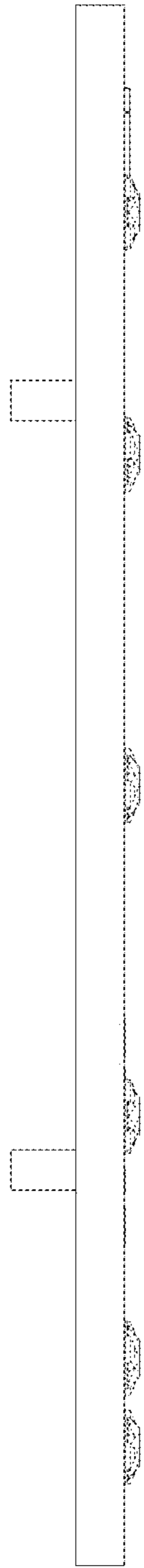

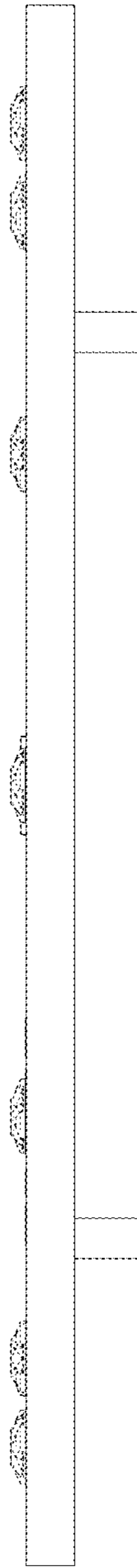

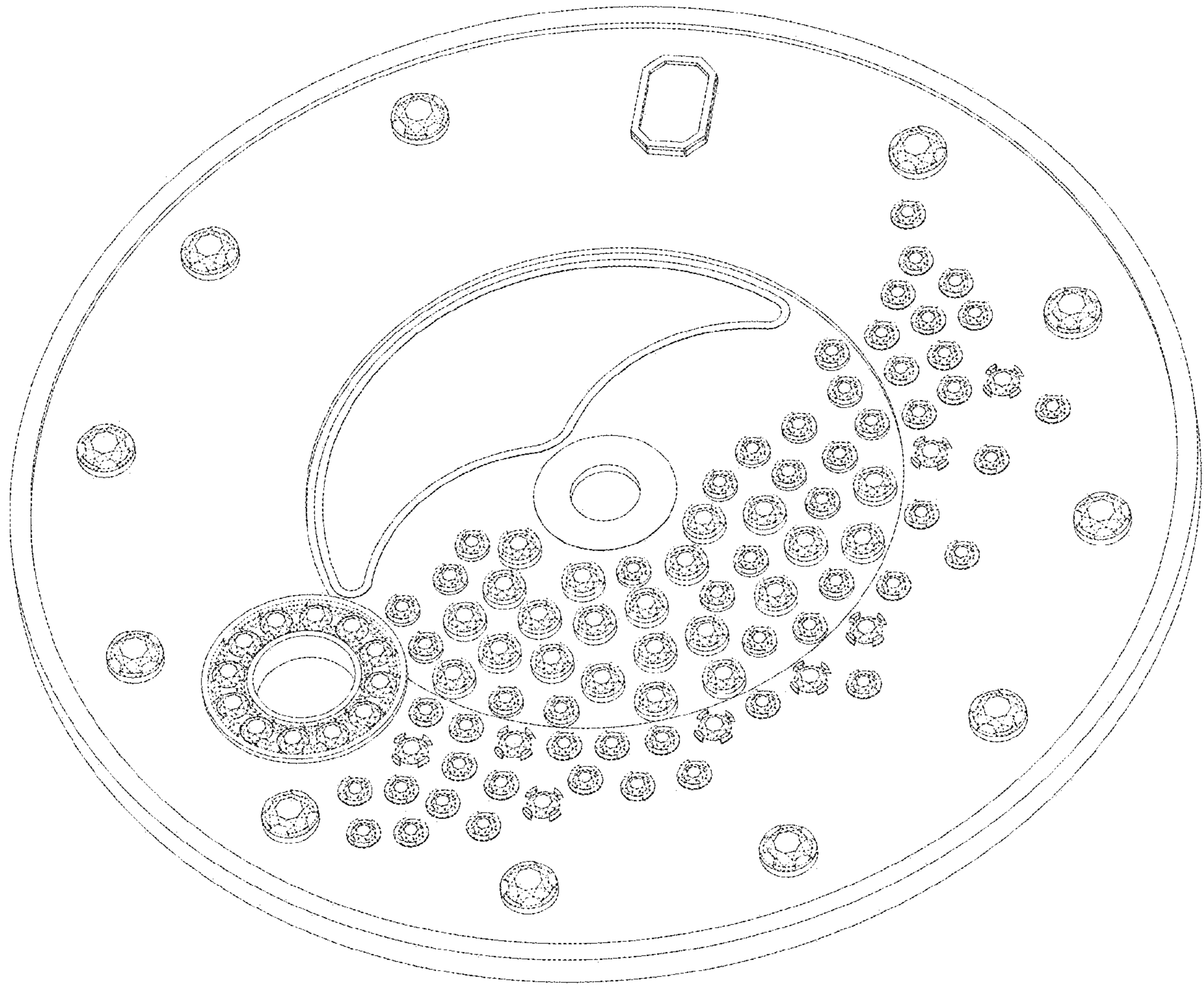

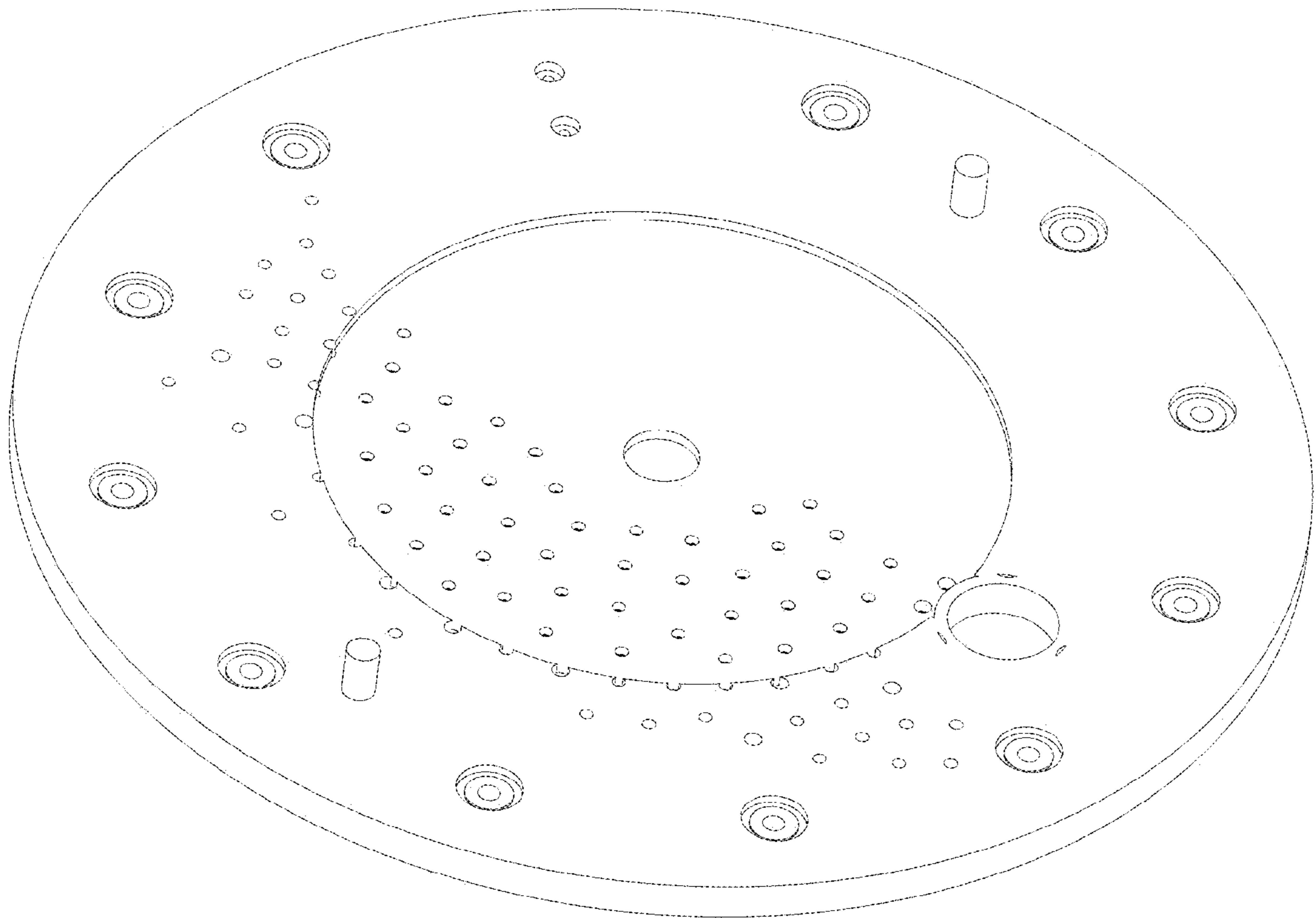
