(57) **CLAIM**

The ornamental design for a rear fender for a vehicle, as shown and described.

DESCRIPTION

This application contains subject matter related to the following co-pending U.S. design patent applications:

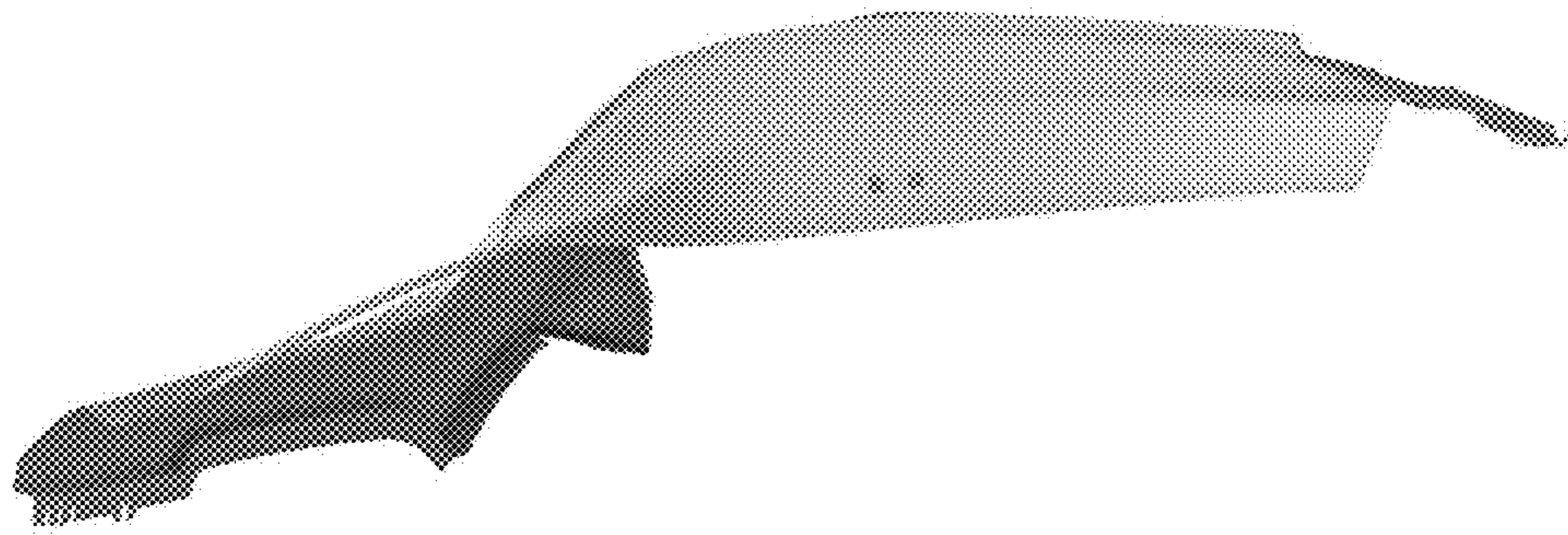

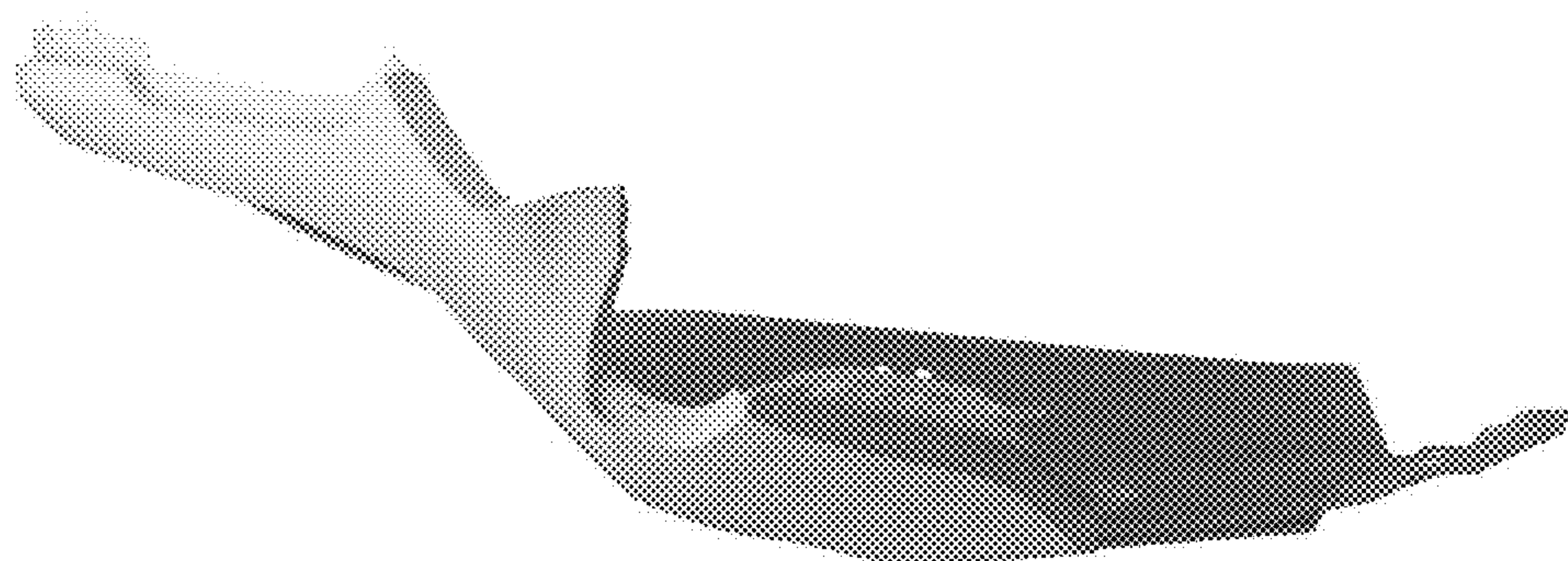

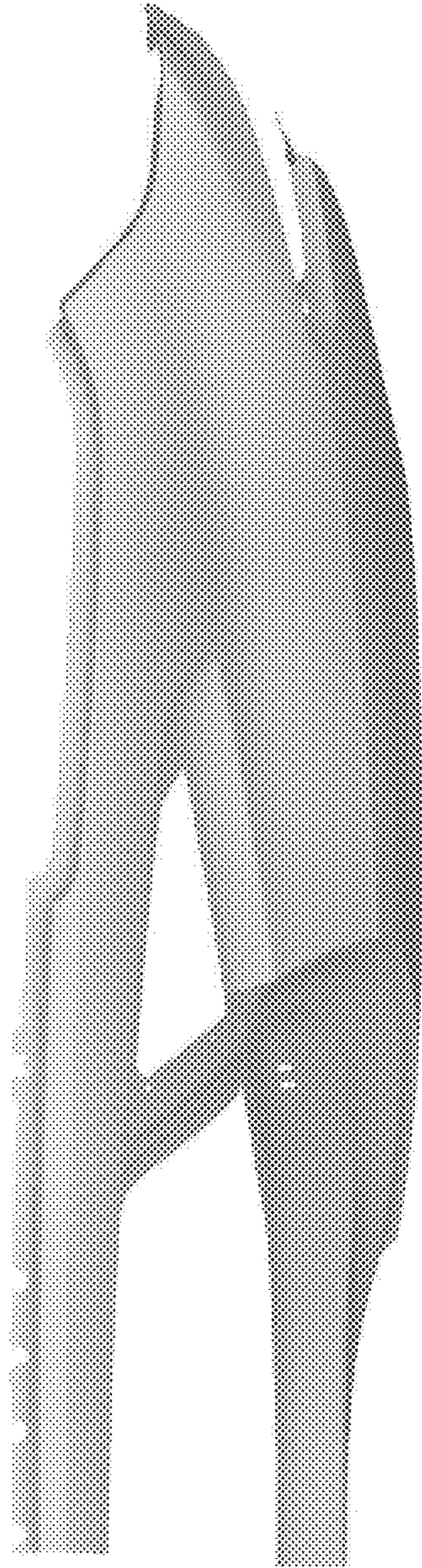

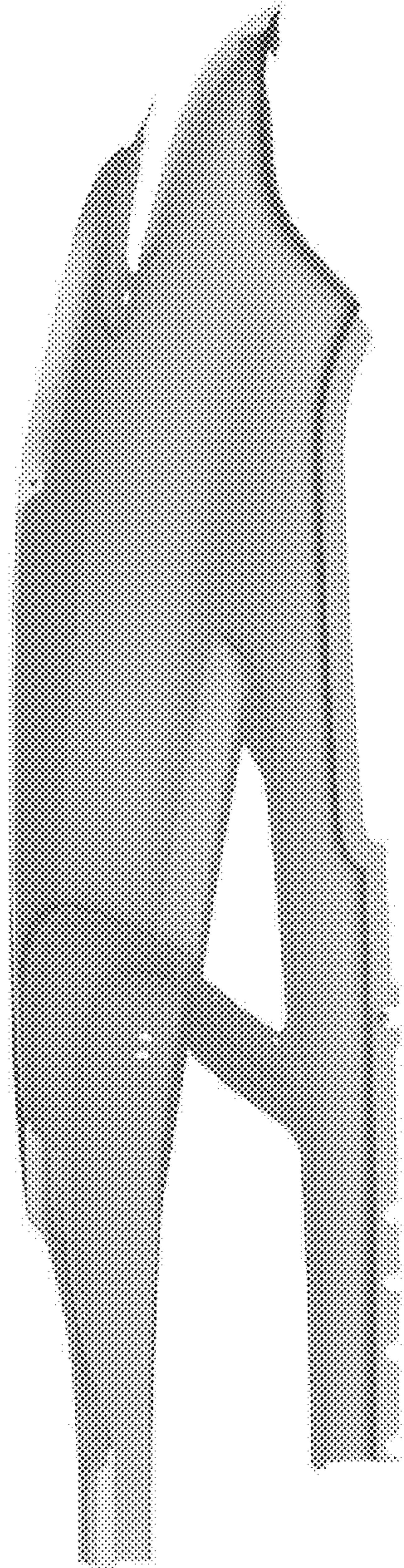

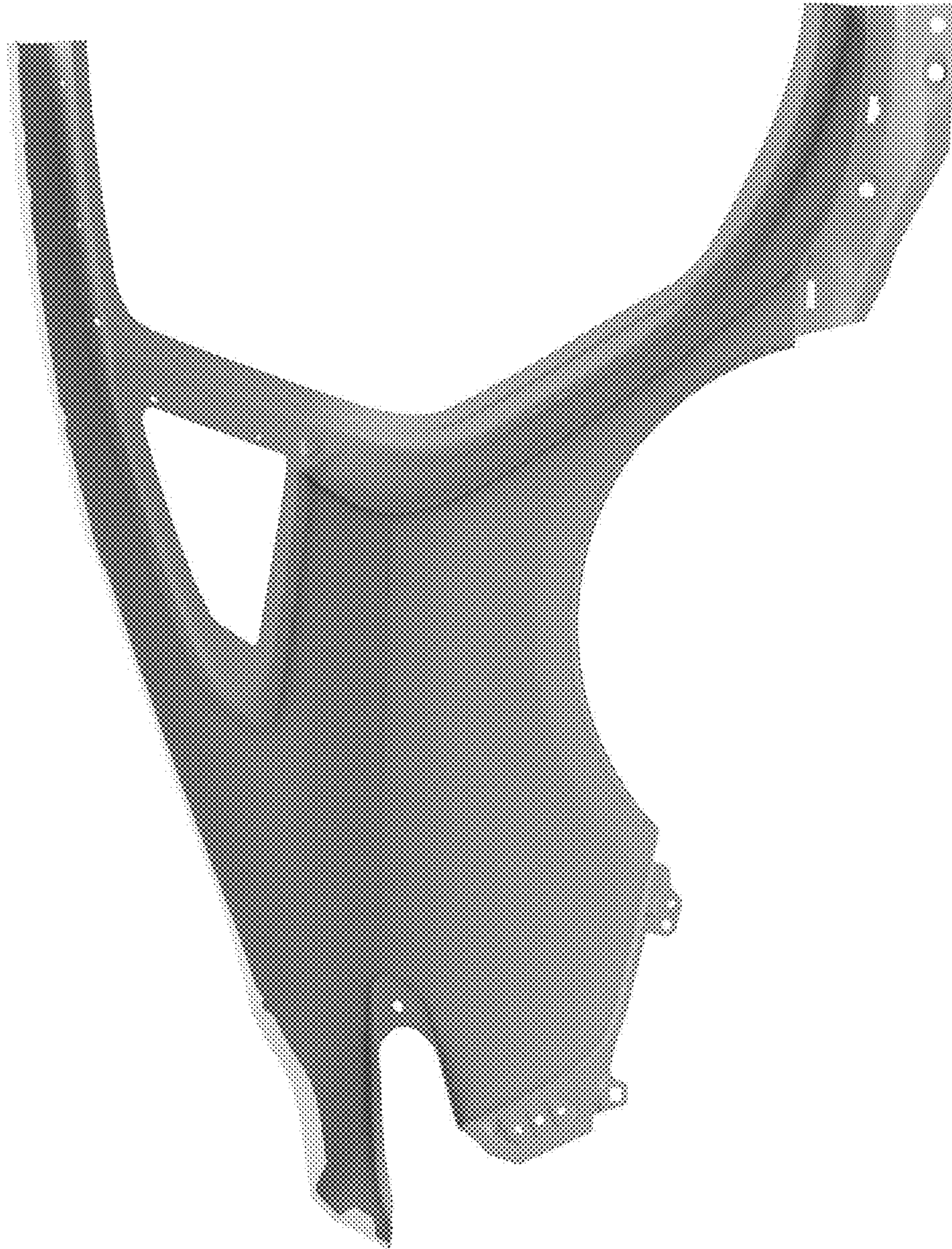
