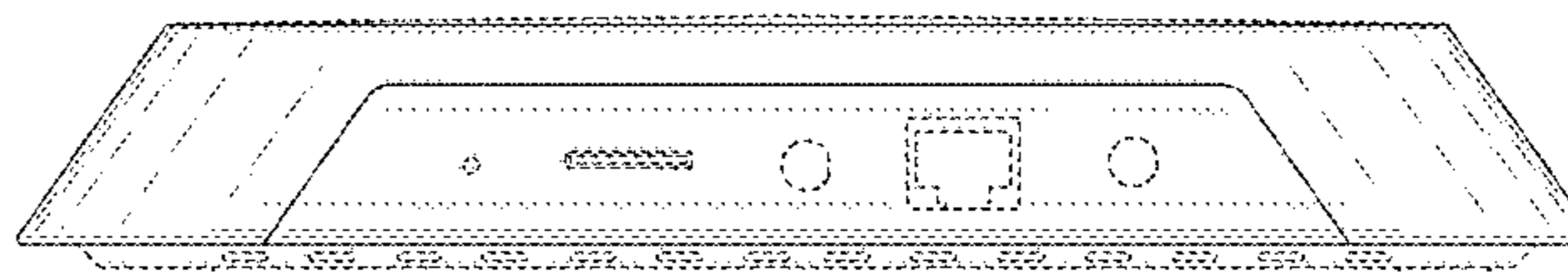
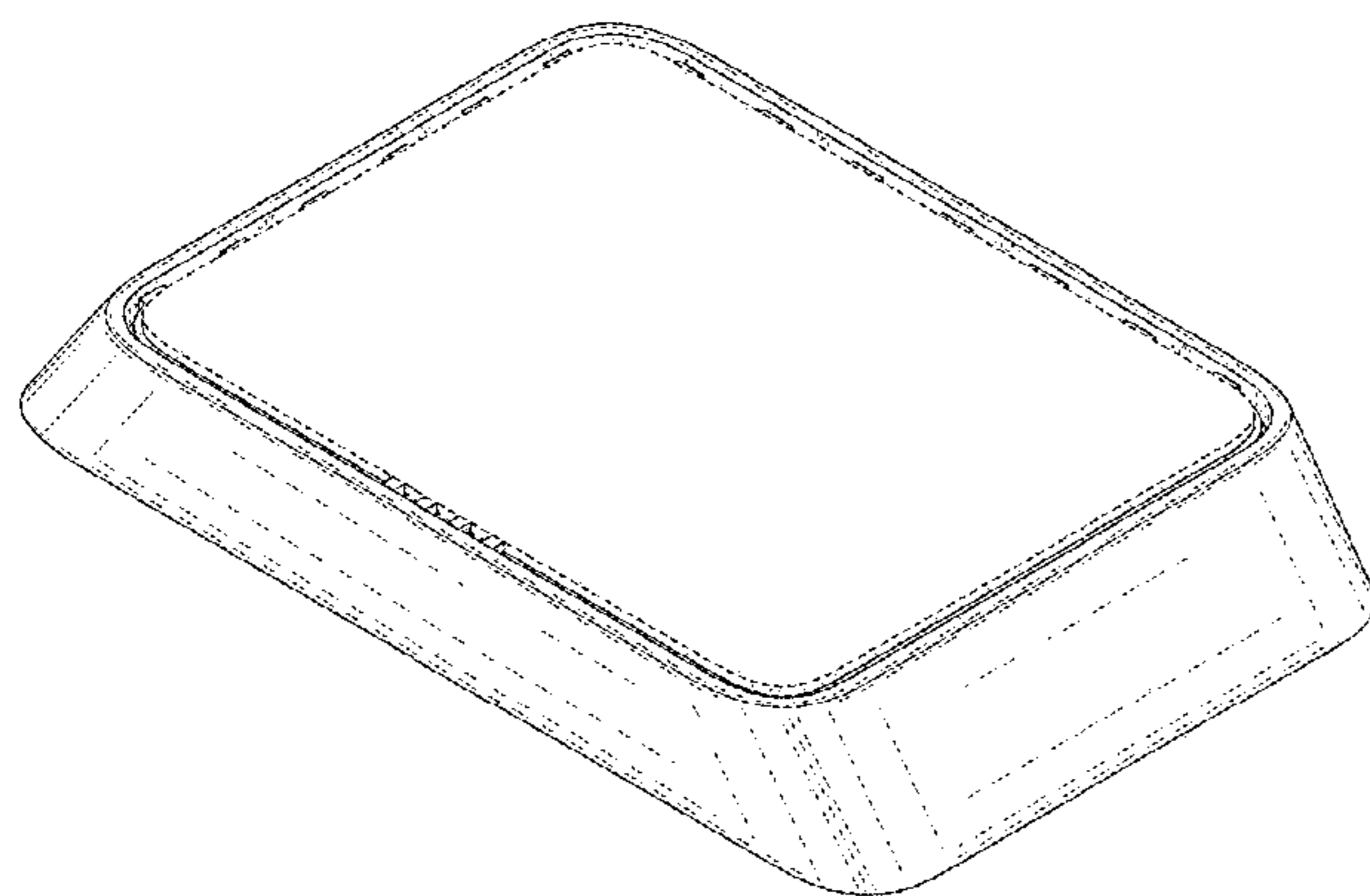
(57) **CLAIM**

The ornamental design for a gateway, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a gateway showing our new design in an unilluminated state;
FIG. 2 is a top rear perspective view thereof;
FIG. 3 is a bottom front perspective view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a left side view thereof;
FIG. 7 is a right side view thereof;
FIG. 8 is a top view thereof;
FIG. 9 is a bottom view thereof;
FIG. 10 is an end view taken through line 10-10 of FIG. 8;
FIG. 11 is an end view taken through line 11-11 of FIG. 8;
FIG. 12 is a top front perspective view of the gateway of FIGS. 1-11 shown in an illuminated state;
FIG. 13 is a top rear perspective view thereof;
FIG. 14 is a bottom front perspective view thereof;
FIG. 15 is a front view thereof;
FIG. 16 is a rear view thereof;
FIG. 17 is a left side view thereof;
FIG. 18 is a right side view thereof;
FIG. 19 is a top view thereof;
FIG. 20 is a bottom view thereof;
FIG. 21 is an end view taken through line 21-21 of FIG. 19; and,
FIG. 22 is an end view taken through line 22-22 of FIG. 19. The even-length broken lines depict portions of the gateway that form no part of the claimed design. The end views are provided merely to illustrate the appearance of the outer surface of the gateway, at specified positions, visible as the perimeter in the end views. The interior of the end views, marked by oblique, uneven-length broken lines, forms no part of the claimed design.

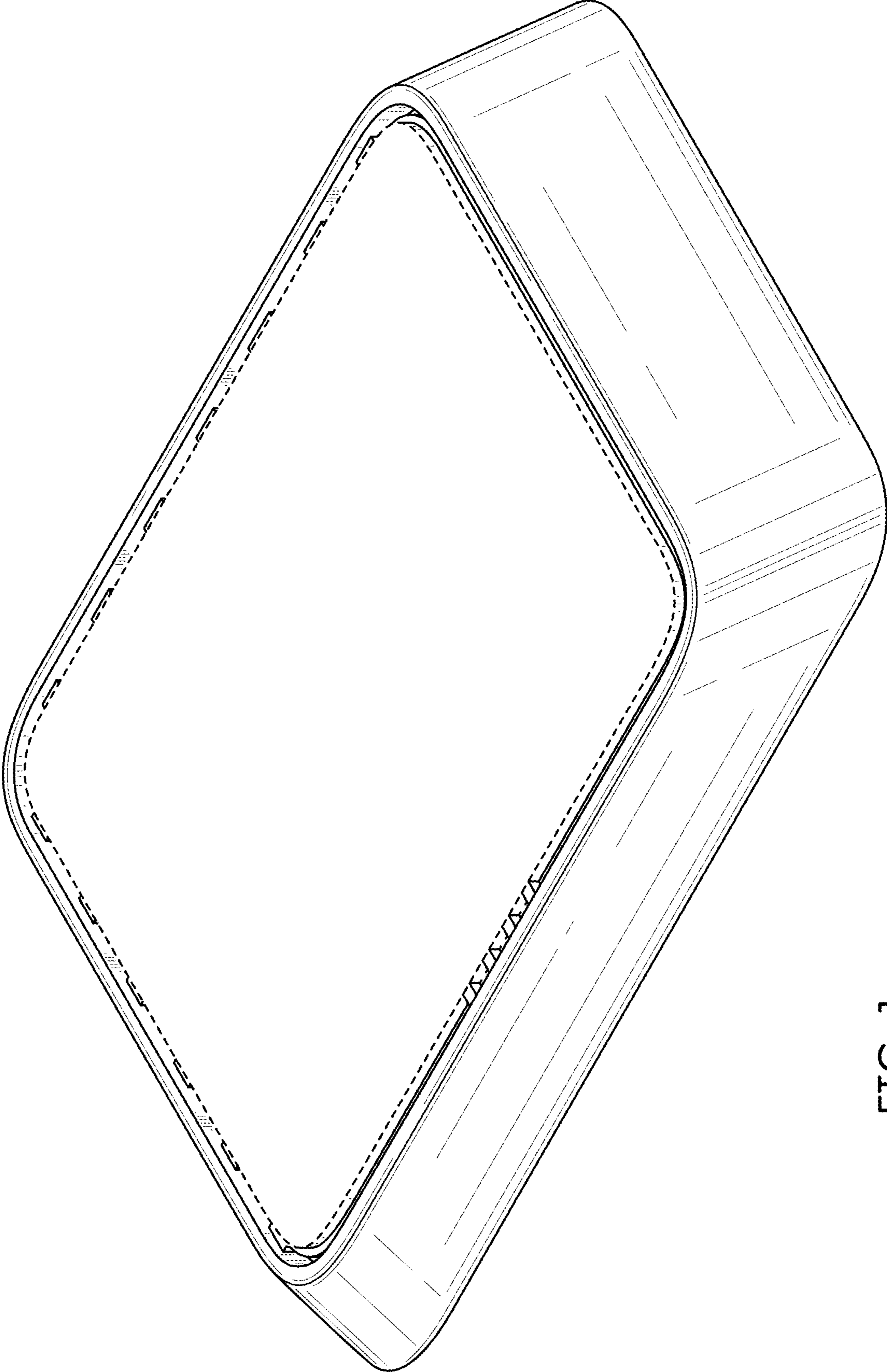

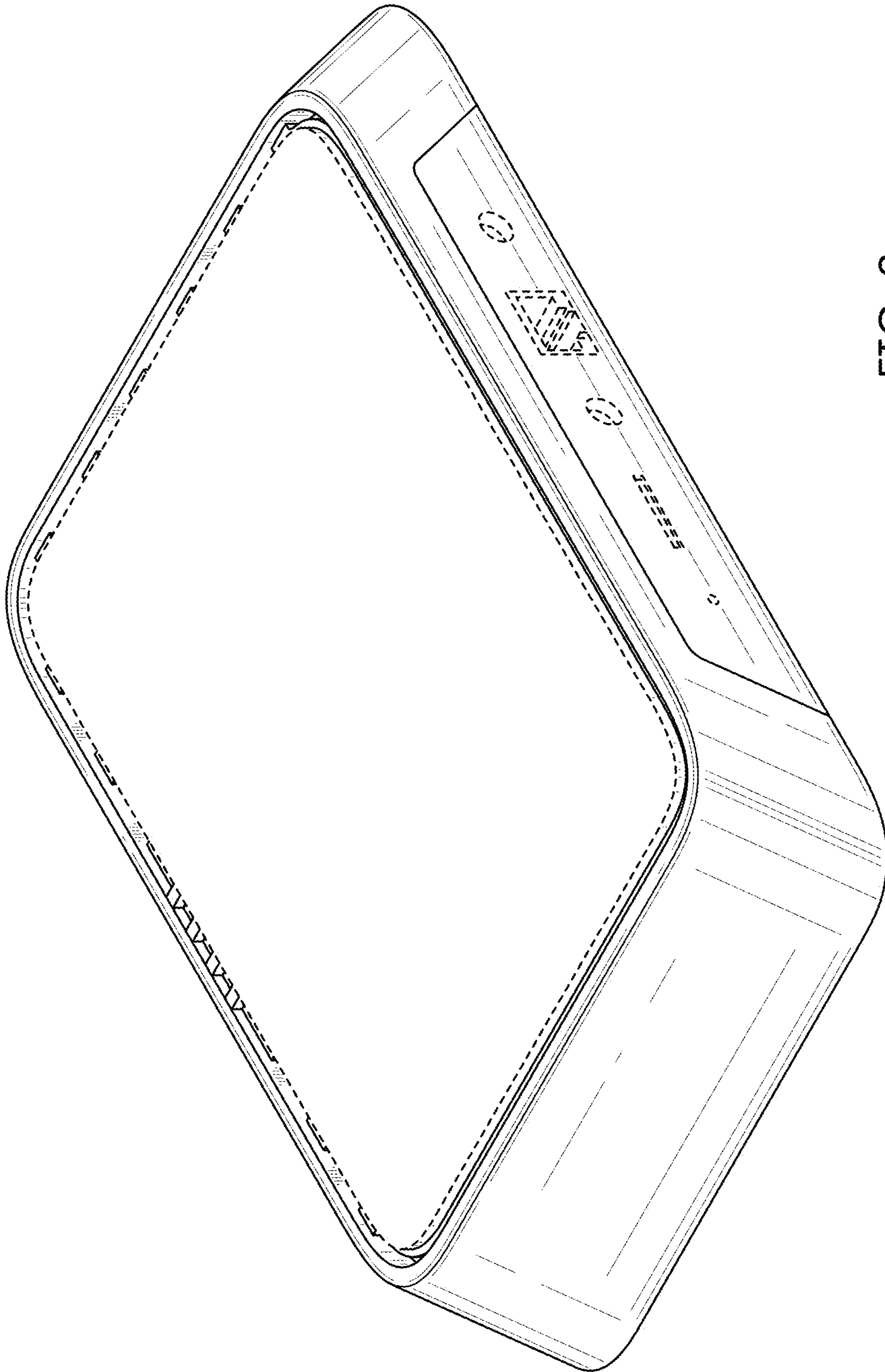

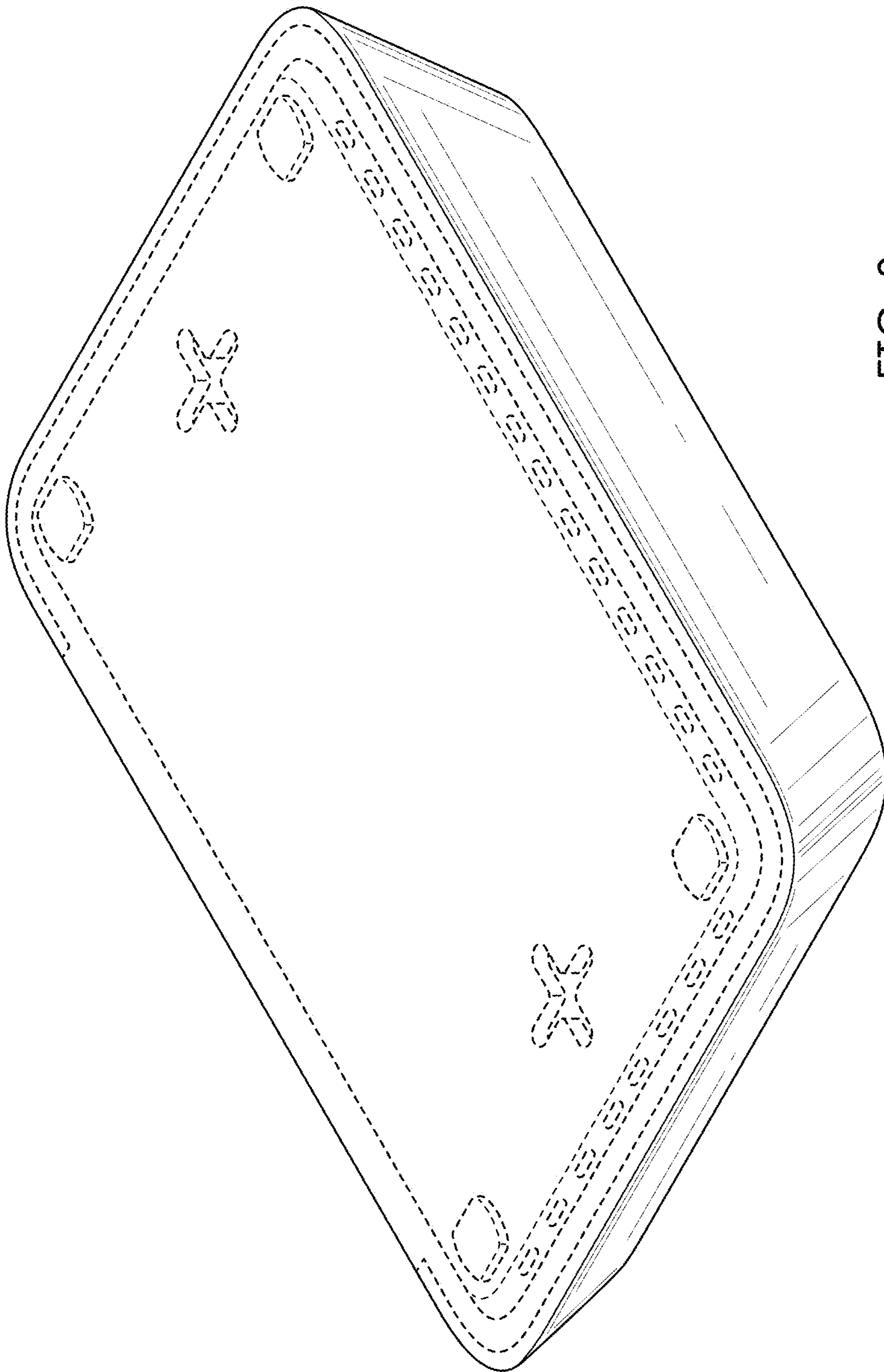

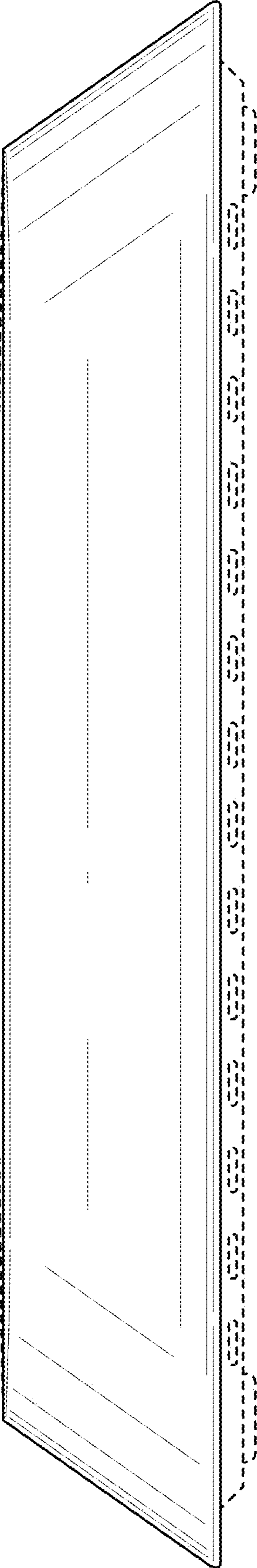

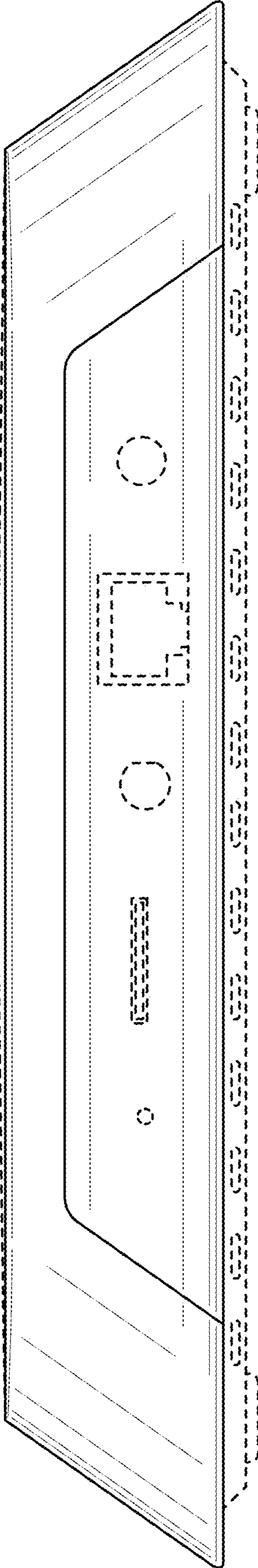

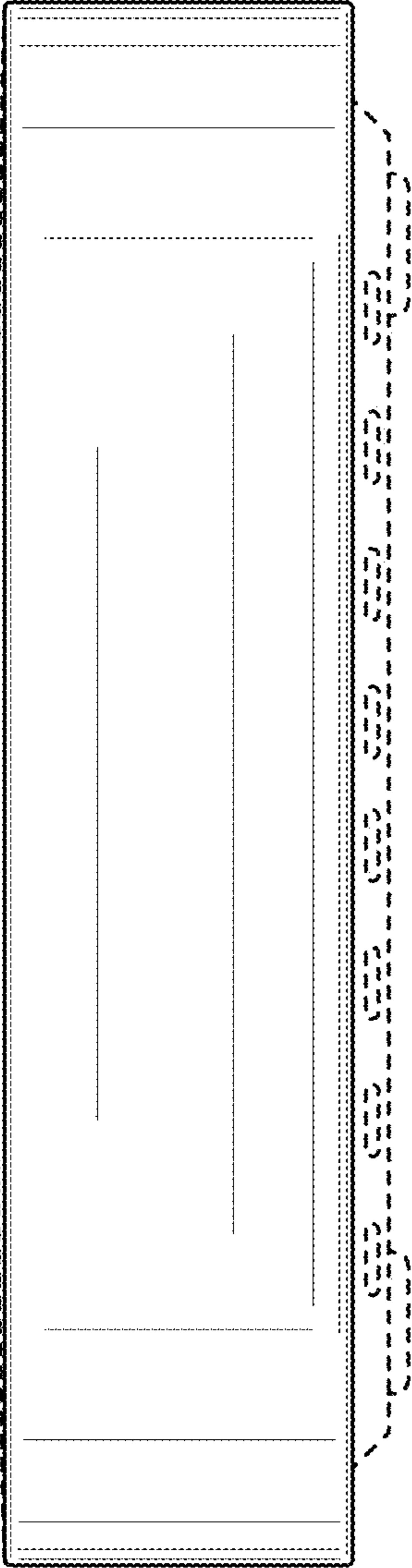

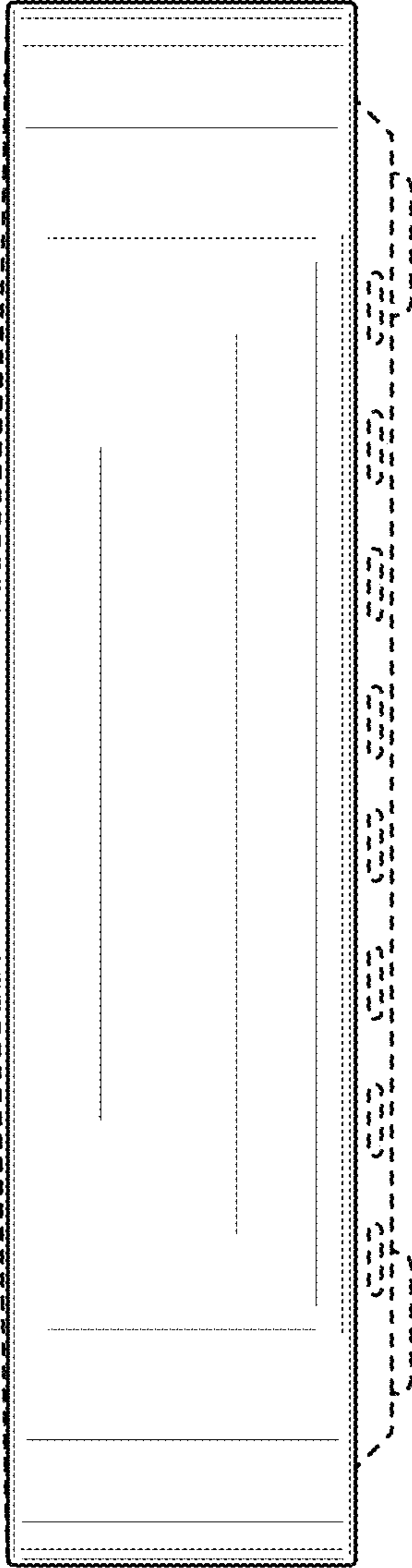

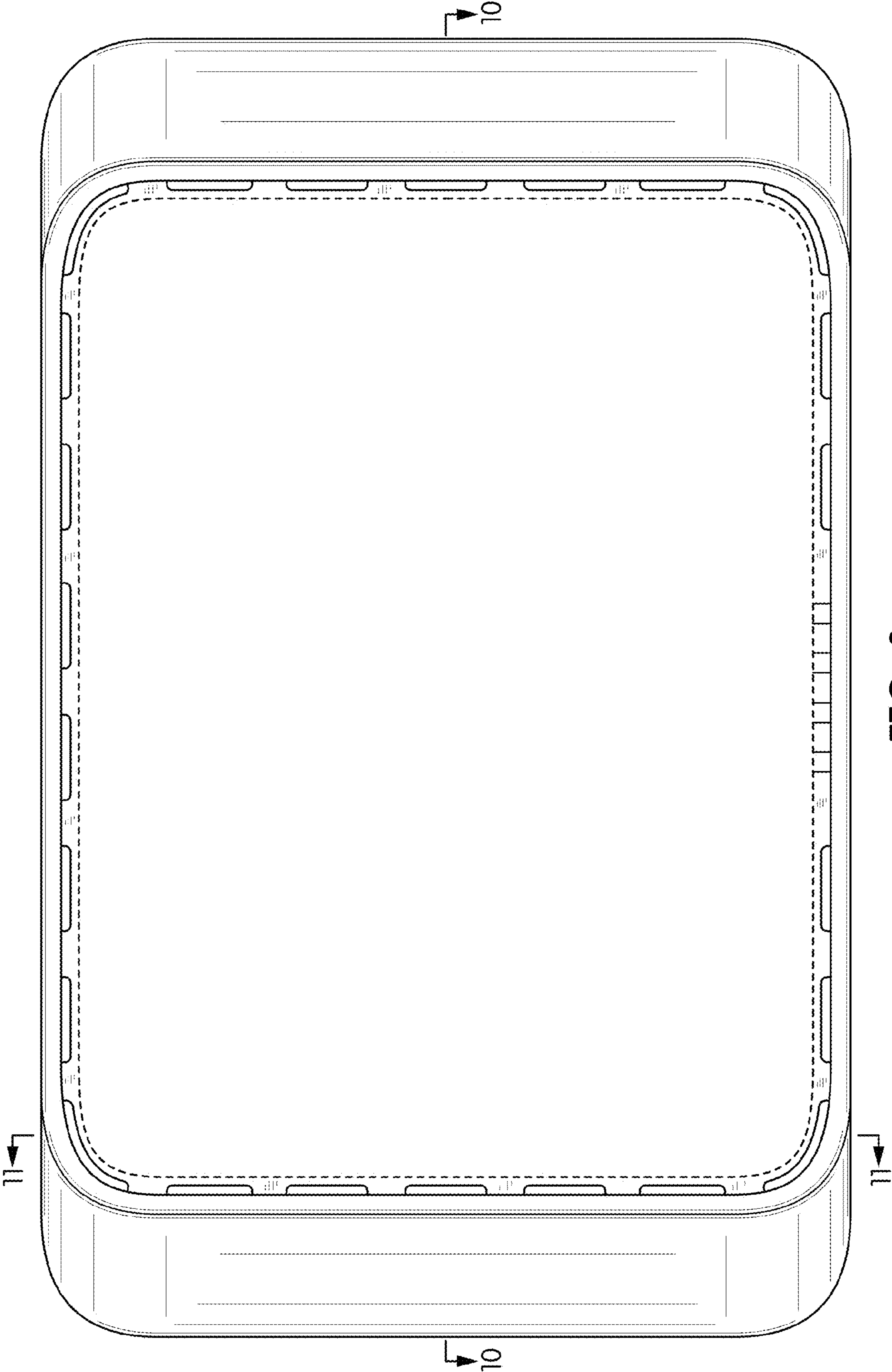

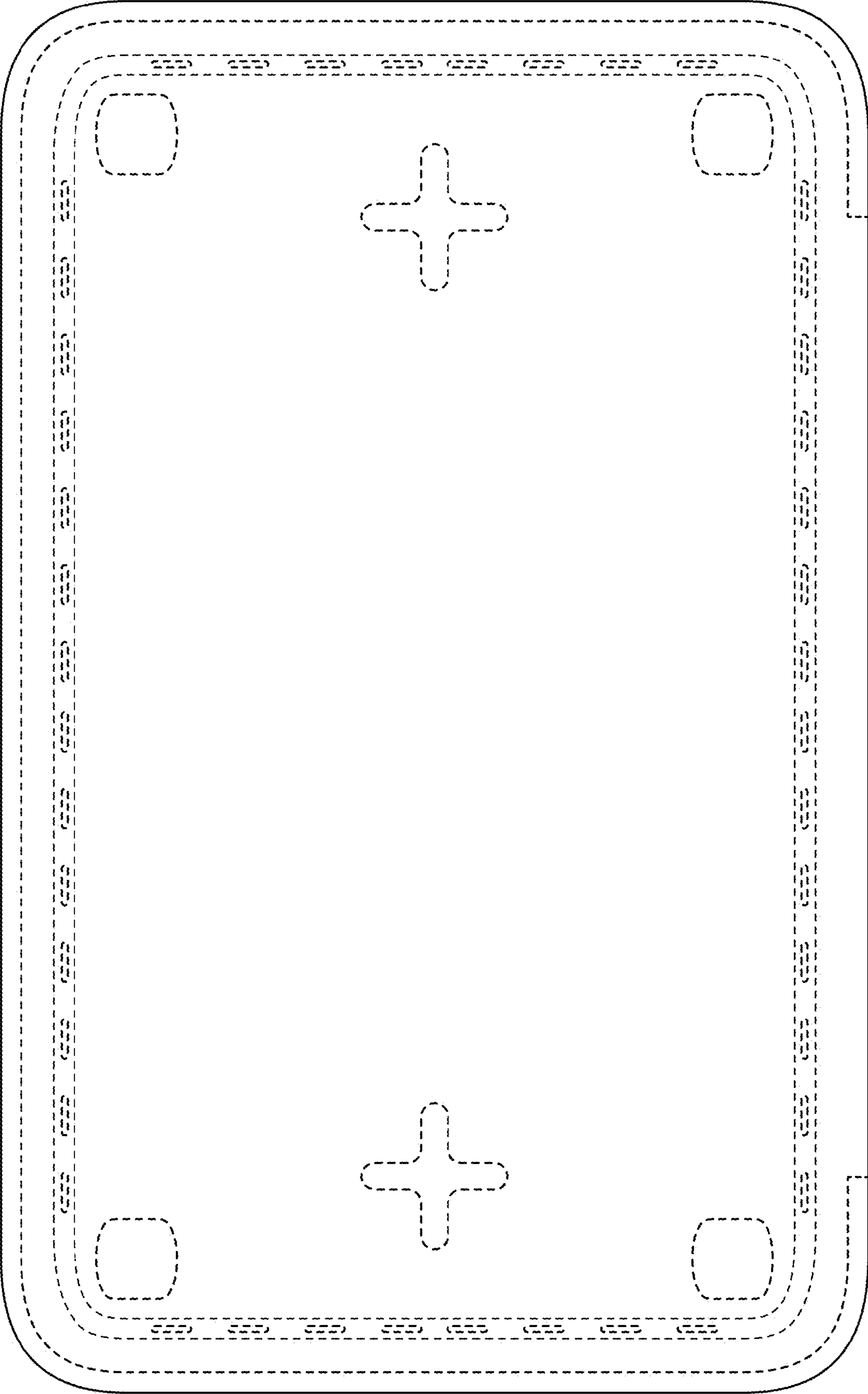

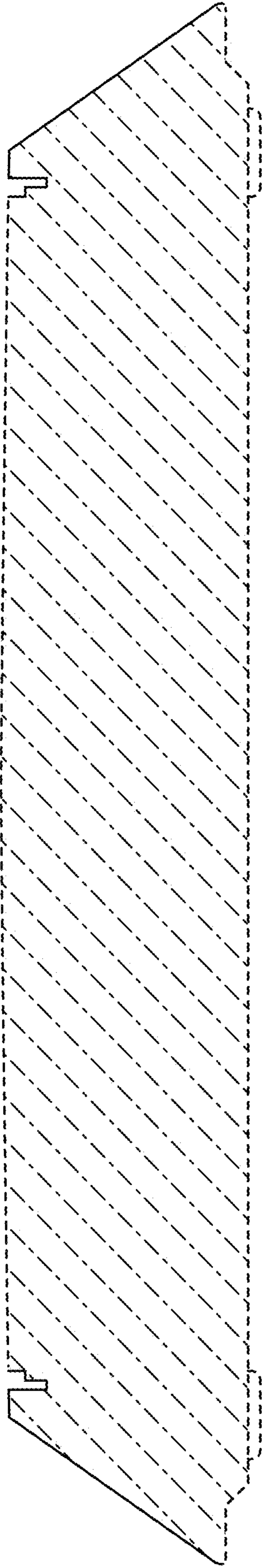

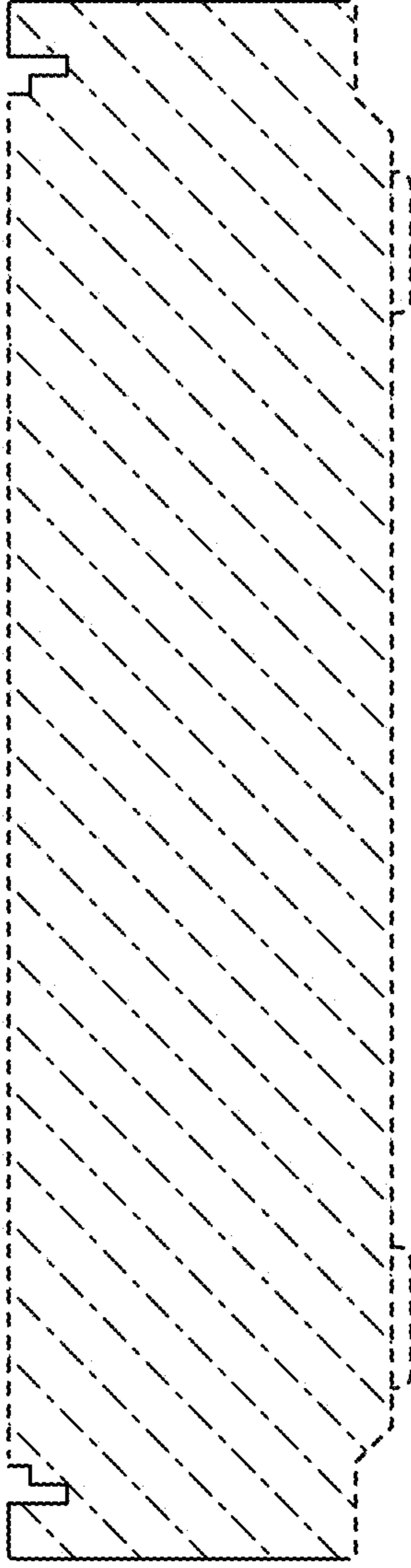

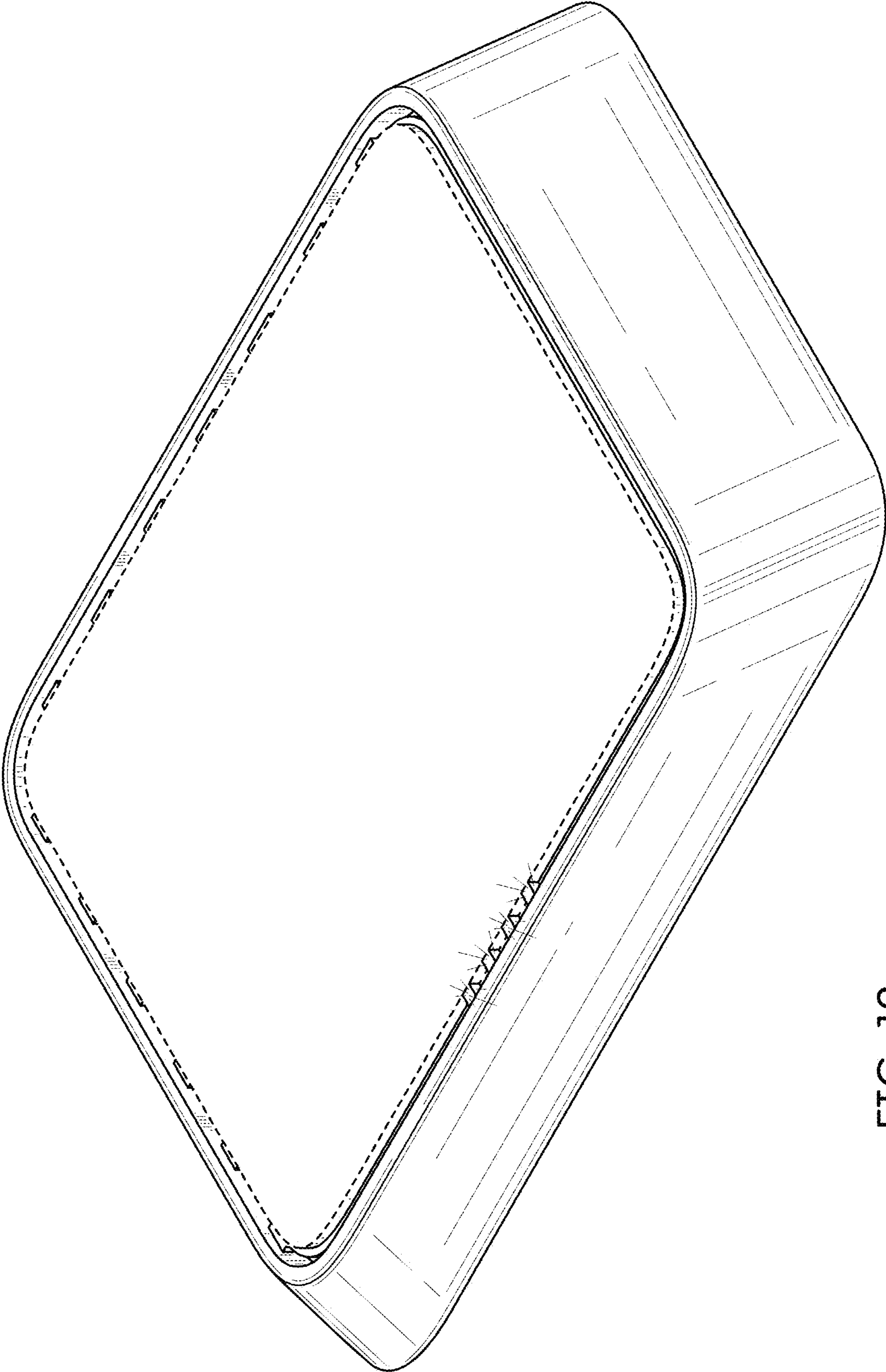

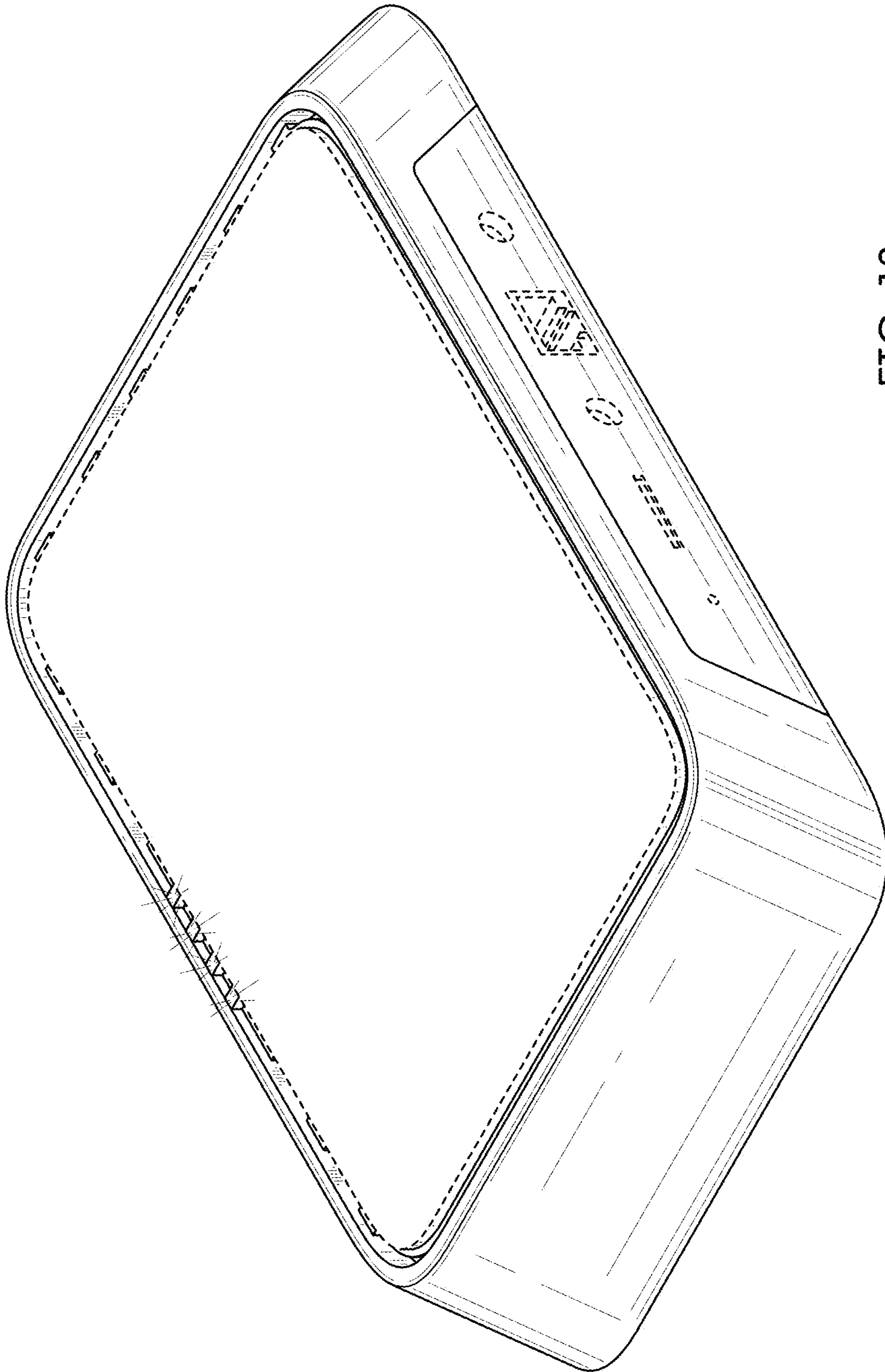

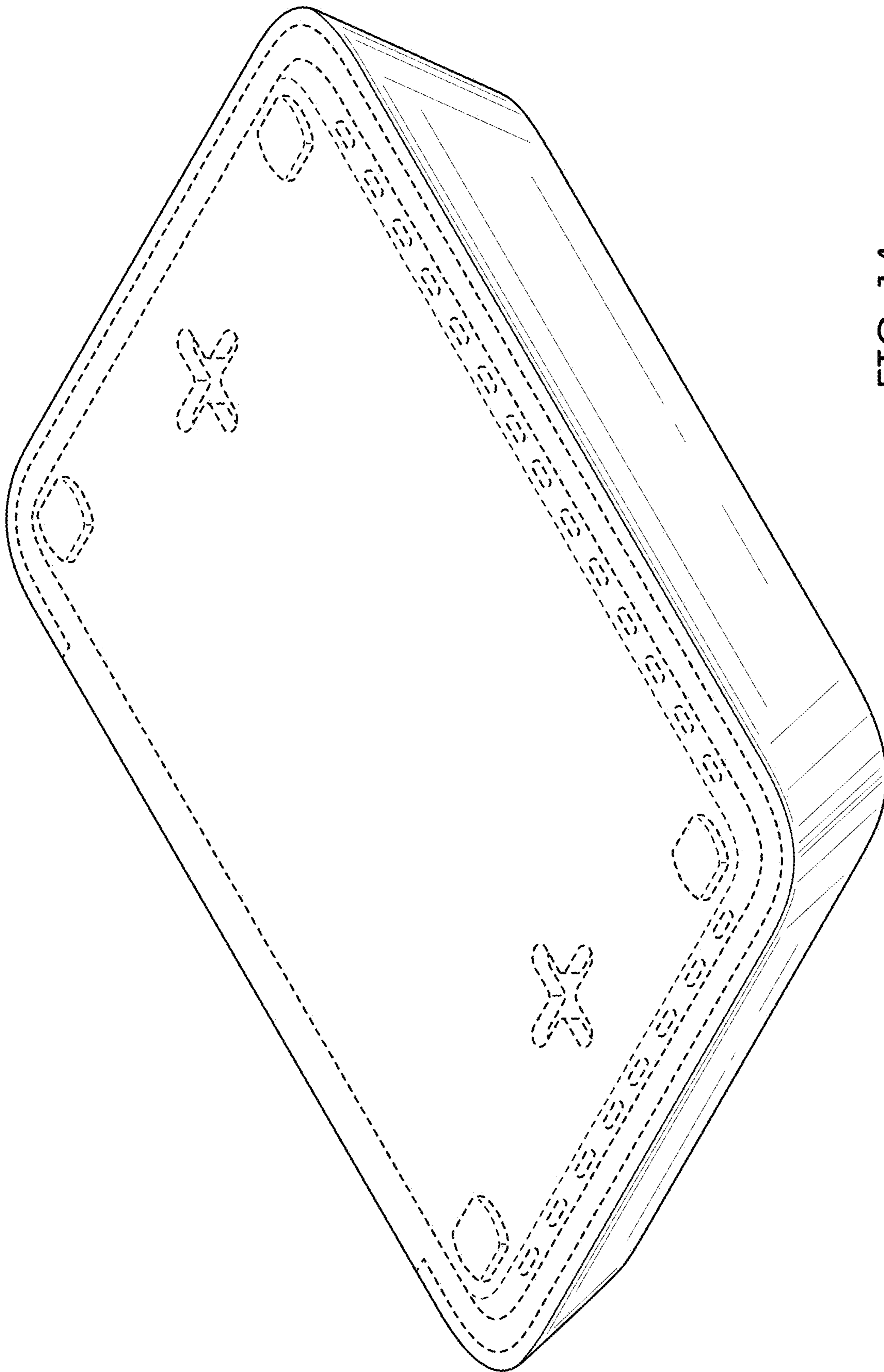

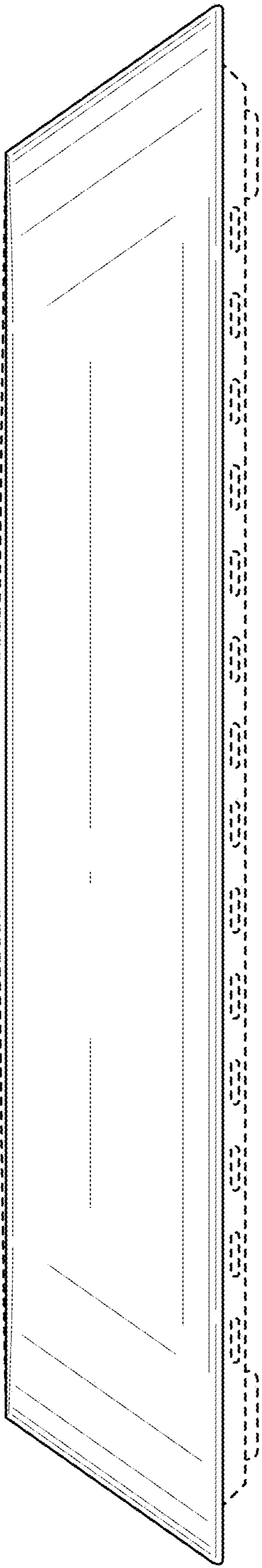

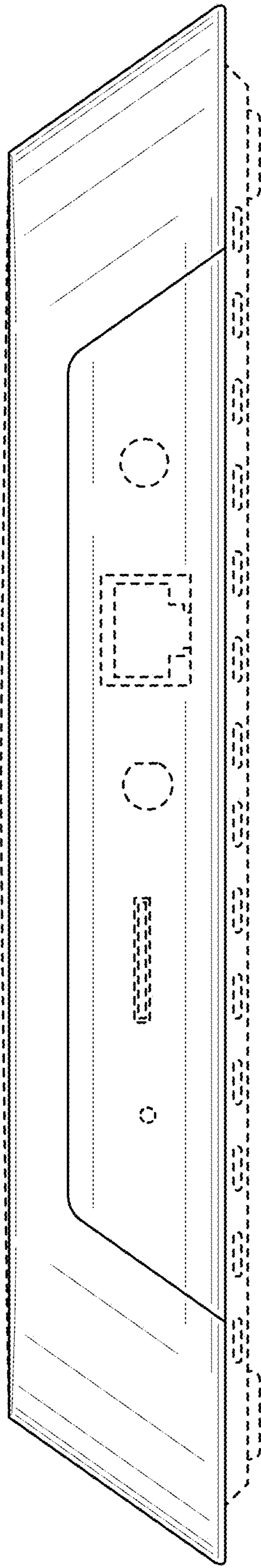

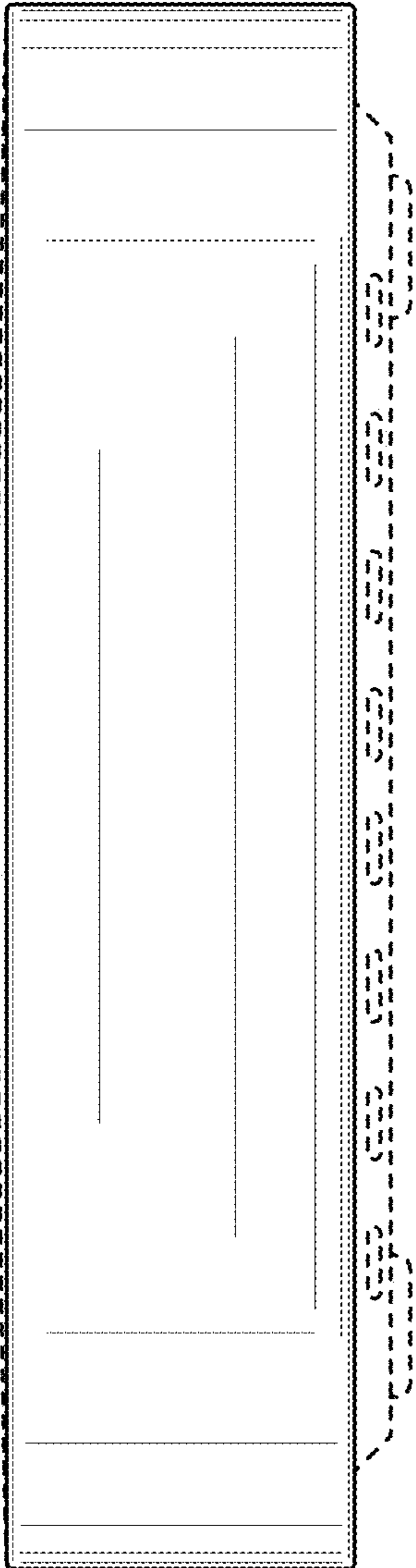

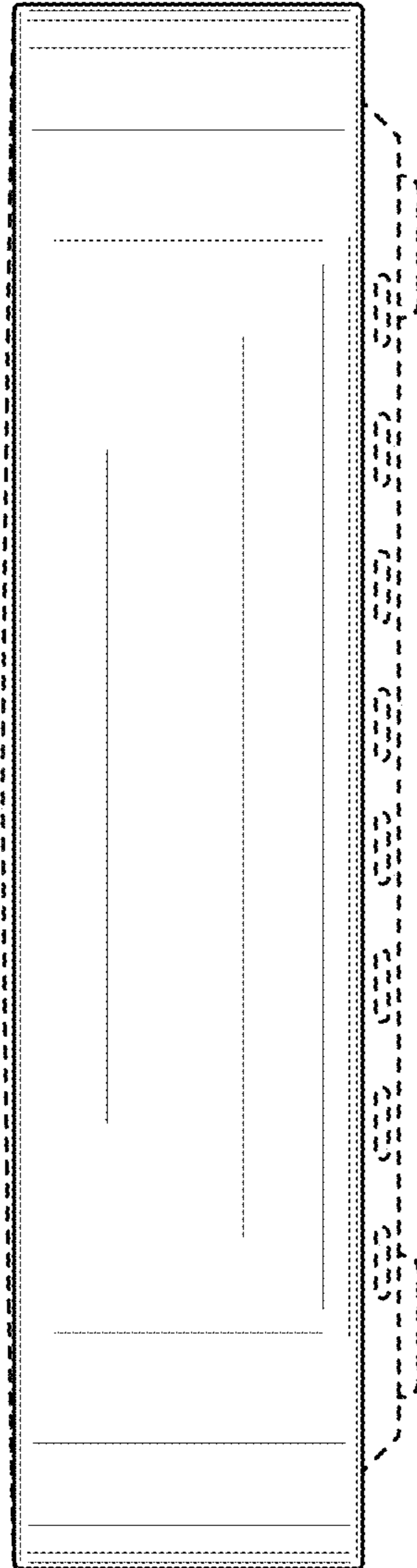

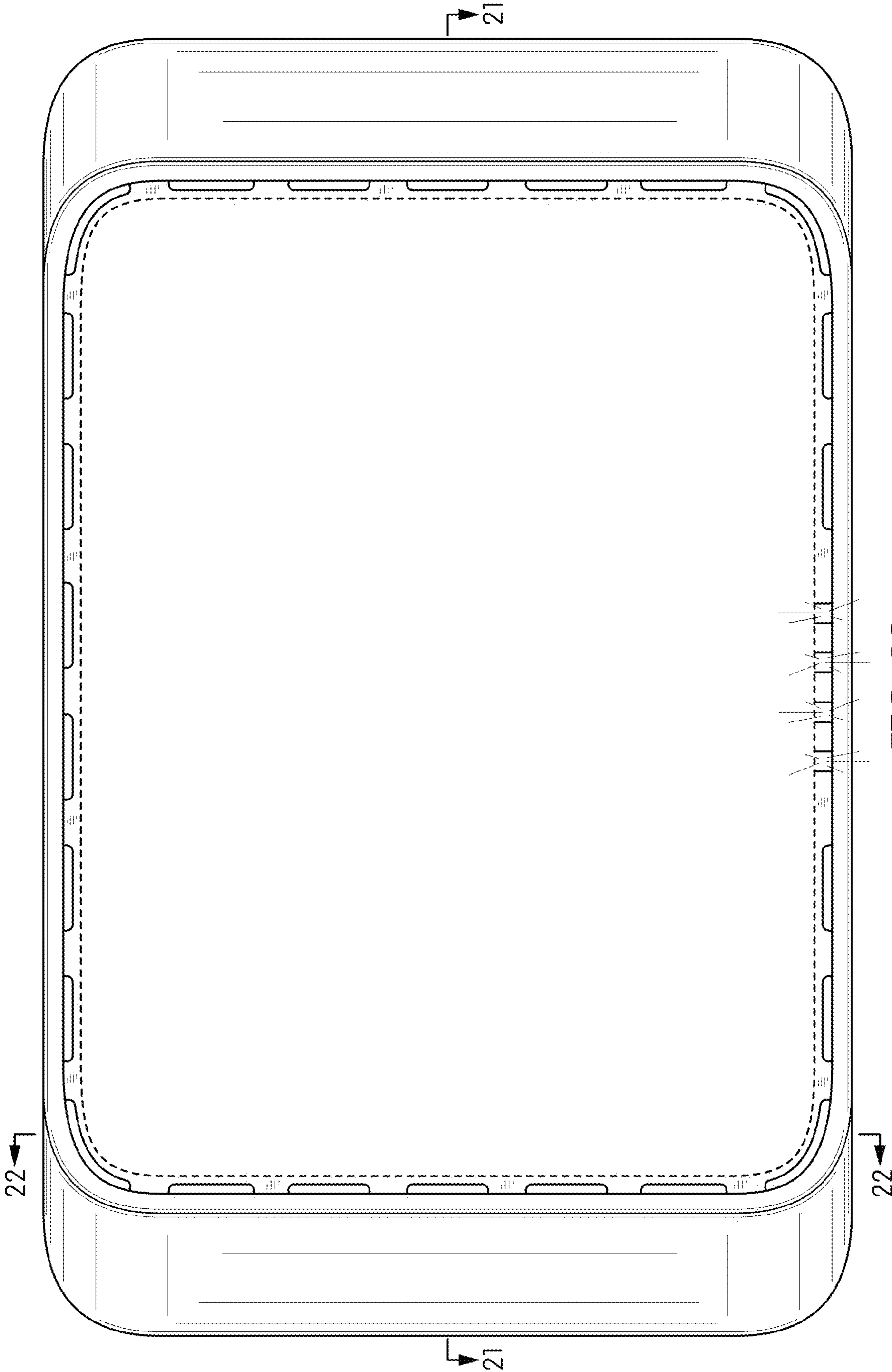

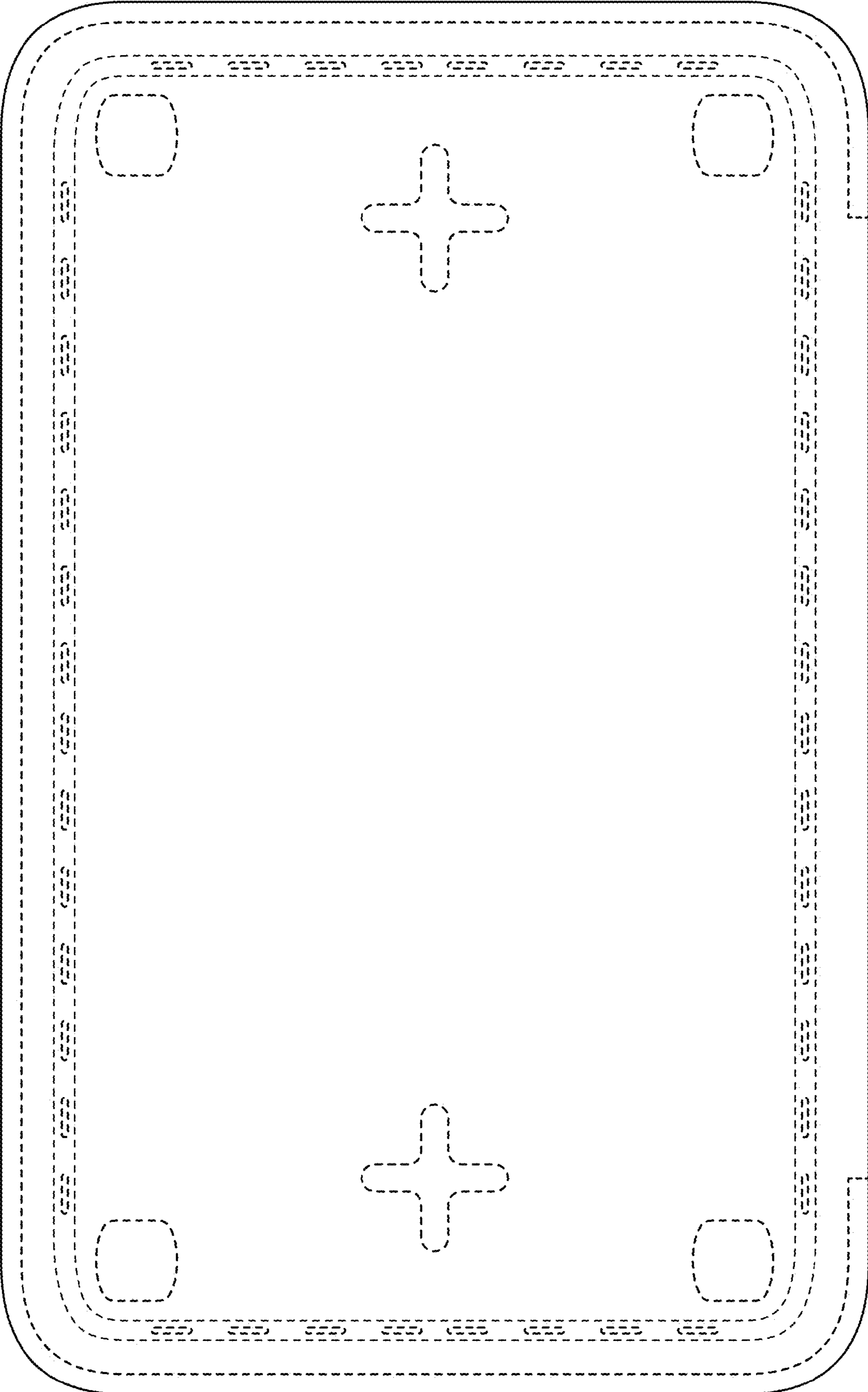

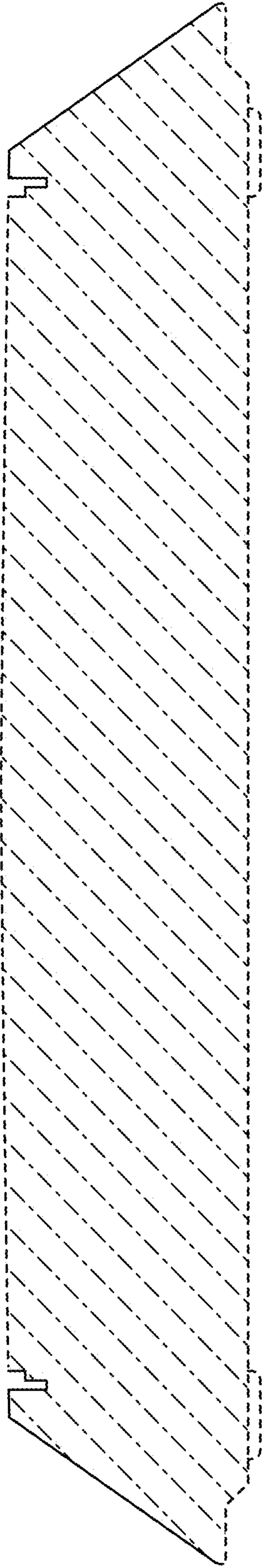

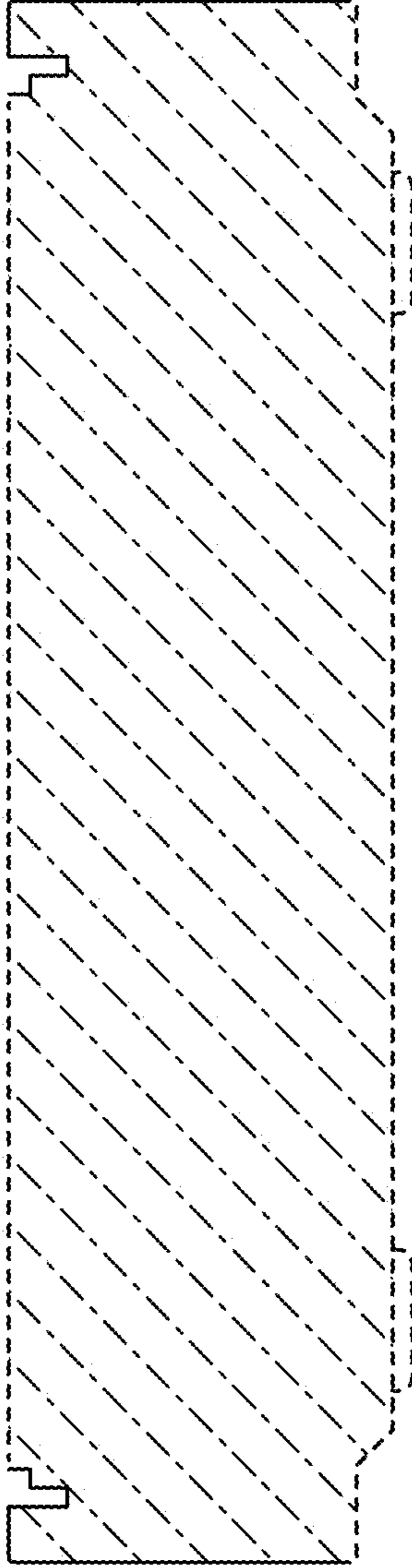
