DESCRIPTION

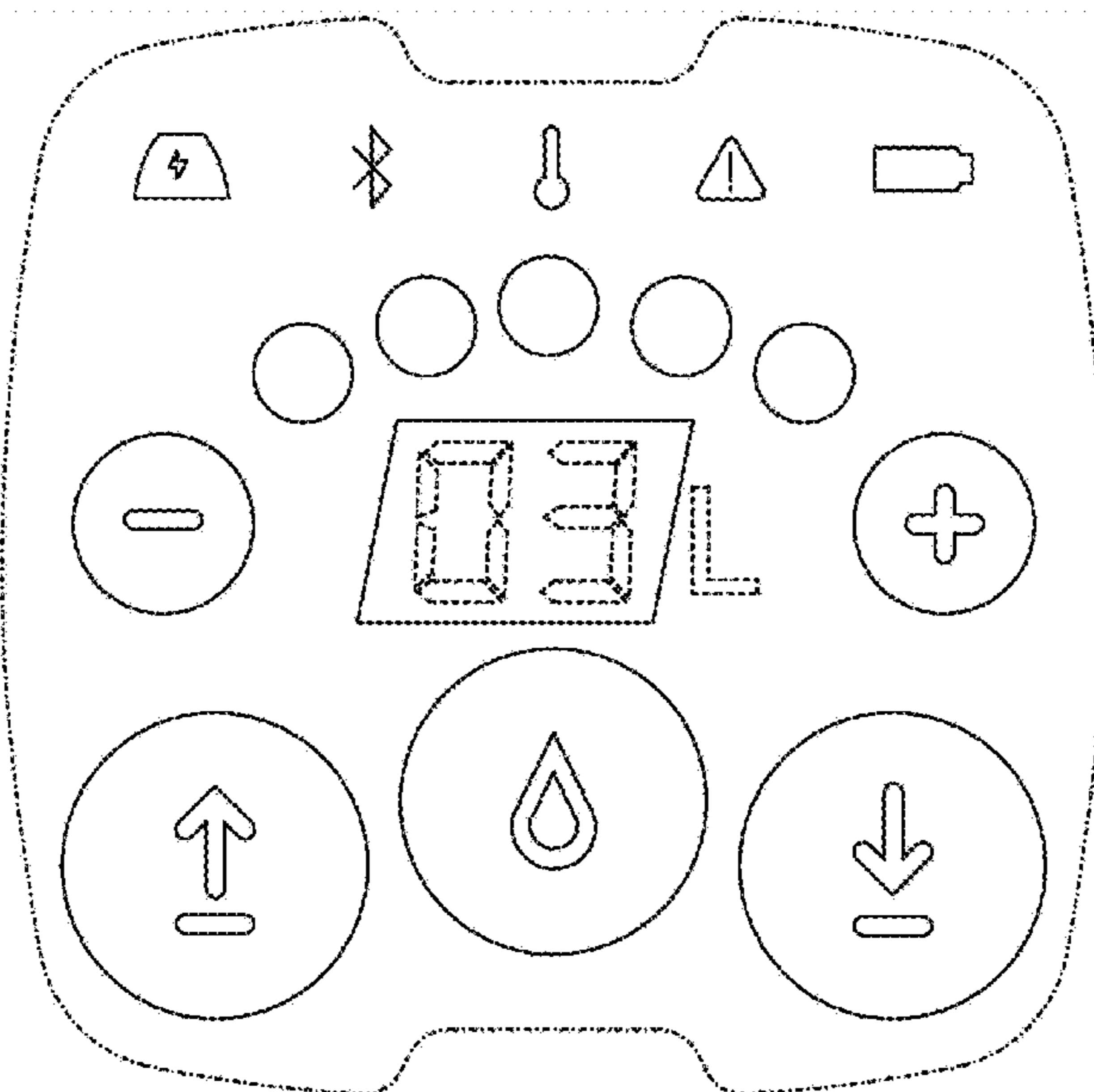
FIG. 1 is a front view of a controller with a transitional graphical user interface flat control panel, showing the claimed design;

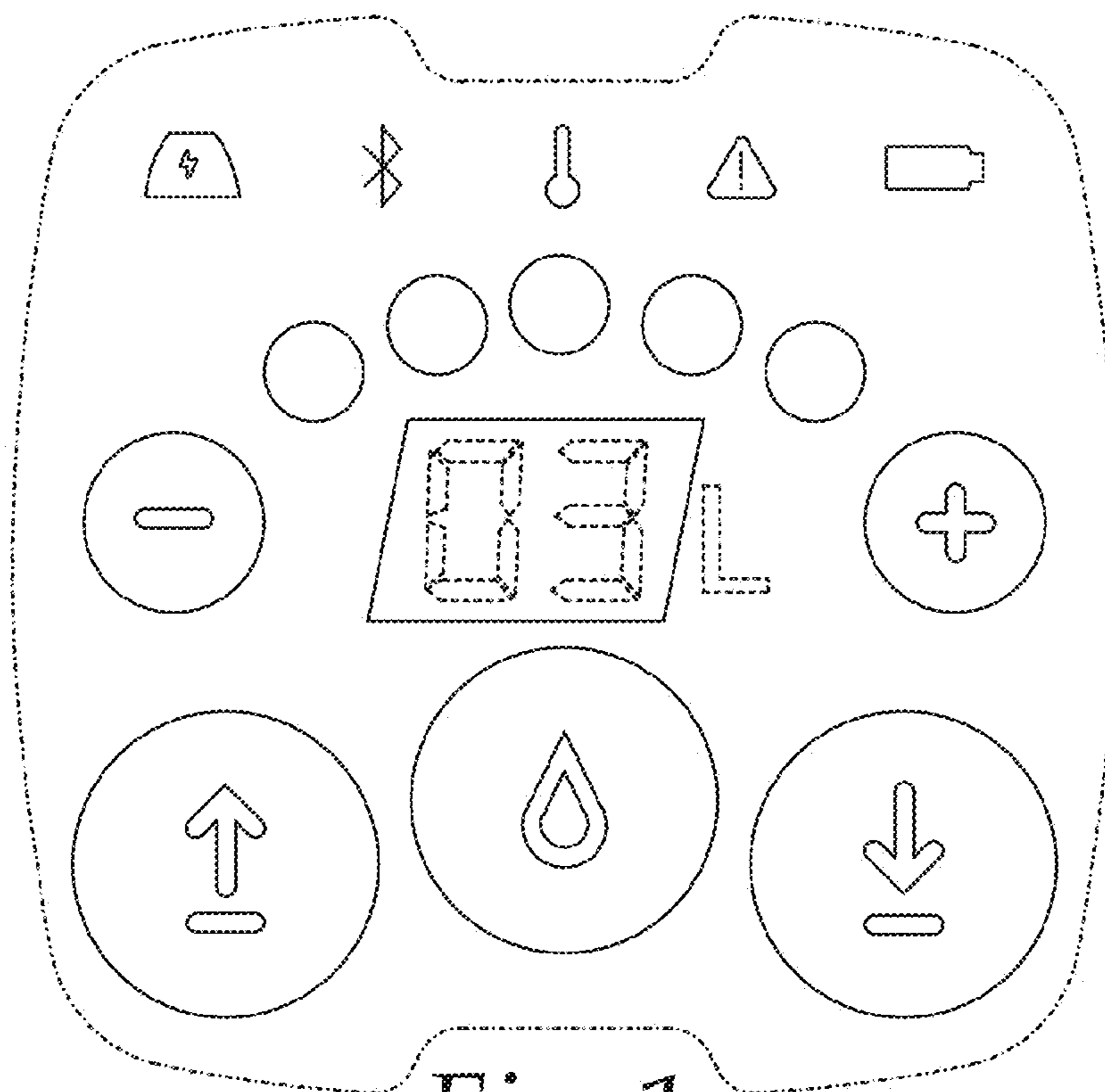

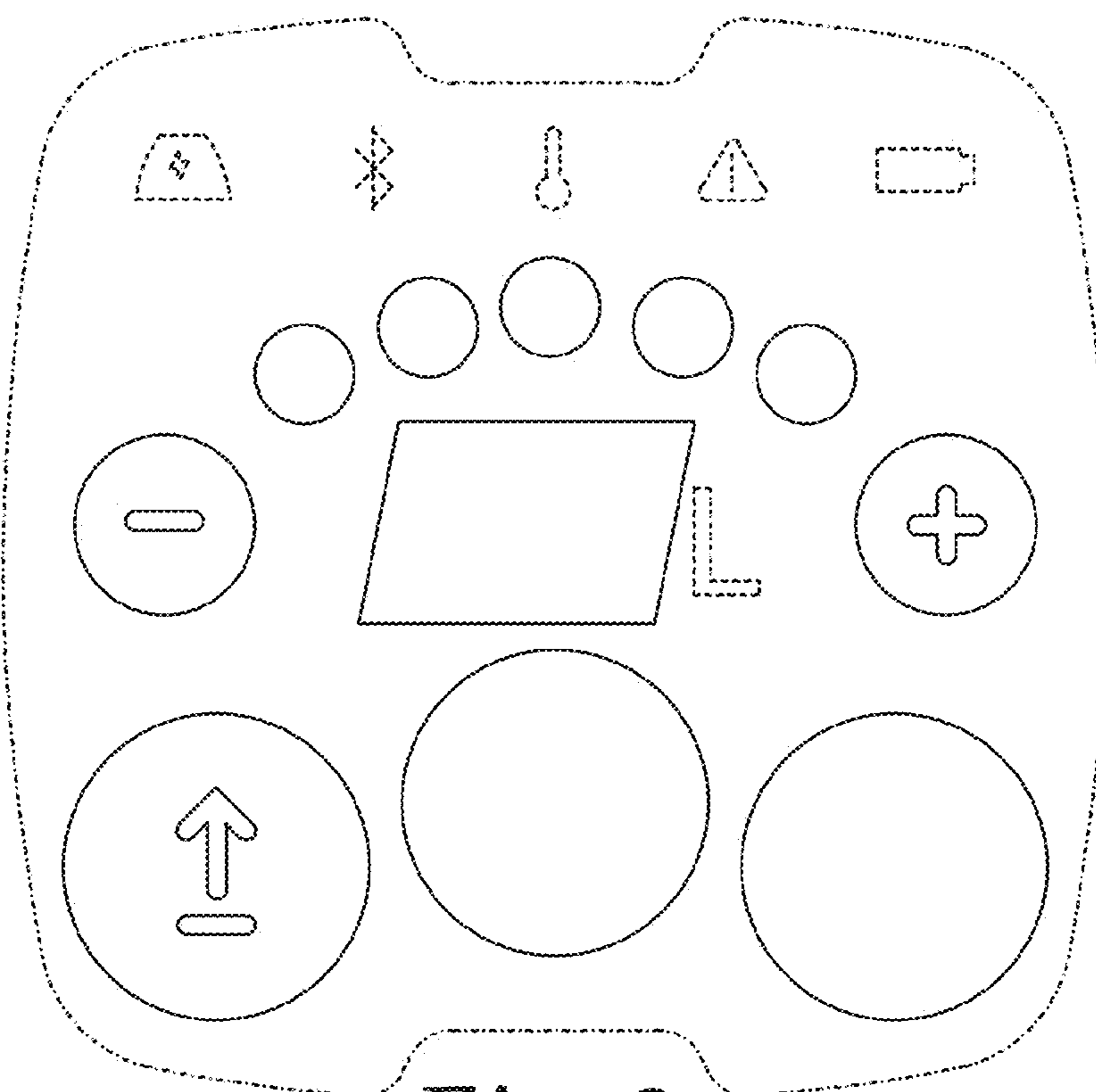

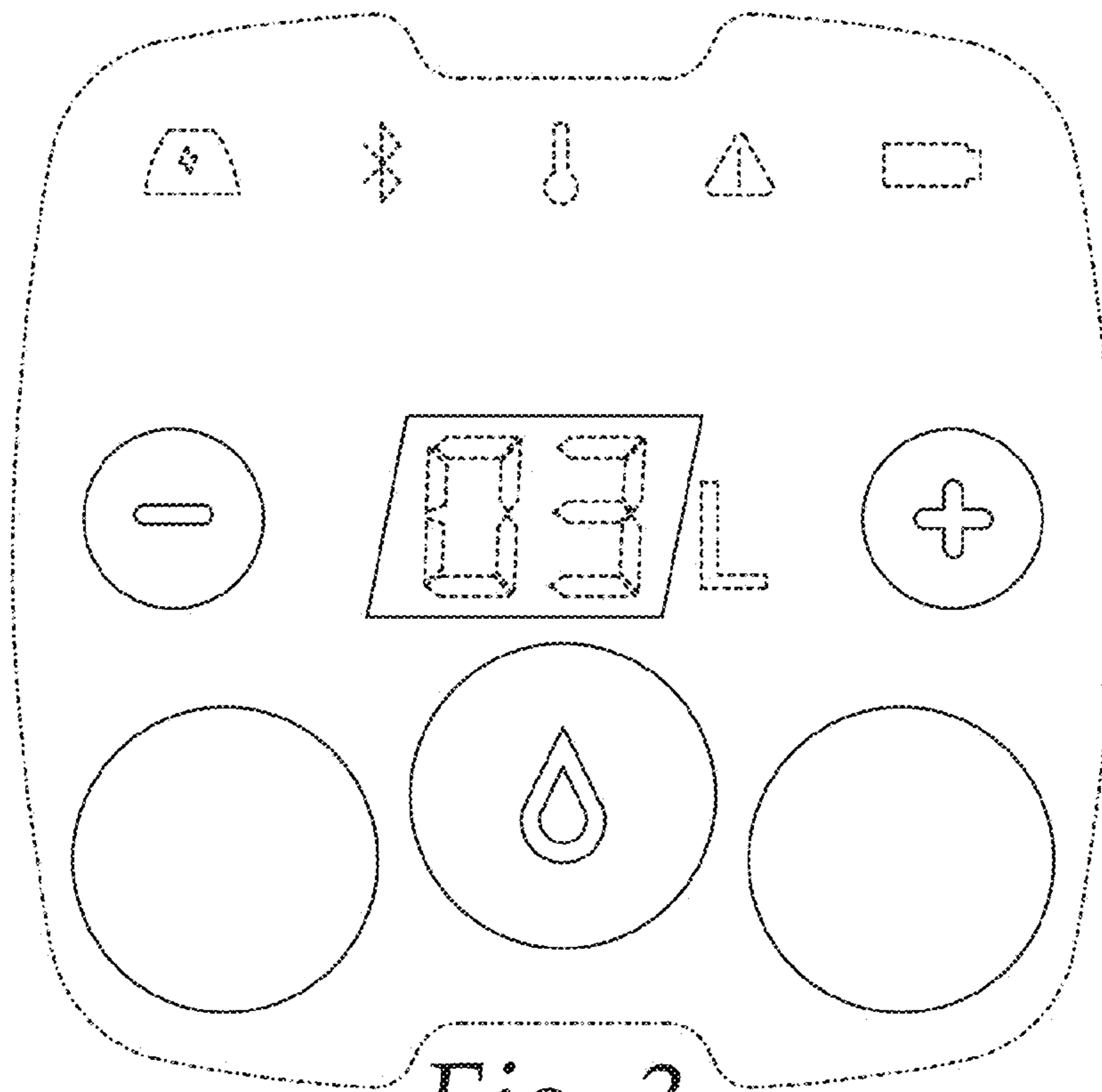

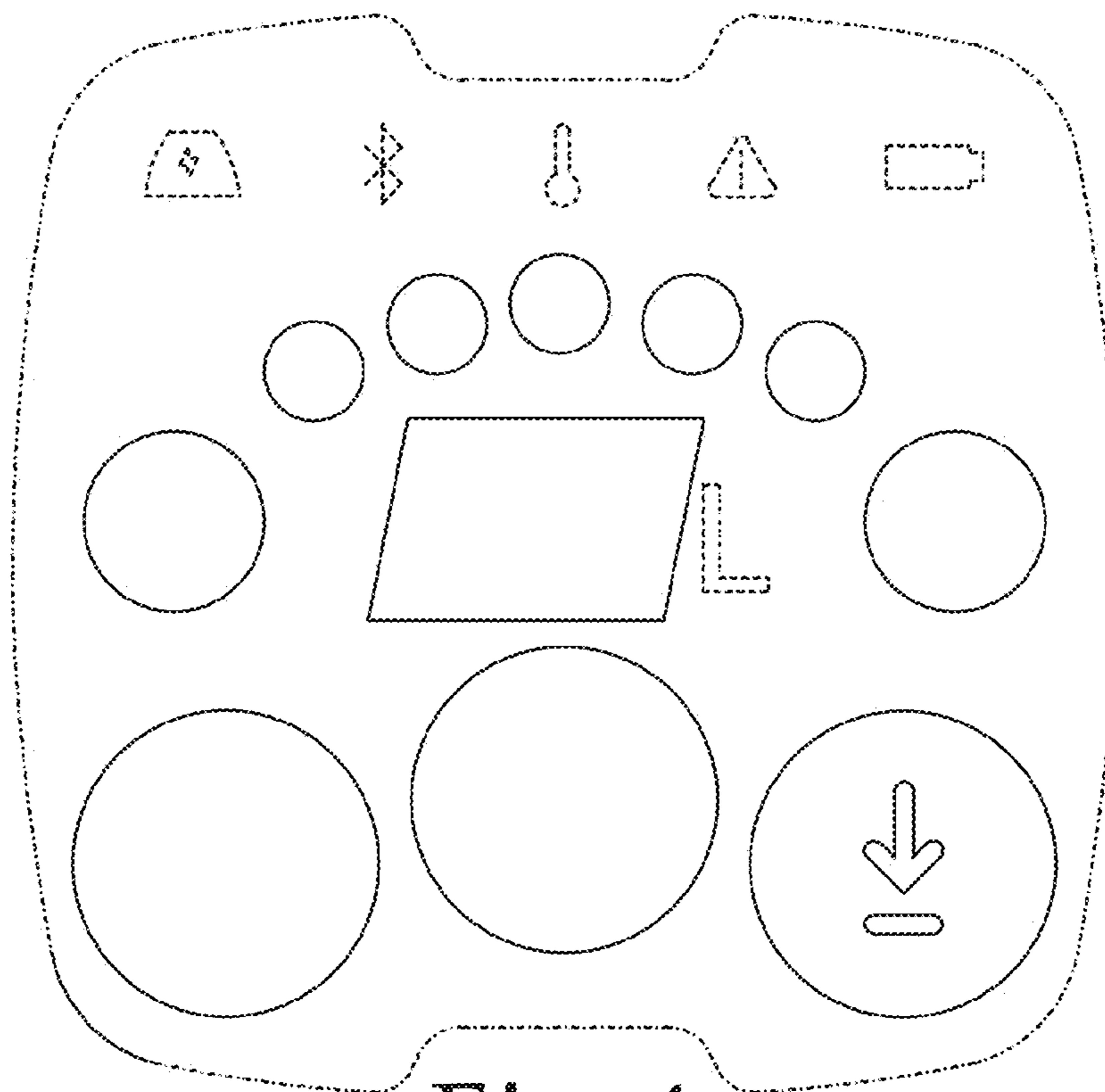
