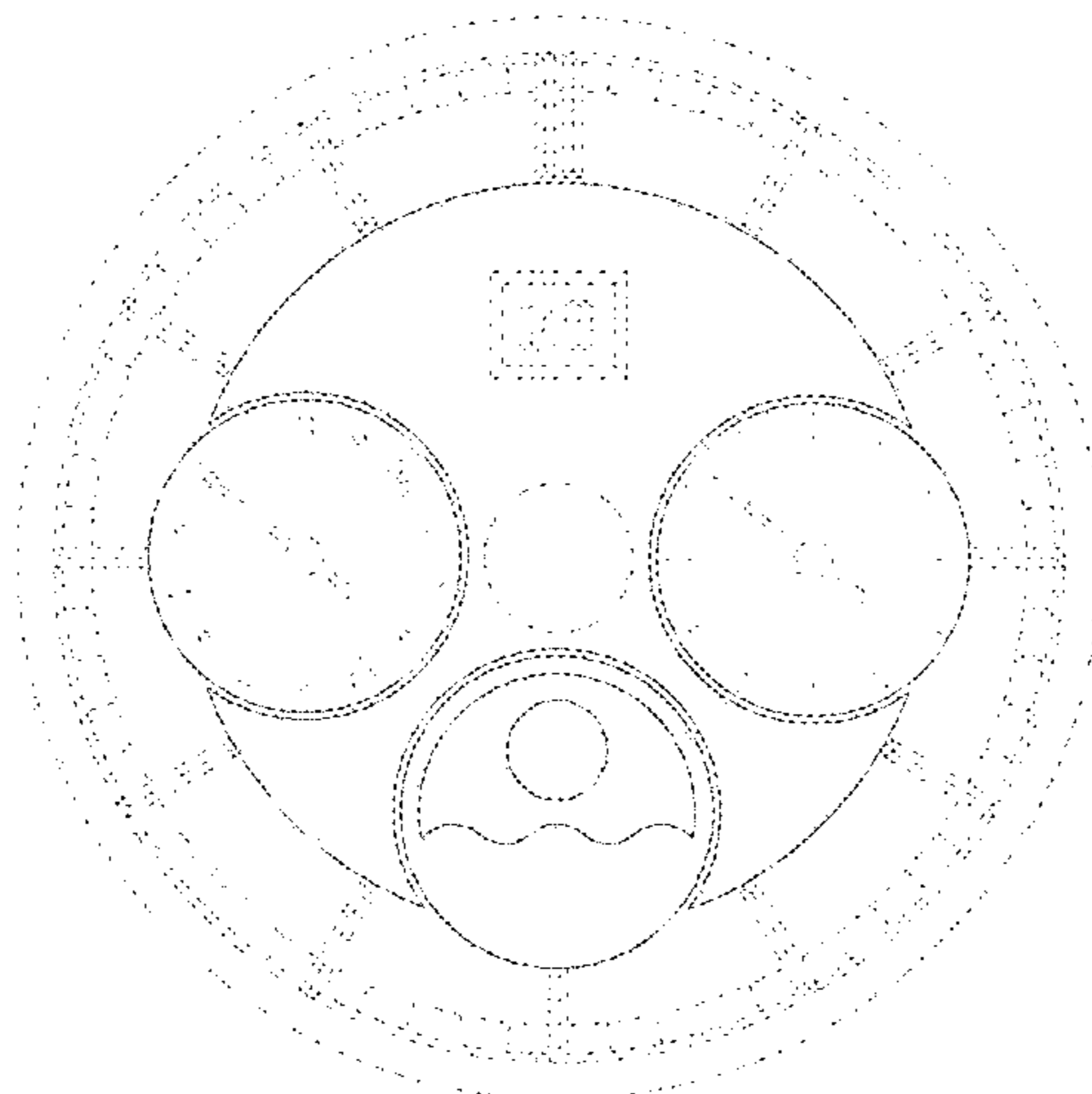
1. Display screen or portion thereof with graphical user interface
