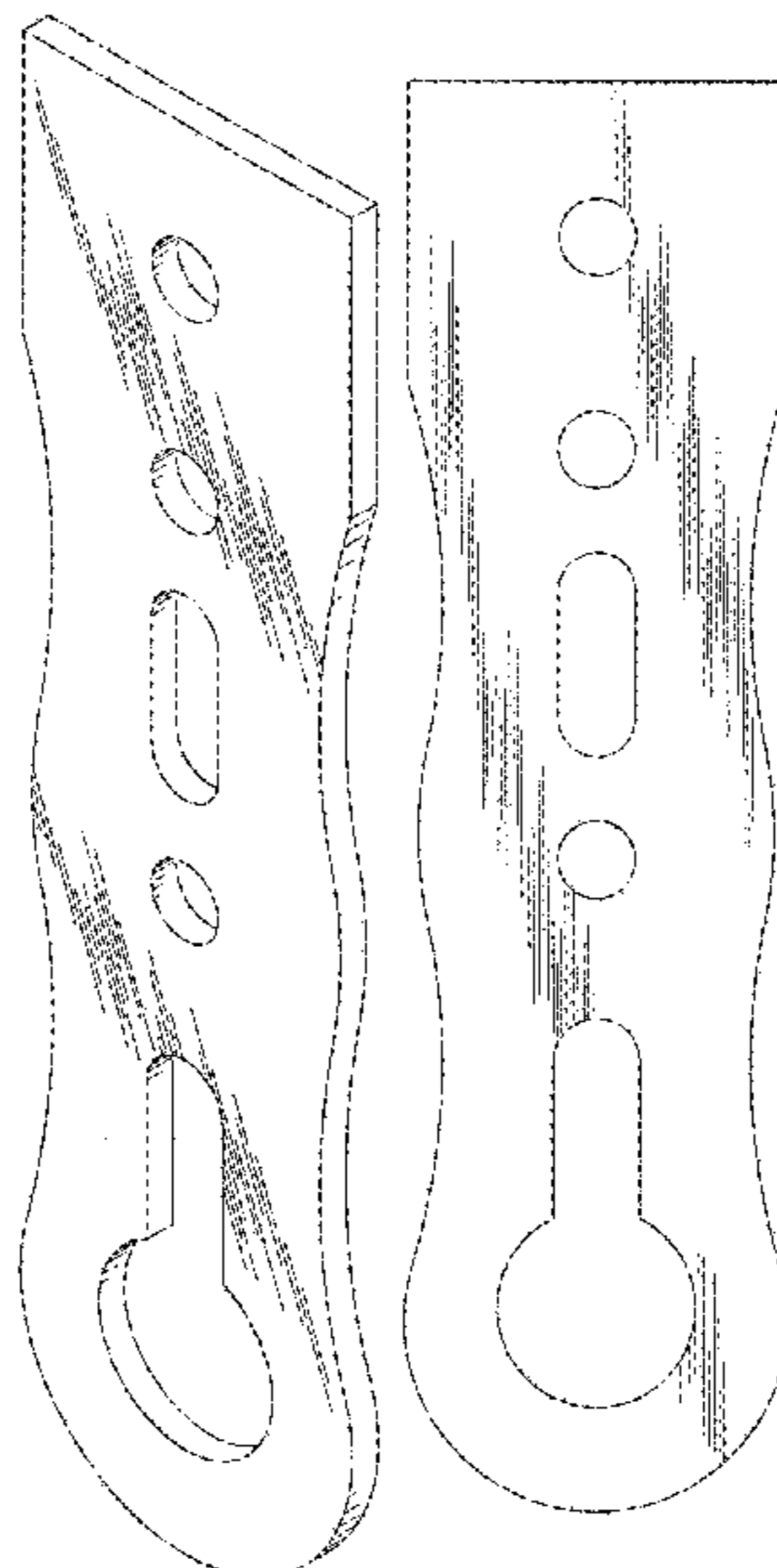
The ornamental design for a hammermill hammer, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a hammermill hammer; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a front elevation view thereof, the rear elevation view being a mirror image of the front elevation view; FIG. 4 is a left side elevation view thereof, the right side elevation view being a mirror image of the left side elevation view; FIG. 5 is a top elevation view thereof; and, FIG. 6 is a bottom elevation view thereof.

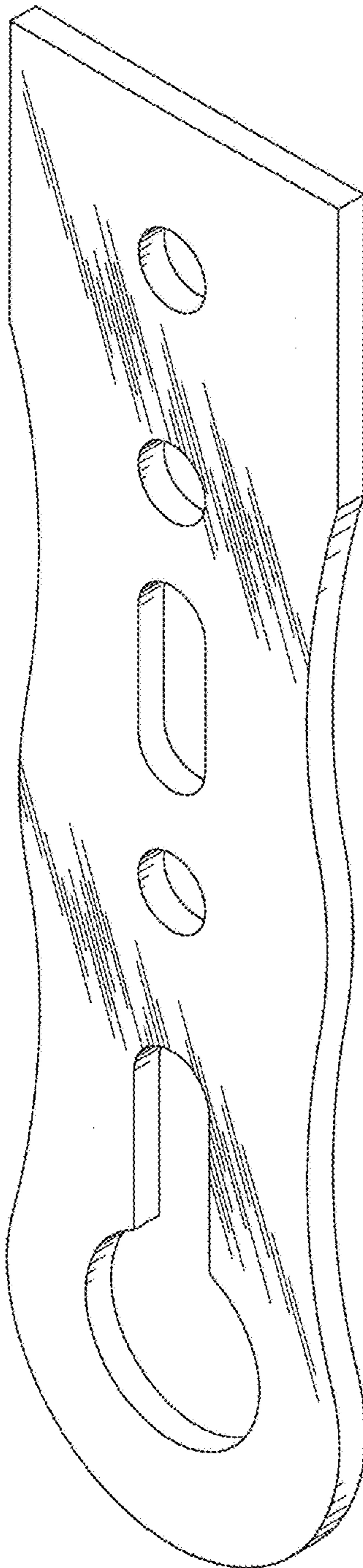

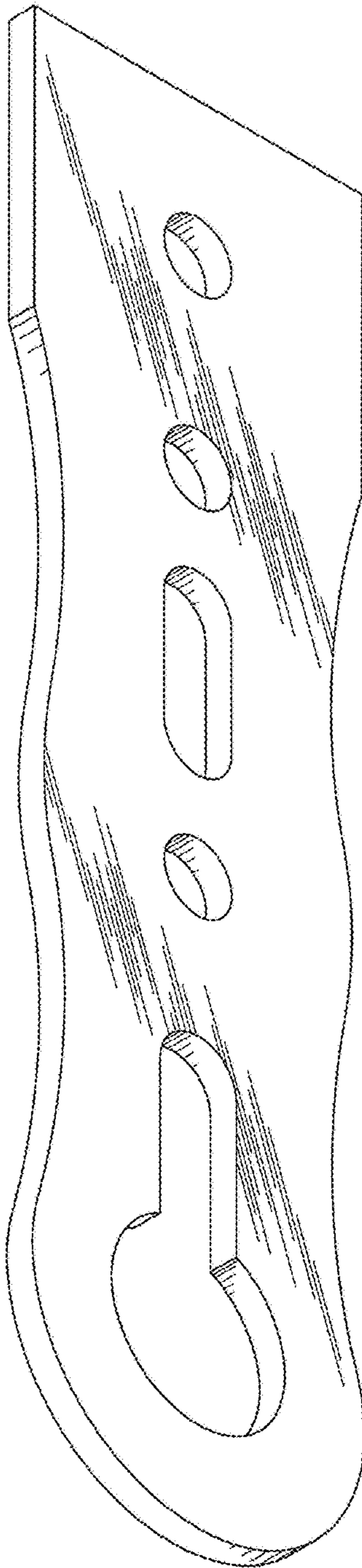

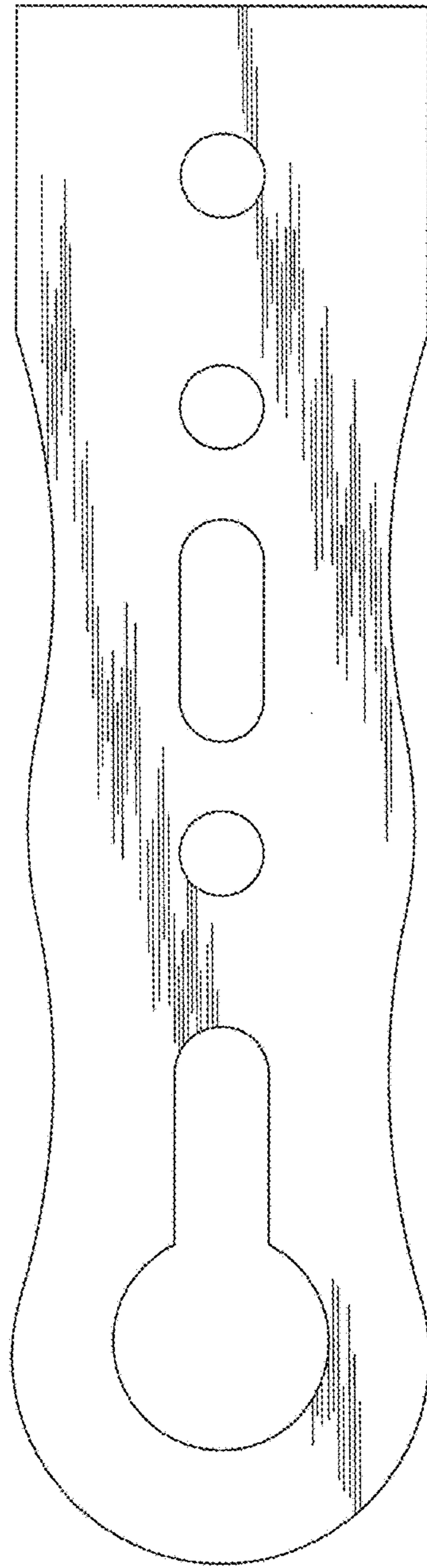

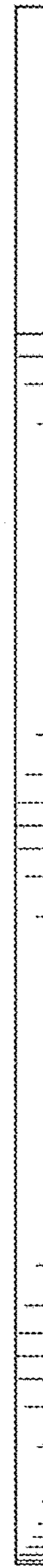
