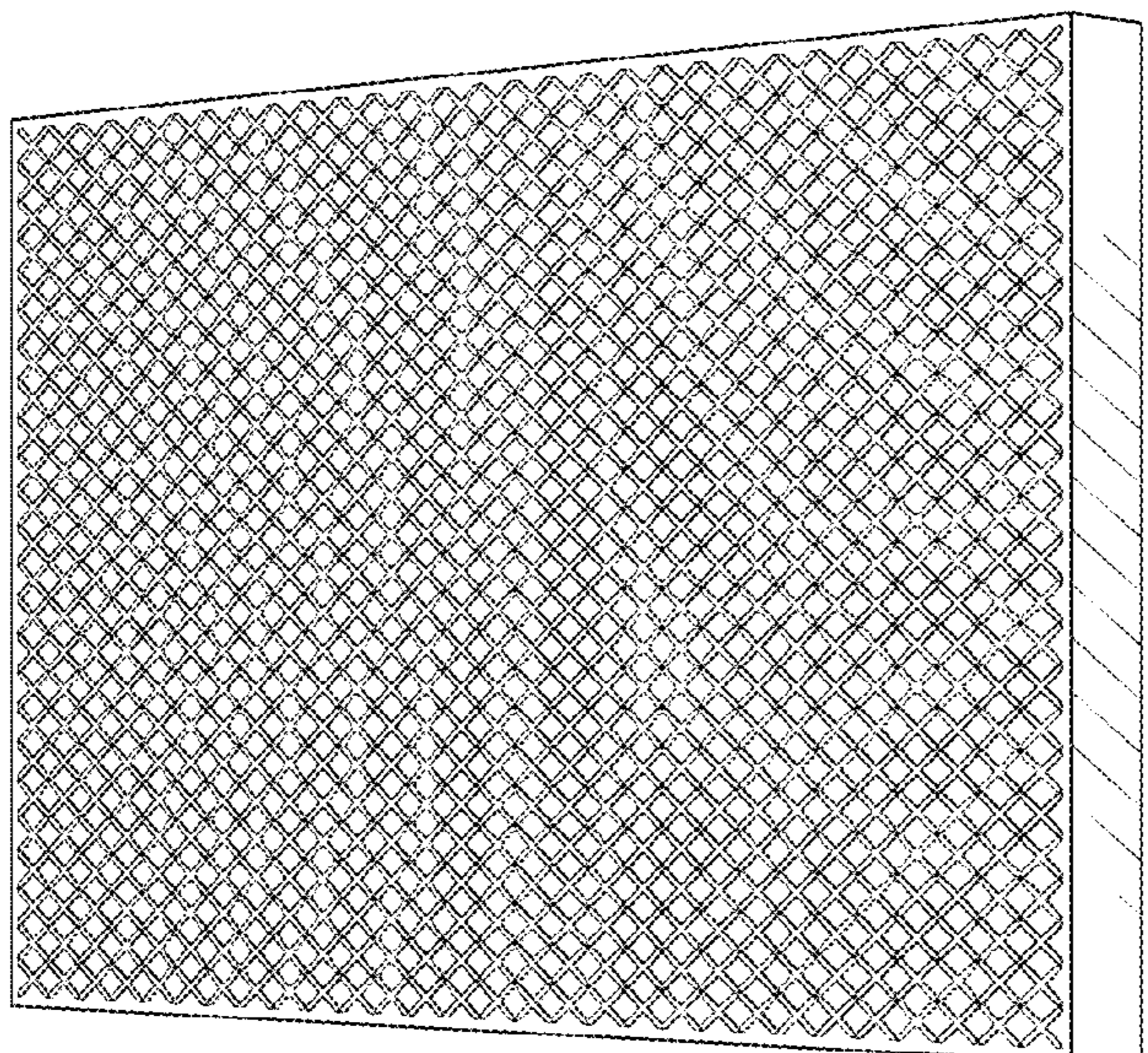

DESCRIPTION
FIG. 1 is a front elevation view of a canvas showing my new design;
FIG. 2 is a perspective view of the canvas of FIG. 1;
FIG. 3 is an enlarged right side elevation view of the canvas of FIG. 1;
FIG. 4 is an enlarged left side elevation view of the canvas of FIG. 1;
FIG. 5 is an enlarged top plan view of the canvas of FIG. 1;
FIG. 6 is an enlarged bottom plan view of the canvas of FIG. 1; and,
FIG. 7 is a rear elevation view of the canvas of FIG. 1.

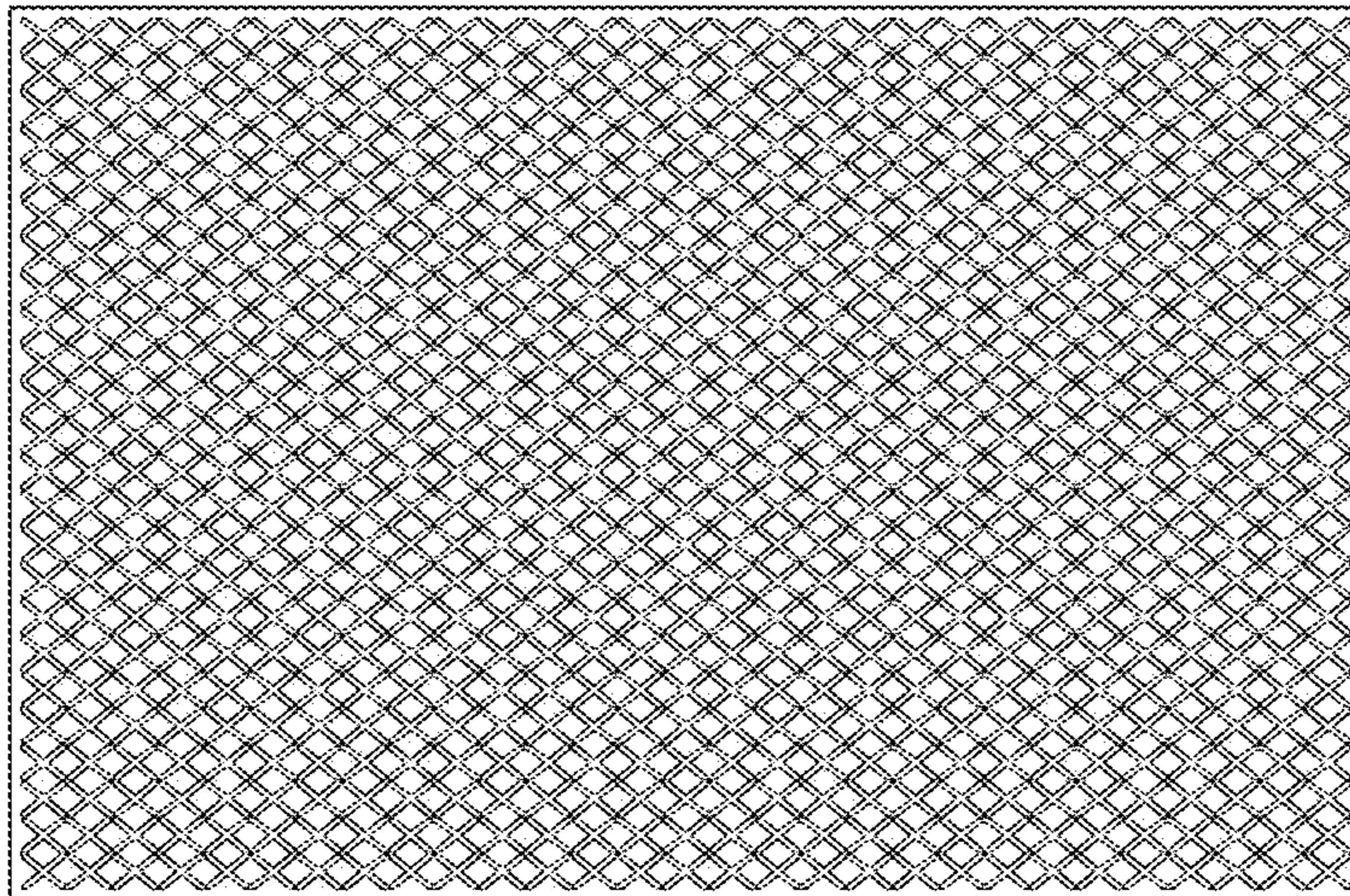

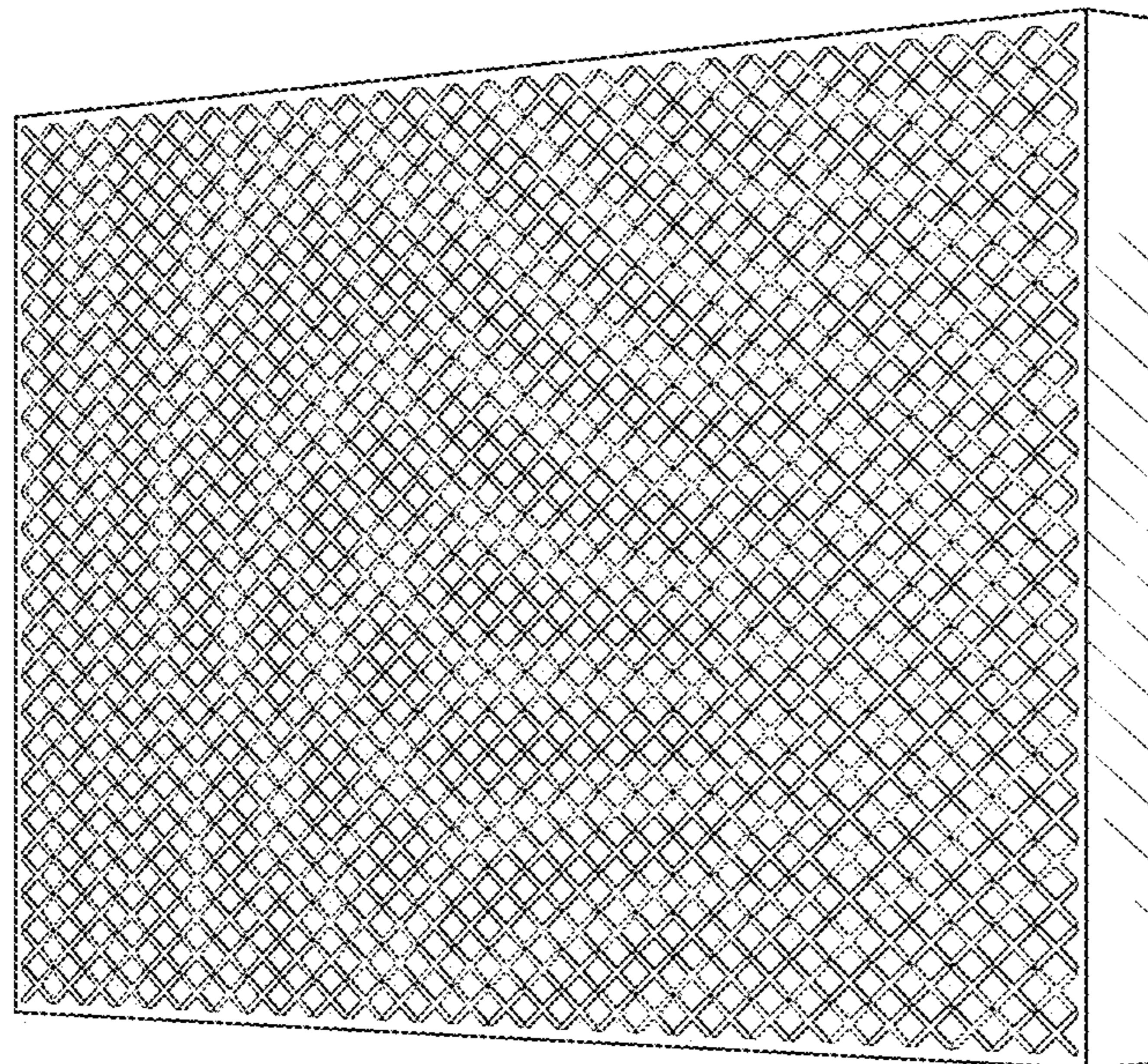

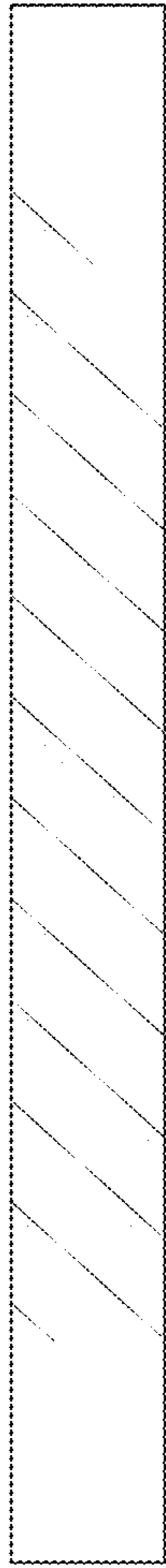

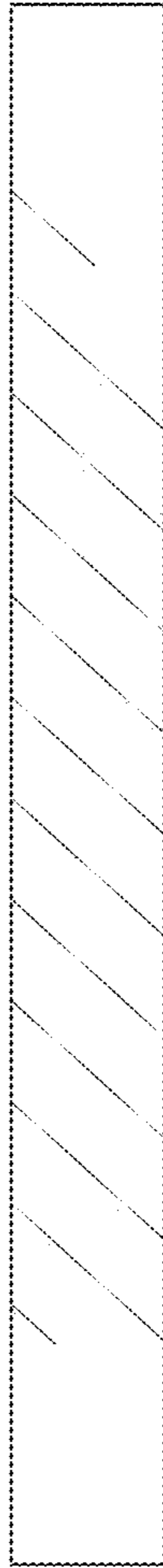

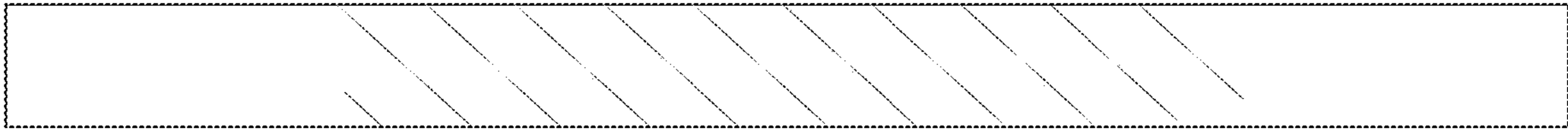

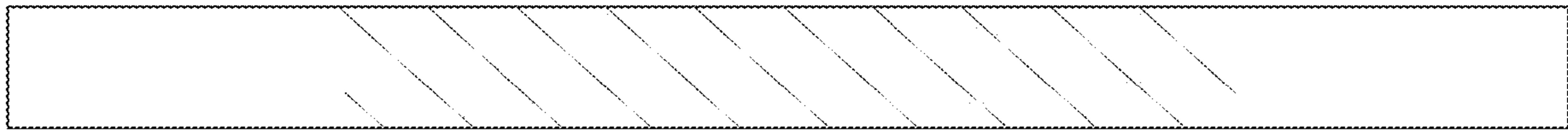

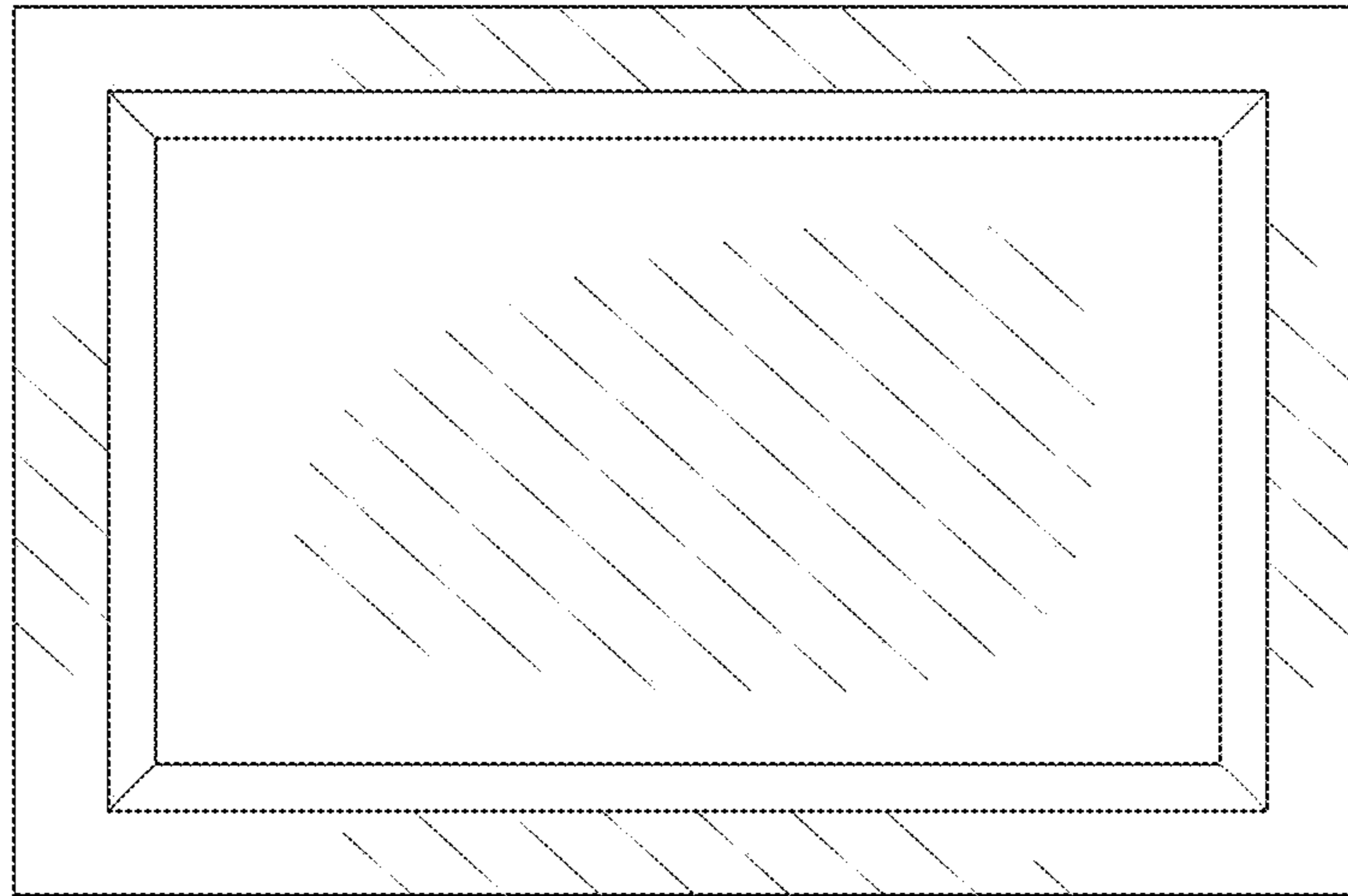
