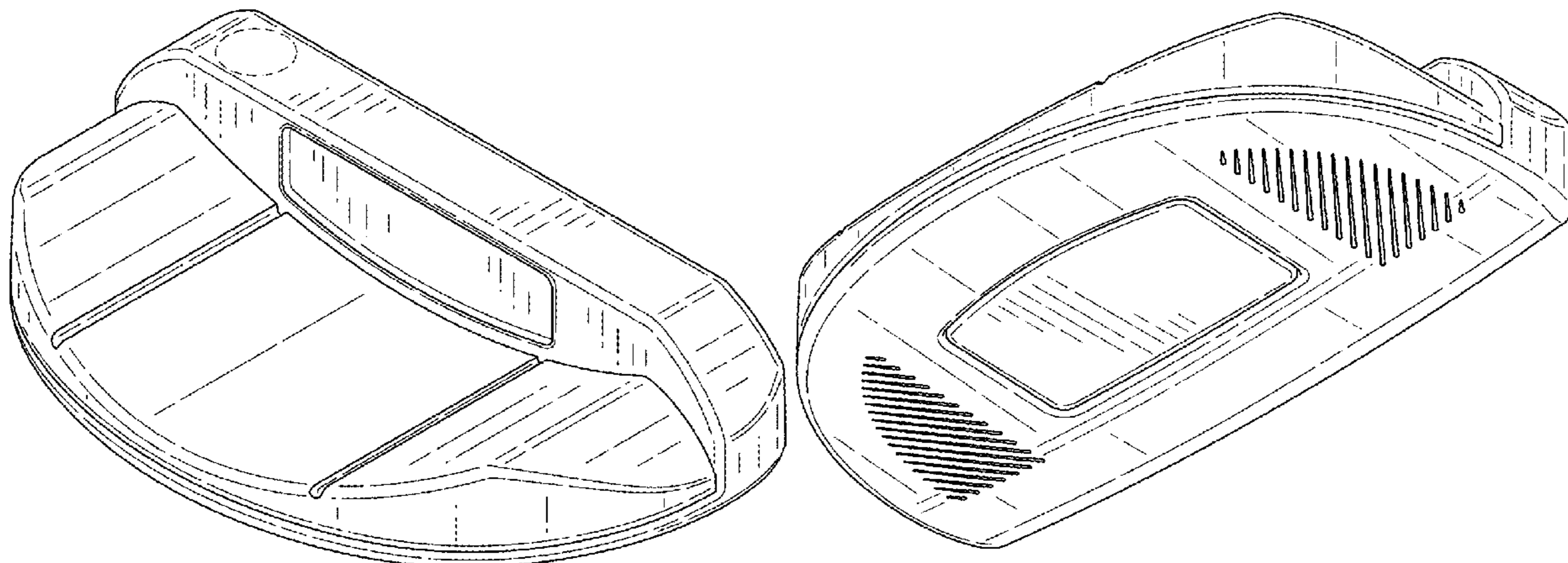
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a golf club head; FIG. 2 is a bottom perspective view of the golf club head of FIG. 1; FIG. 3 is a top view of the golf club head of FIG. 1; FIG. 4 is a bottom view of the golf club head of FIG. 1; FIG. 5 is a front view of the golf club head of FIG. 1; FIG. 6 is a rear view of the golf club head of FIG. 1; FIG. 7 is a toe side view of the golf club head of FIG. 1; and, FIG. 8 is a heel side view of the golf club head of FIG. 1. The broken lines in the figures show portions of golf club head that form no part of the claimed design.

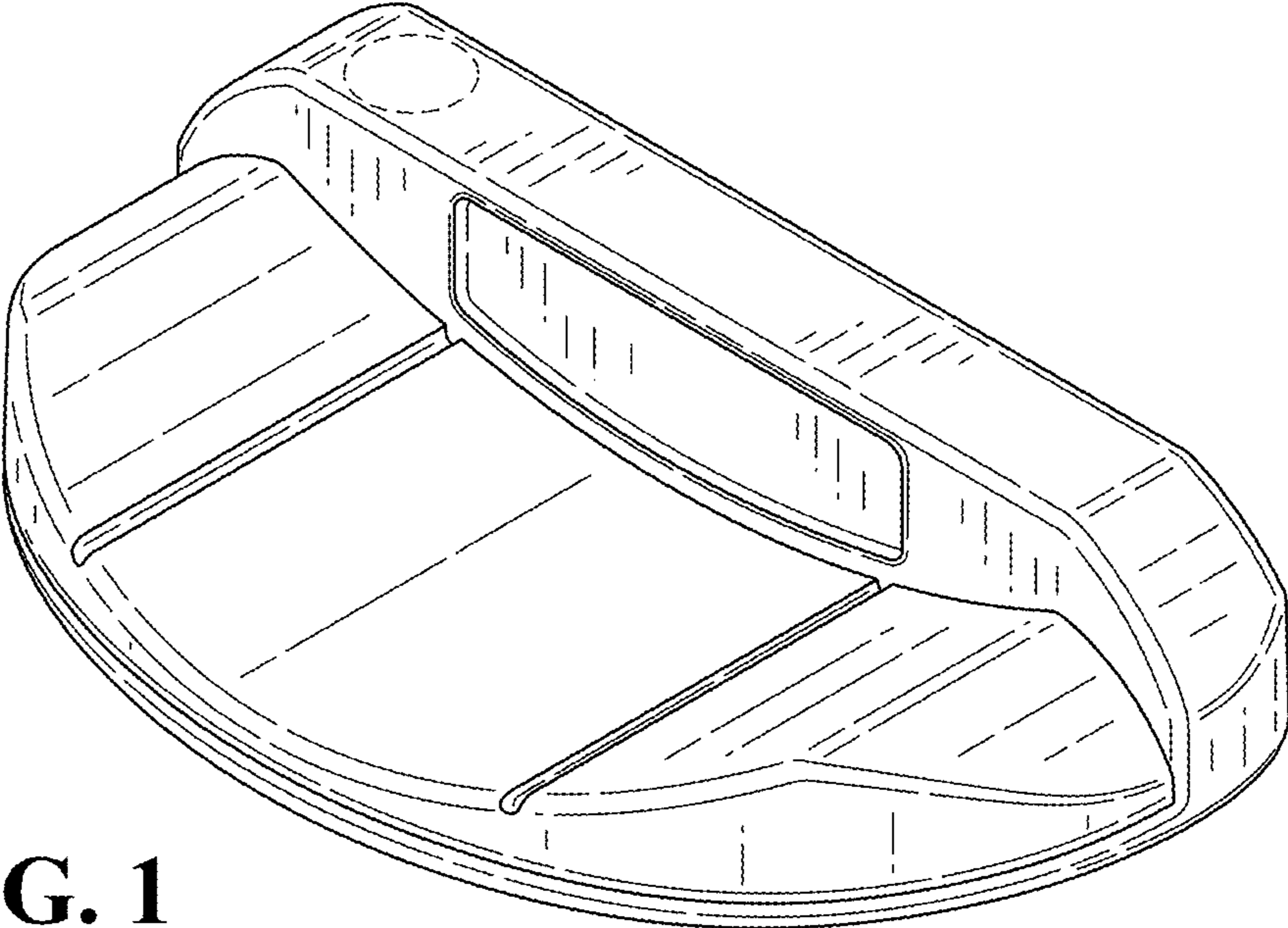

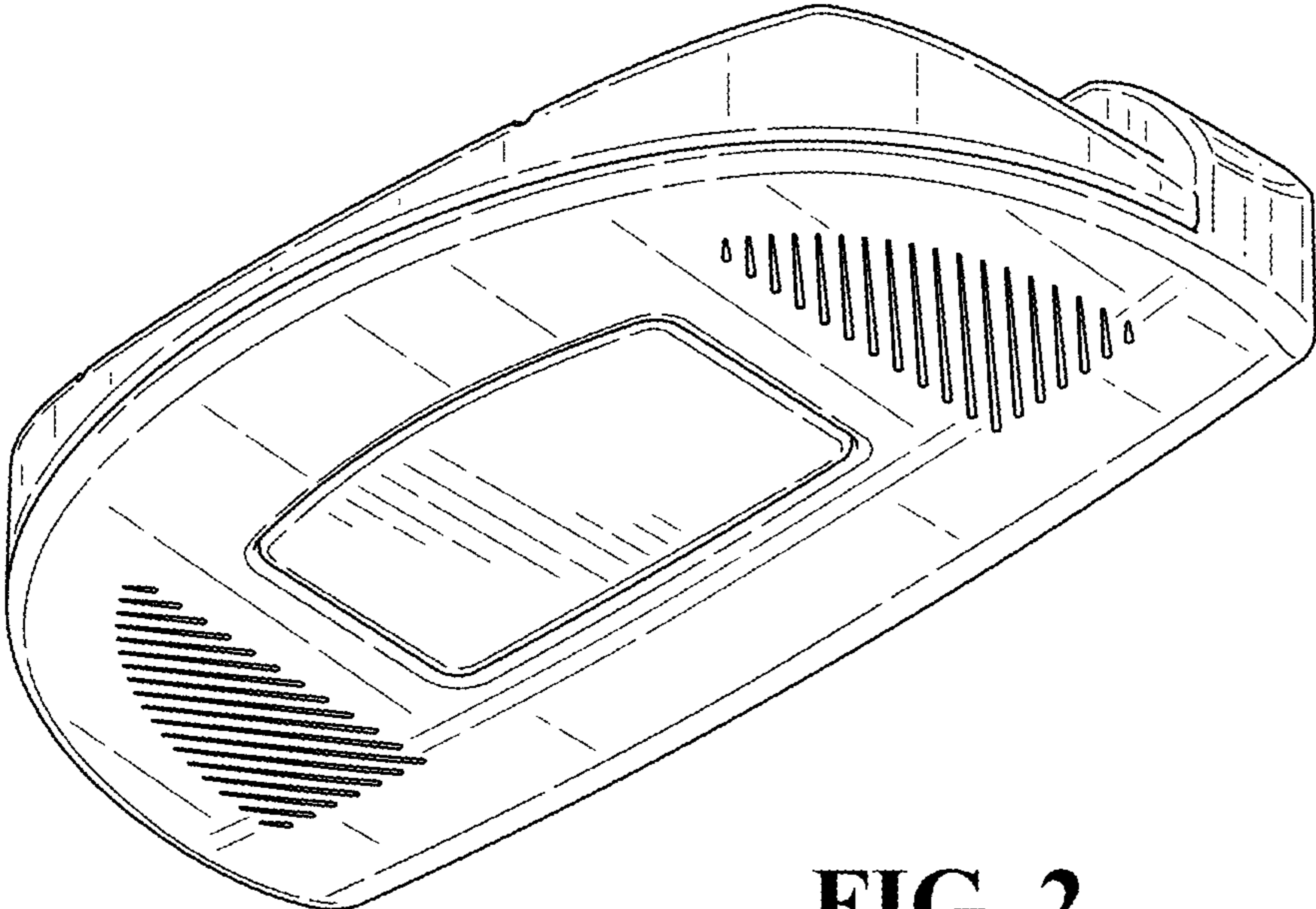

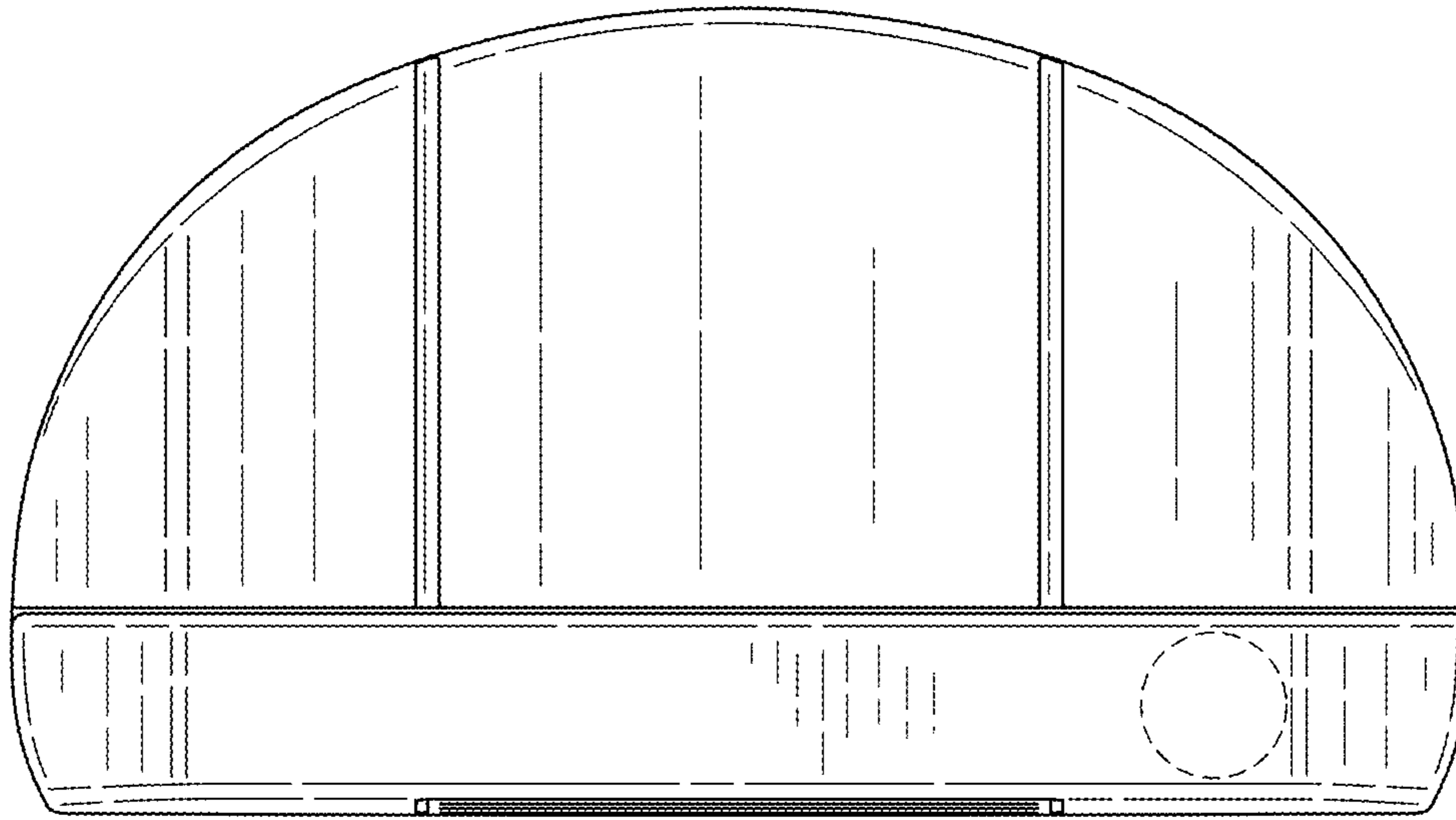

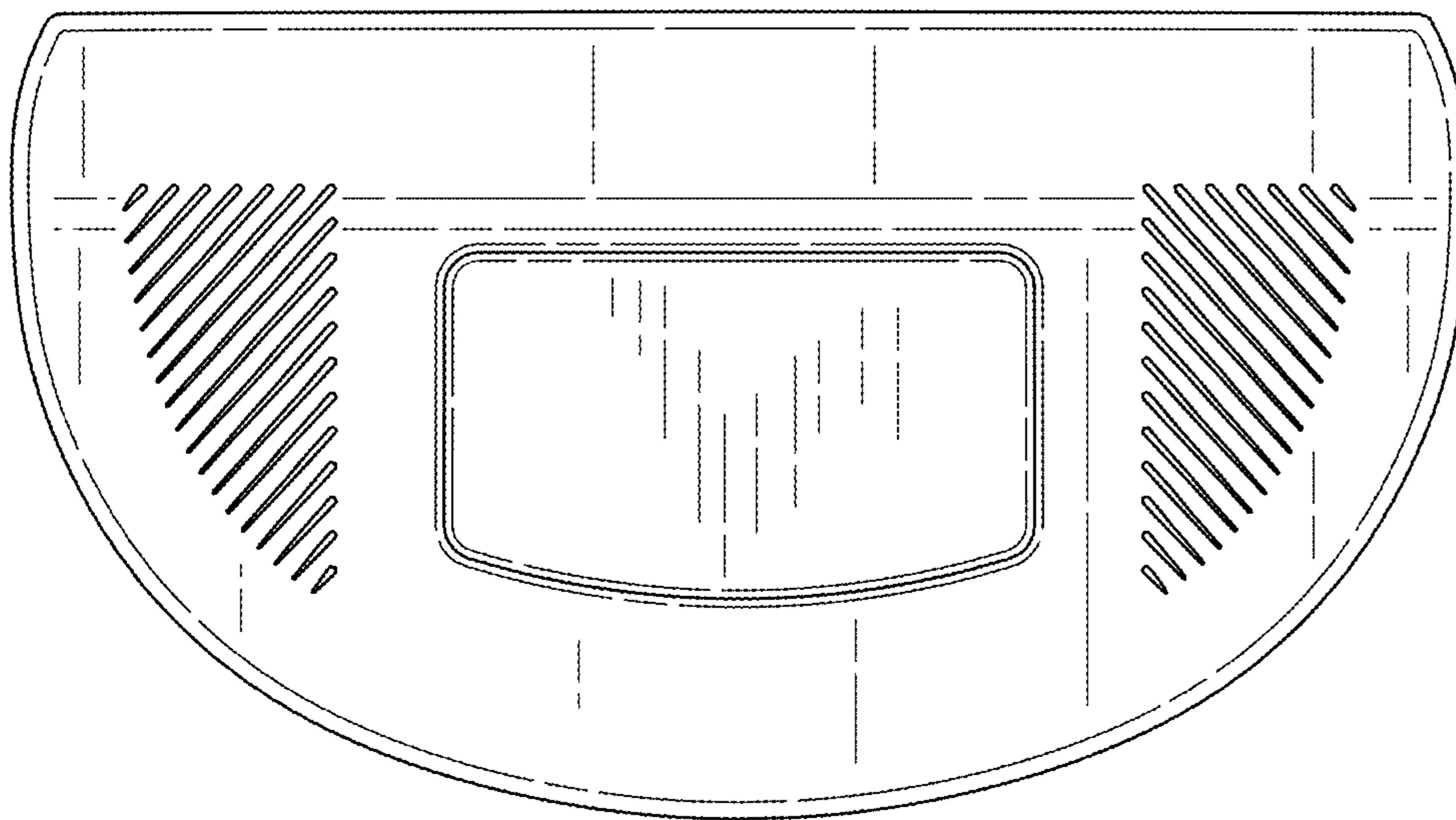

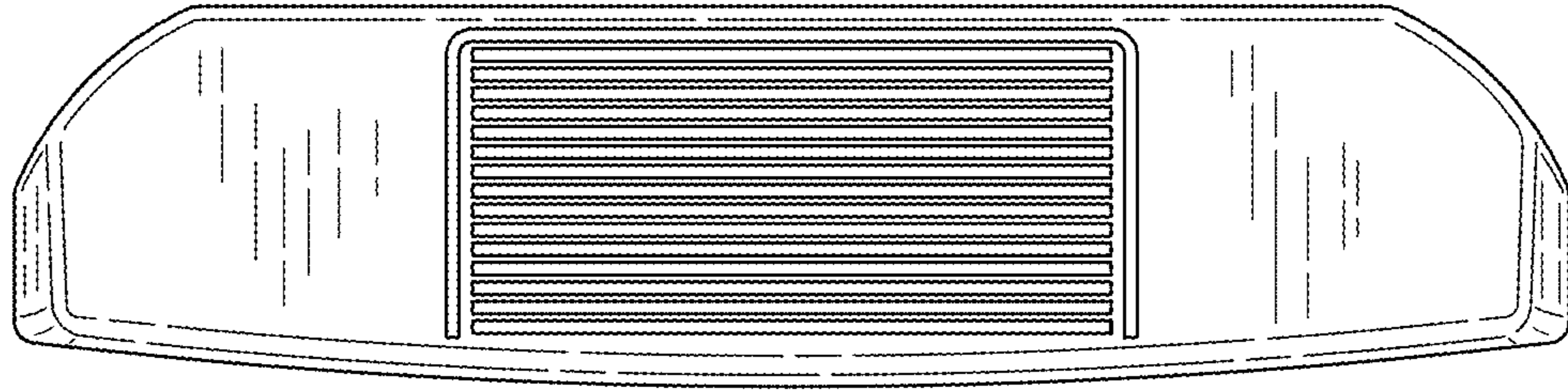

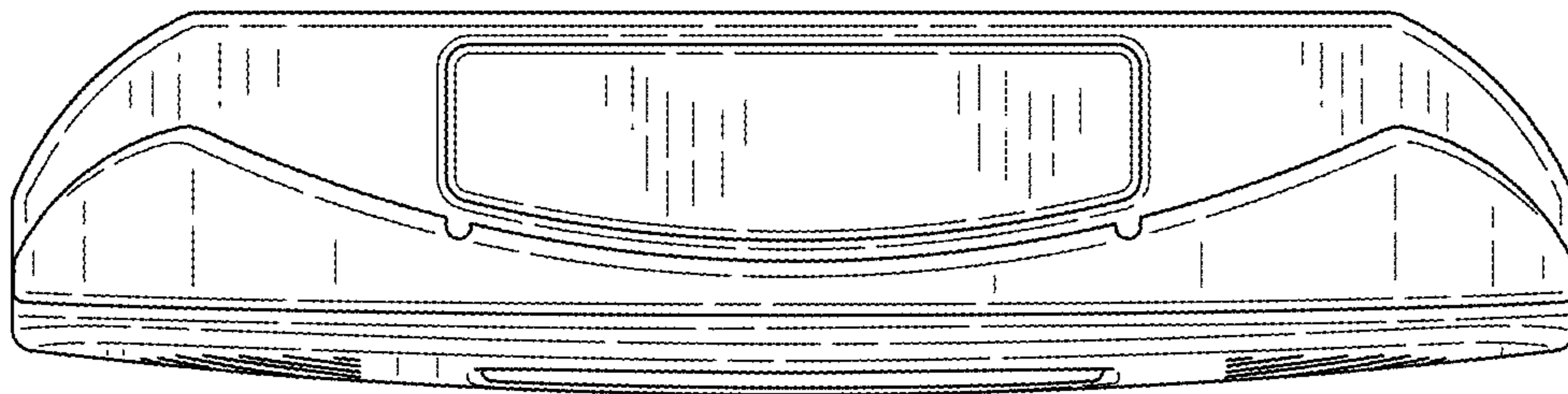

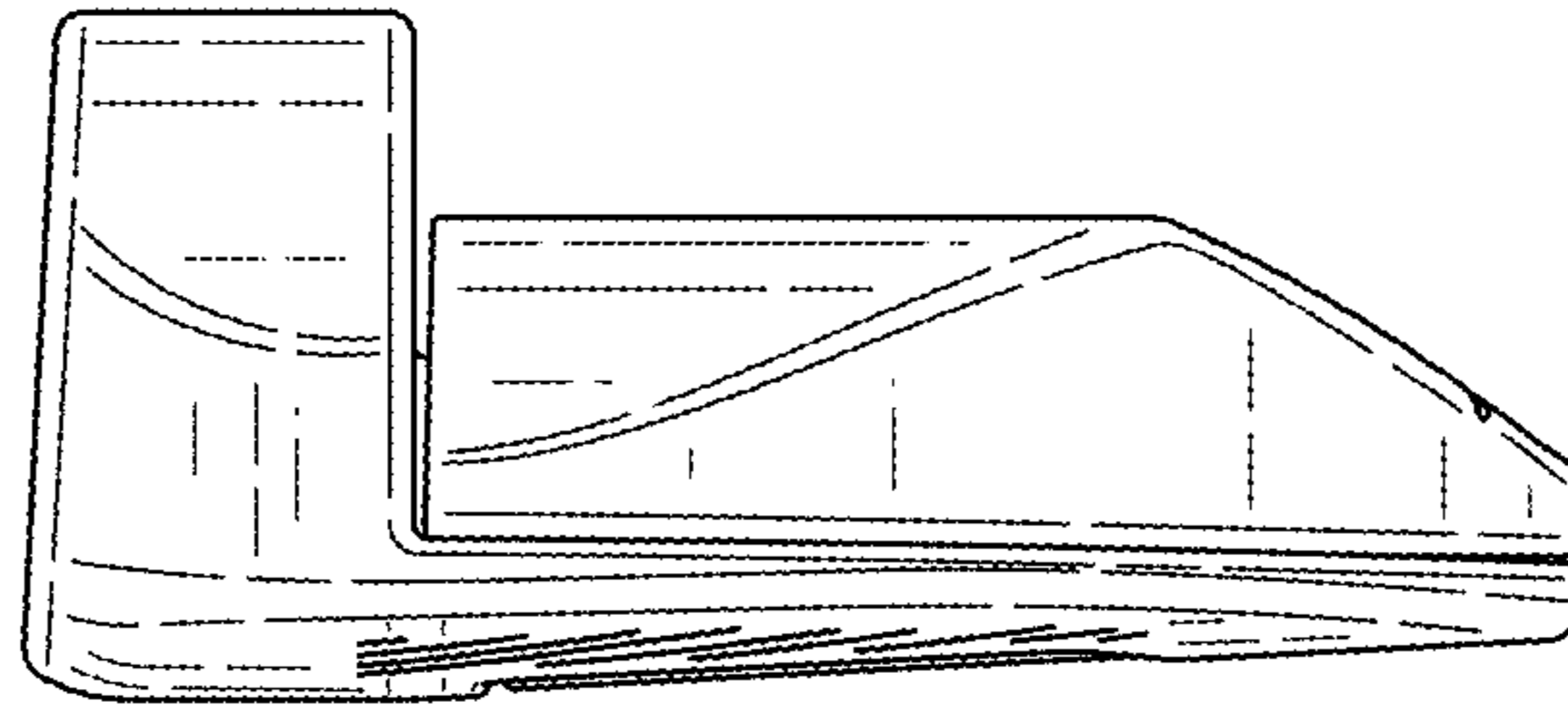

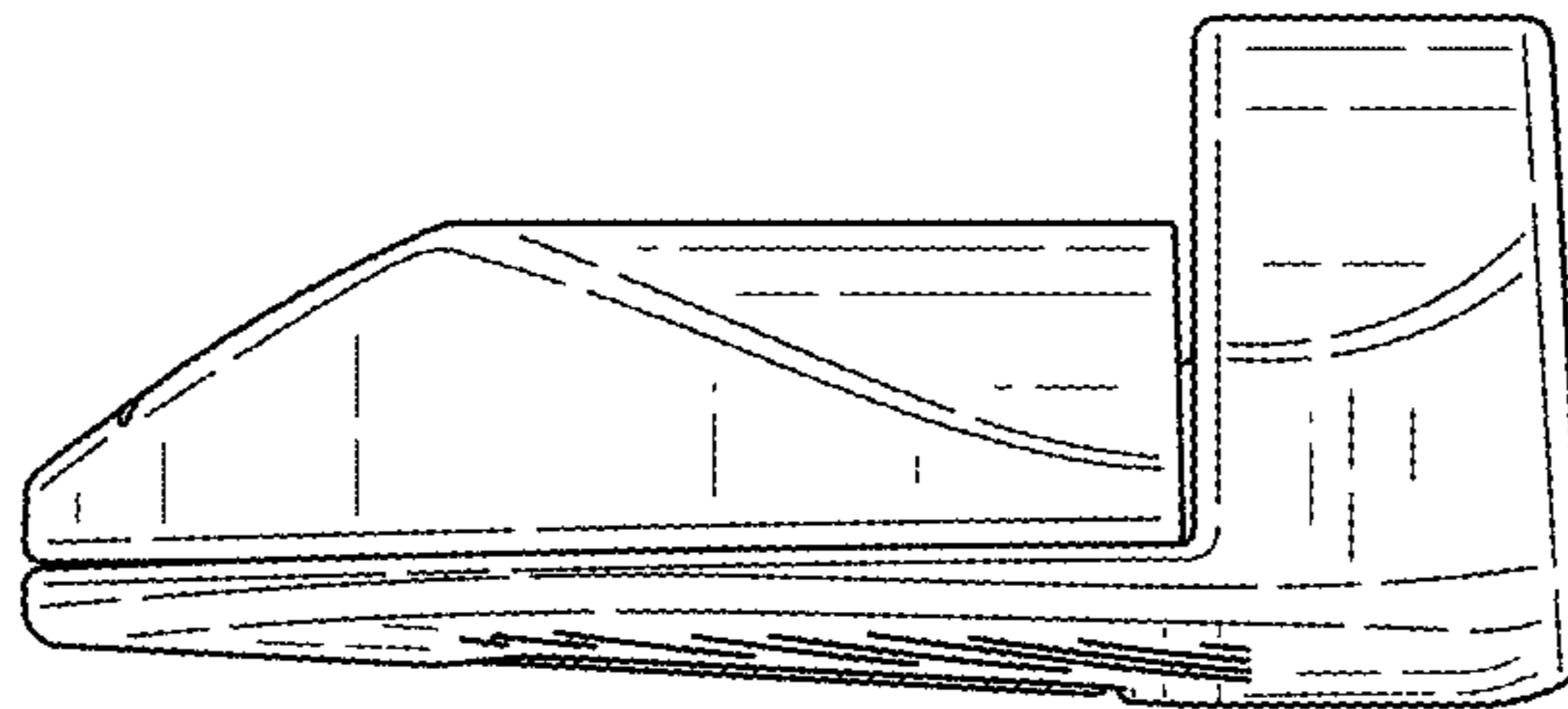
