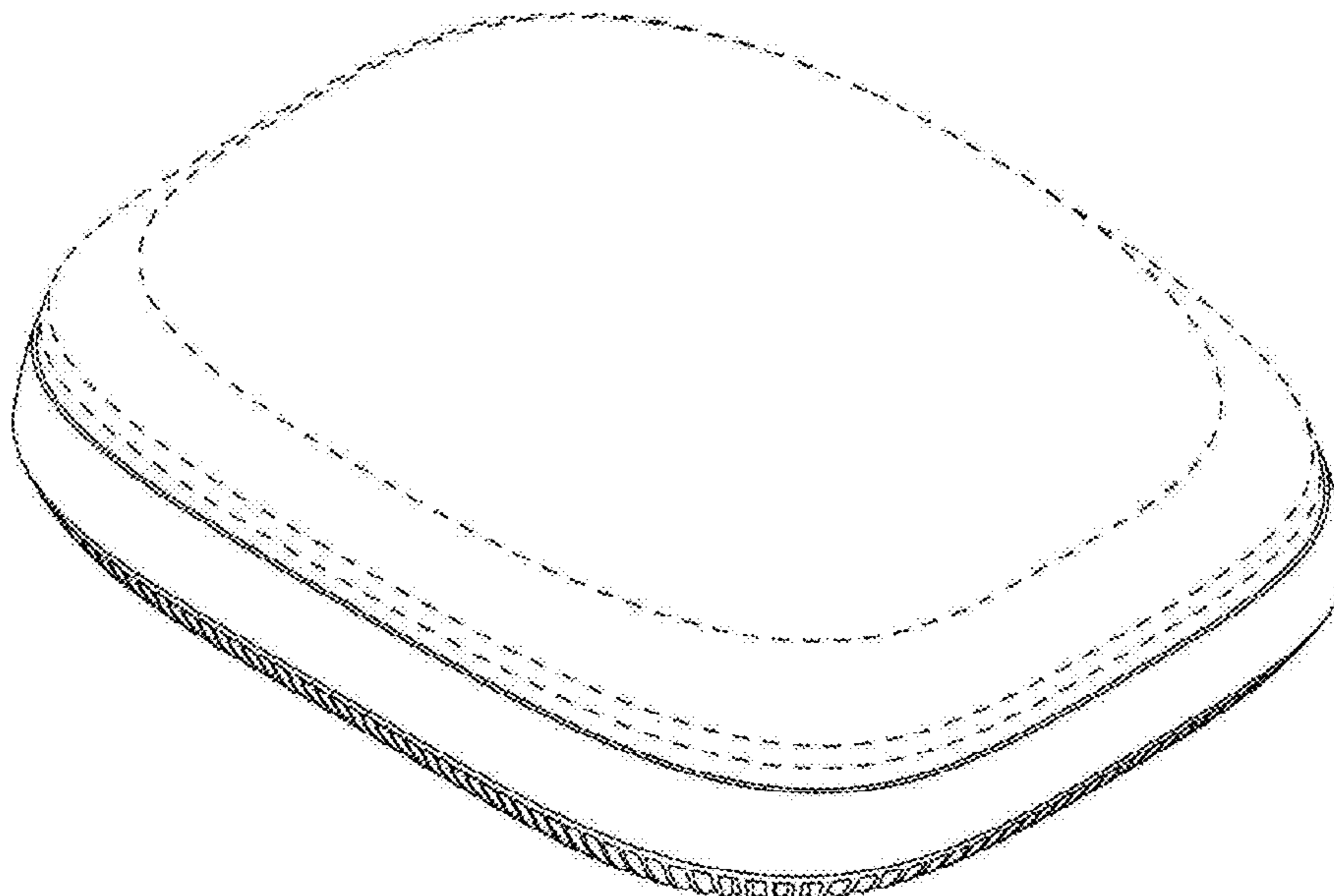
The broken lines in the drawings illustrate portions of the air conditioning apparatus which form no part of the claimed design.

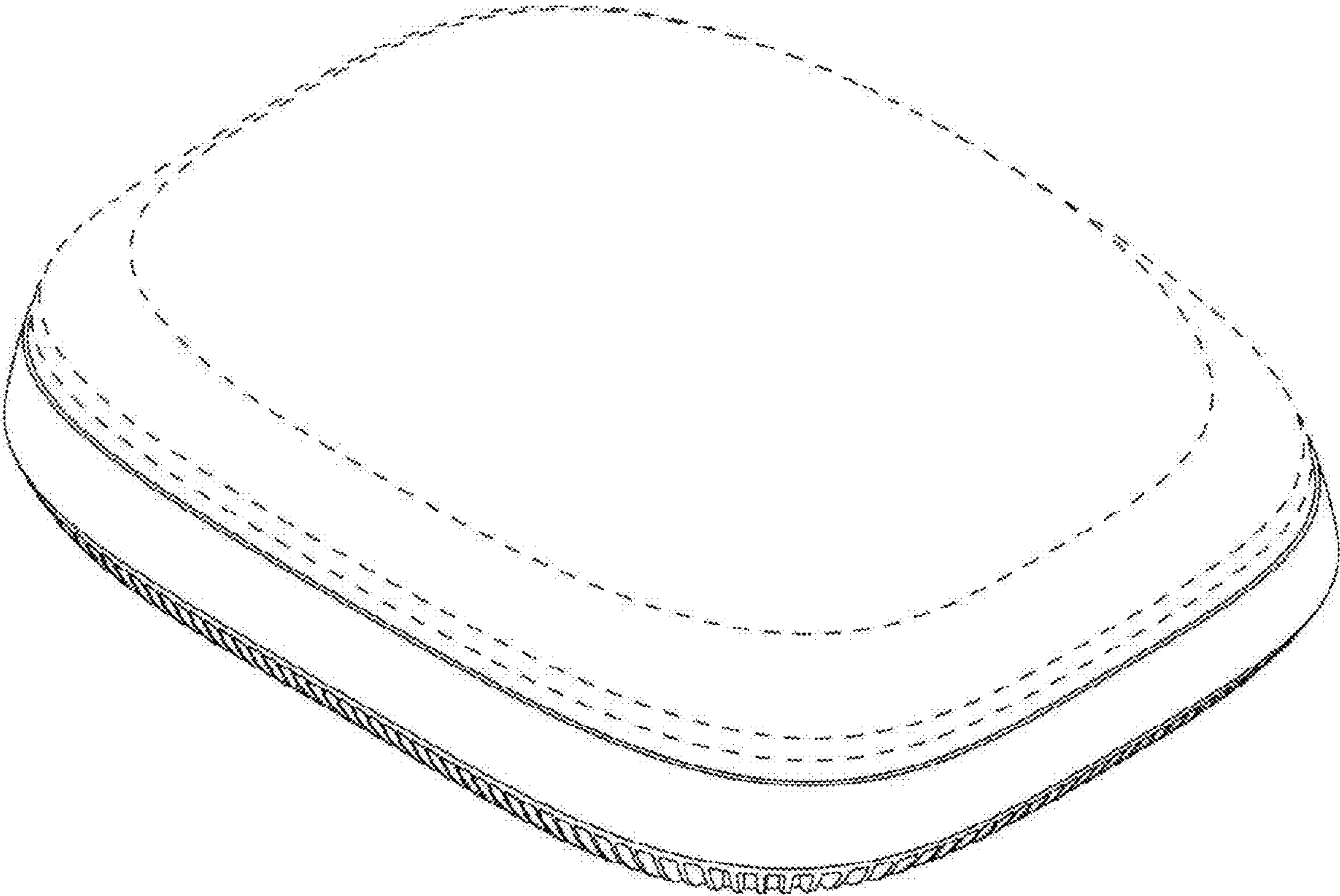

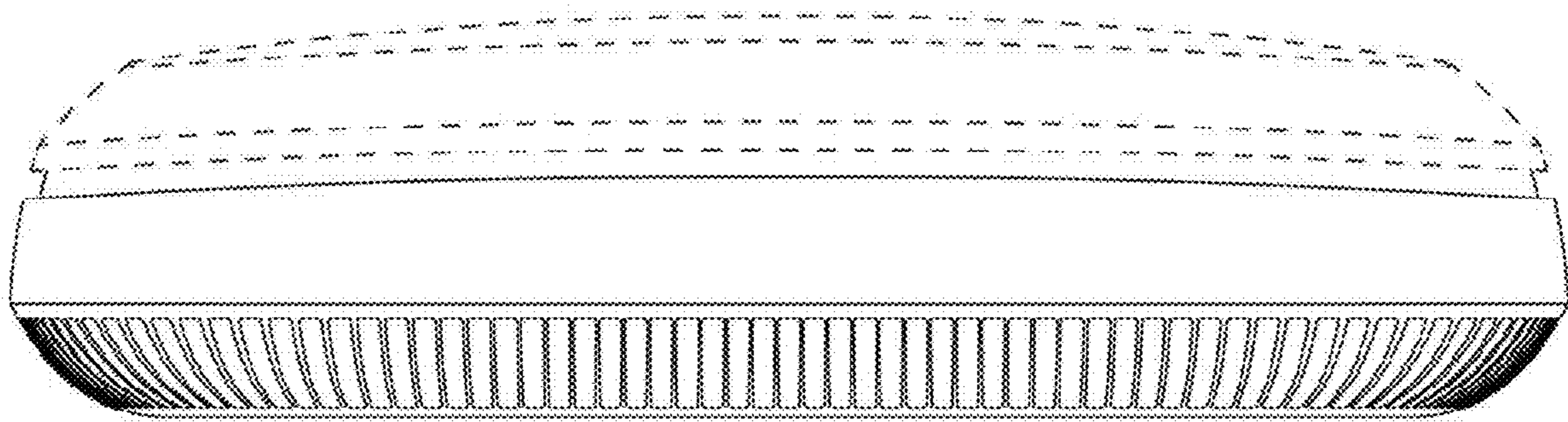
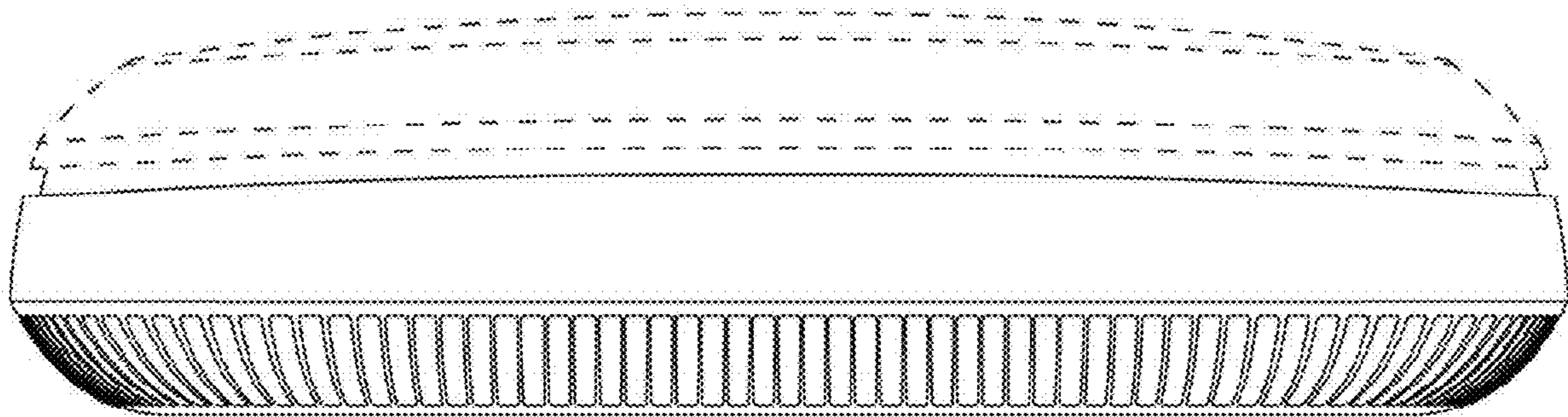

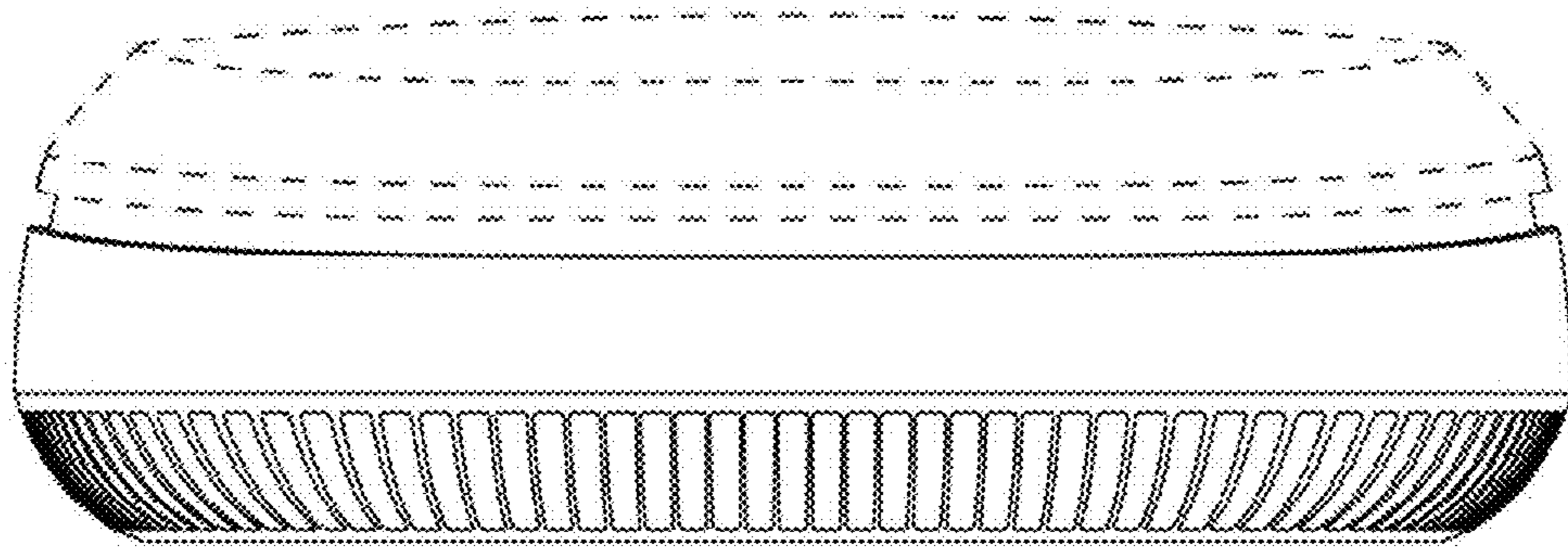
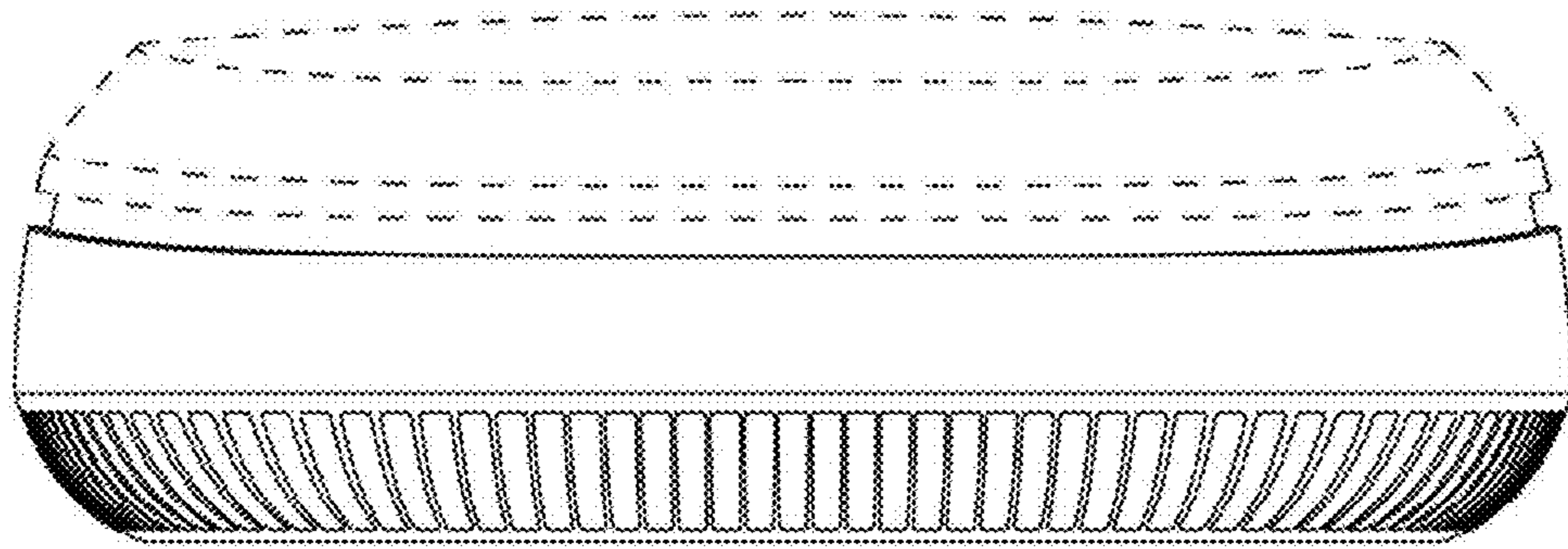

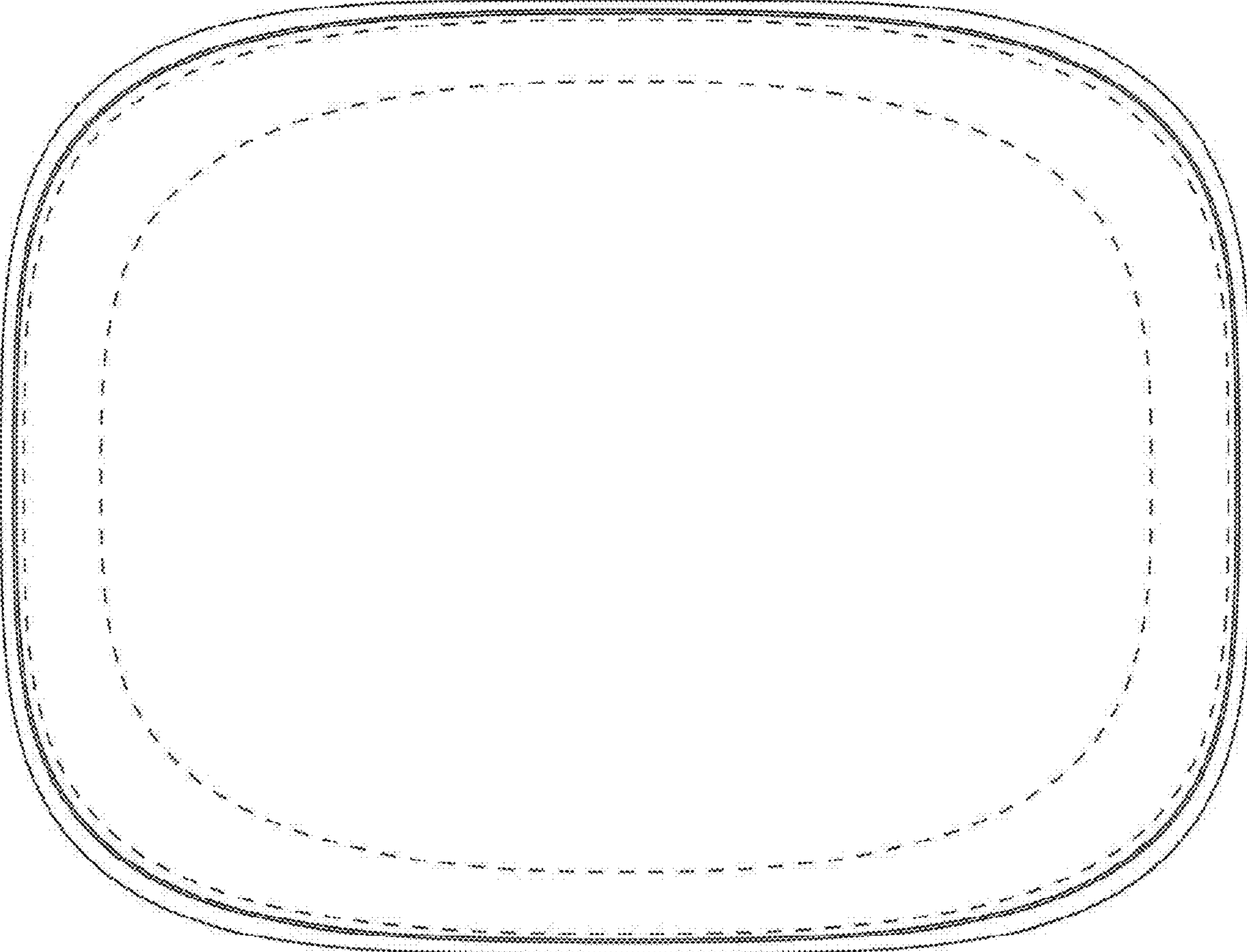
