DESCRIPTION

FIG. 1 is a perspective view of a medical thread according to the present invention.
FIG. 2 is a front view thereof;

FIG. 6 is a top plan view thereof,
FIG. 7 is a bottom view thereof; and,

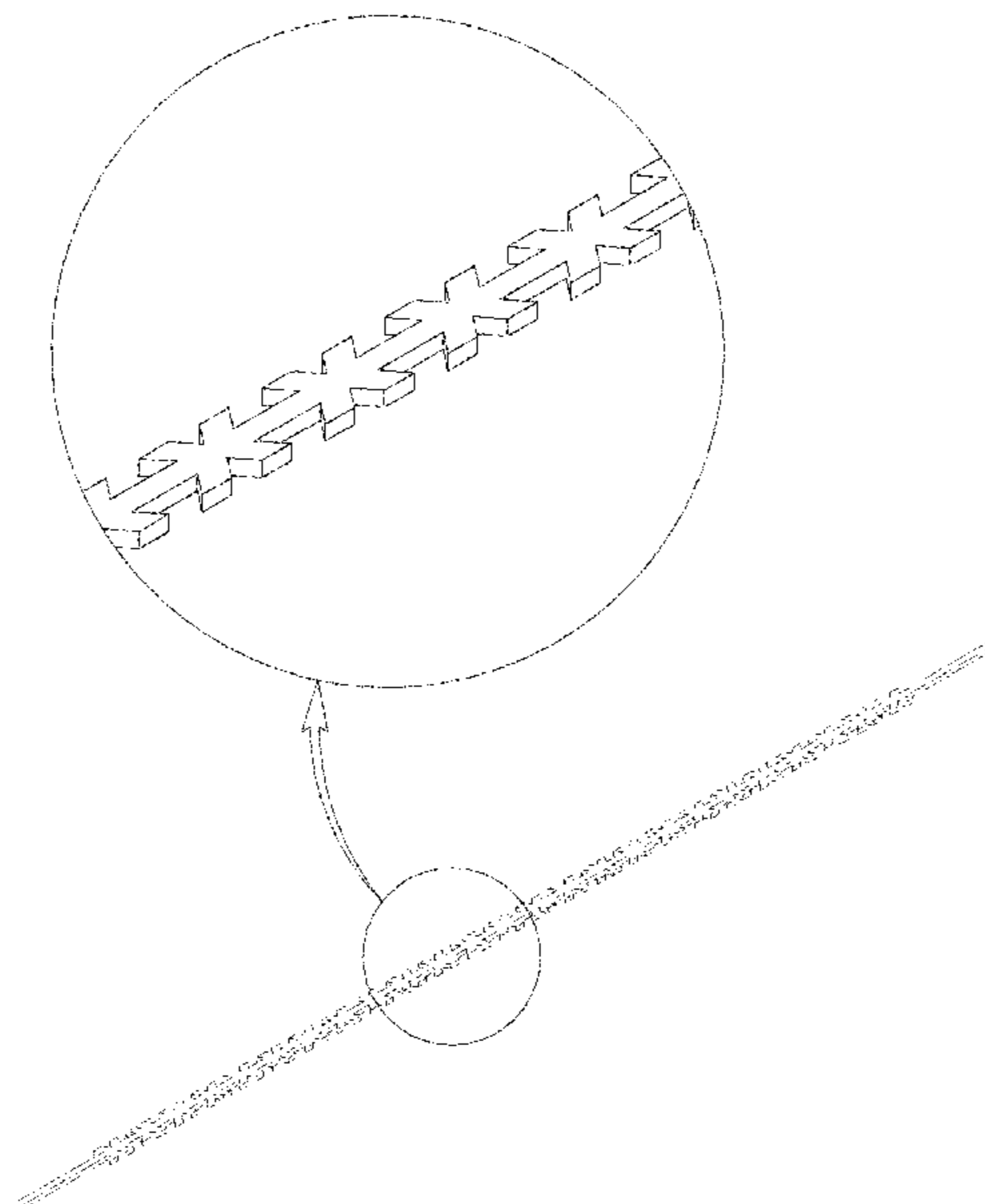

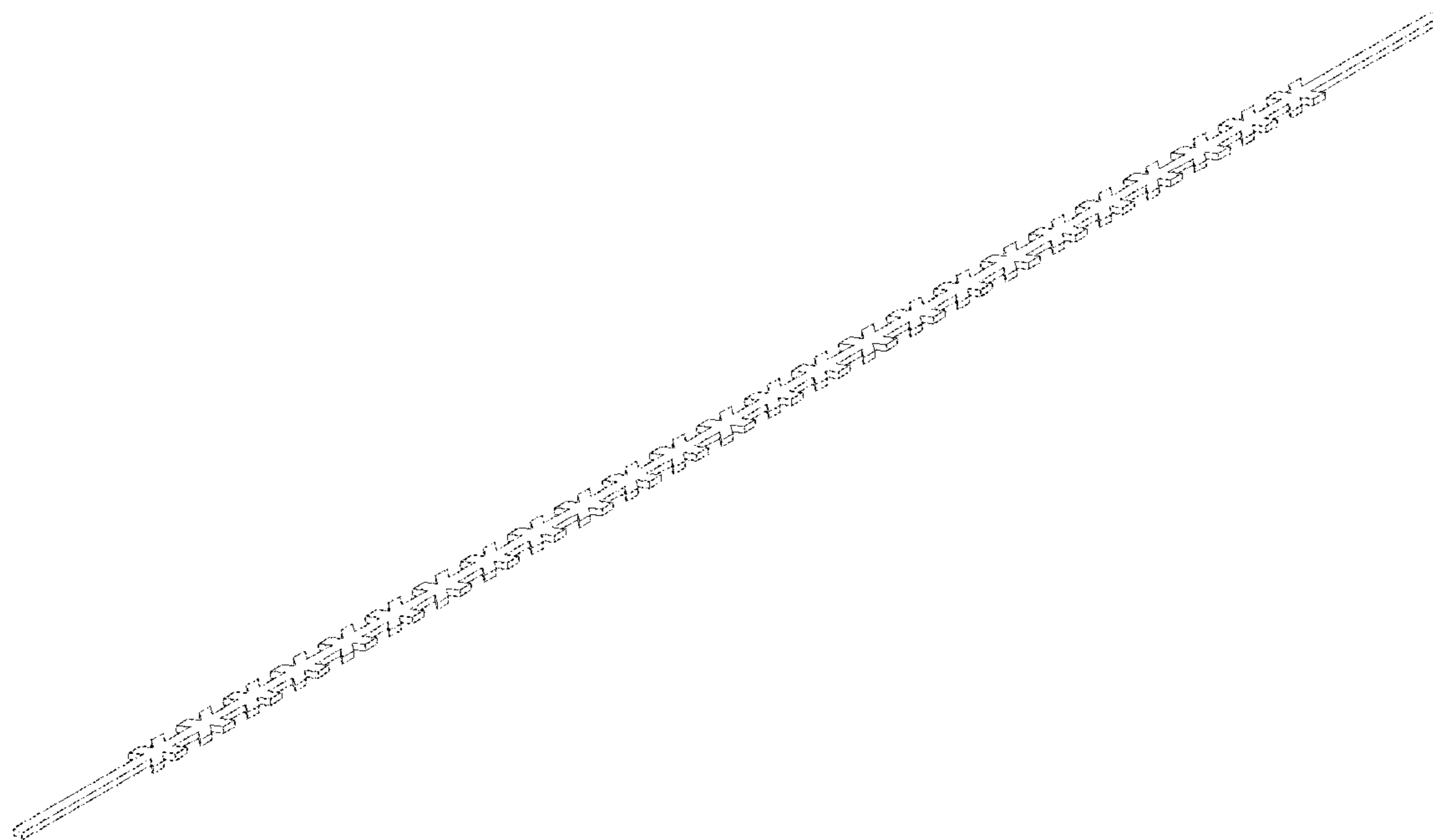

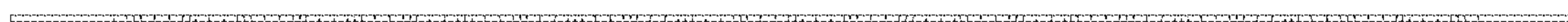

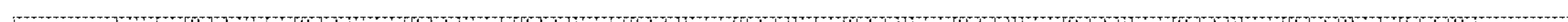

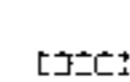

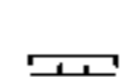

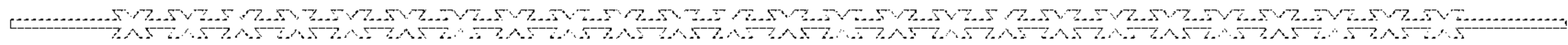

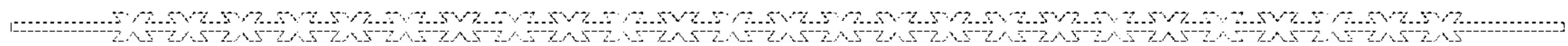
