(57) **CLAIM**

The ornamental design for a shower mitt, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a shower mitt showing my new design;
FIG. 2 is a rear elevation view of the shower mitt;
FIG. 3 is a right side elevation view of the shower mitt;
FIG. 4 is a left side elevation view of the shower mitt;
FIG. 5 is a top plan view of the shower mitt;
FIG. 6 is a bottom plan view of the shower mitt; and,
FIG. 7 is a top front right side perspective view of the shower mitt.

The broken line in FIG. 6, which defines the bounds of the claimed design, forms no part thereof.

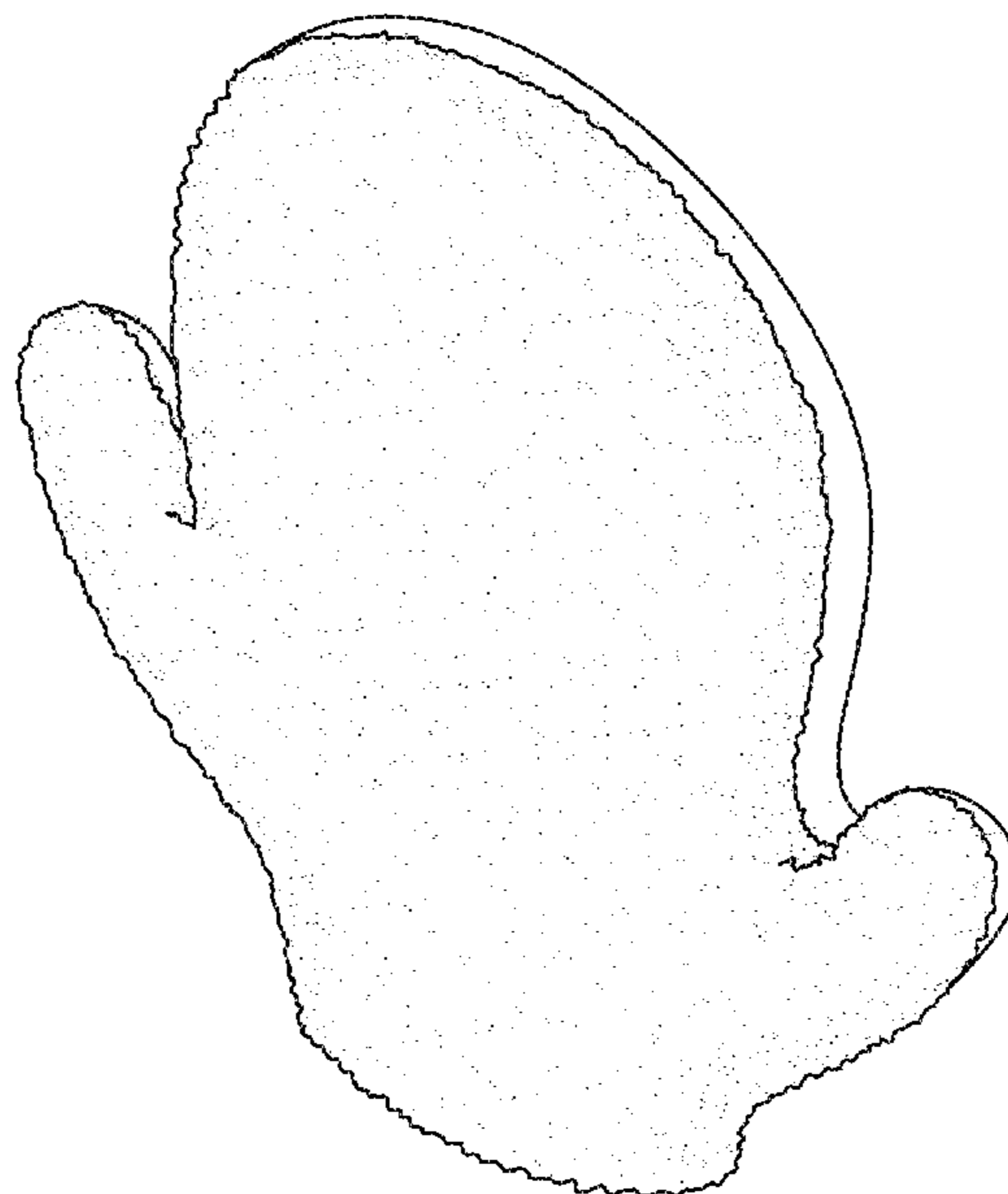

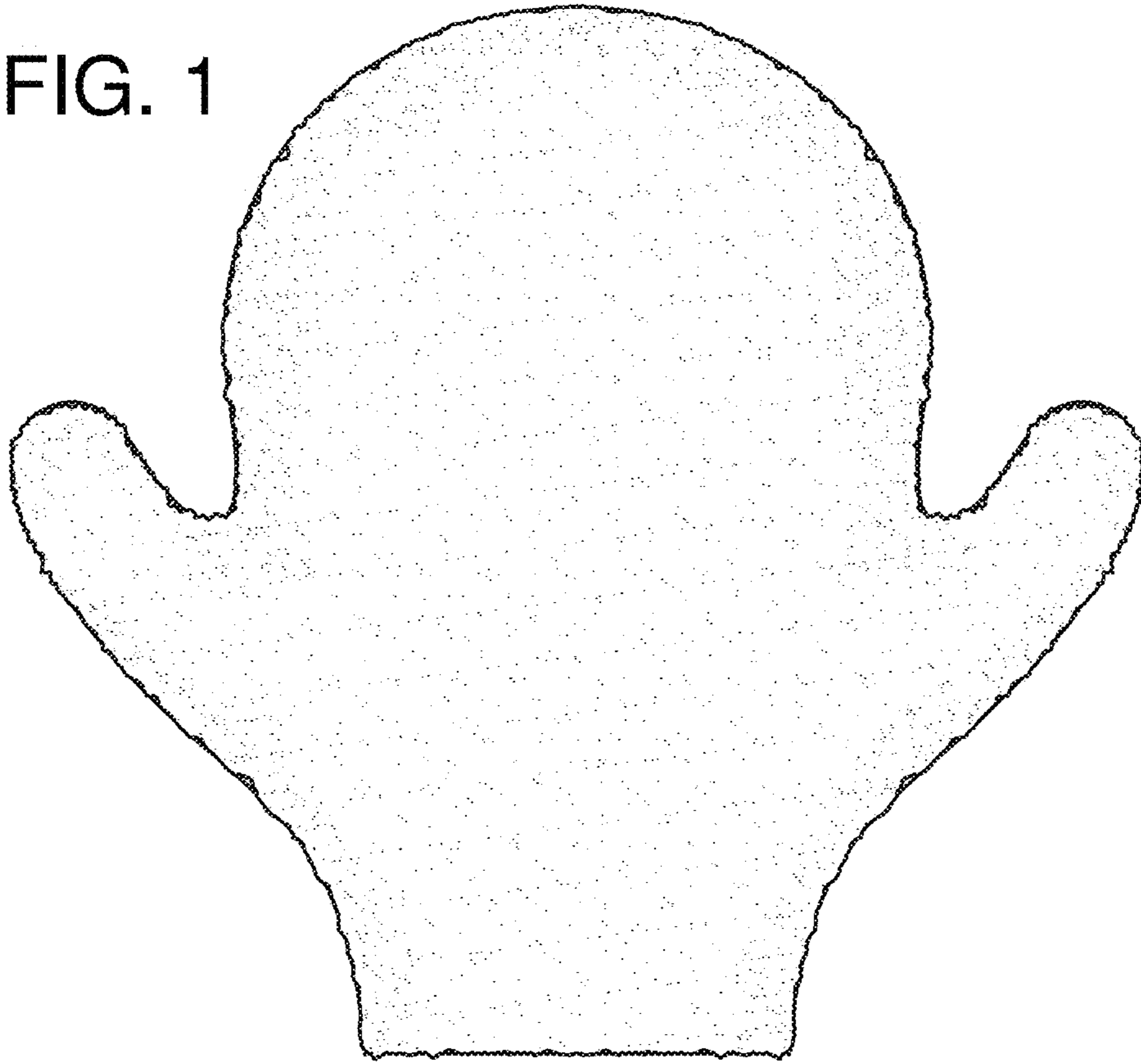
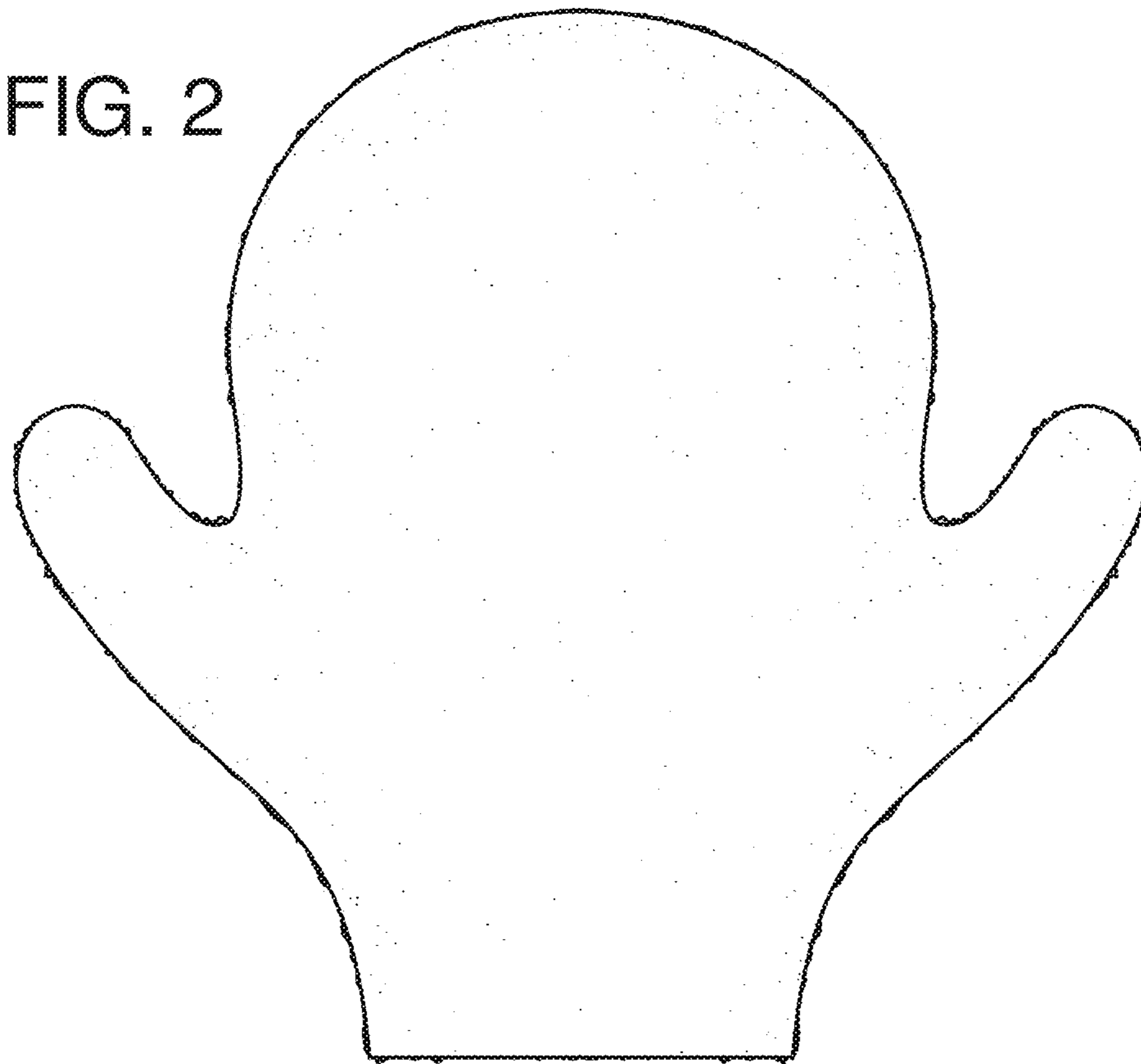

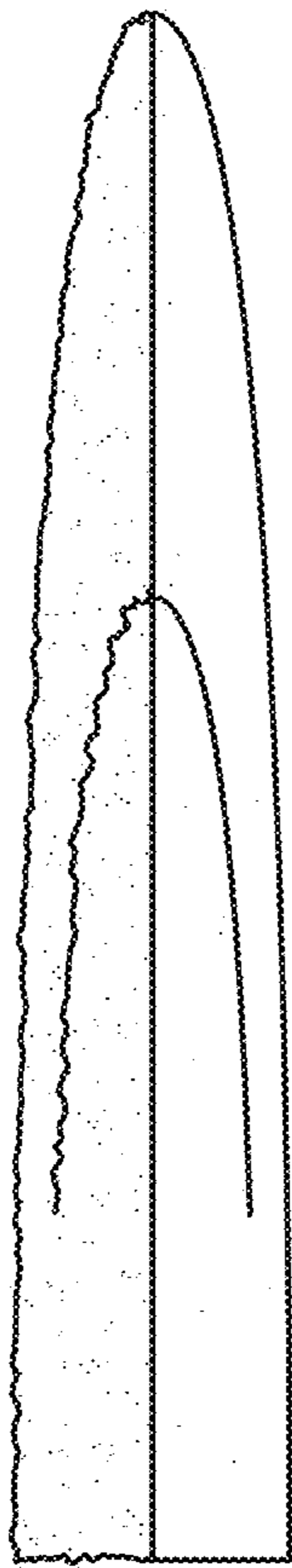

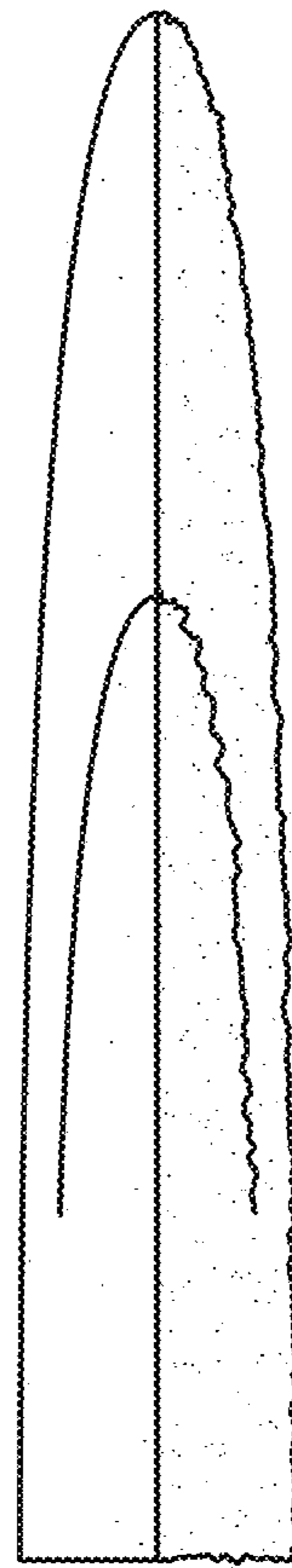

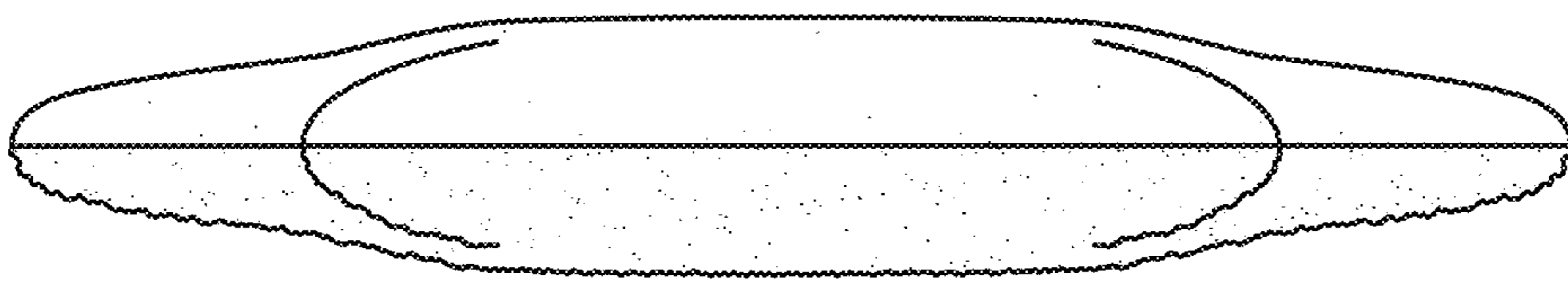
