(57) **CLAIM**

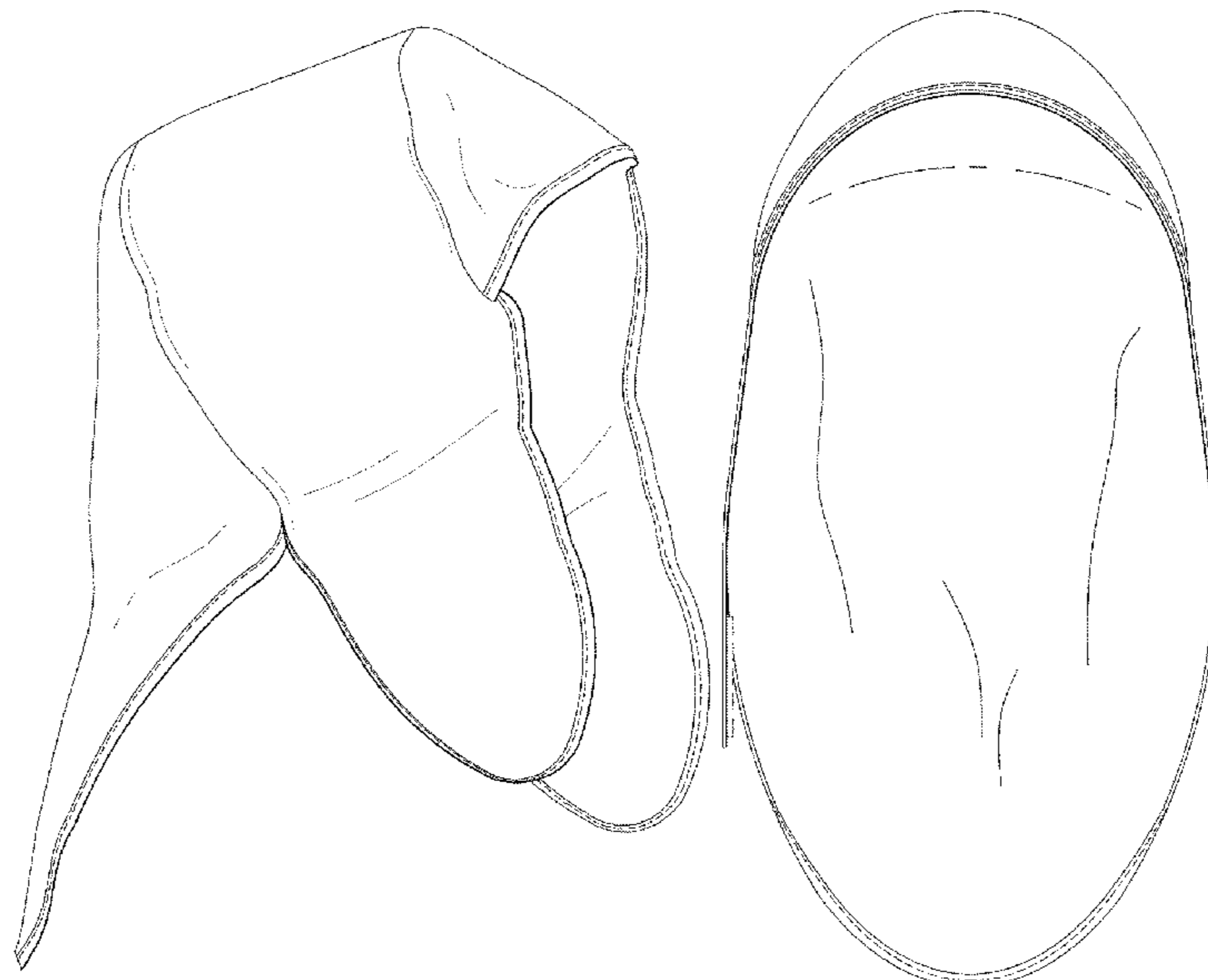
The ornamental design for a rain bonnet, as shown and described.

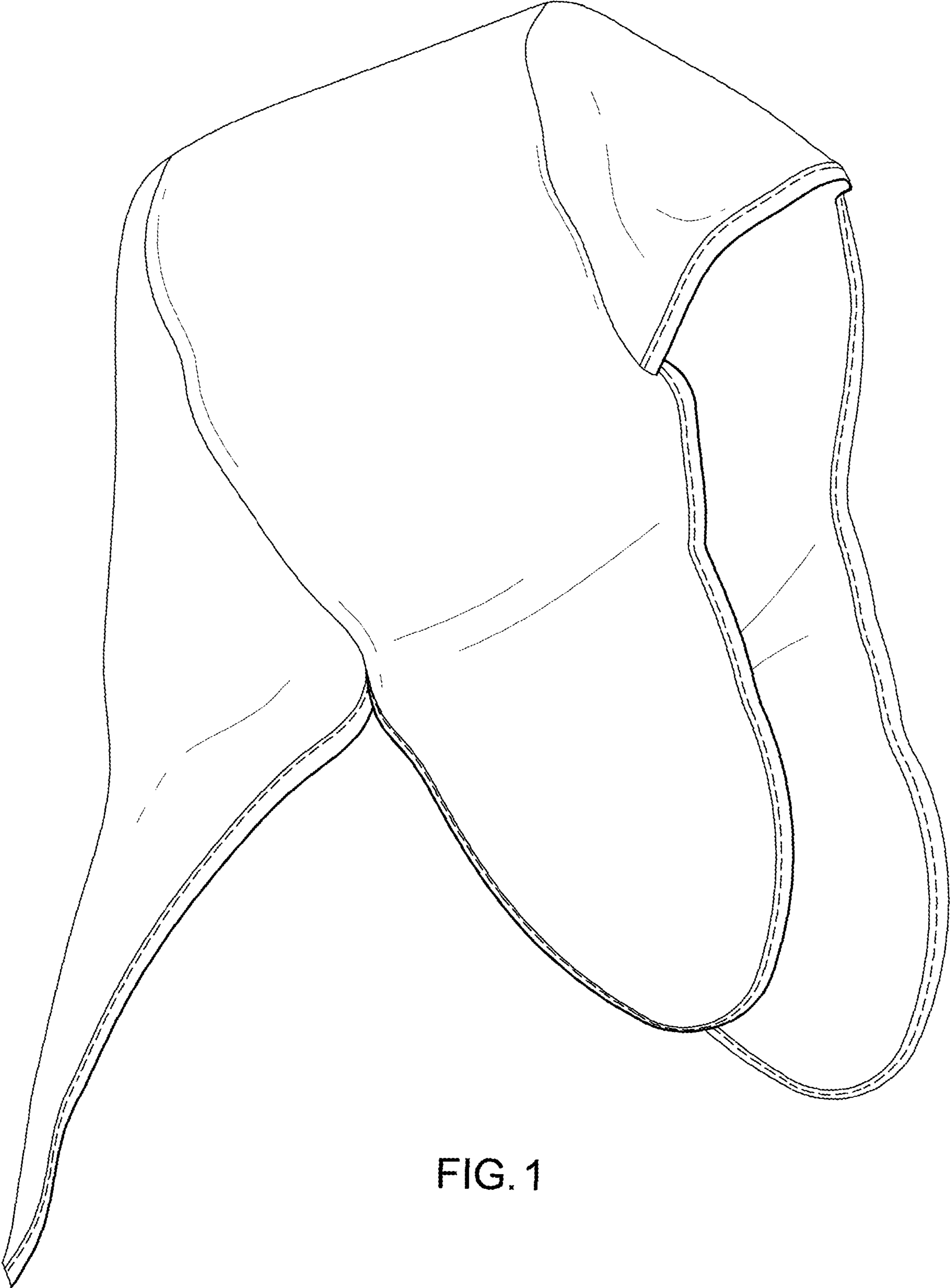

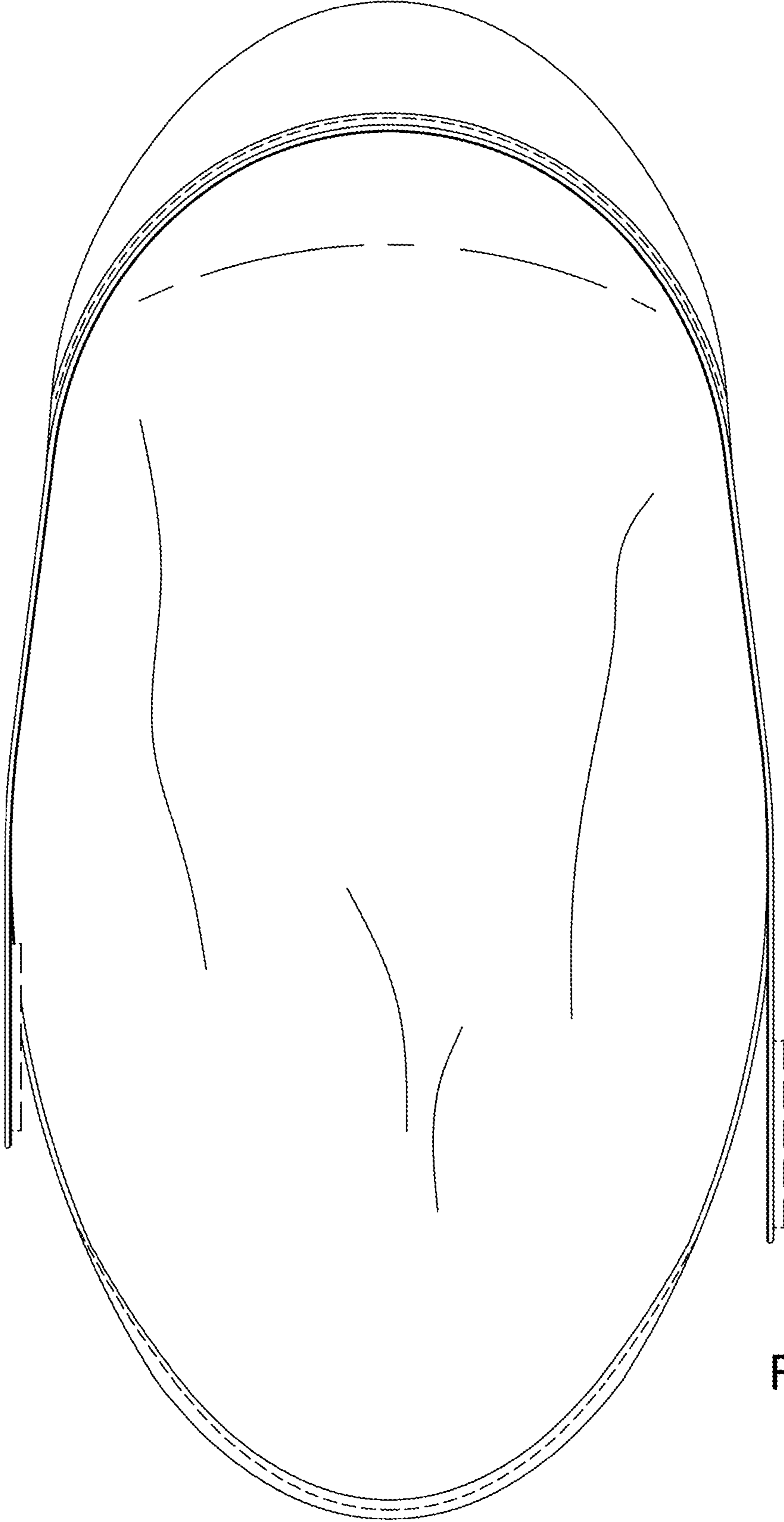

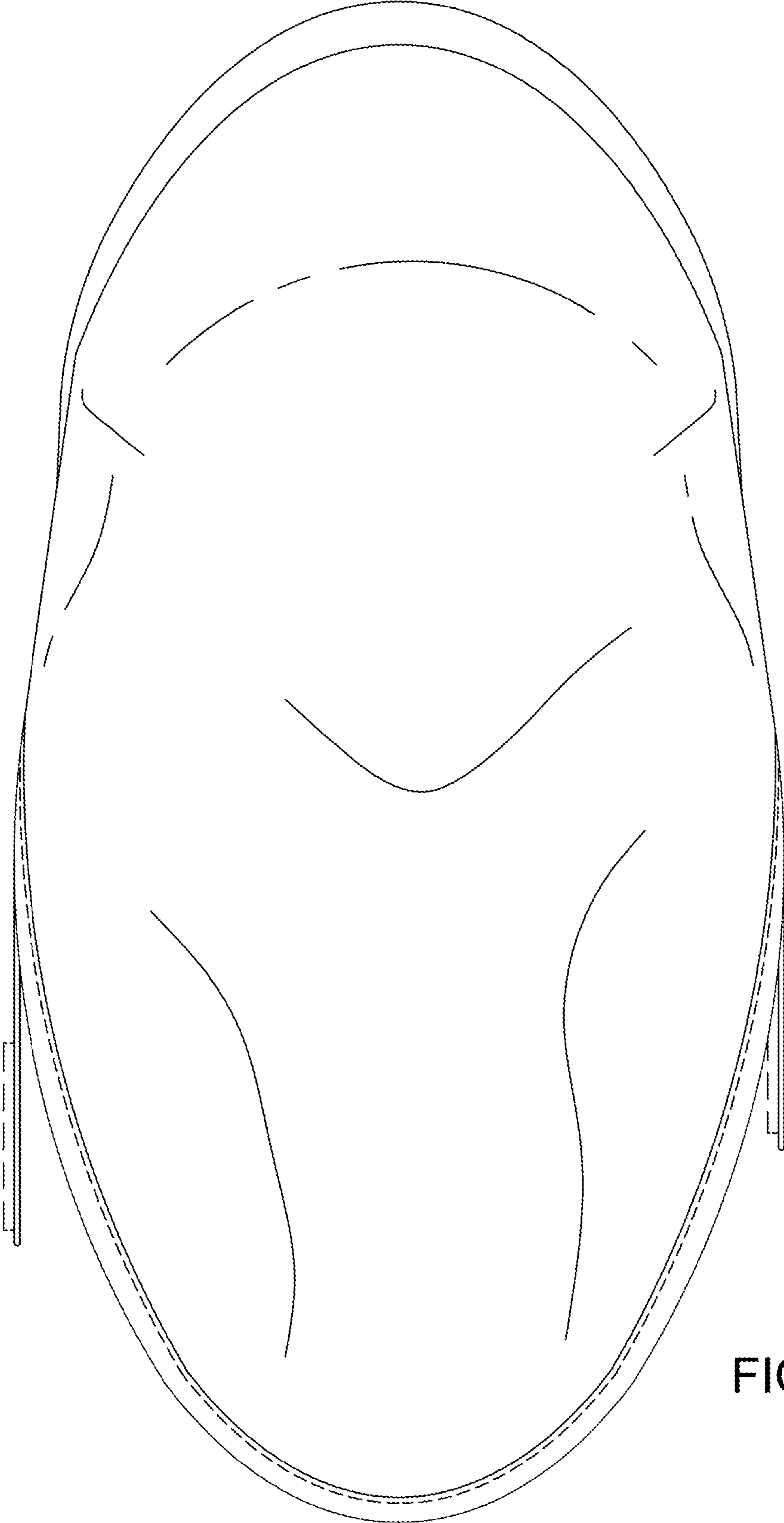

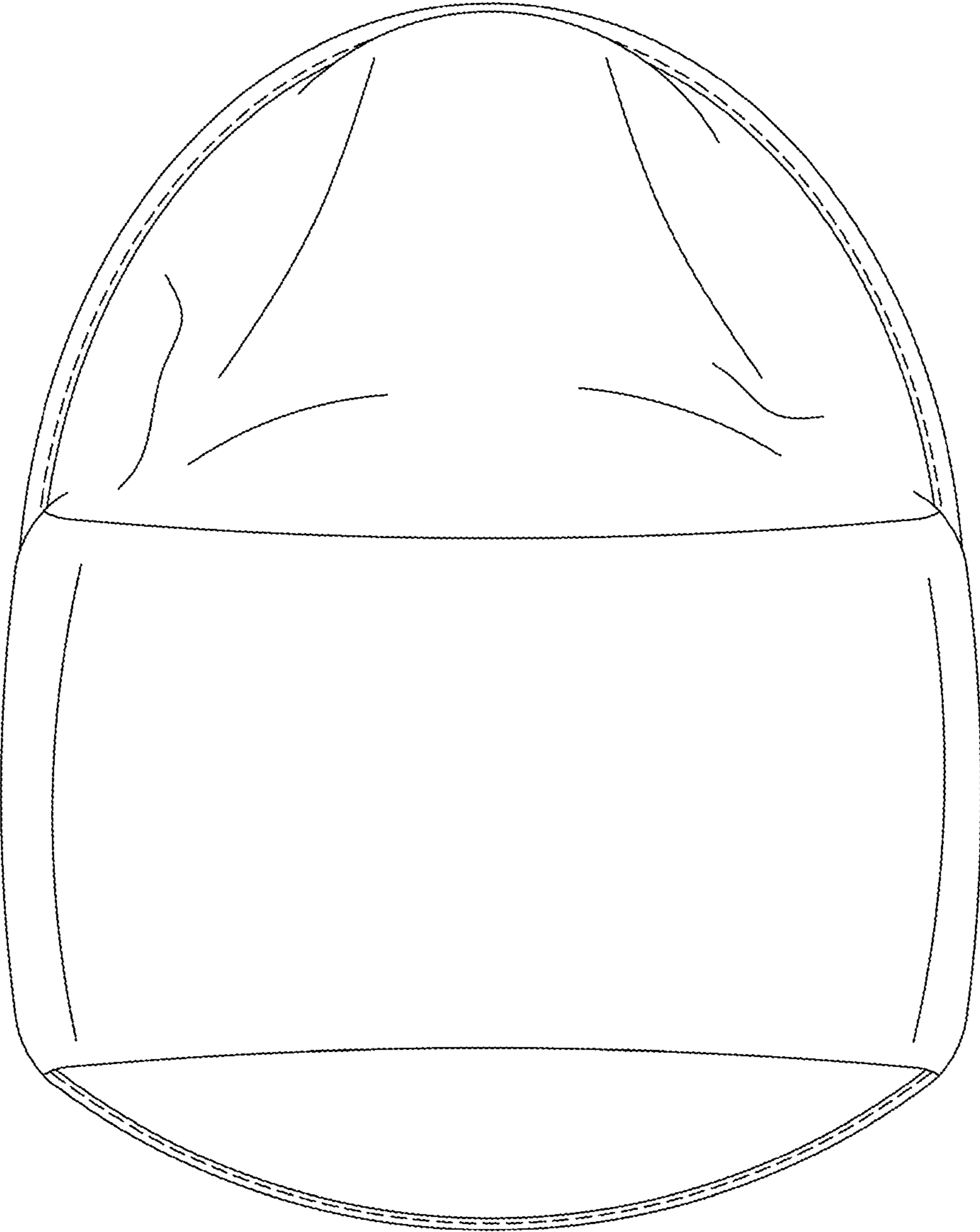

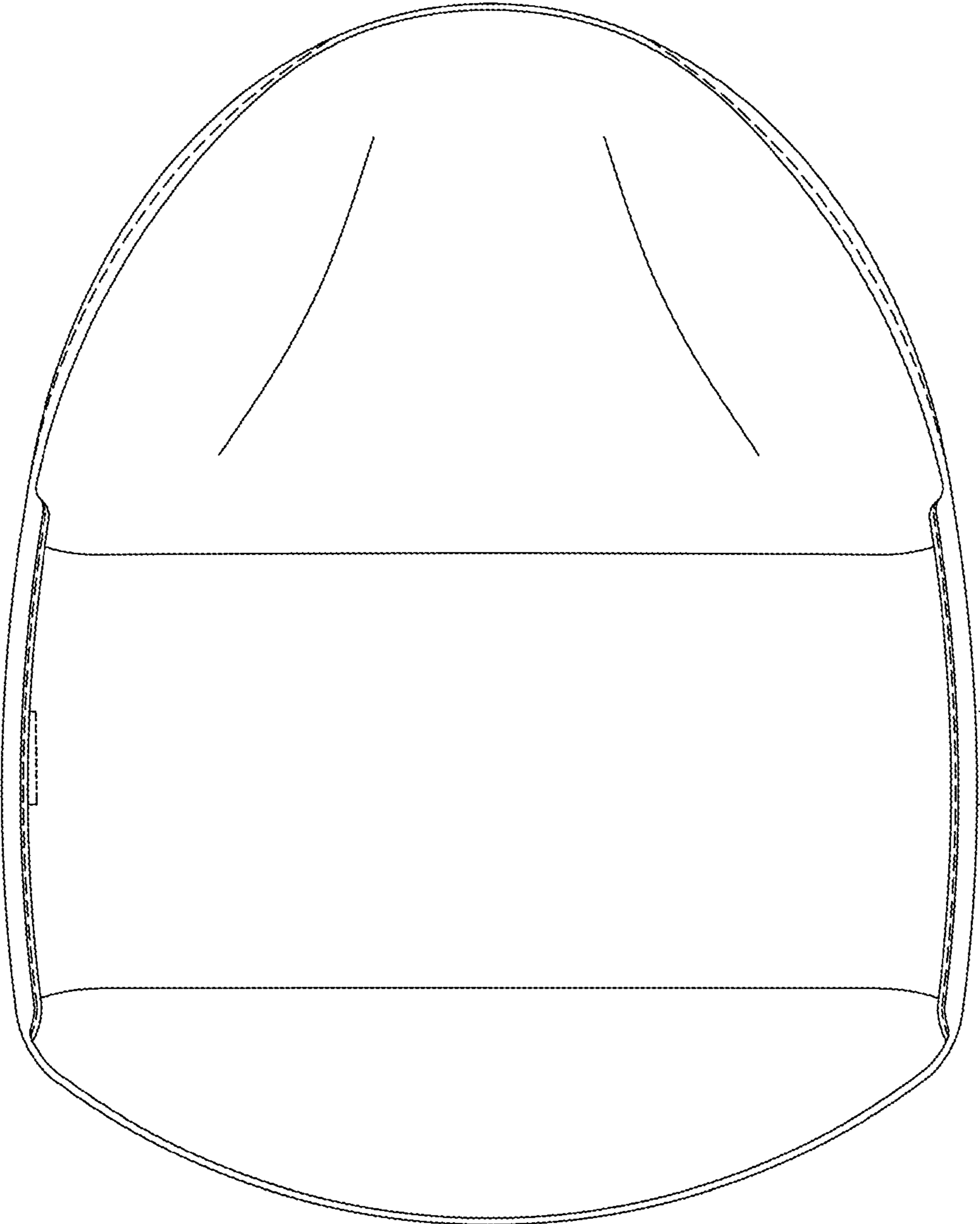

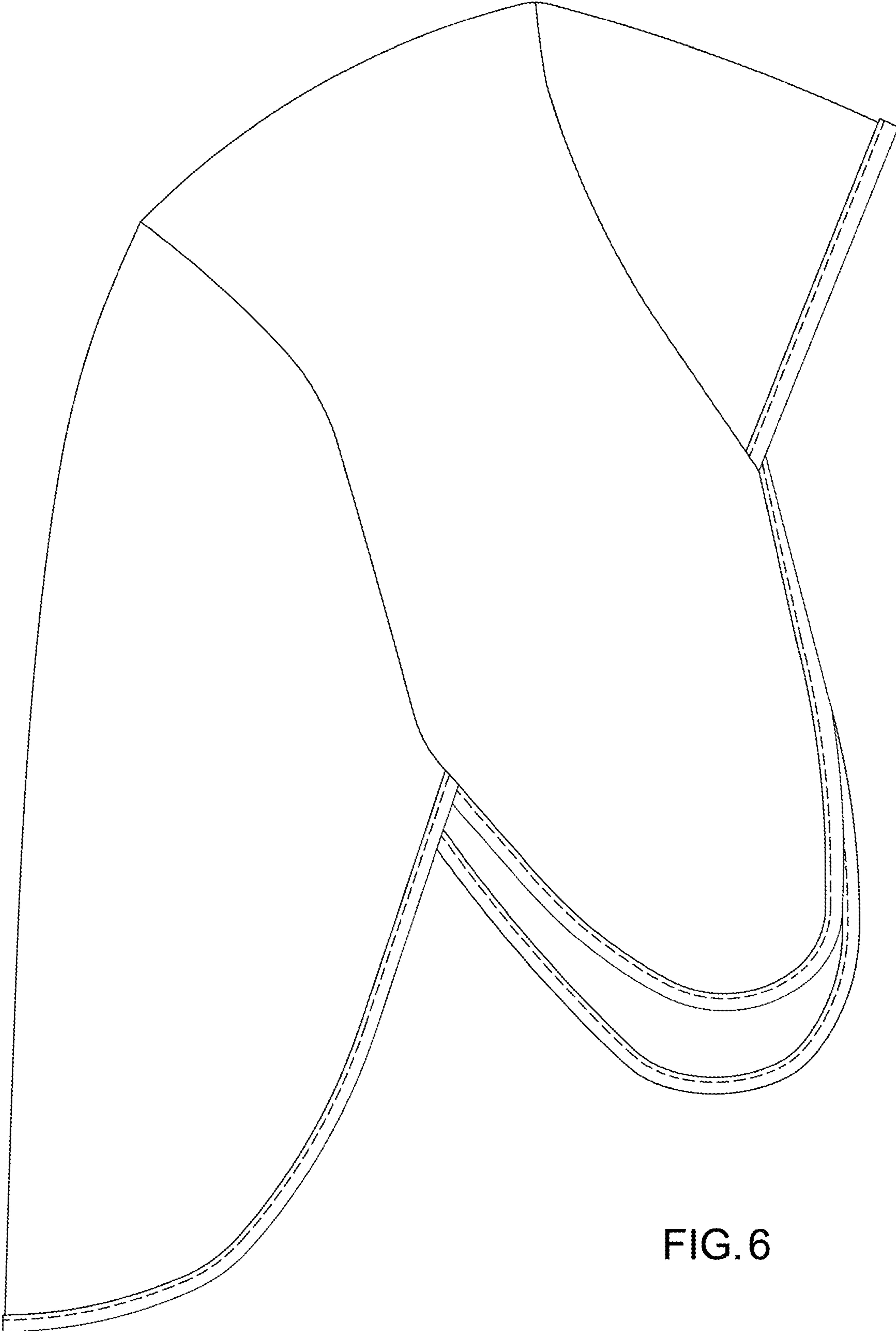

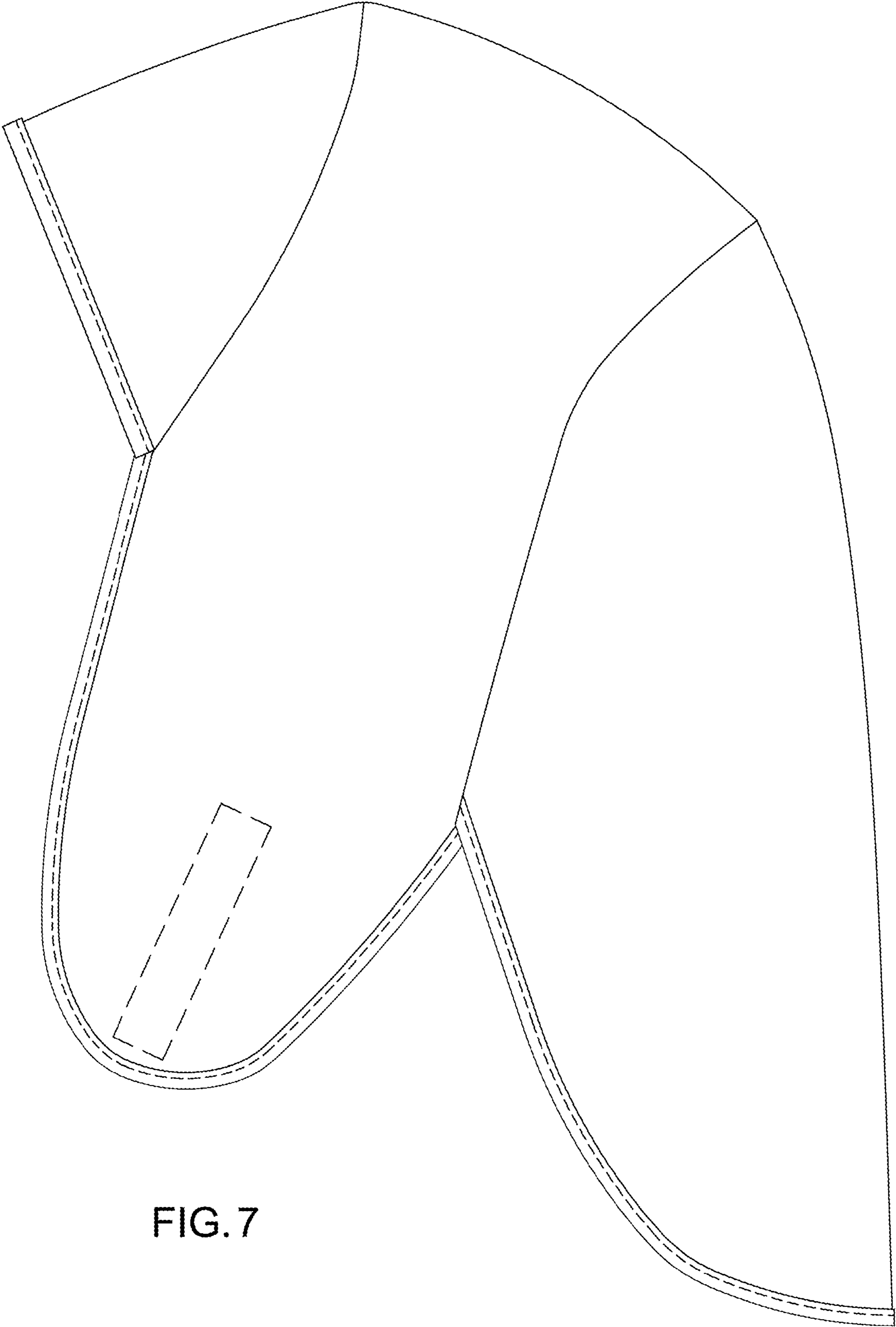
