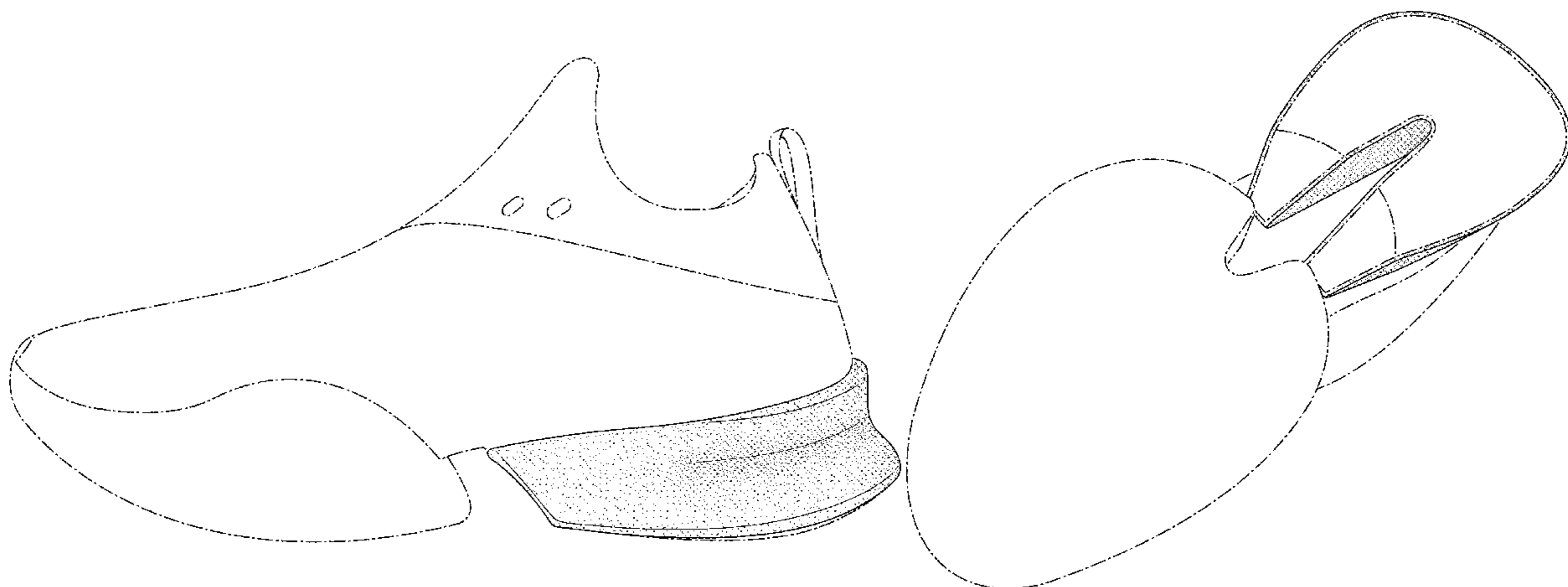
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a shoe showing our new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is an opposite side rear perspective view thereof;
FIG. 4 is an opposite side view thereof;
FIG. 5 is a bottom rear perspective view thereof;
FIG. 6 is a bottom view thereof; and,
FIG. 7 is a bottom front perspective view thereof.
The broken line immediately adjacent to the internal perimeter of the shaded area on the bottom of the shoe defines the bounds of the claimed design and forms no part thereof. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

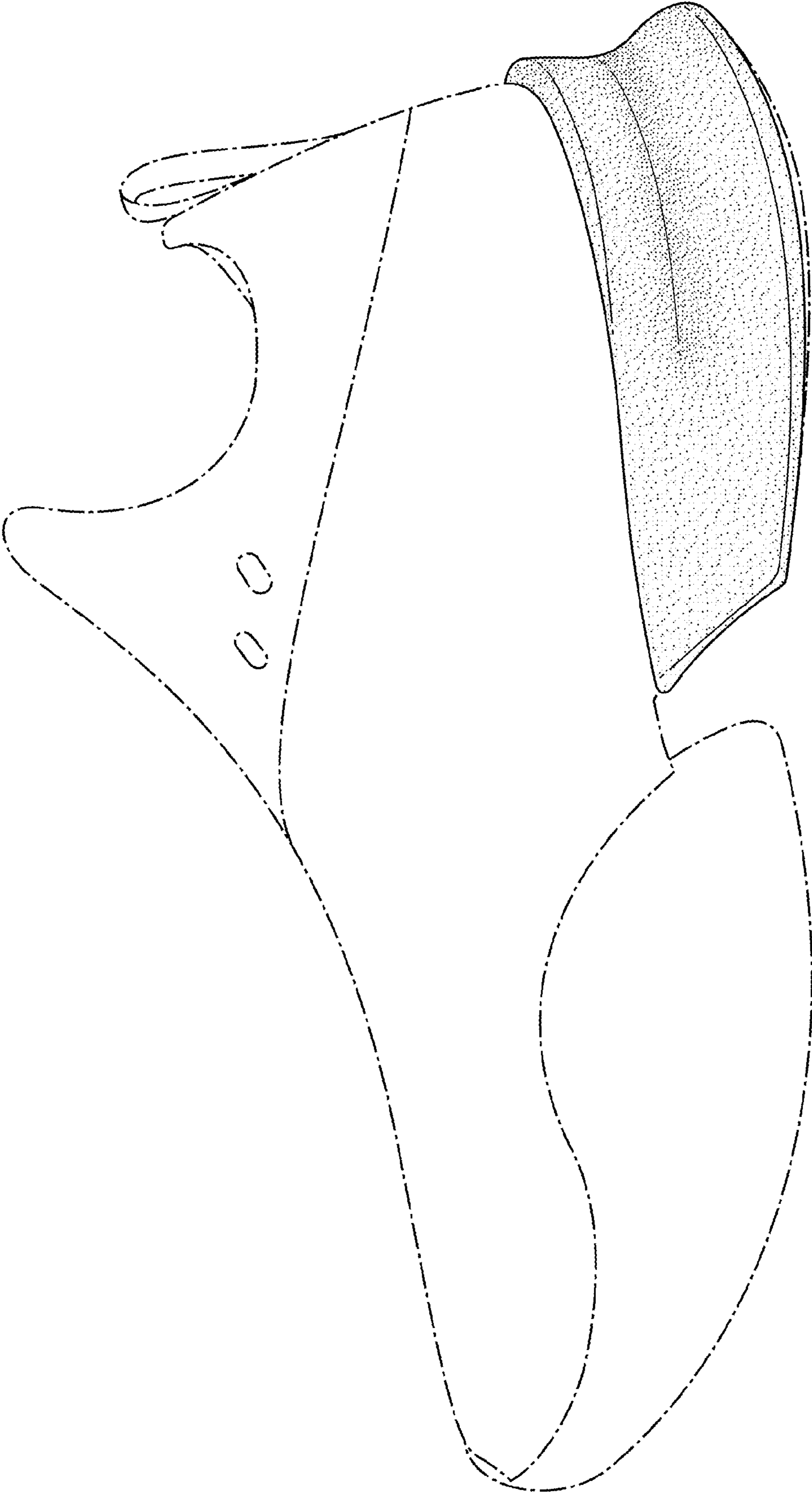

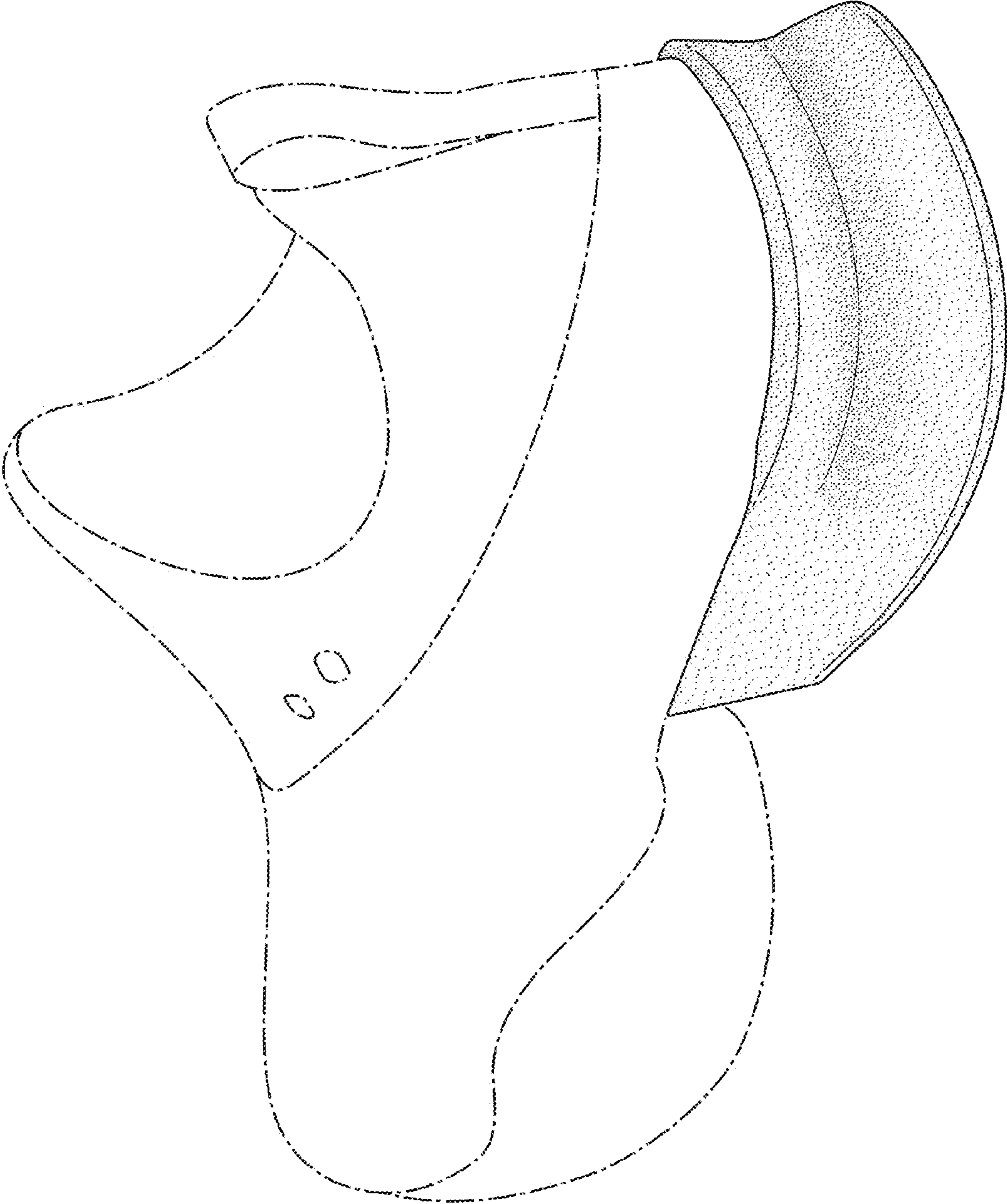

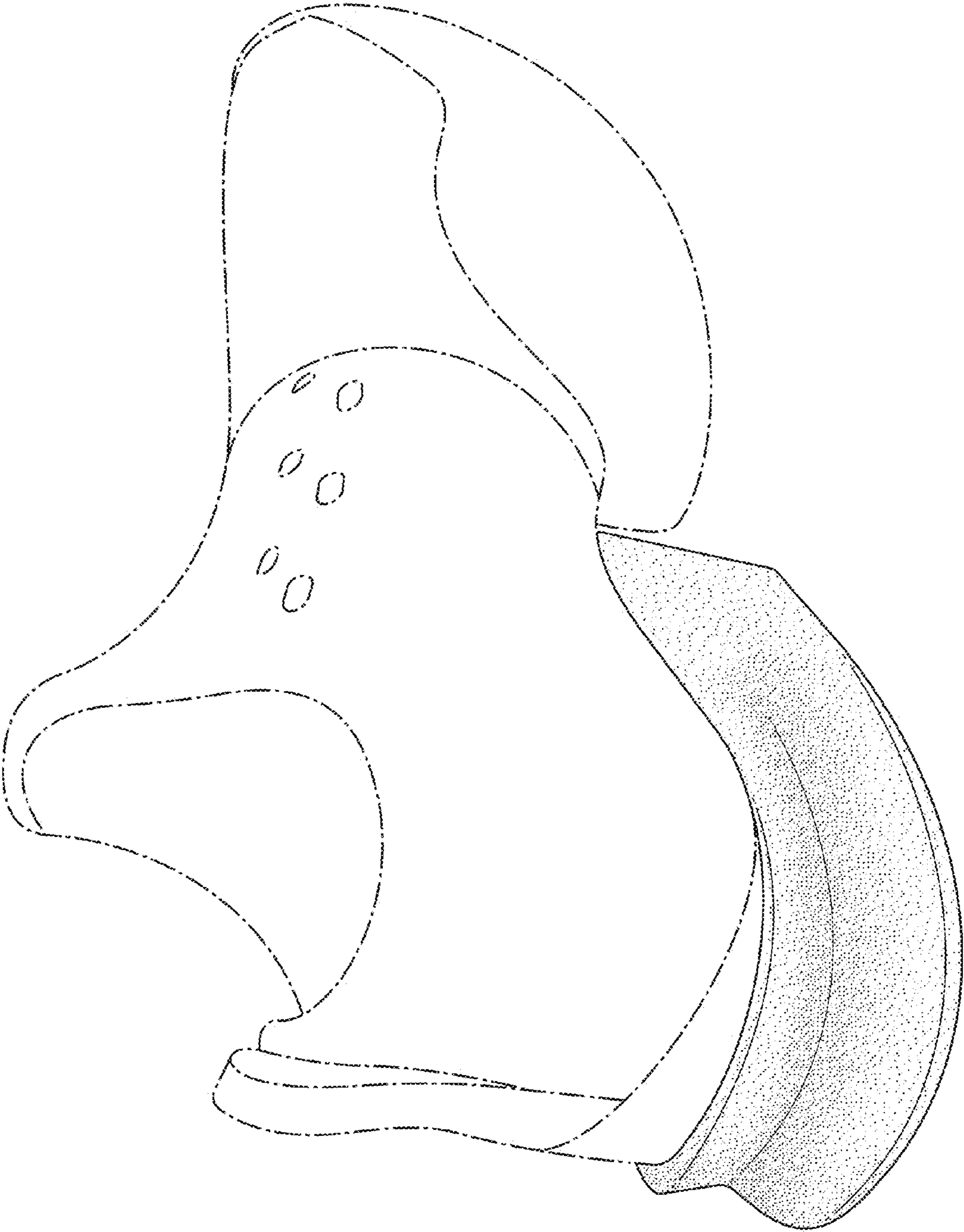

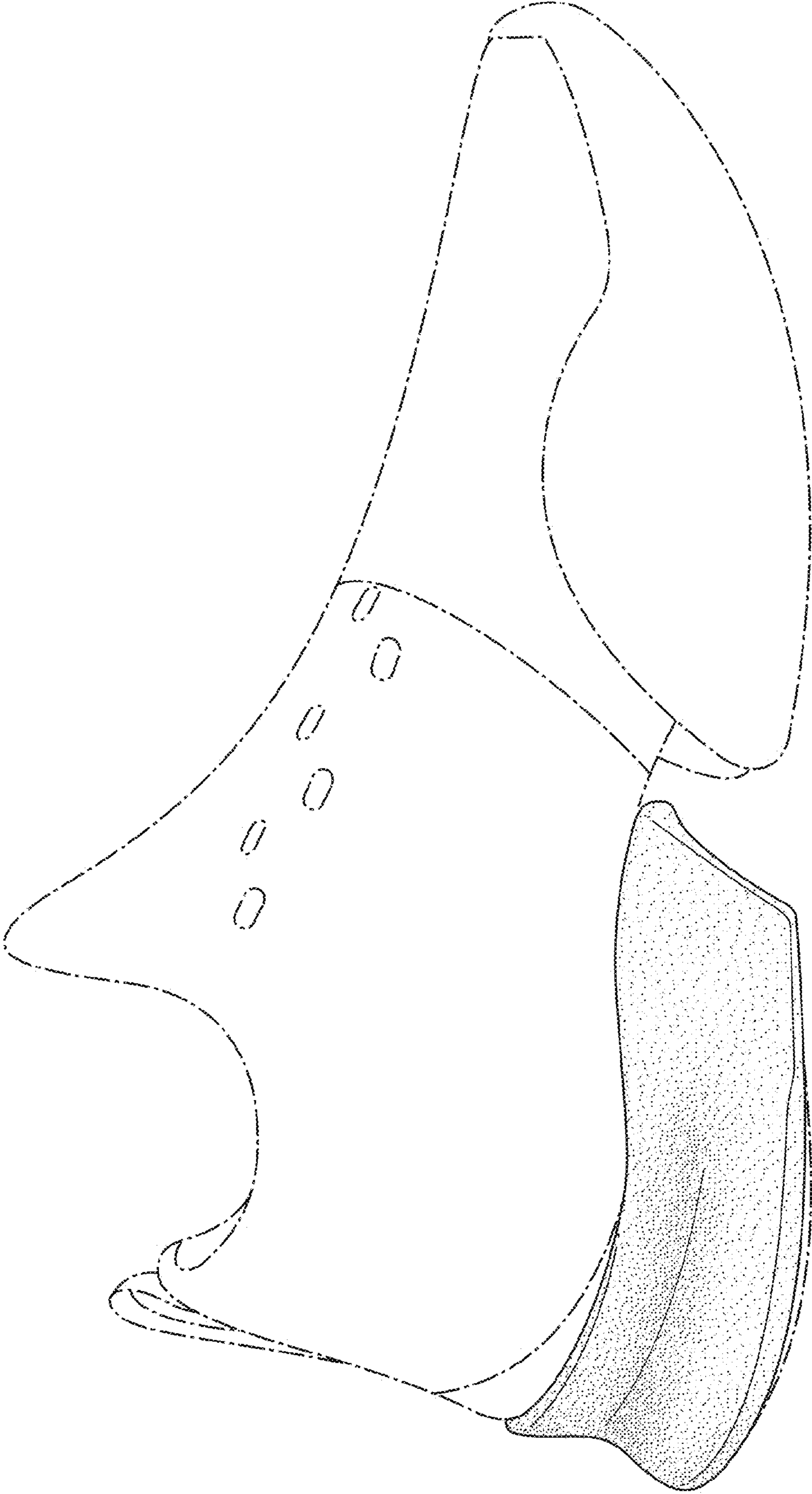

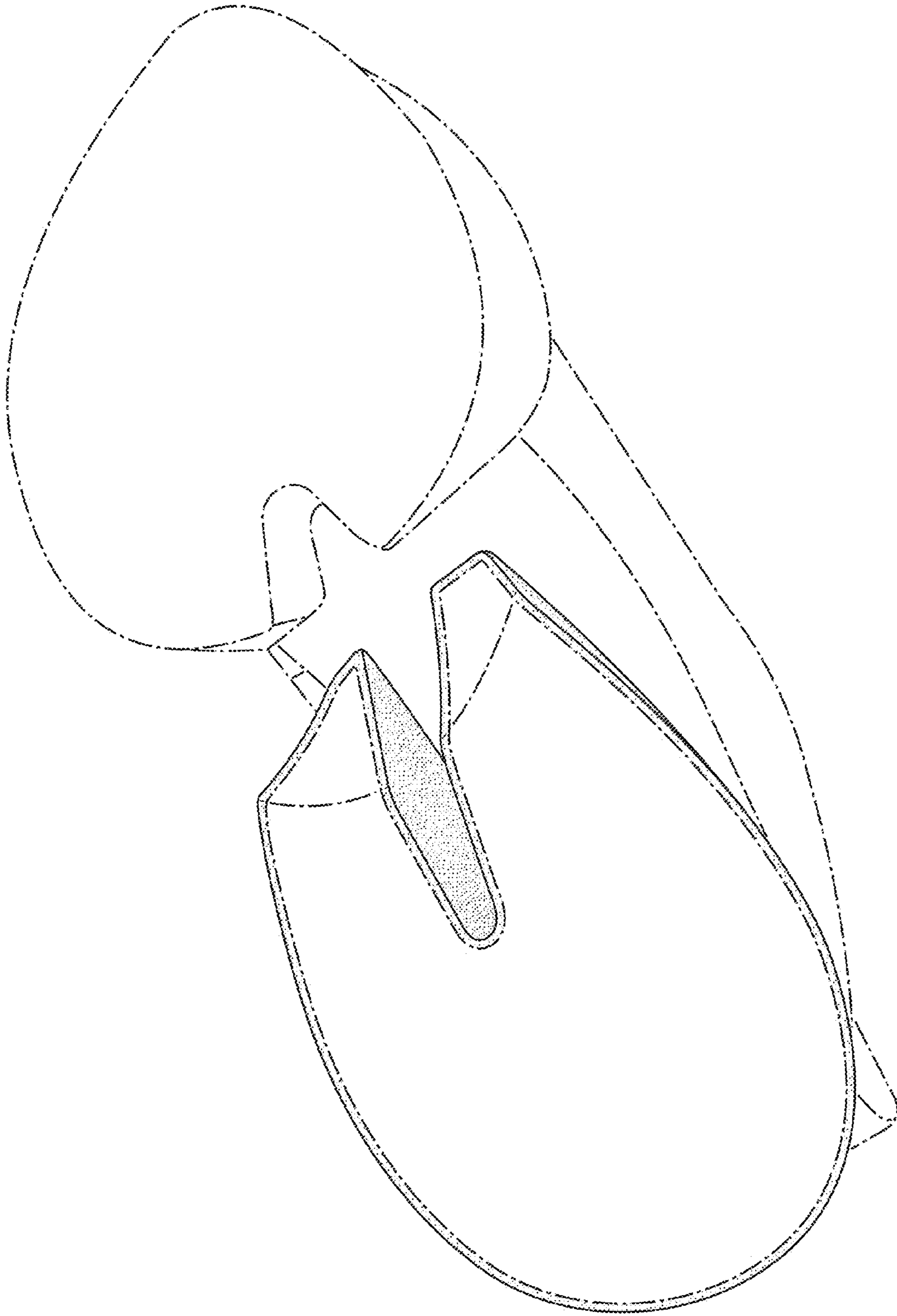

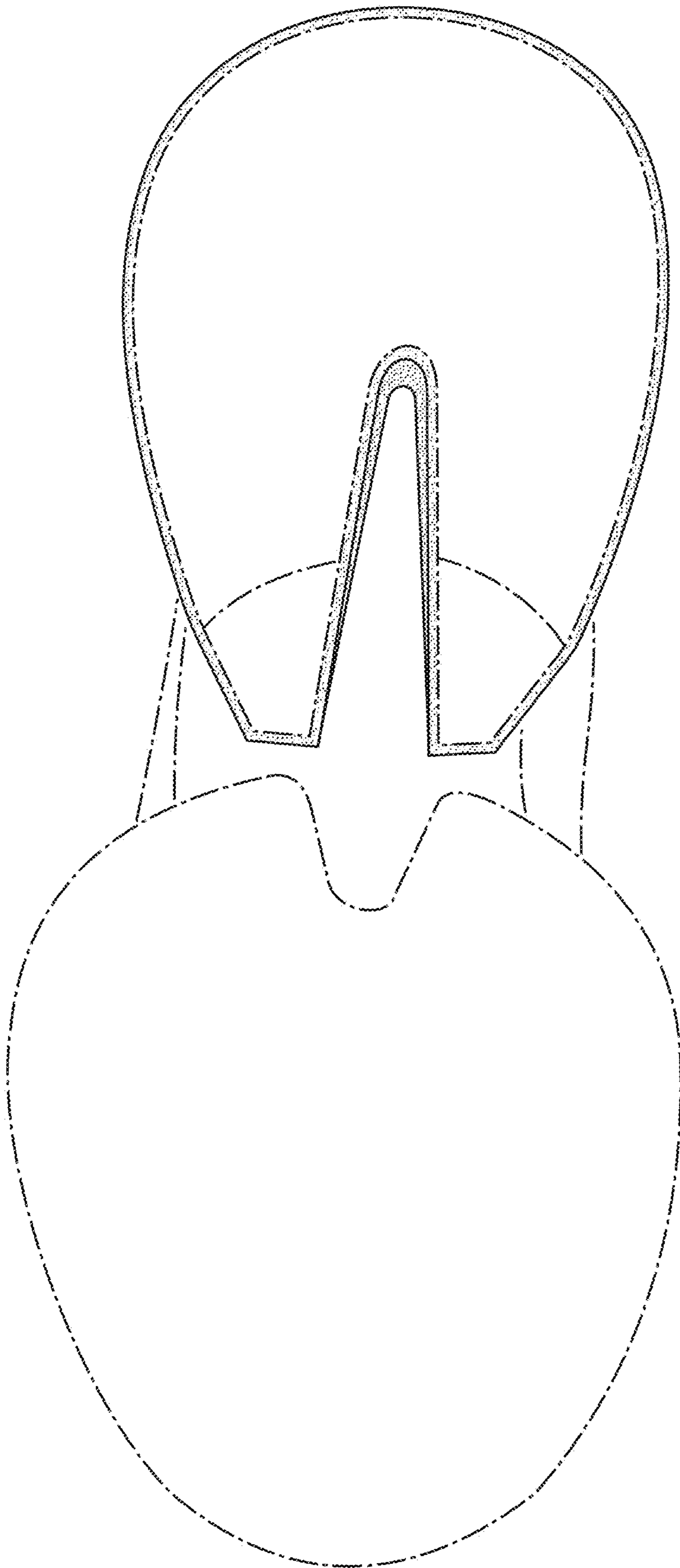

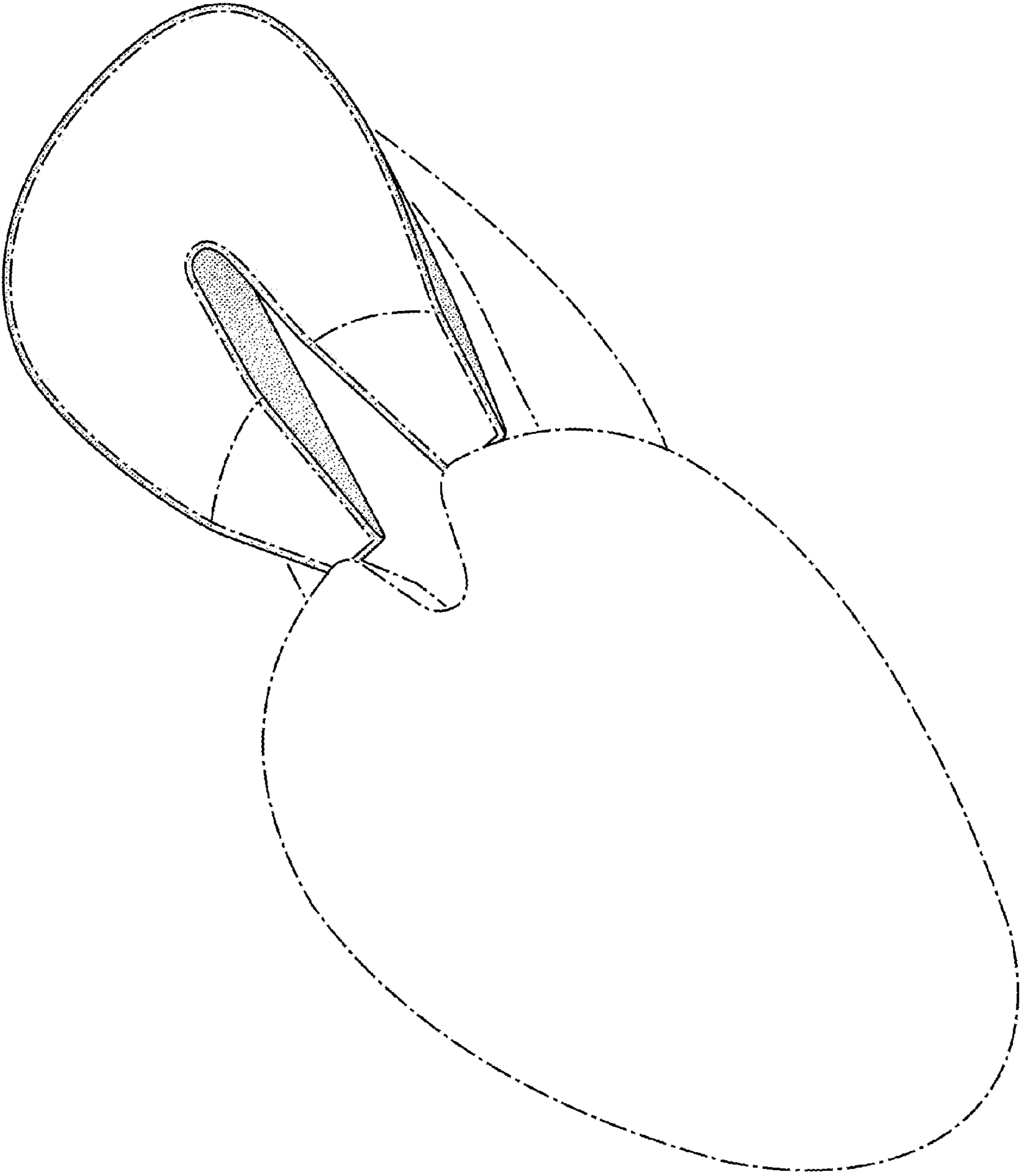
