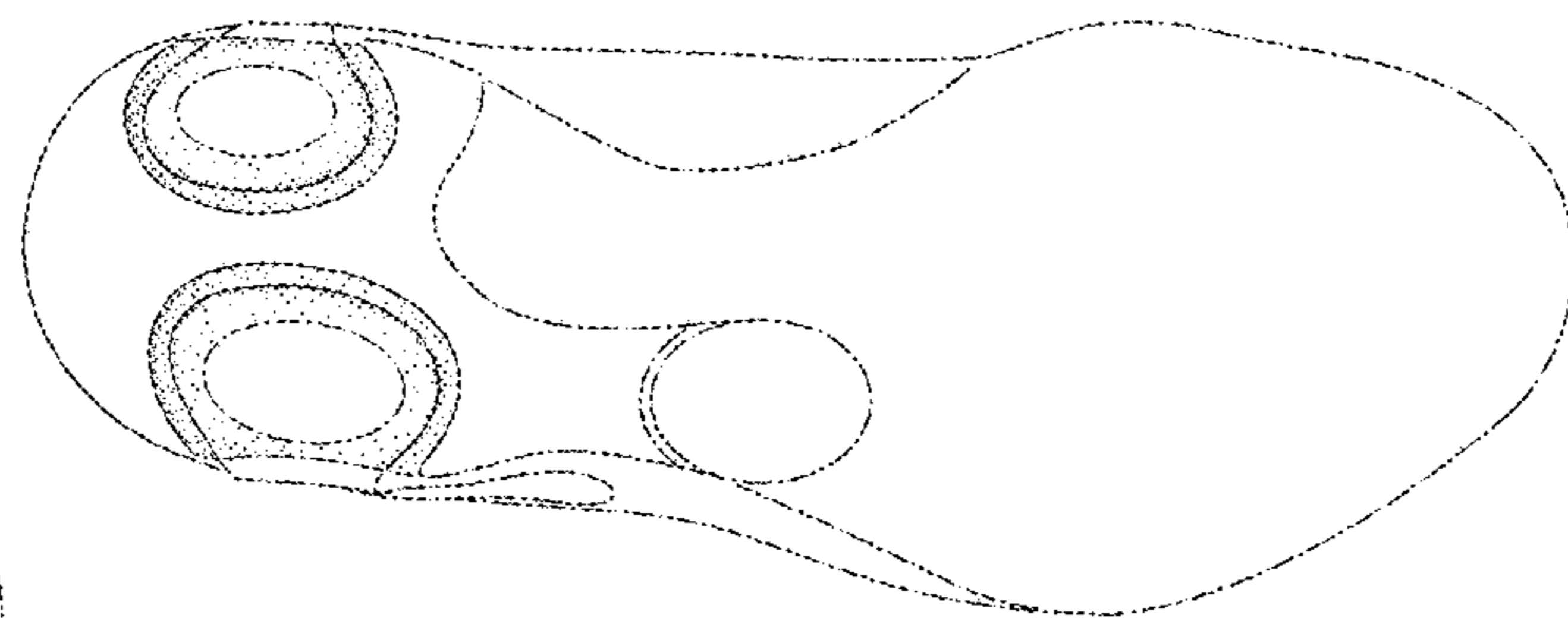
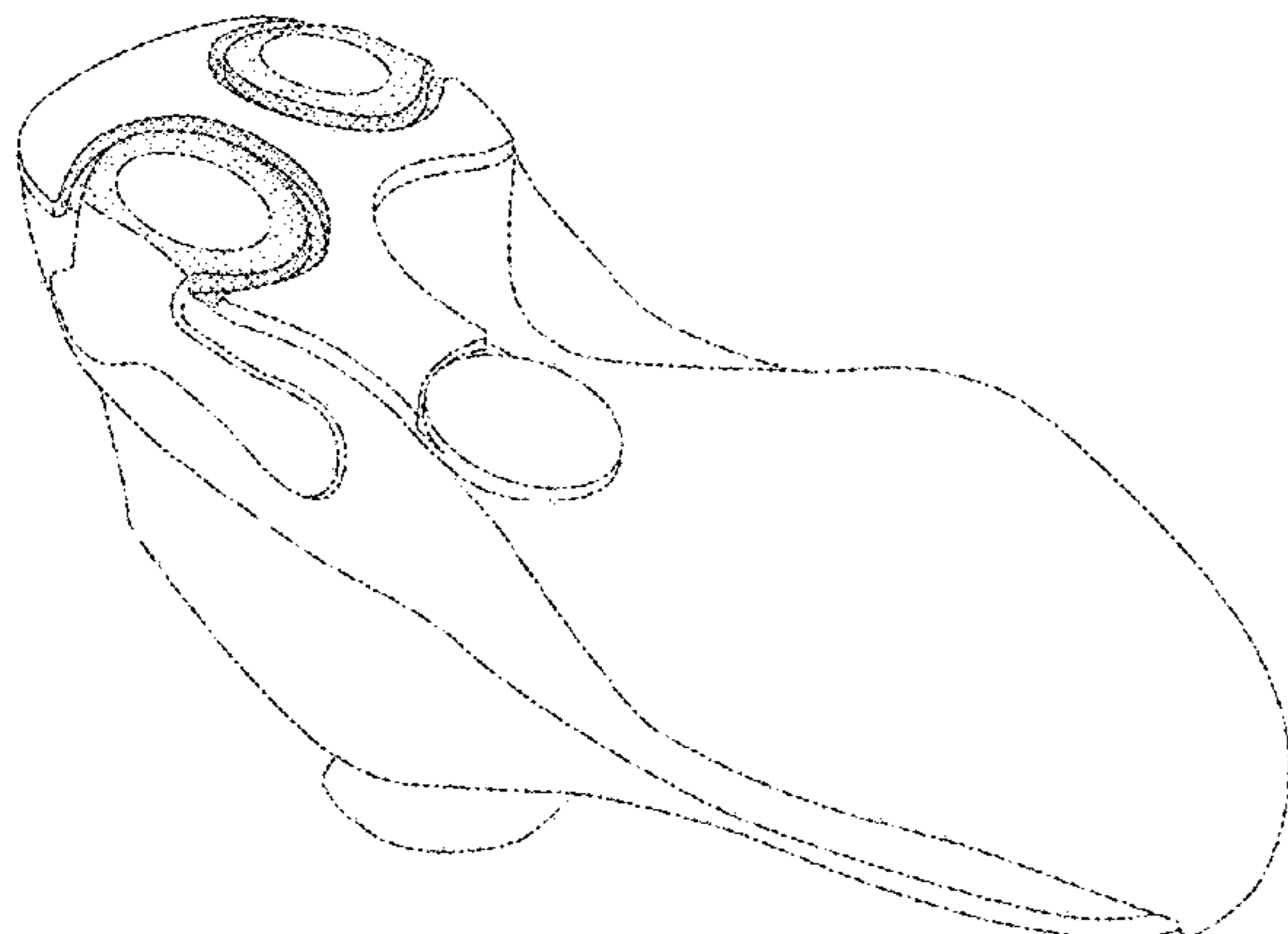
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom front perspective view of a shoe showing our new design;
FIG. 2 is a bottom view thereof; and,
FIG. 3 is a bottom rear perspective view thereof.
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken line showing of the two ovals within the shaded area forms no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

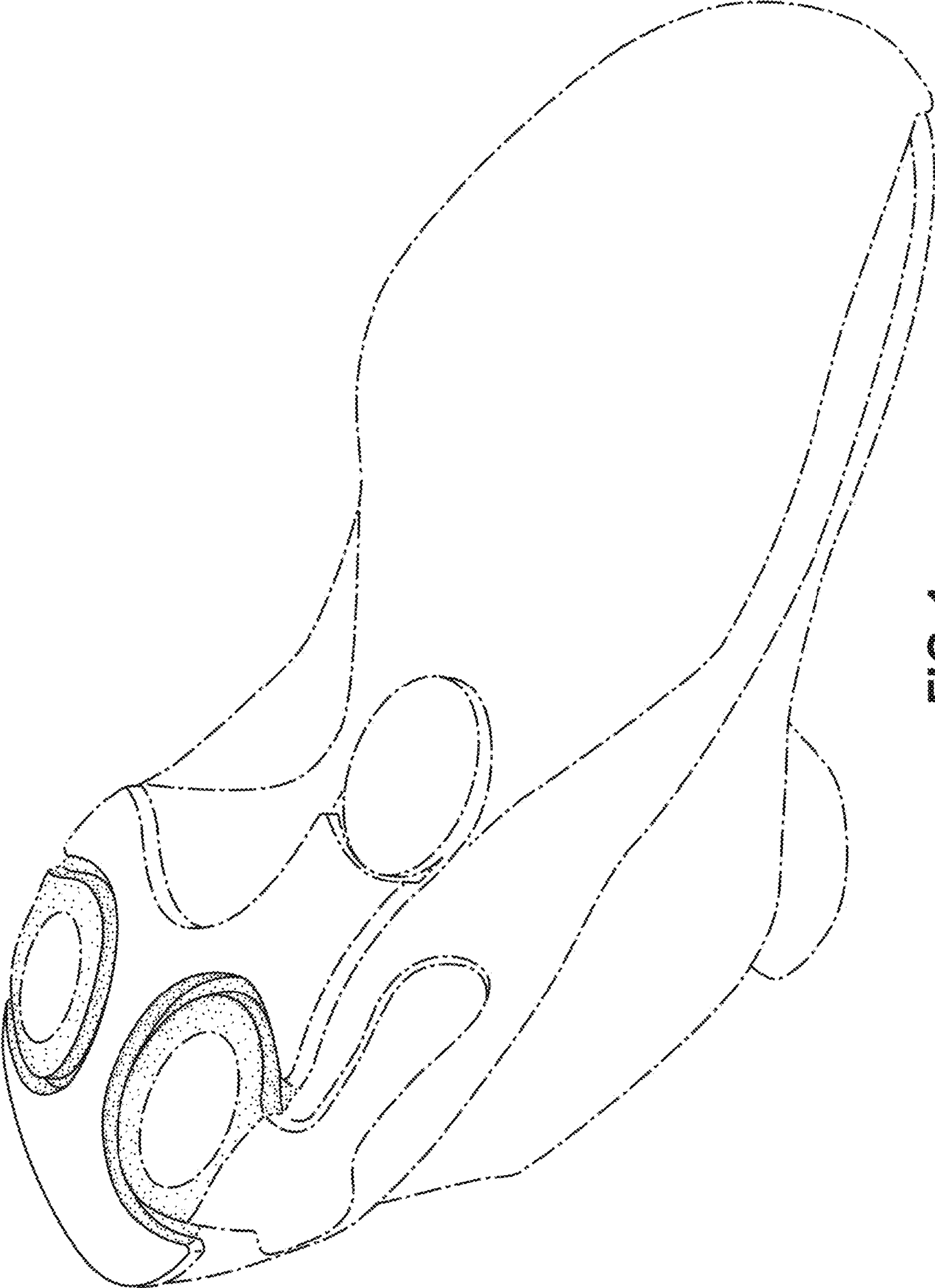

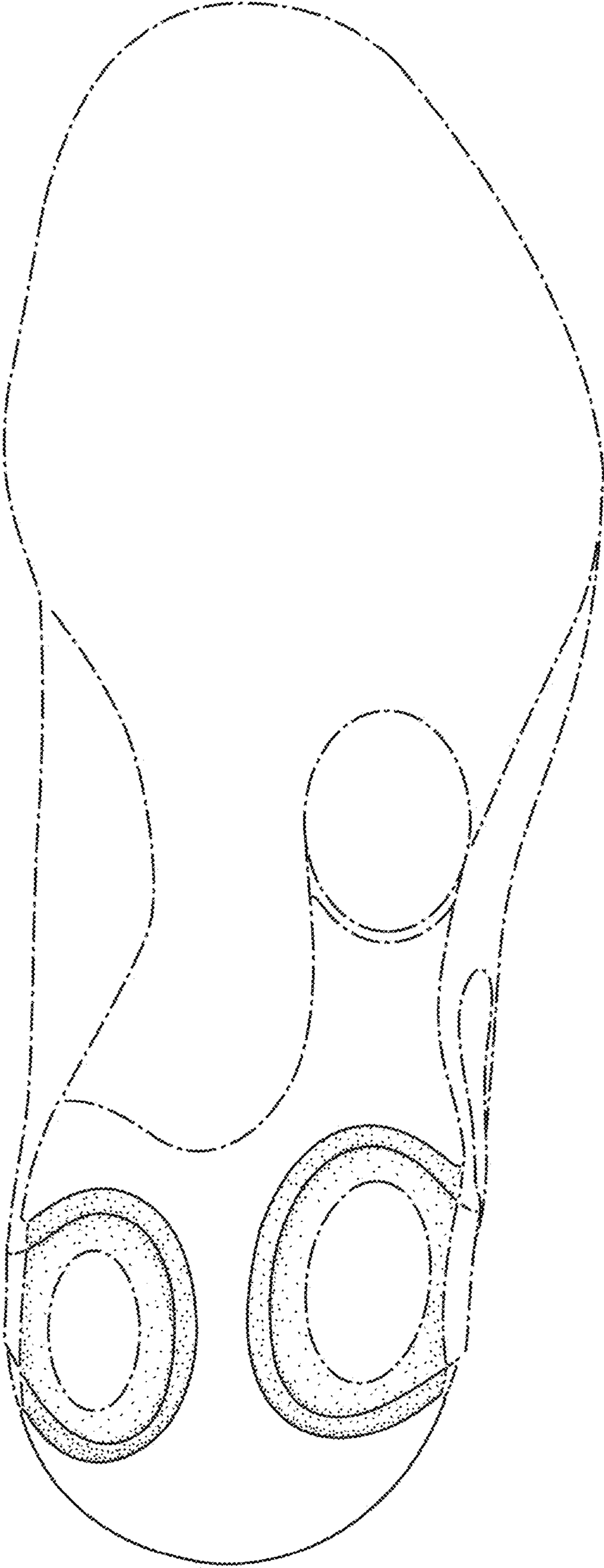

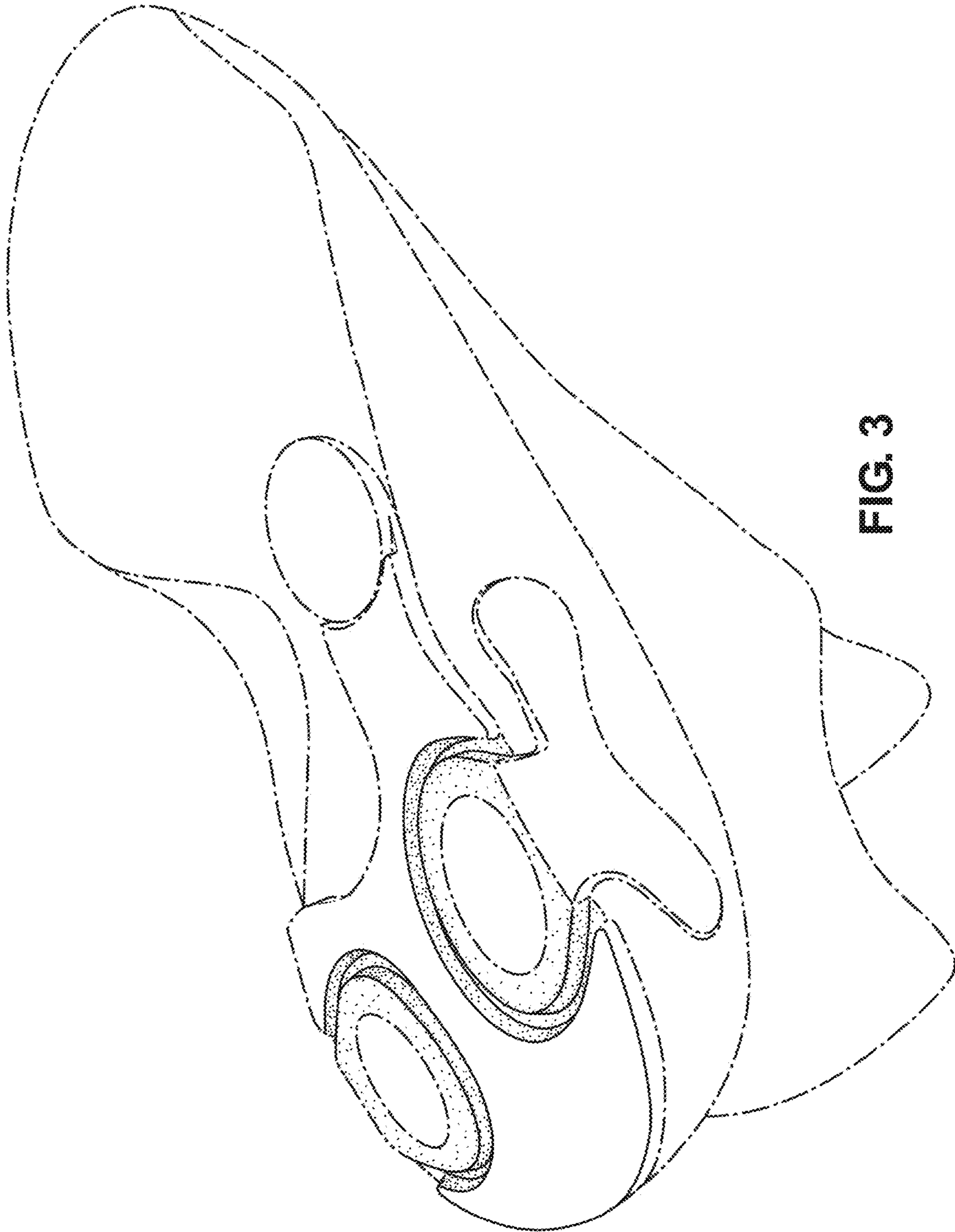
