(57) **CLAIM**

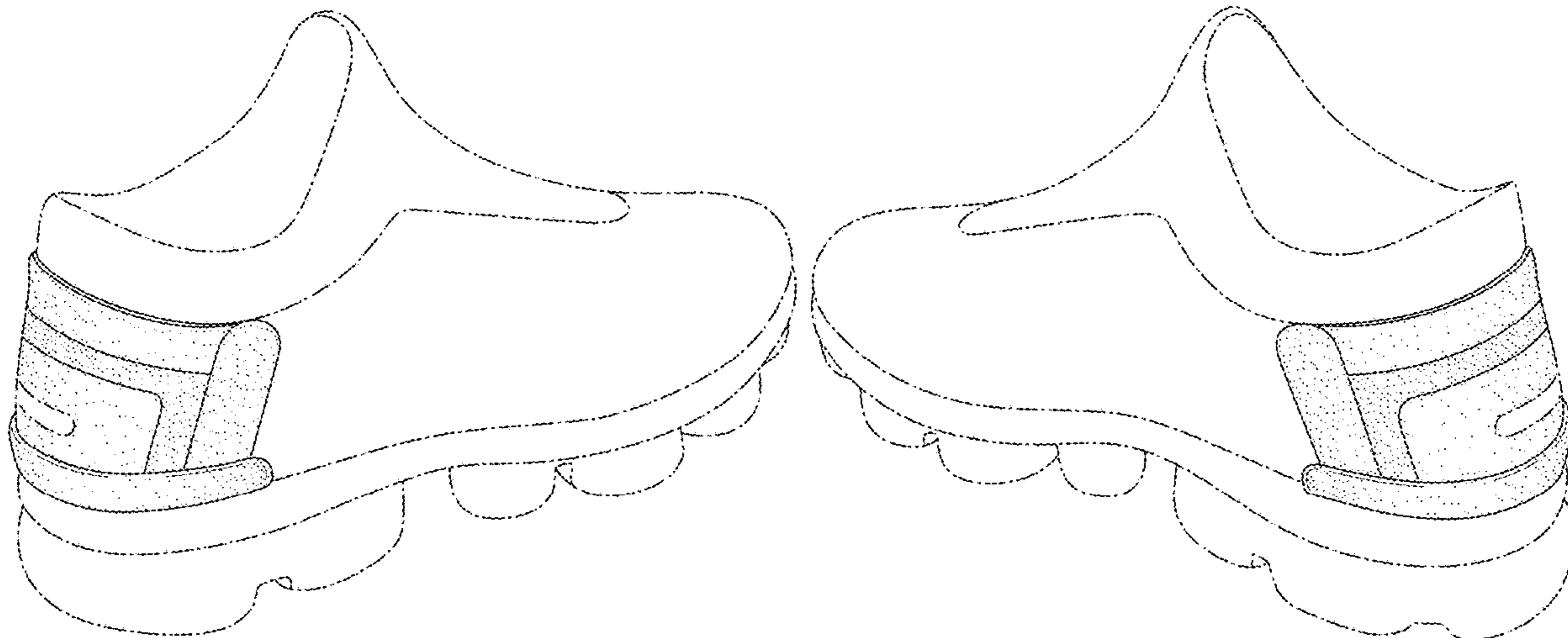
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a shoe showing my new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is an opposite side rear perspective view thereof; and,
FIG. 5 is an opposite side view thereof.

The broken line showing of the oval shaped region within the shaded area forms no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

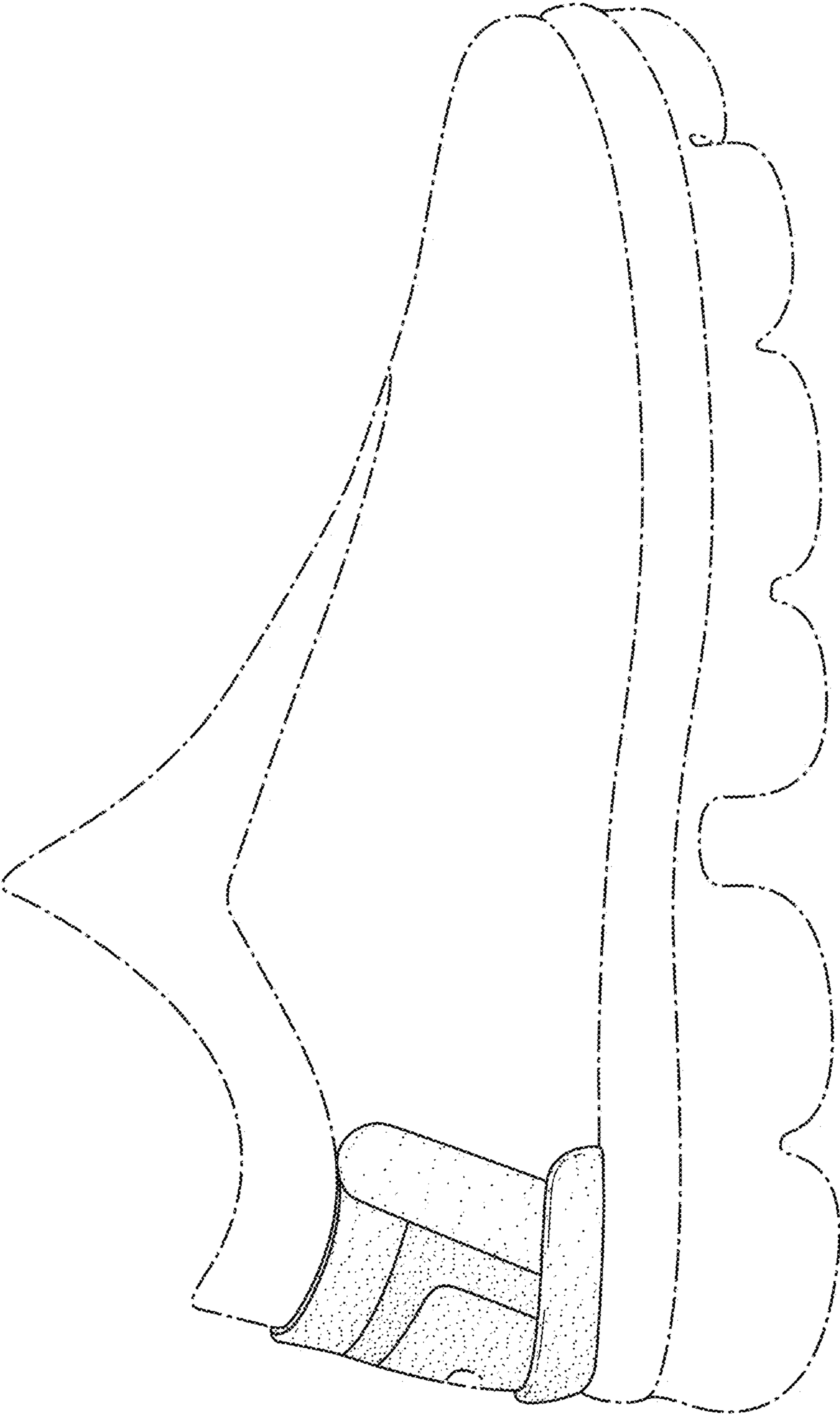

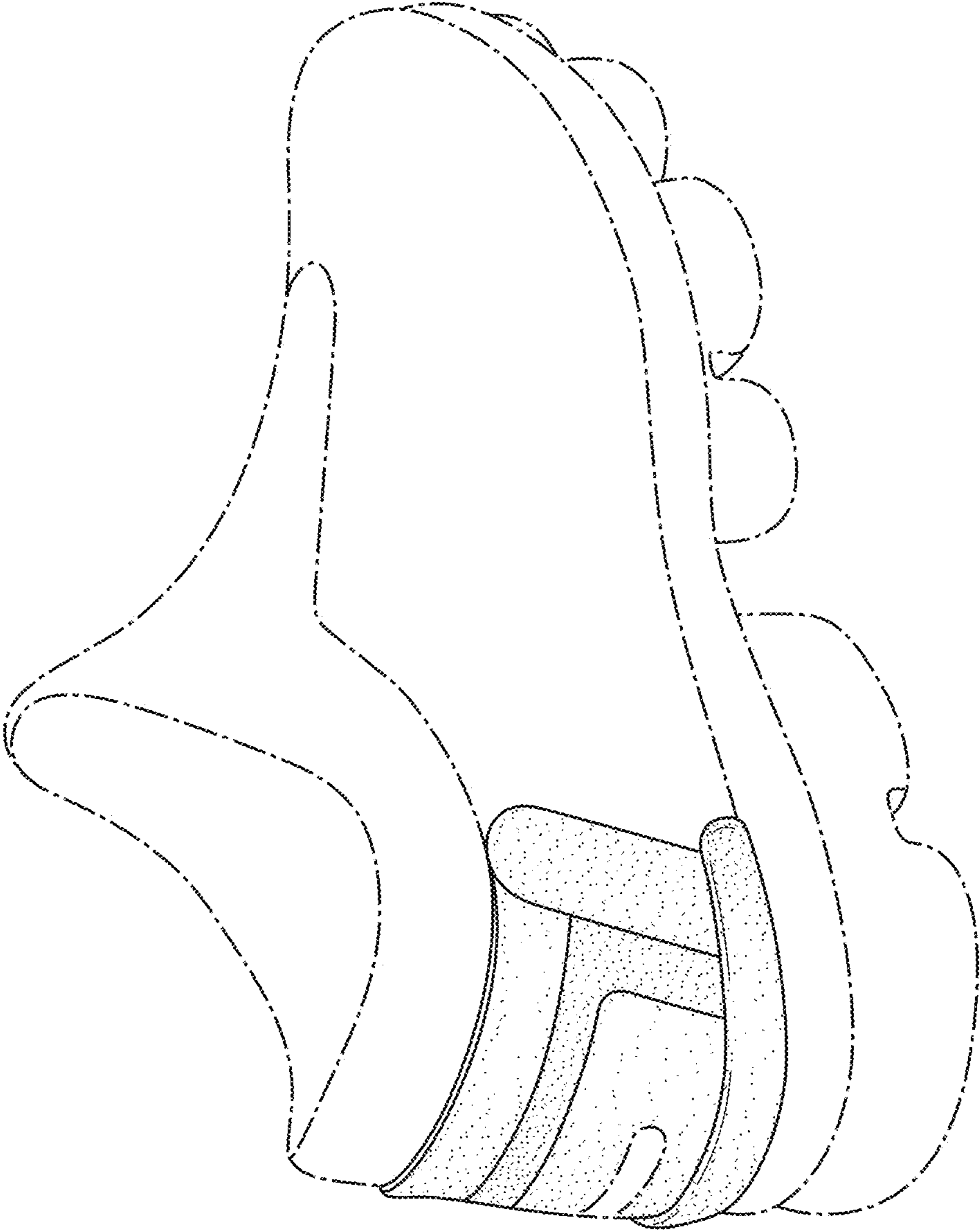

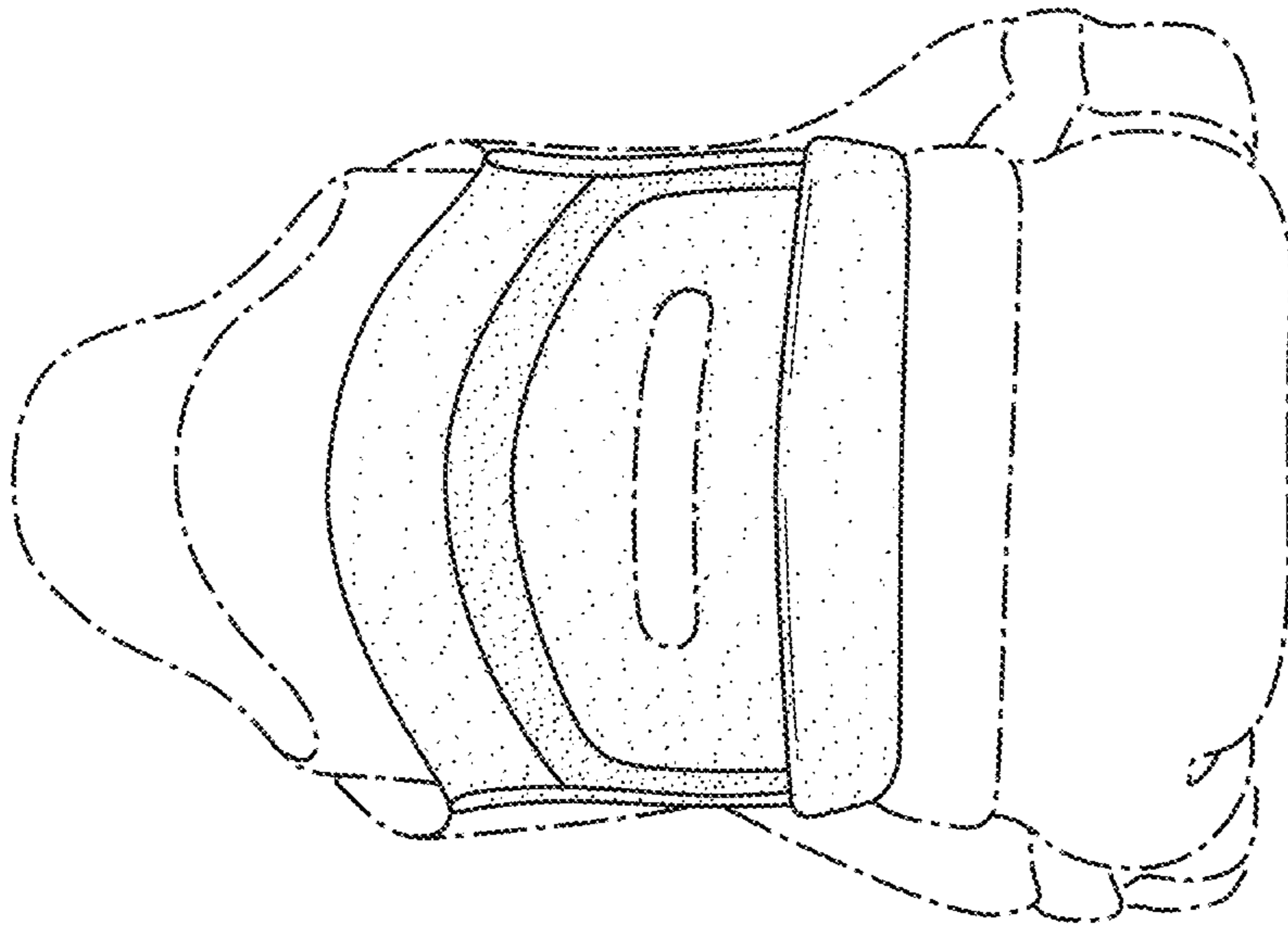

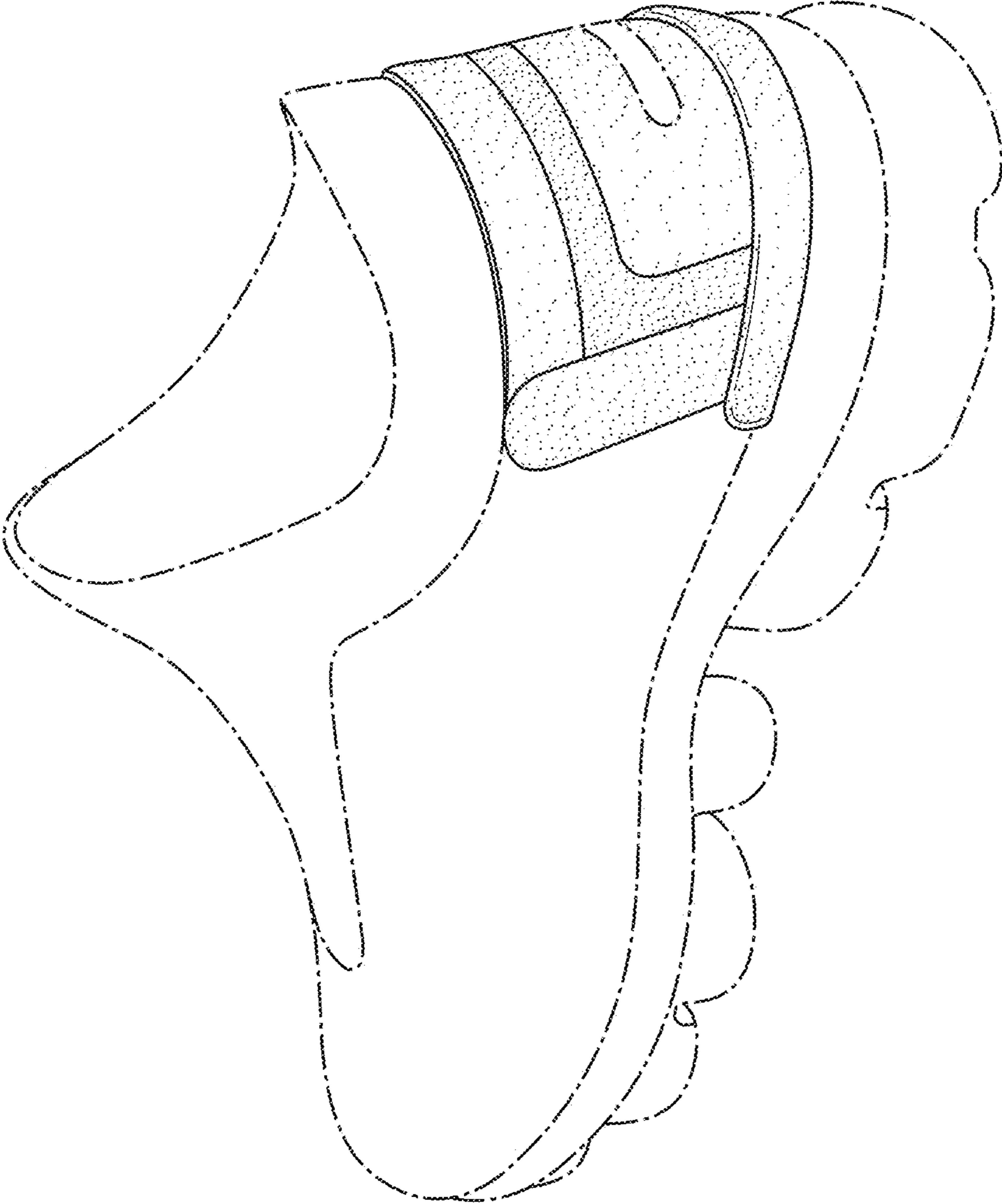

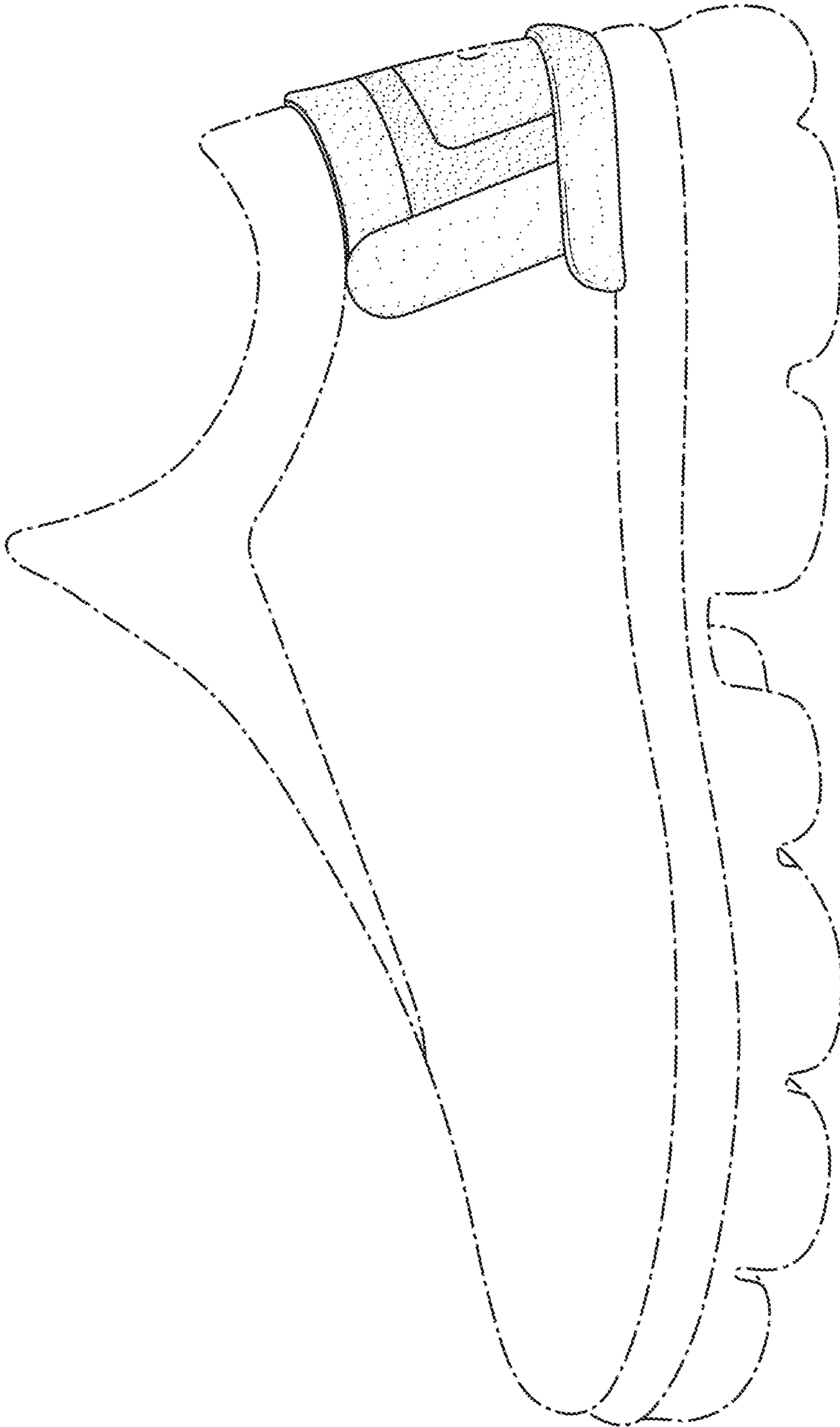
