FIG. 6 is a right side elevational view of the invention.

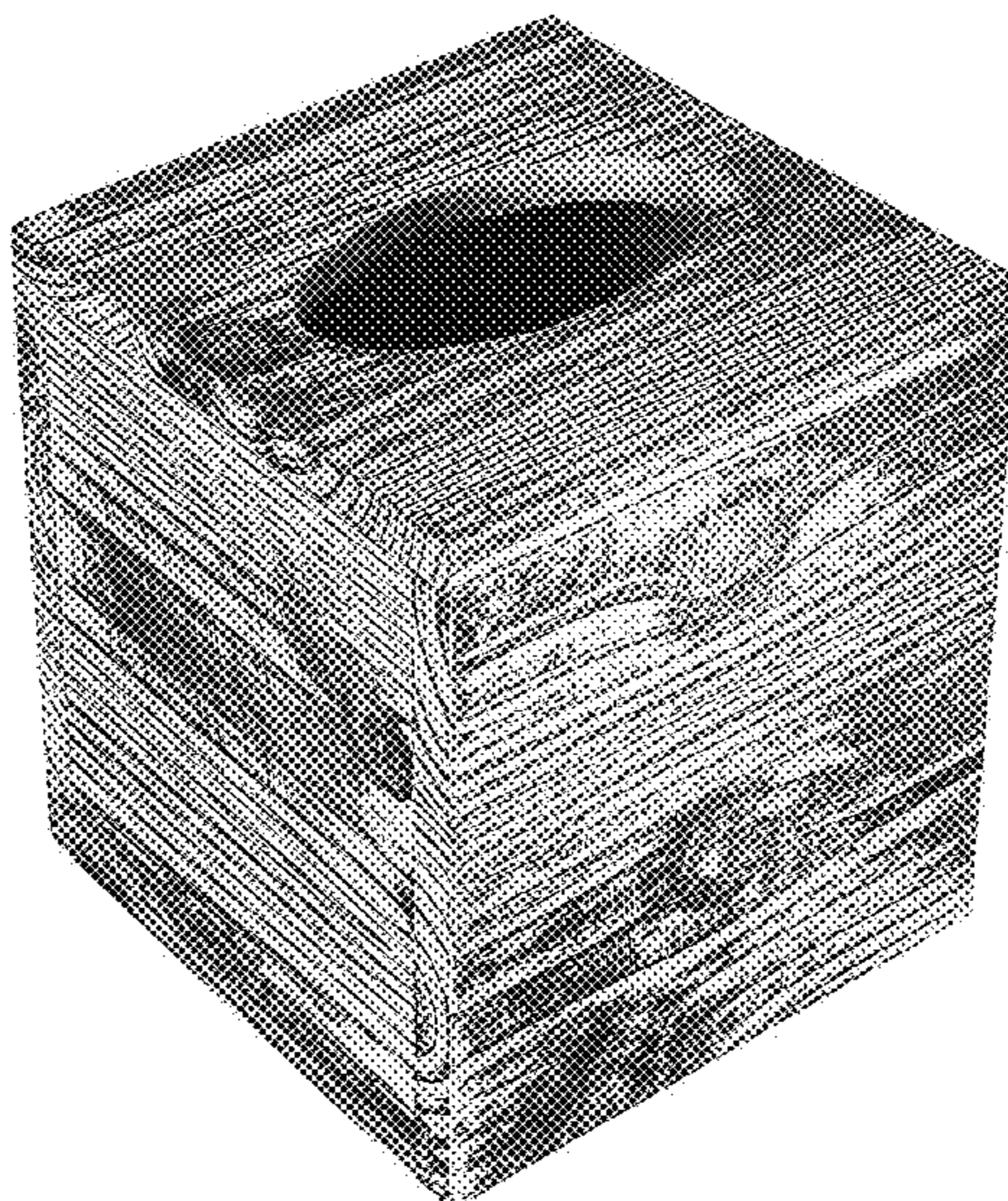
FIG. 7 is a left side elevational view of the invention.

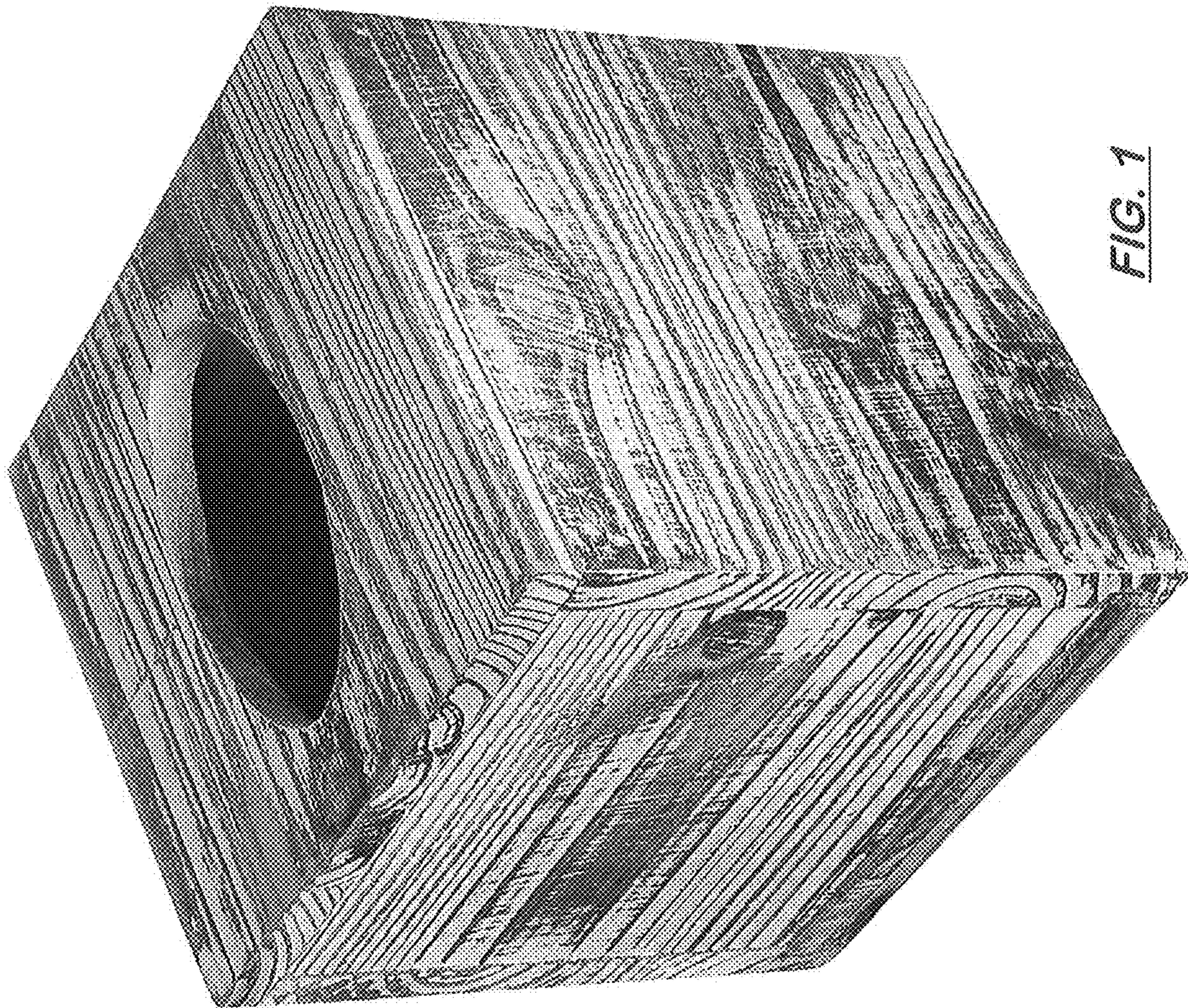

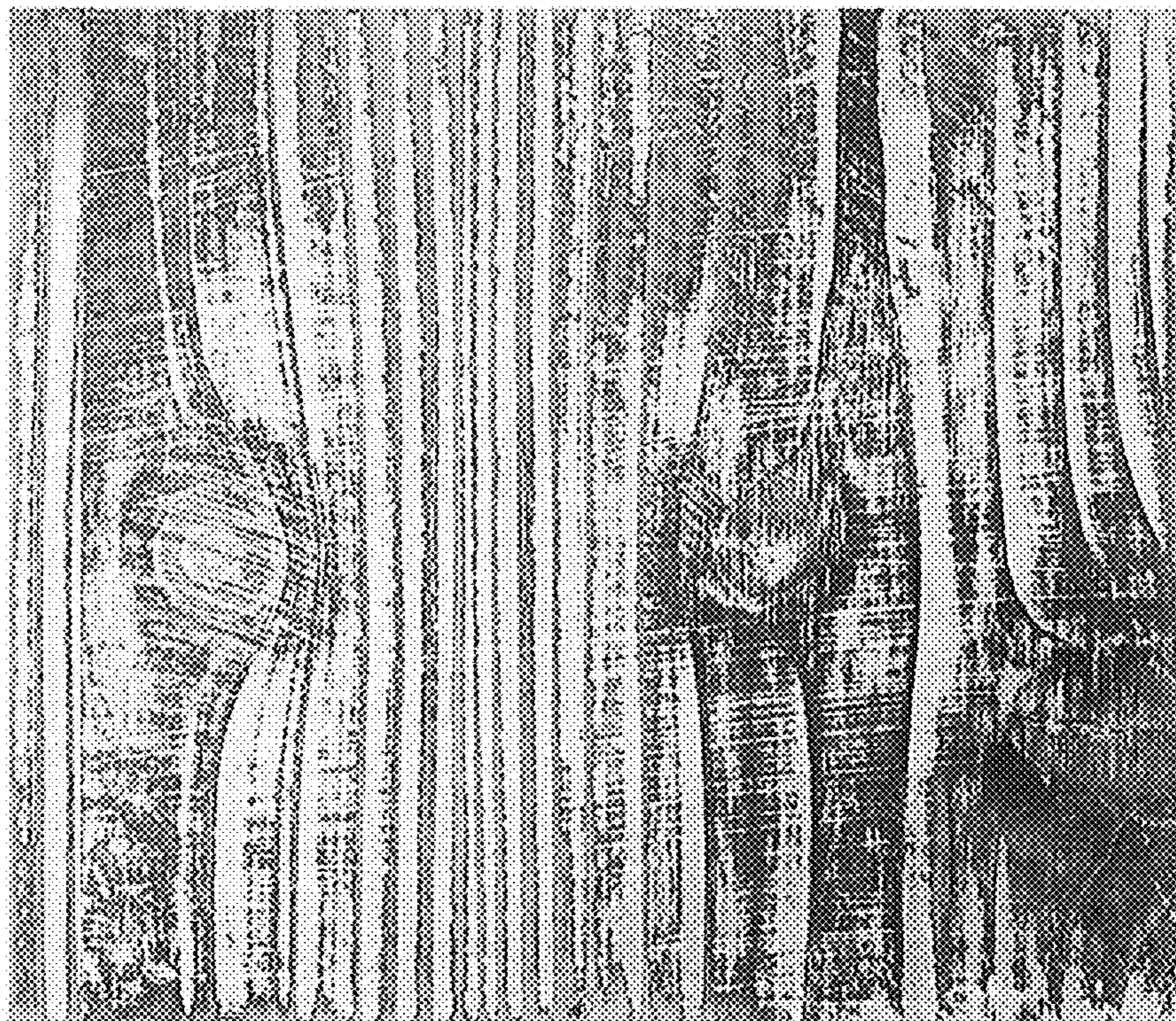

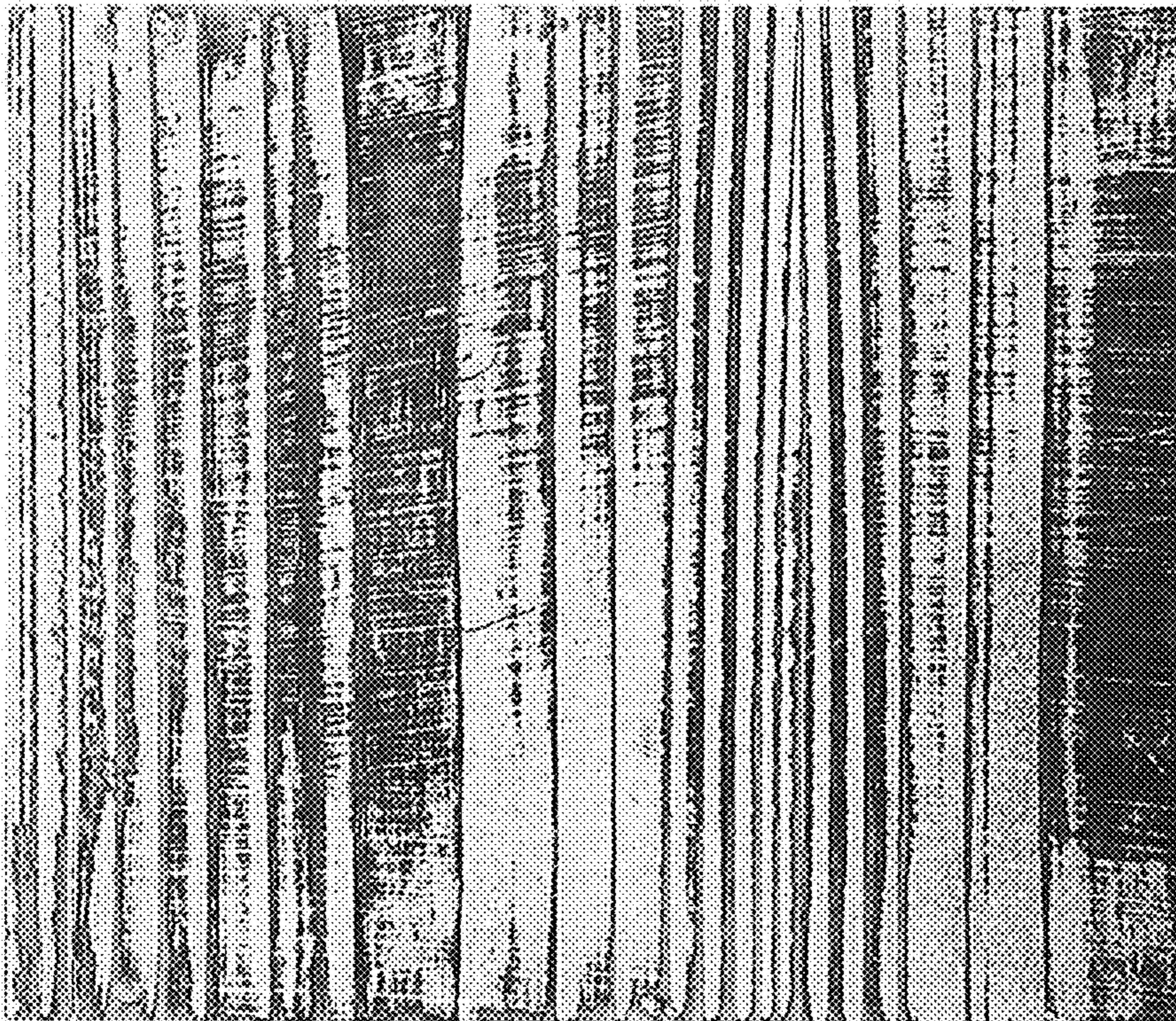

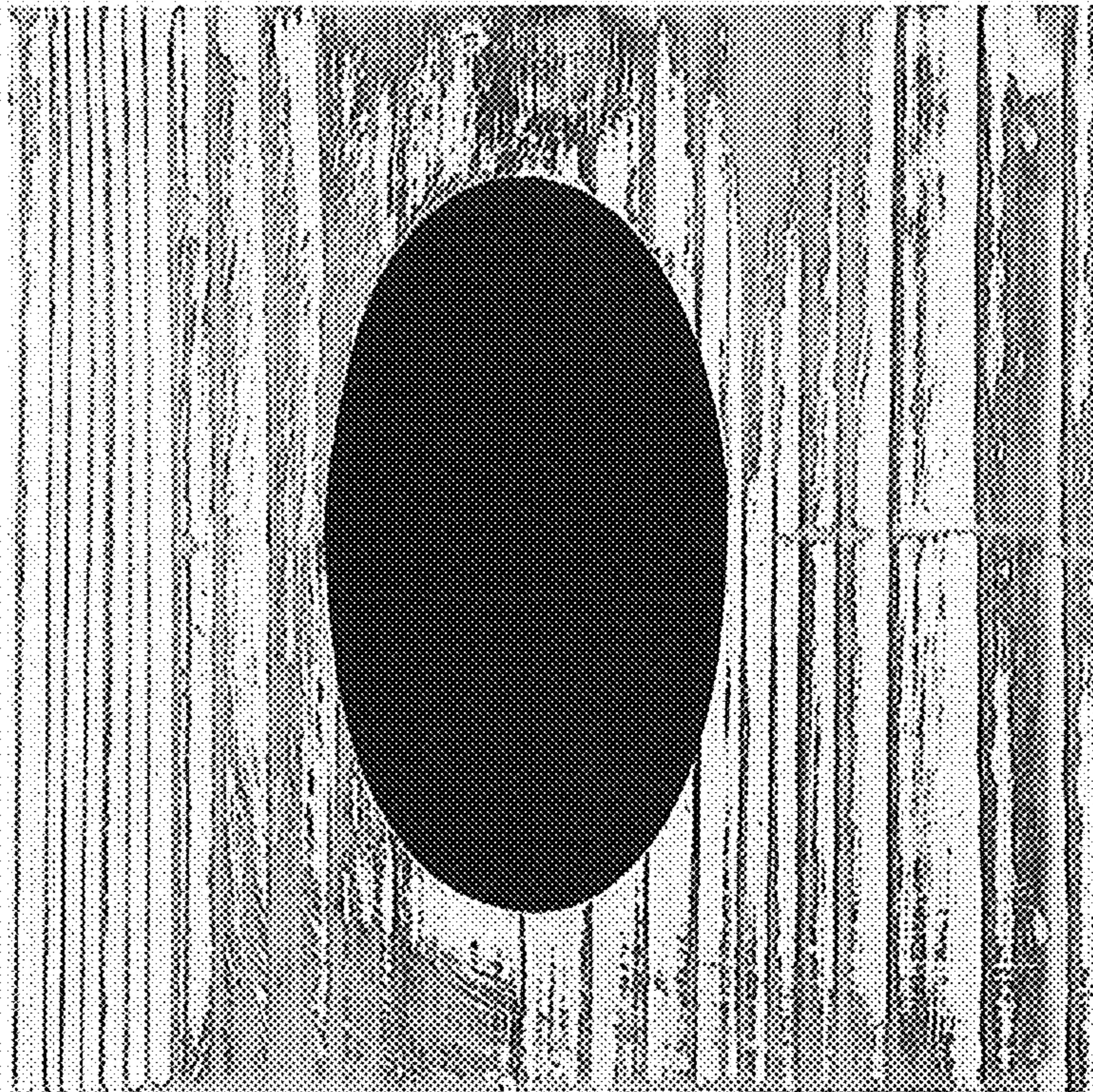

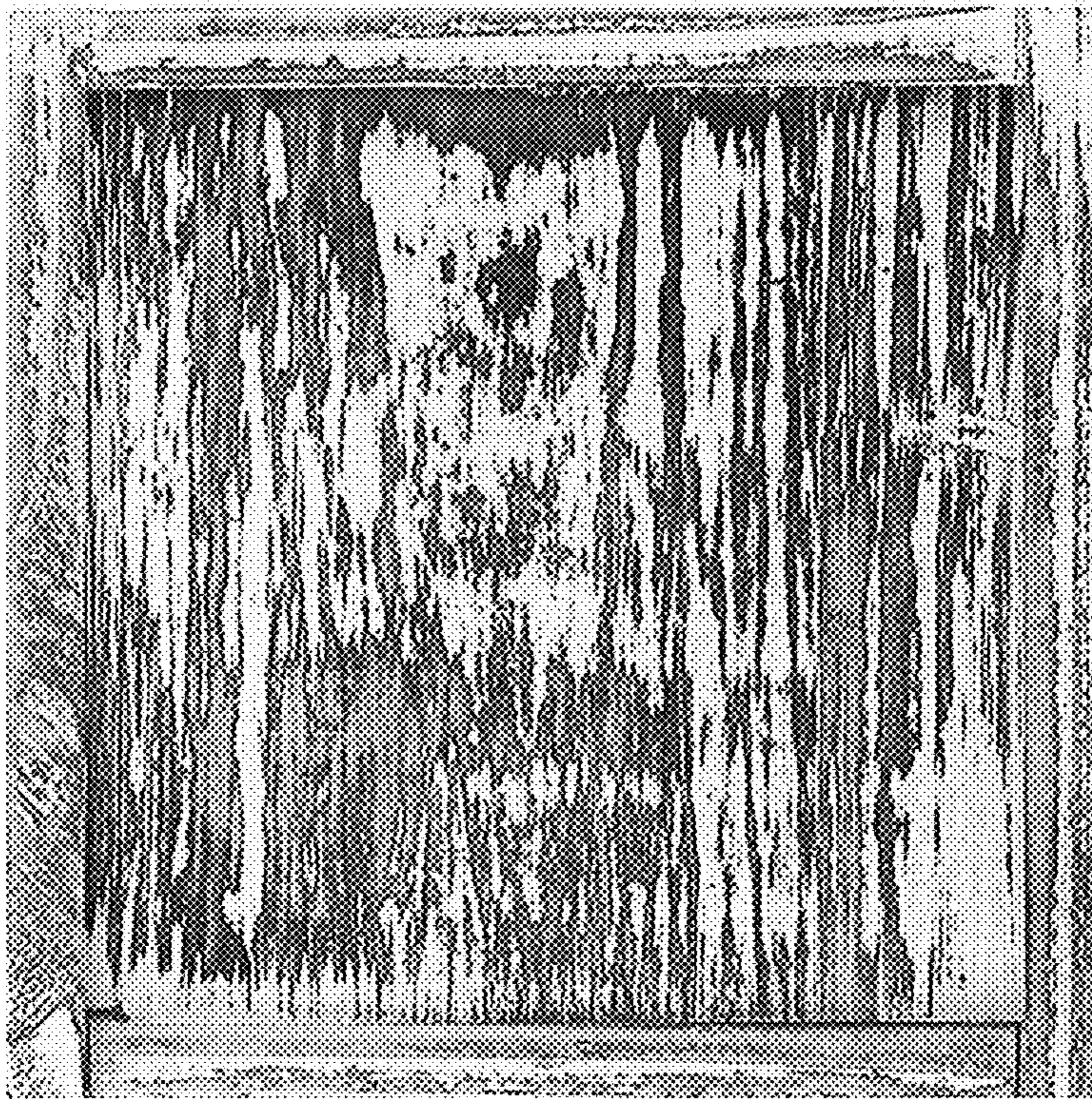

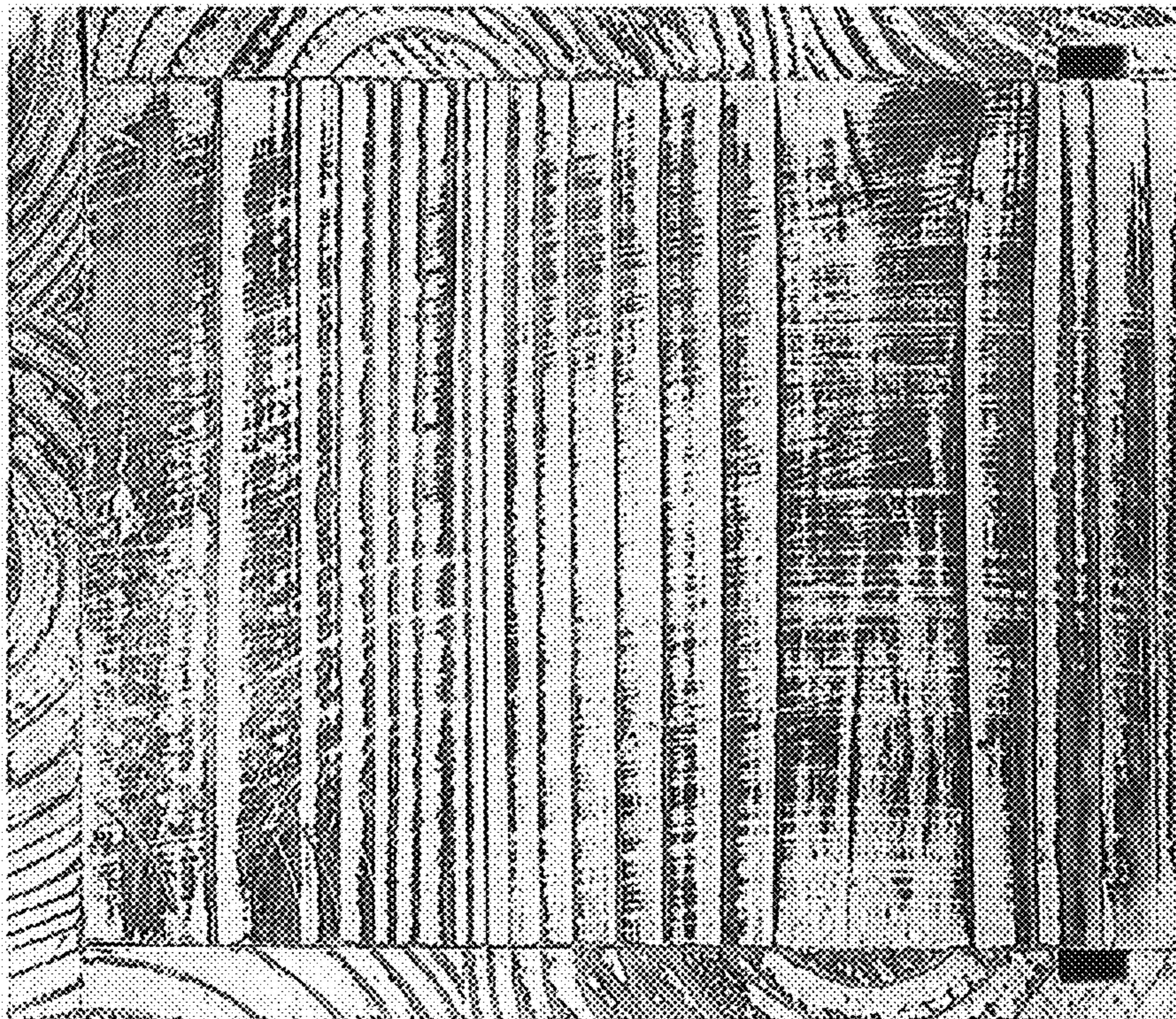

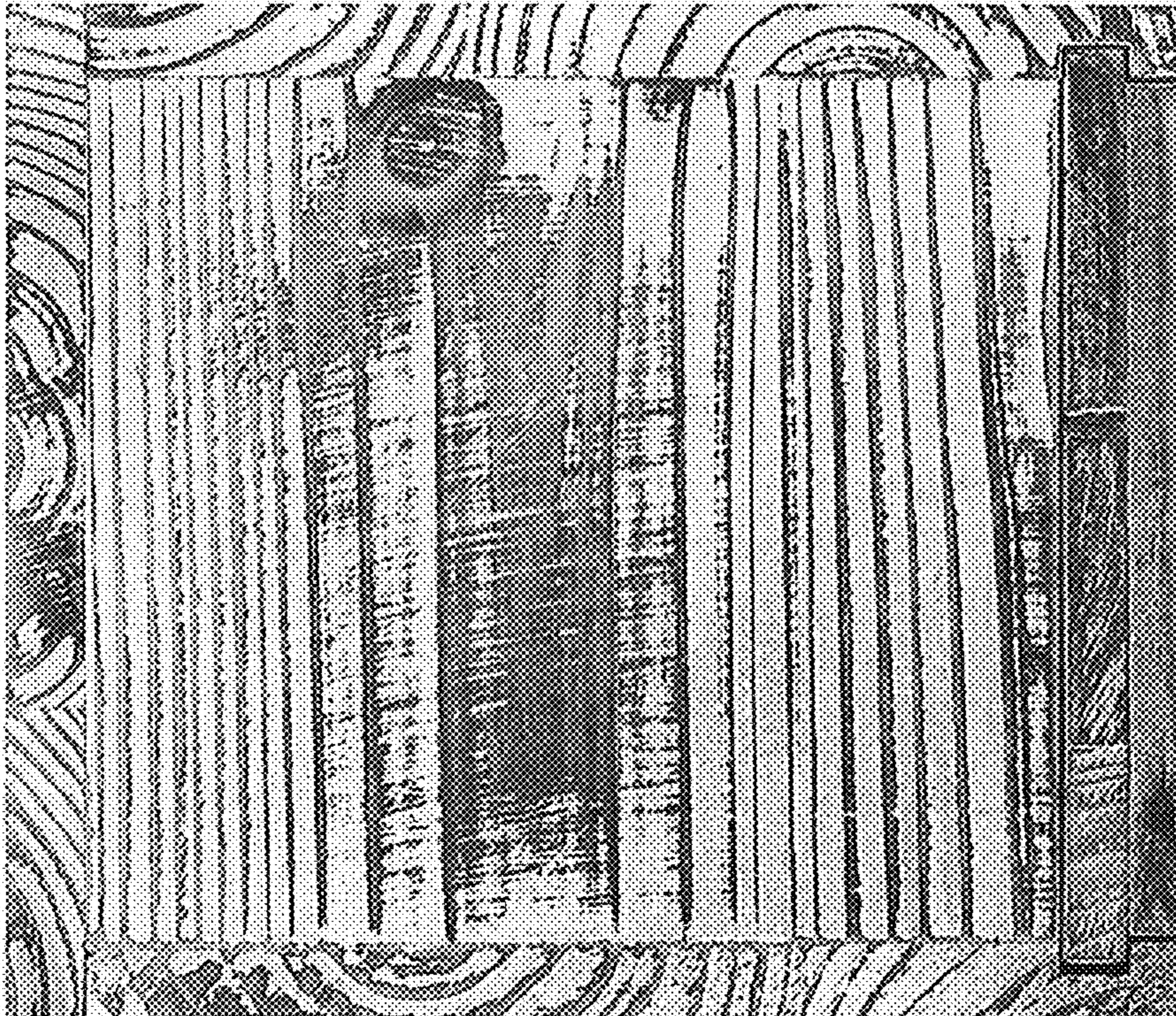

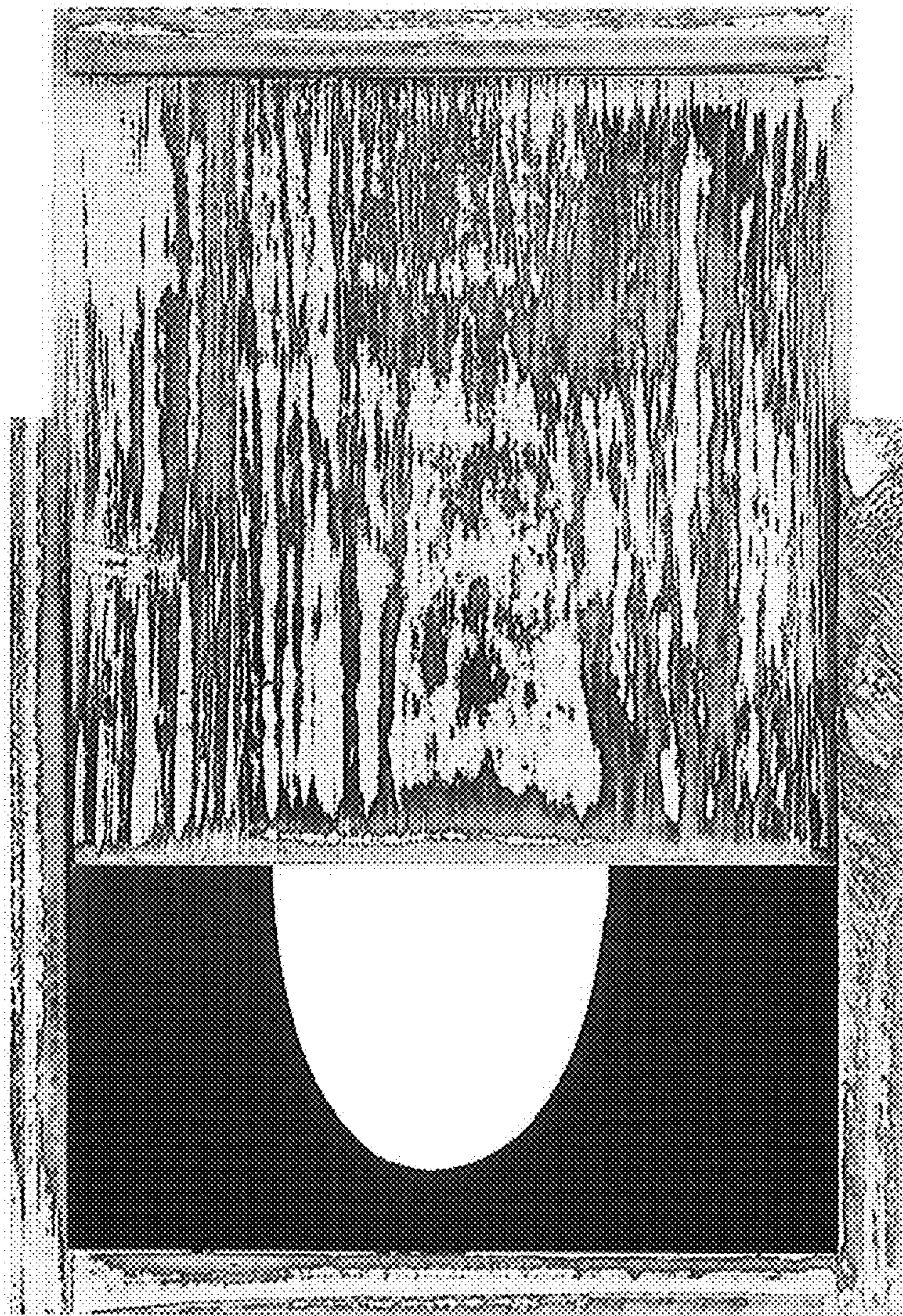

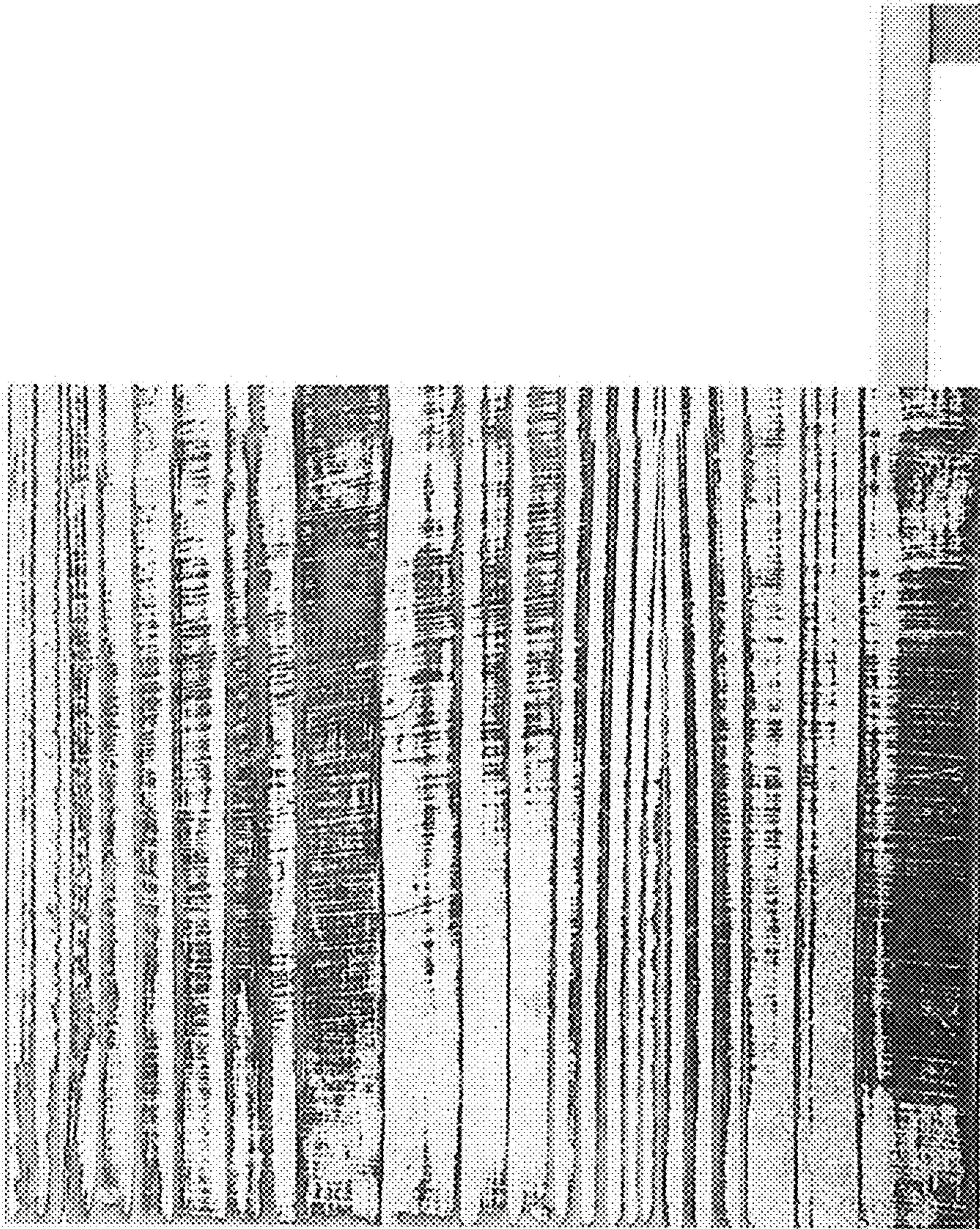

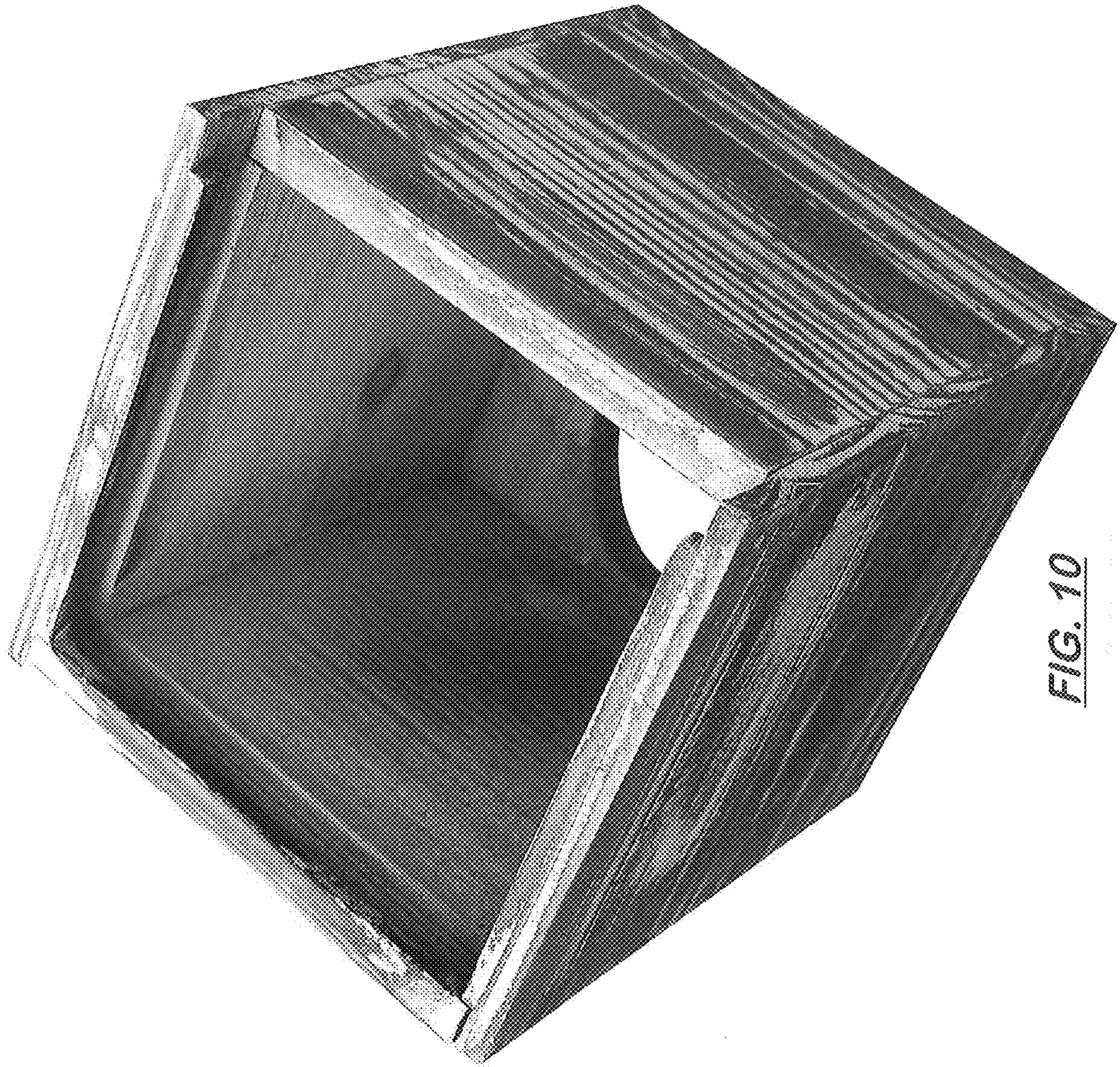
