**DESCRIPTION**

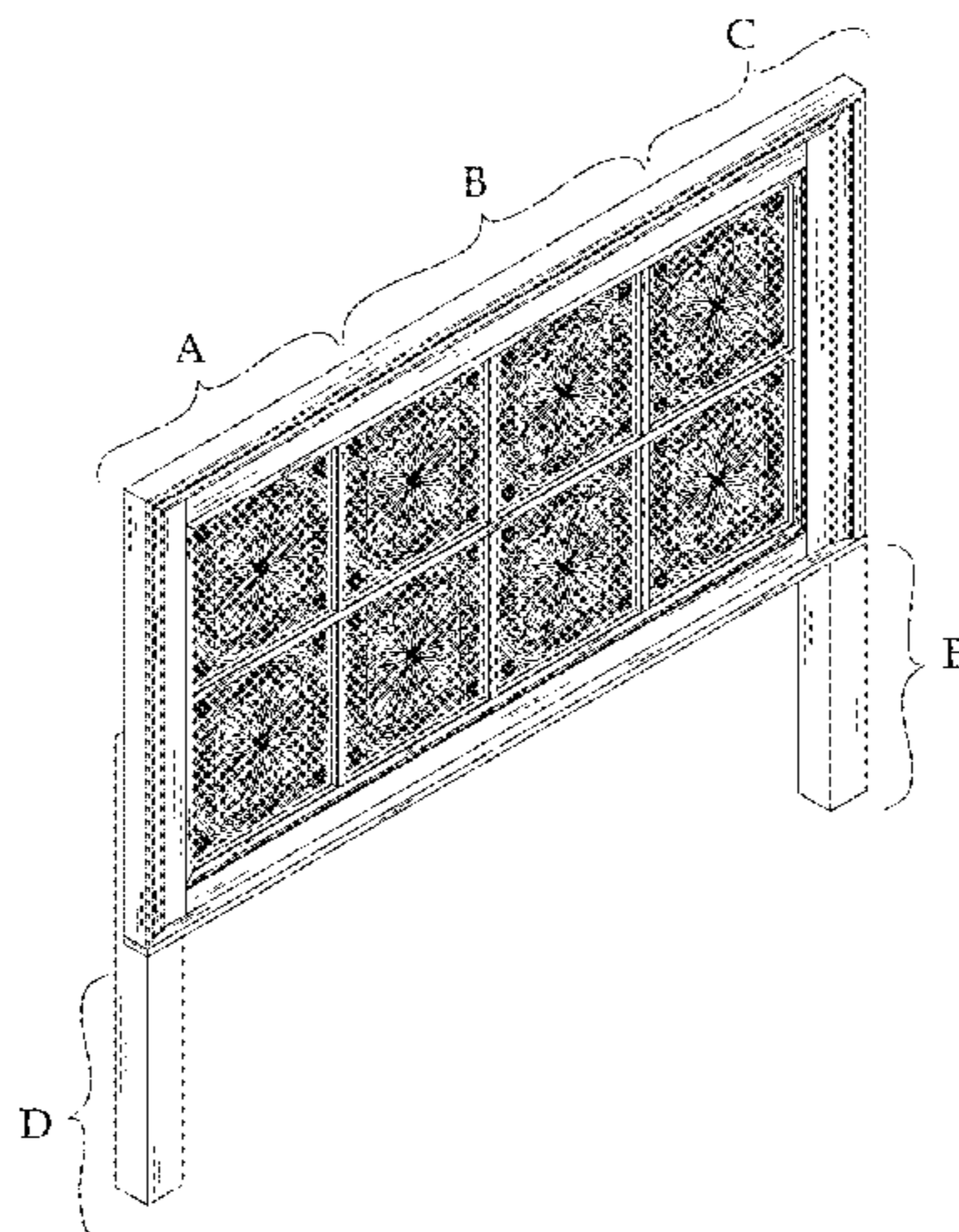


FIG. 8B pictures a partial view of the headboard of FIG. 8 as seen by bracket B;

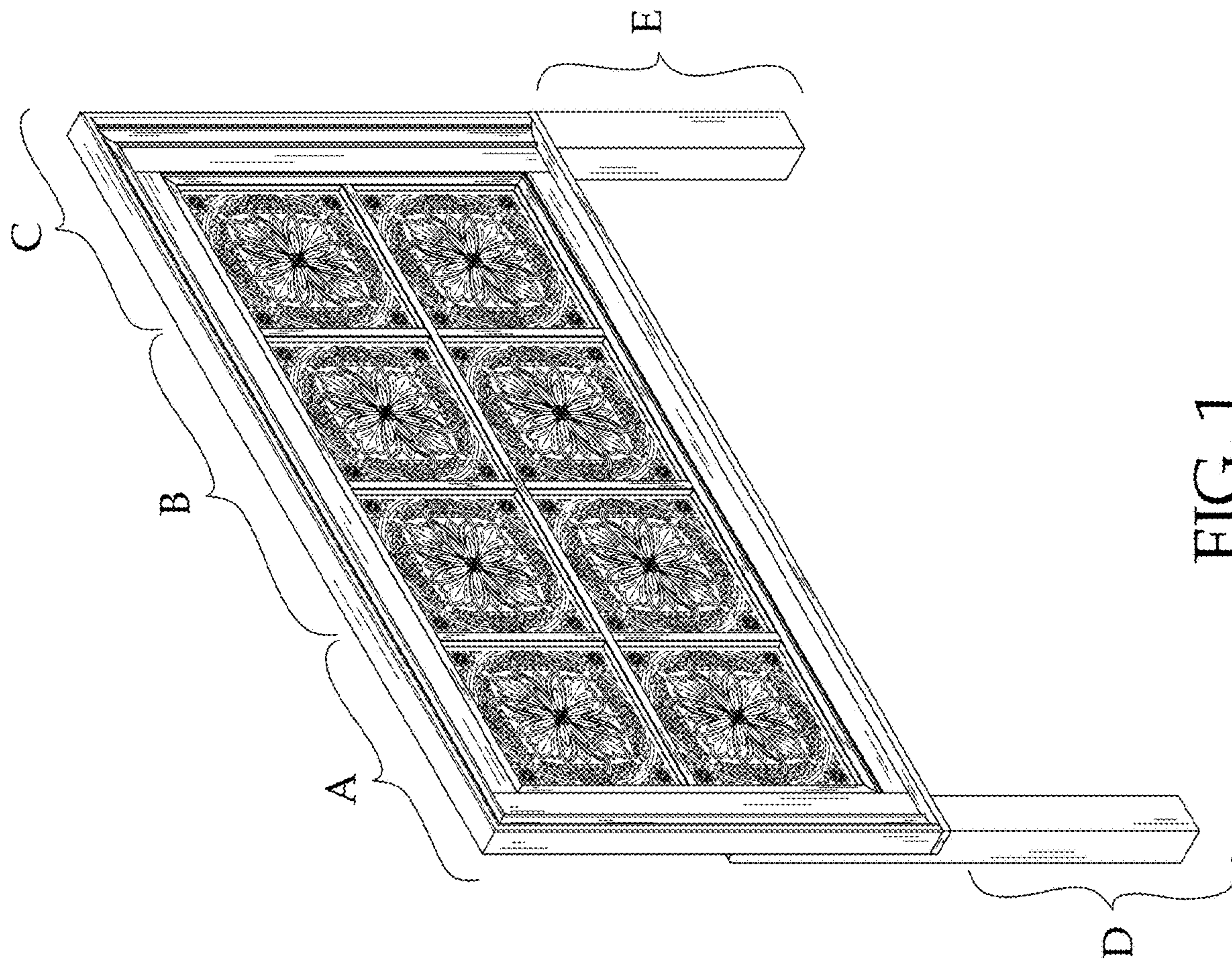
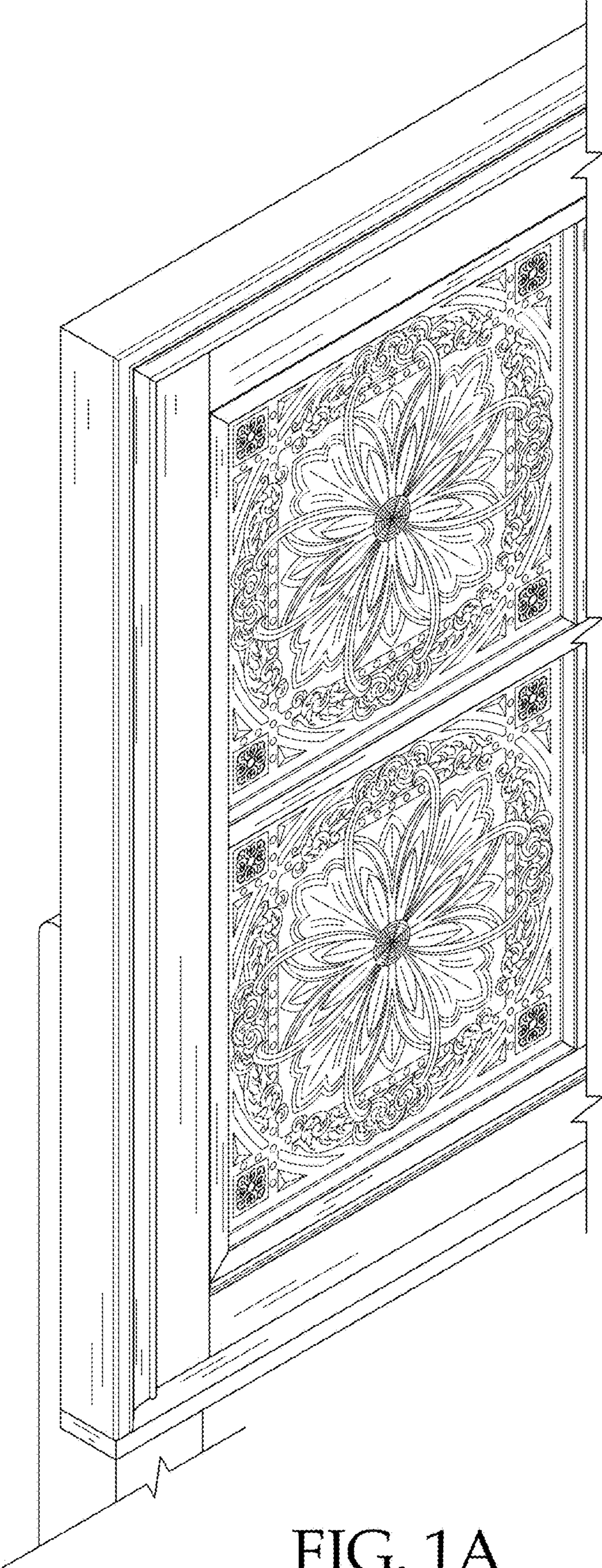

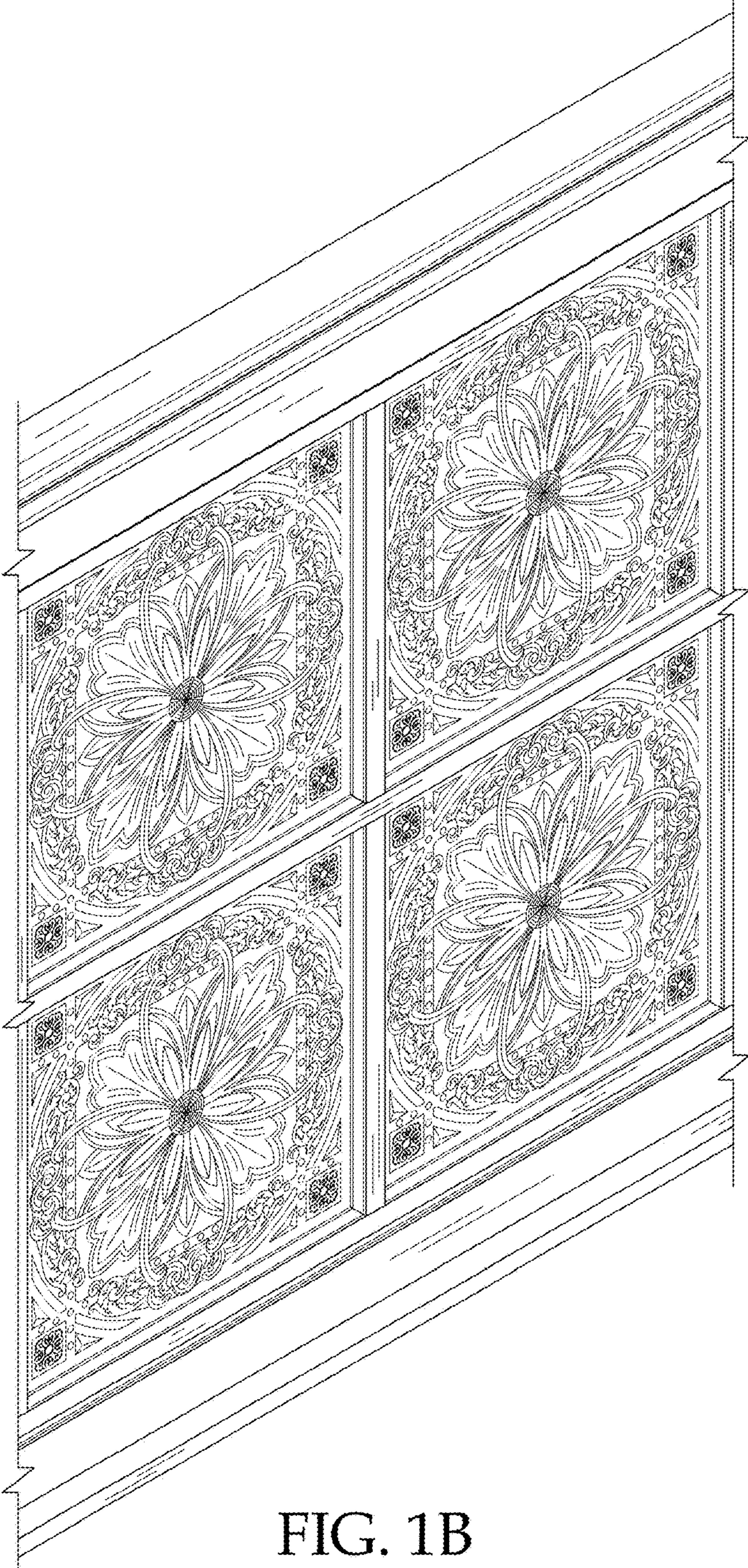

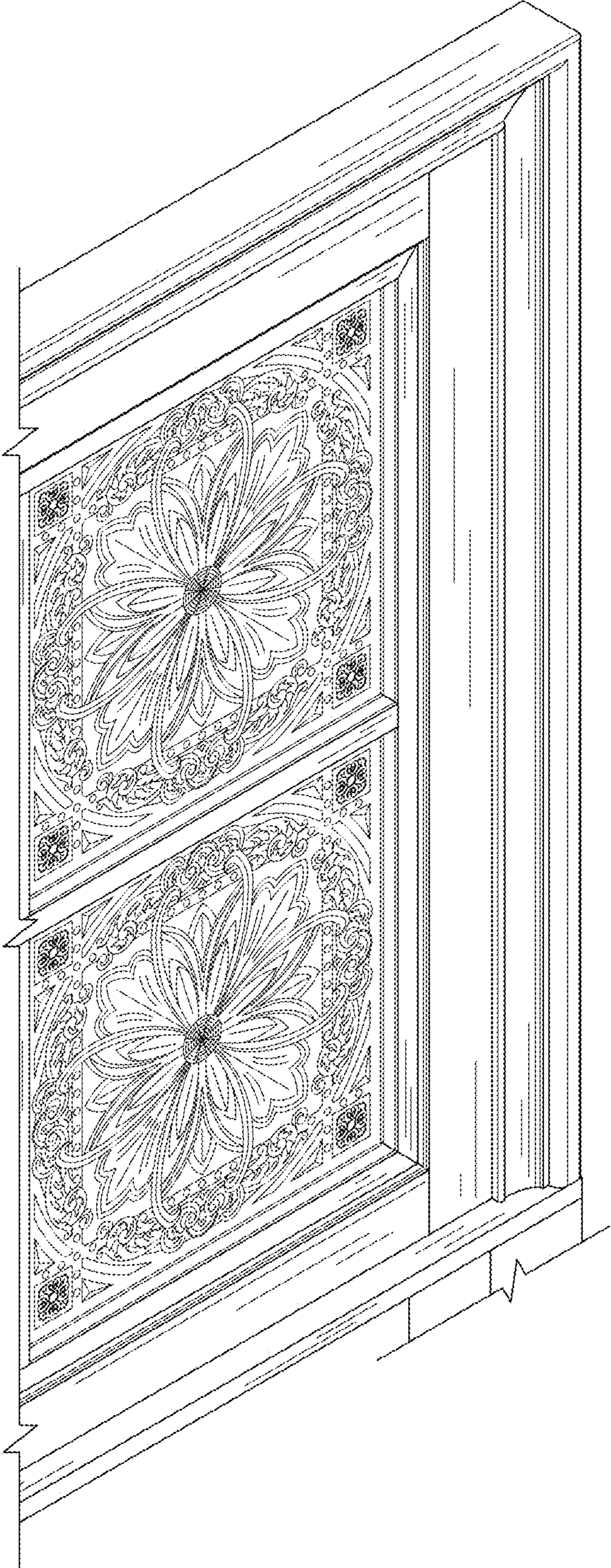

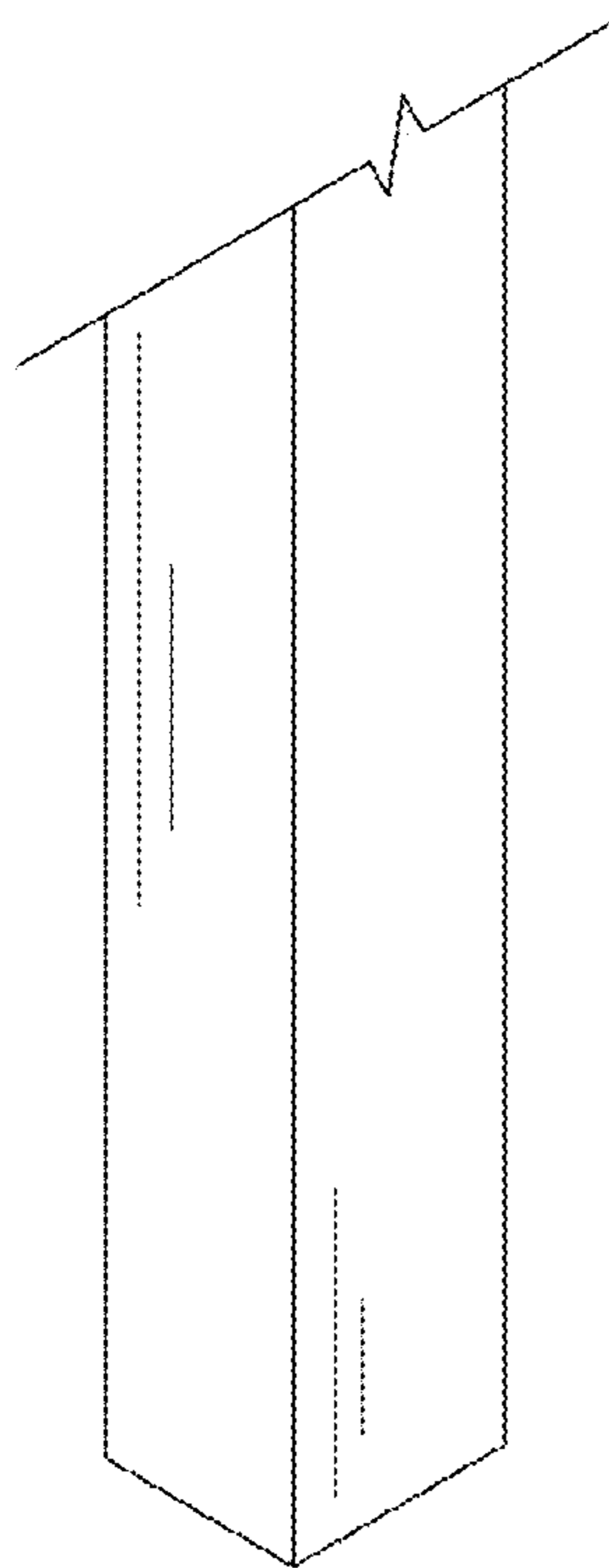

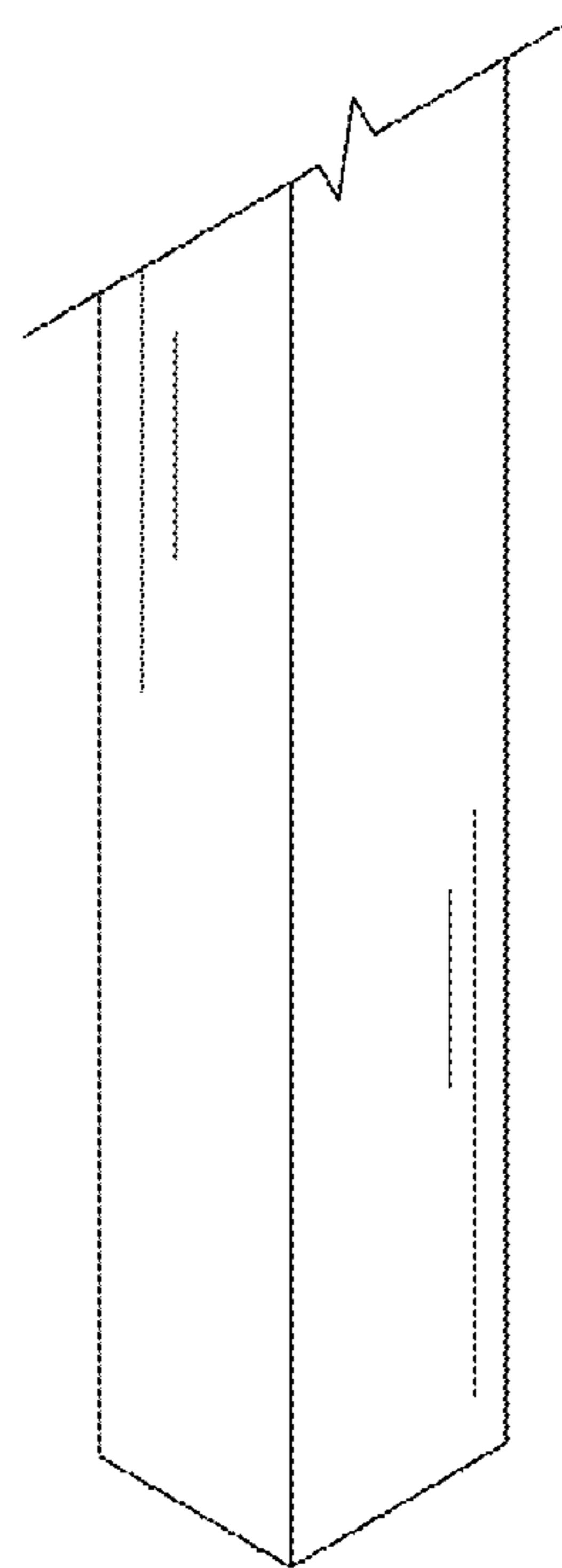

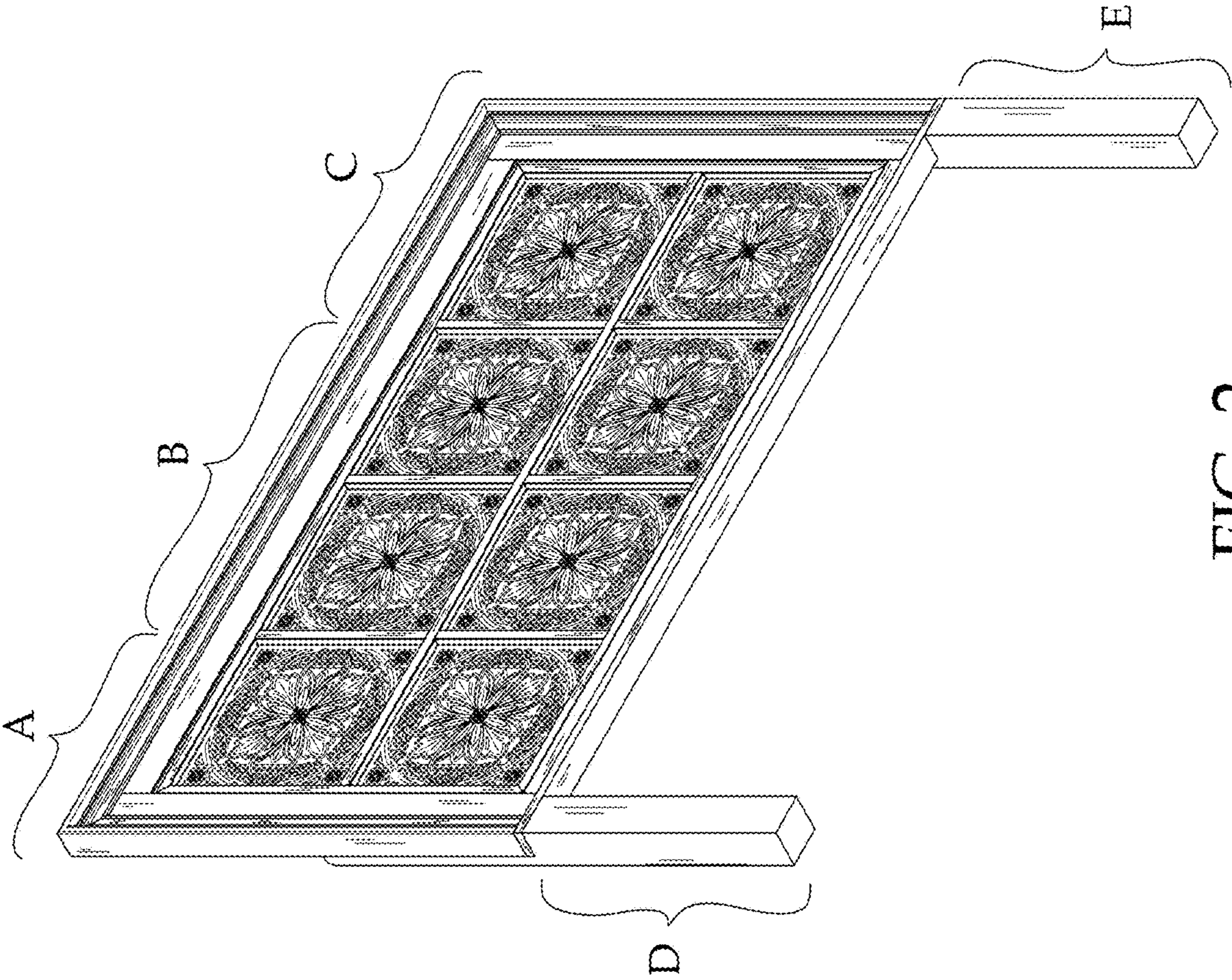

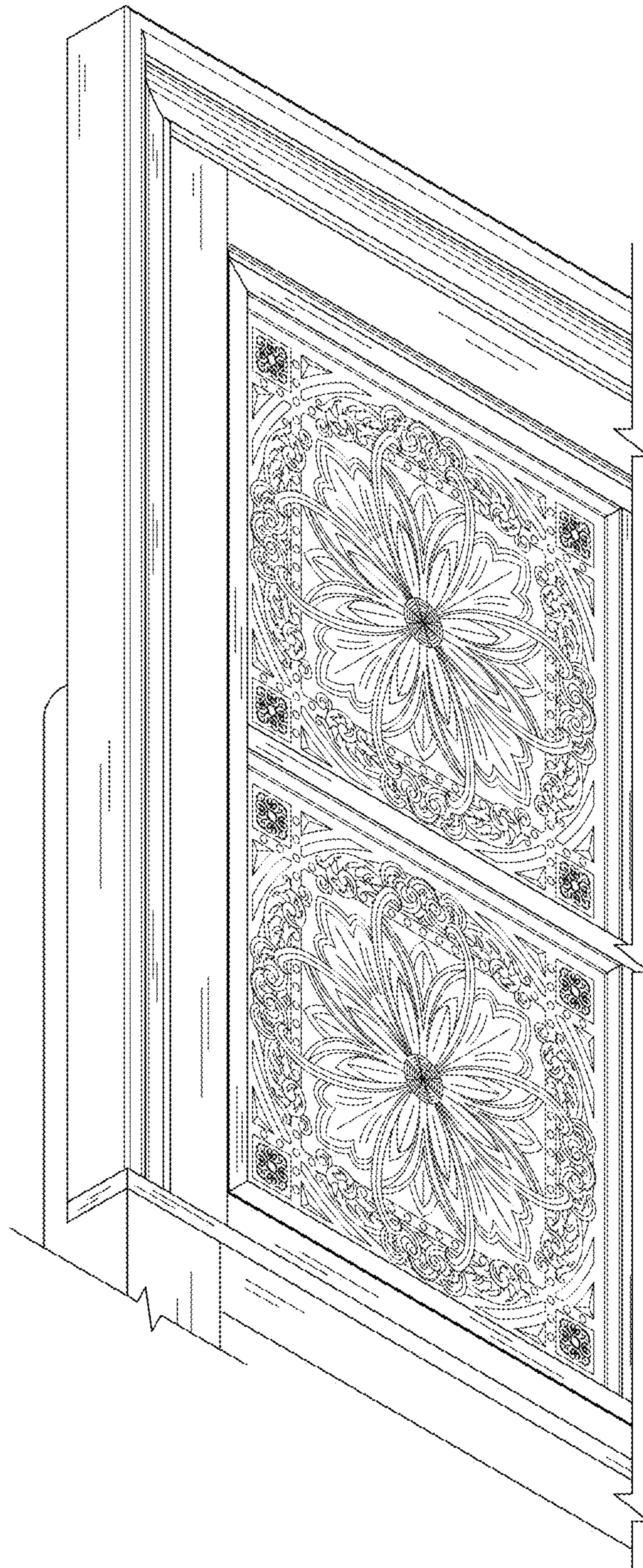

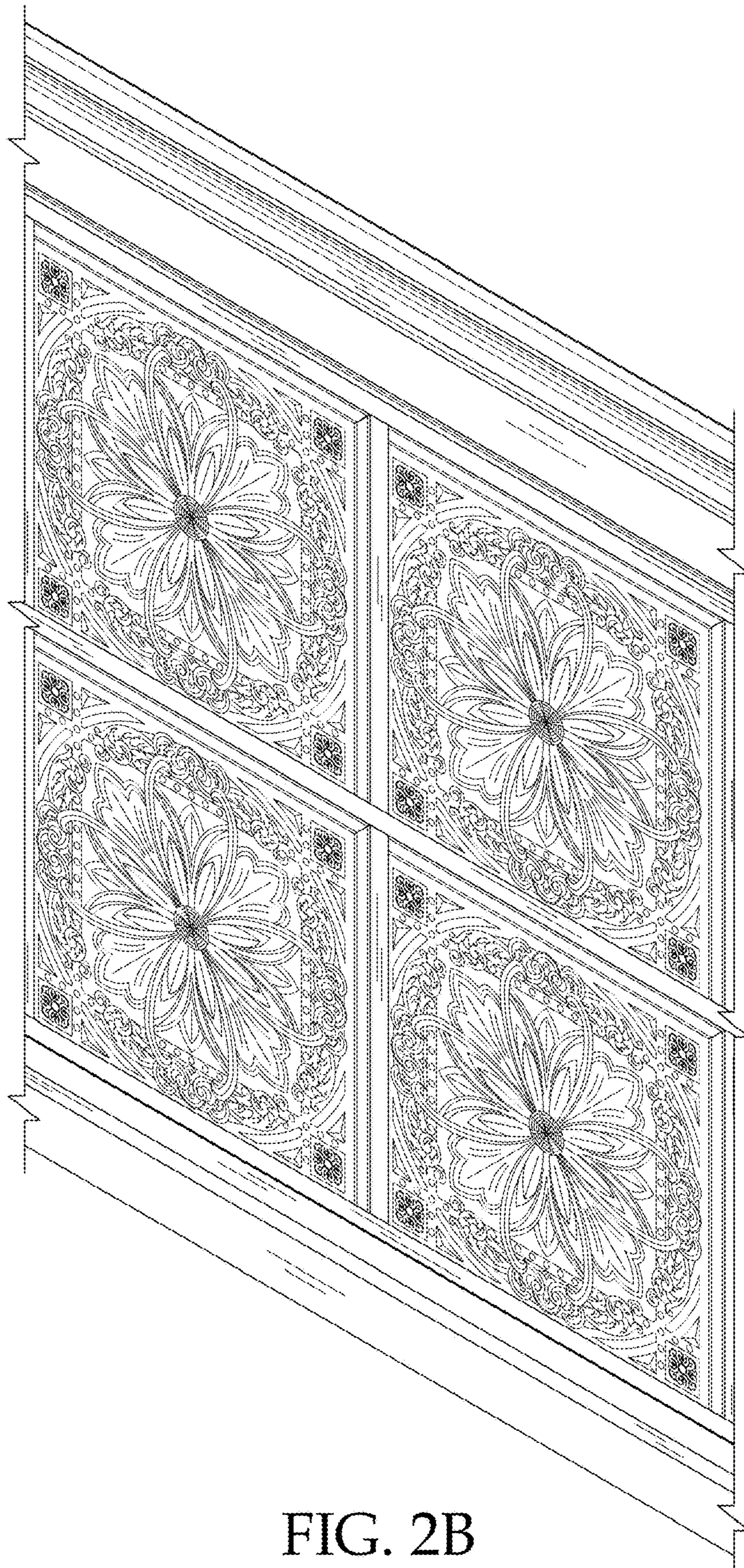

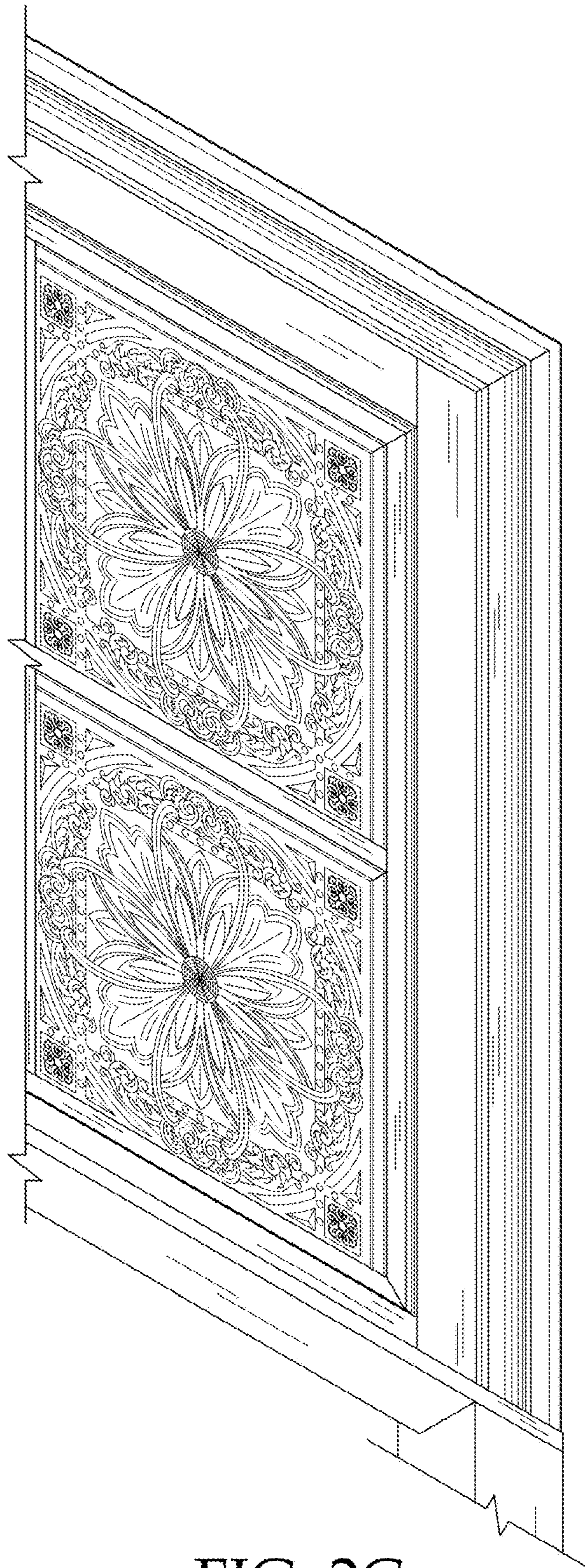

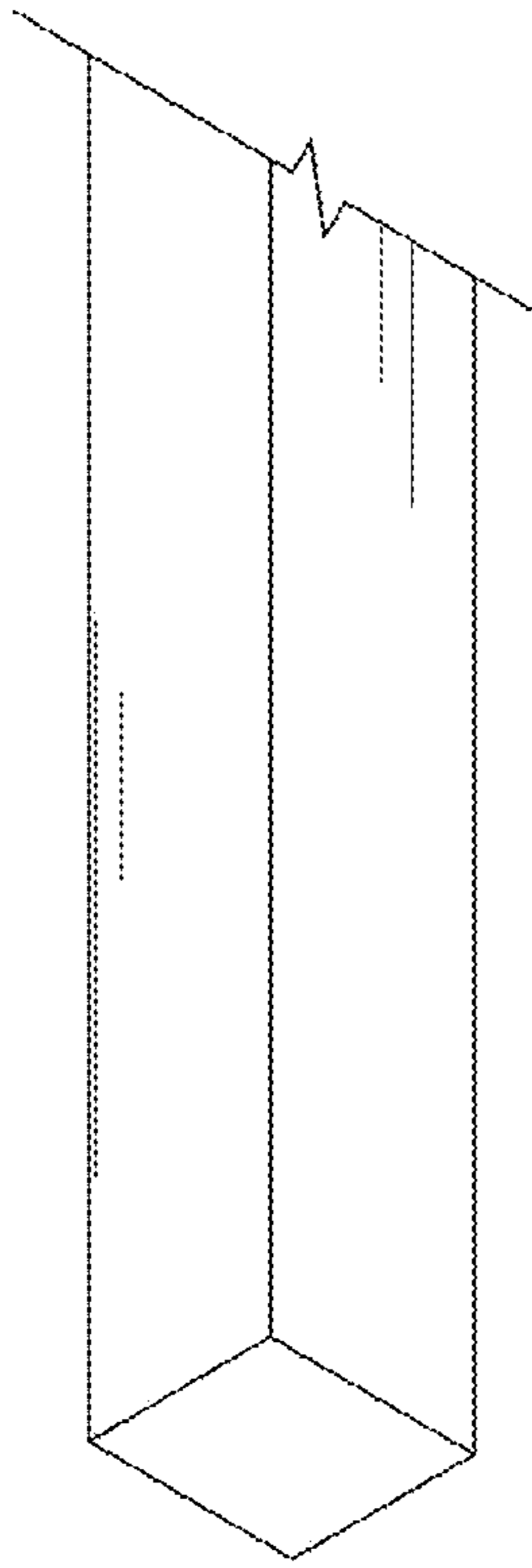

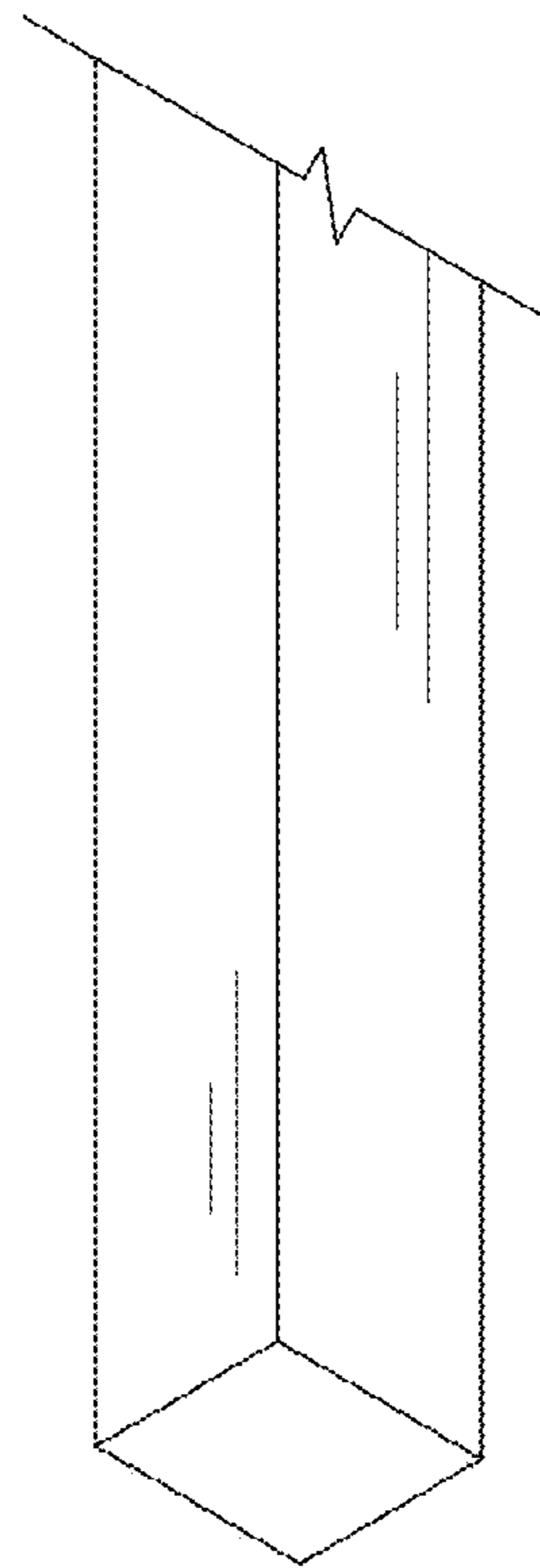

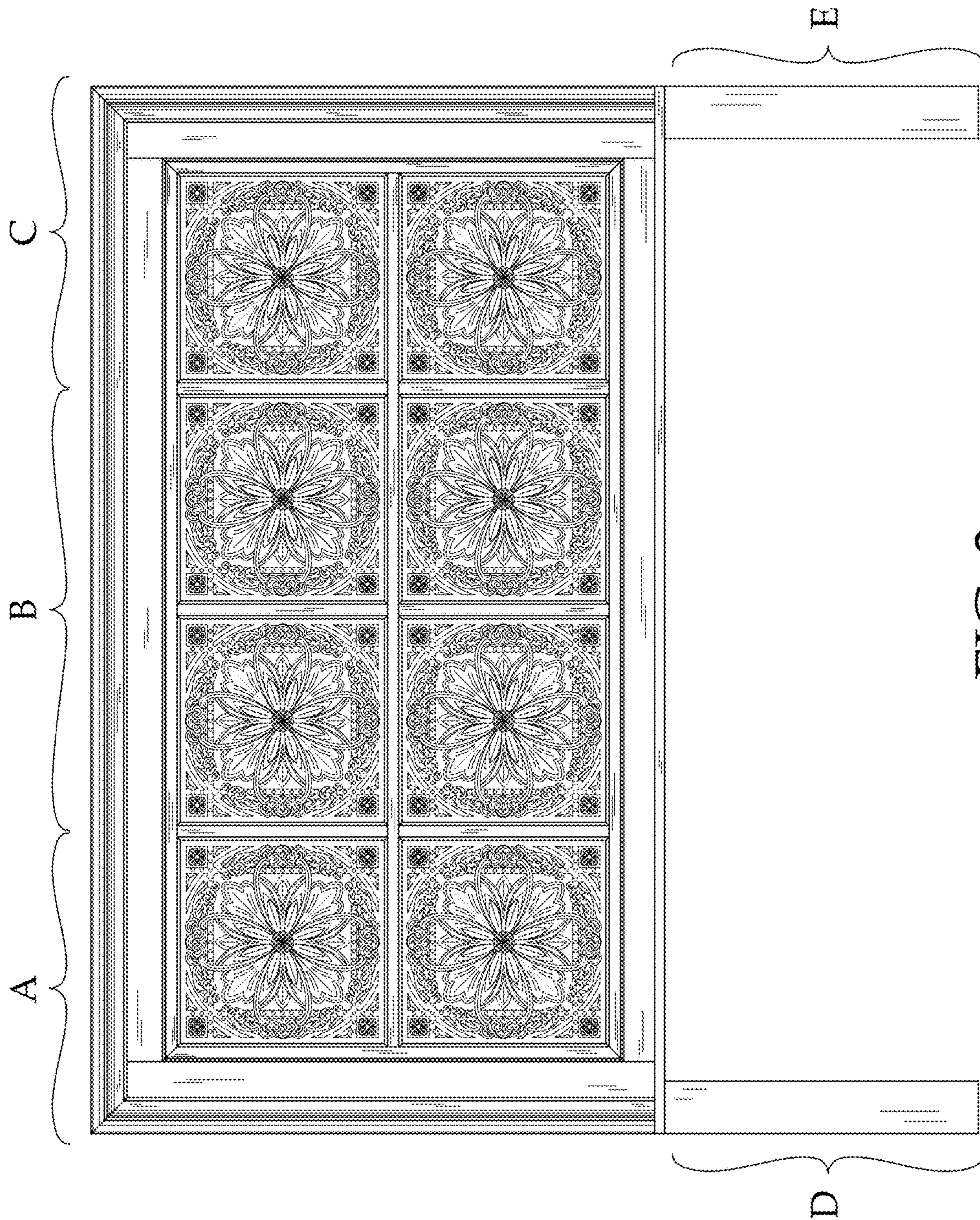

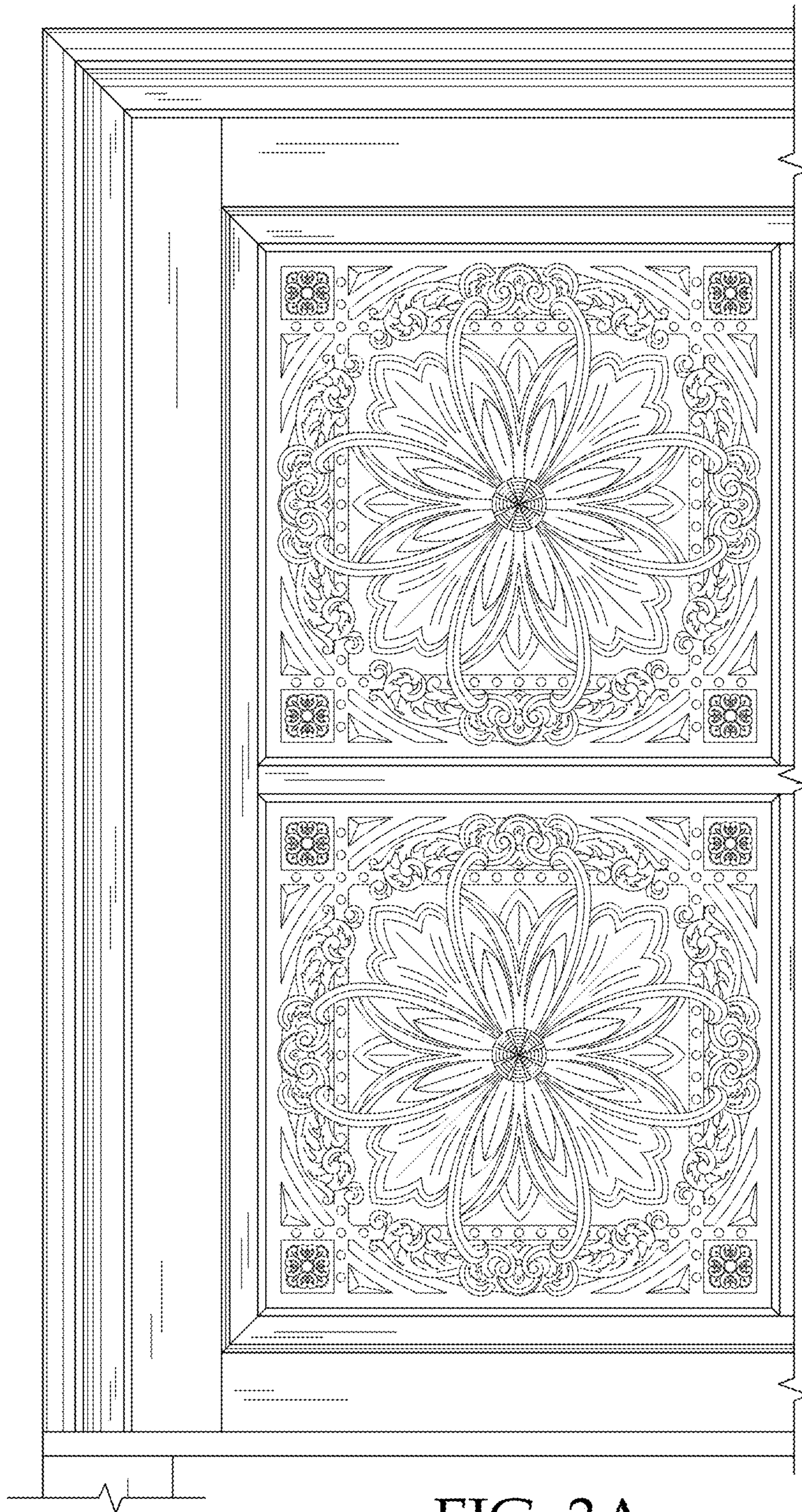

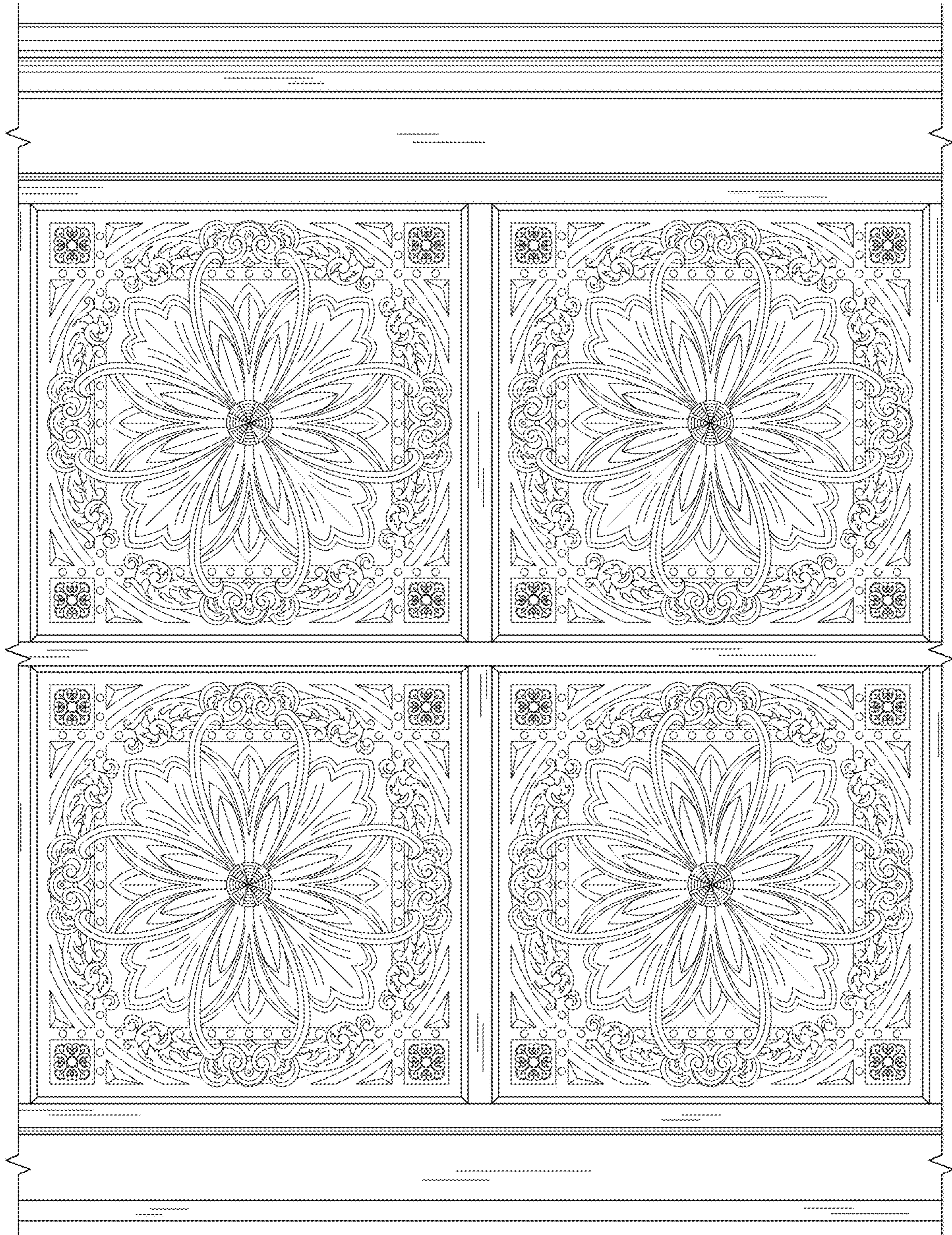

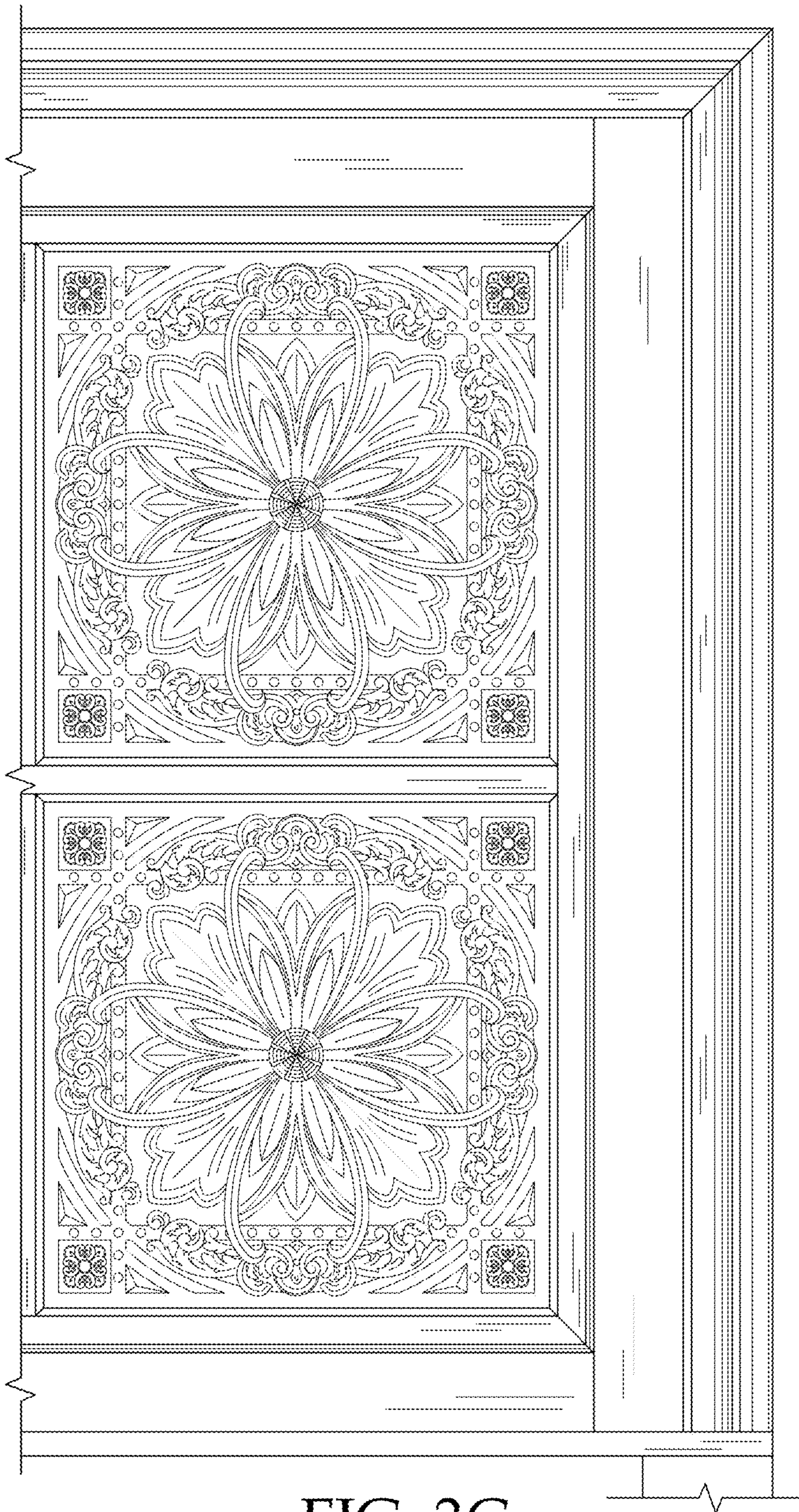

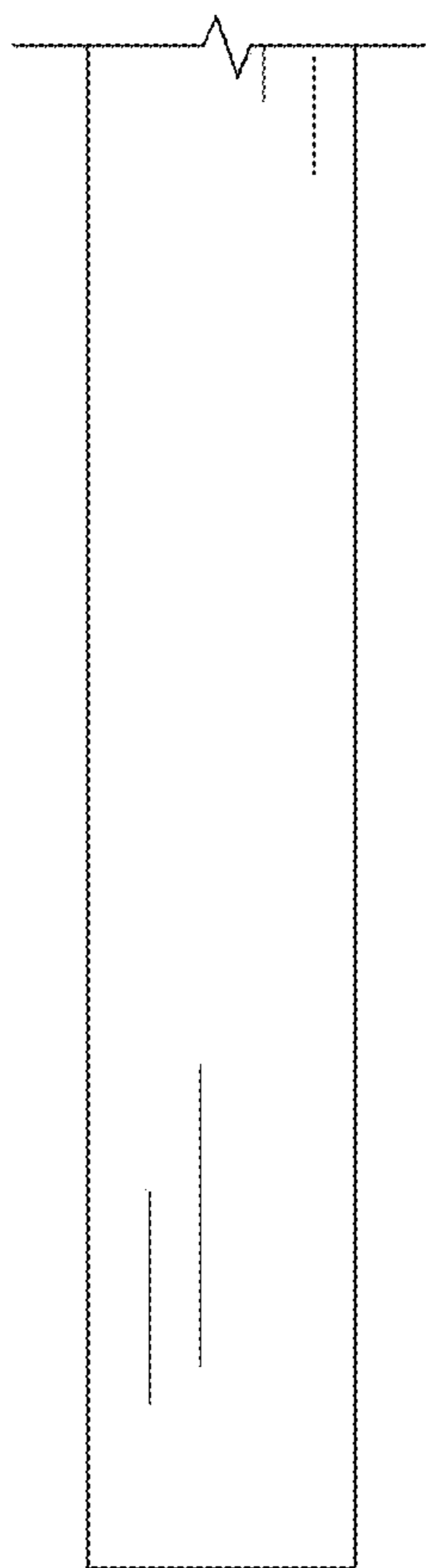

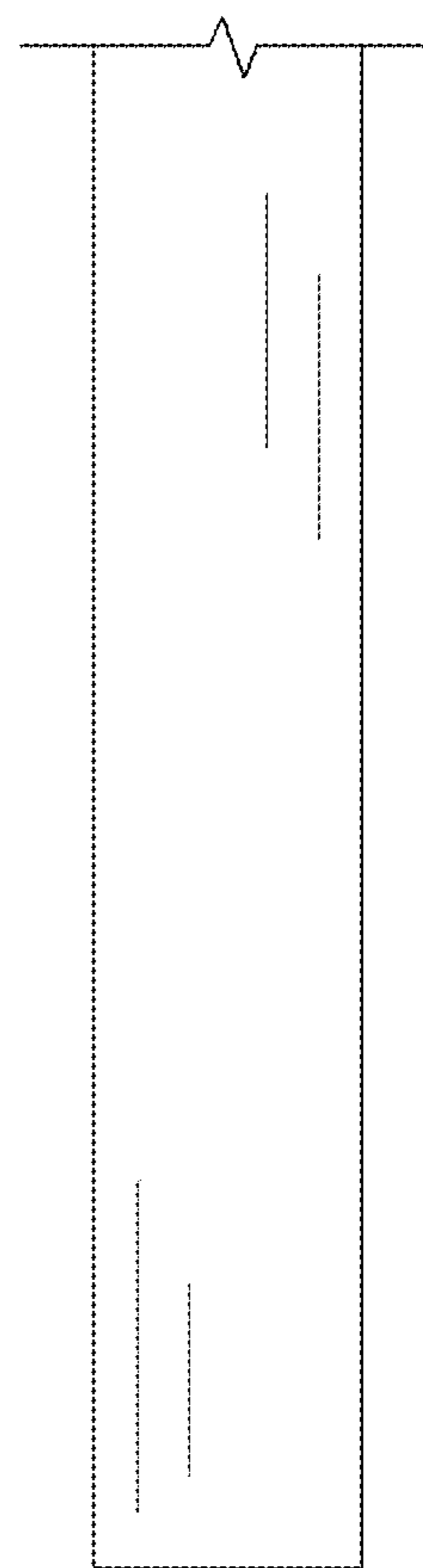

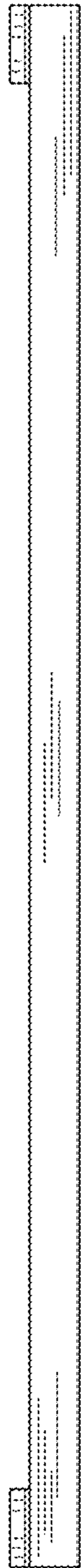

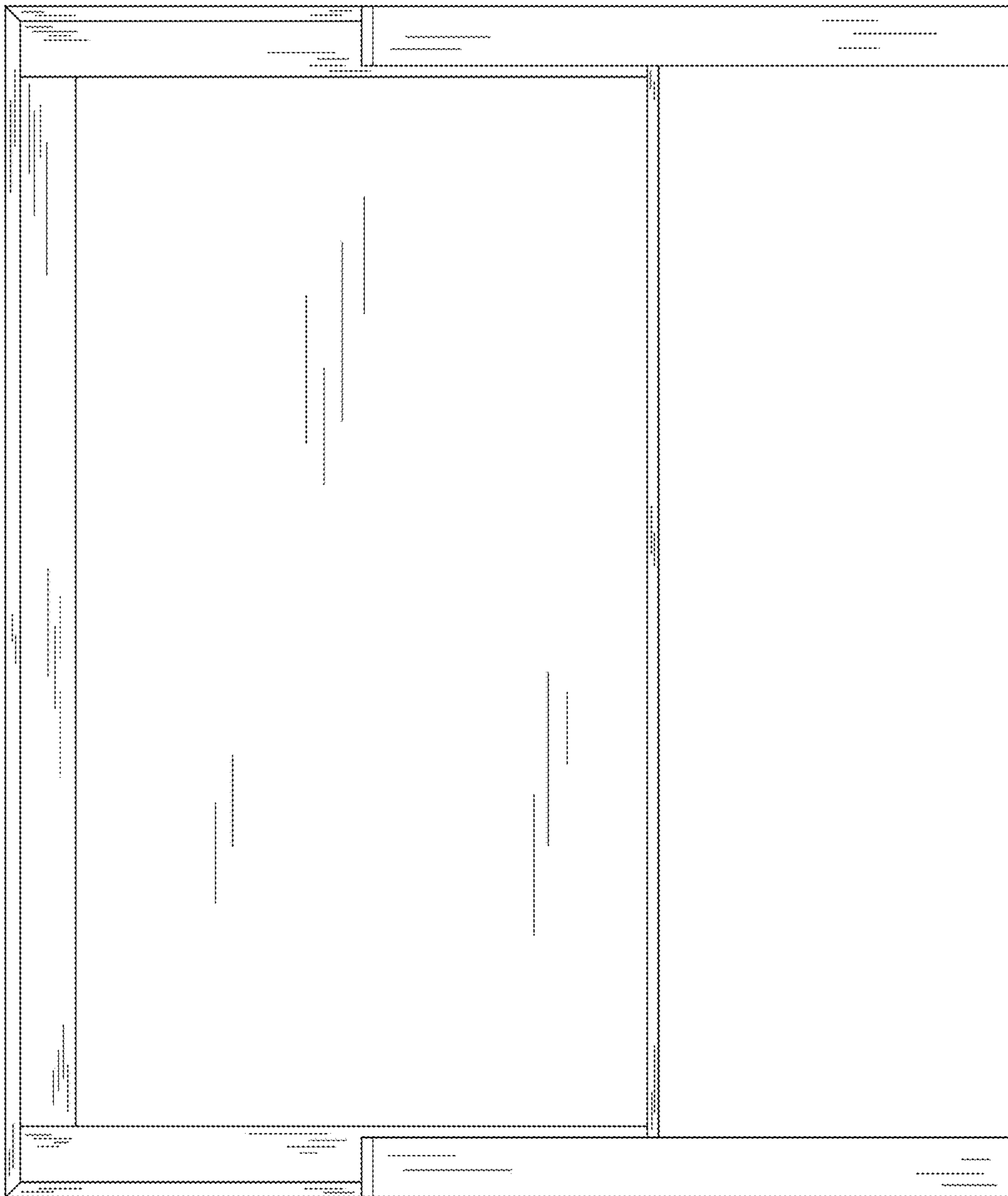

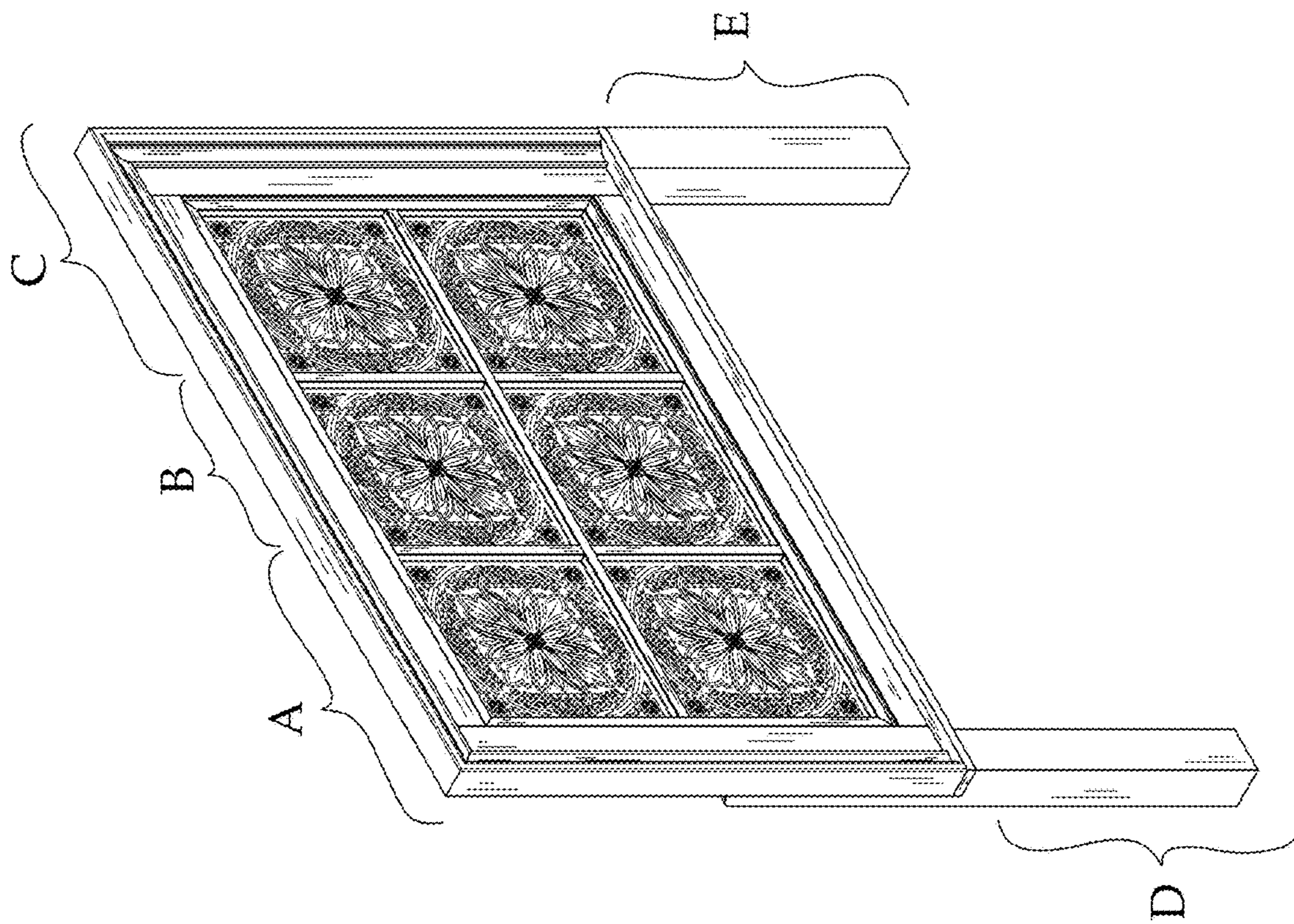

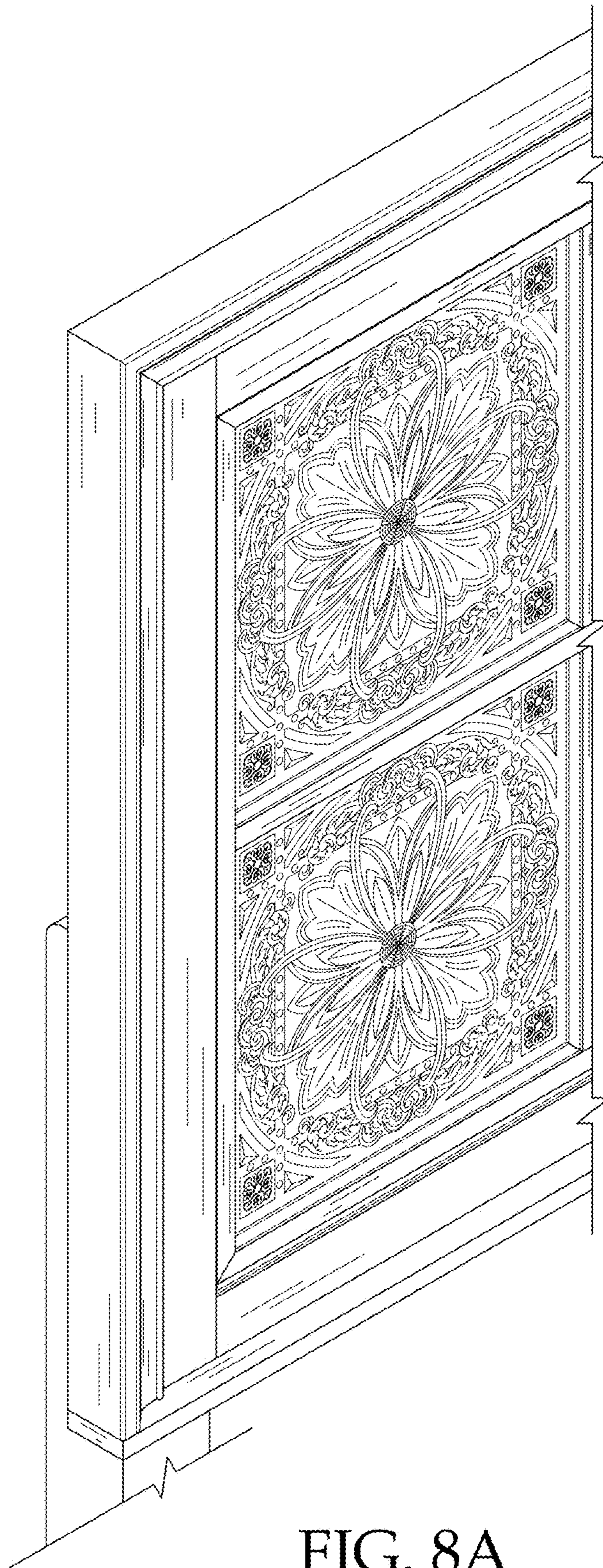

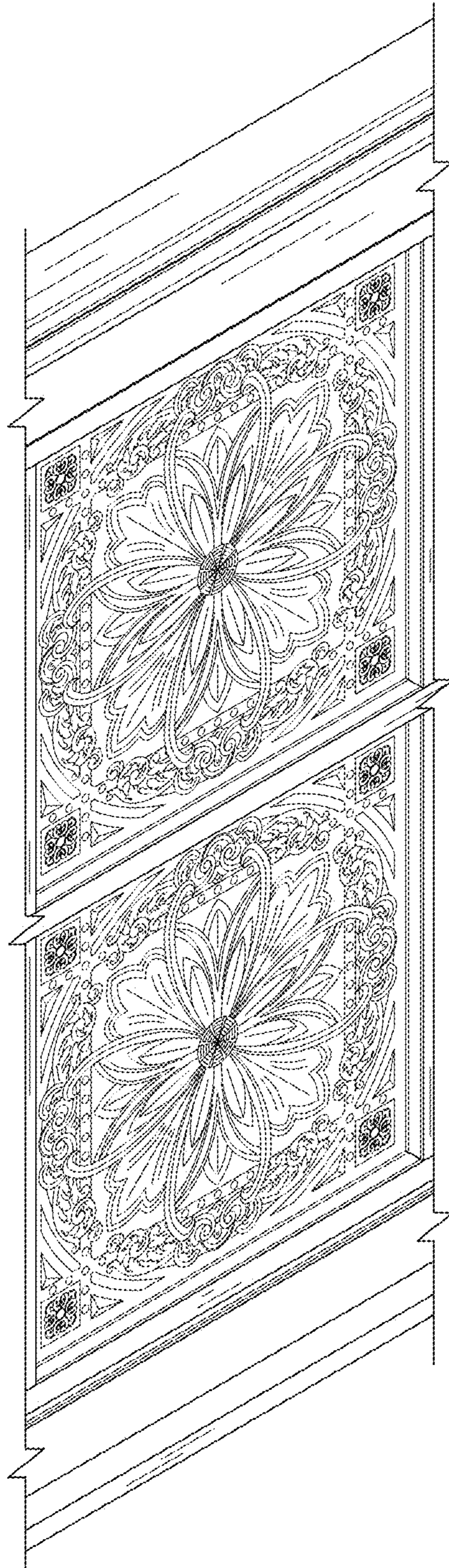

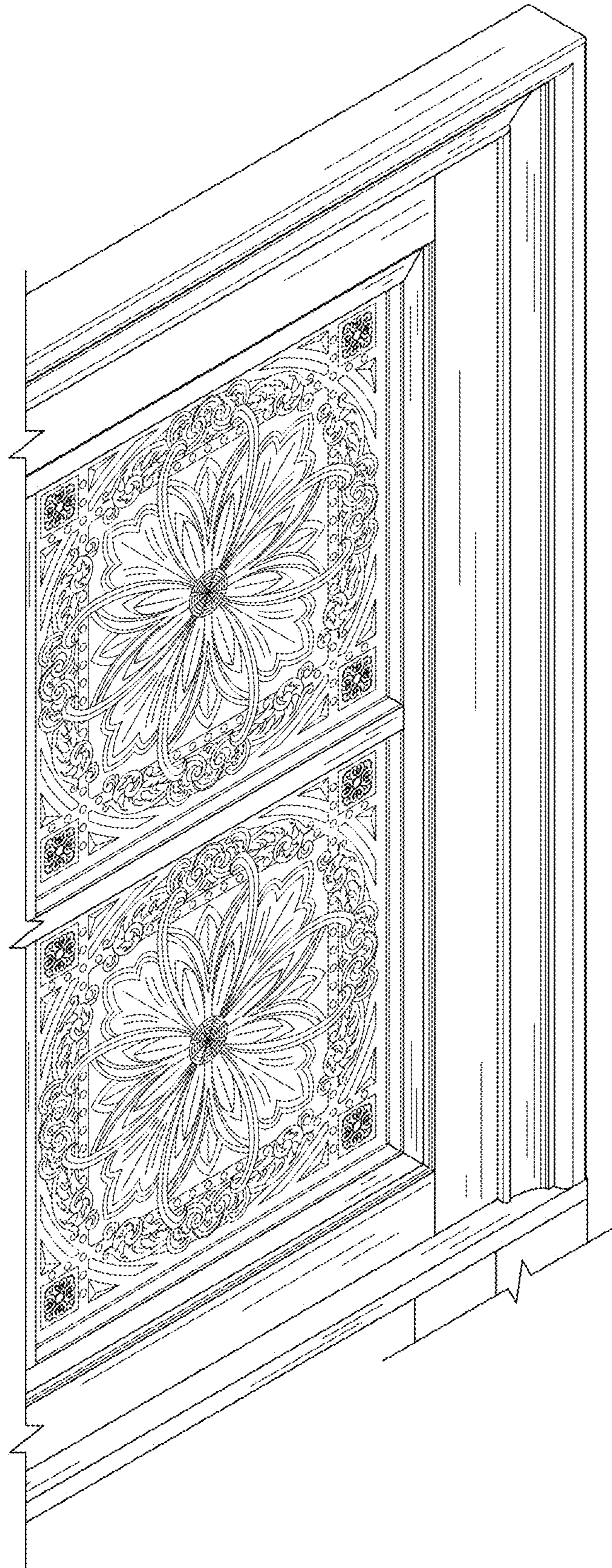

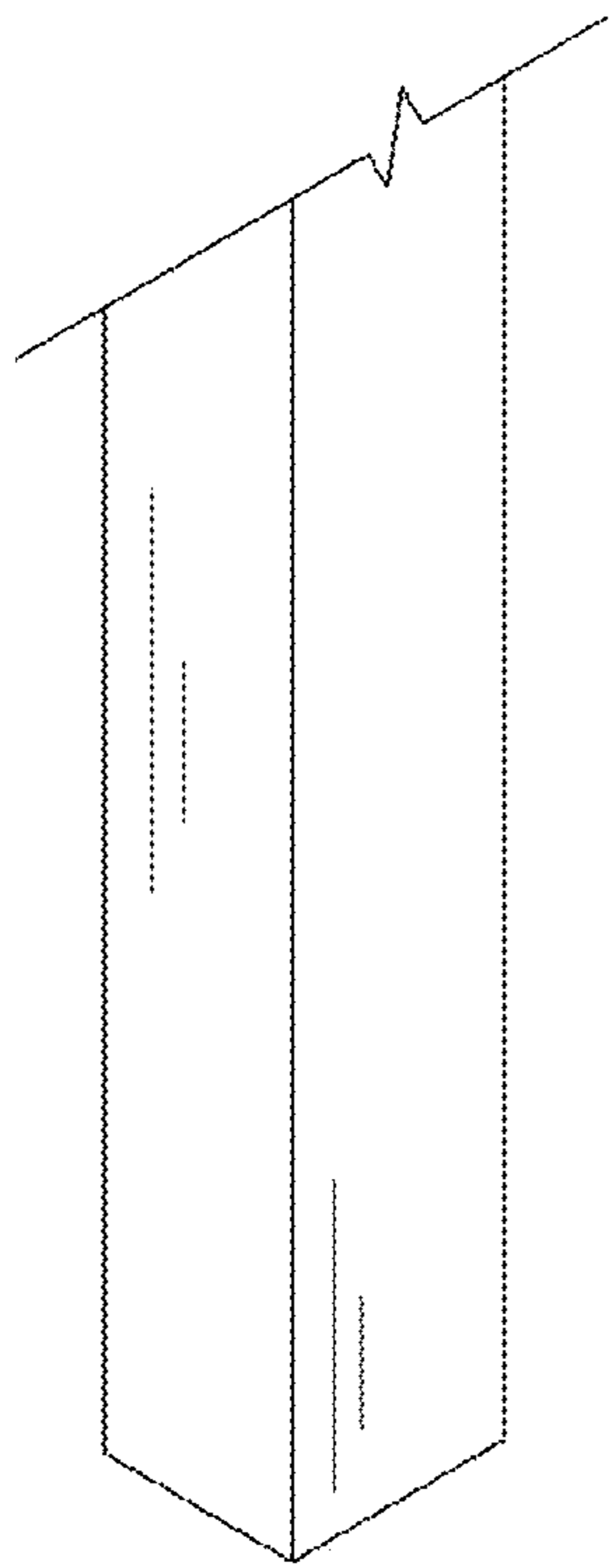

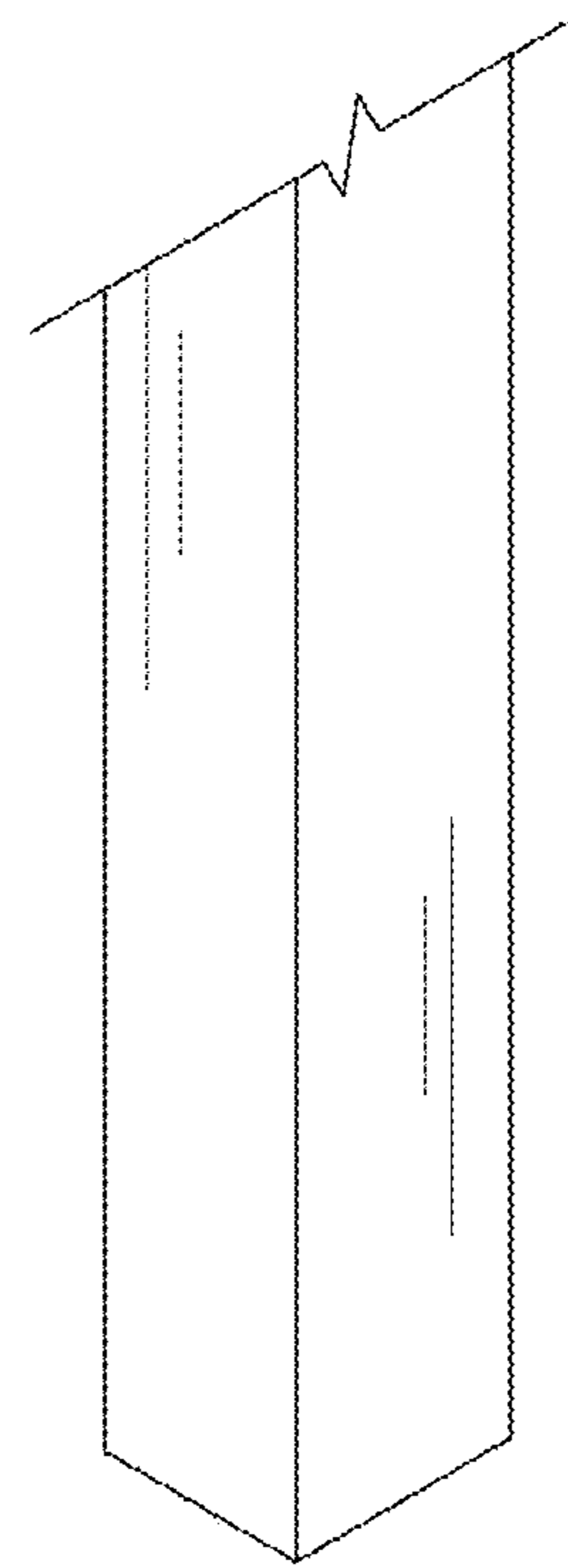

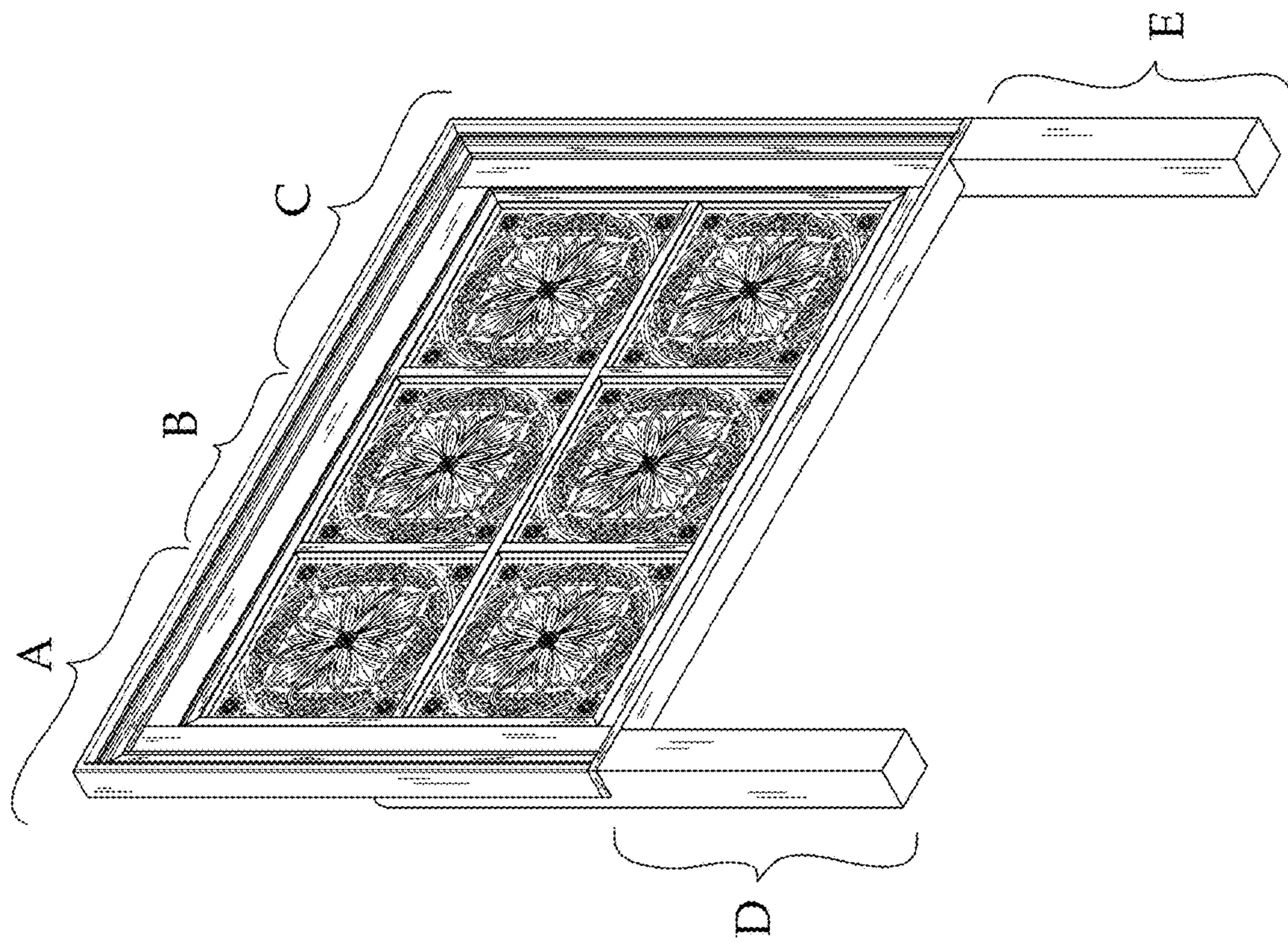

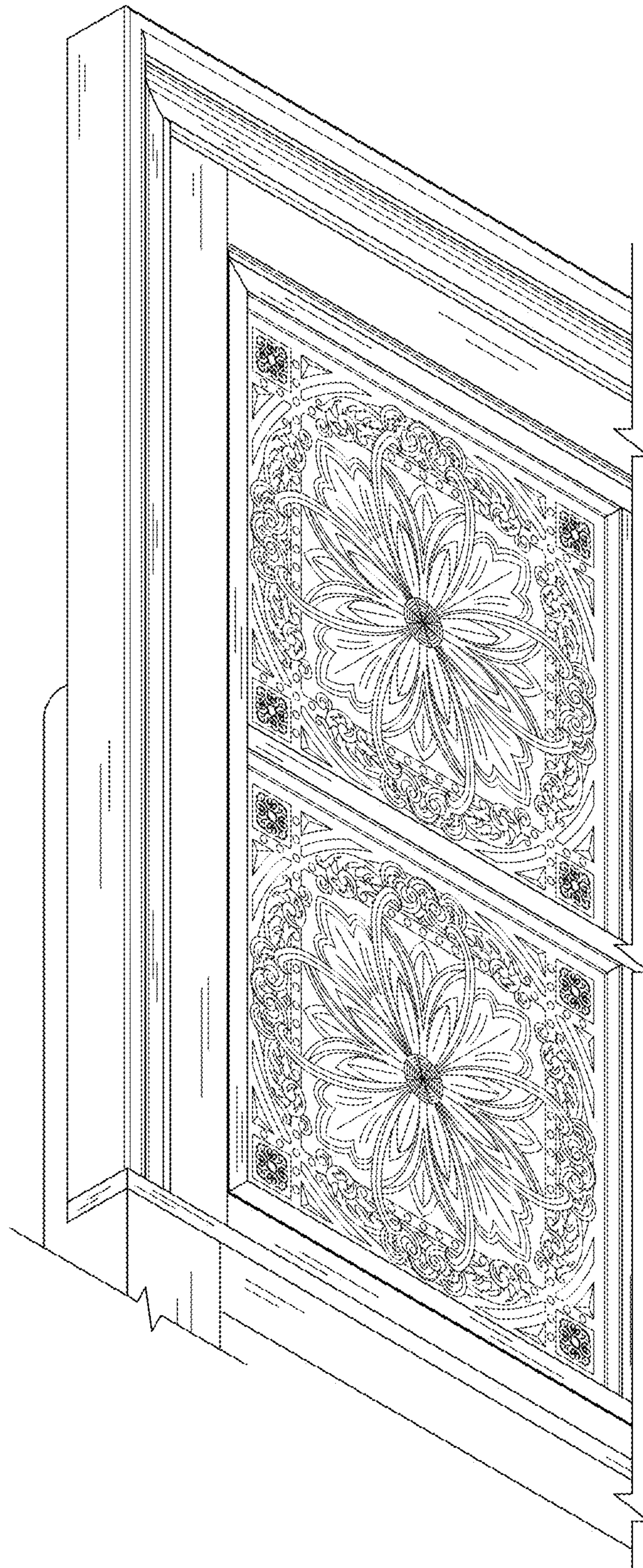

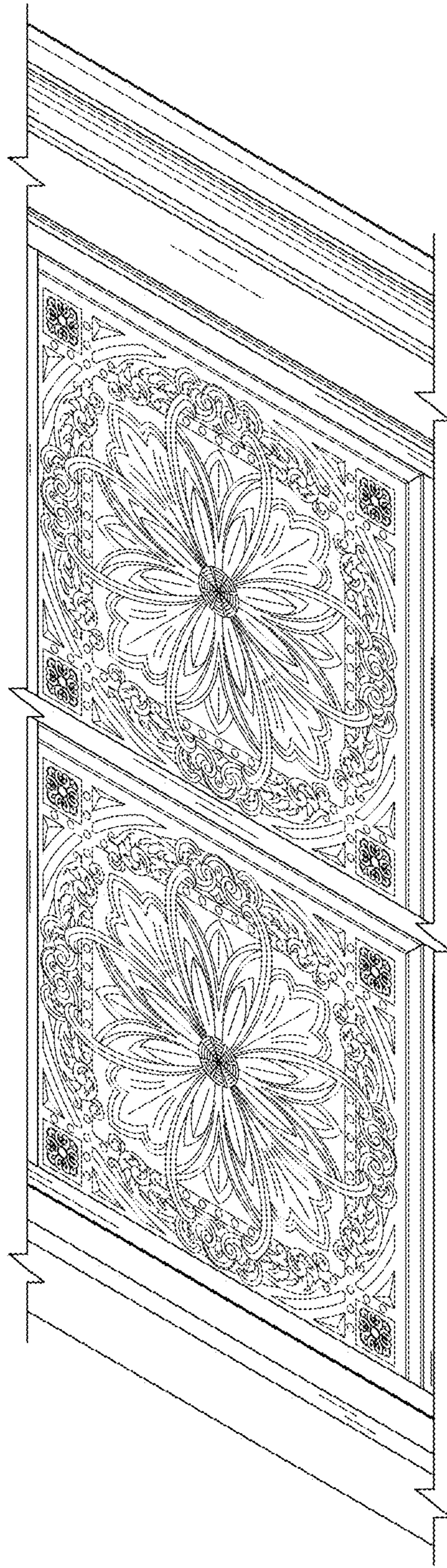

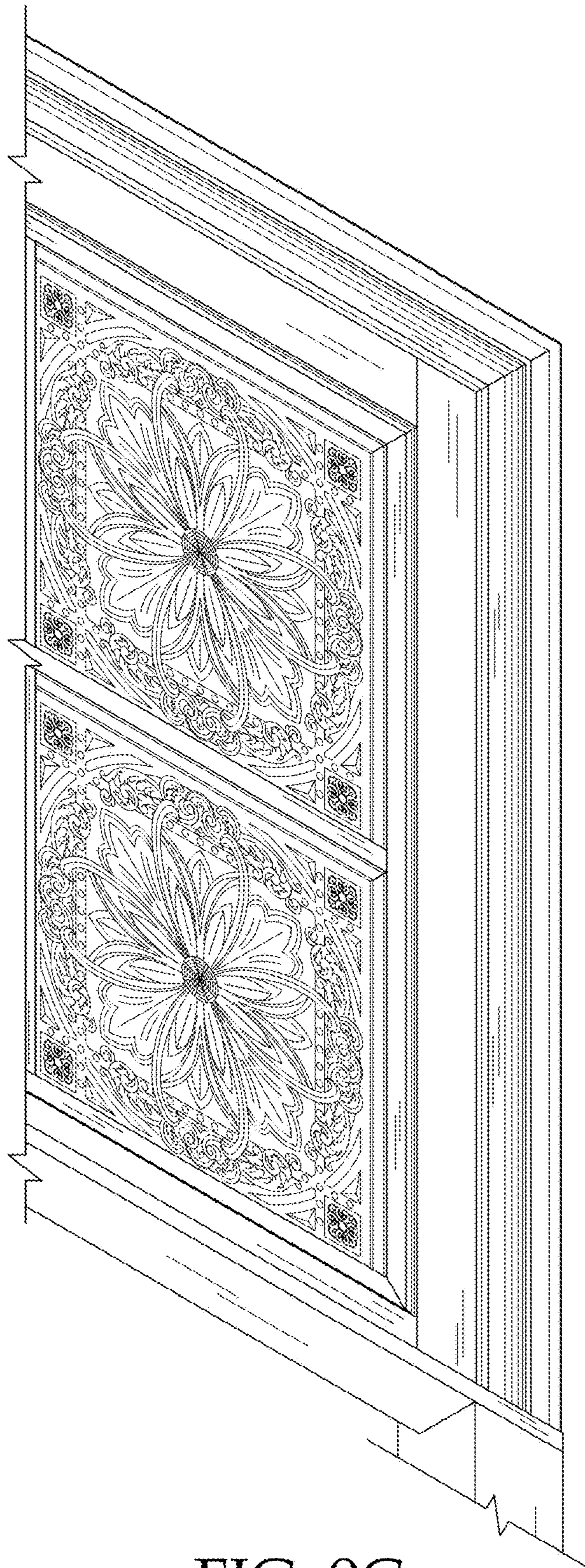

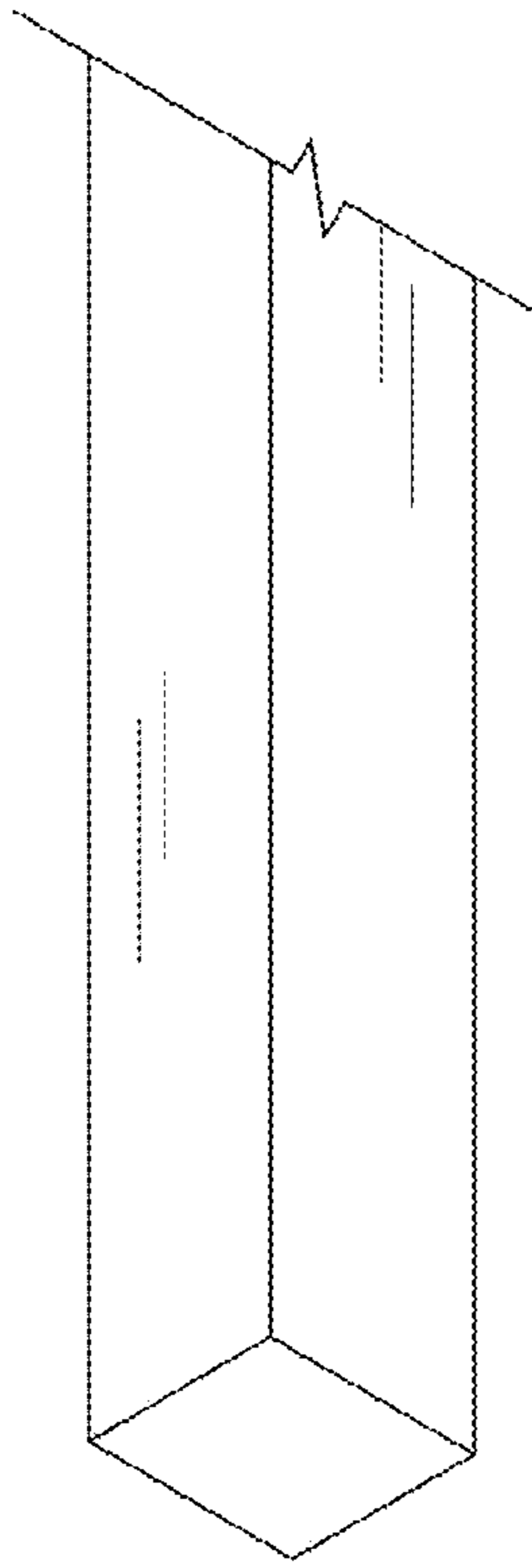

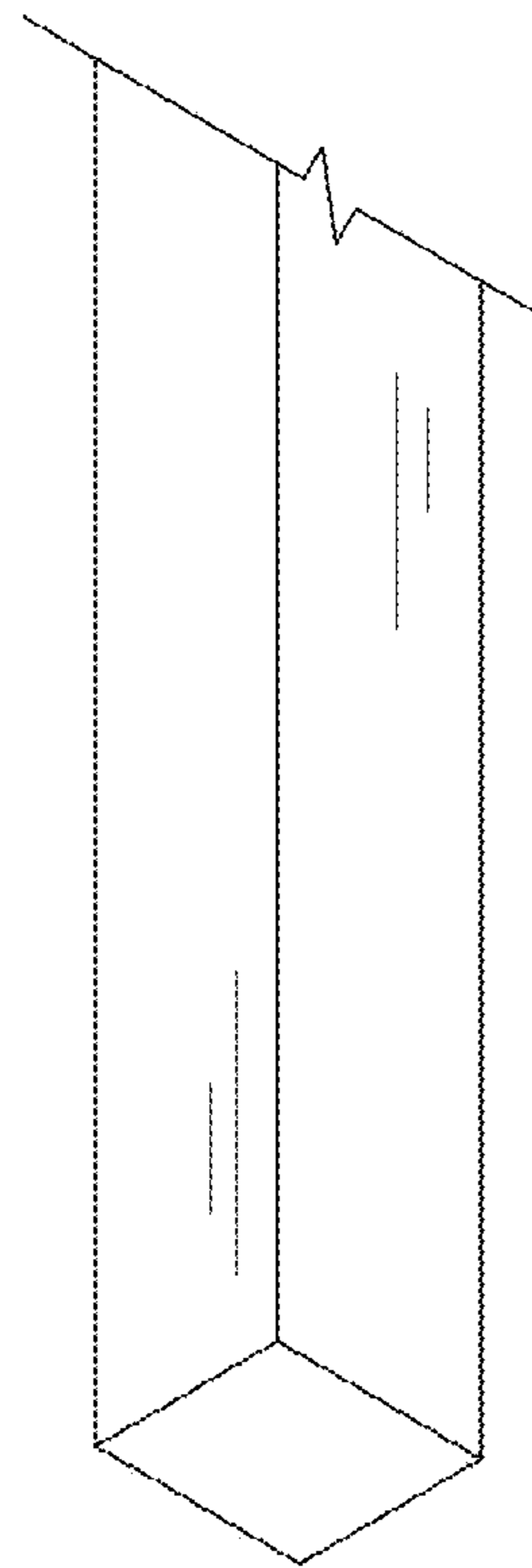

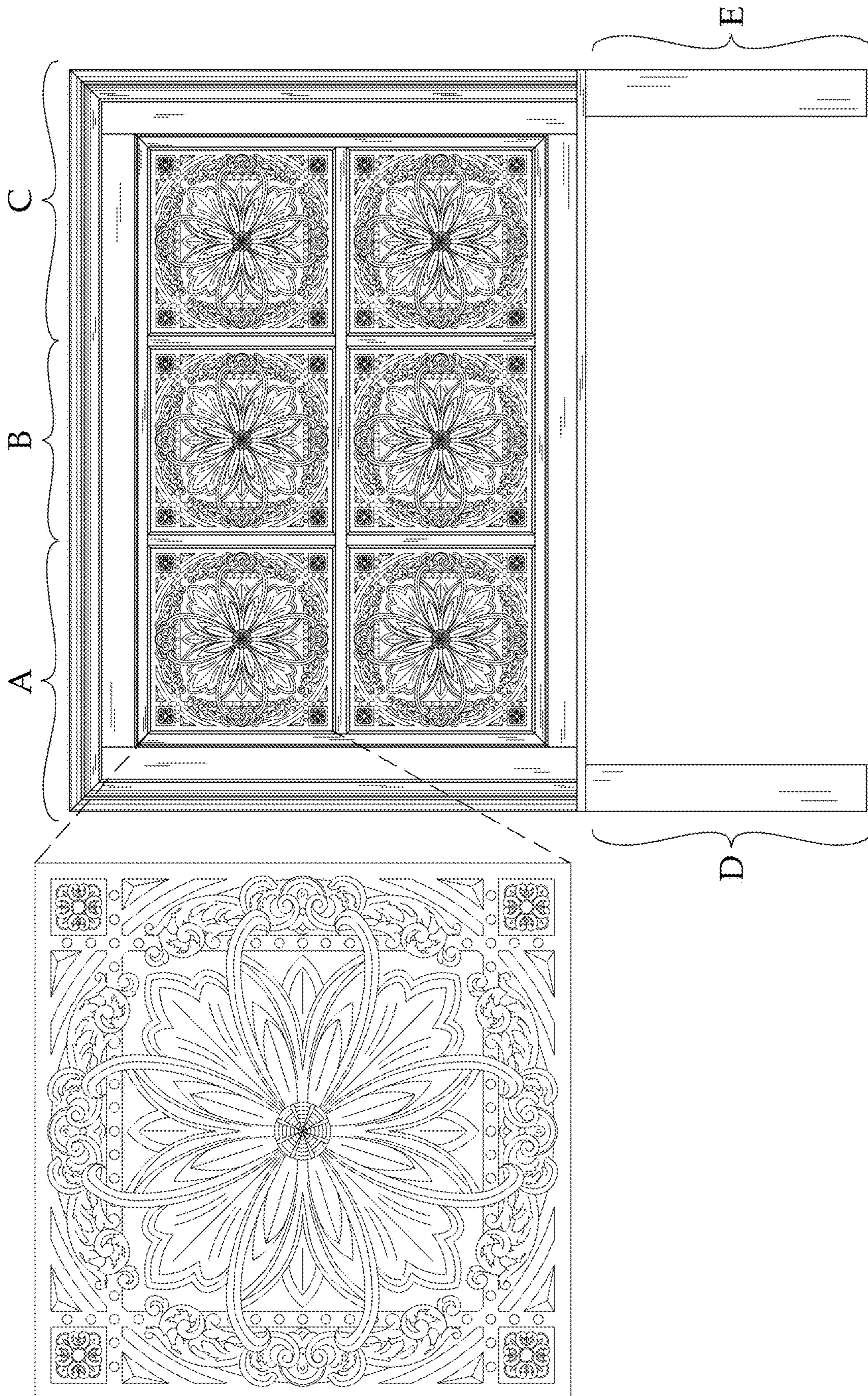

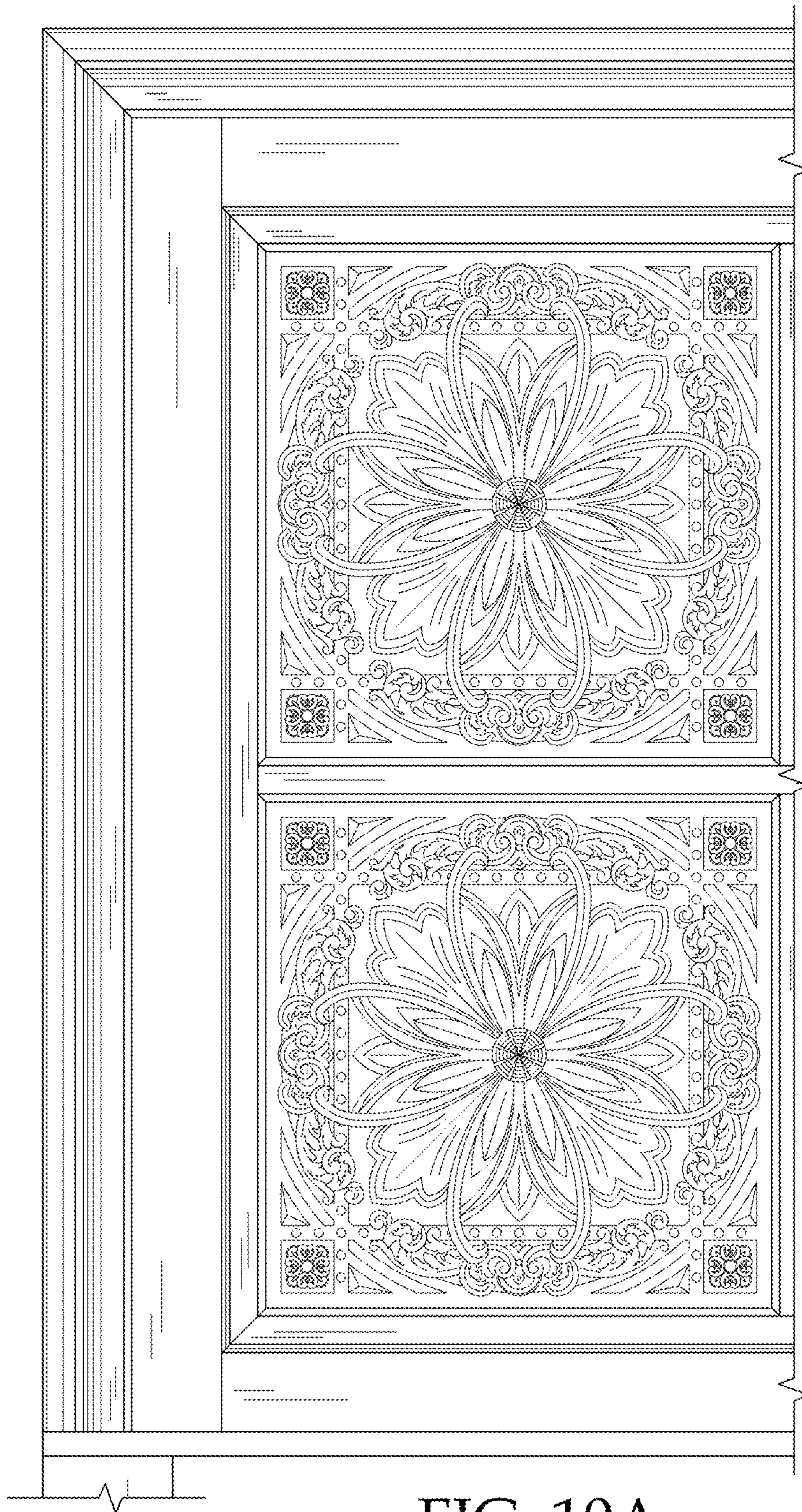

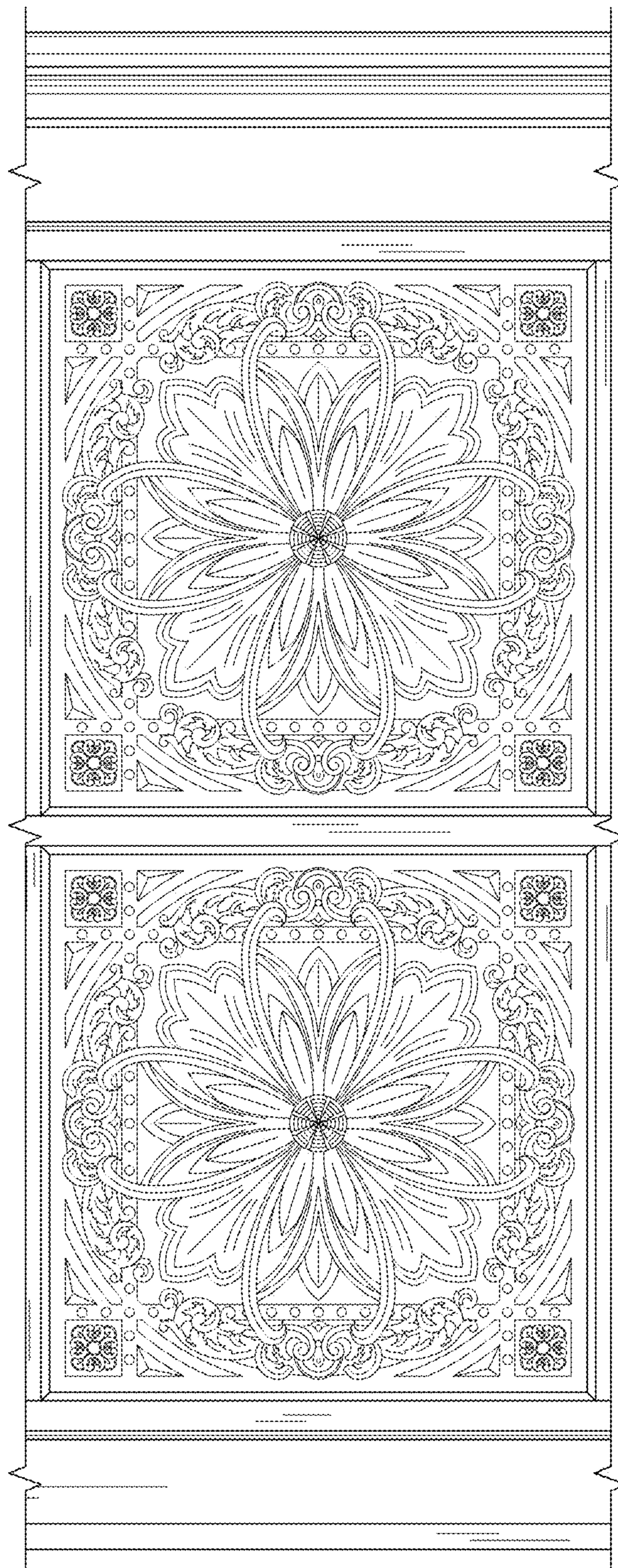

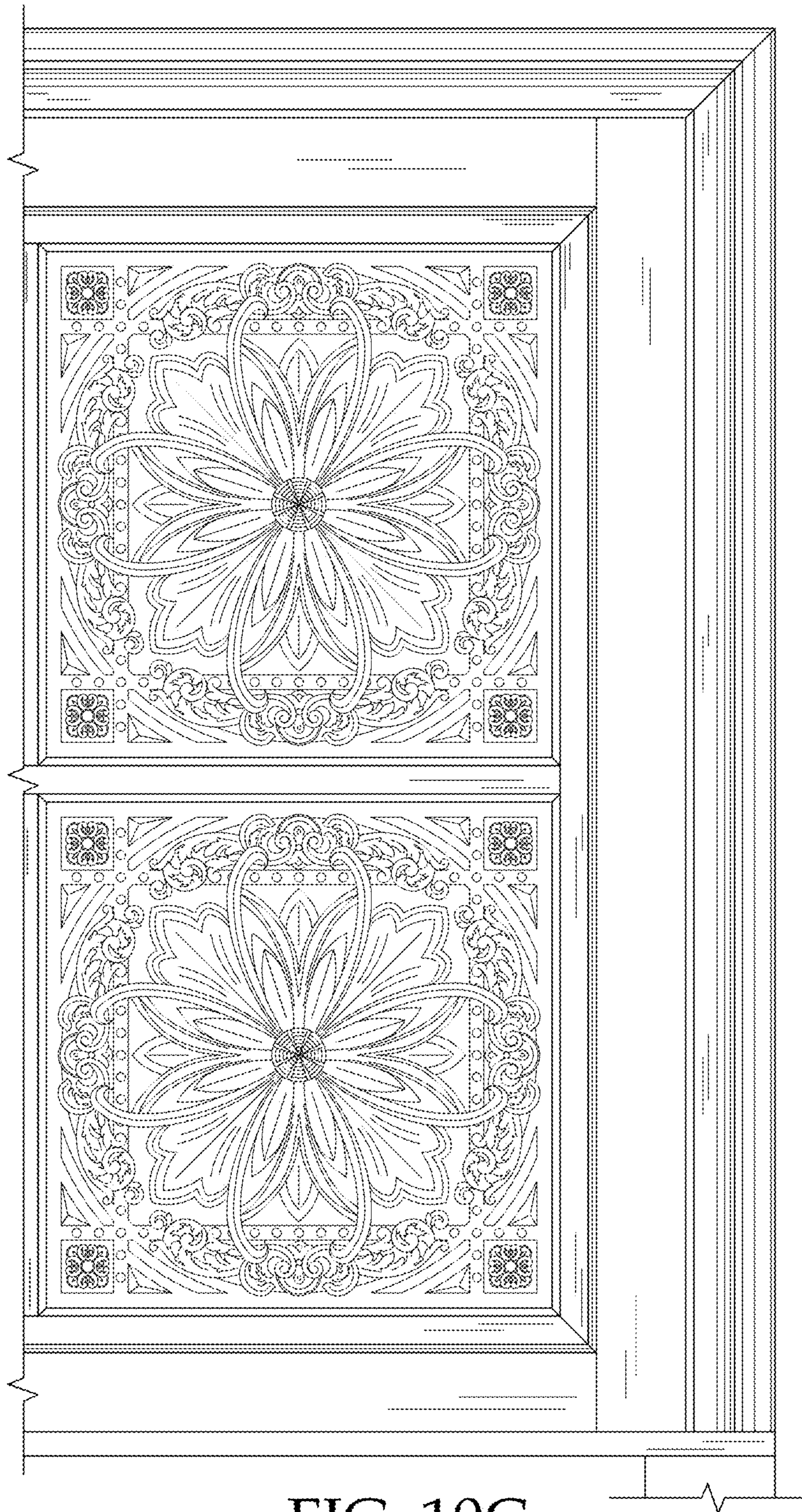

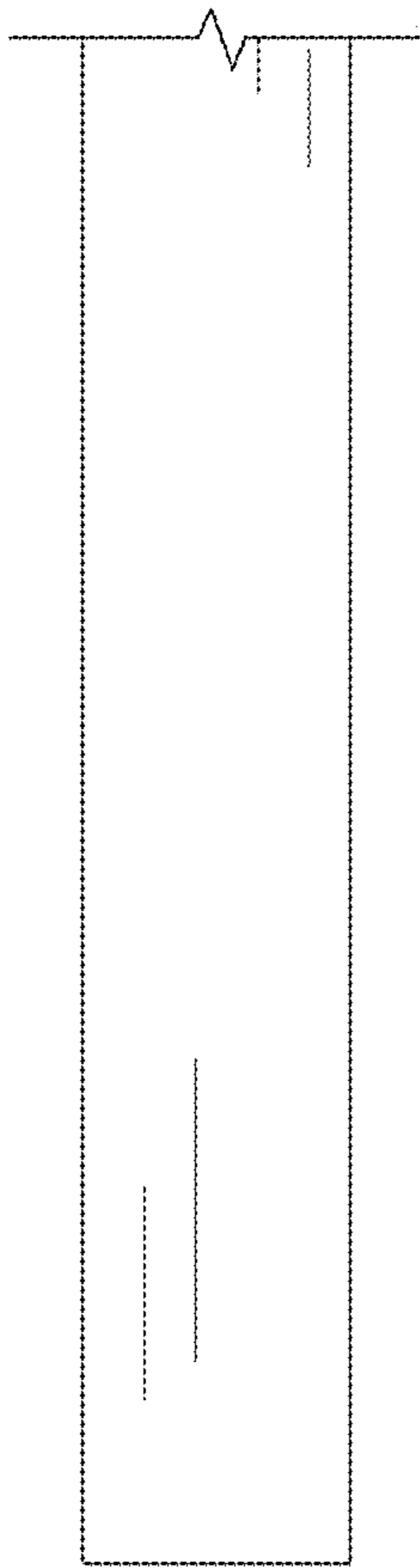

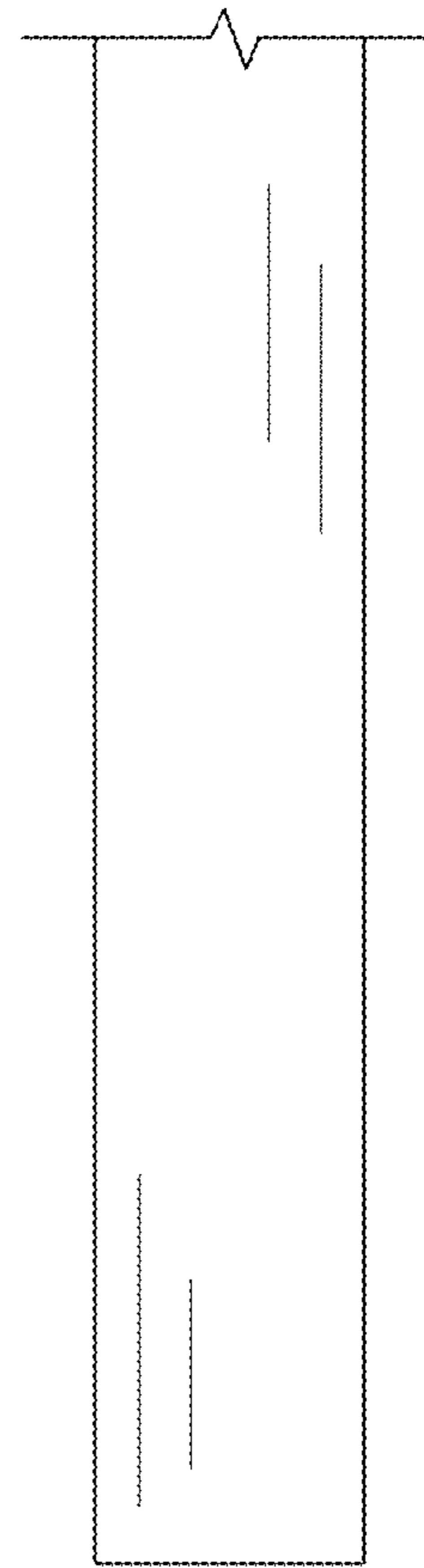

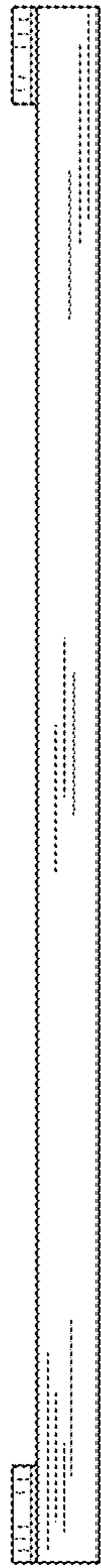

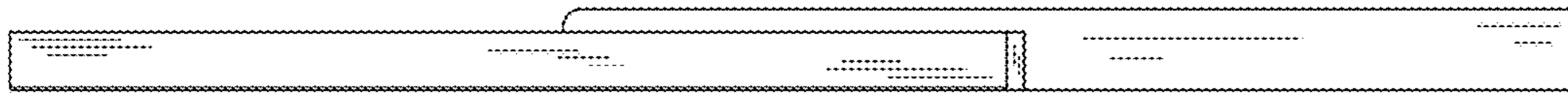

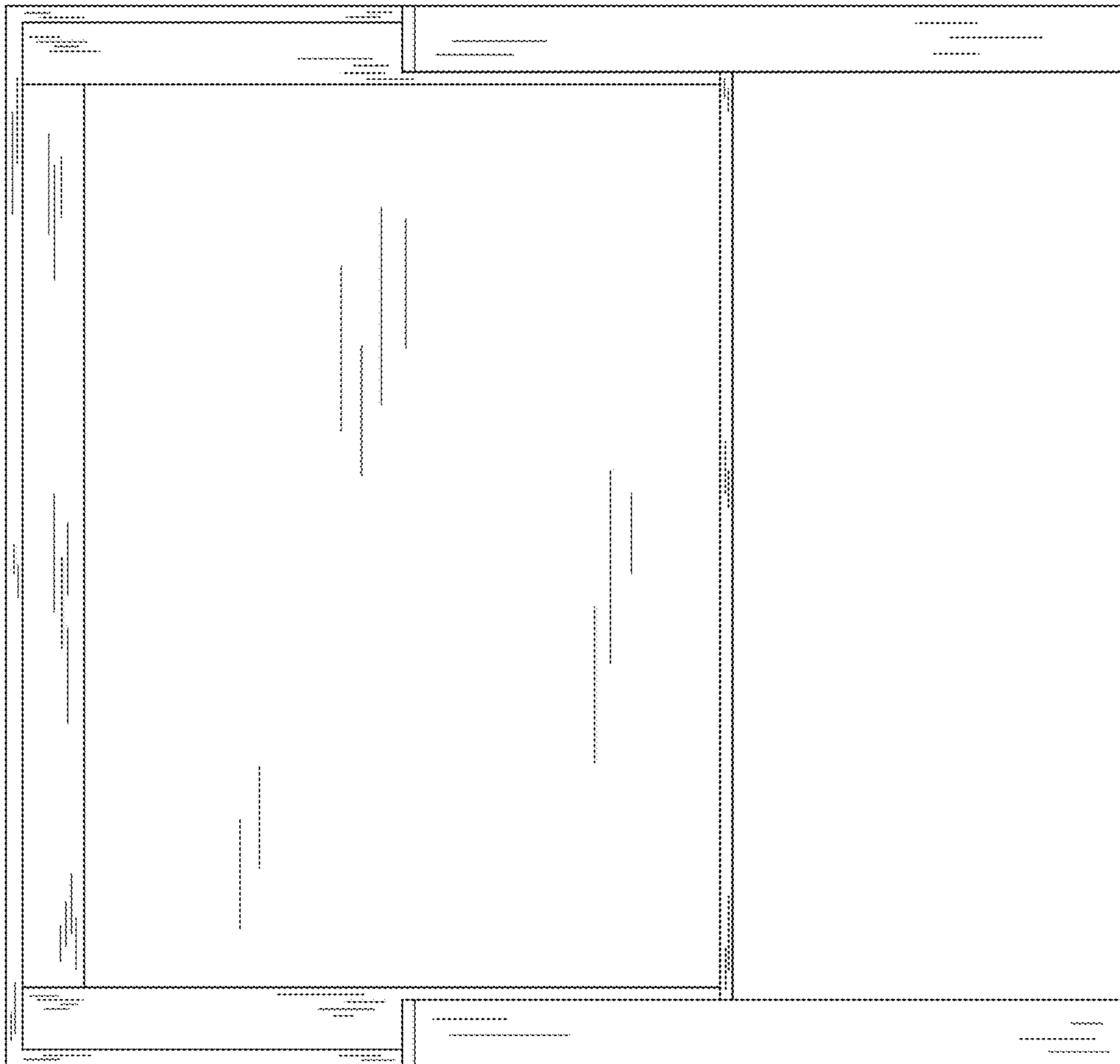
