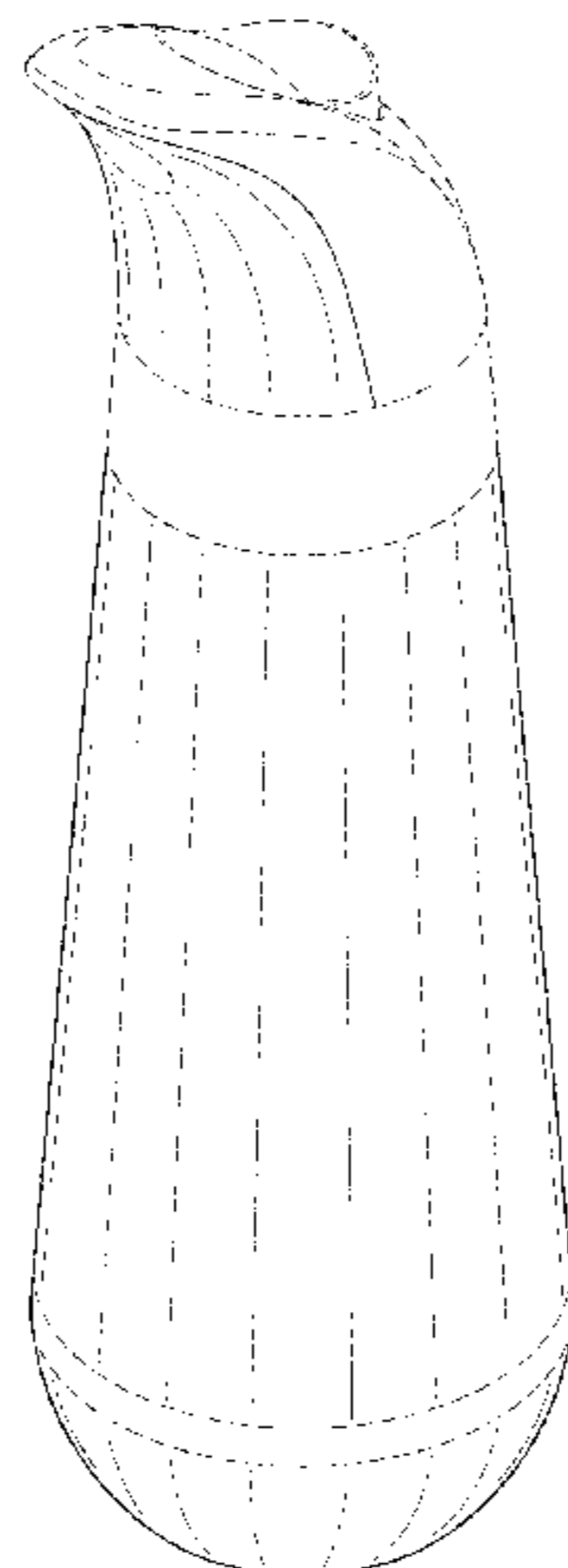
(57) **CLAIM**

The ornamental design for an aerosol bottle for dispensing a foam hair care composition, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an aerosol bottle for a foam hair care composition, embodying our new design; FIG. 2 is a front view thereof; FIG. 3 is a first side view thereof; FIG. 4 is a back view thereof; FIG. 5 is a second side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. The broken lines depict the portions of the aerosol bottle for dispensing foam hair care composition that form no part of the claimed design. The appearance within the unshaded area of FIG. 7 forms no part of the claimed design.

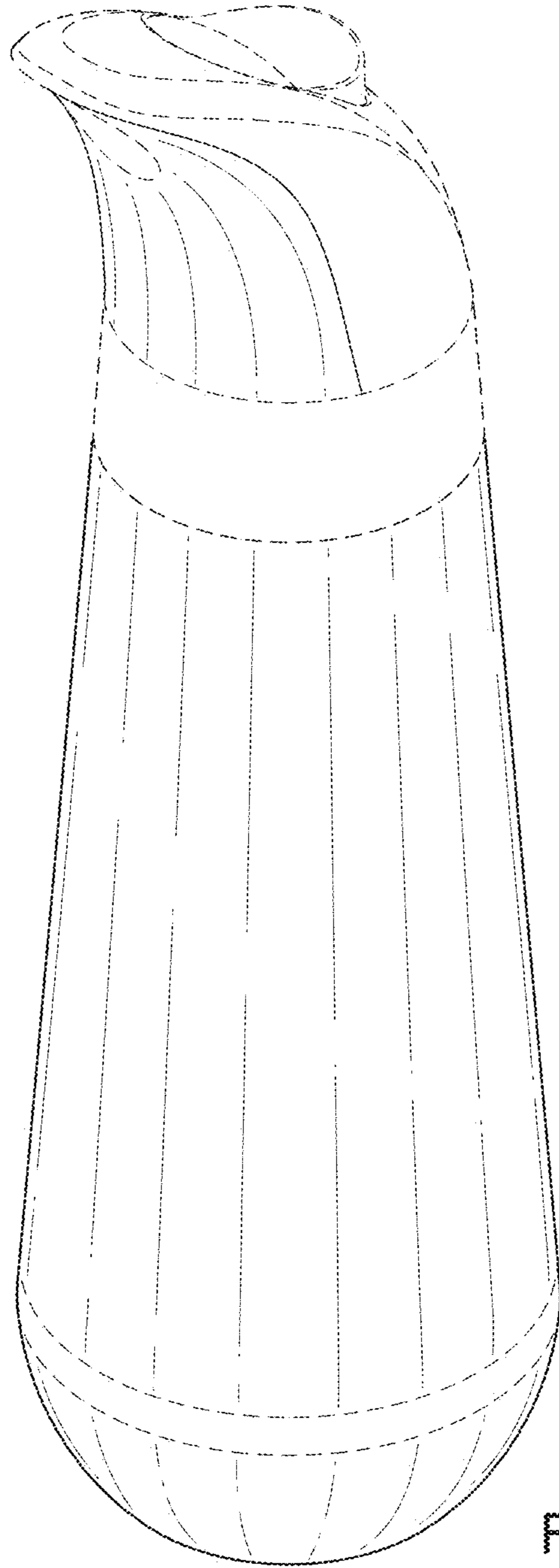

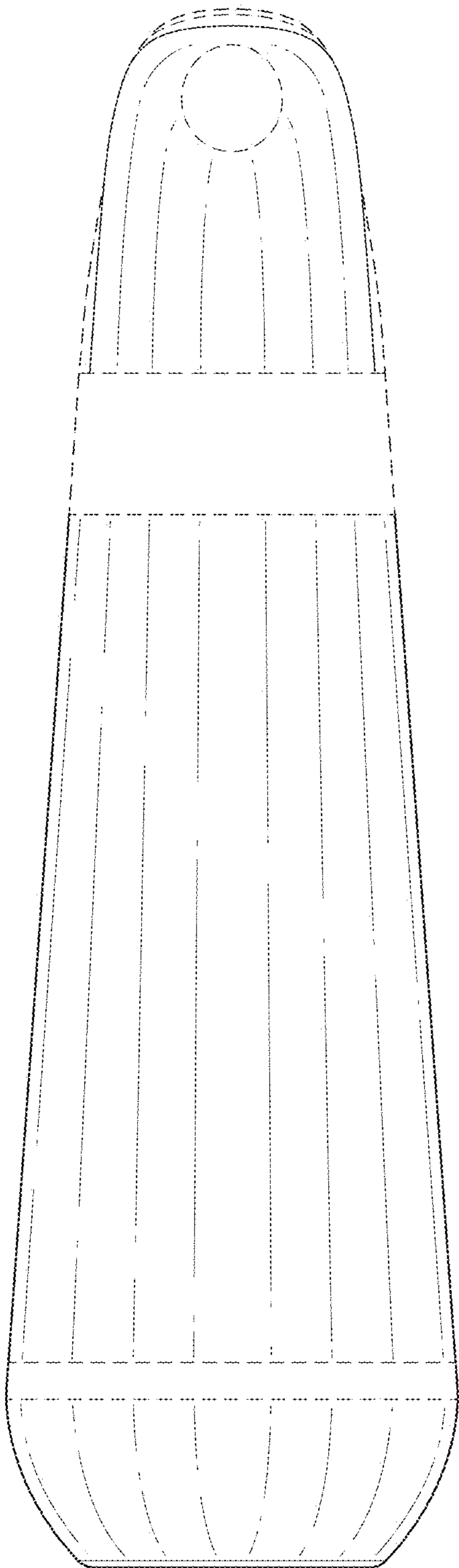

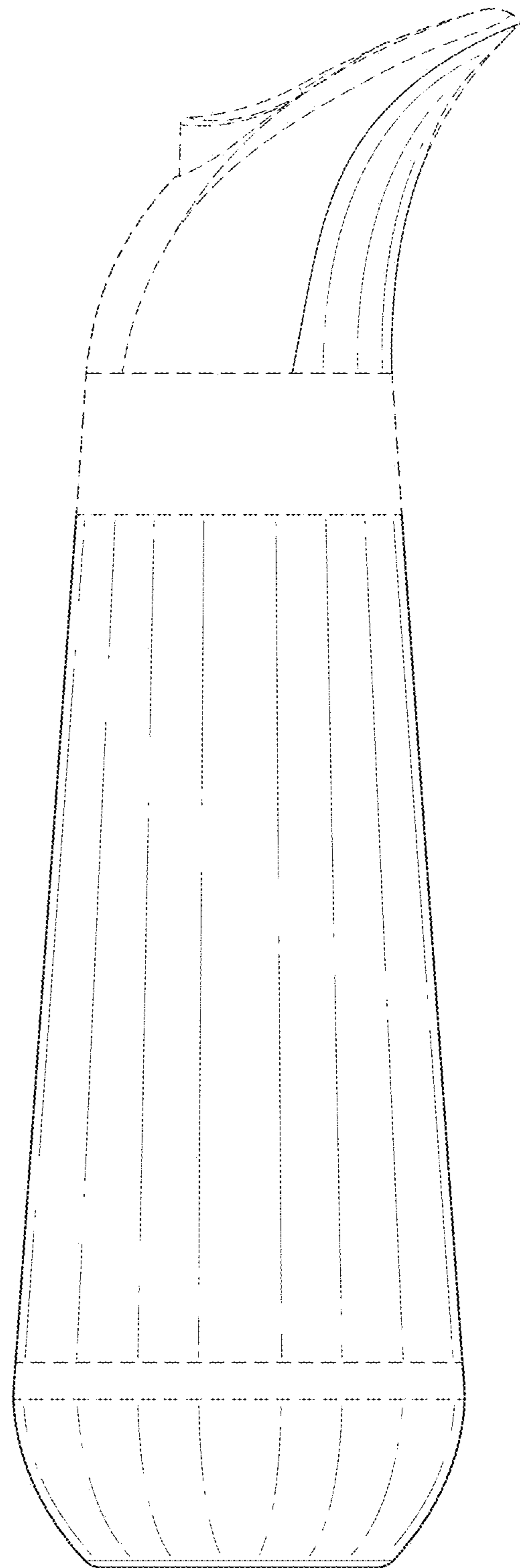

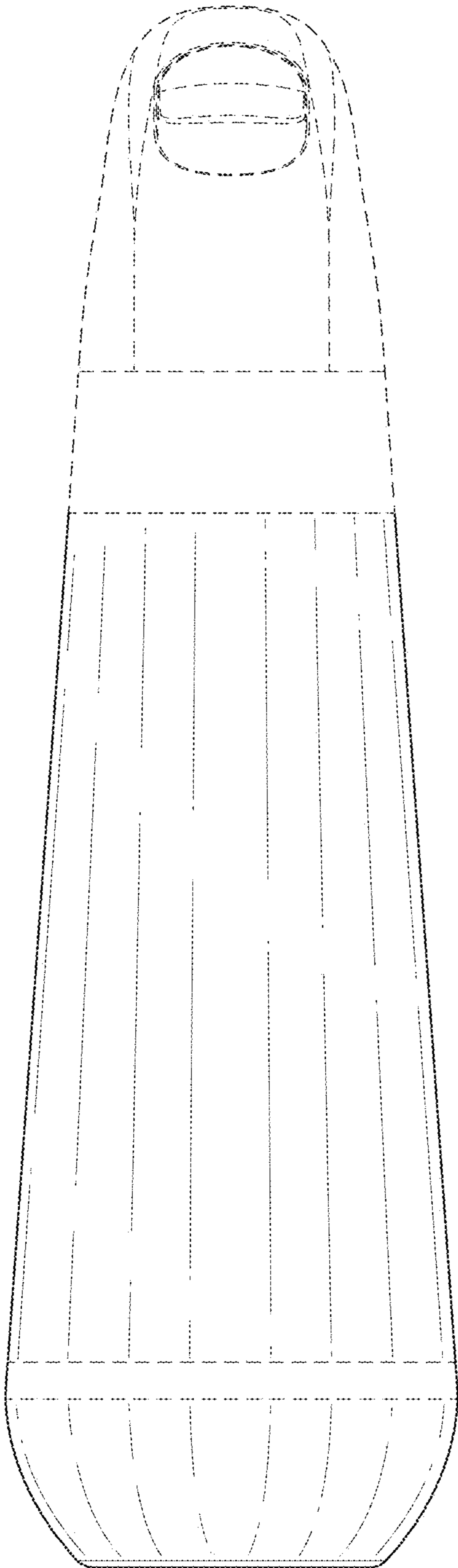

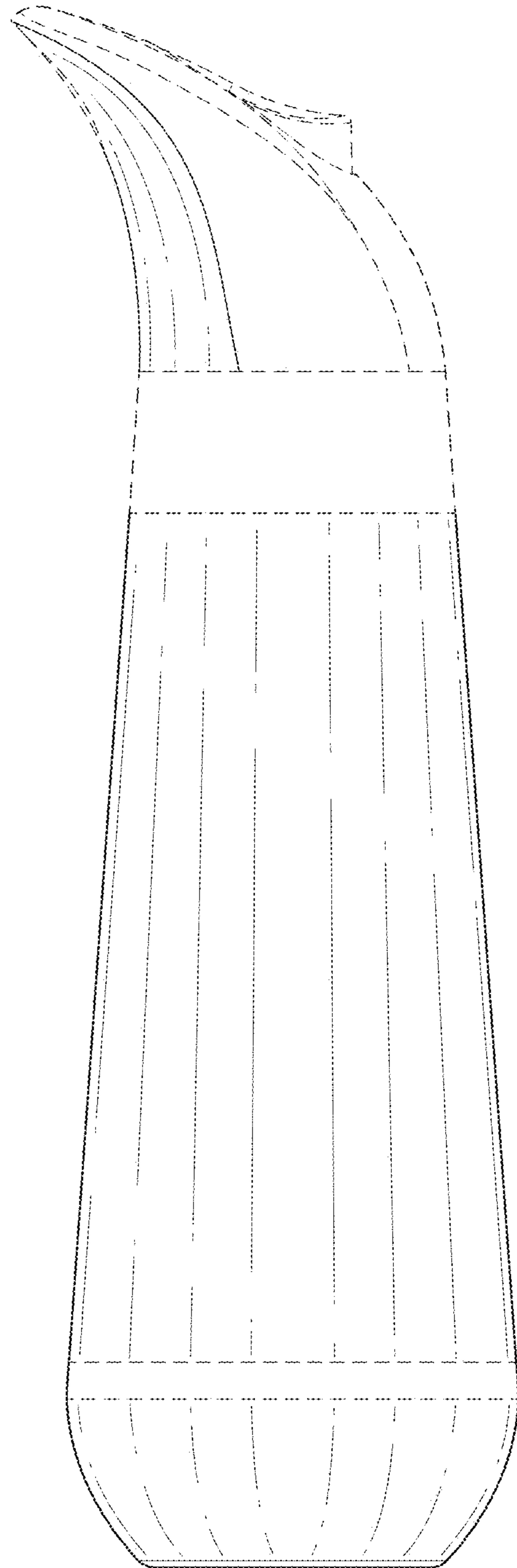

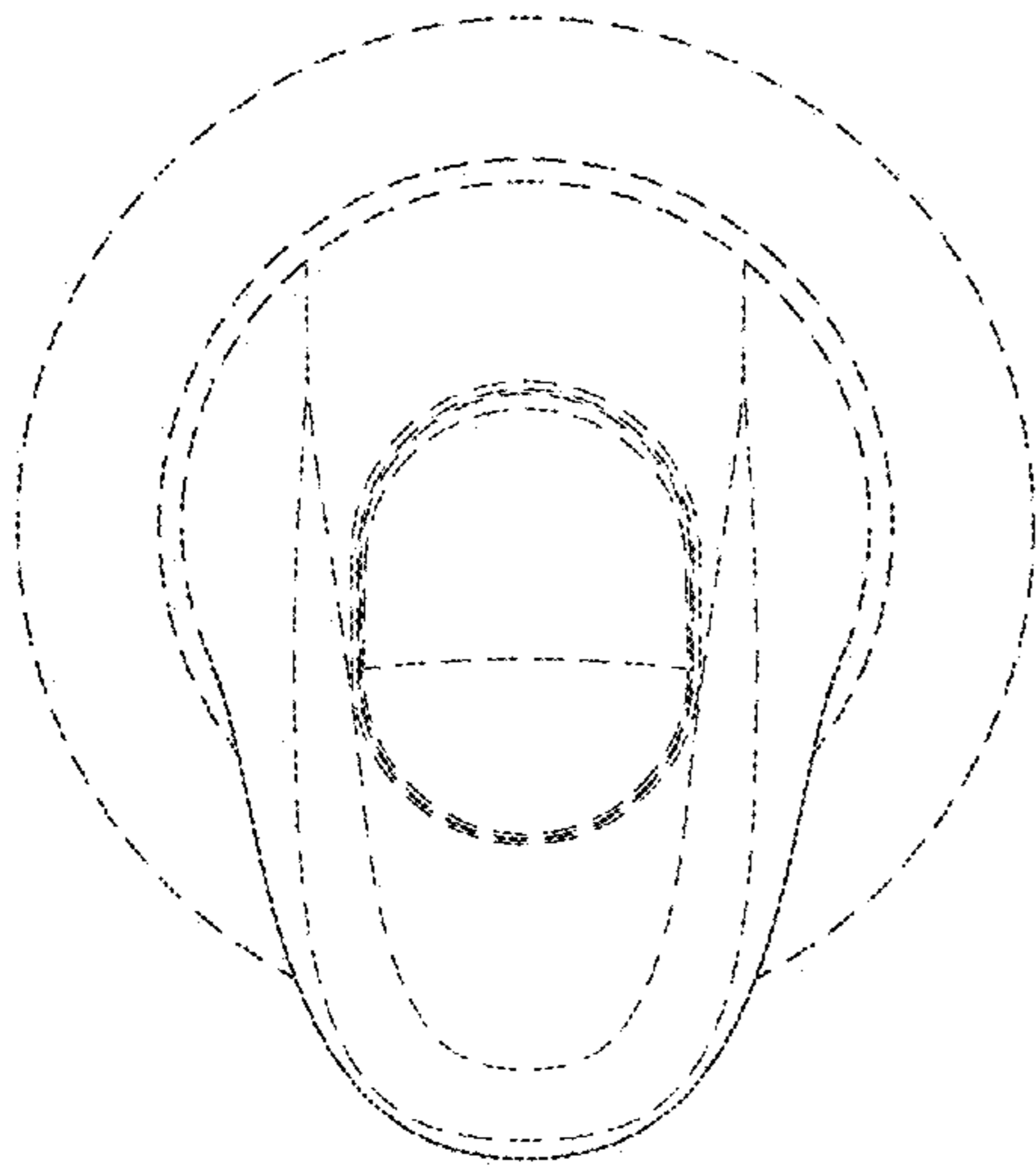

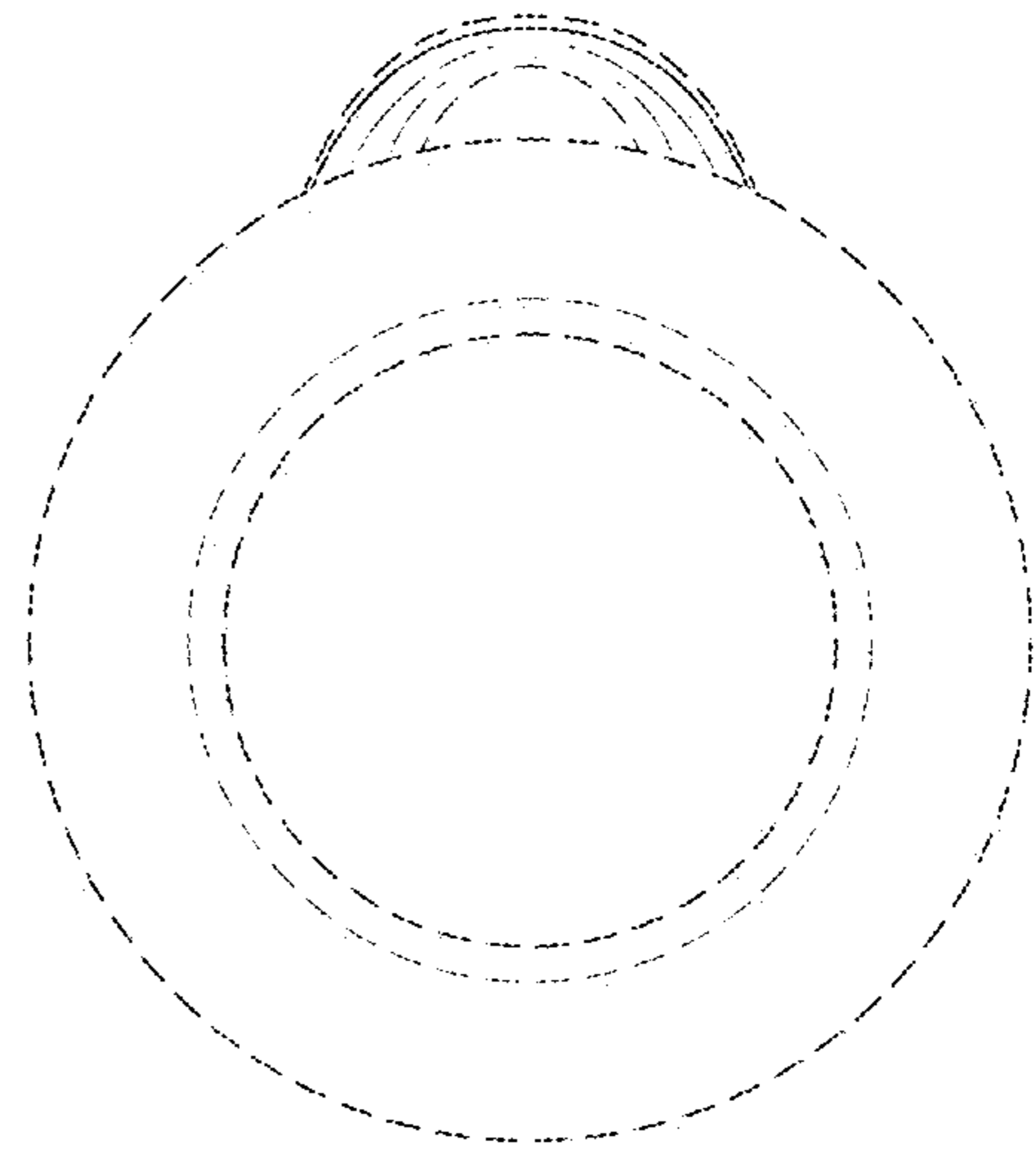
