**DESCRIPTION**

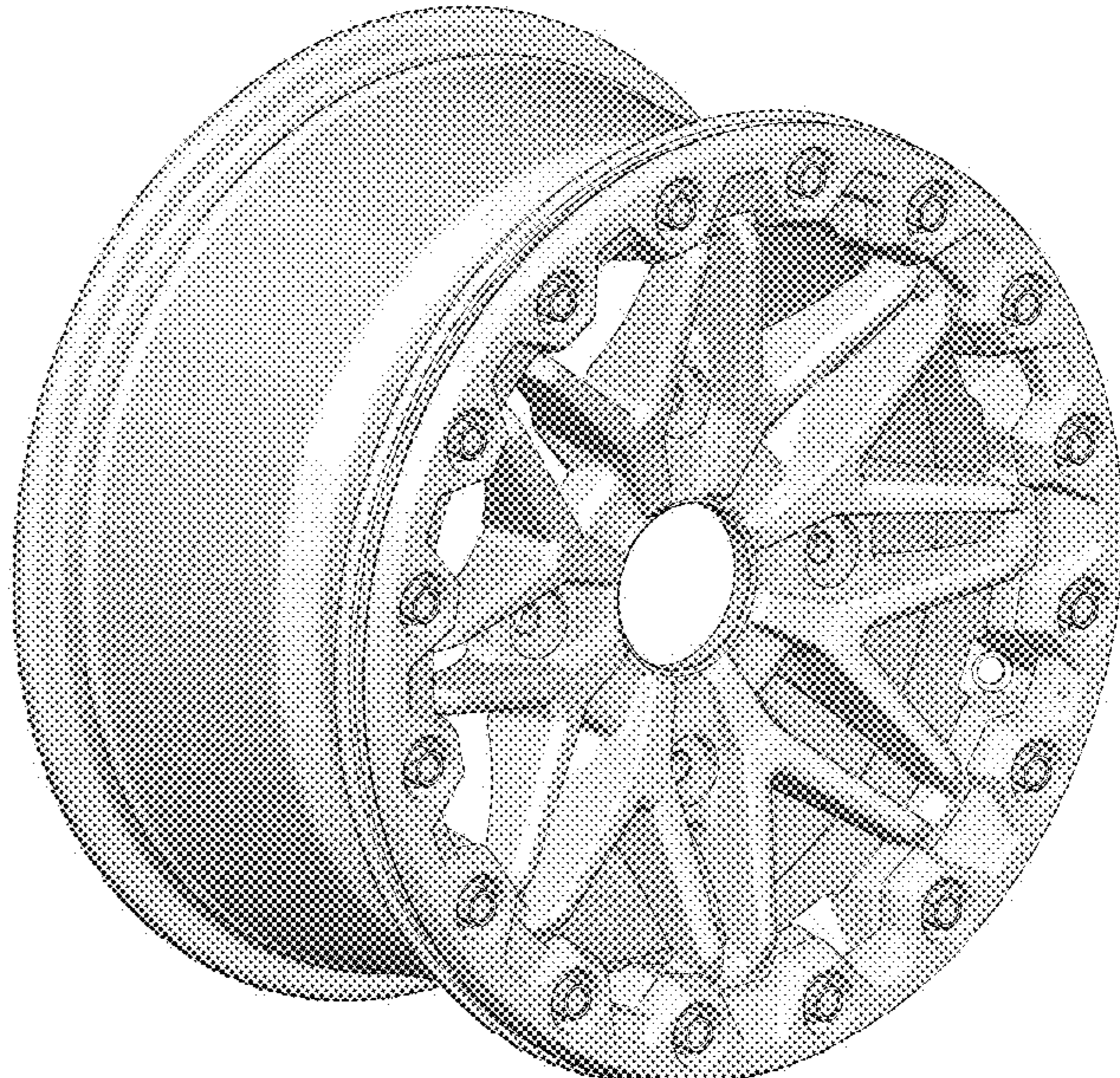
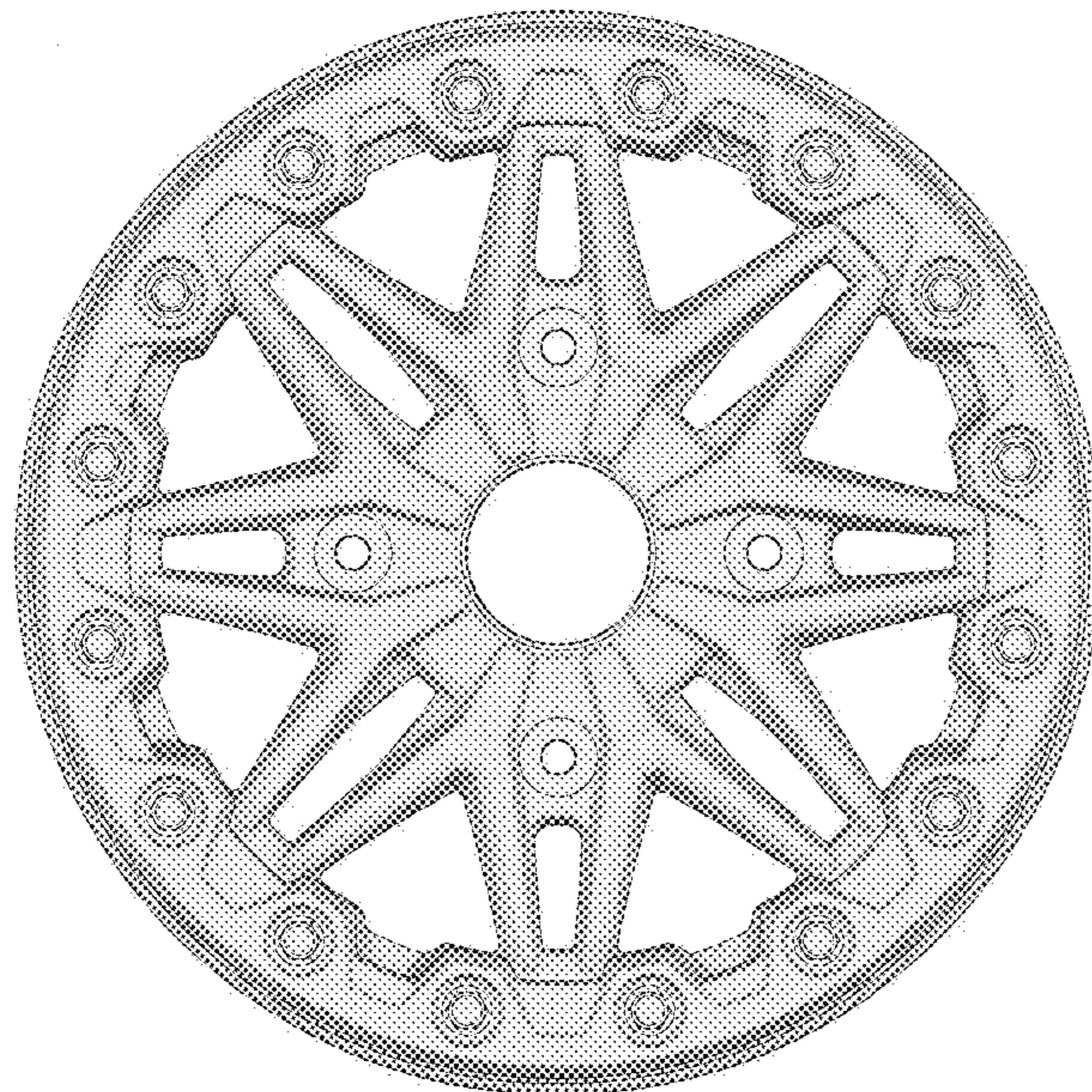

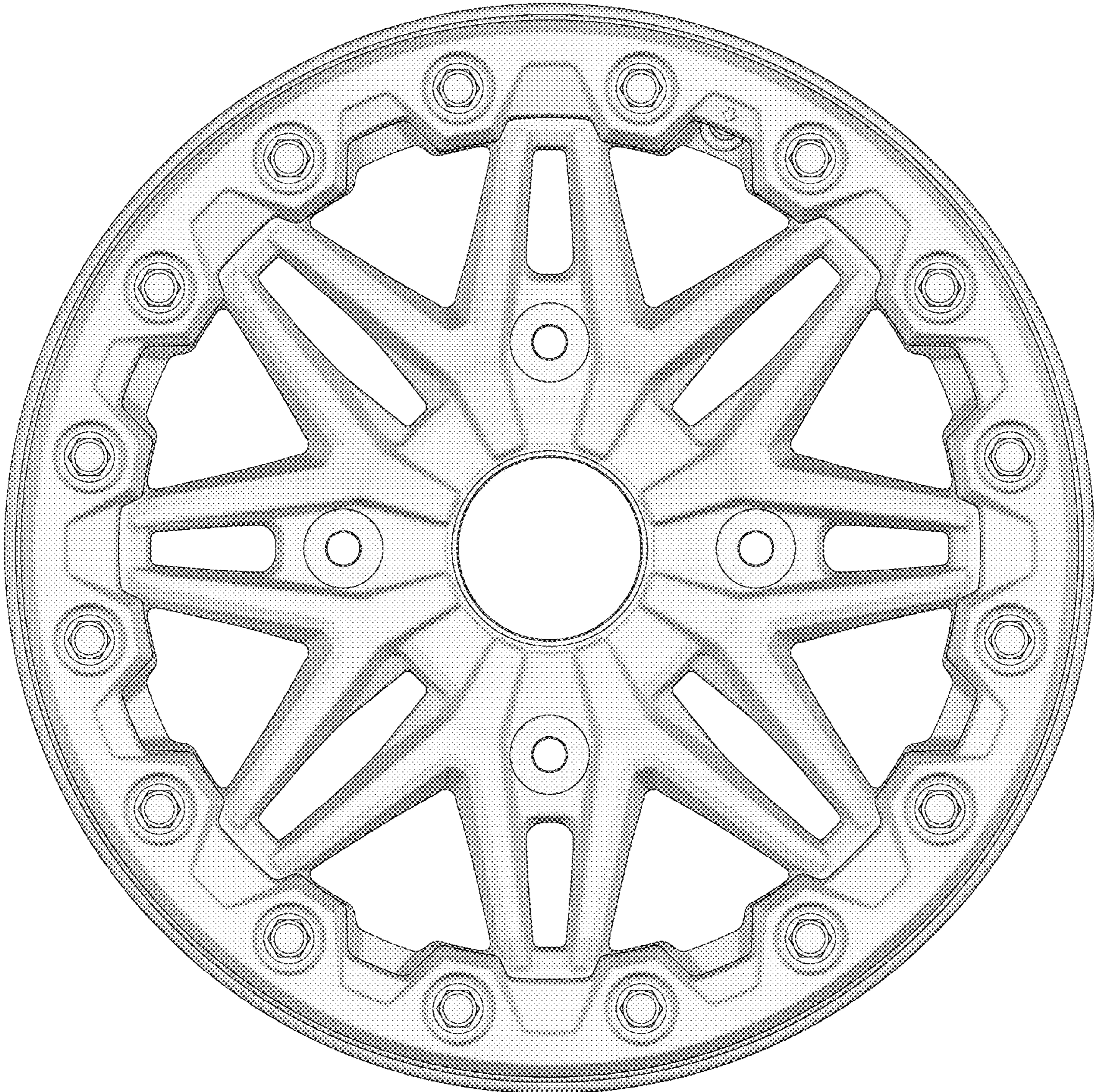

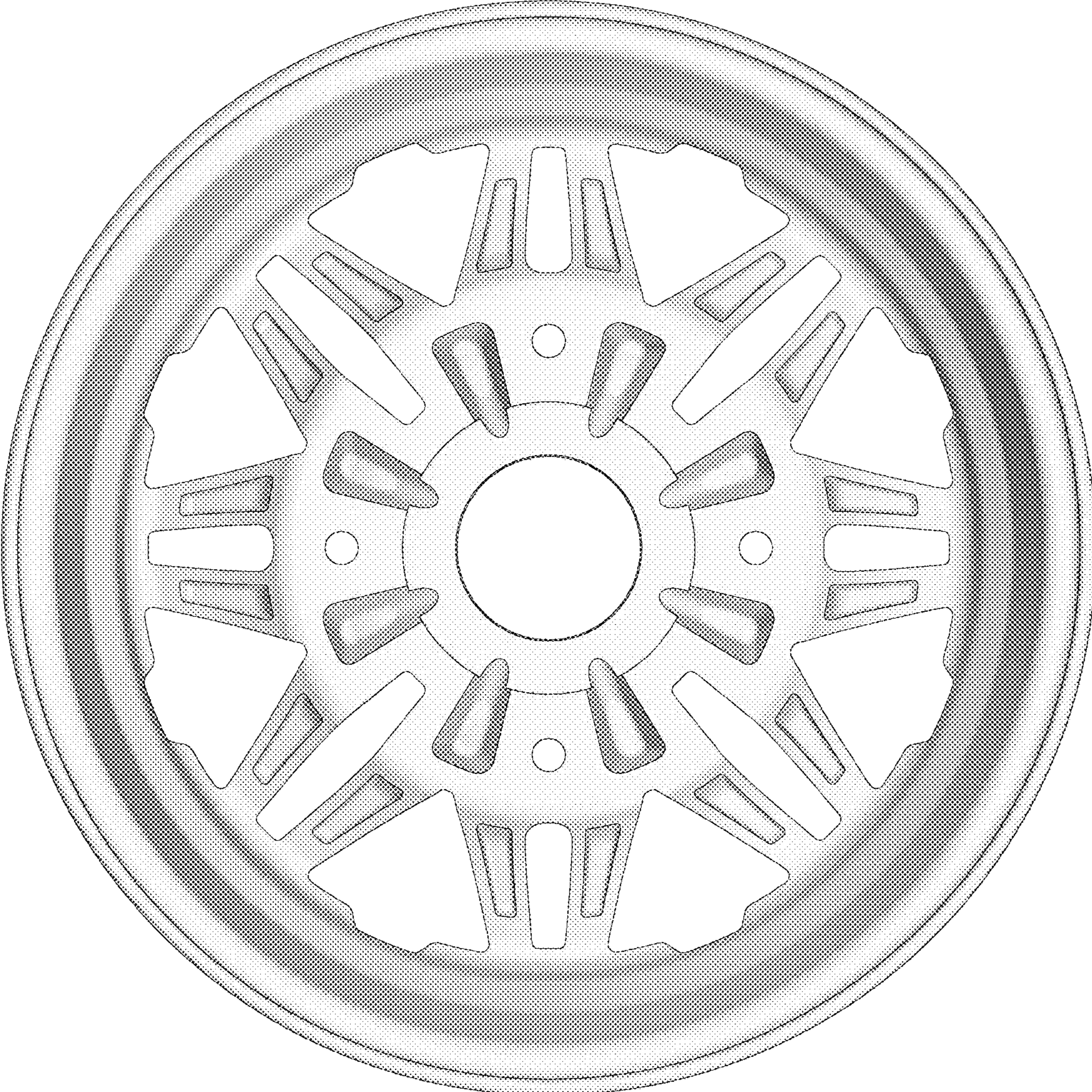

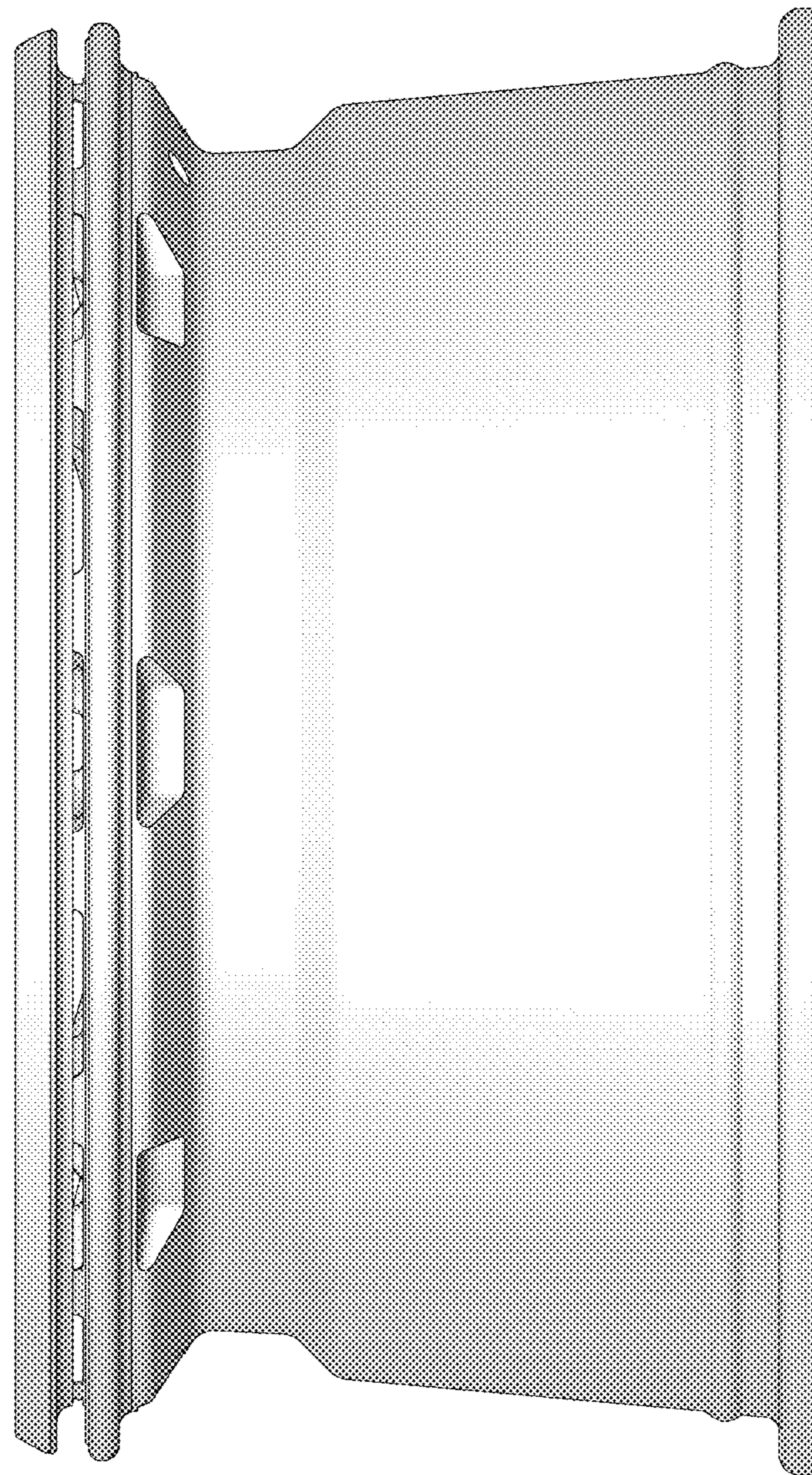

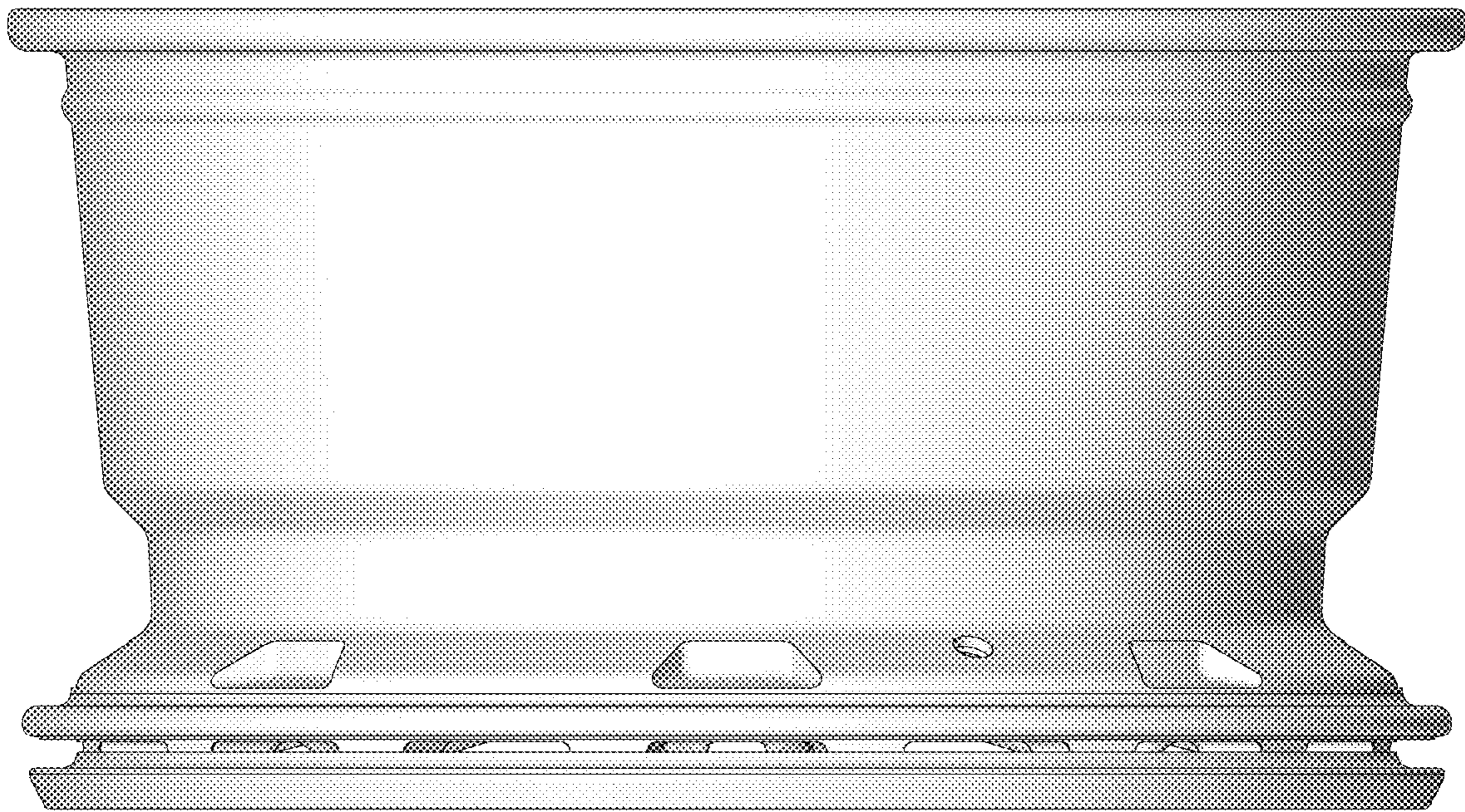

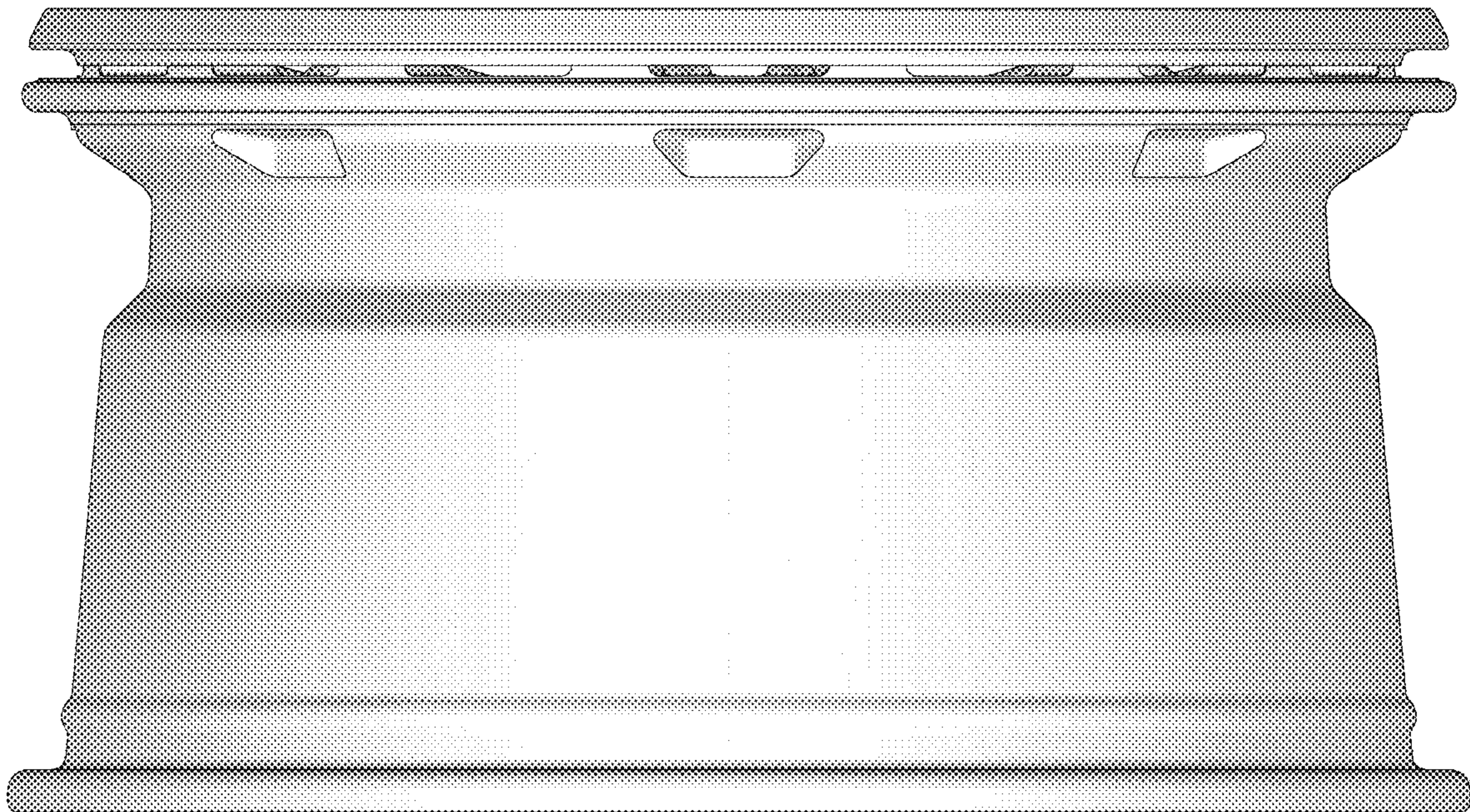

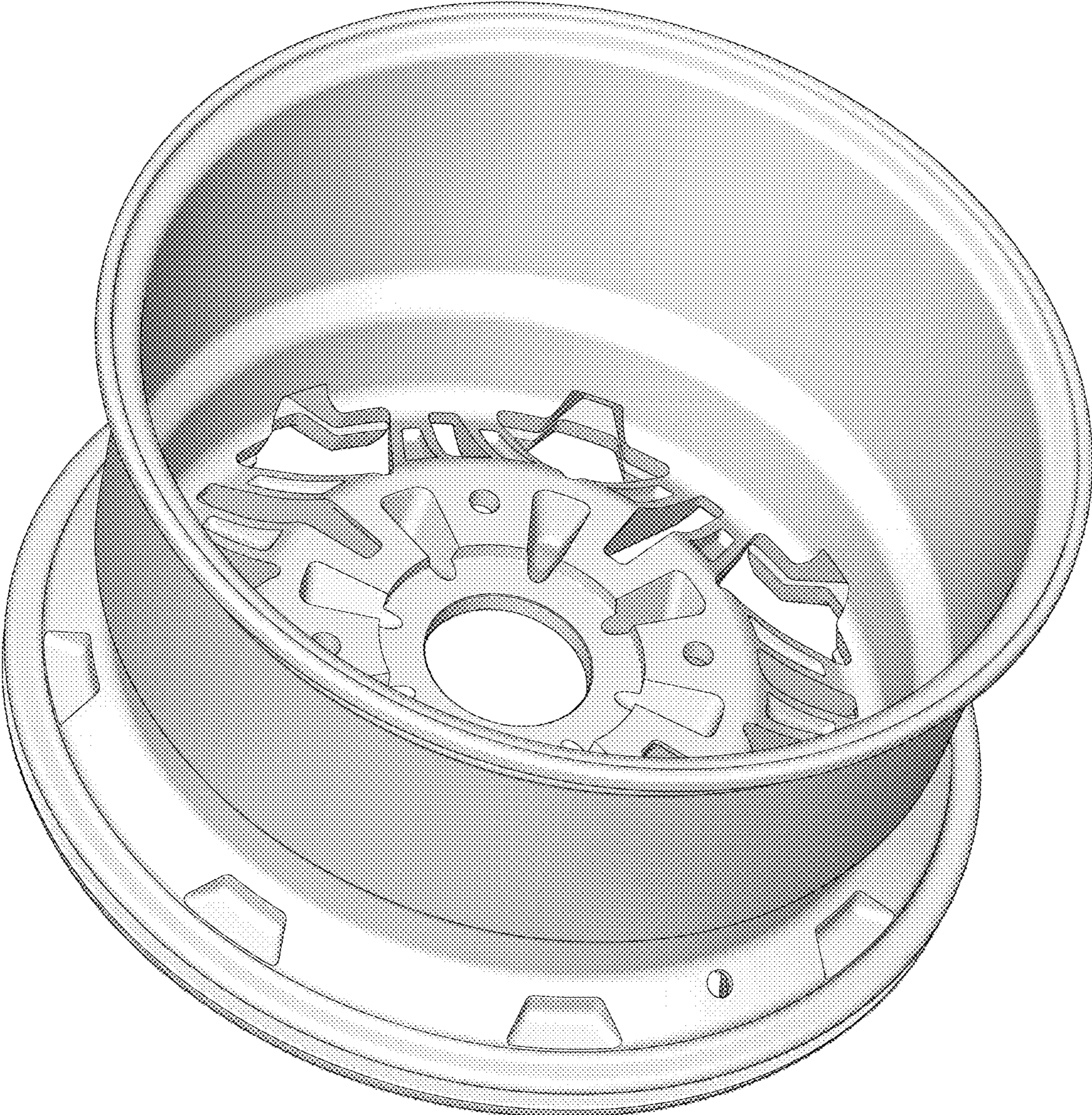
