**DESCRIPTION**

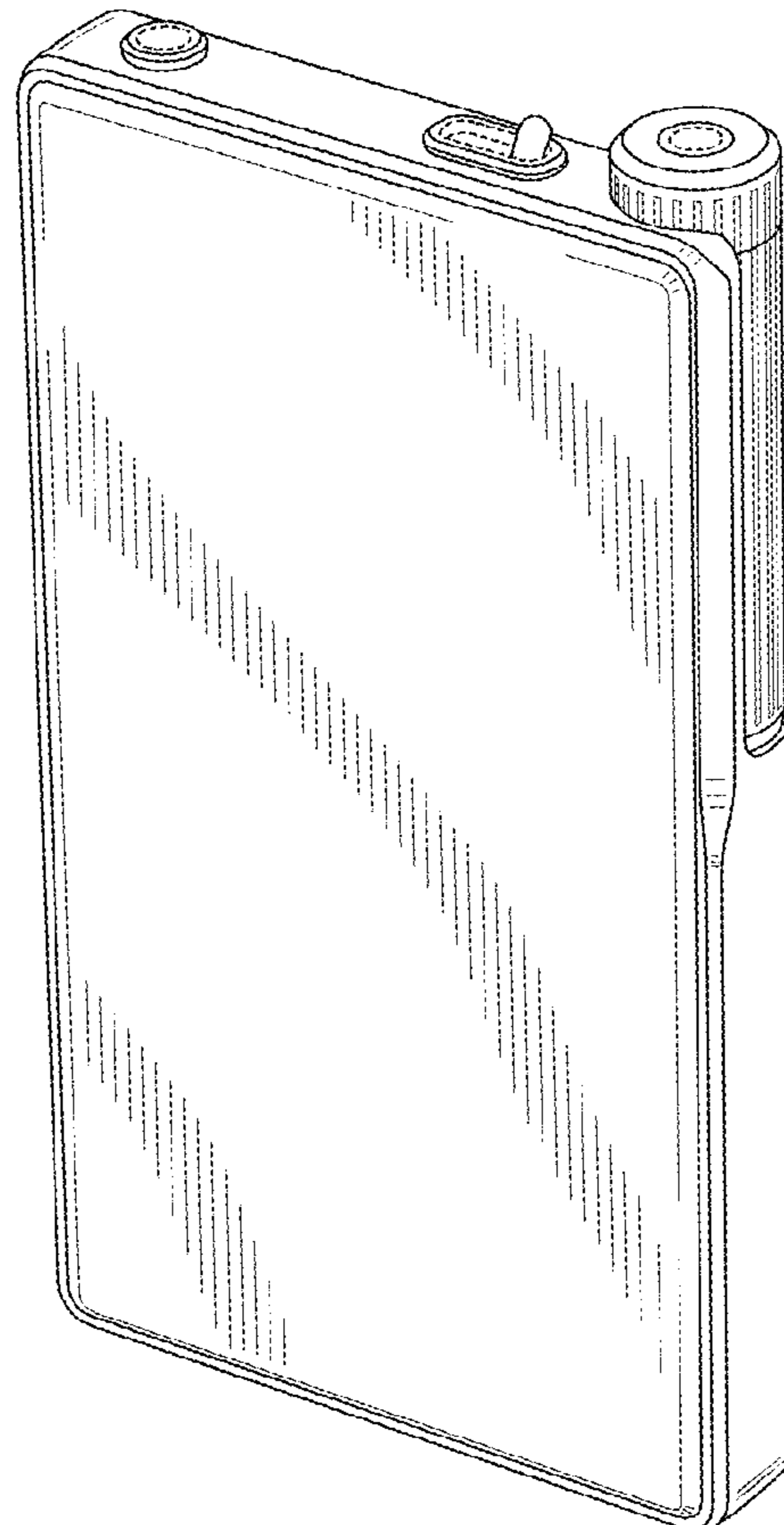
FIG. 1 is a front view of a portable music player showing my design;

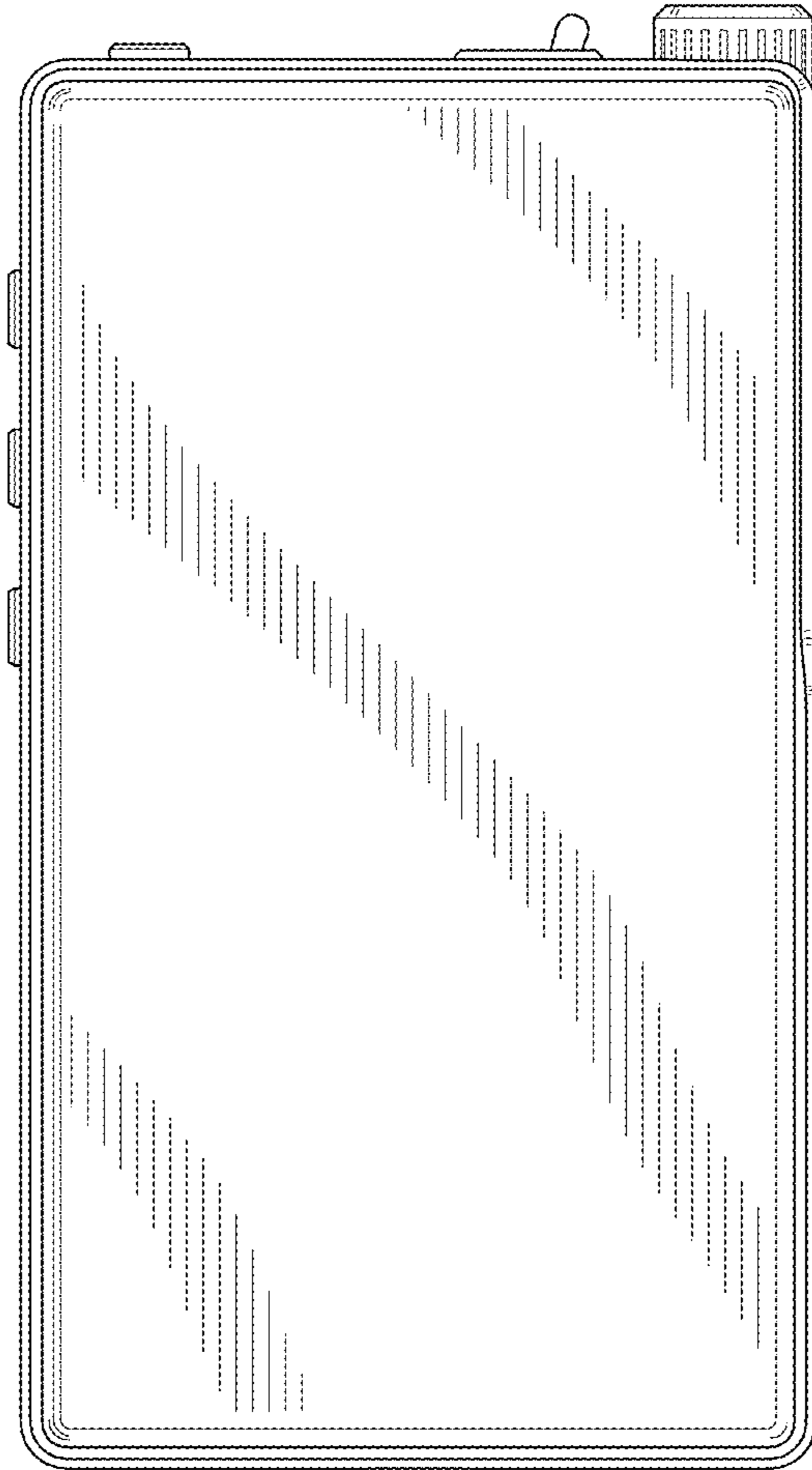

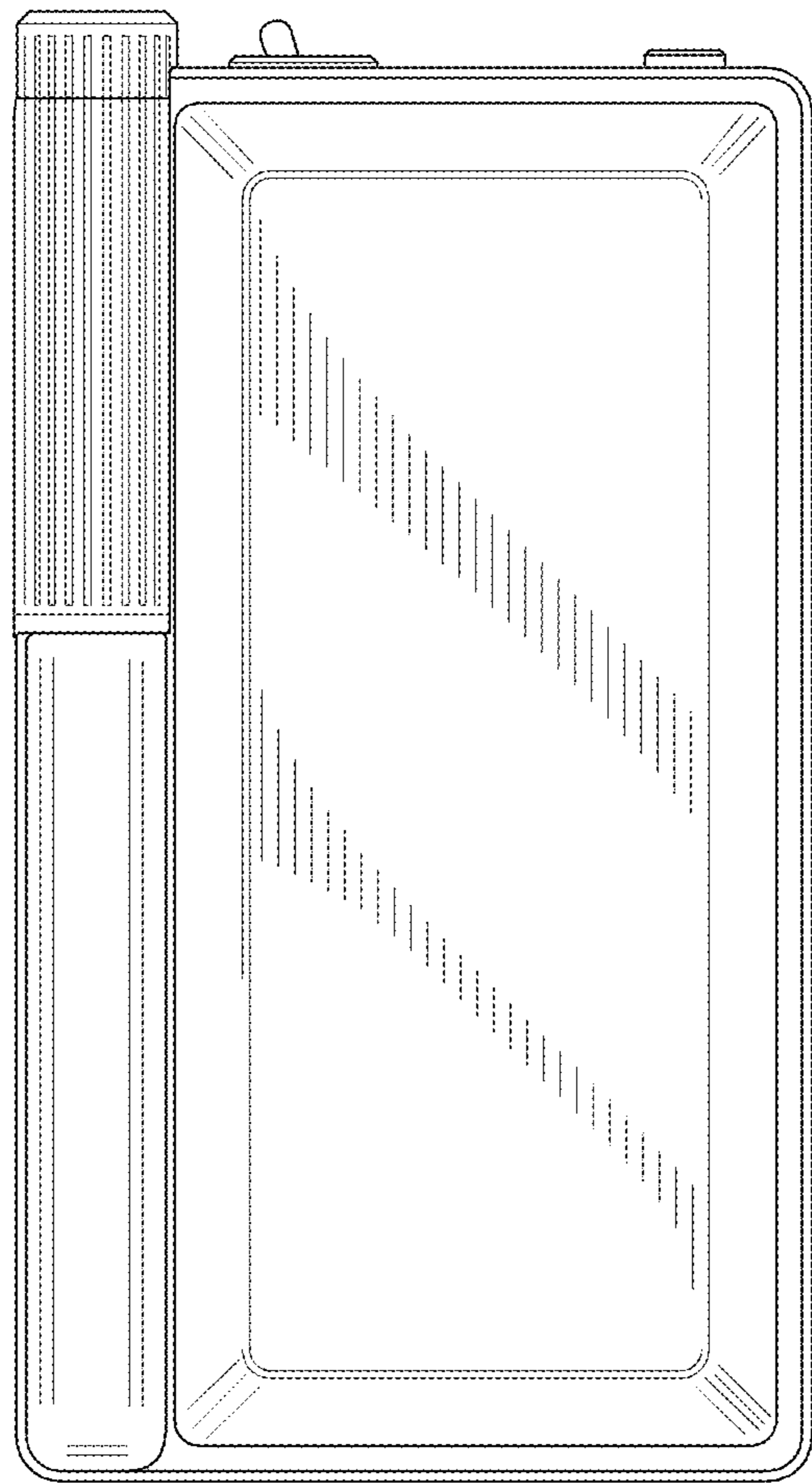

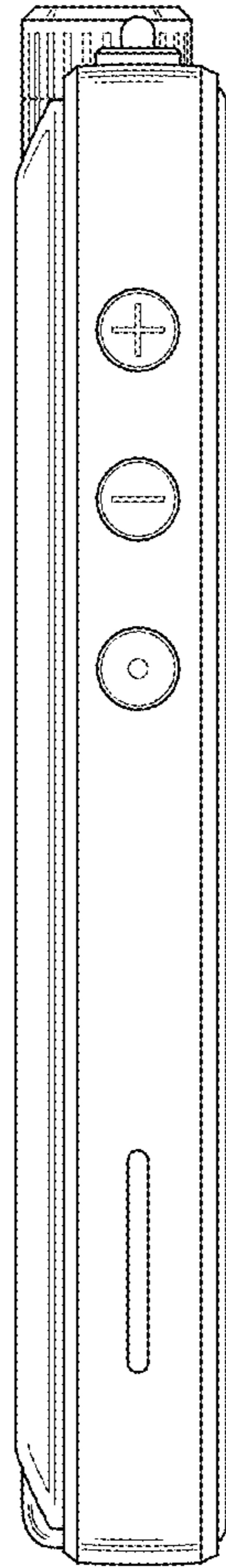

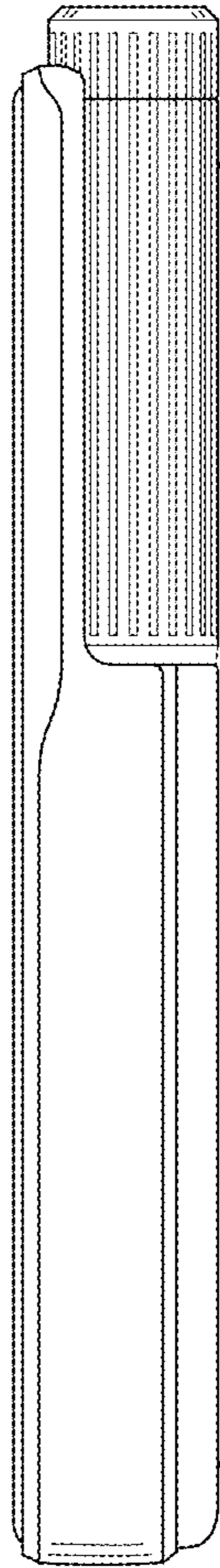

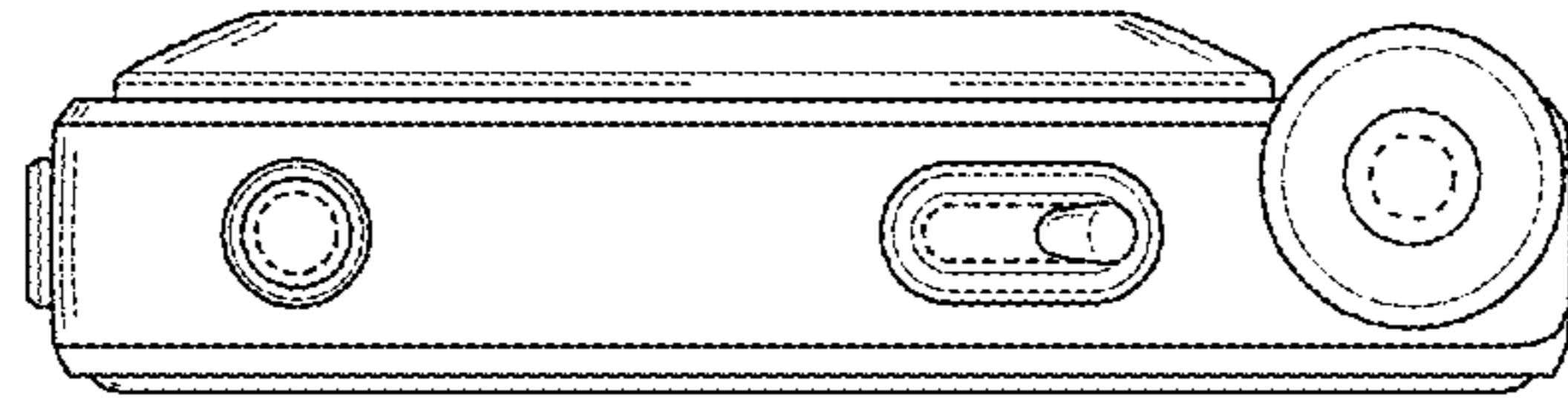

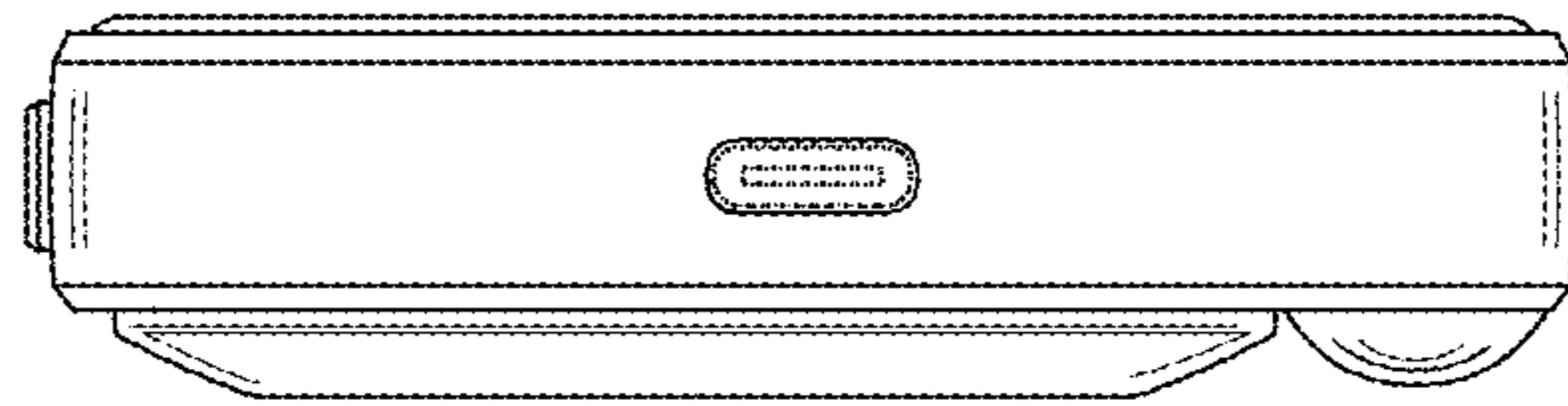

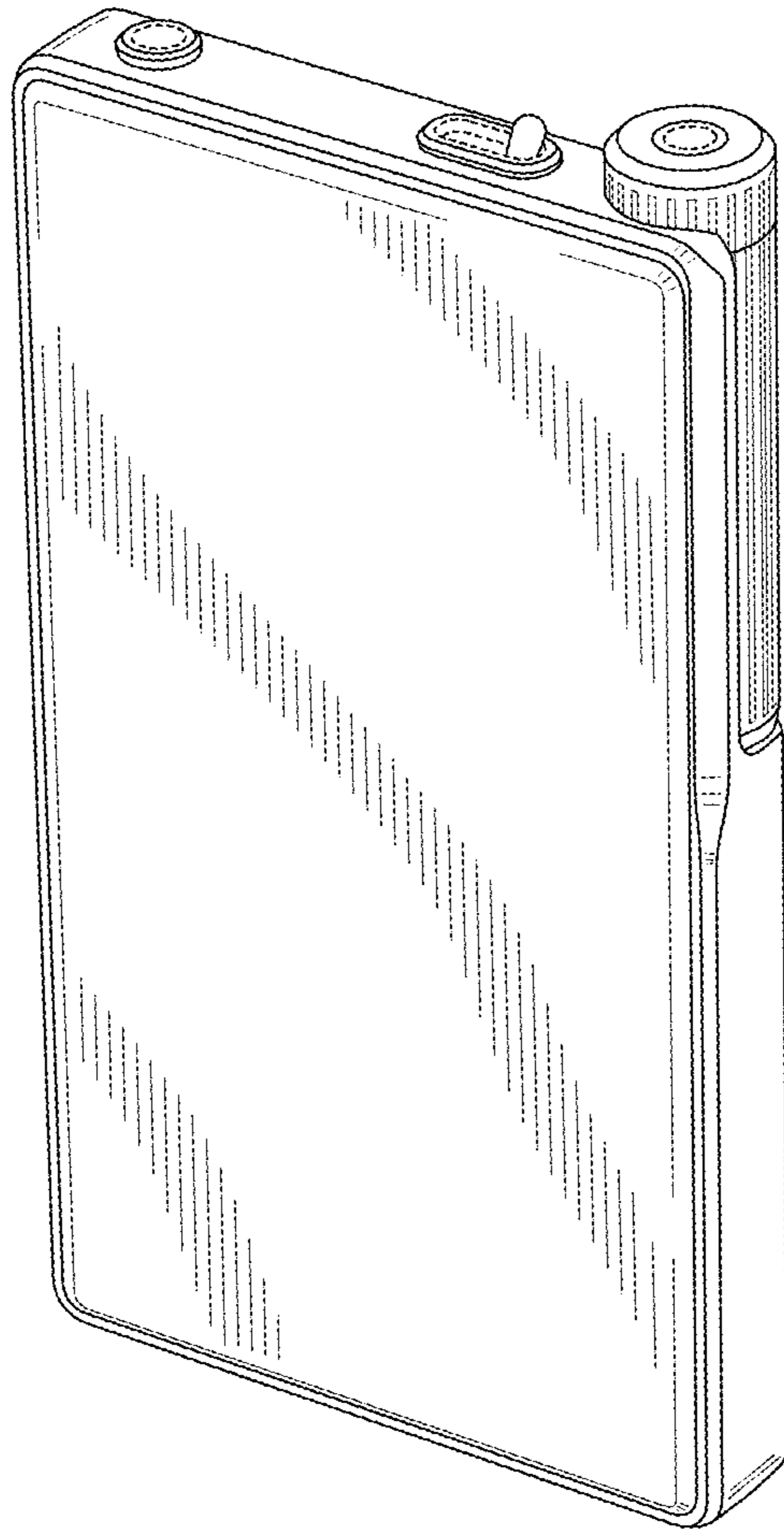
