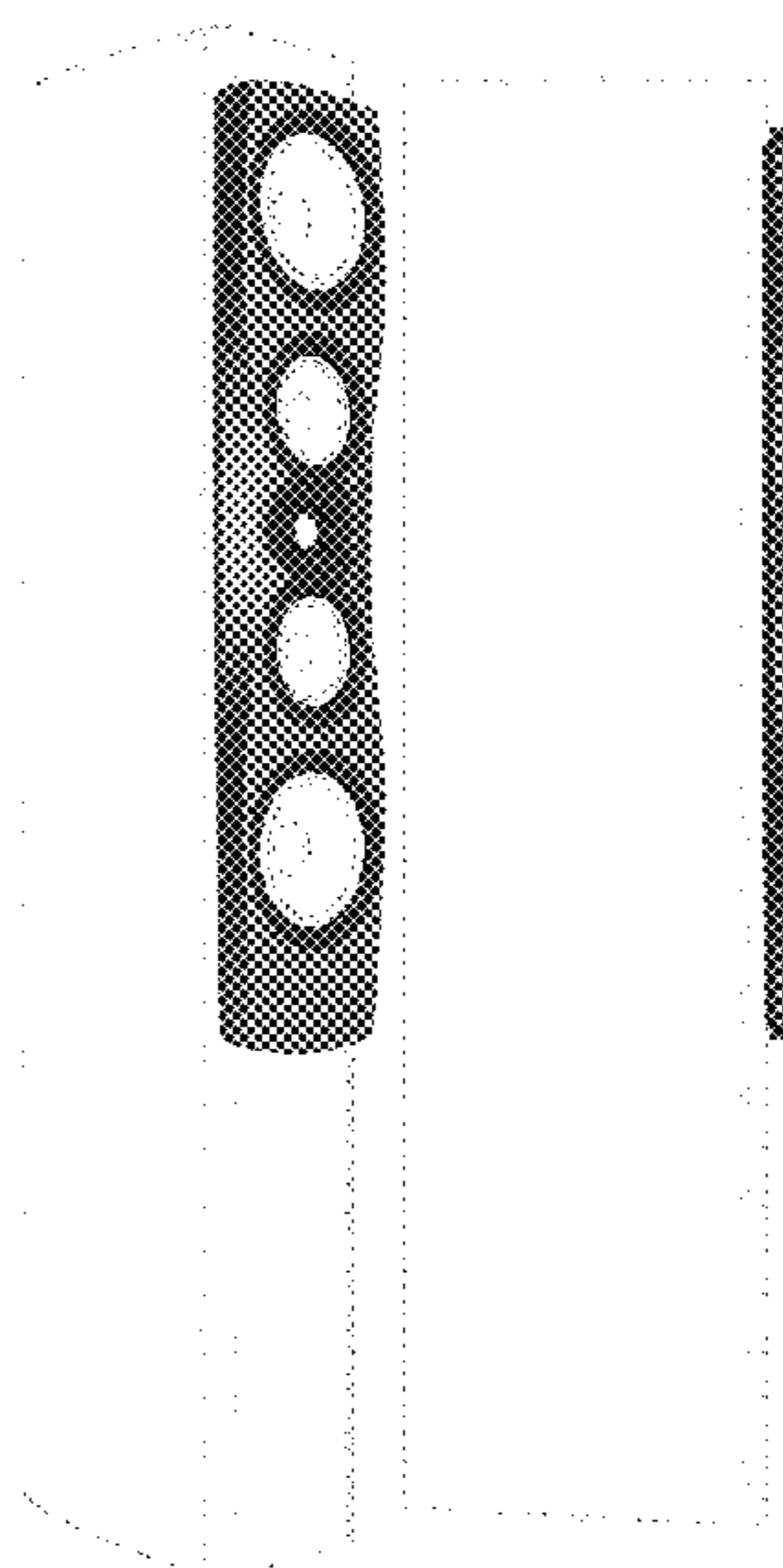
The ornamental design for baffles for loudspeaker, as shown and described.

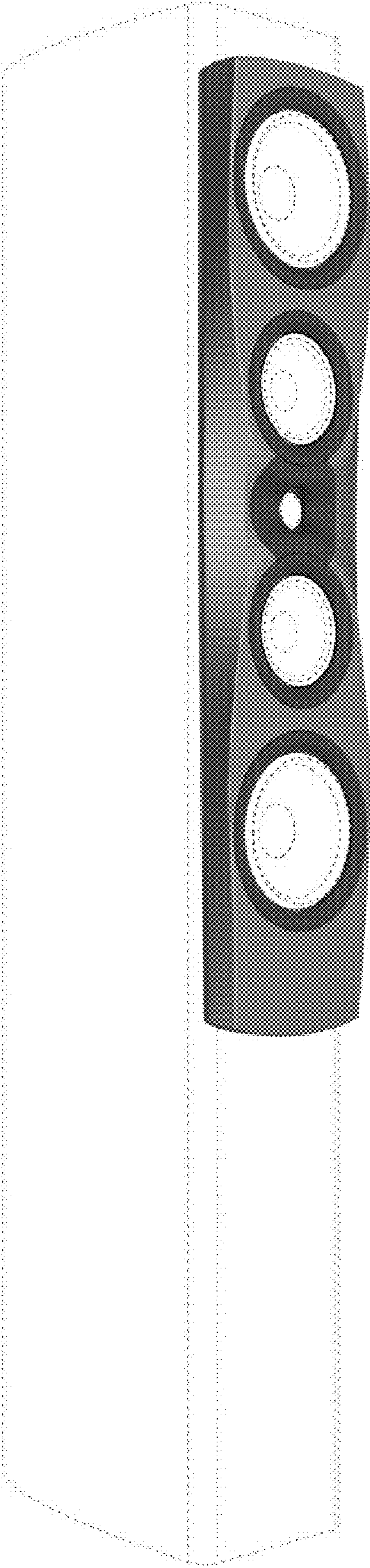

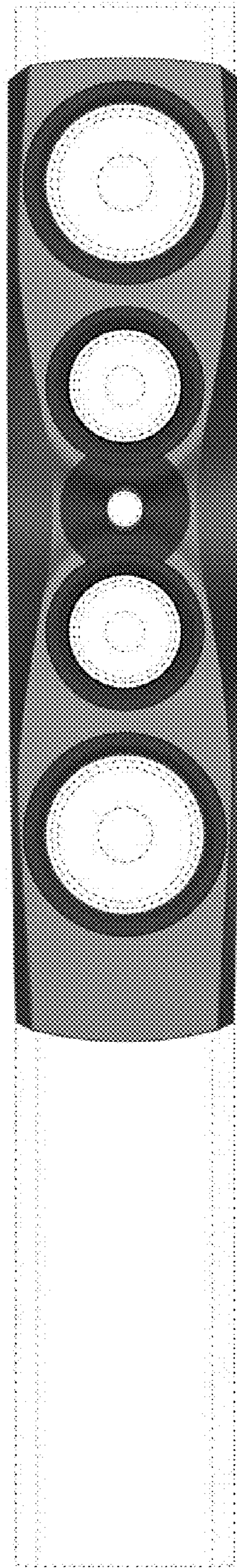

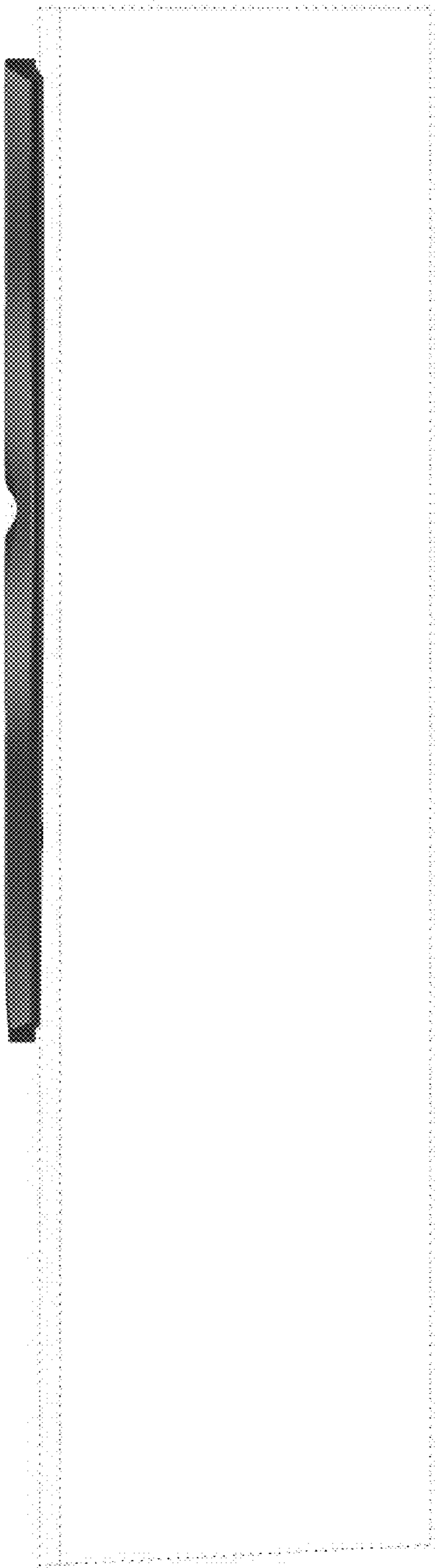

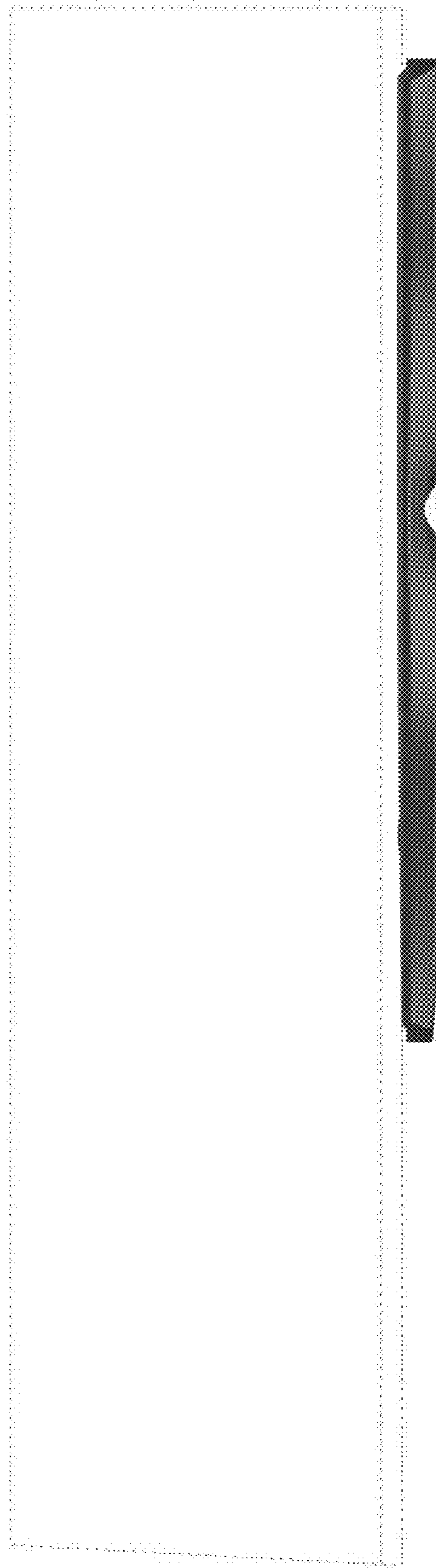

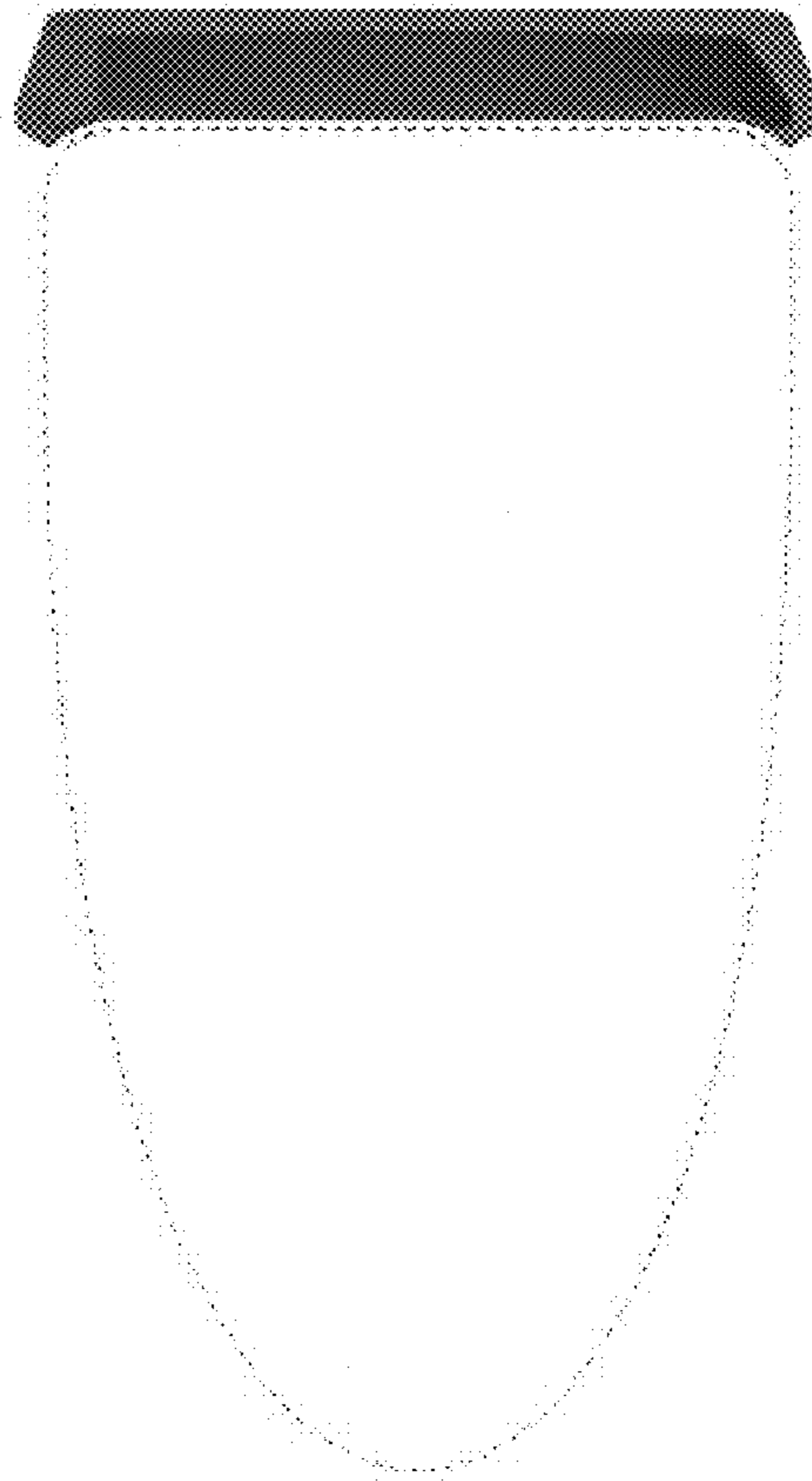

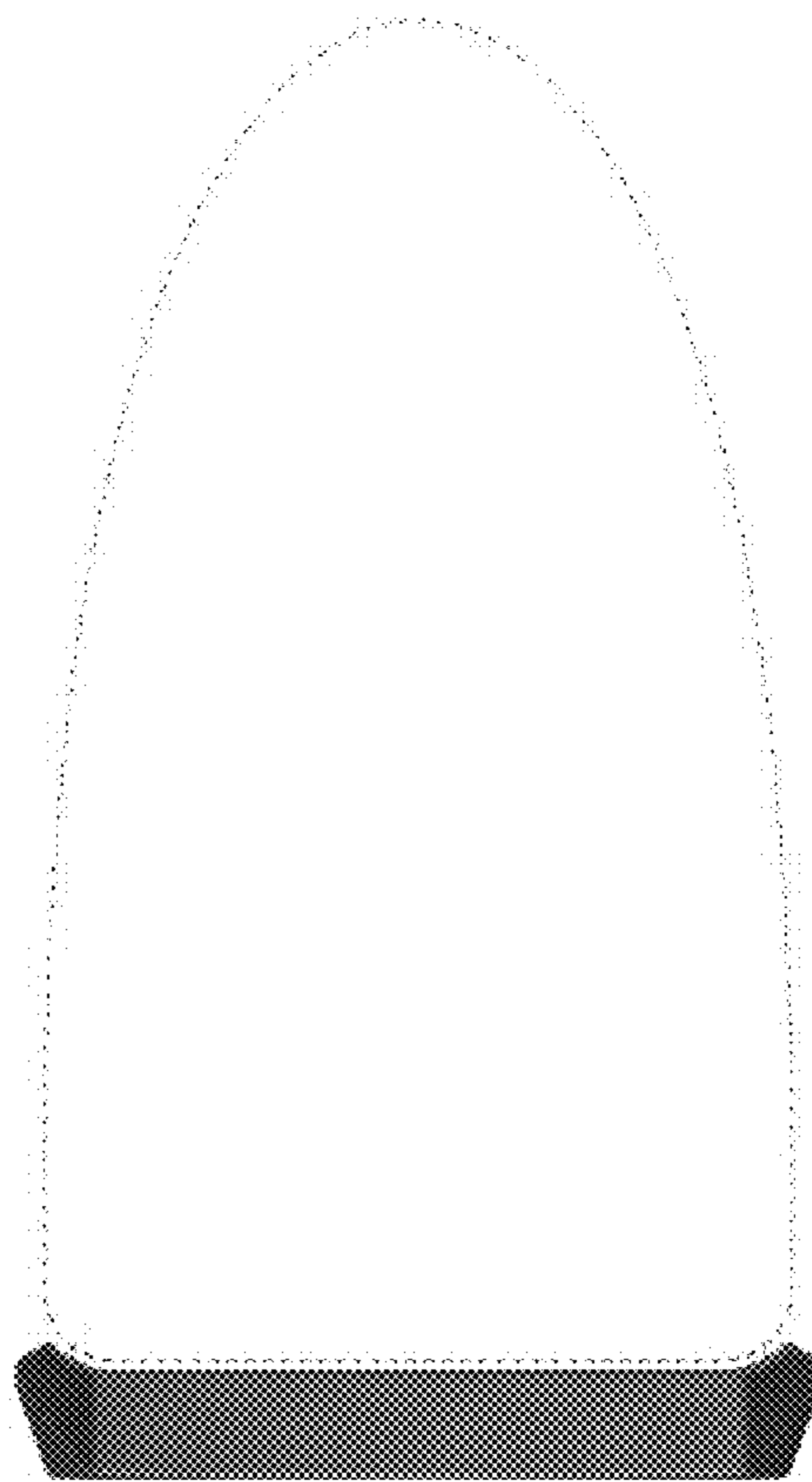
