(57) **CLAIM**

The ornamental design for a display screen or portion thereof with transitional graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of the claimed design;

FIG. 2 is a front view showing a second image of the first embodiment;

FIG. 3 is a front view showing a third image of the first embodiment;

FIG. 4 is a front view of a second embodiment of the claimed design;

FIG. 5 is a front view showing a second image of the second embodiment;

FIG. 6 is a front view showing a third image of the second embodiment;

FIG. 7 is a front view showing a fourth image of the second embodiment.

FIG. 8 is a front view of a third embodiment of the claimed design;

FIG. 9 is a front view showing a second image of the third embodiment;

FIG. 10 is a front view showing a third image of the third embodiment;

FIG. 11 is a front view of a fourth embodiment of the claimed design;

FIG. 12 is a front view showing a second image of the fourth embodiment;

FIG. 13 is a front view showing a third image of the fourth embodiment; and,

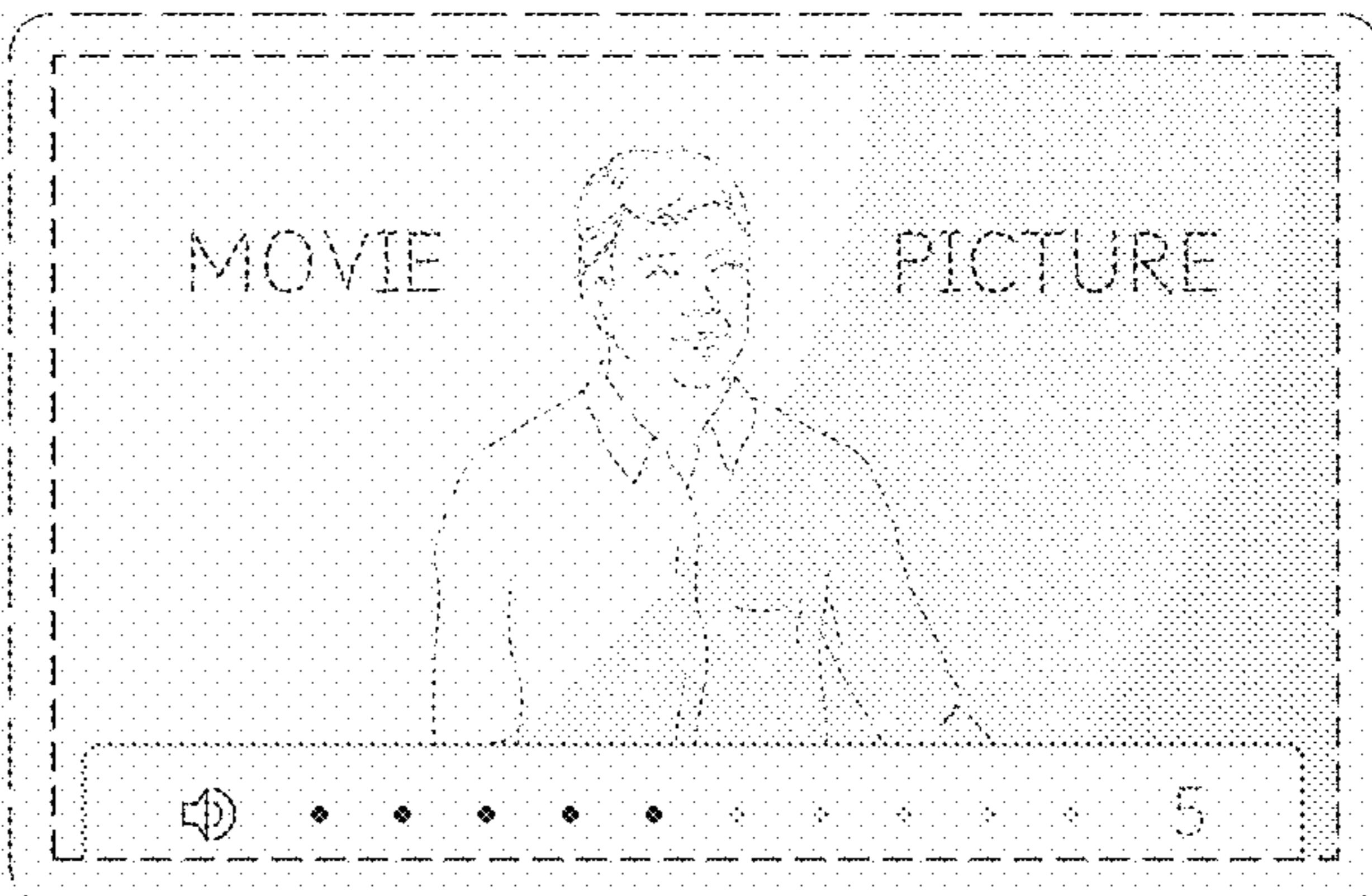
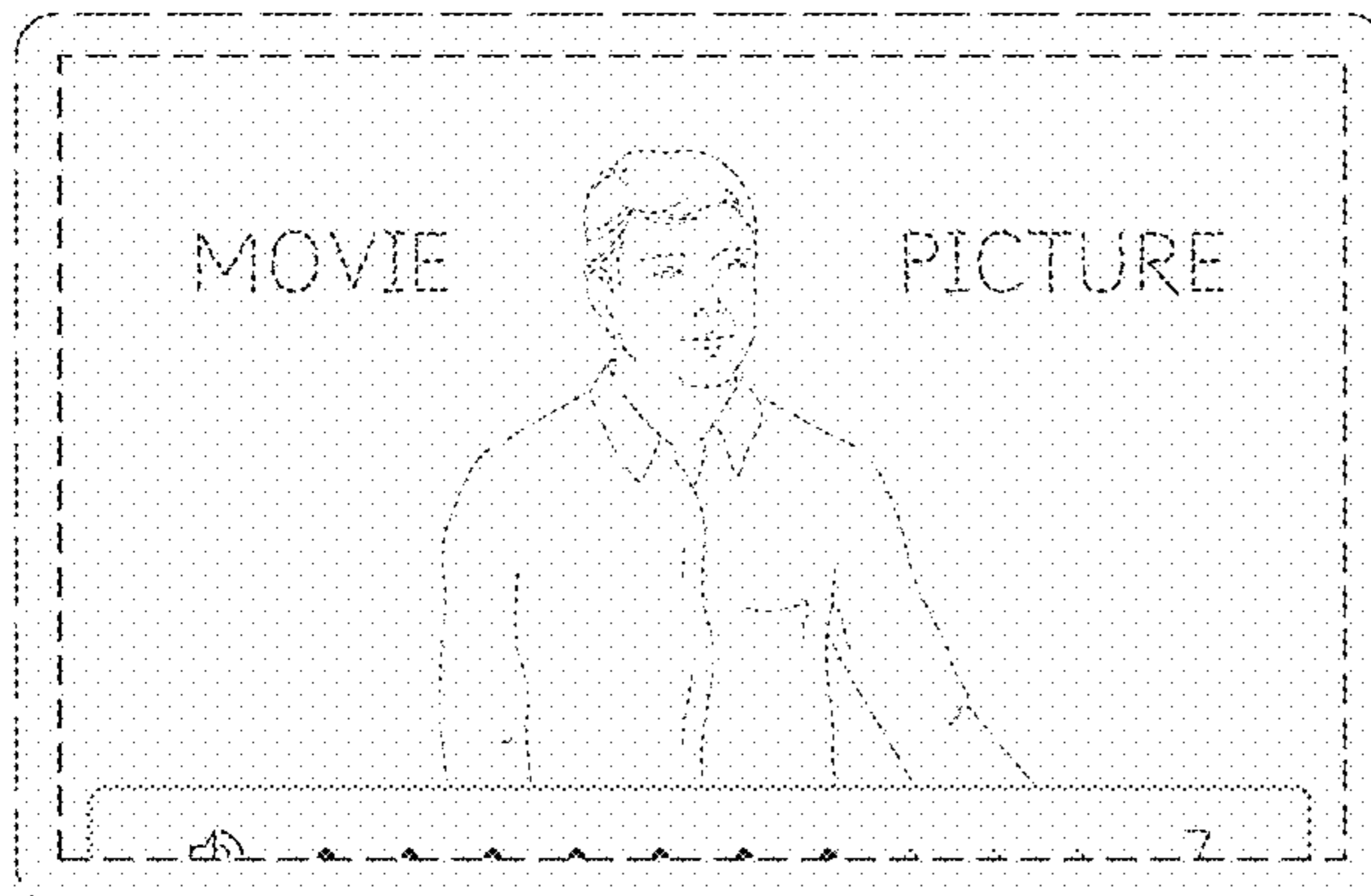


FIG. 14 is a front view showing a fourth image of the fourth embodiment.

The appearance of the transition is sequential from FIG. 1 to FIG. 3 in the first embodiment, from FIG. 4 to FIG. 7 in the second embodiment, from FIG. 8 to FIG. 10 in the third embodiment, and from FIG. 11 to FIG. 14 in the fourth embodiment. The process or period in which an image transitions to another image forms no part of the claimed design.

The shading in the Figures indicate a contrast in appearance. The longer broken-line showing of a portion of an electronic device and the intermediate-length broken-line showing of a display screen boundary, as well as the features within the interface shown in still shorter broken-lines, are included for the purpose of illustrating environmental structure and form no part of the claimed design.

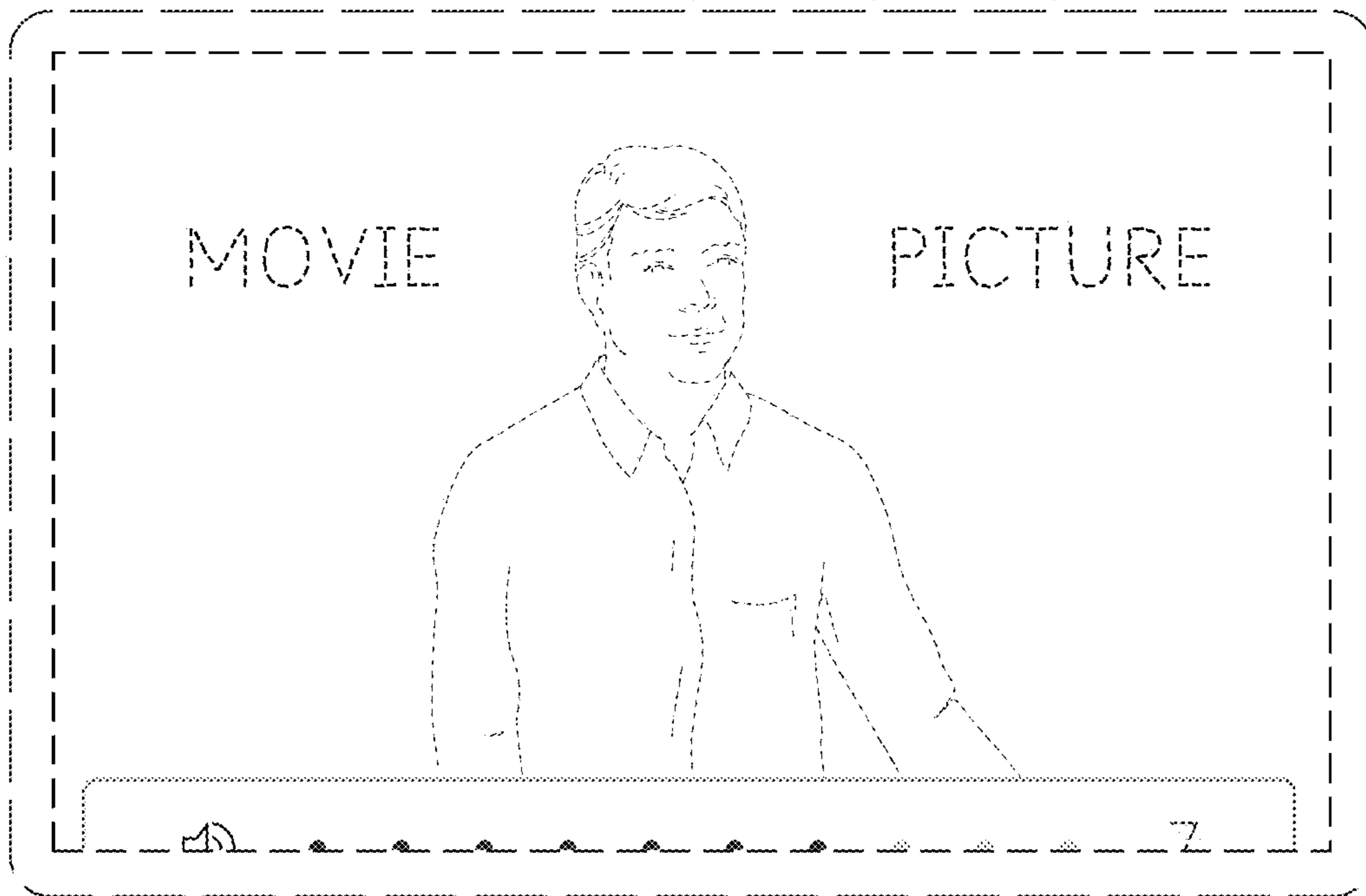

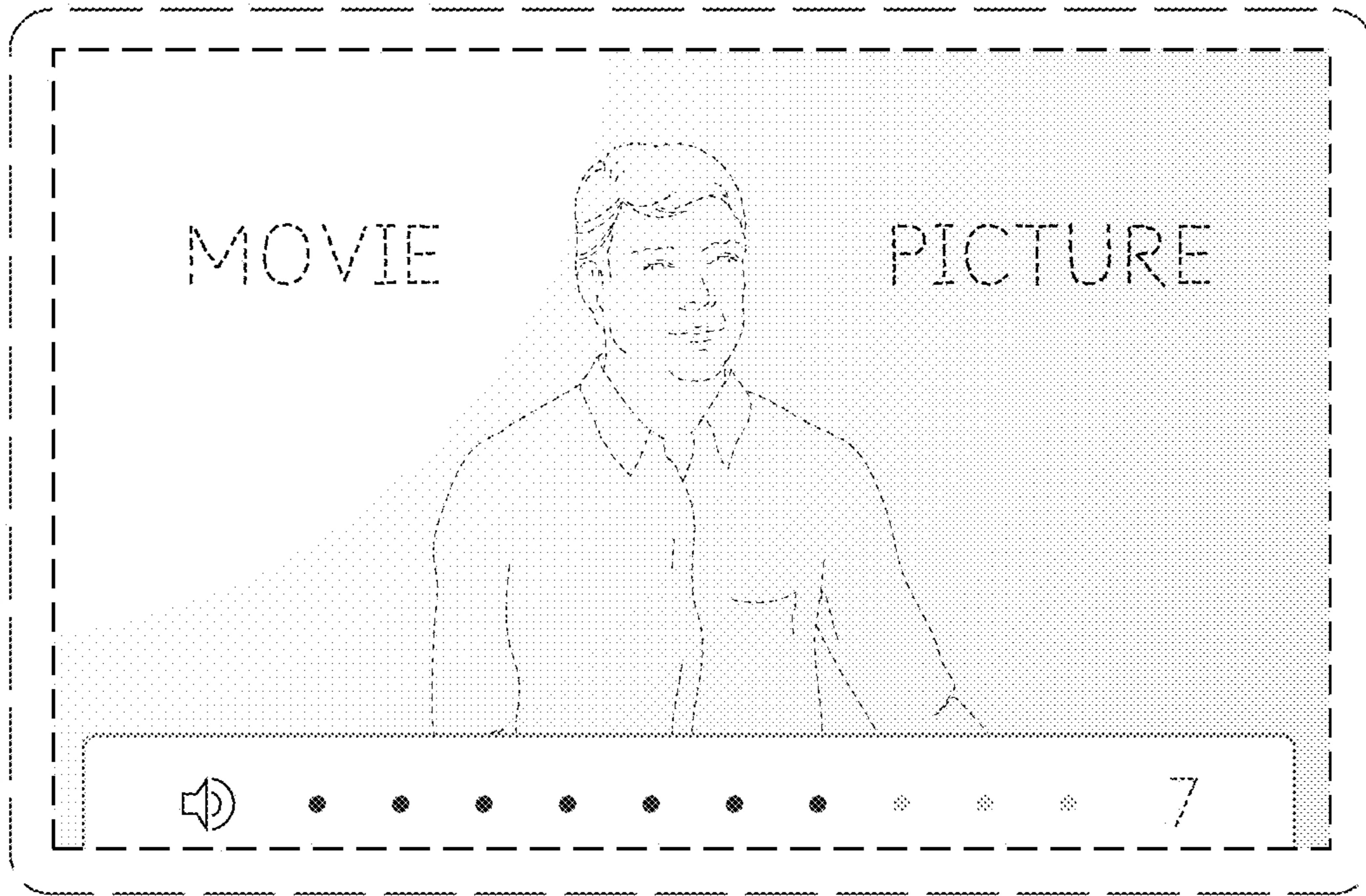

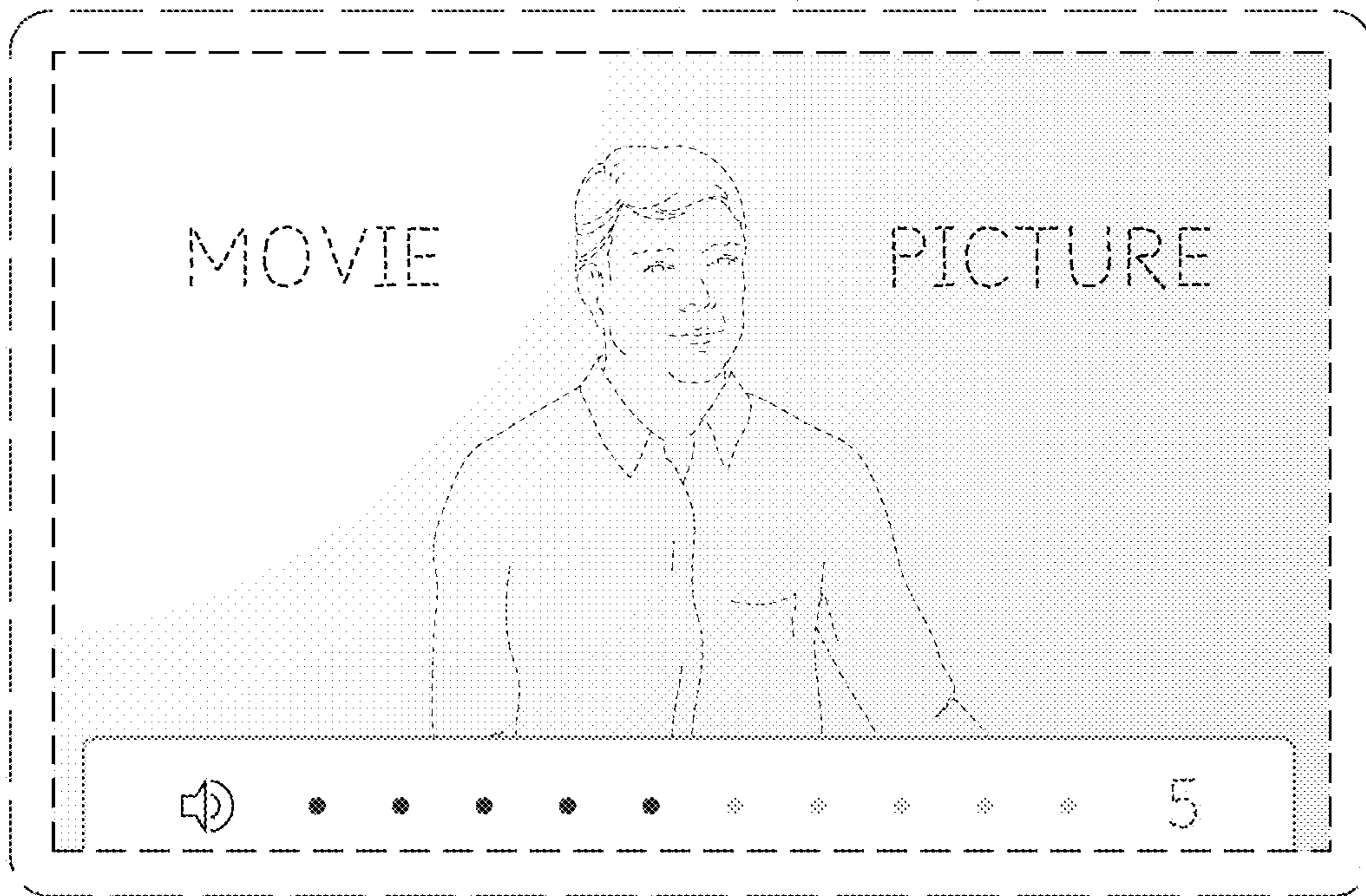

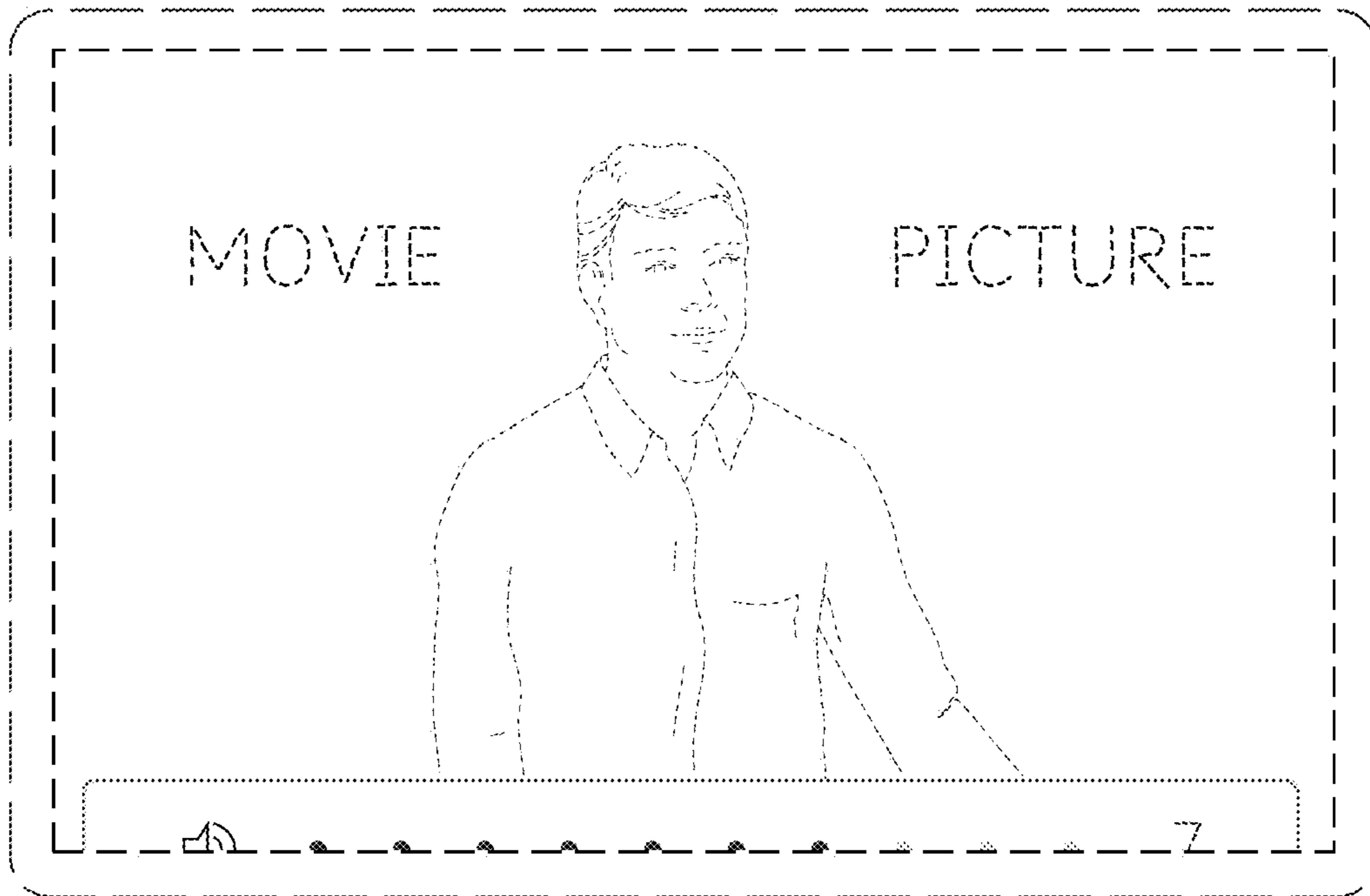

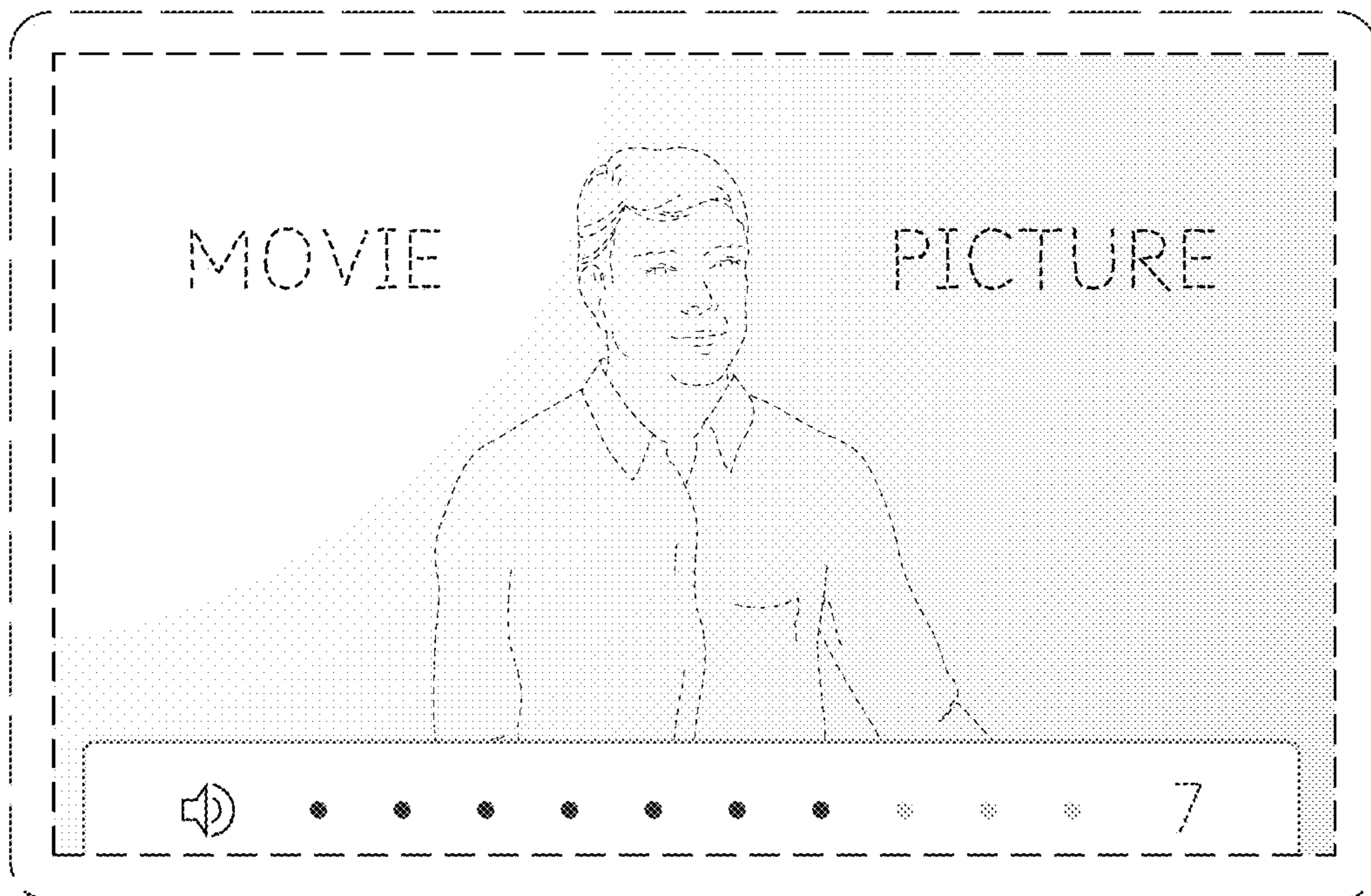

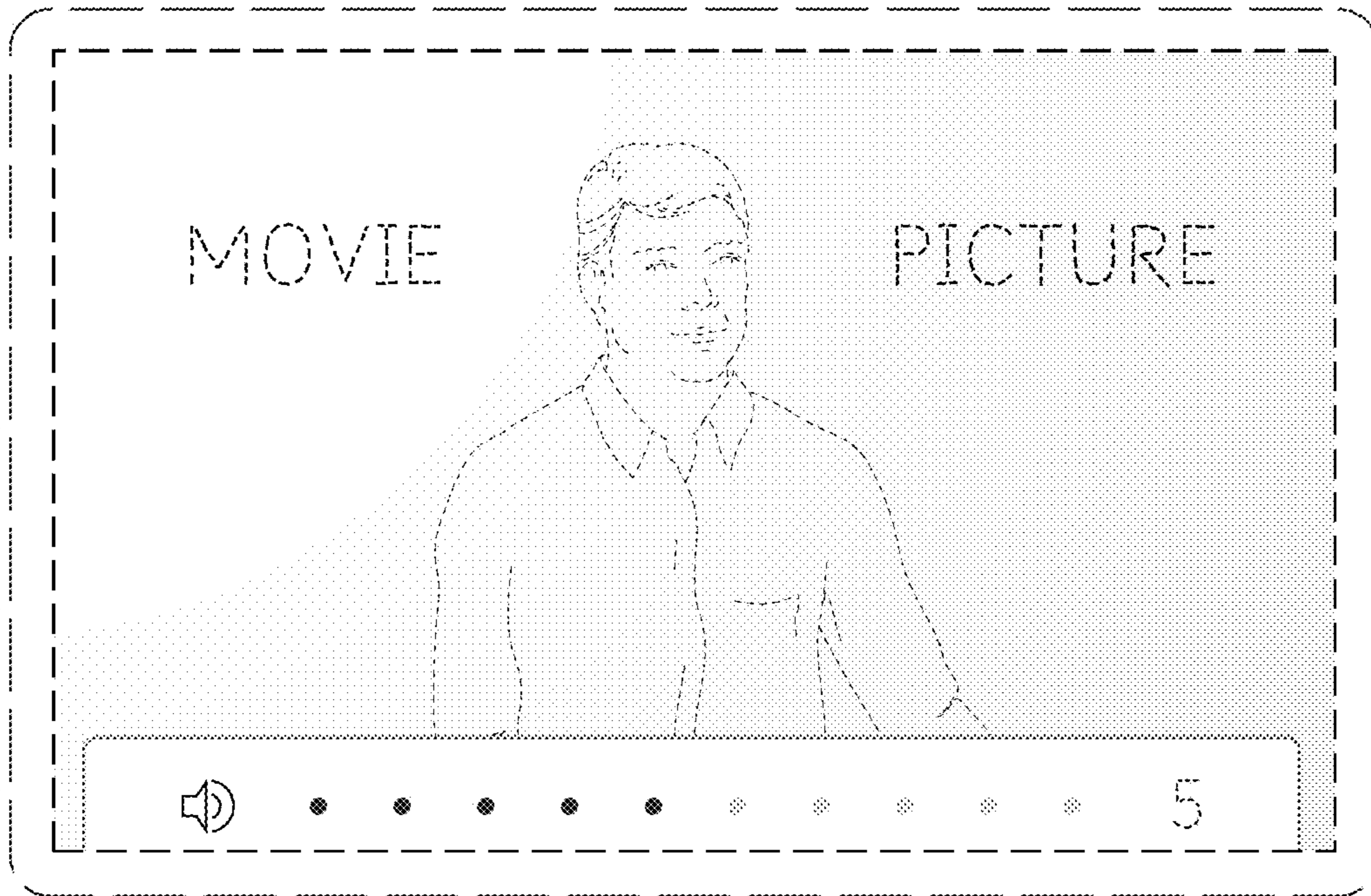

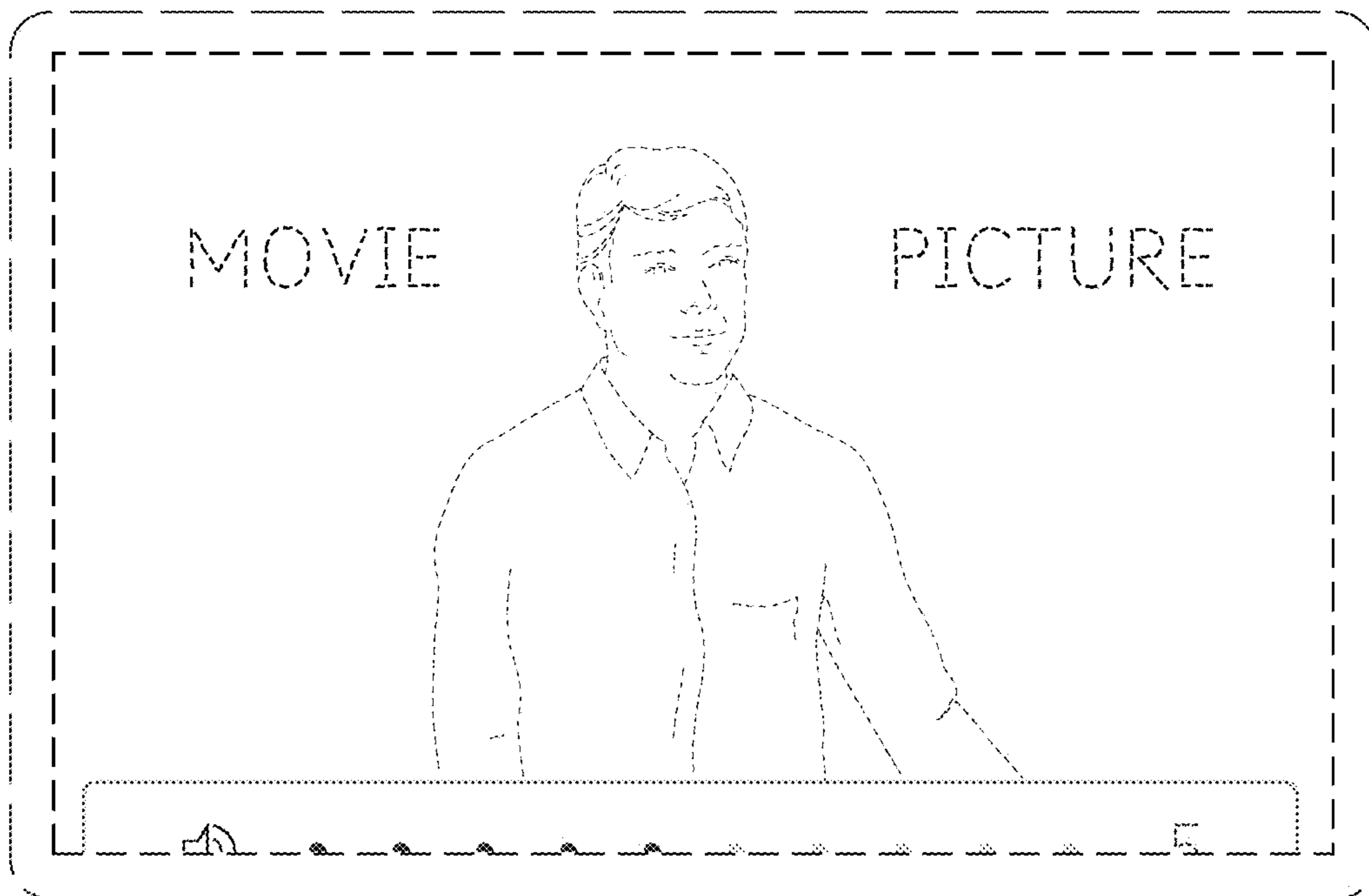

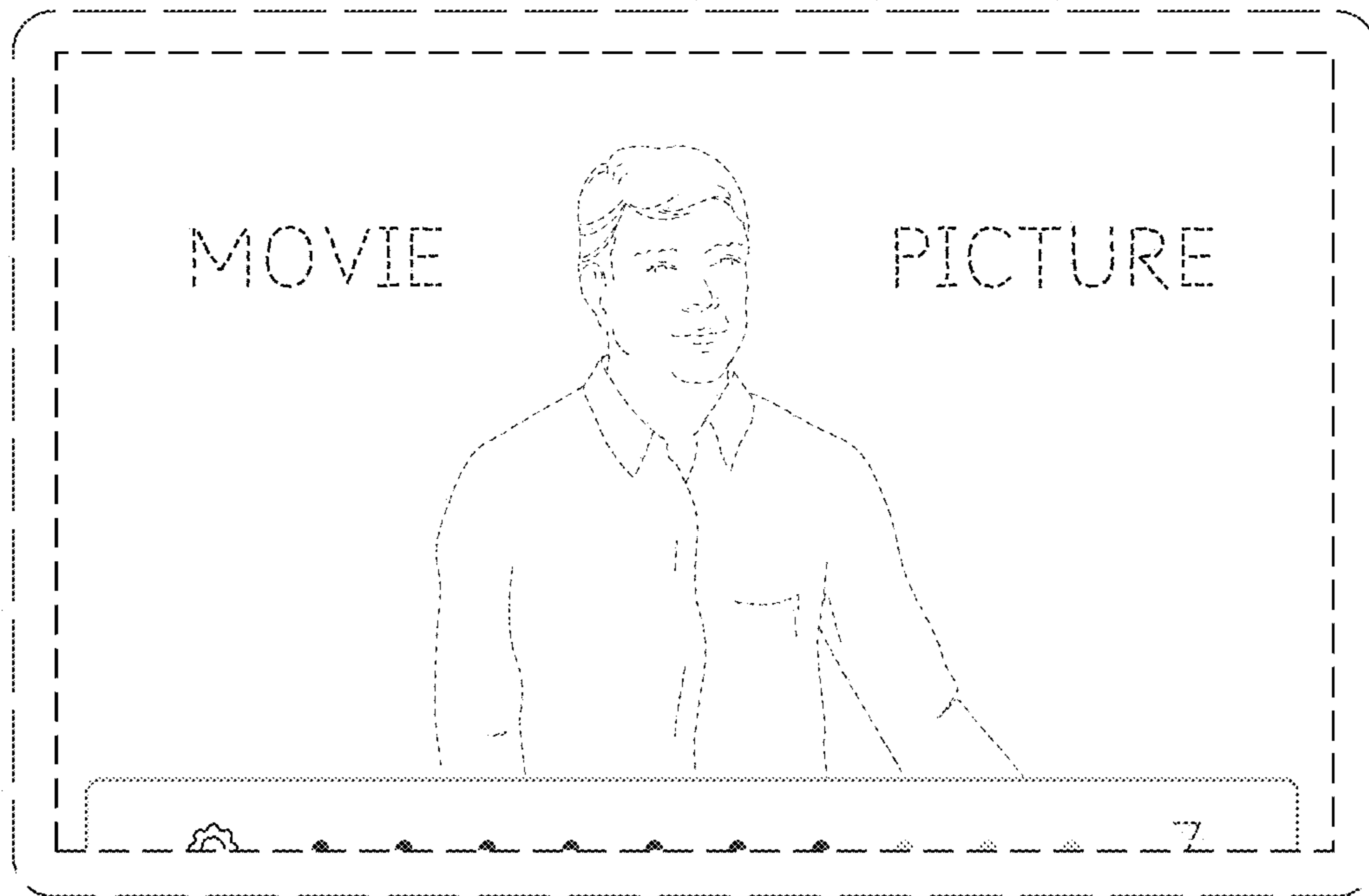

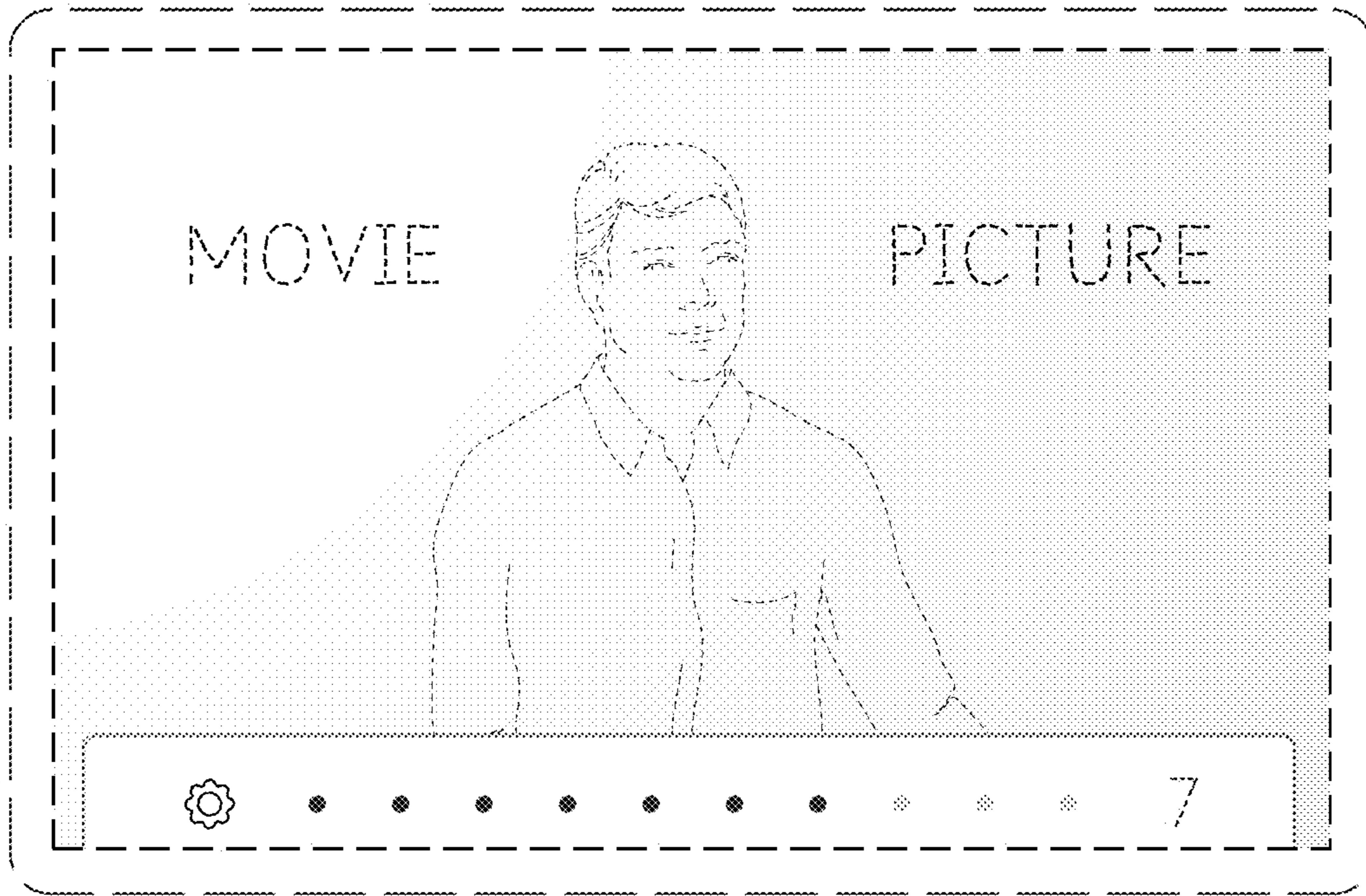

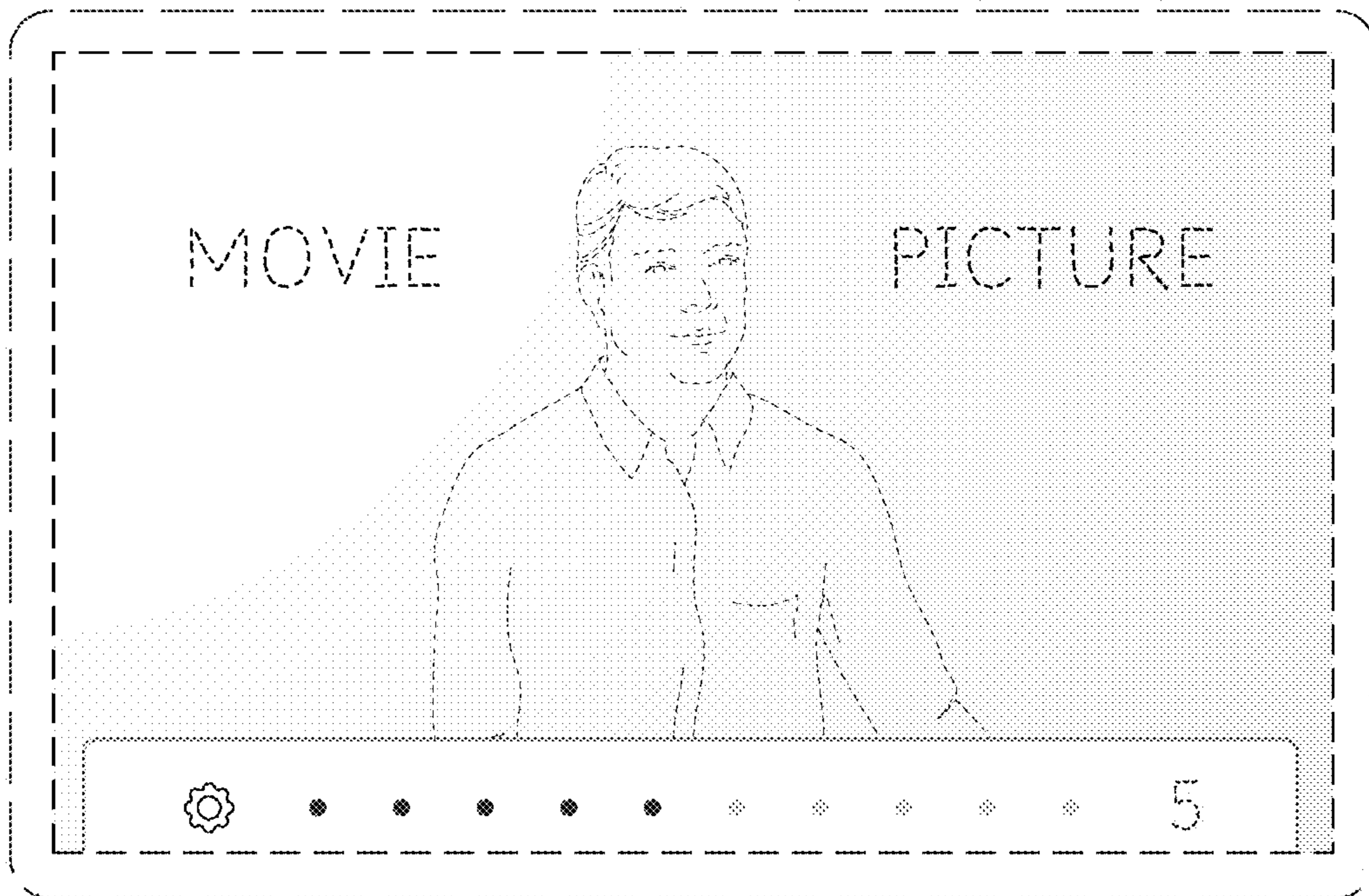

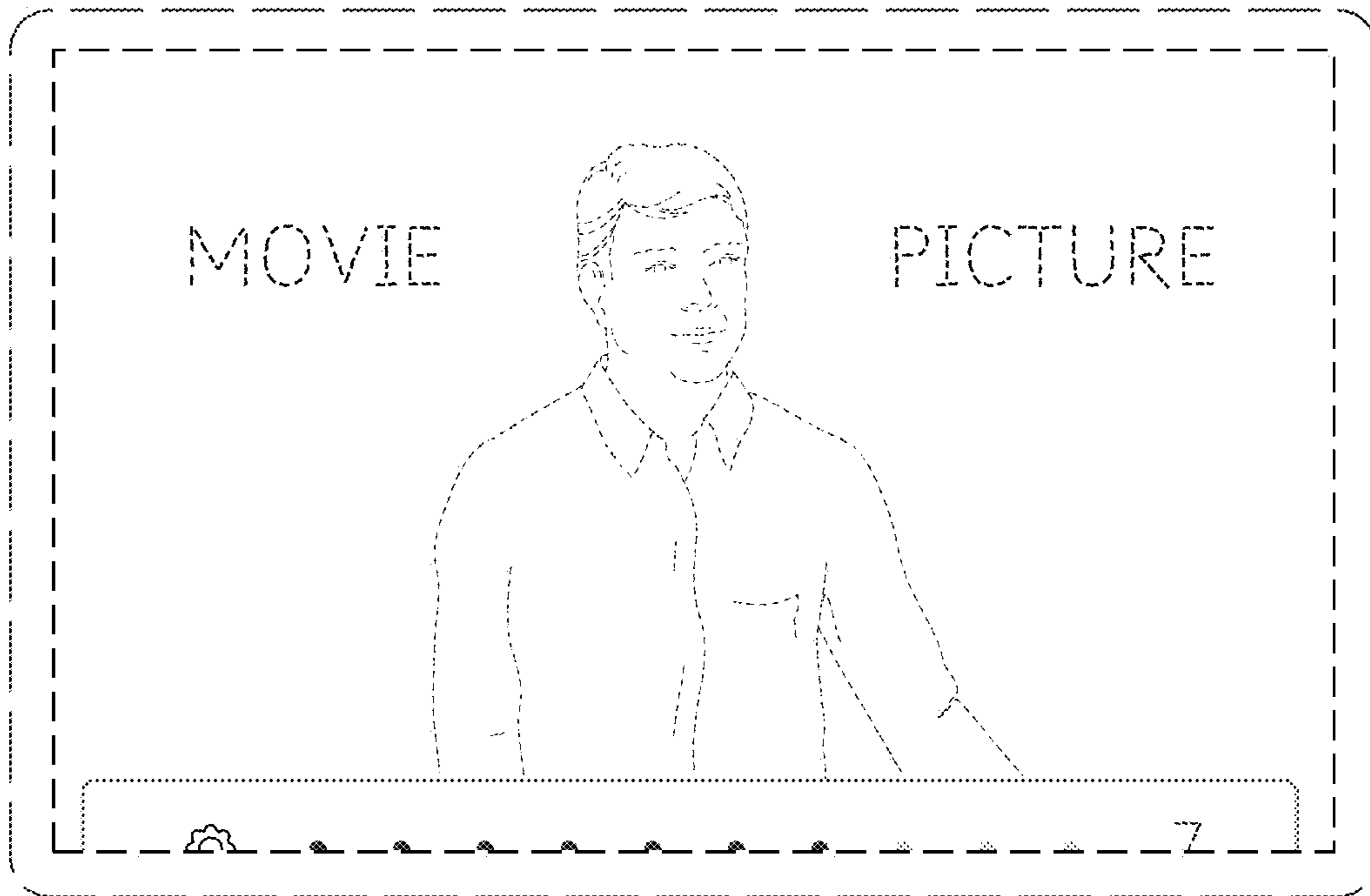

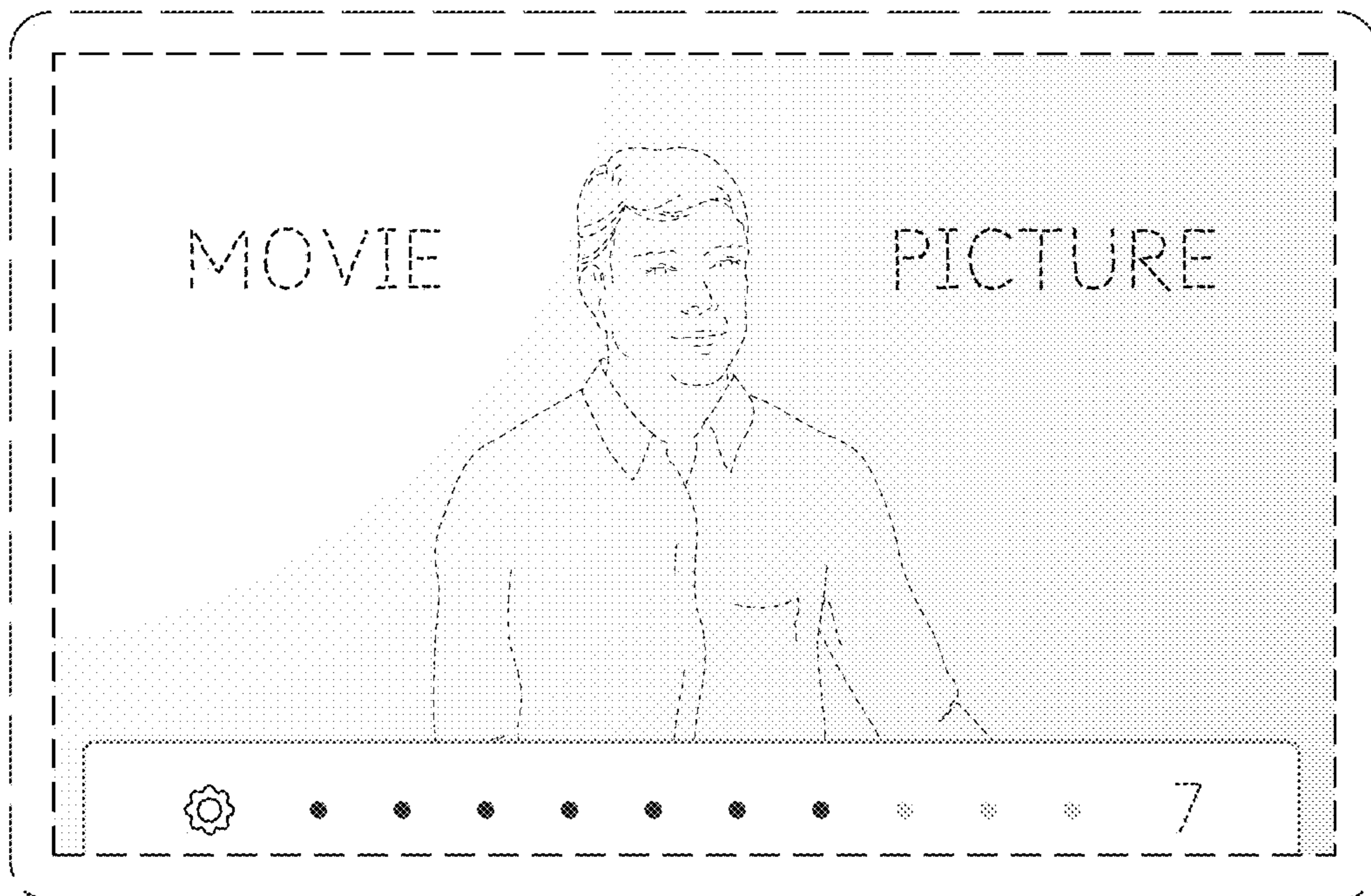

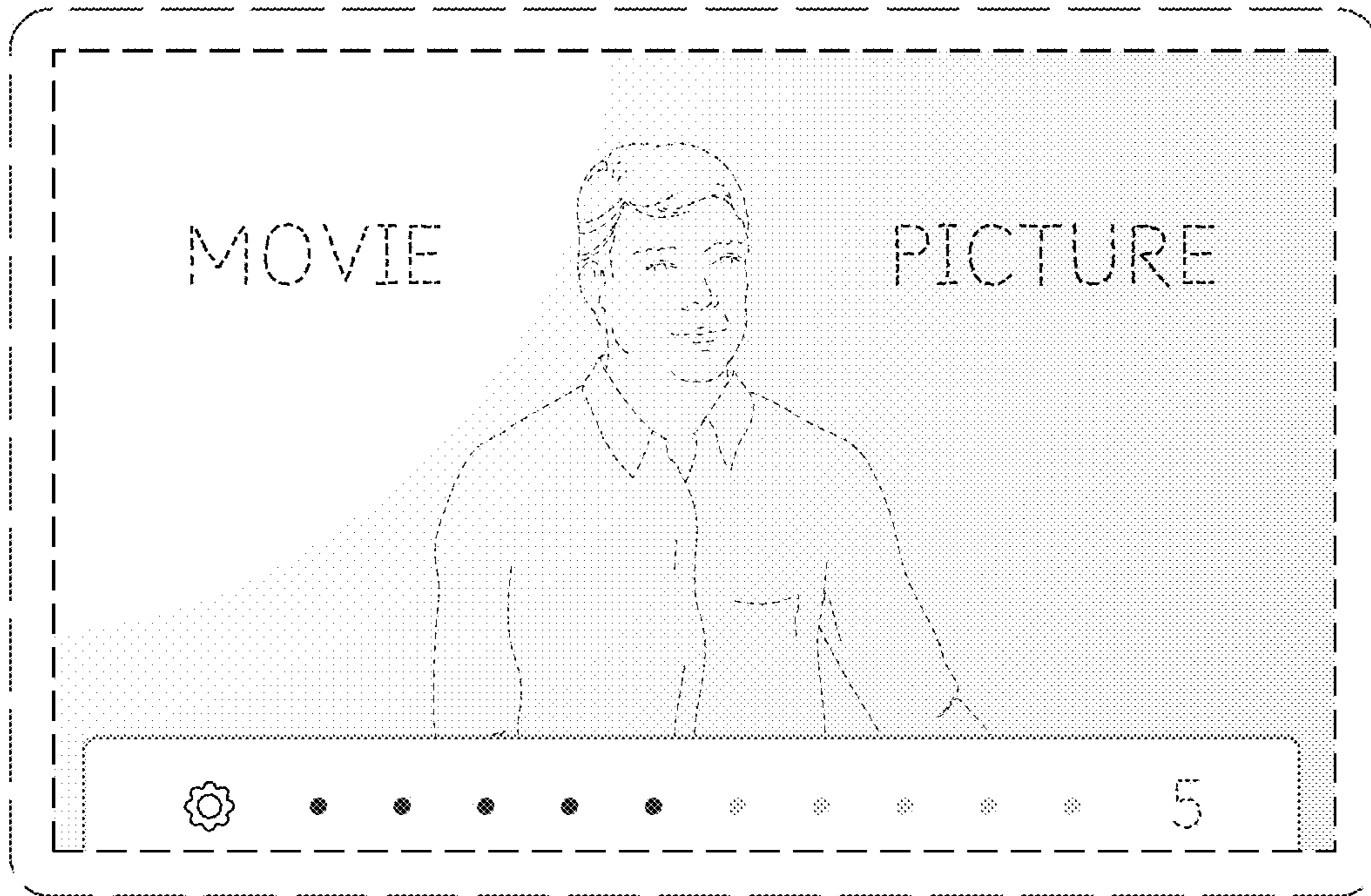

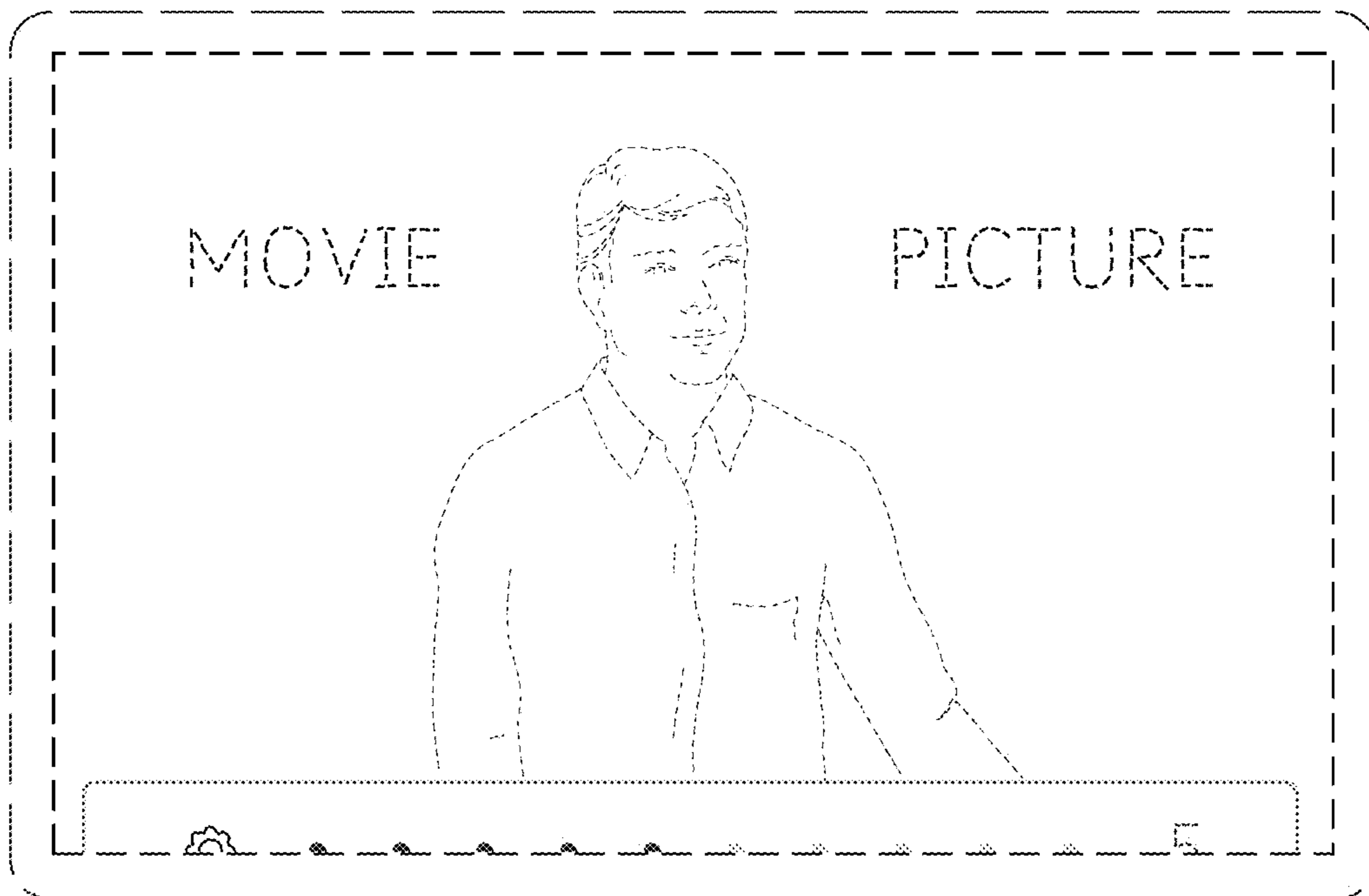
